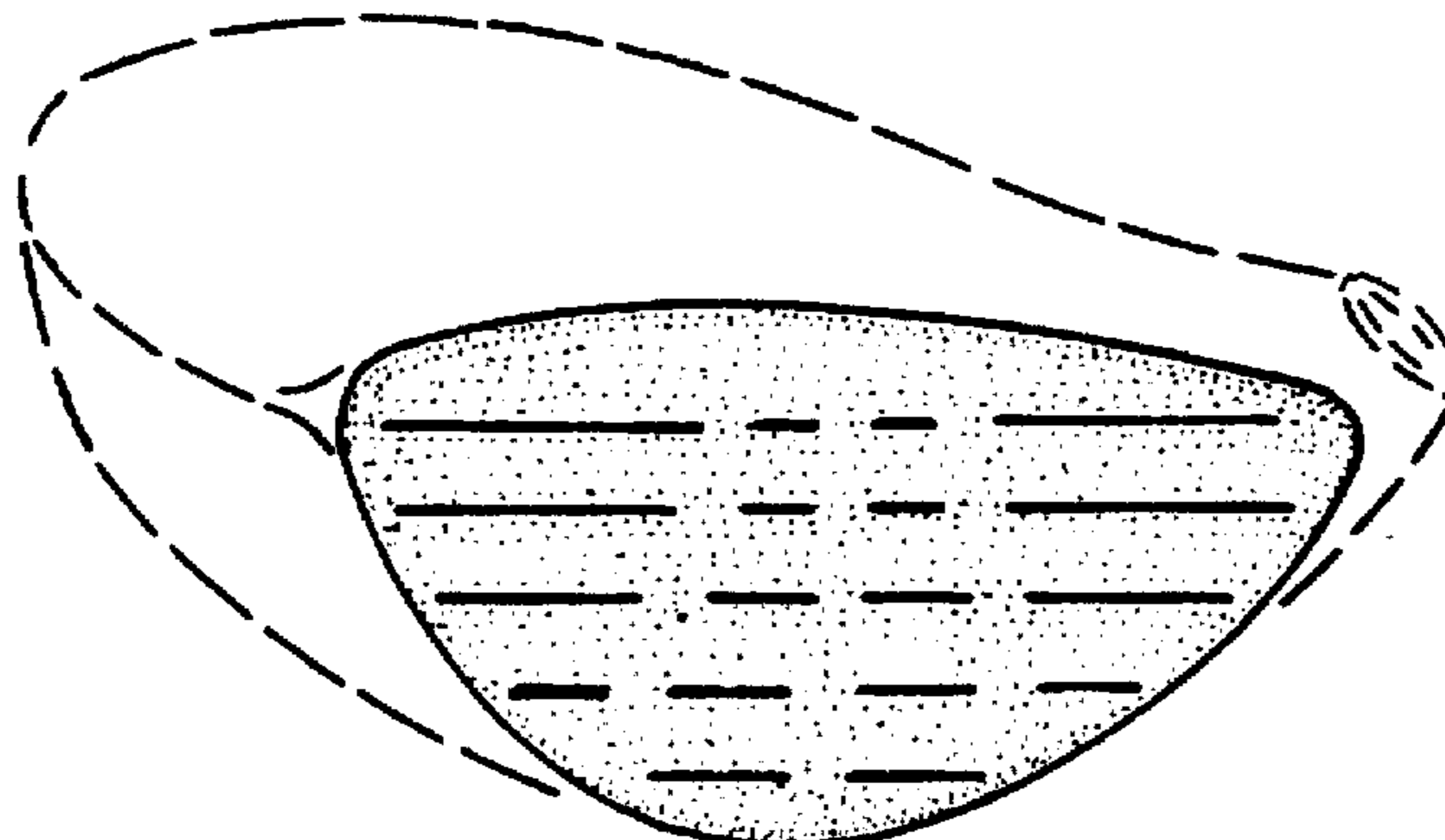
[57] **CLAIM**

The ornamental design for a scoreline pattern for golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the top, front and toe regions of a golf club driver head; FIG. 2 is a top plan view of the FIG. 1 head; FIG. 3 is a front face elevation view of the FIG. 1 head; FIG. 4 is a bottom plan view of the FIG. 1 head; FIG. 5 is a toe end elevation view of the FIG. 1 head; and, FIG. 6 is a heel end elevation view of the FIG. 1 head. The broken line showing of a golf club head is for illustrative purposes only and forms no part of the claimed design.

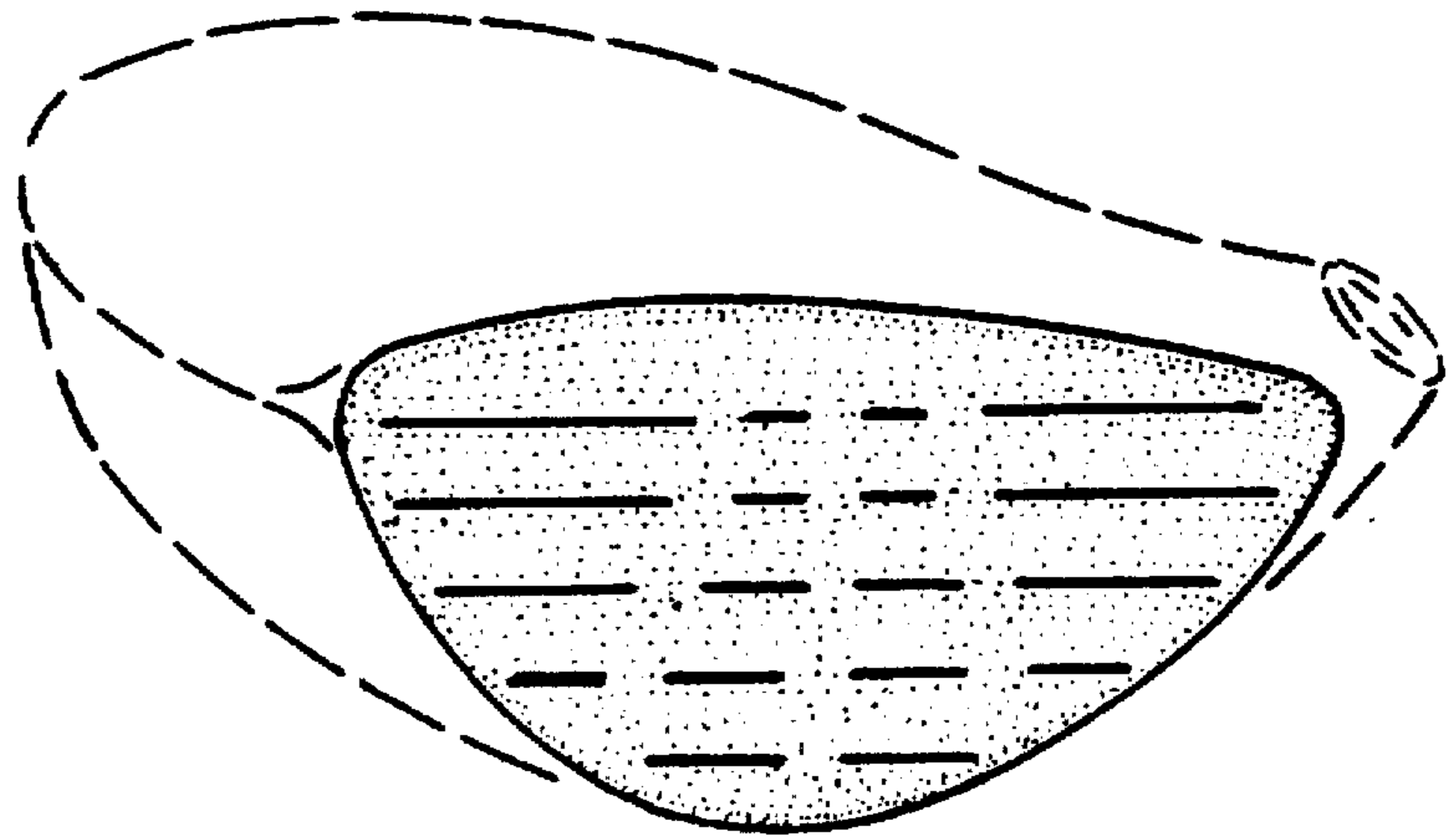

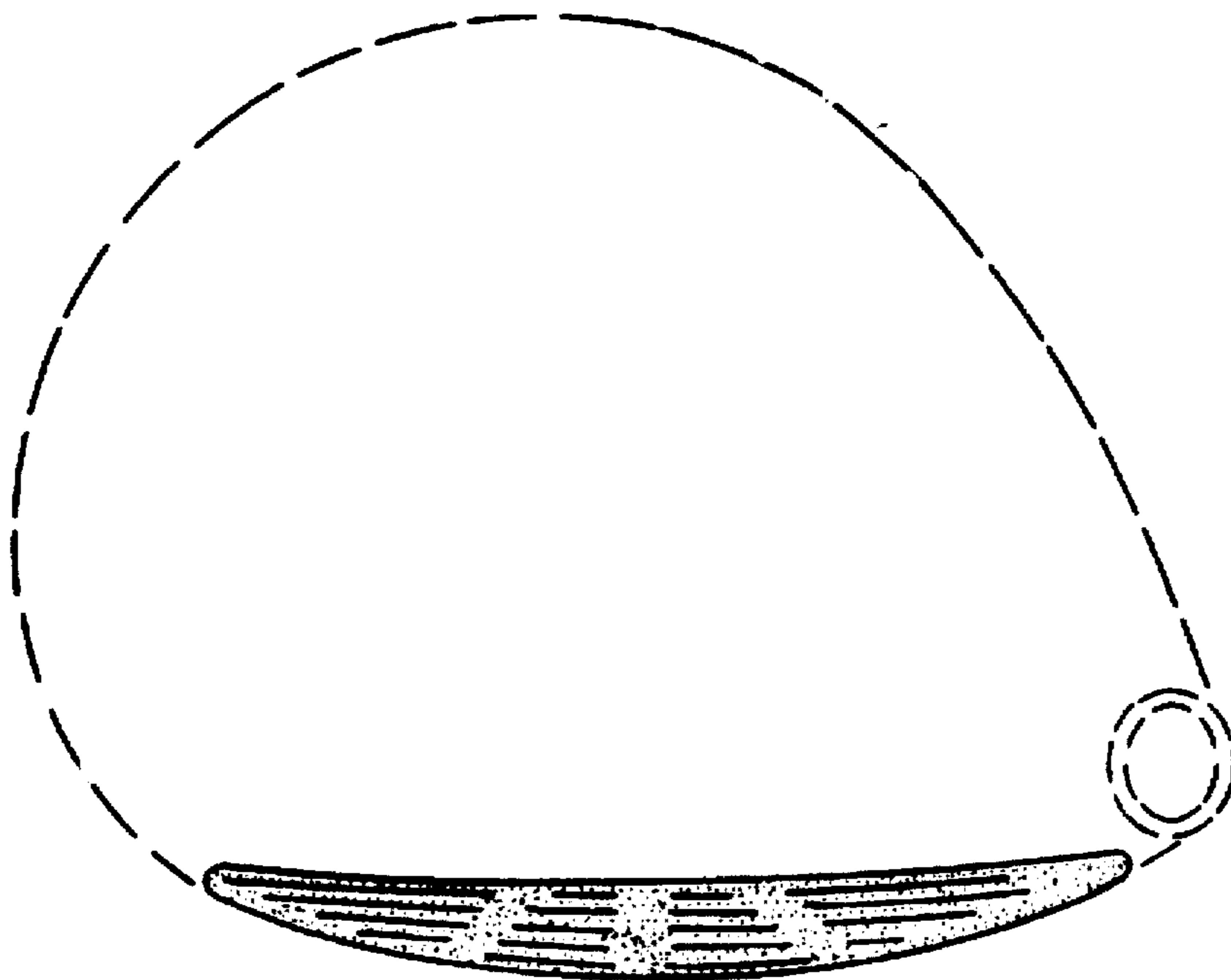

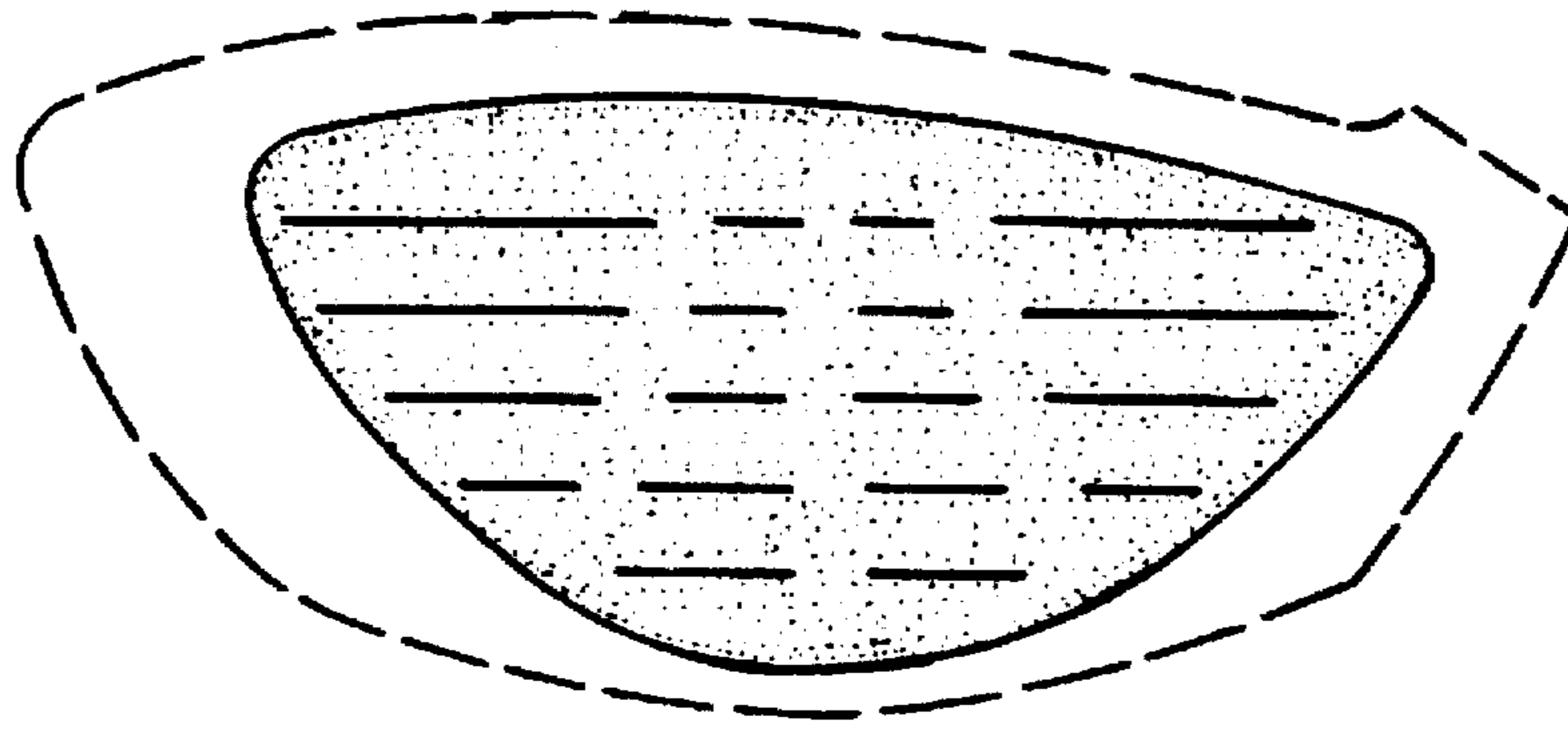

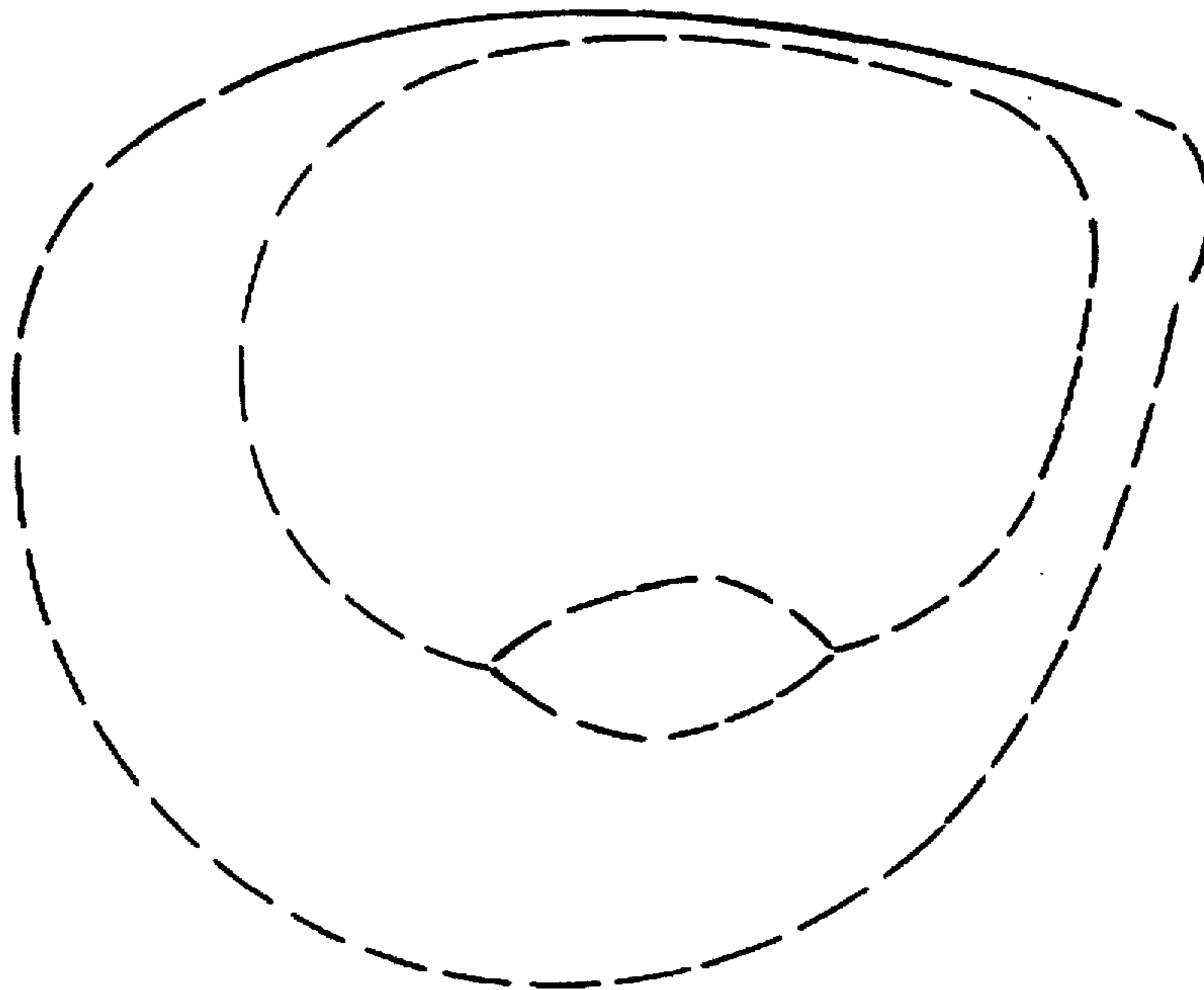

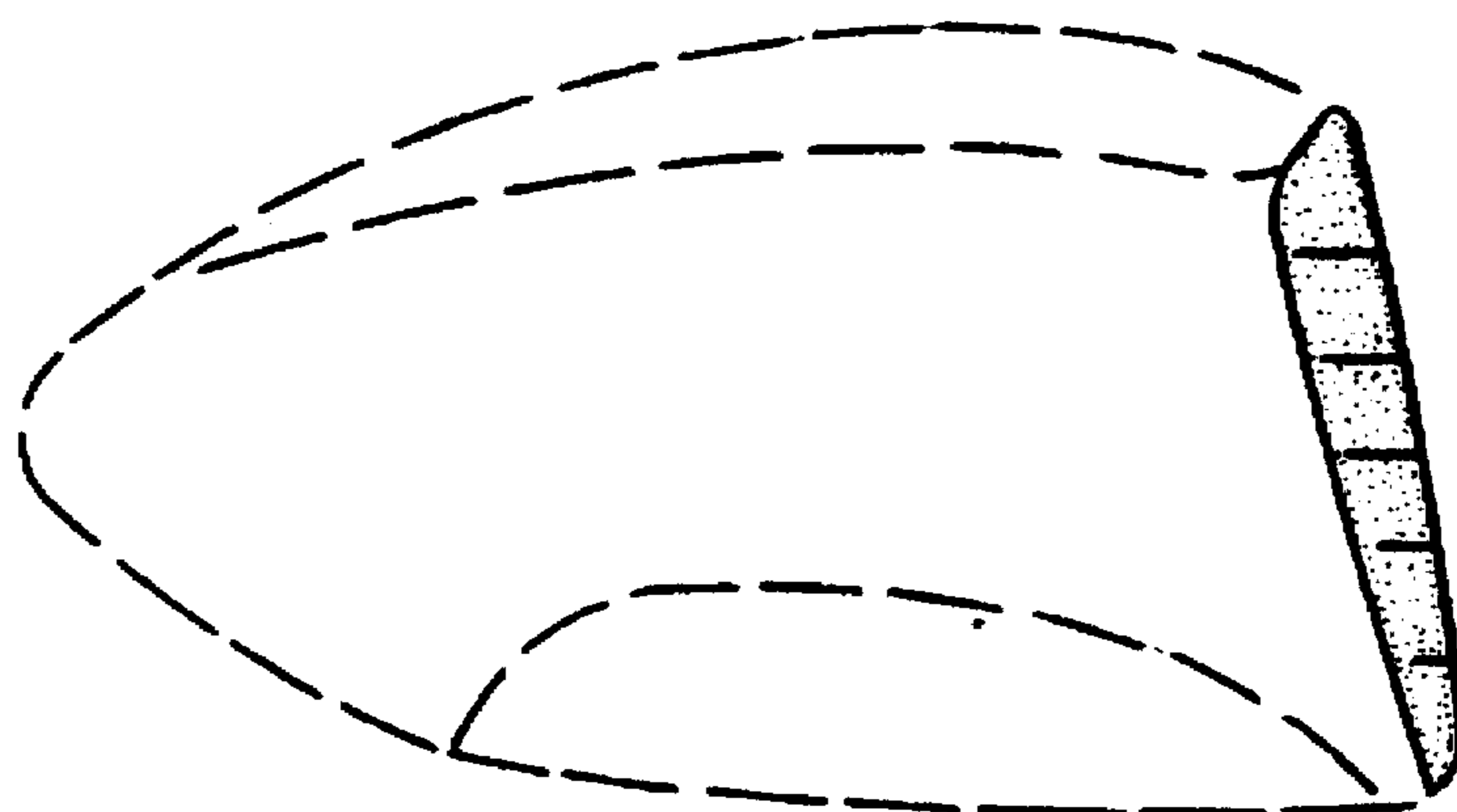
