**CLAIM**

[57] The ornamental design for a combination wicker and wrought iron chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a combination wicker and wrought iron chair showing my new design;  
FIG. 2 is a front elevational view;  
FIG. 3 is a right side elevational view, the left side elevational view being identical thereto;  
FIG. 4 is a rear elevational view;  
FIG. 5 is a top plan view; and,  
FIG. 6 is a bottom plan view.

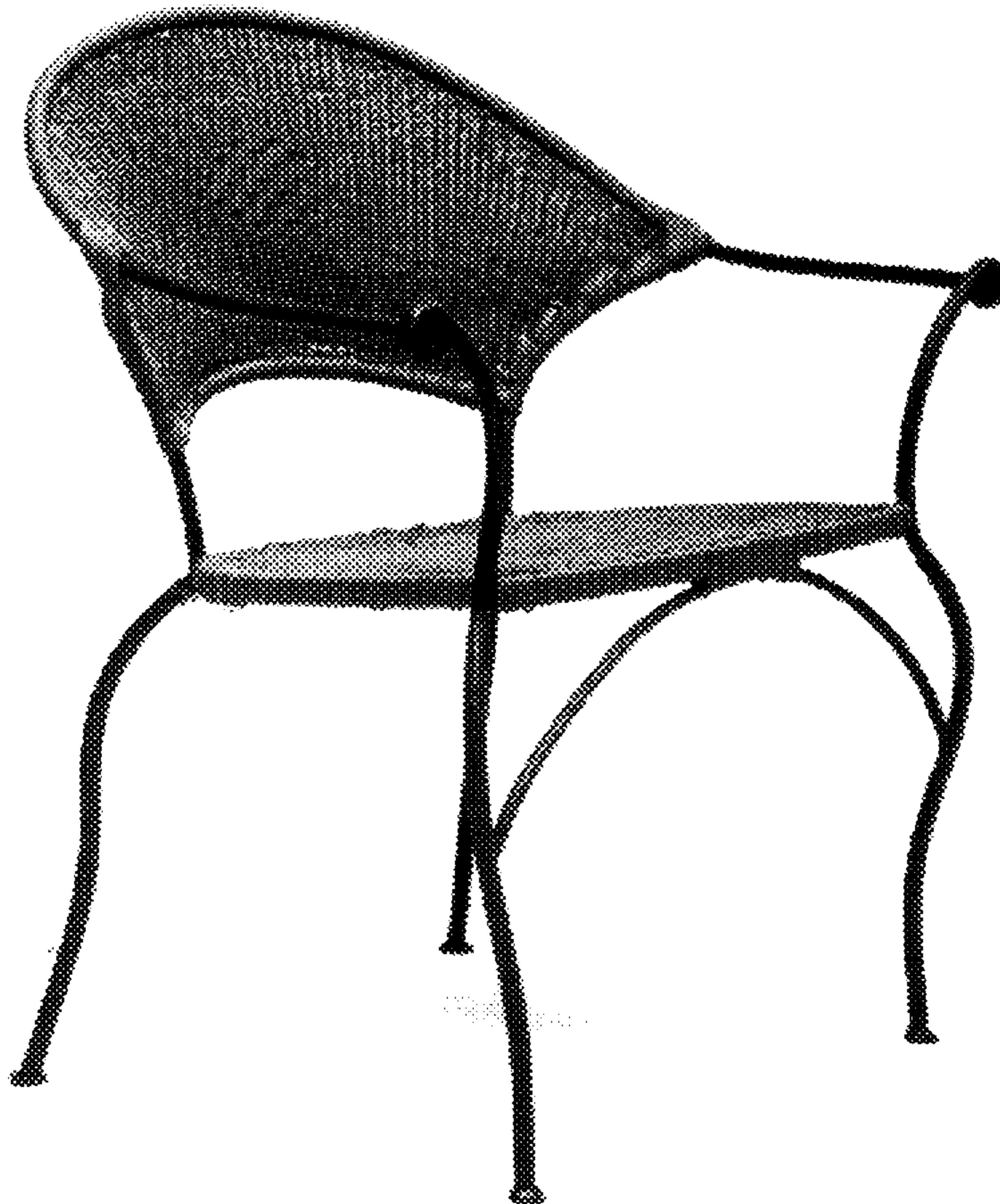

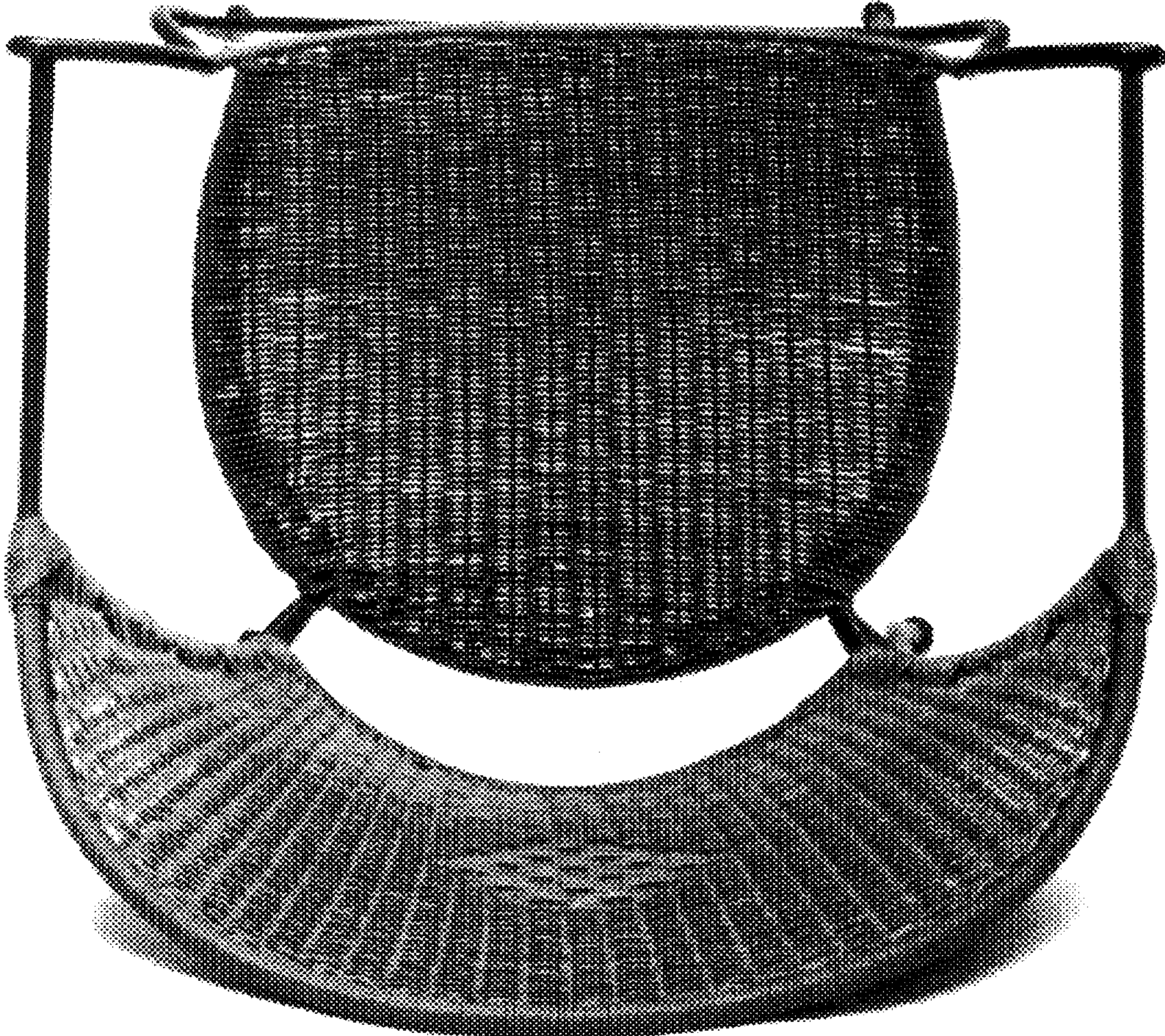
