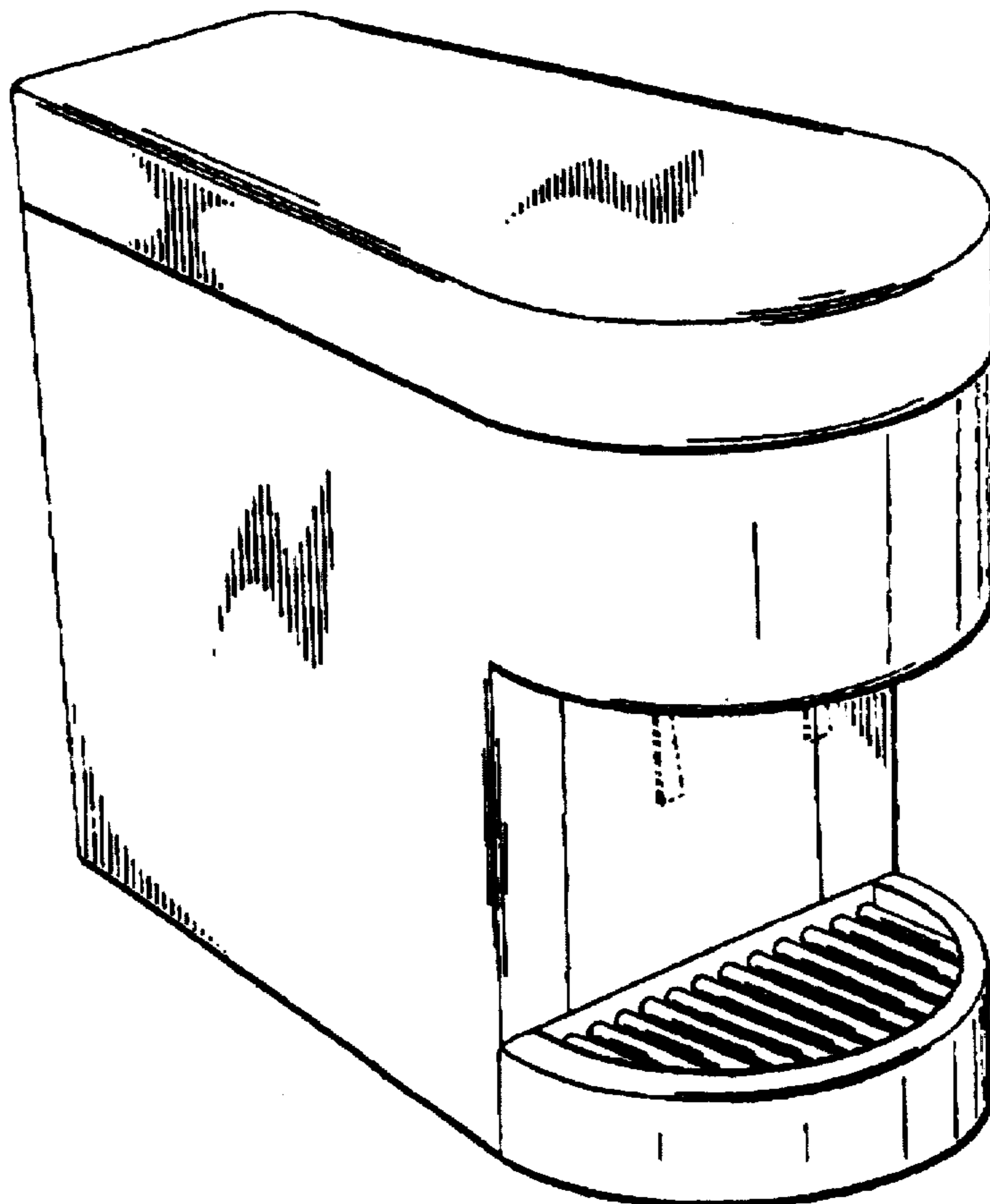

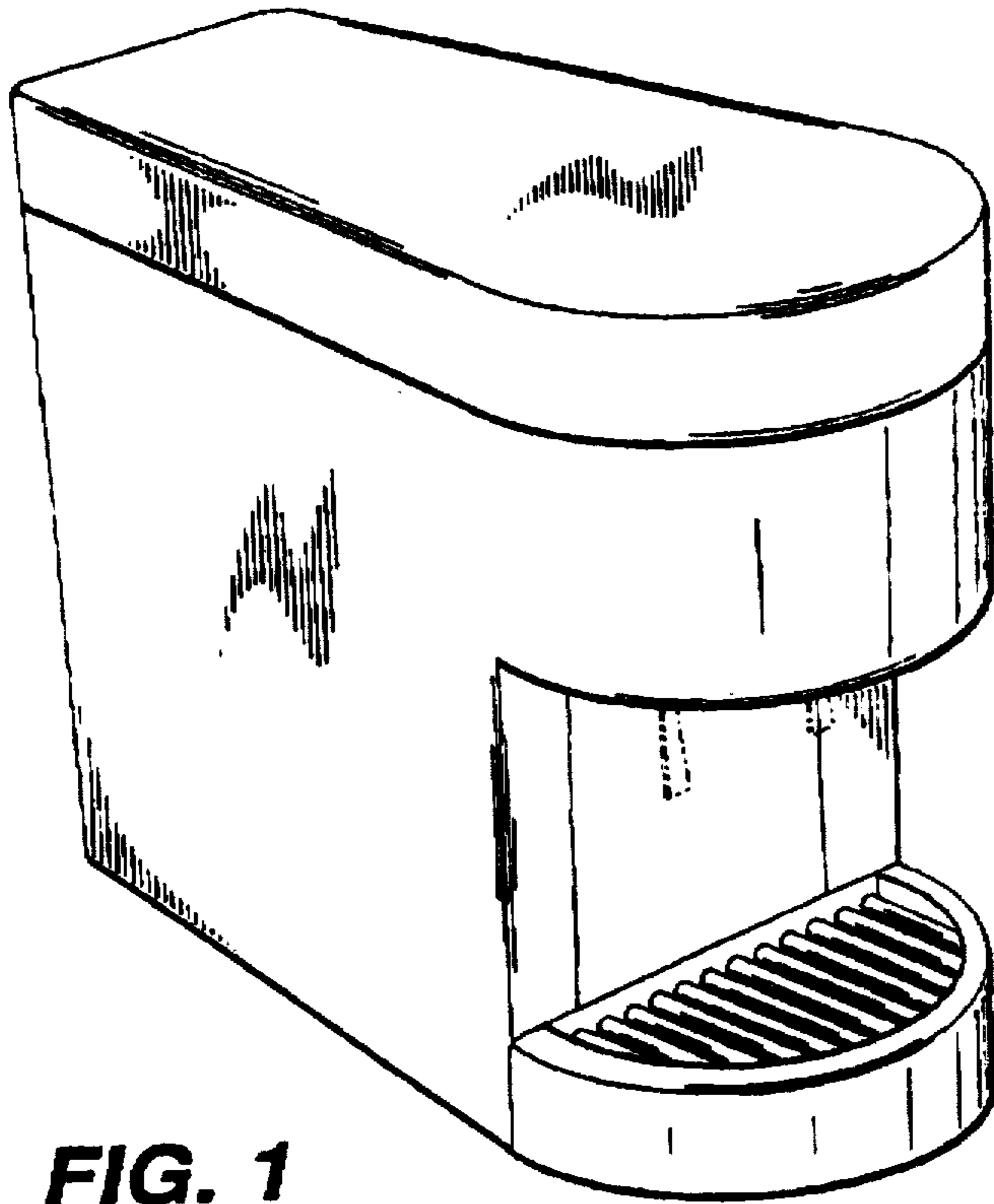
The ornamental design for a beverage dispenser, as shown and described.

**DESCRIPTION**

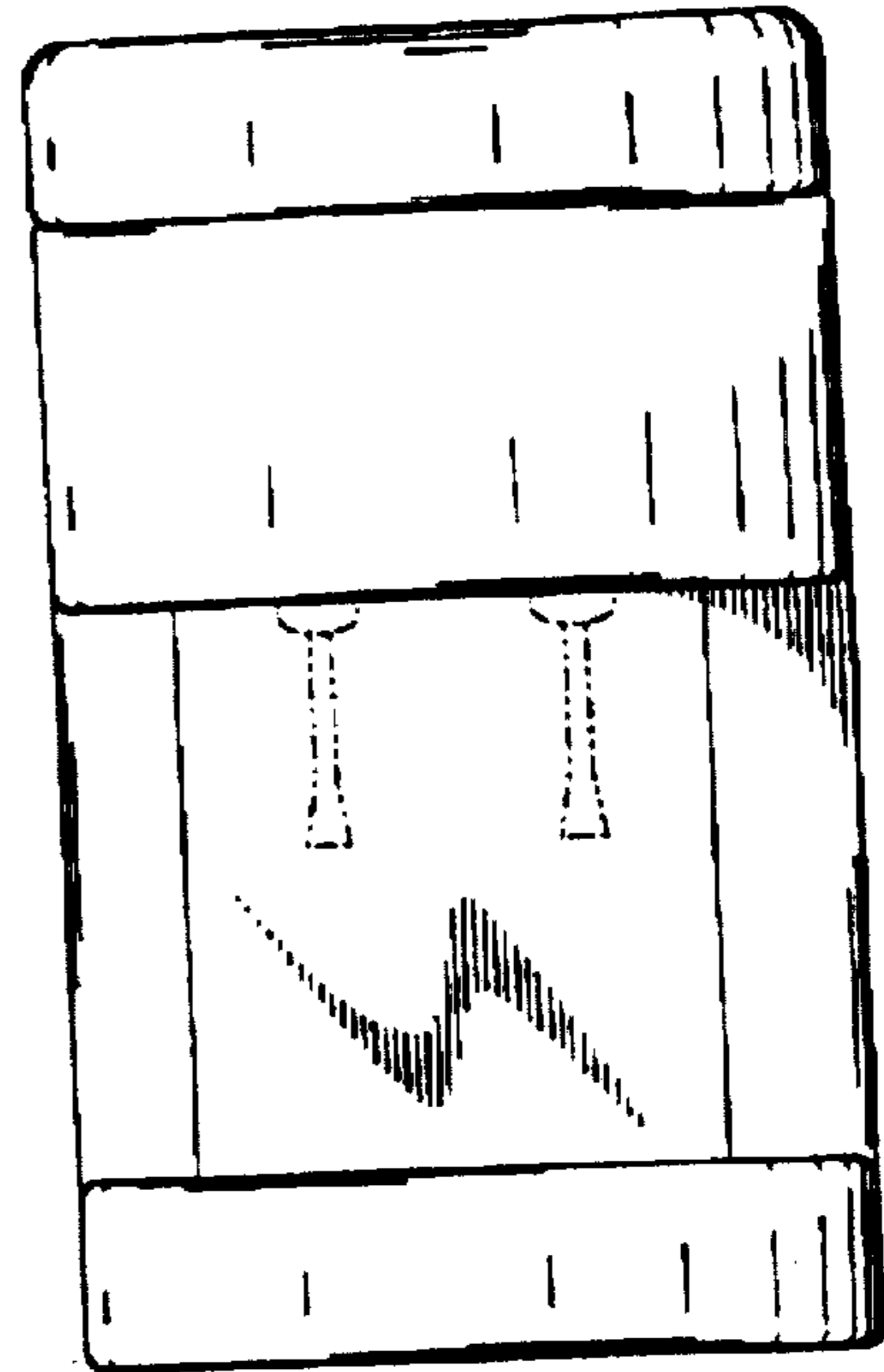
FIG. 1 is a top, front, left side perspective view of a dispenser showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a top plan view thereof (the bottom view is identical to this top plan view);  
 FIG. 7 is a top, front, left side perspective view of the dispenser of this invention with graphics shown in dotted lines on the graphics panel;  
 FIG. 8 is a front elevational view of the dispenser of FIG. 1;  
 FIG. 9 is a left side elevational view thereof;  
 FIG. 10 is a right side elevational view thereof;  
 FIG. 11 is a rear elevational view thereof; and  
 FIG. 12 is a top plan view thereof (the bottom view is identical to this top plan view).  
 The broken lines in FIGS. 1, 2, 3, 4, and 7-10 are for illustrative purposes only and form no part of the claimed design.

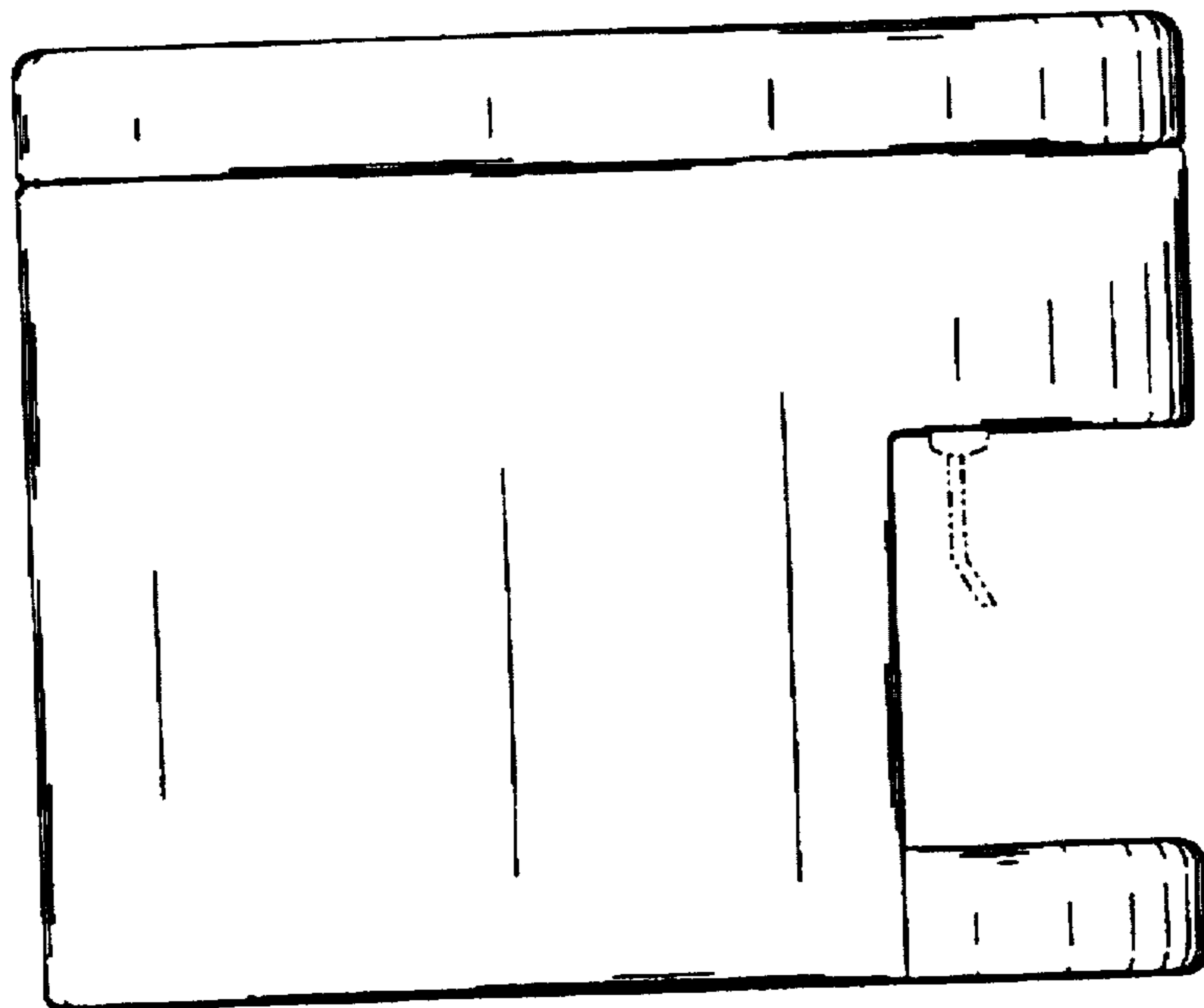




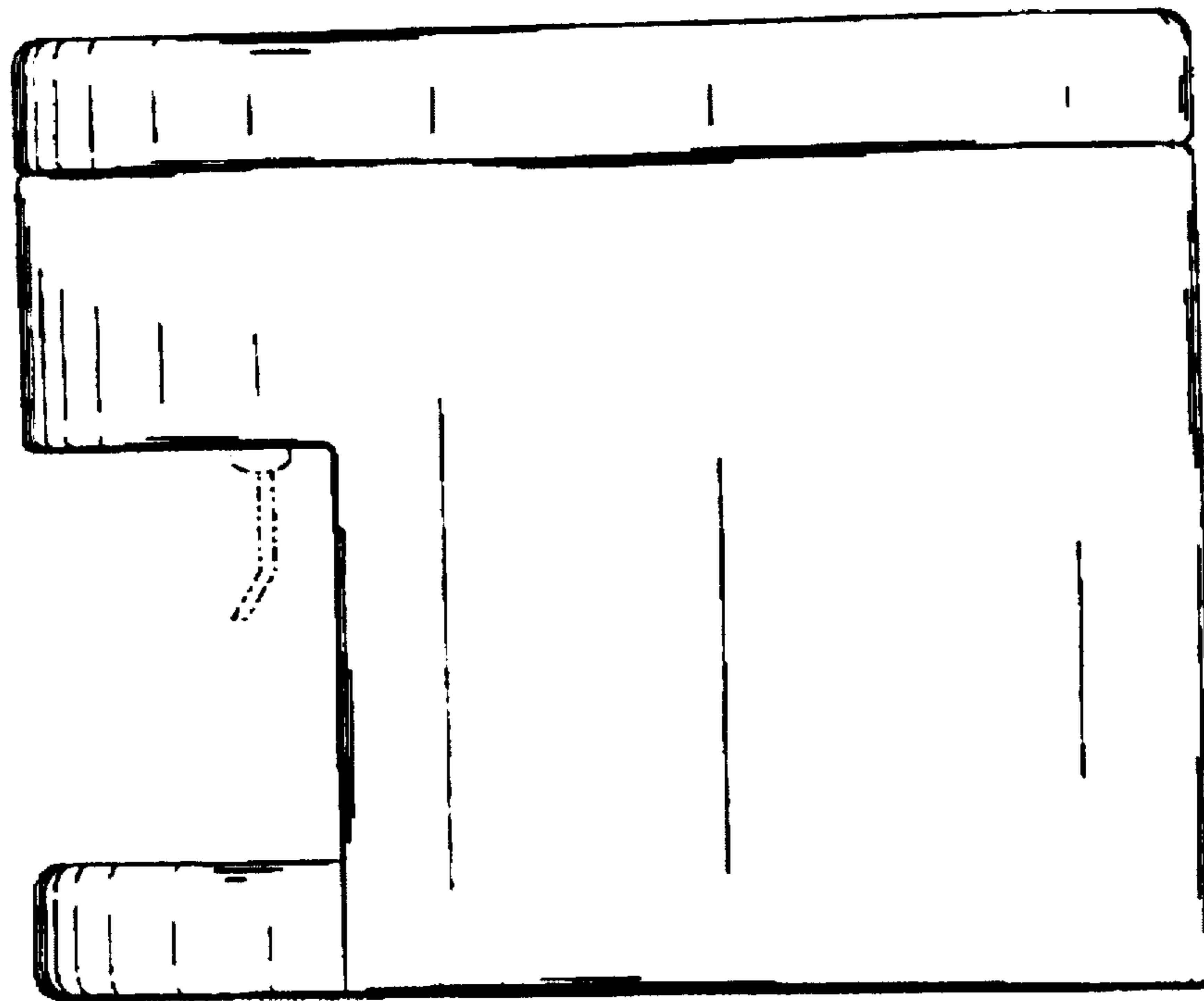

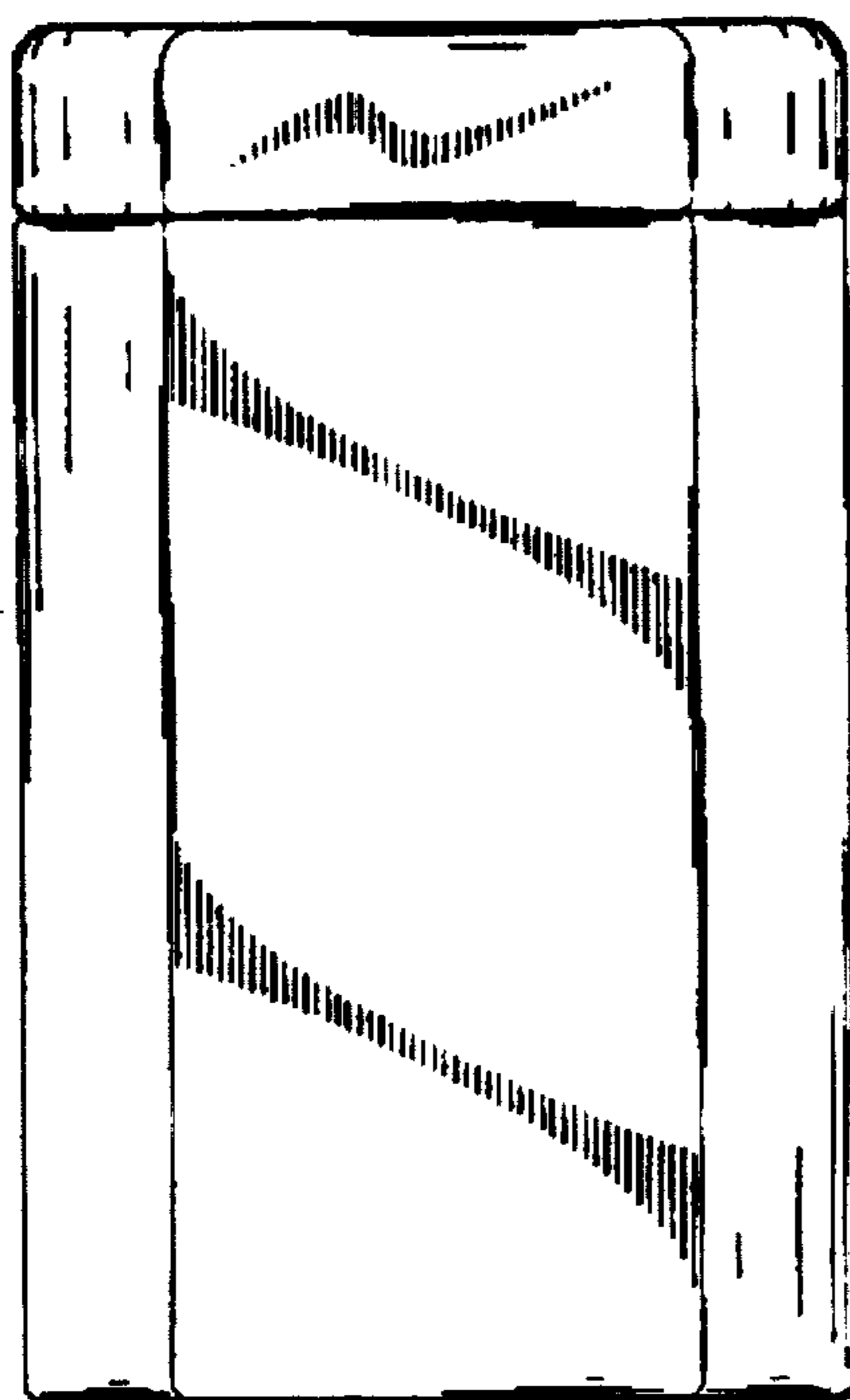

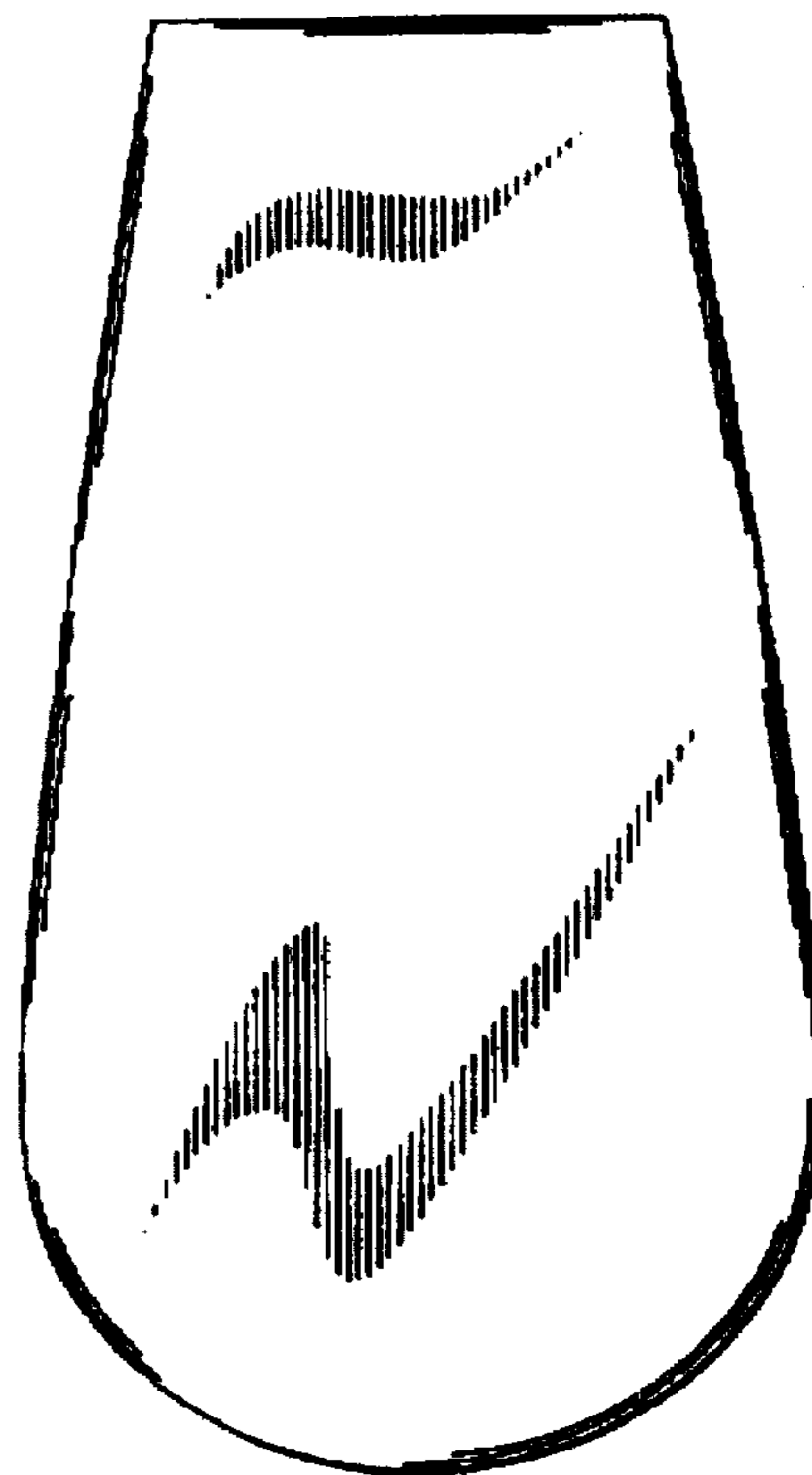

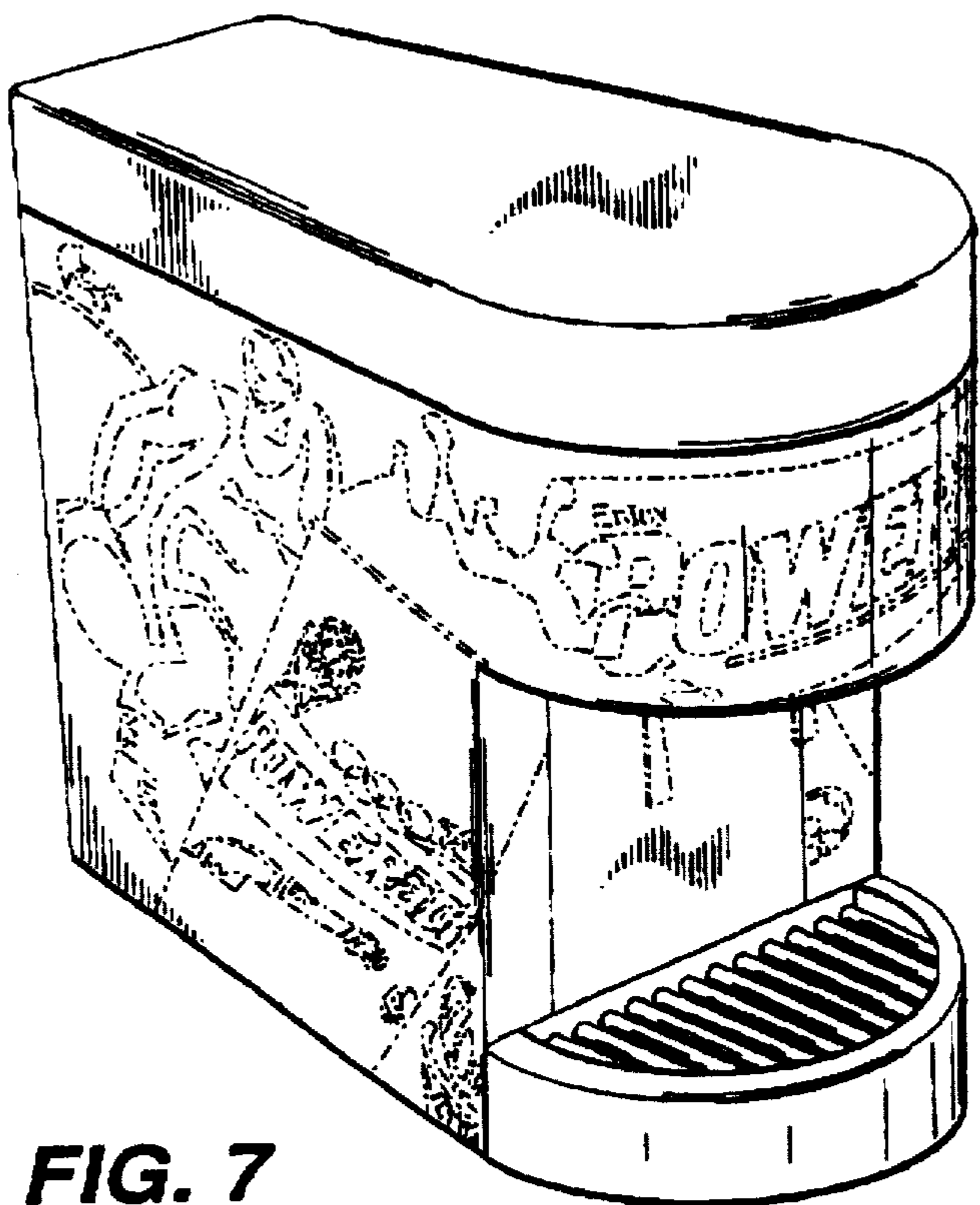

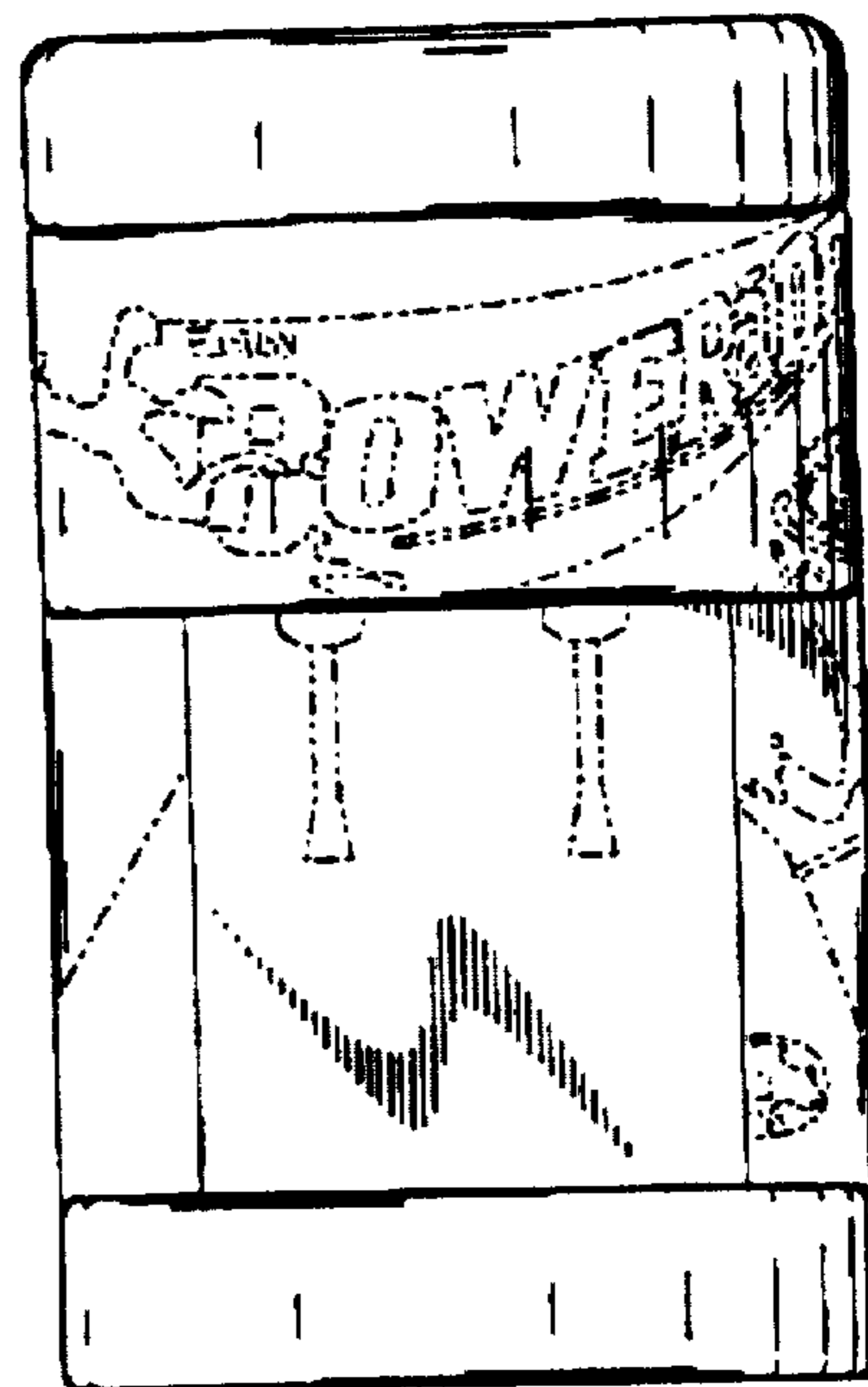

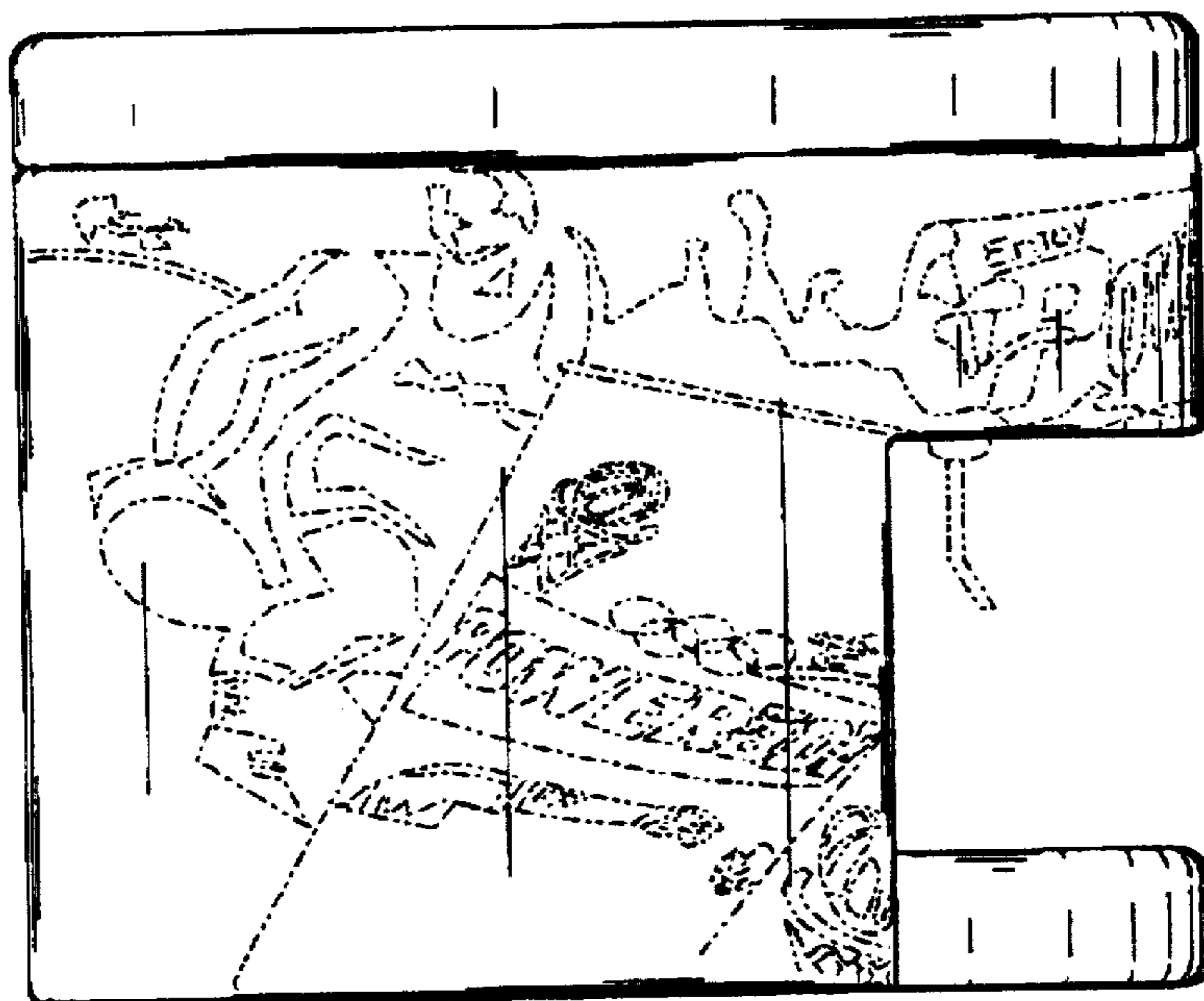

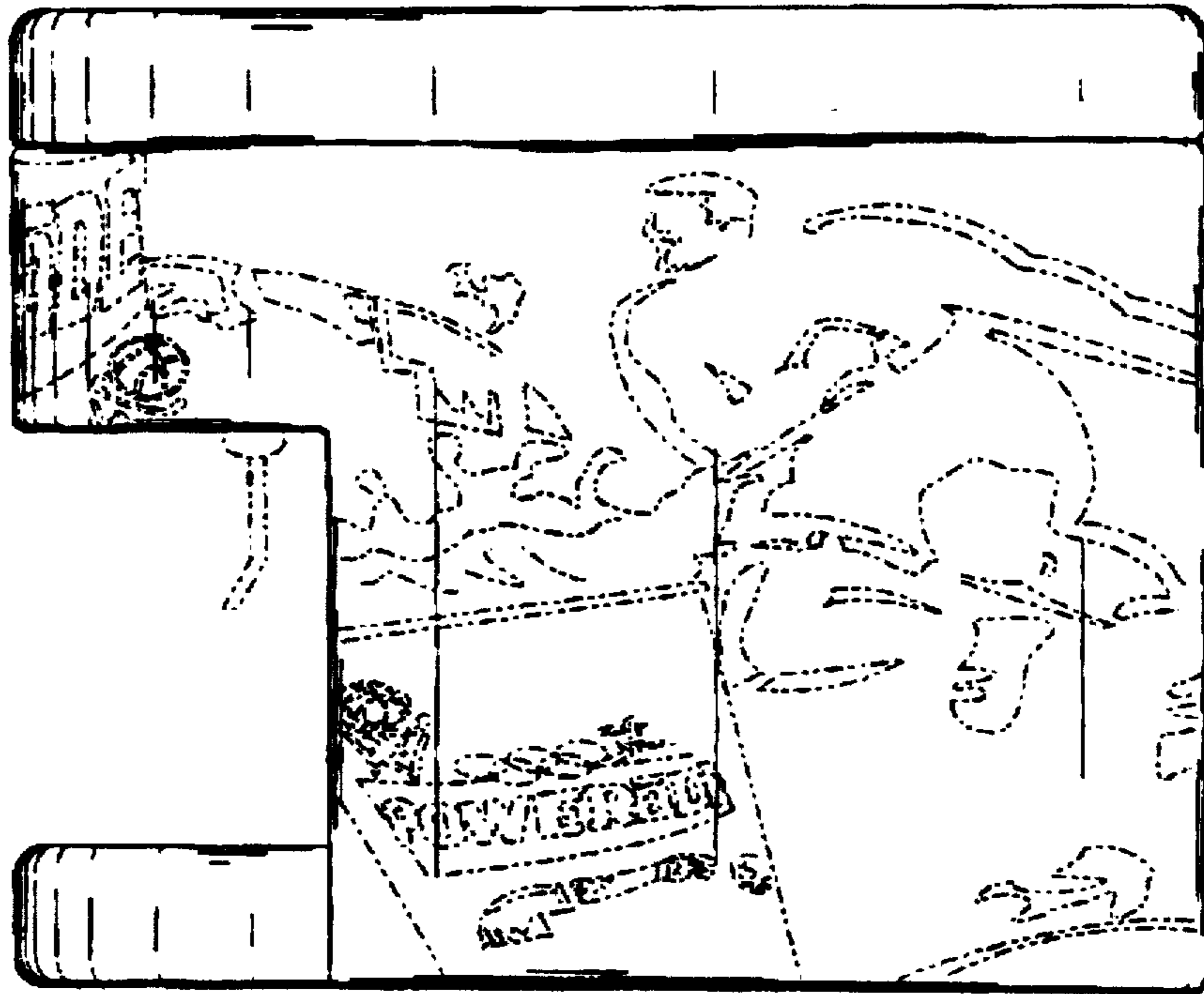

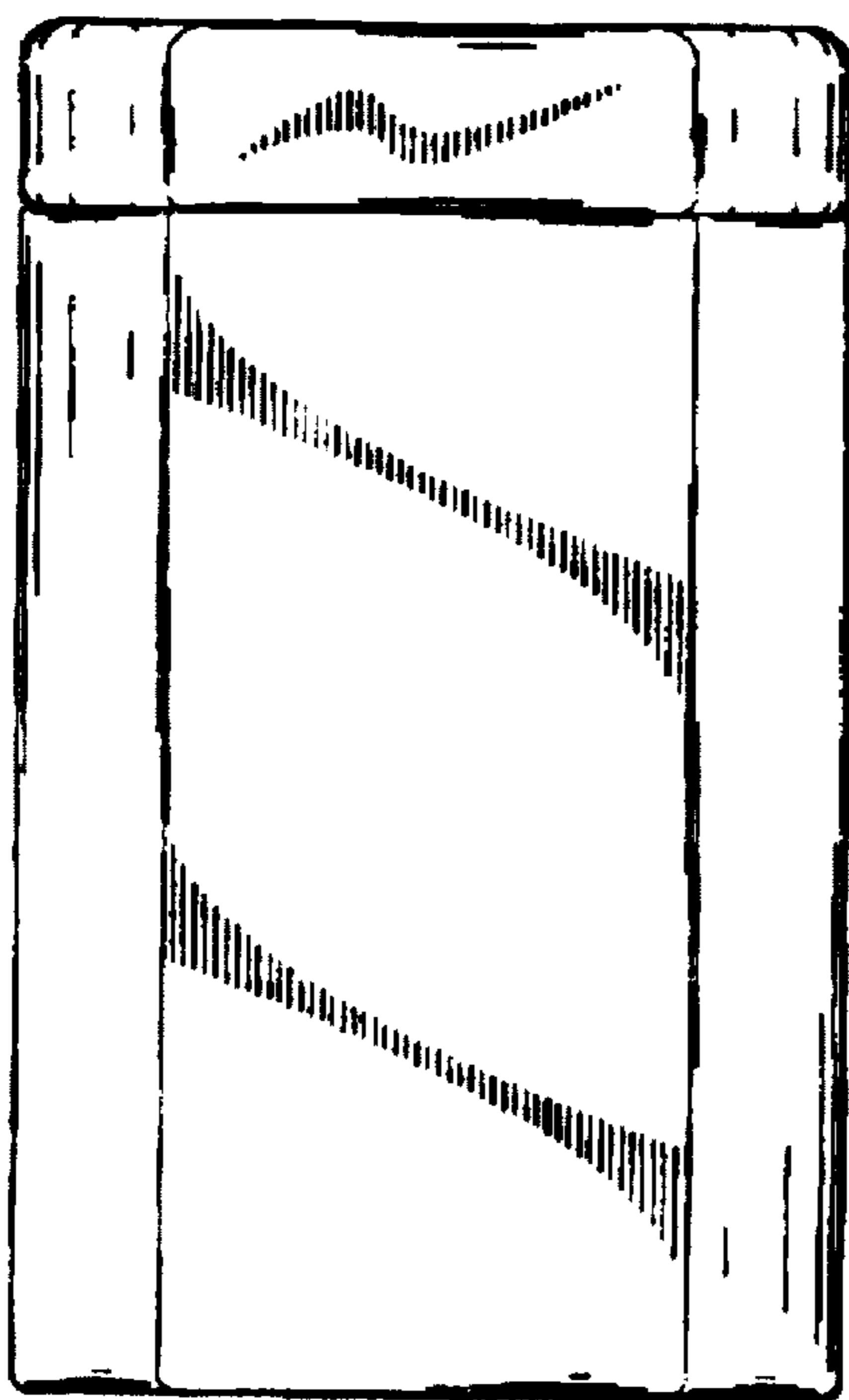

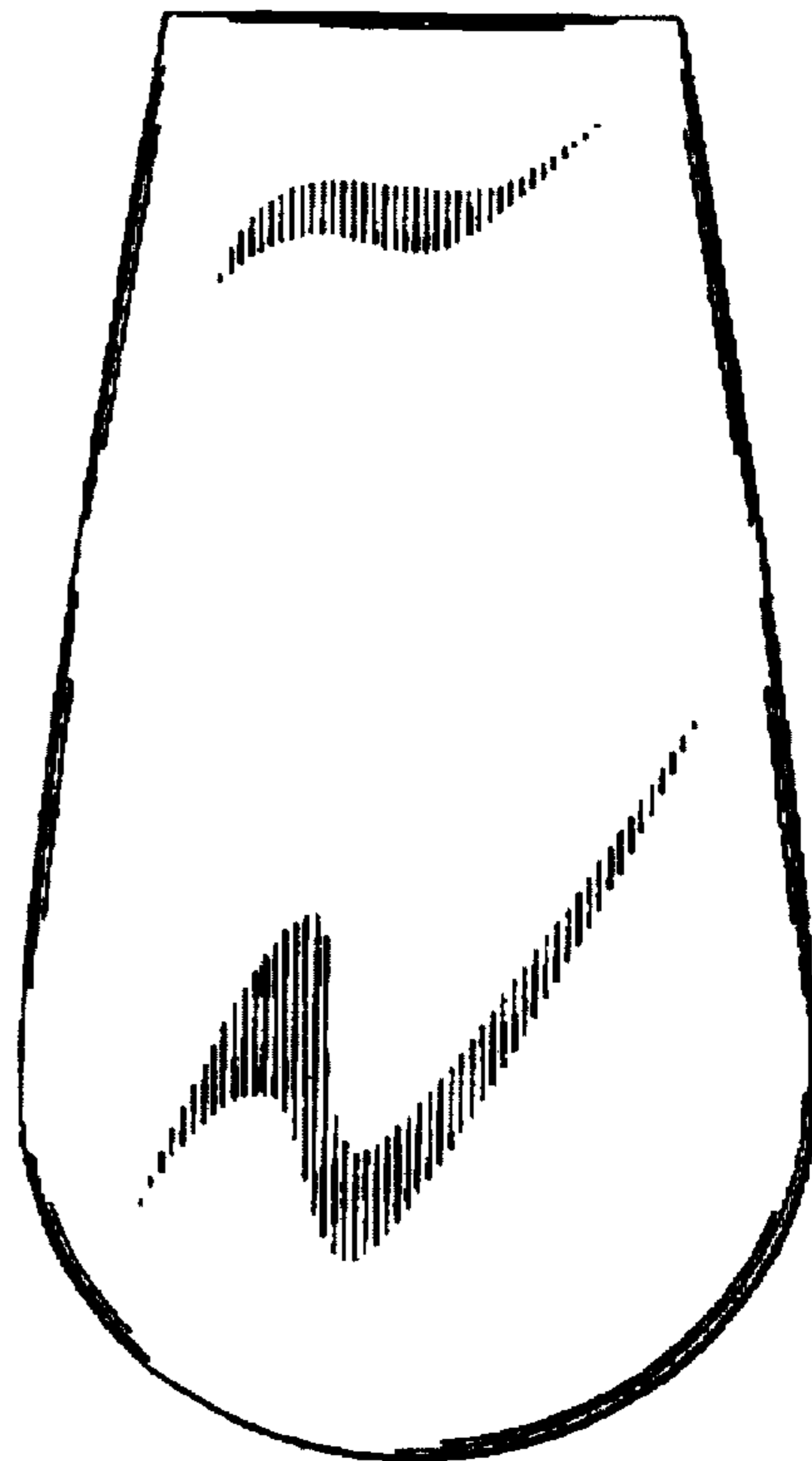
