The ornamental design for enclosure for terminating television service and/or telephone service and/or data service at the customer's premises, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the enclosure for terminating television service and/or telephone service and/or data service at the customer's premises;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a bottom view thereof taken from FIG. 4;  
FIG. 6 is a right side elevational view thereof taken from FIG. 2;  
FIG. 7 is a left side elevational view thereof taken from FIG. 2; and,  
FIG. 8 is a rear perspective view thereof.

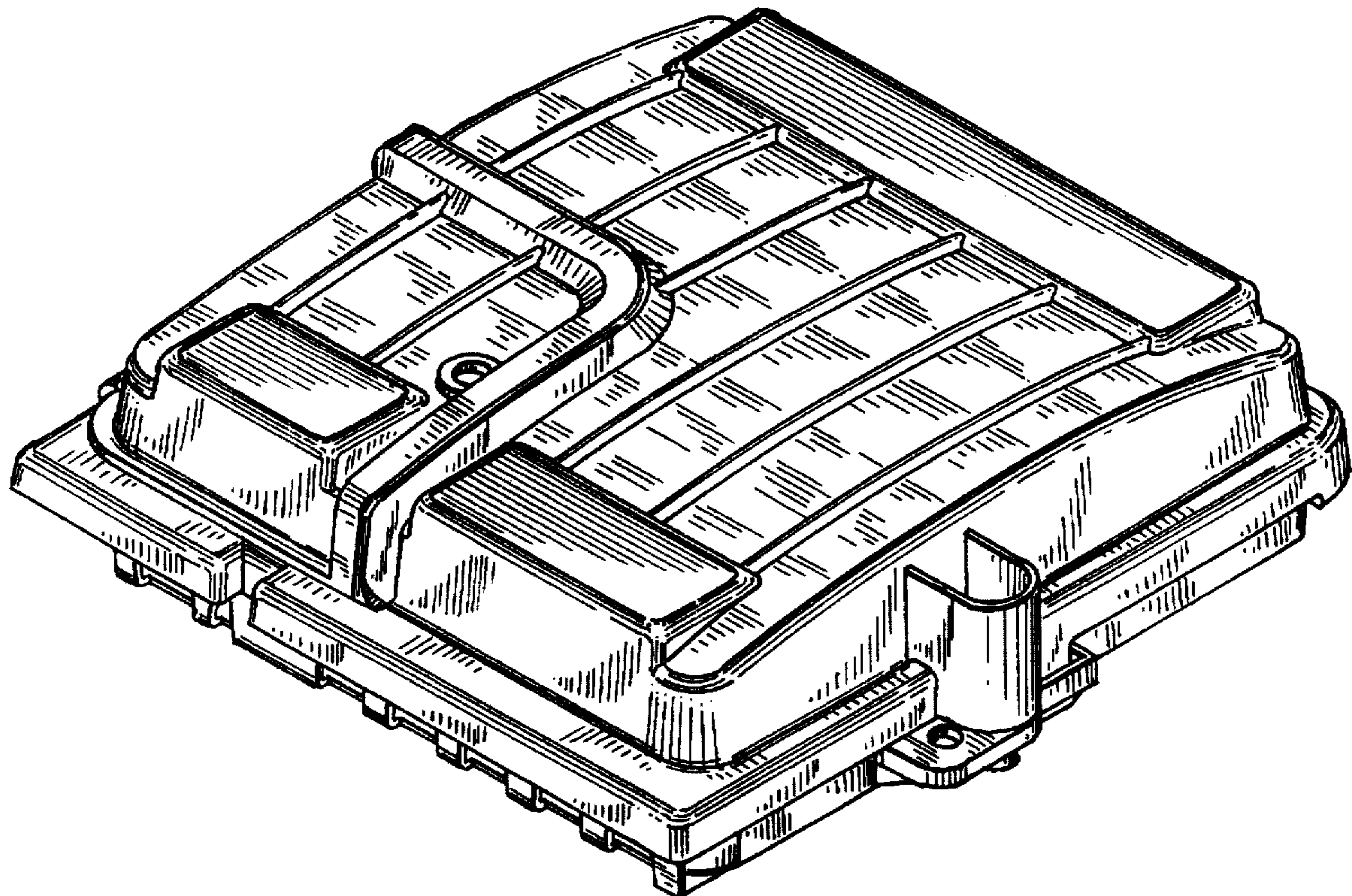

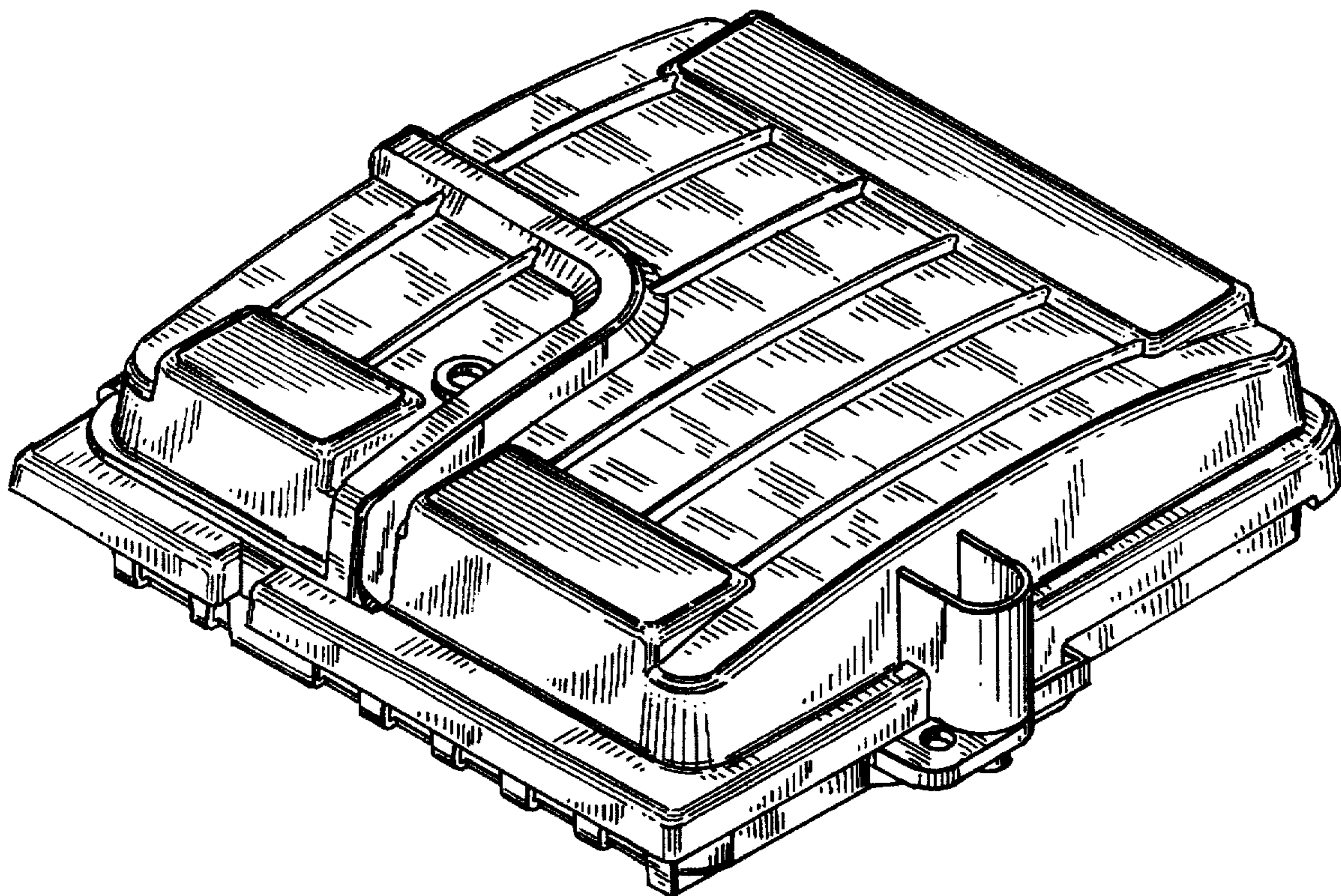

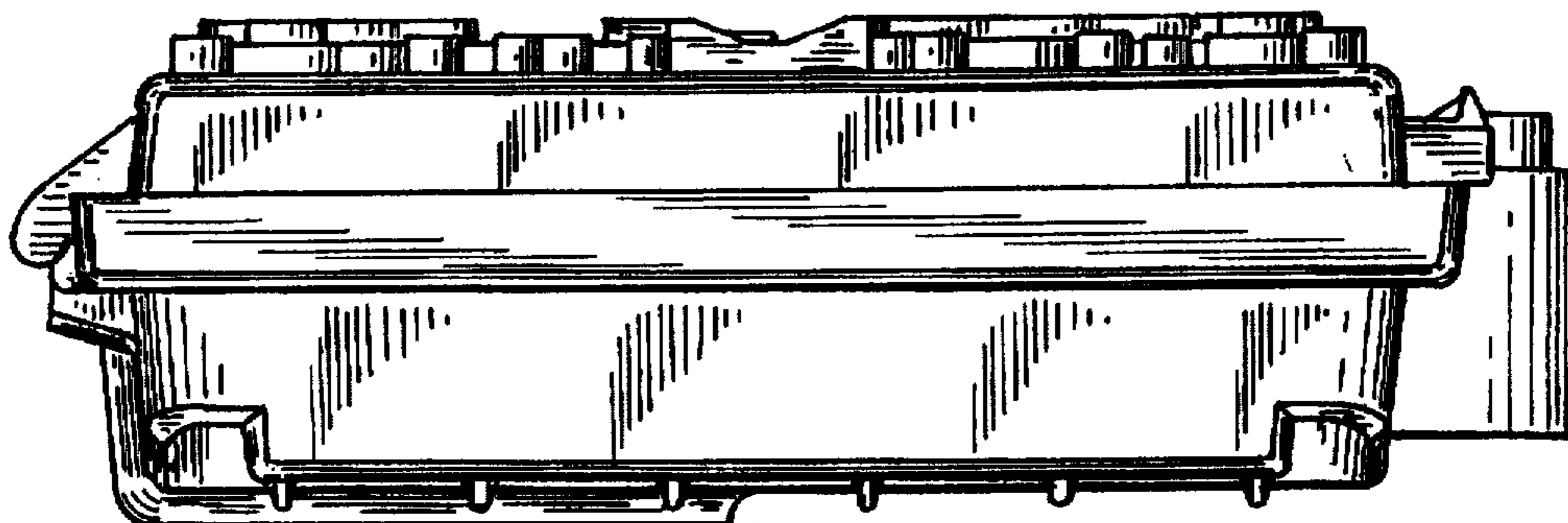

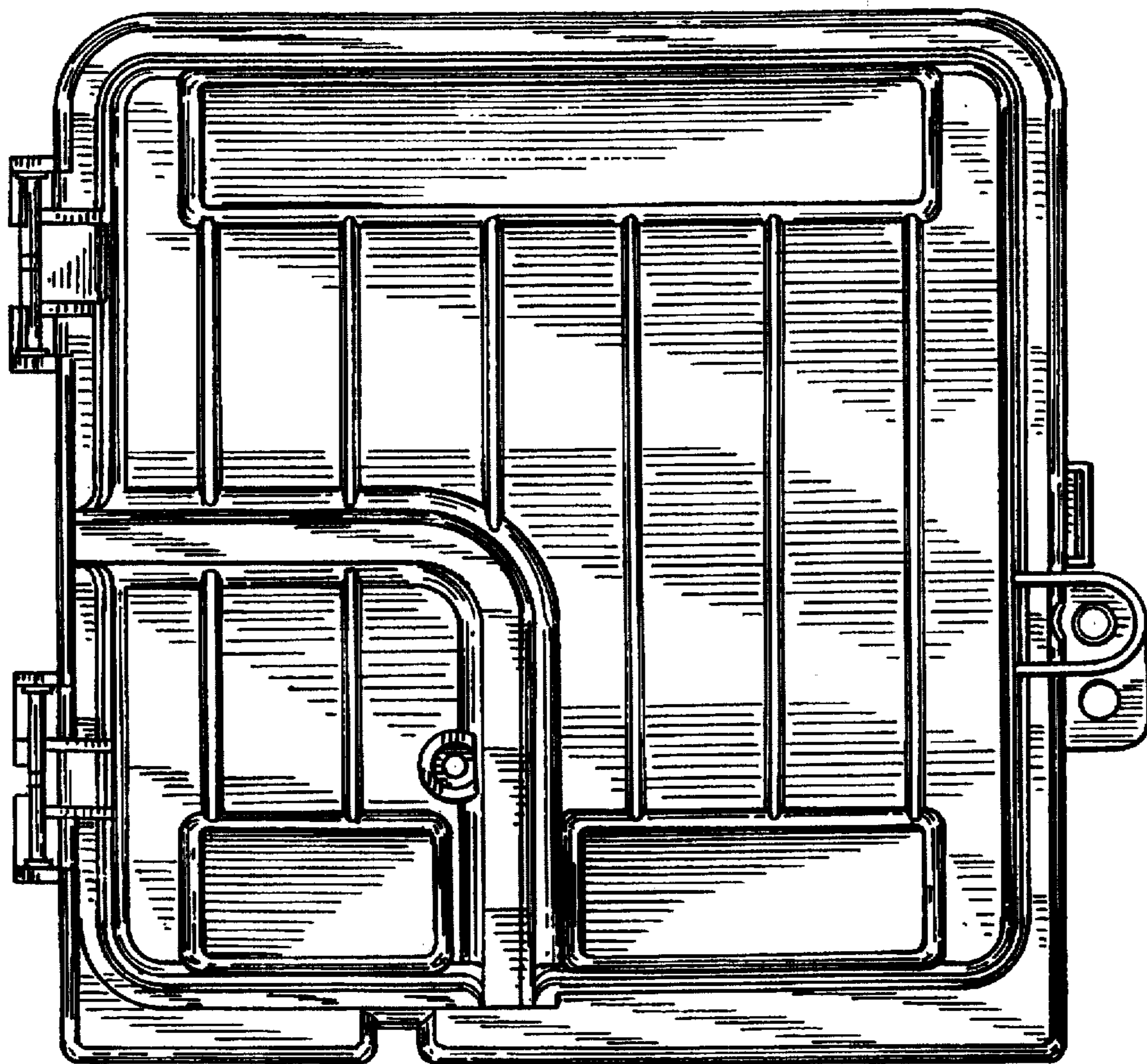

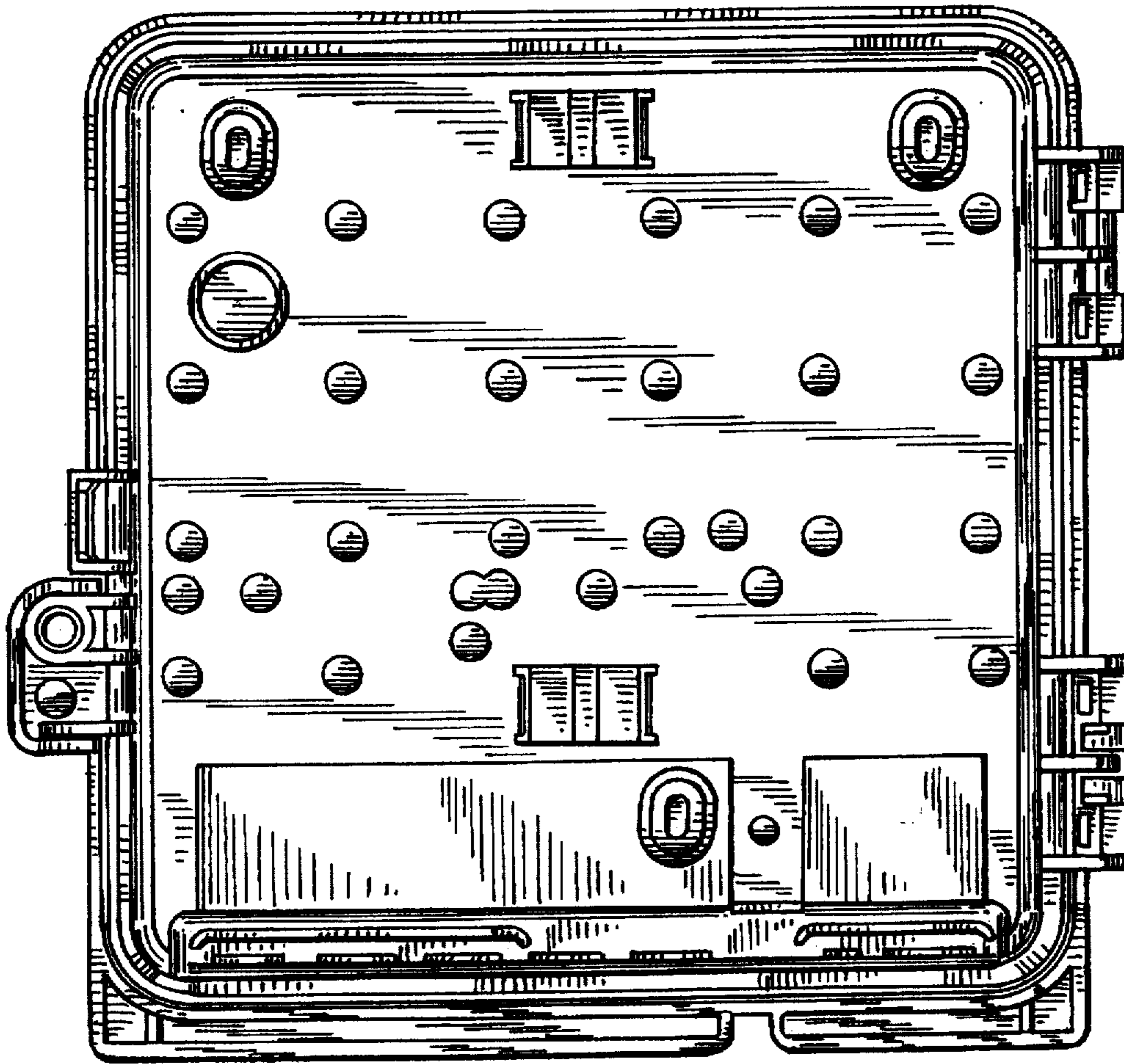

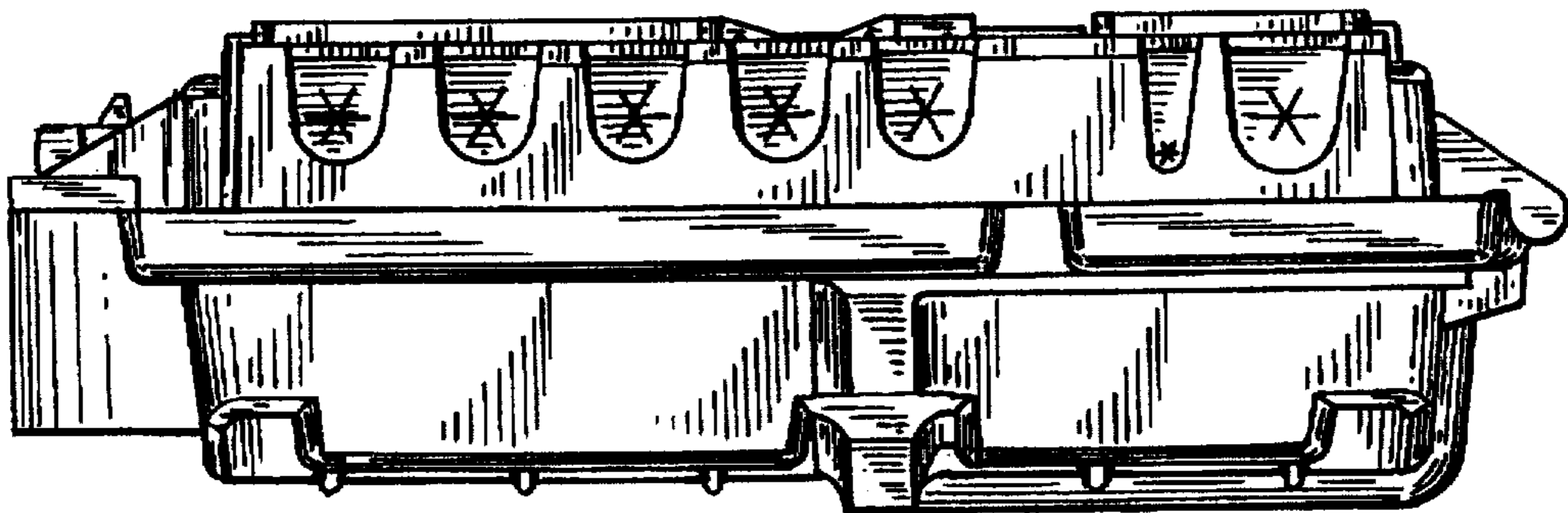

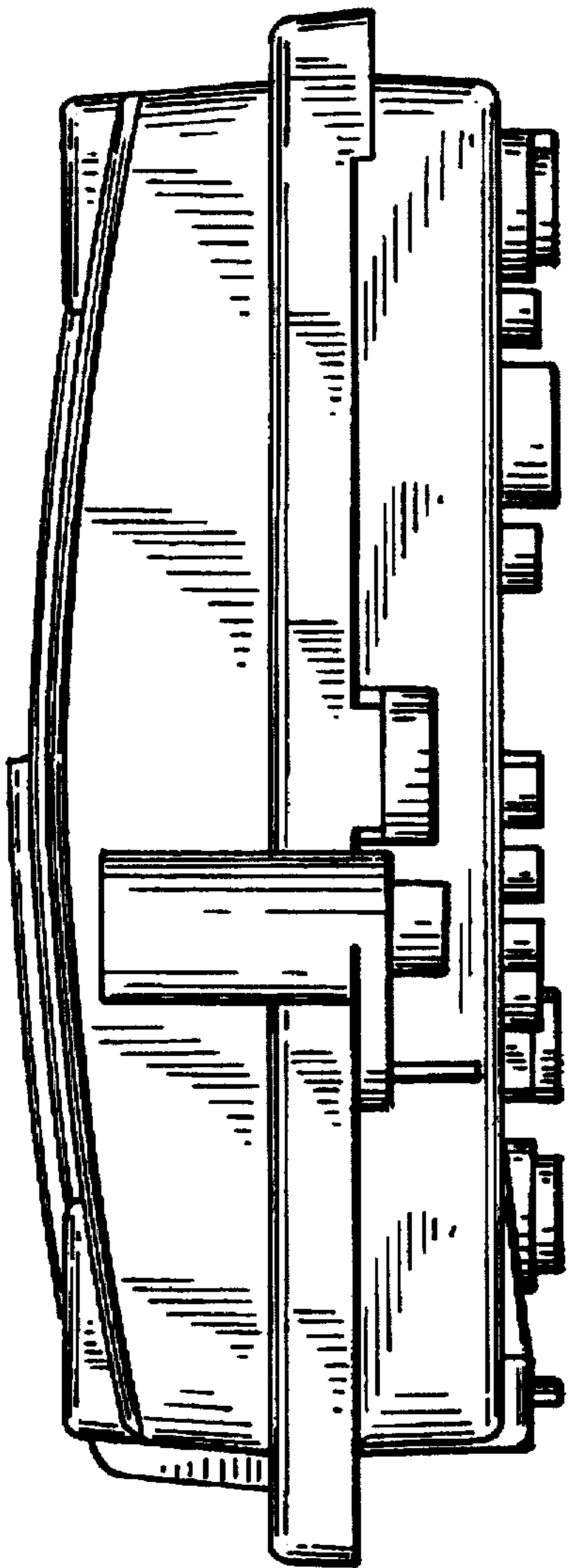

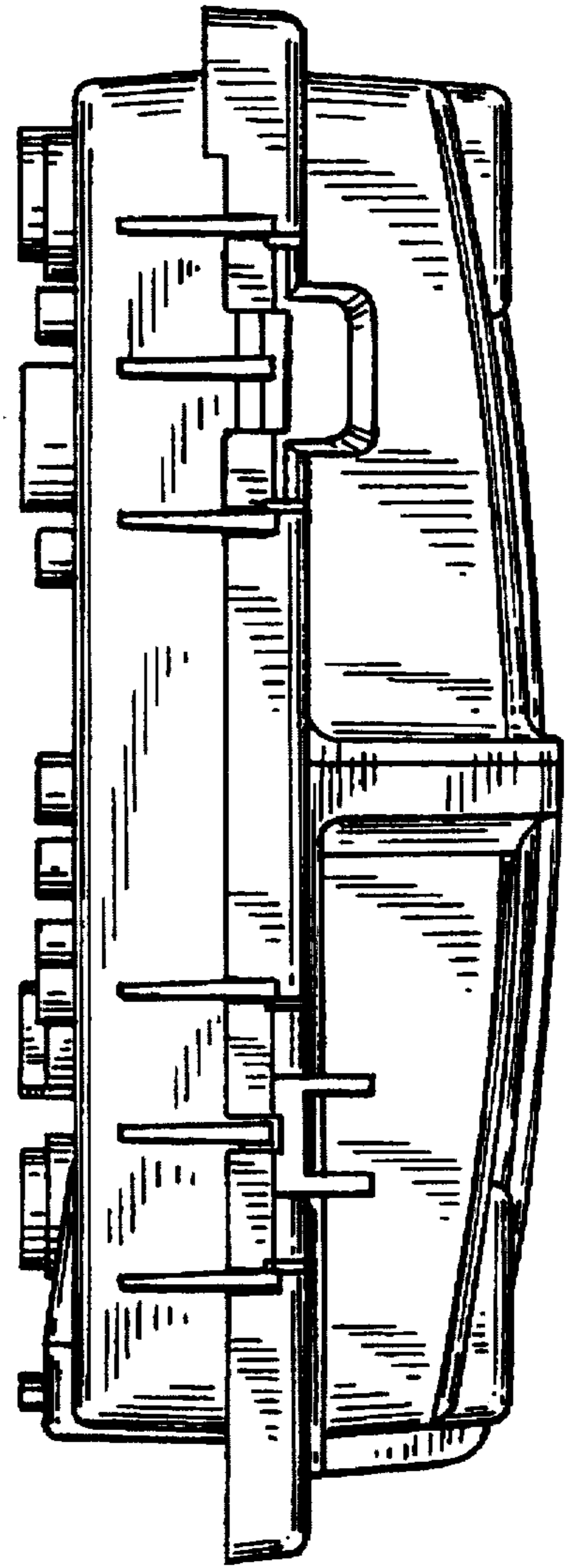
