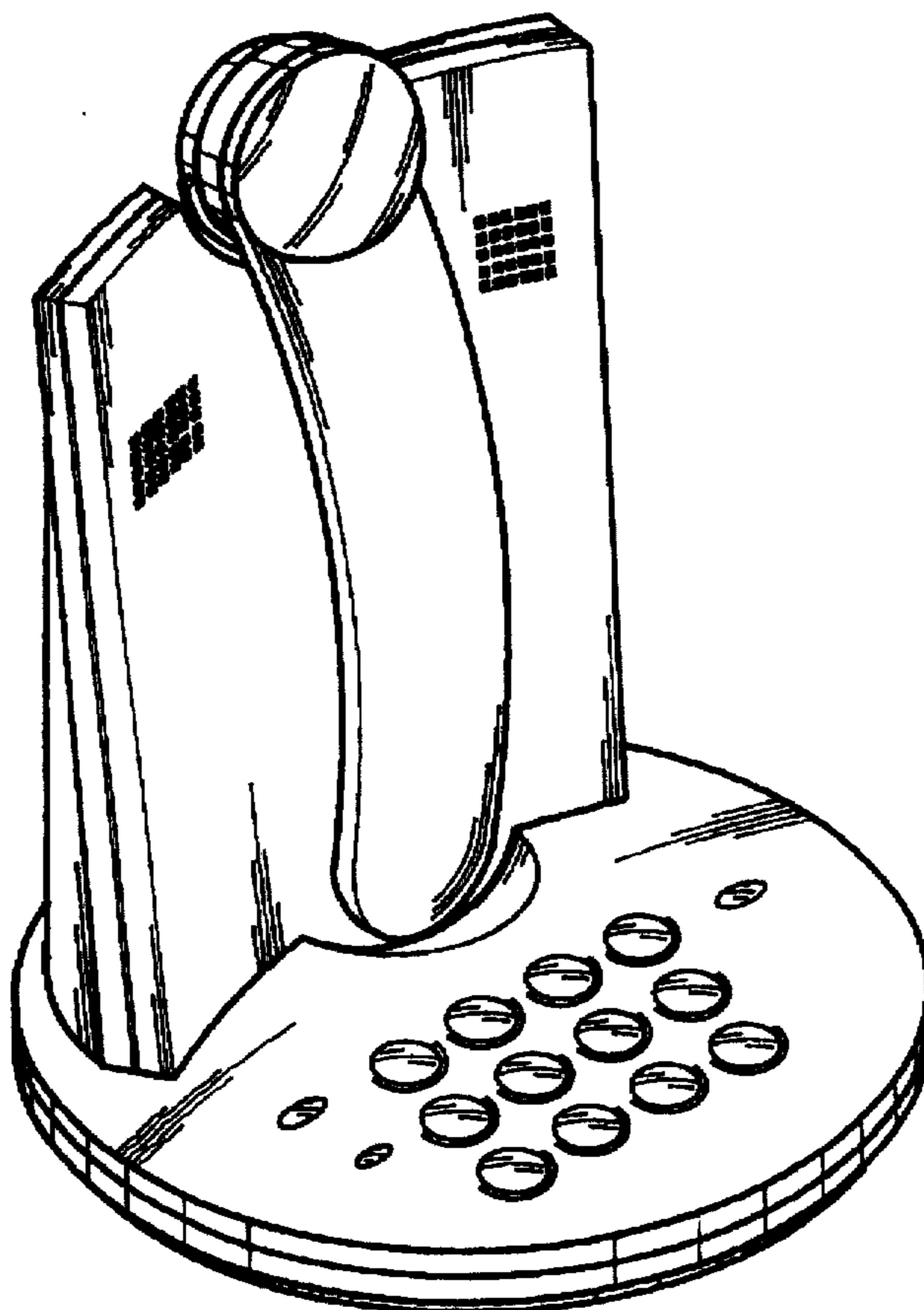
[57] CLAIM

The ornamental design for a telephone, as shown and described.

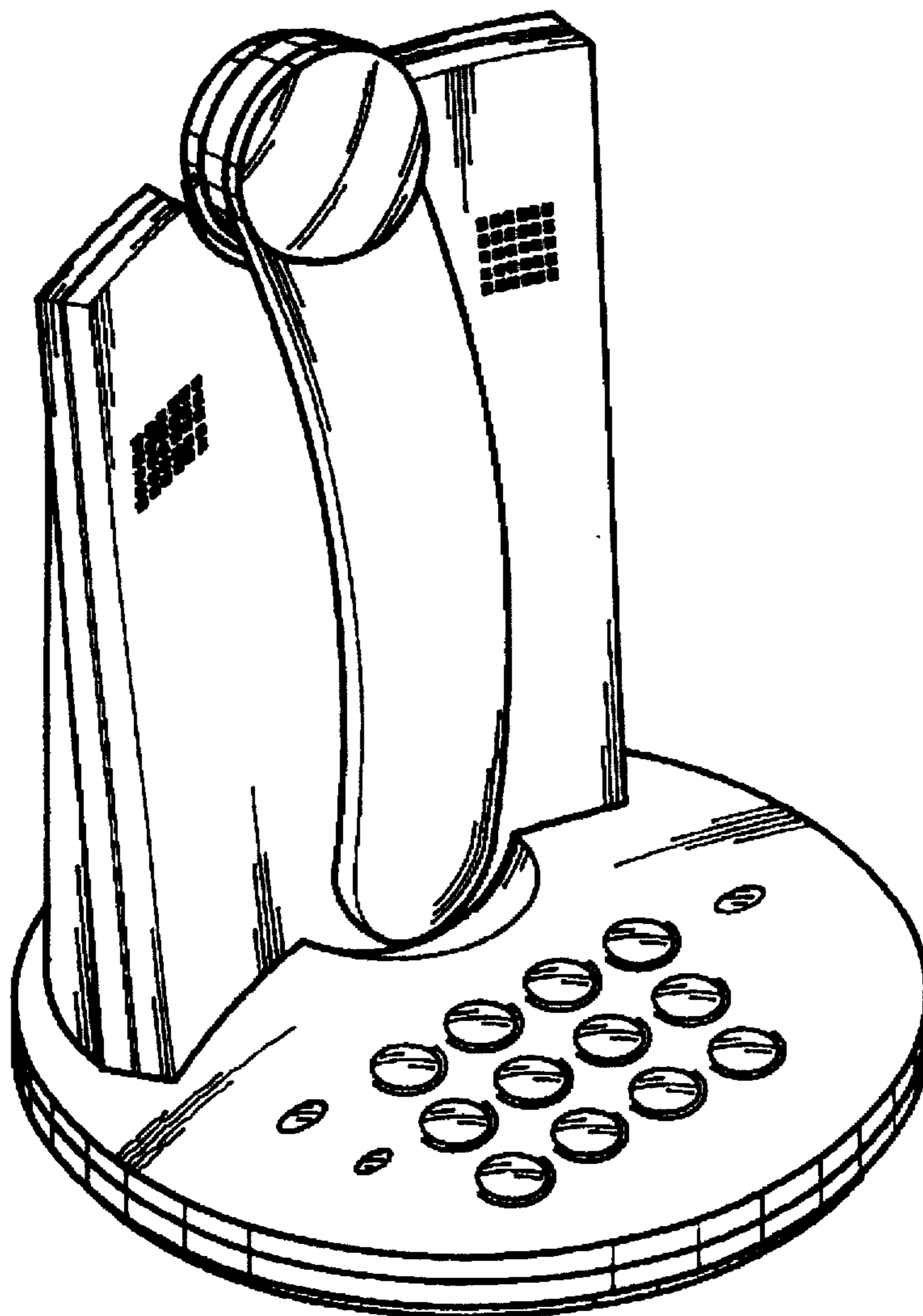
DESCRIPTION

FIG. 1 is a perspective view of a telephone showing my new design;  
FIG. 2 is a top plan view thereof;

FIG. 6 is a right side elevational view thereof, which is symmetrical to a left side elevational view not shown herein.

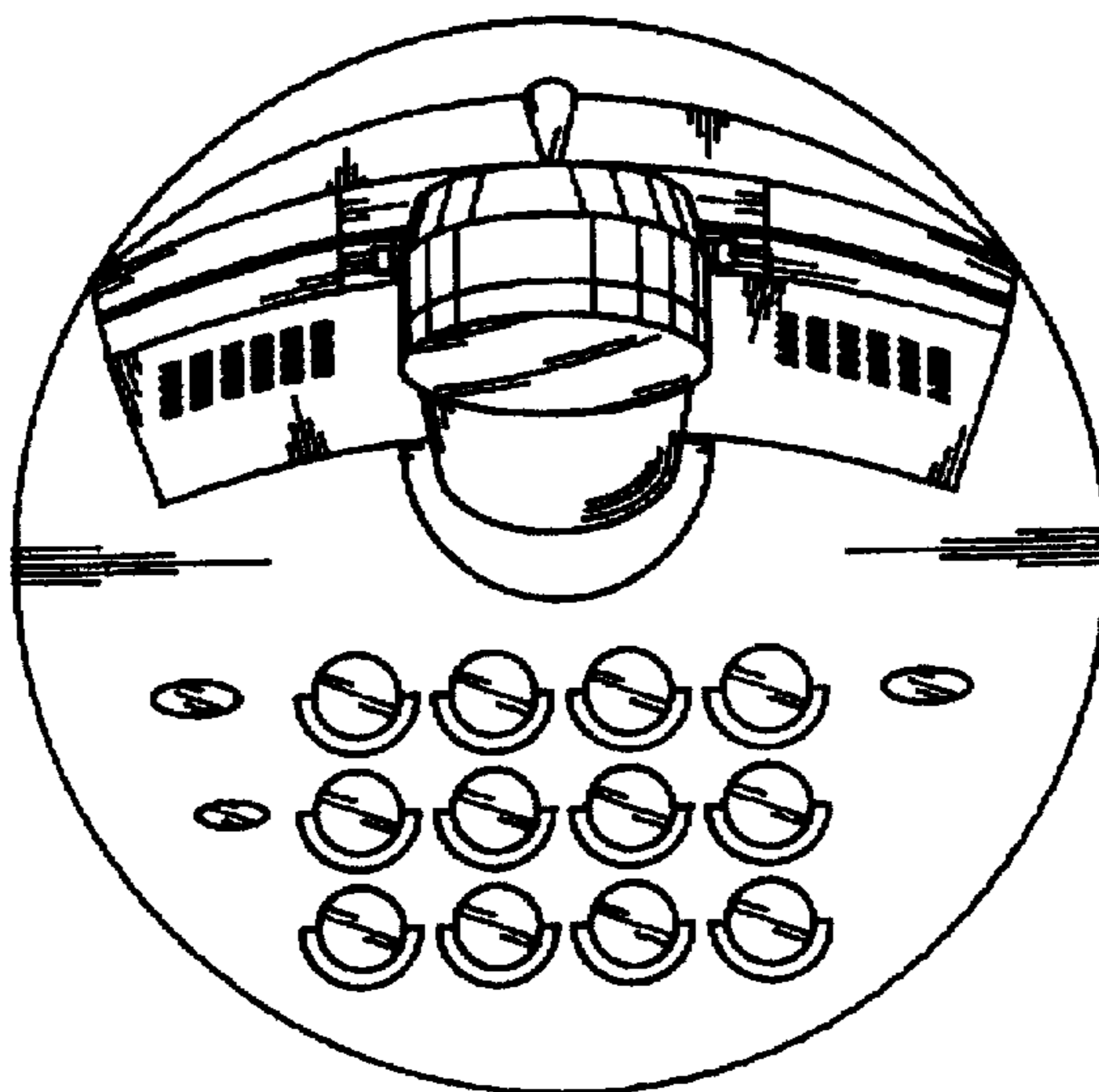

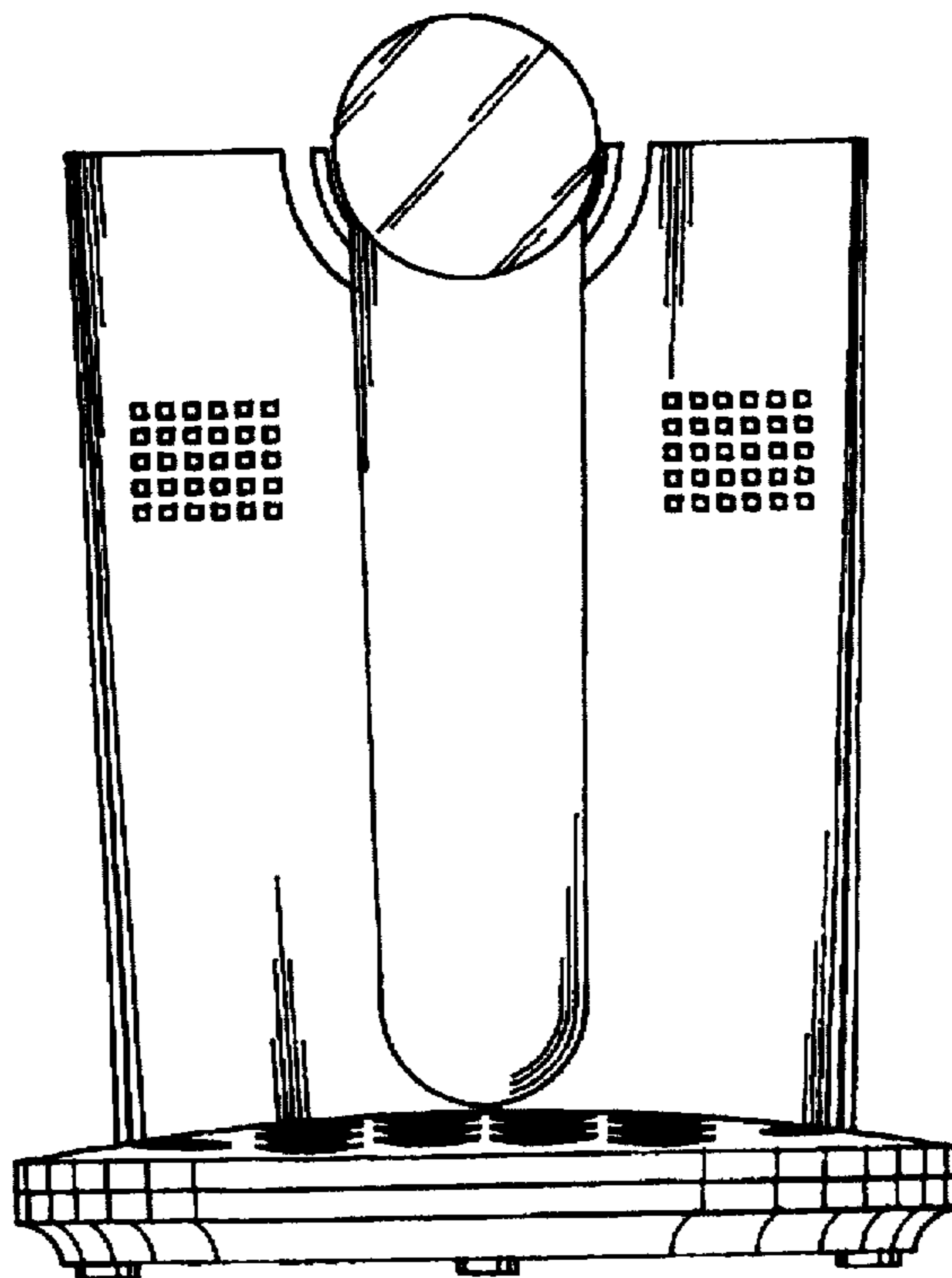

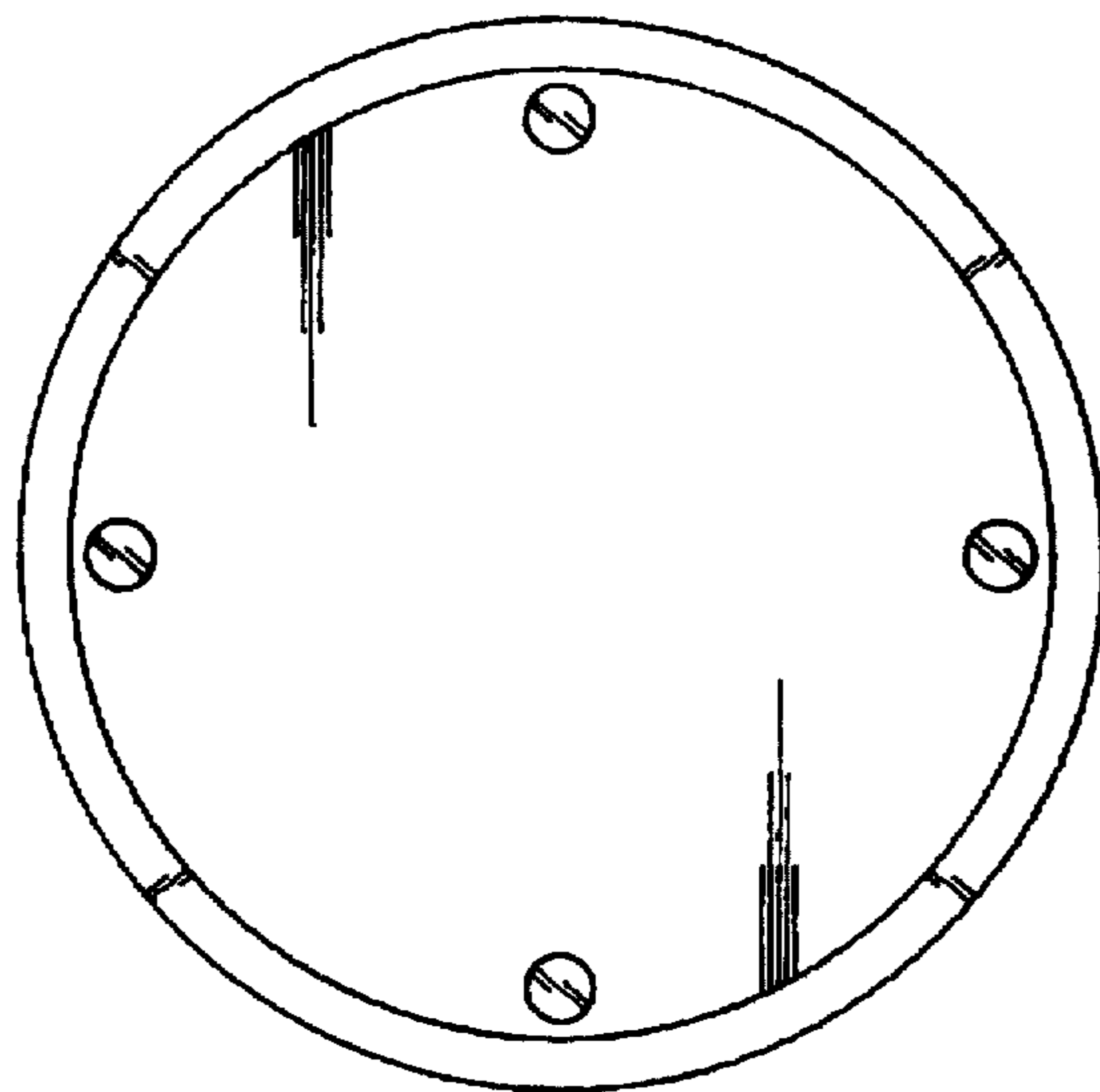

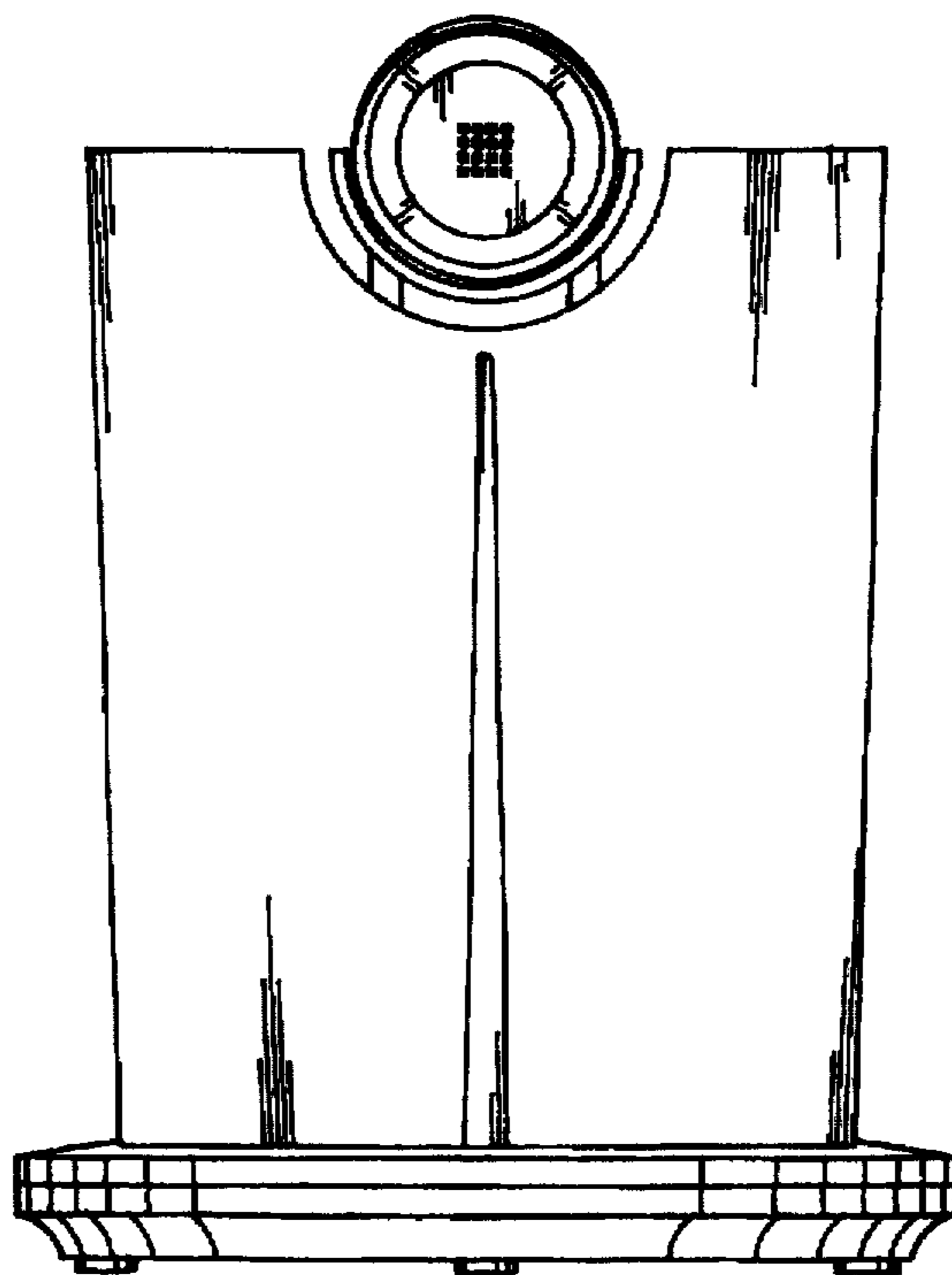
