FIG. 4 is a top plan view of FIG. 1;

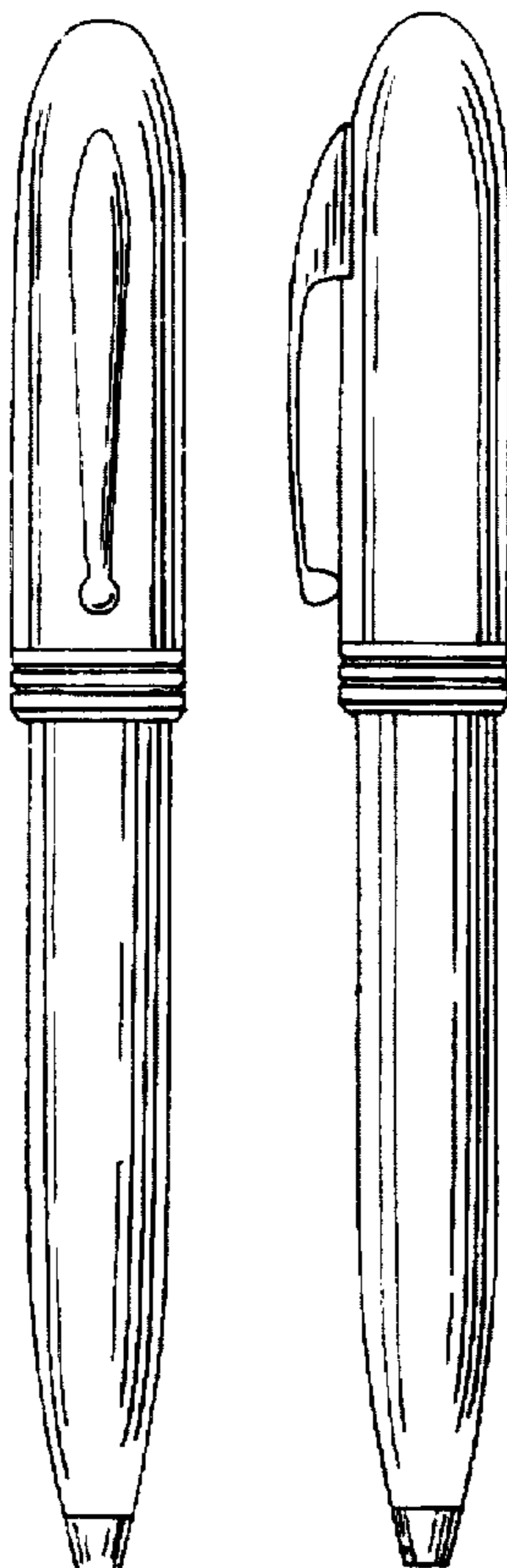
FIG. 5 is a front elevational view of a second embodiment of our new design in the form of a fountain pen;

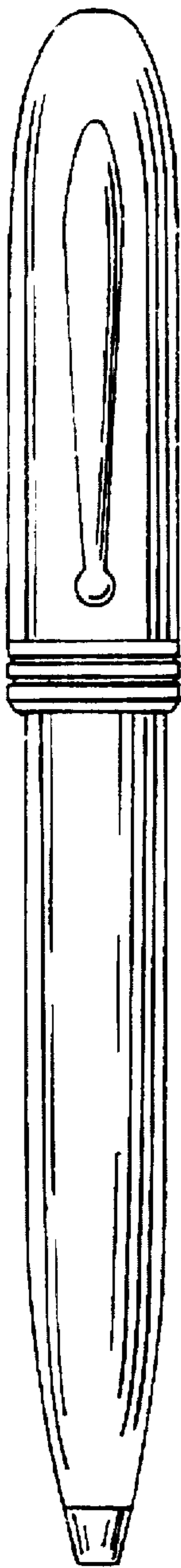

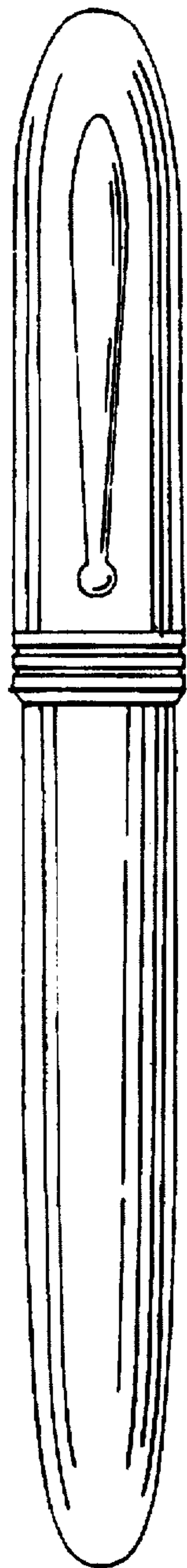

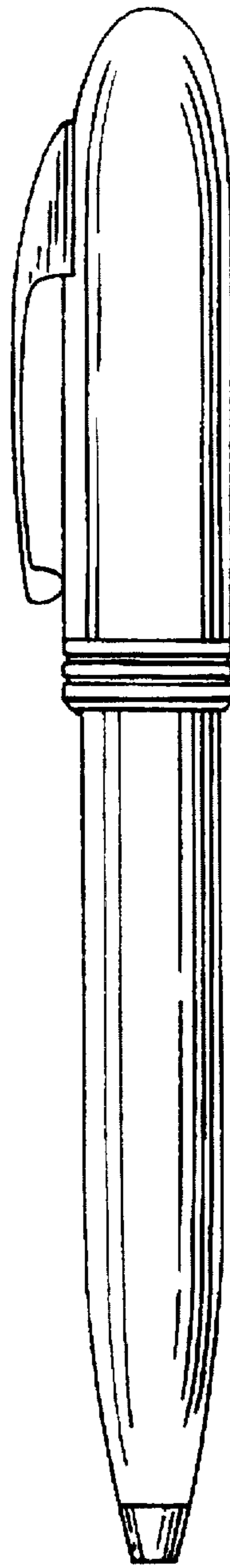

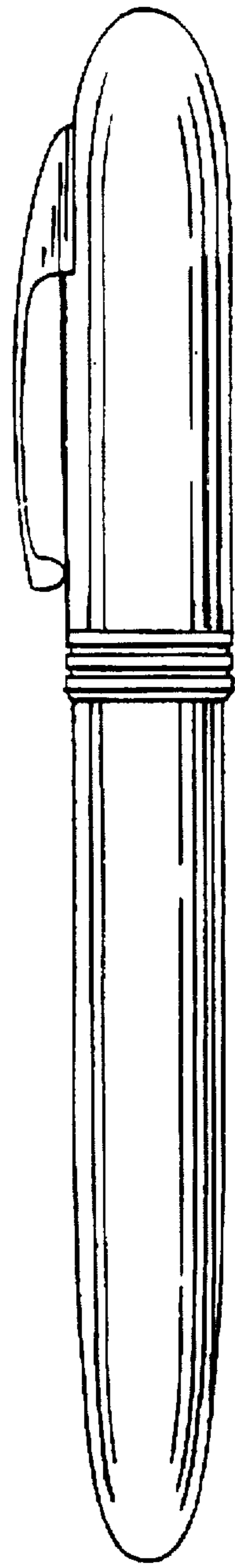

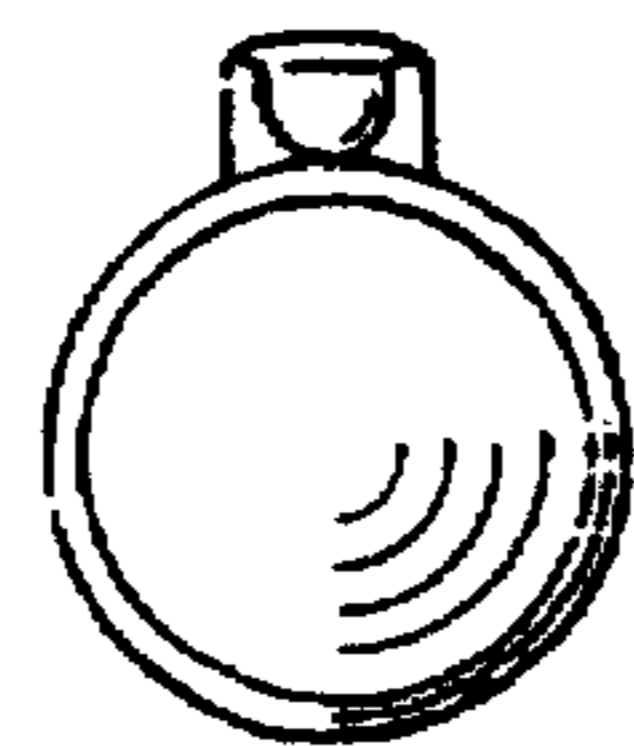

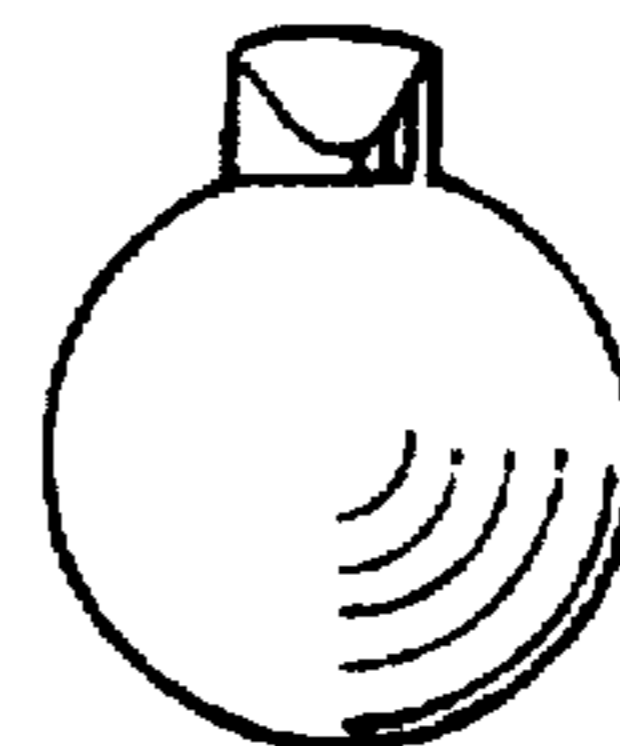
