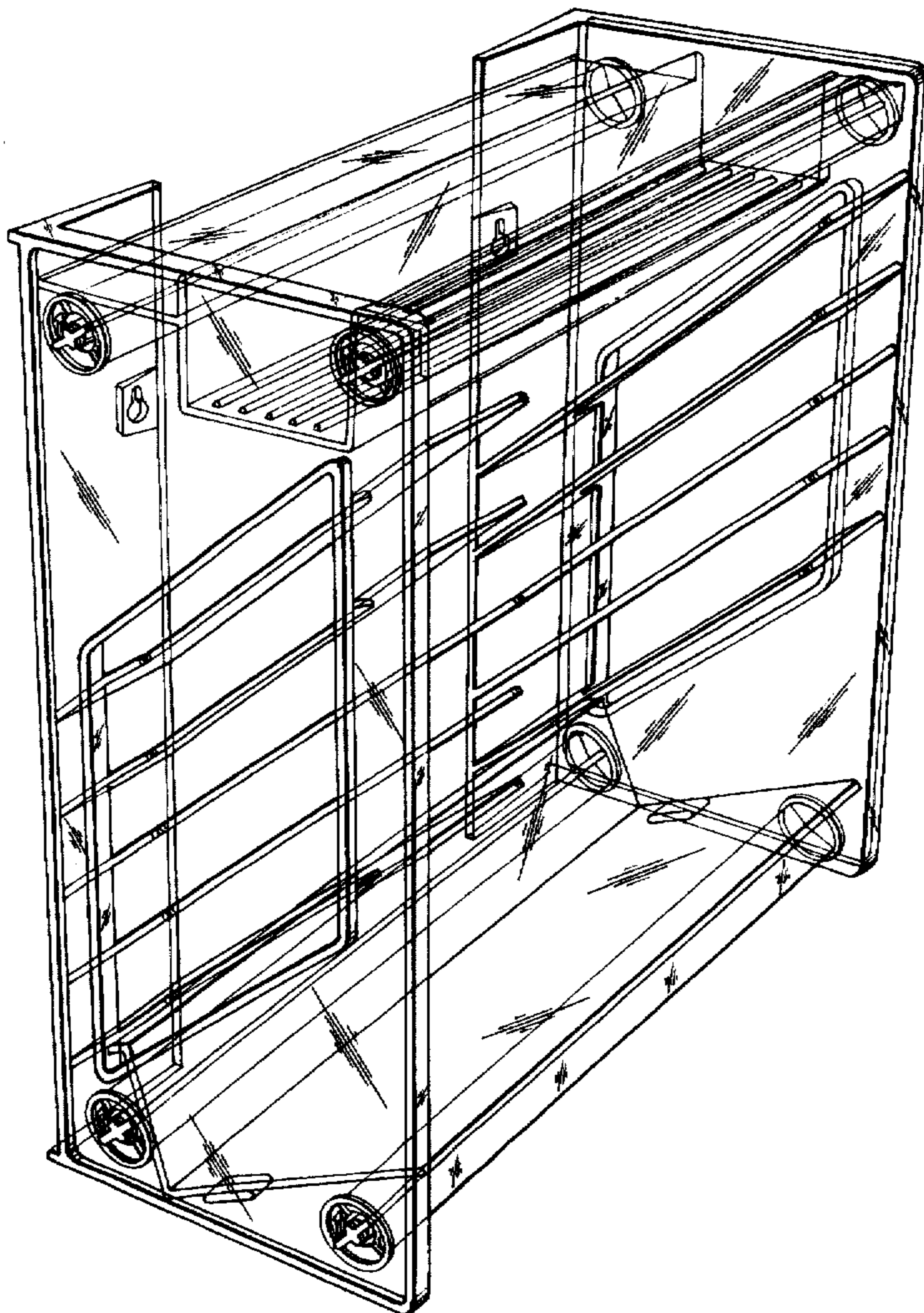
[57] **CLAIM**

The ornamental design for a file folder organizer rack, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a file folder organizer rack showing my new design;  
FIG. 1 is a top plan view thereof;

FIG. 4 is a right side view thereof, the left side view being a mirror image;

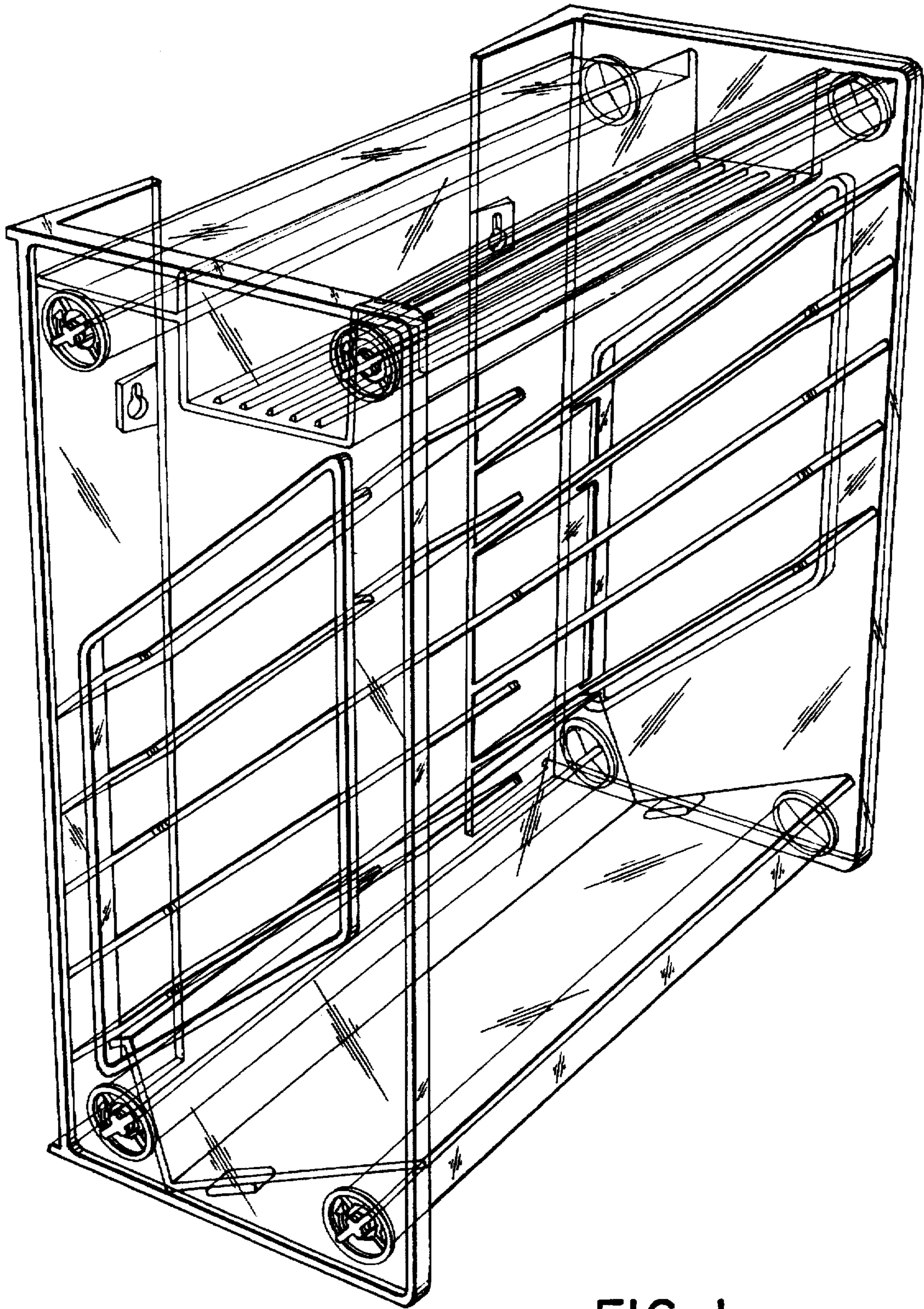

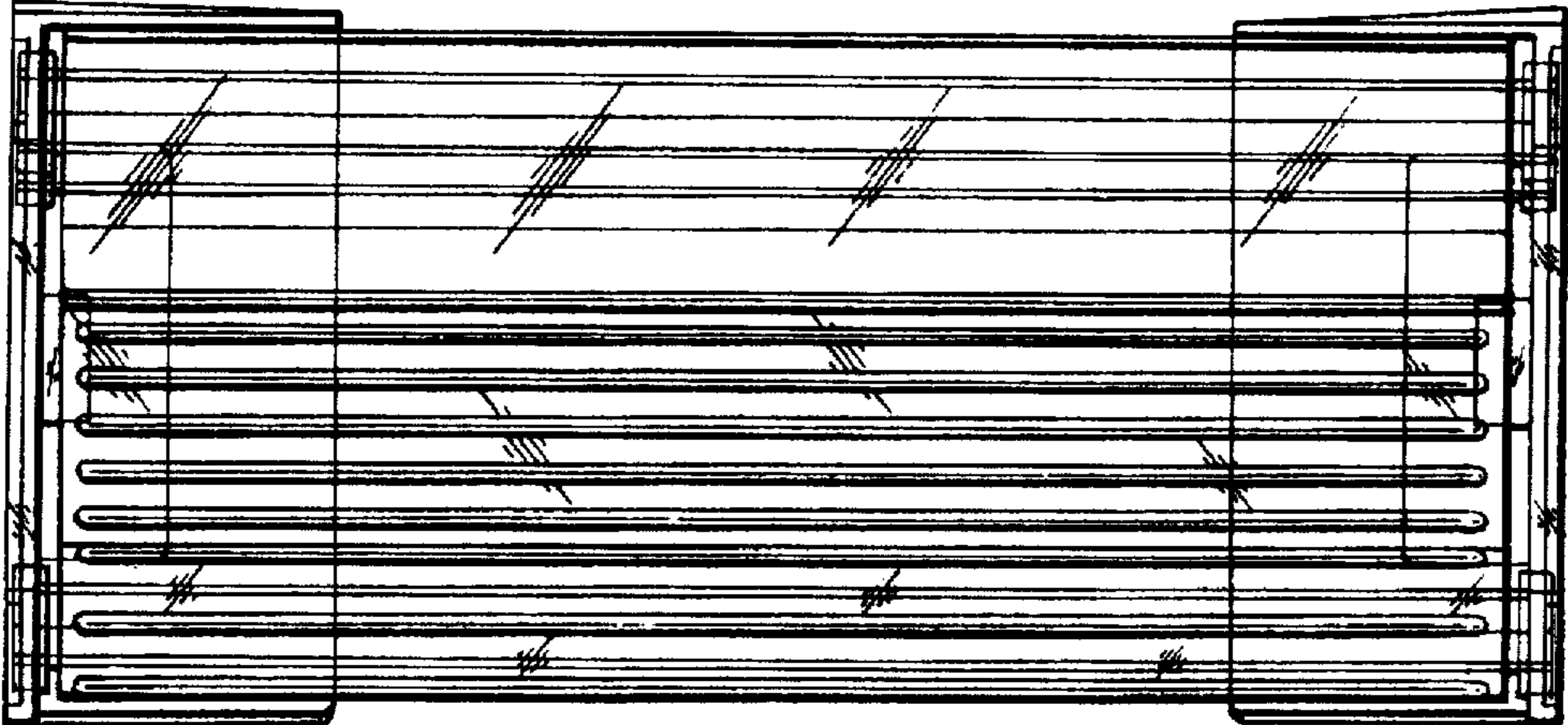

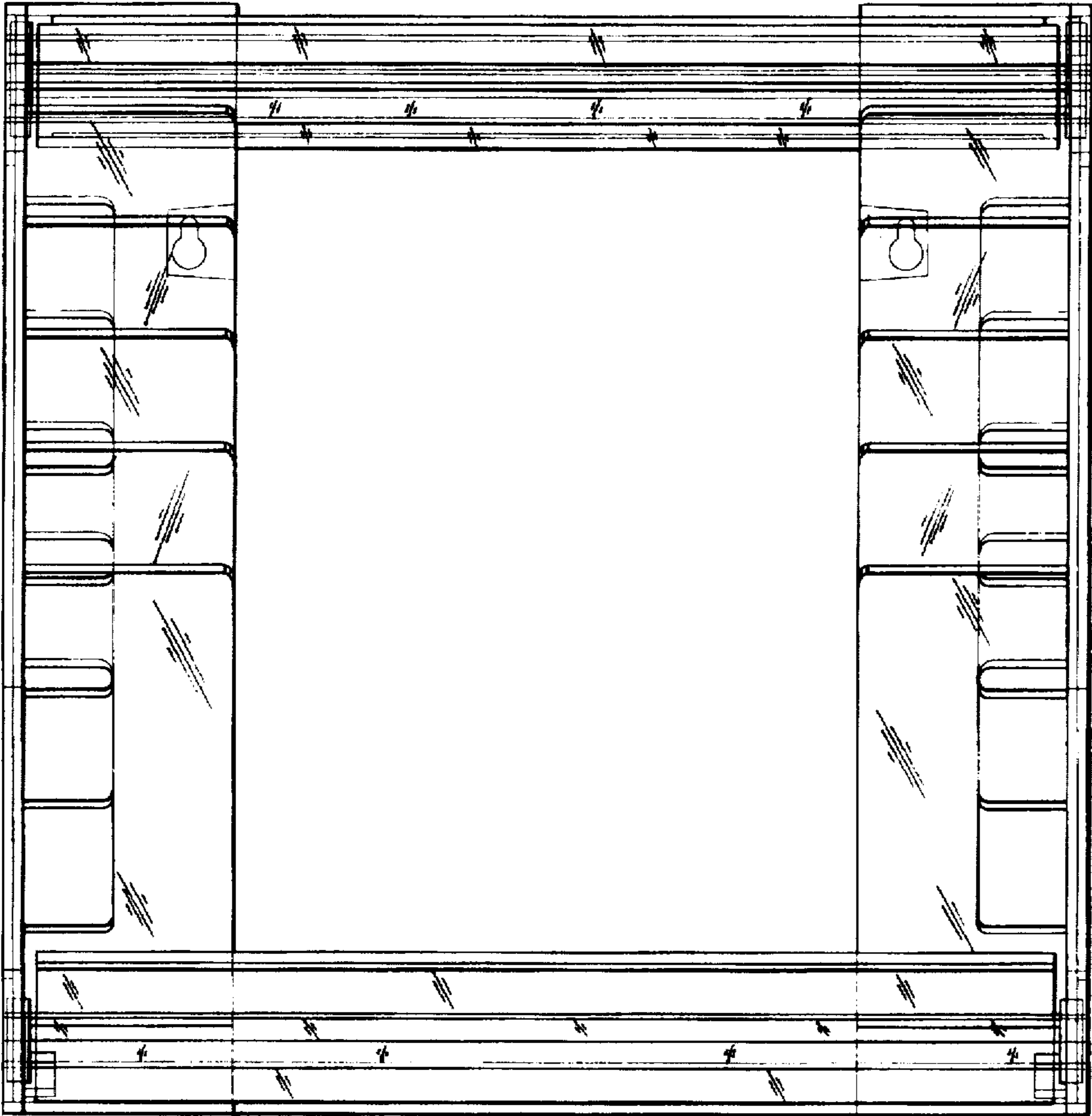

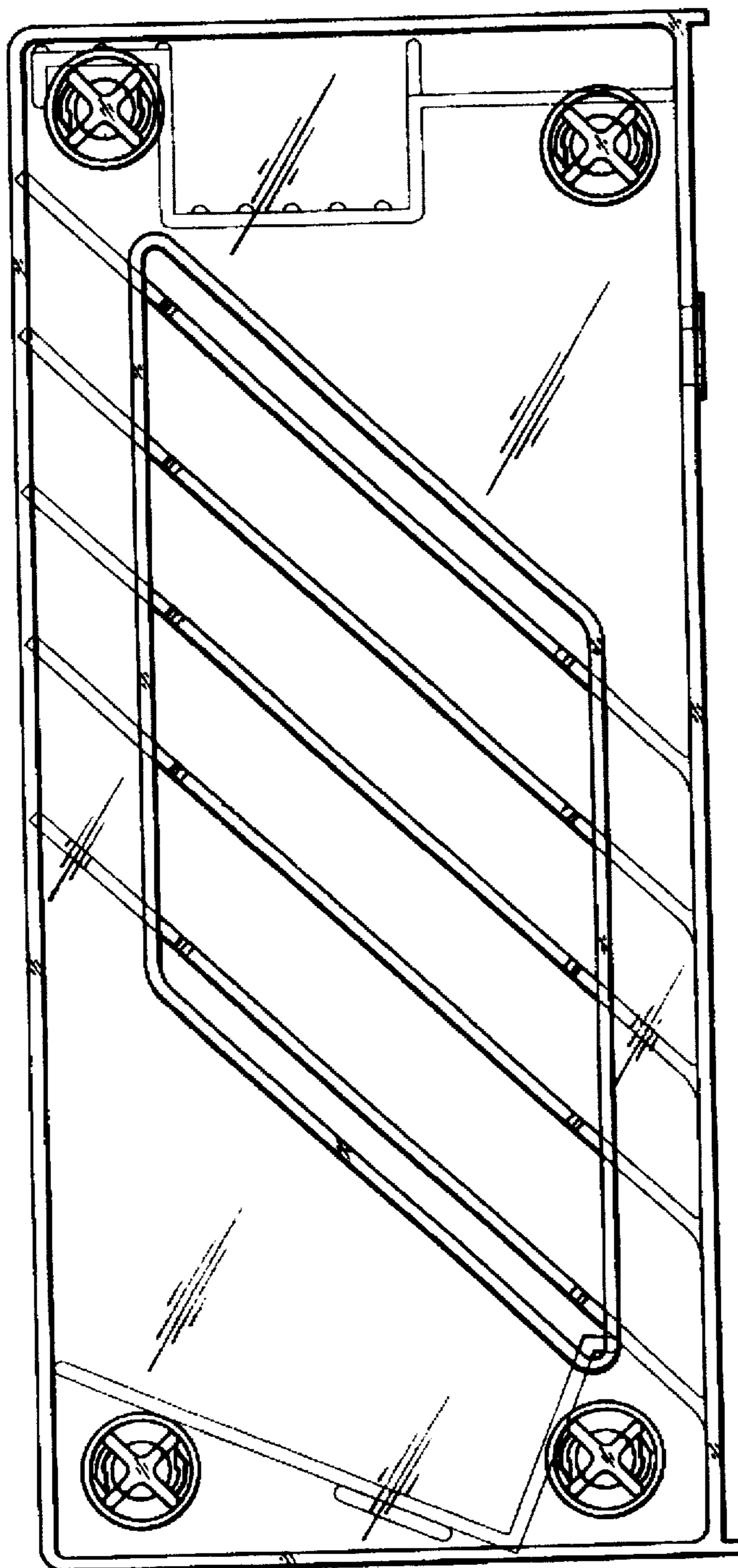

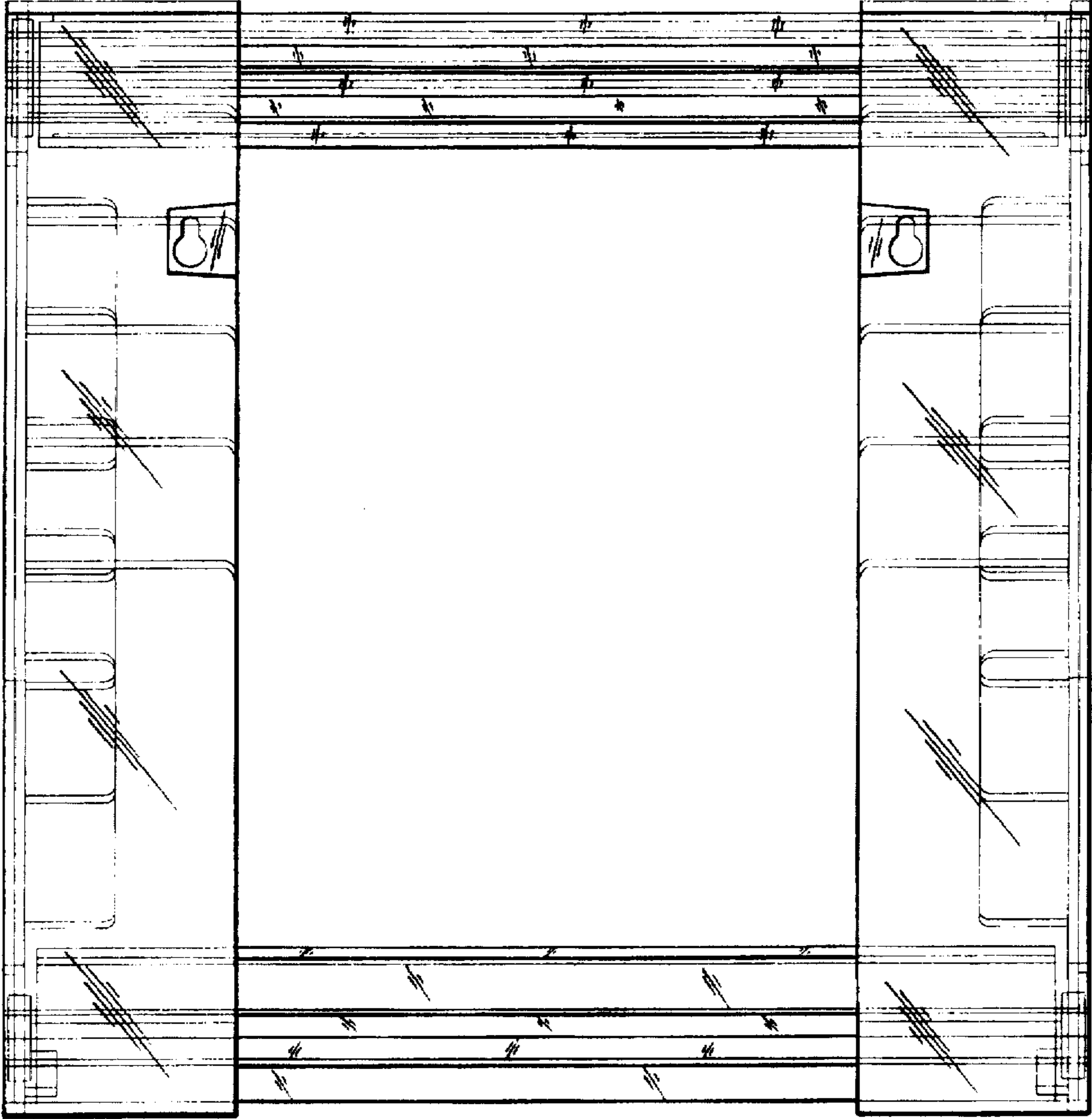

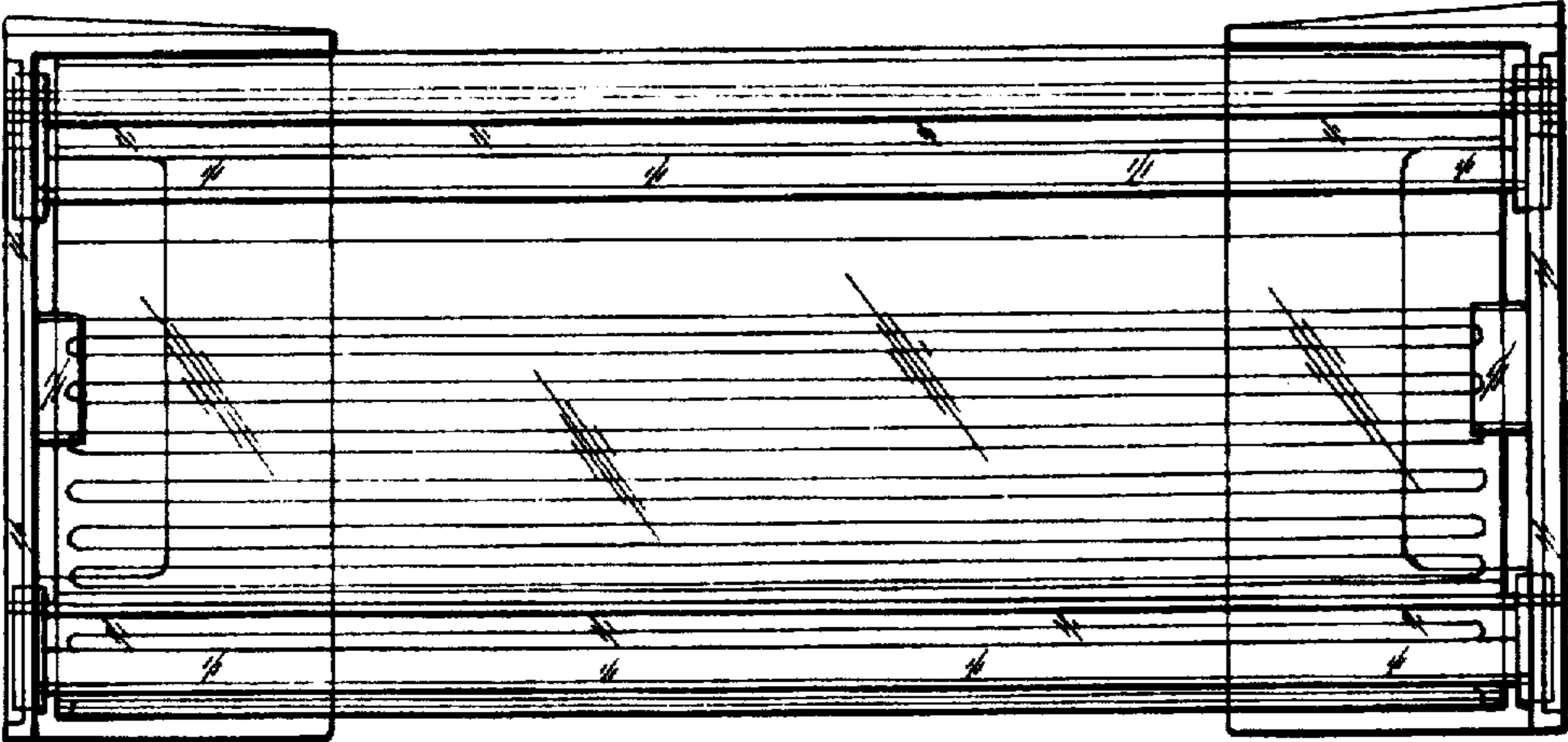
