The ornamental design for a toy musical keyboard, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left front perspective view of a toy musical keyboard showing my new design;

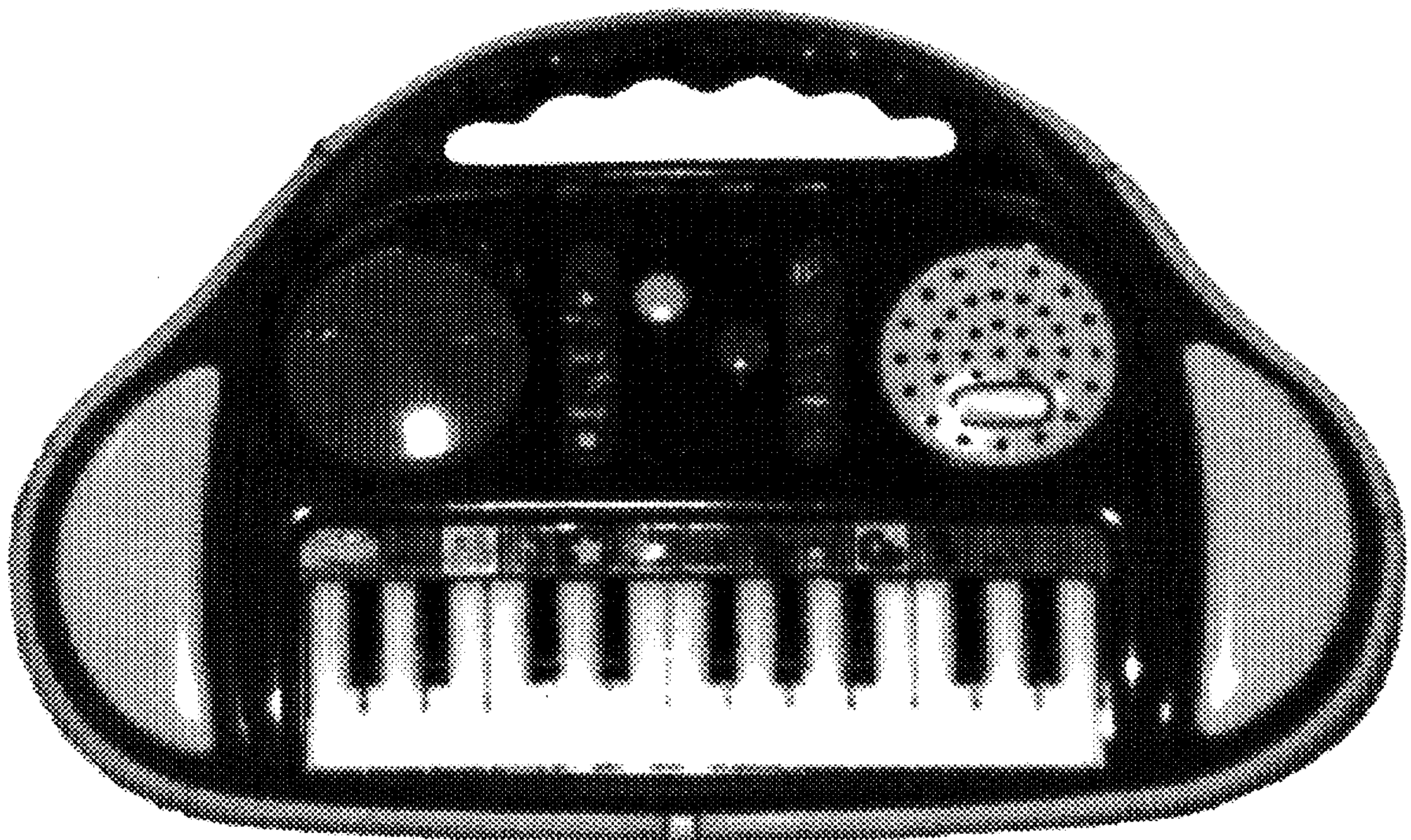

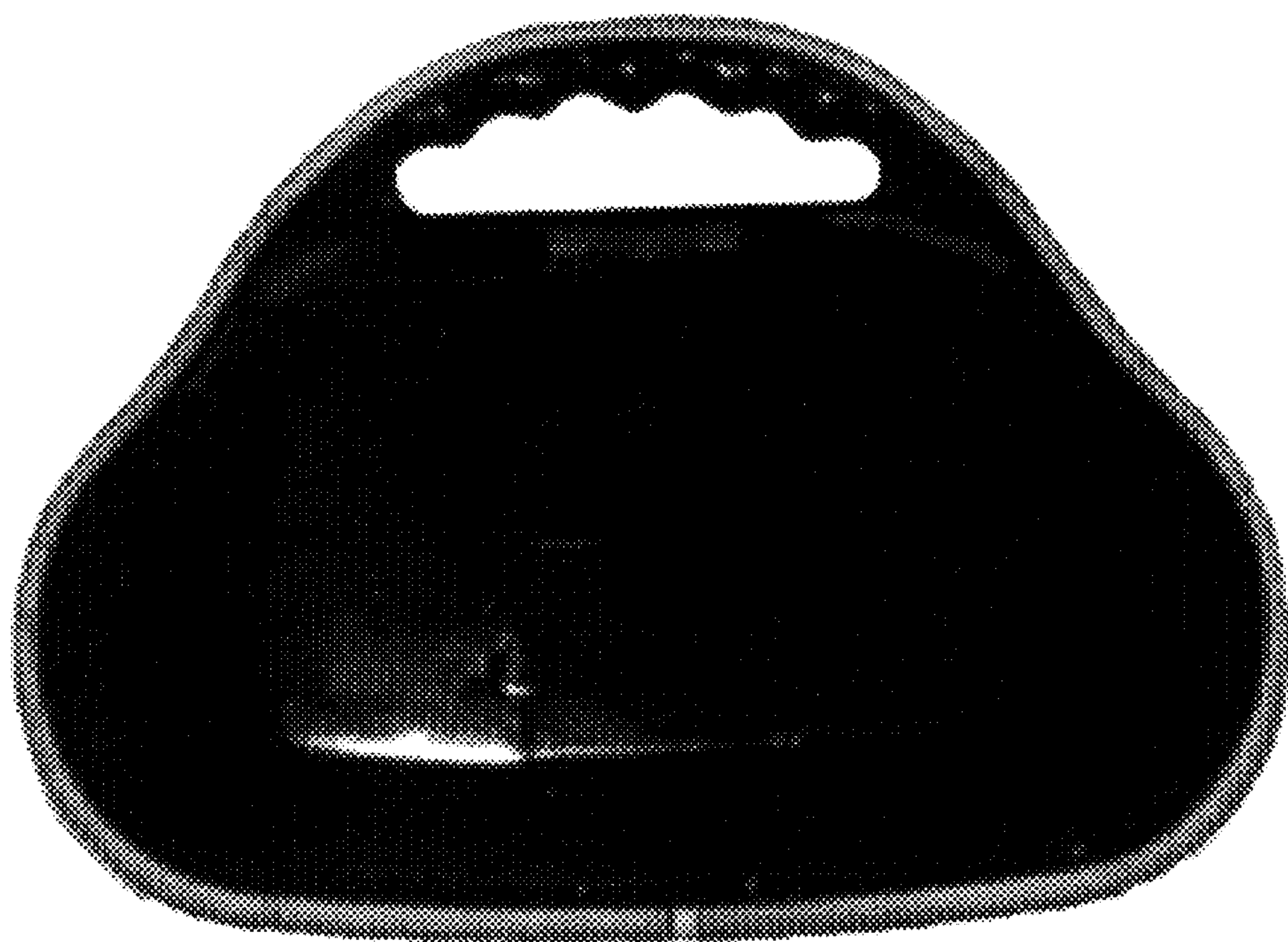

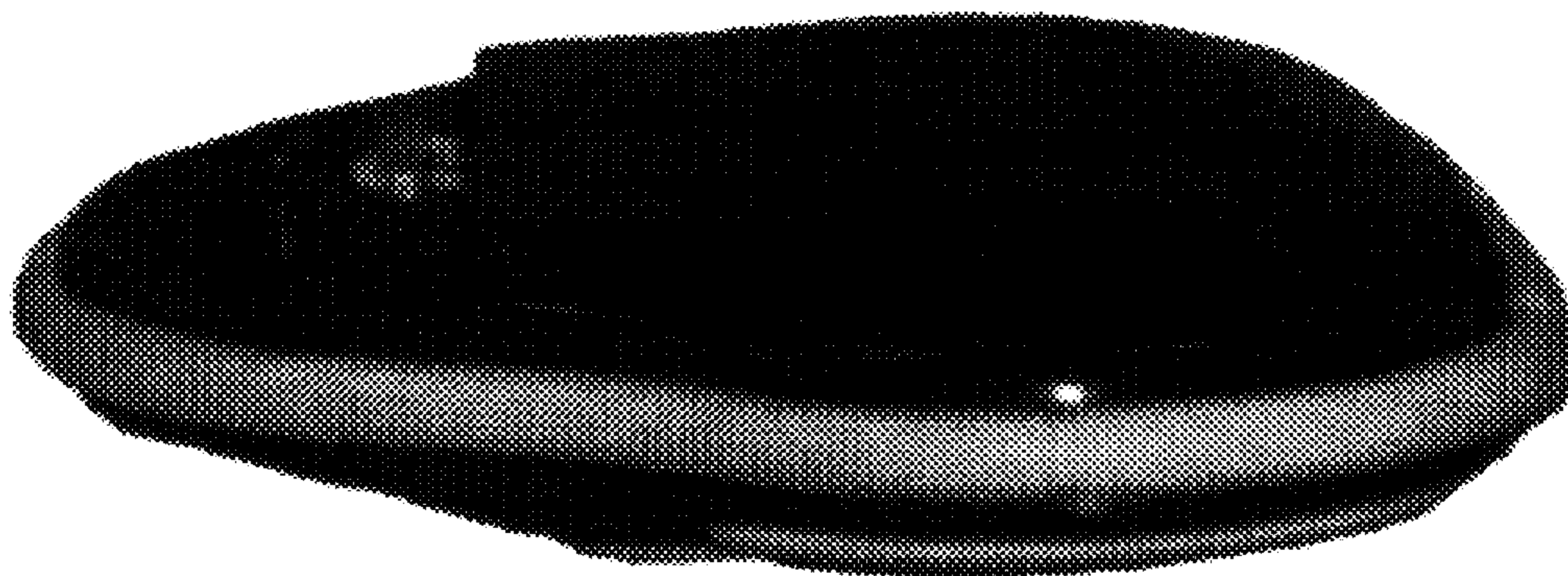

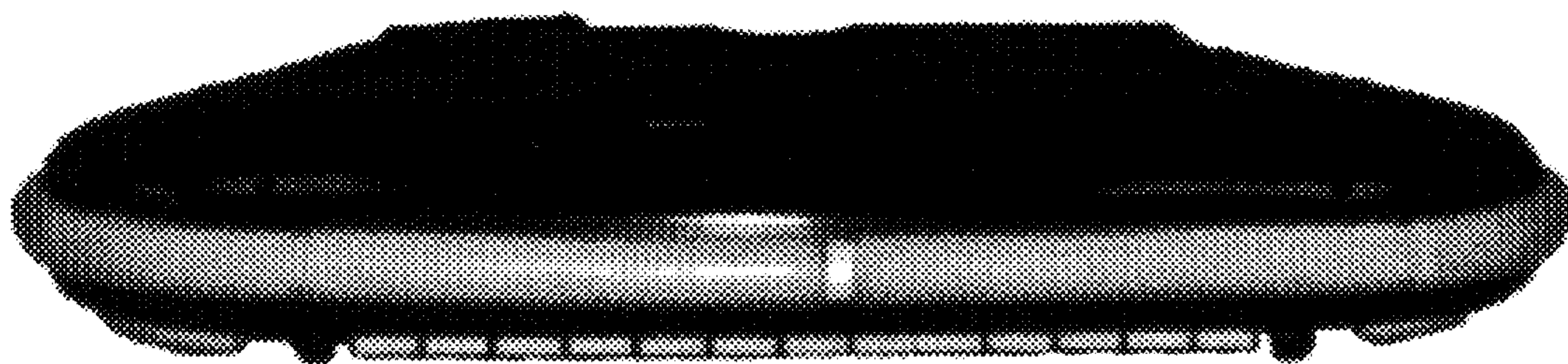
