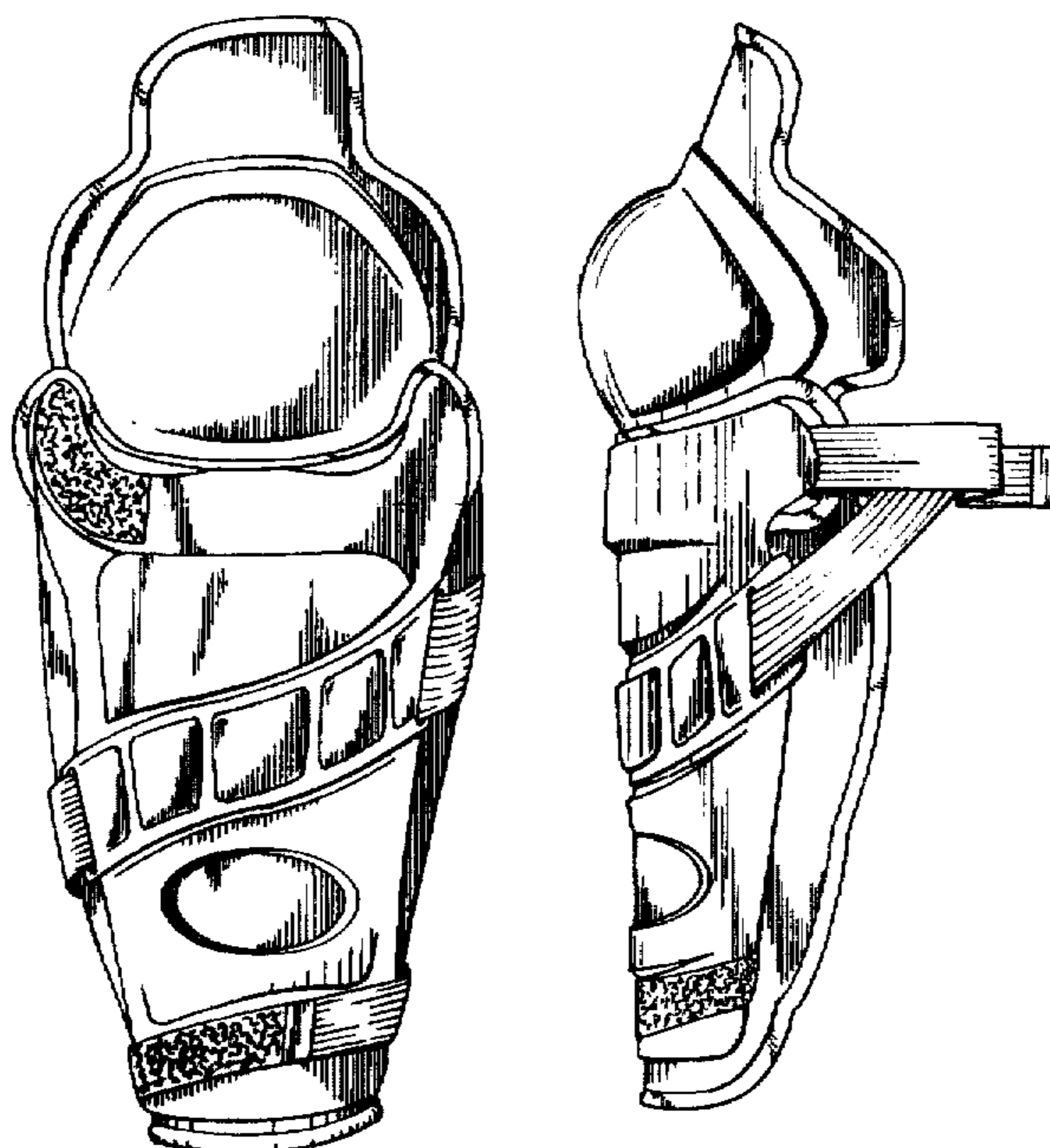
[57] **CLAIM**

The ornamental design for protective shin guards, as shown and described.

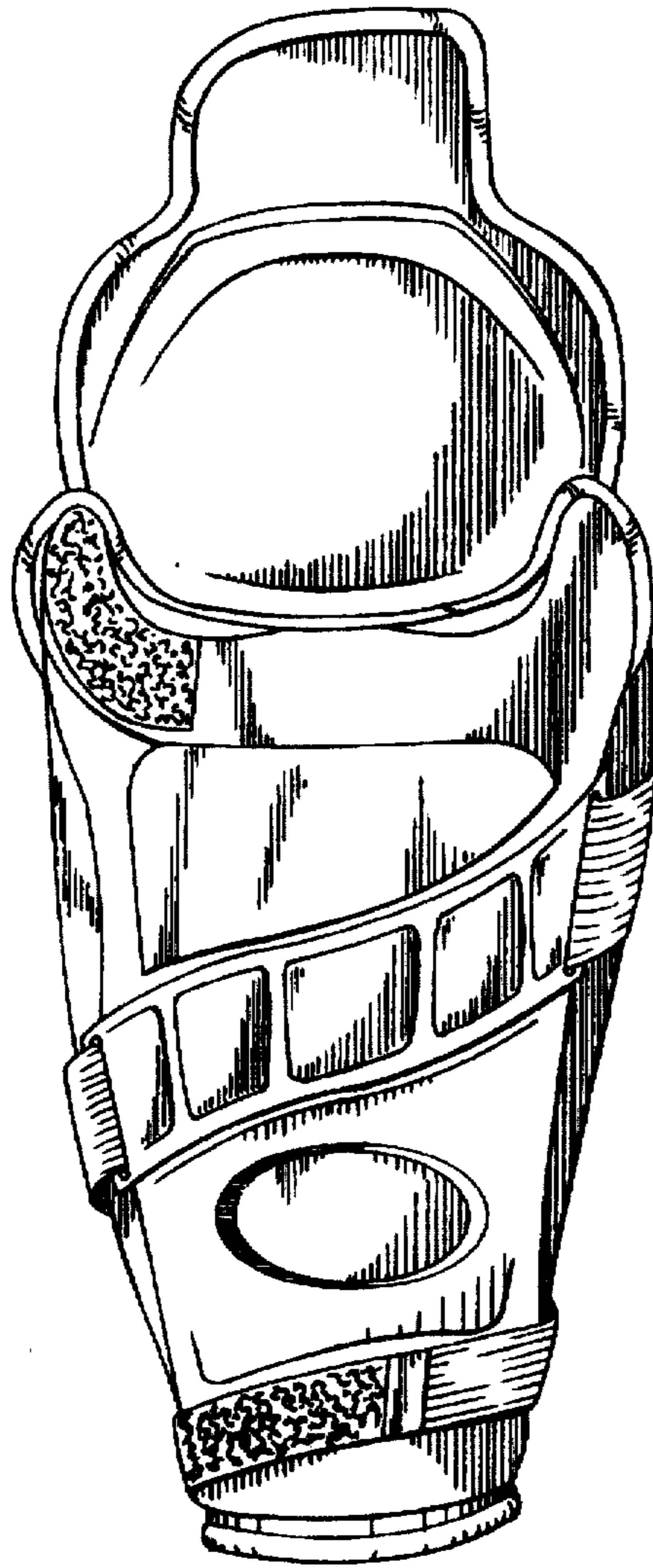
### DESCRIPTION

FIG. 6 is a bottom view thereof.

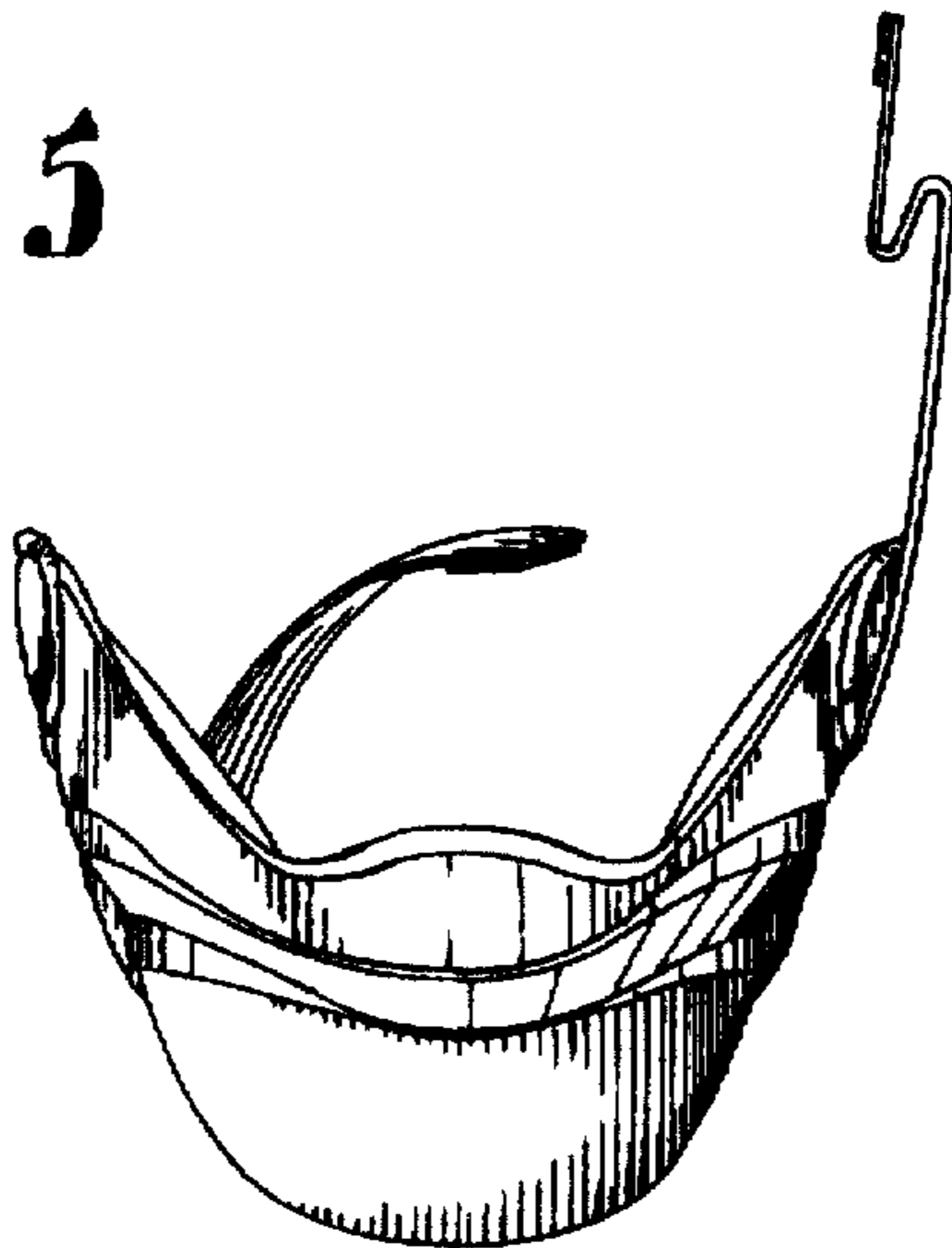

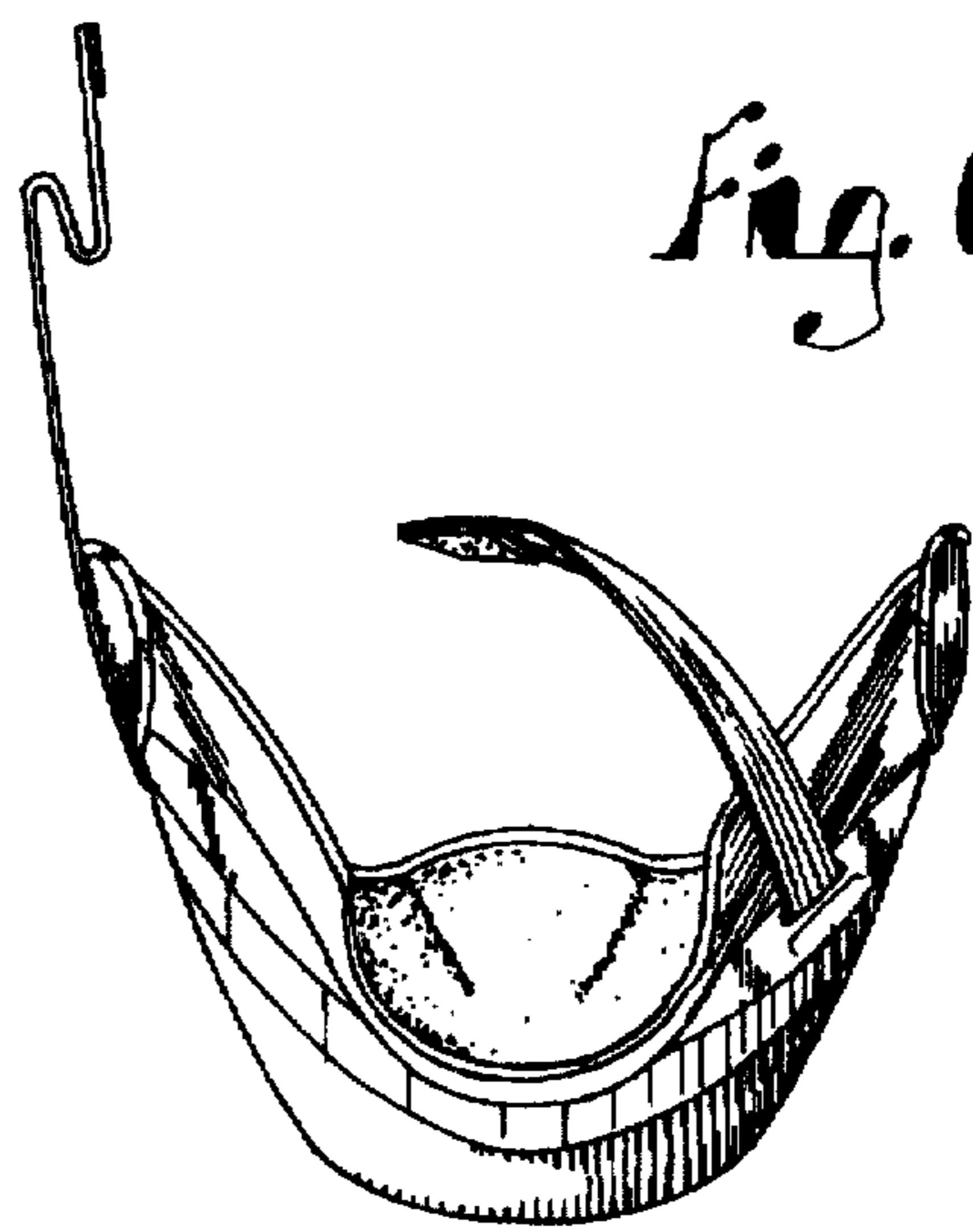

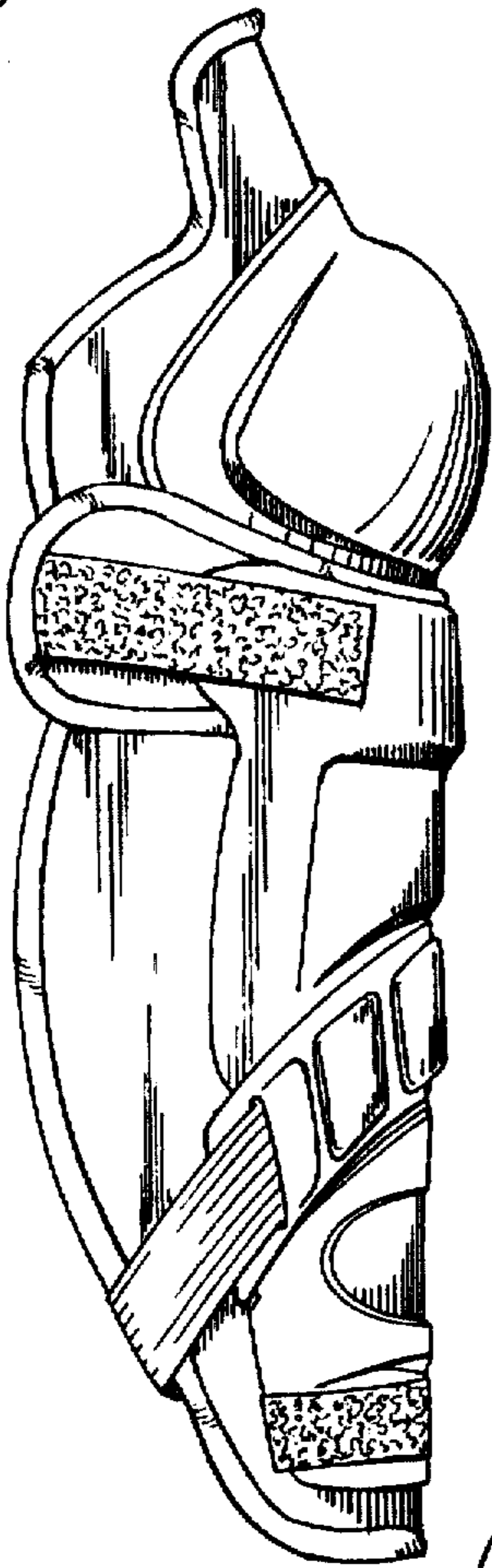

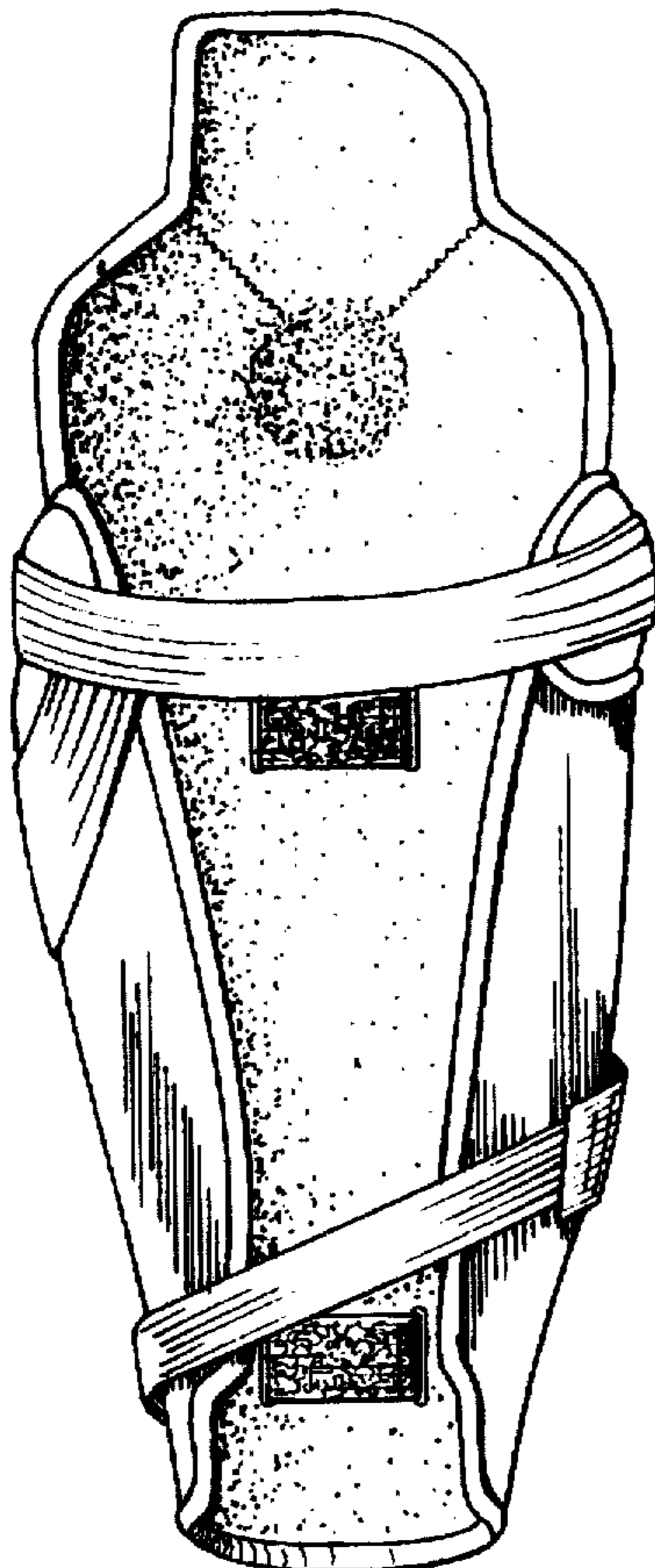
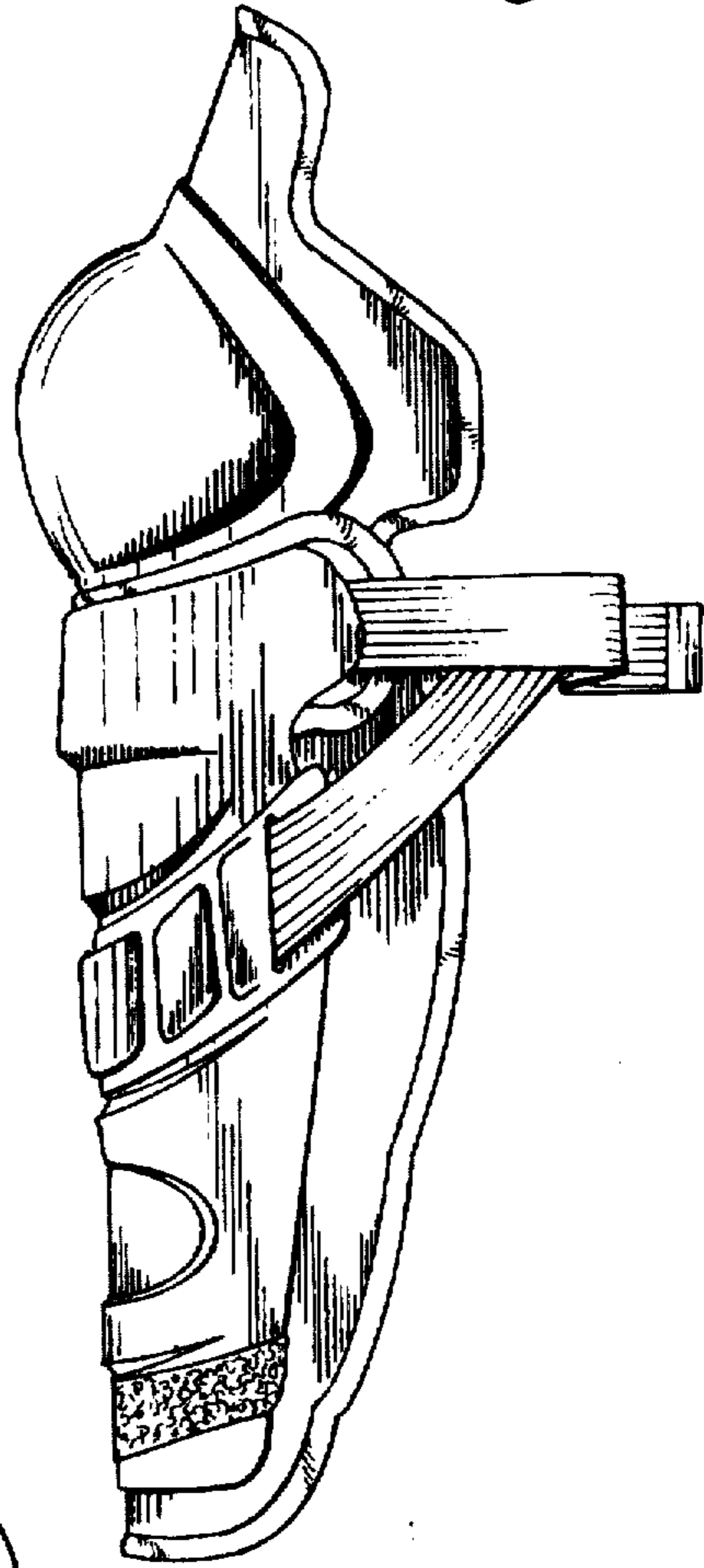
