The ornamental design for a travel steam iron, as shown and described.

DESCRIPTION

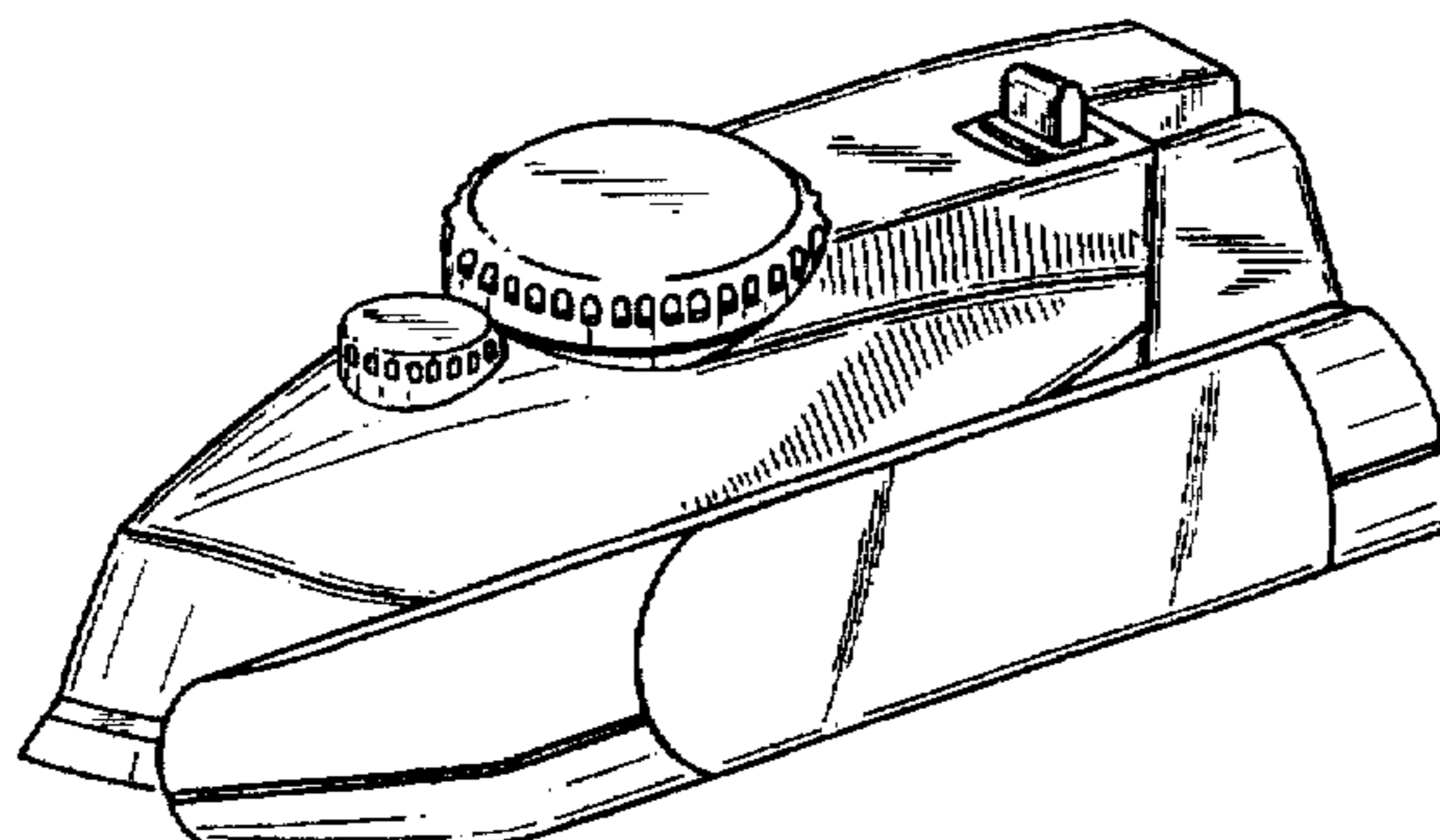
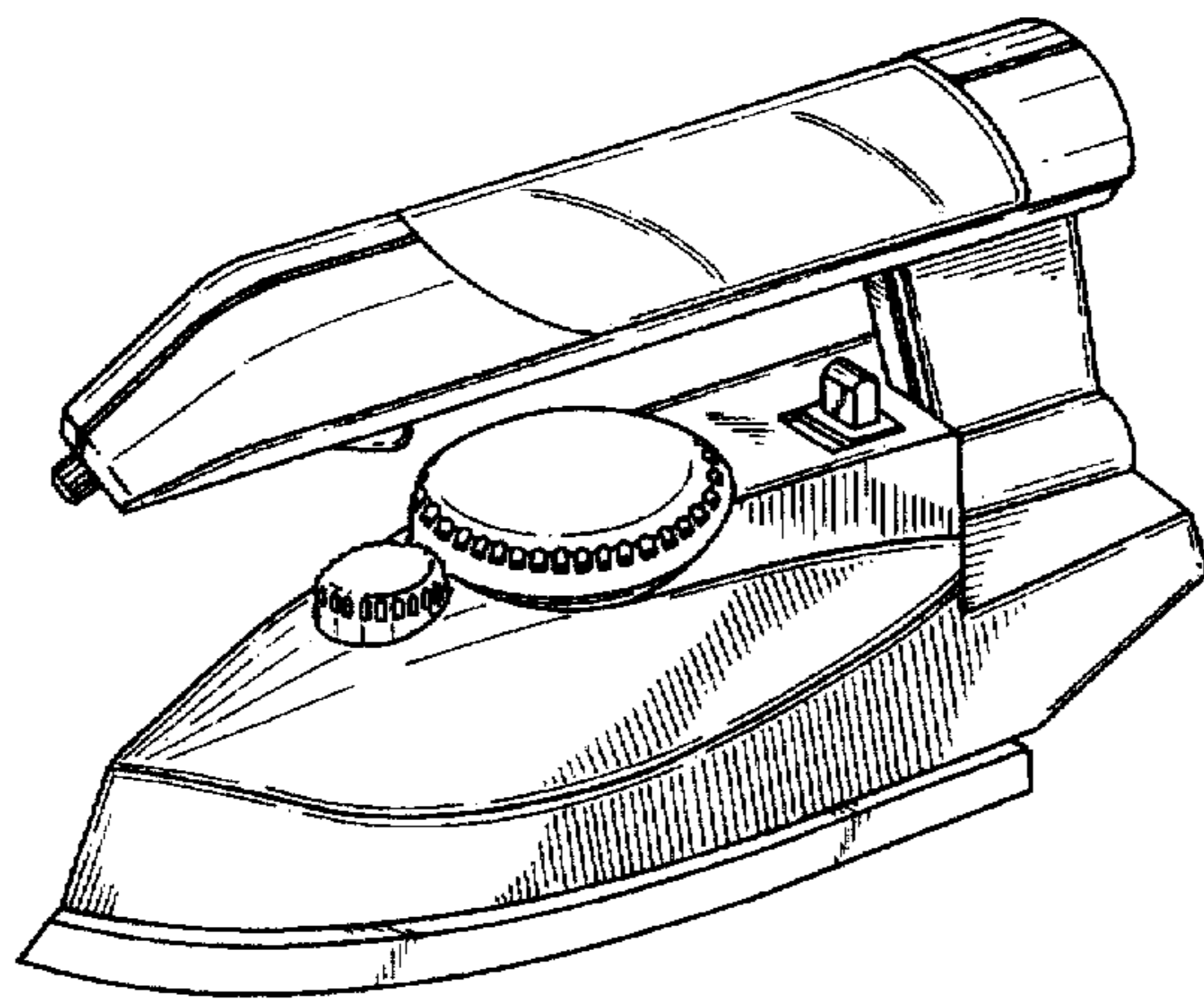

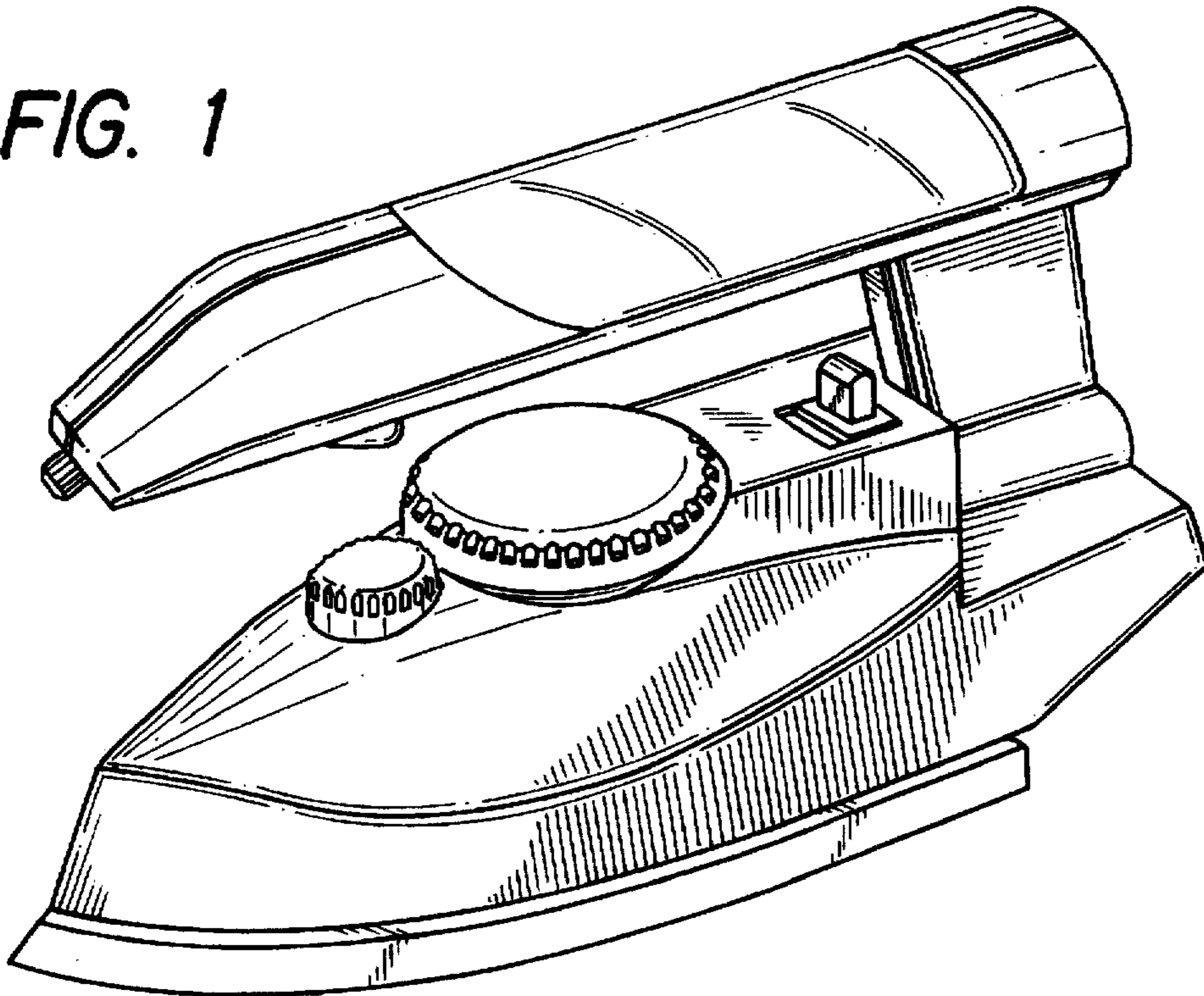

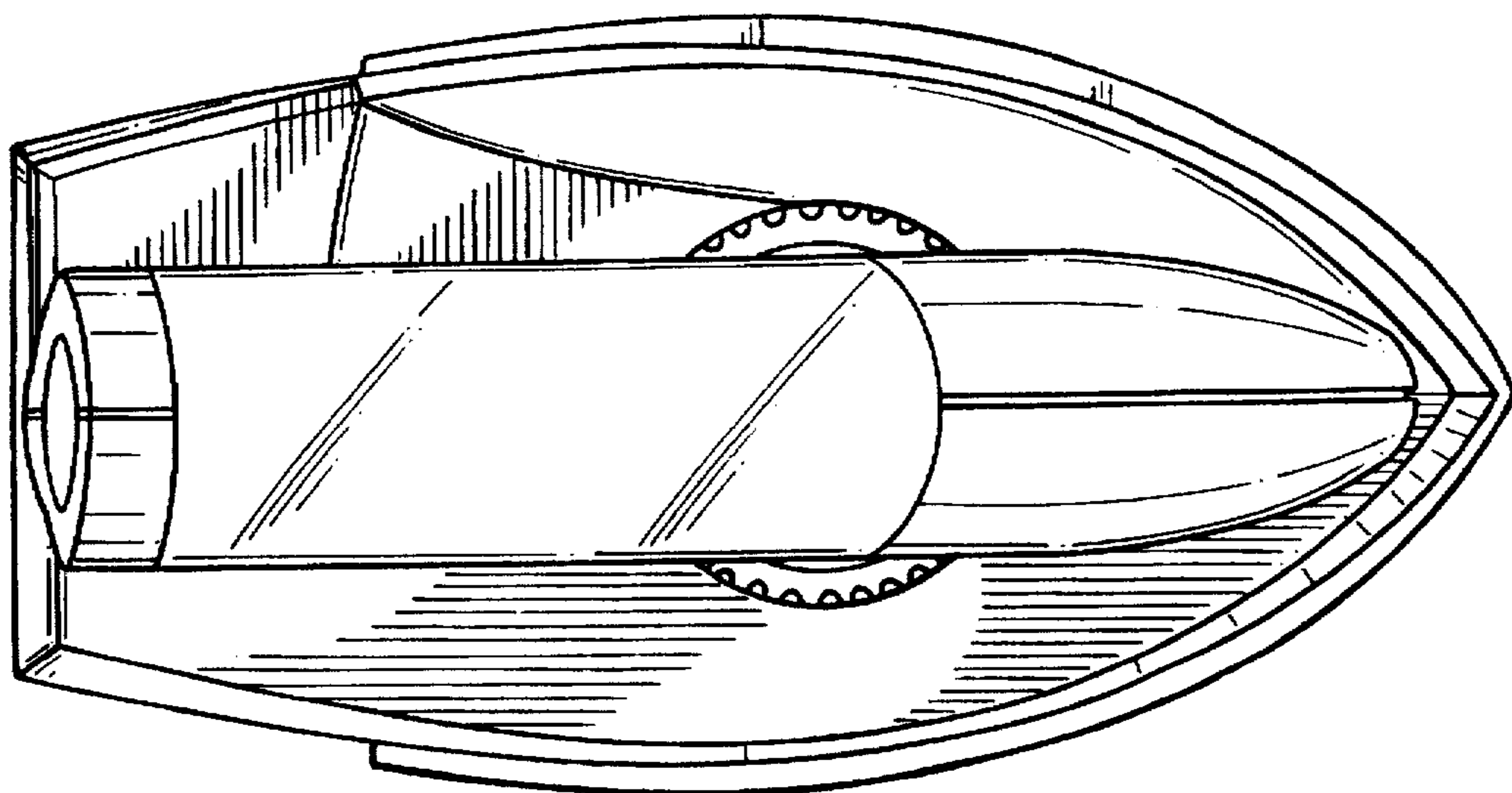

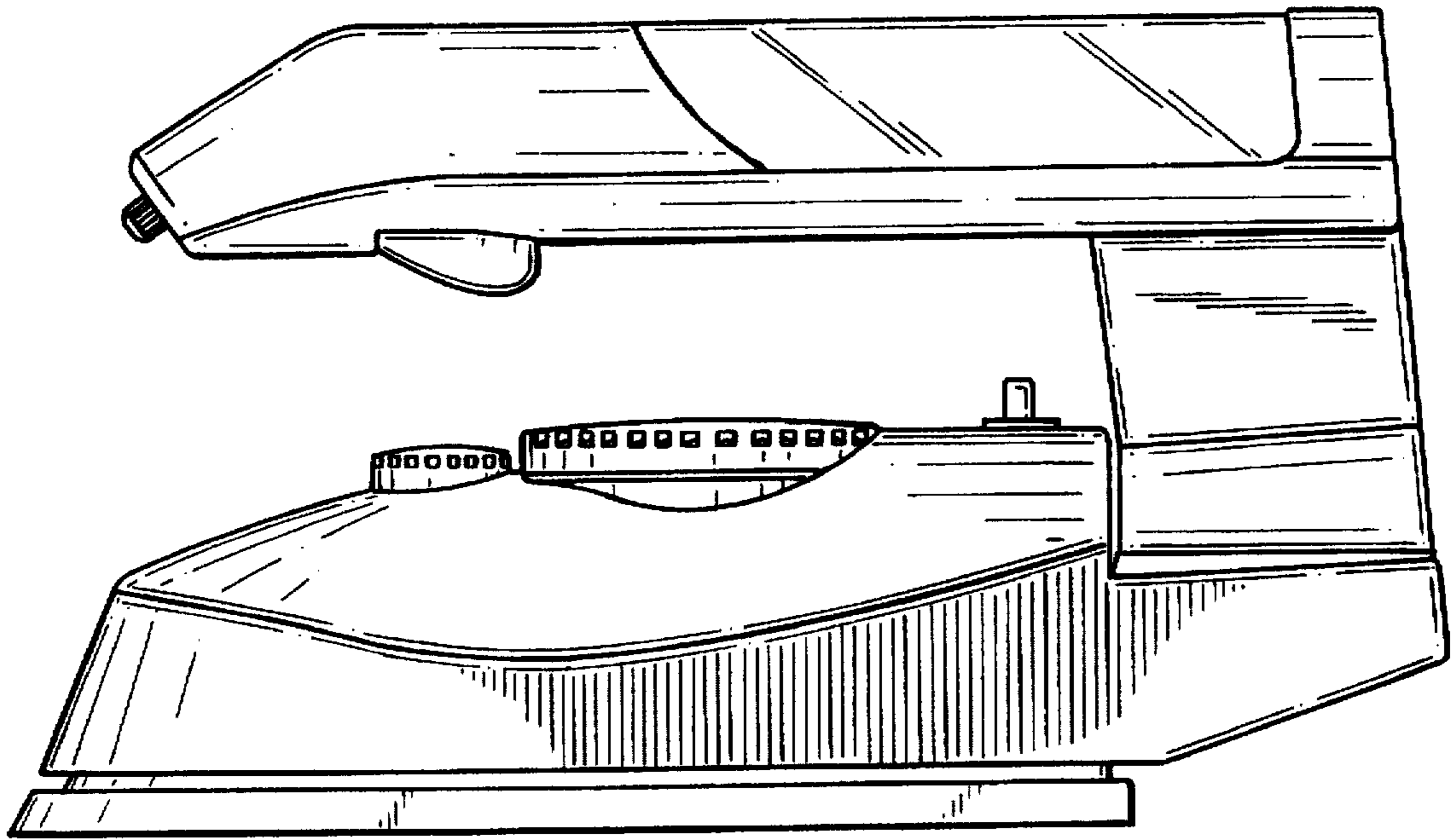

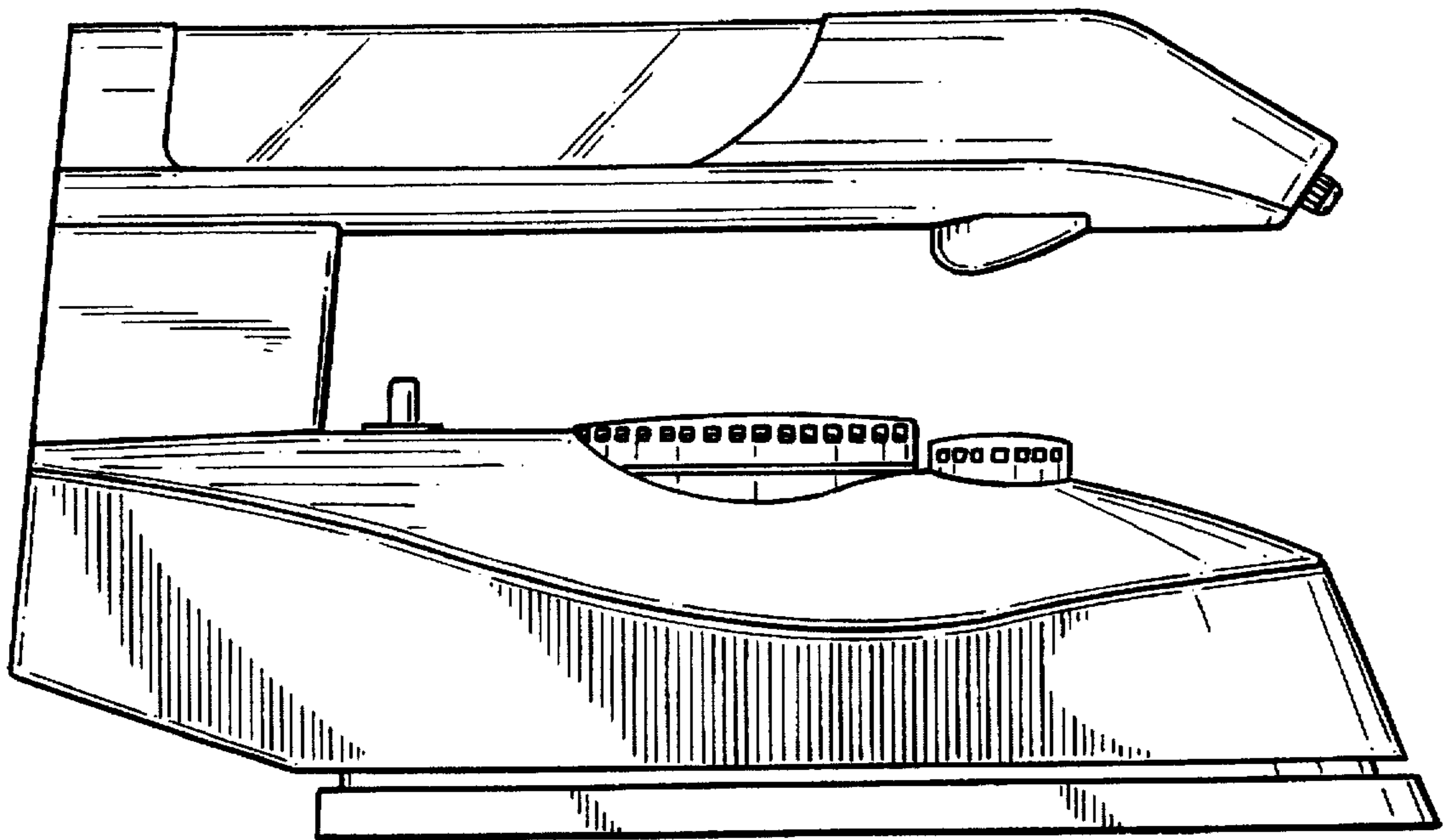

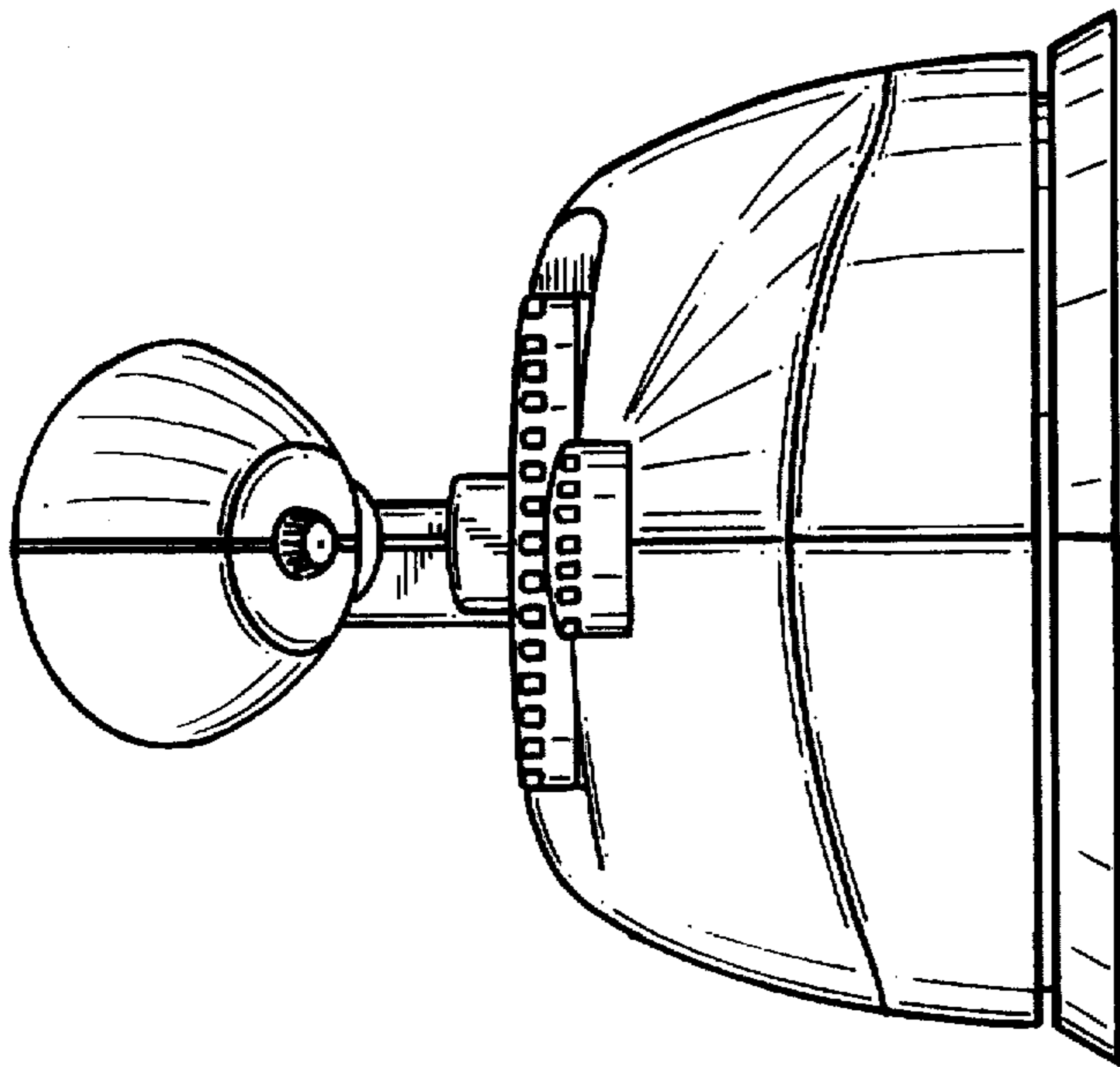

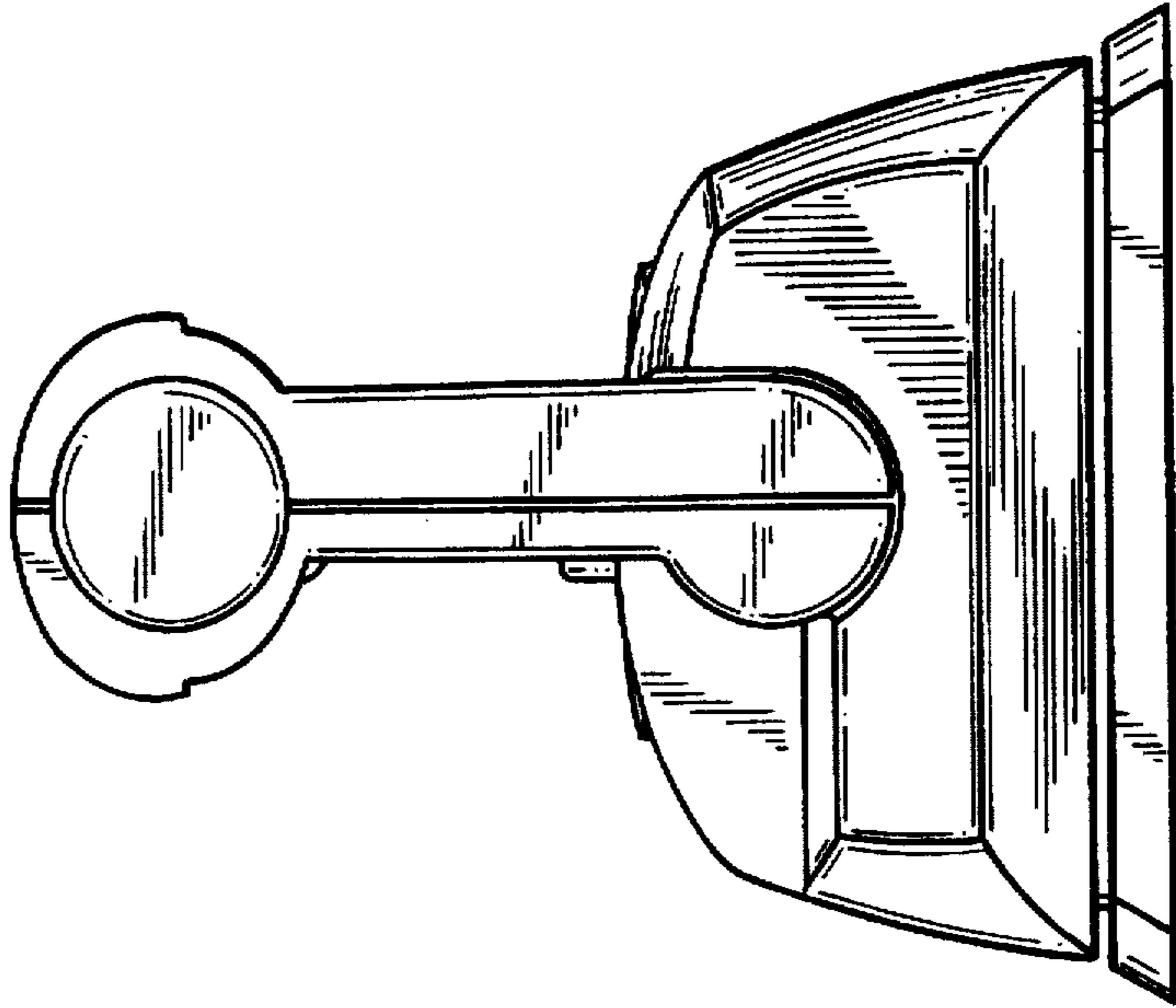

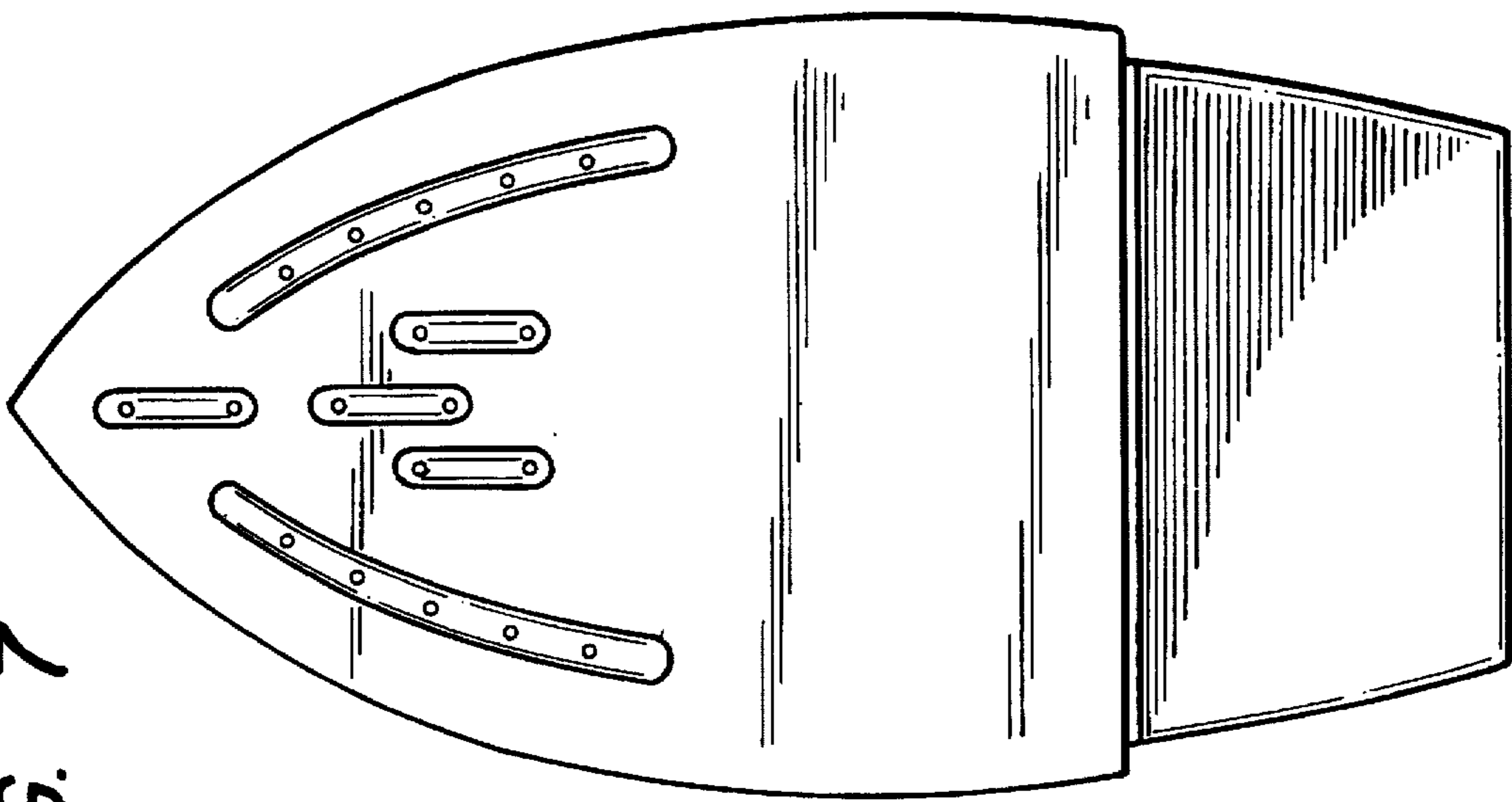

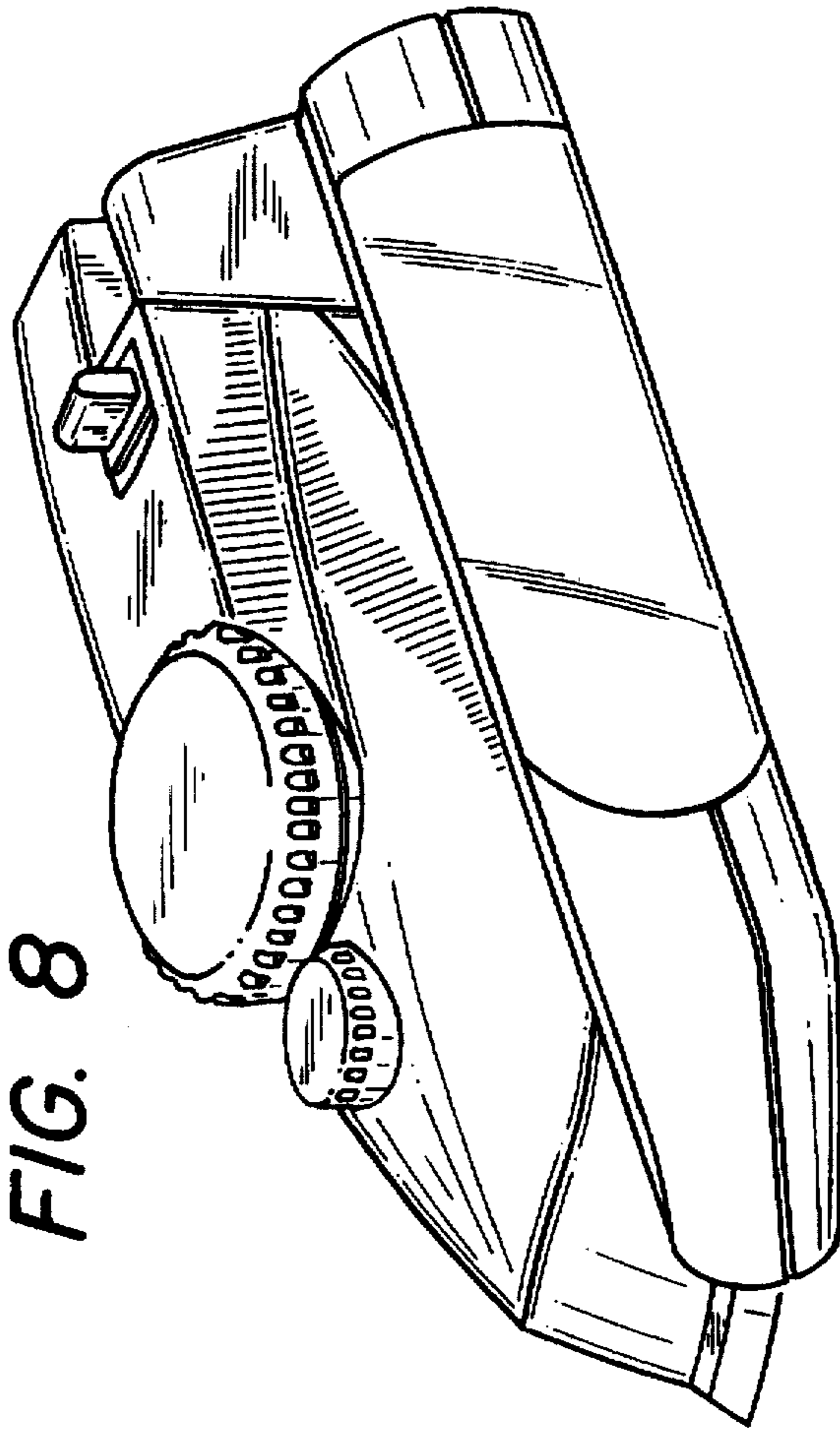

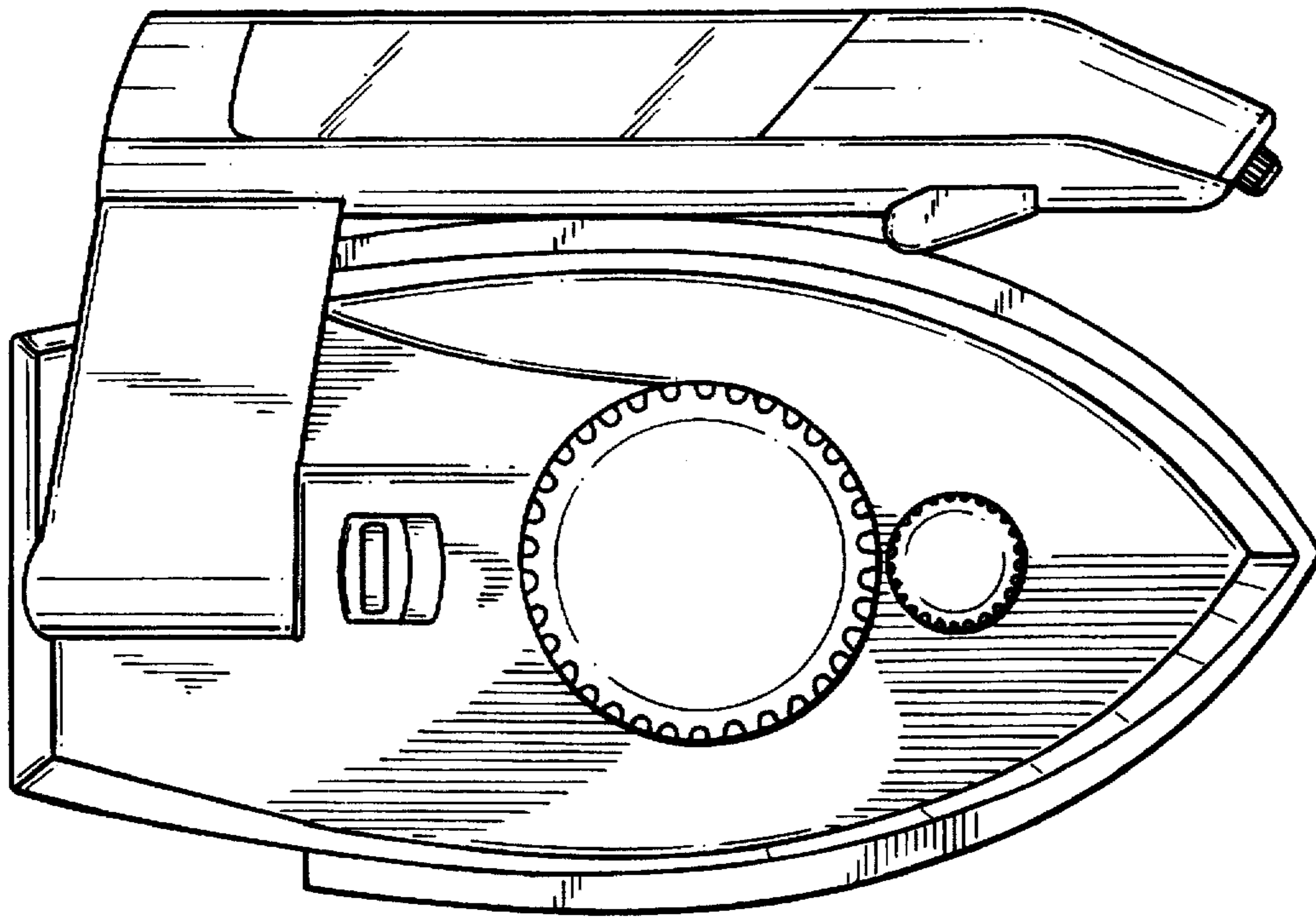

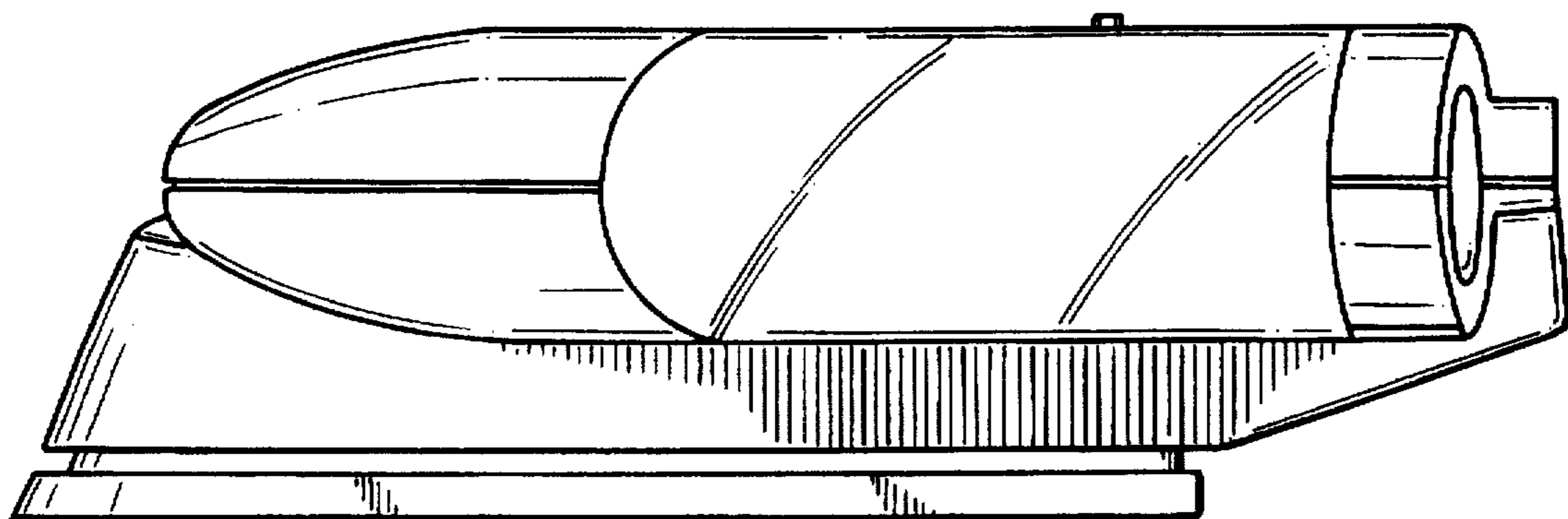

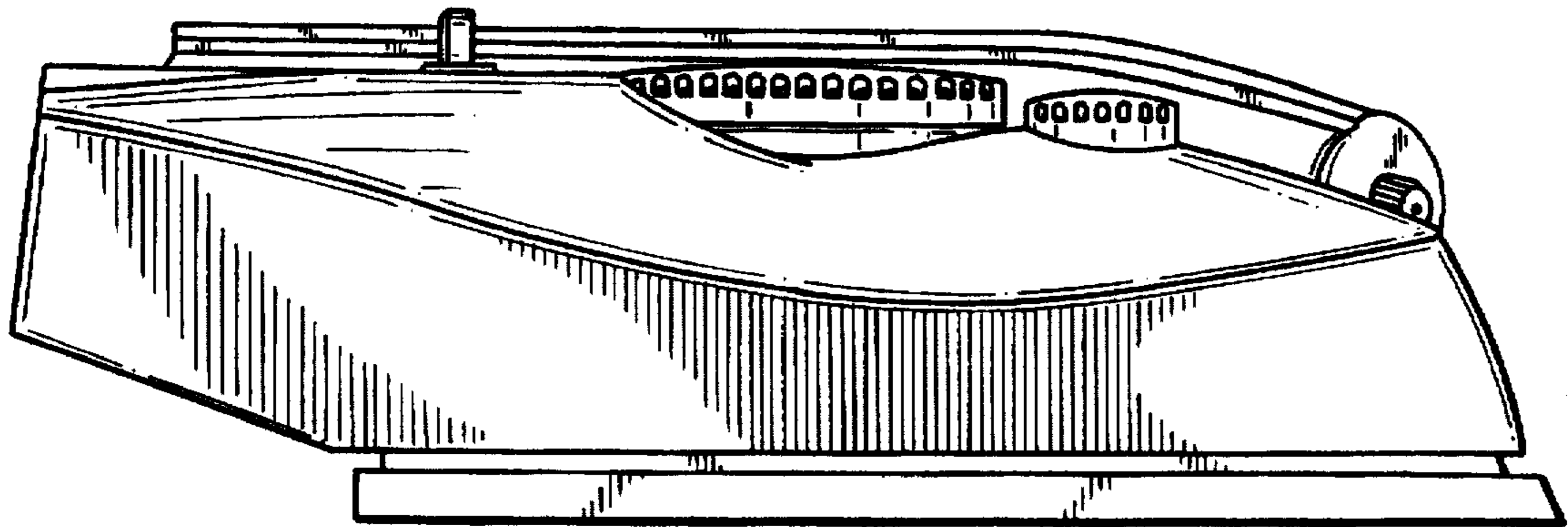

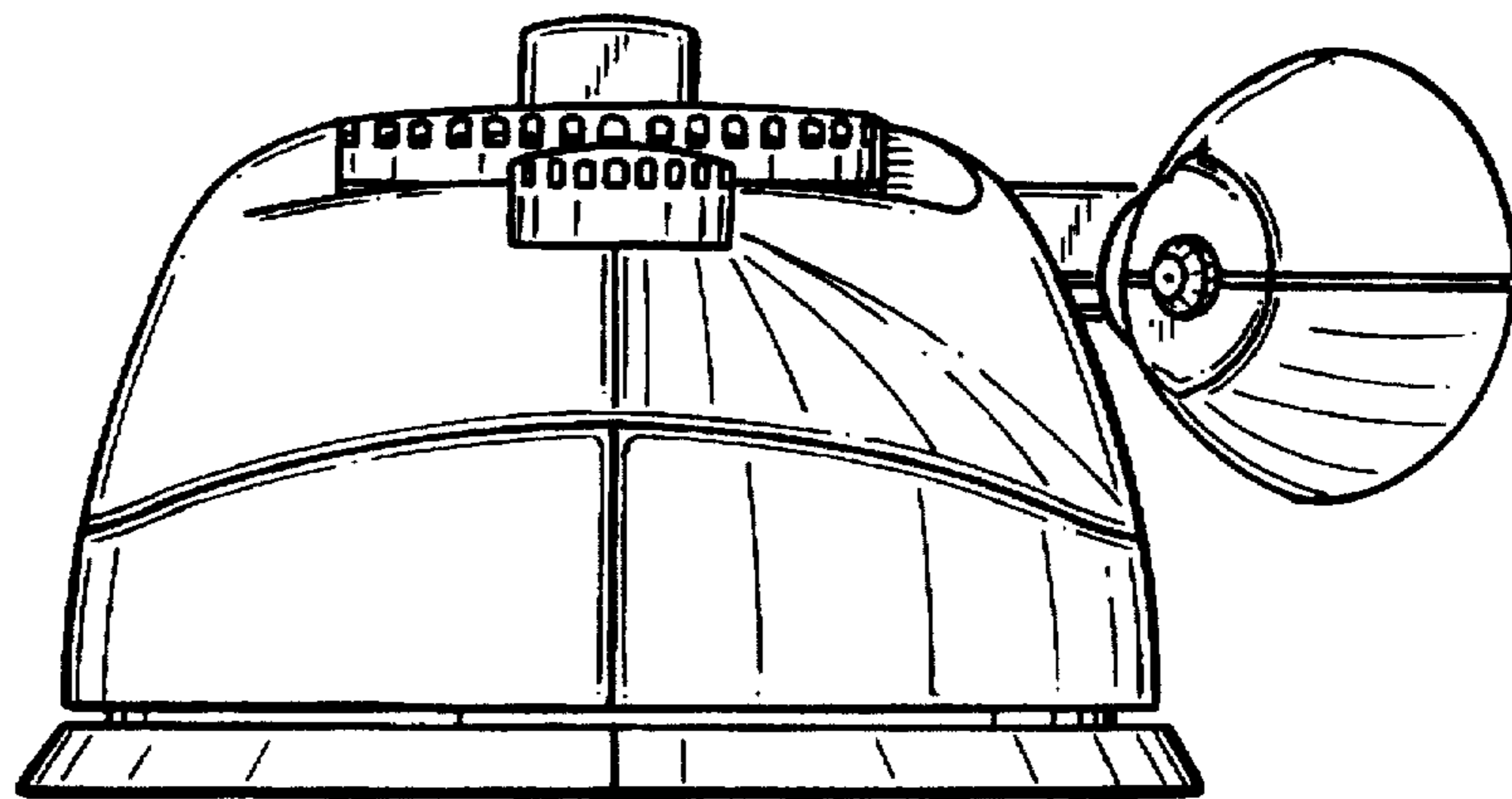

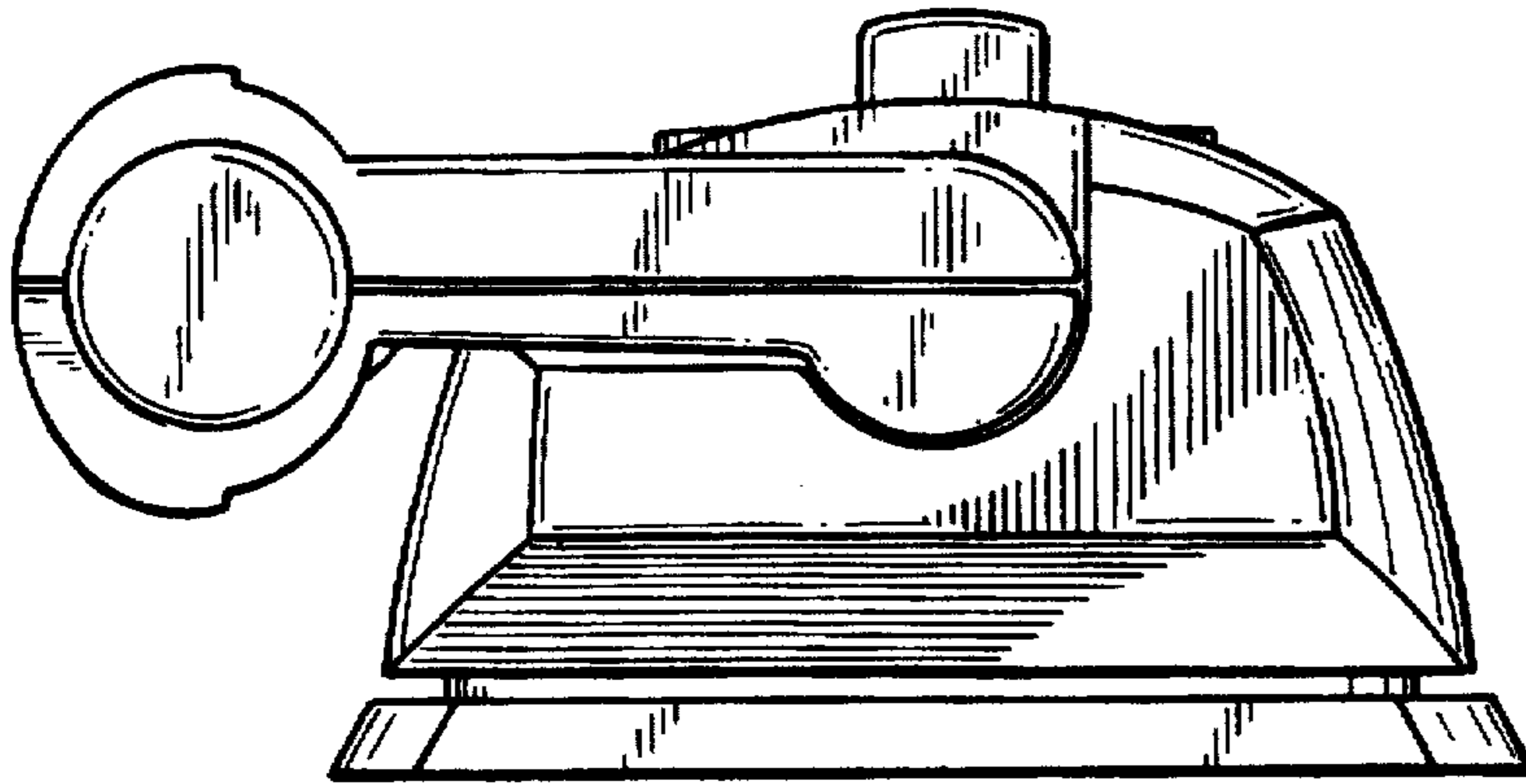
