[57] **CLAIM**

The ornamental design for a bottom surface of a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottom surface of a shoe outsole showing my new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a cross-sectional view taken along the line 3—3 of FIG. 2;

FIG. 4 is a cross-sectional view taken along the line 4—4 of FIG. 2;

FIG. 5 is a cross section view taken along the line 5—5 of FIG. 2;

FIG. 6 is a cross-sectional view taken along the line 6—6 of FIG. 2; and,

FIG. 7 is a rear view of the bottom surface of a outsole shown in FIG. 1.

The broken line showing of a shoe sole and/or shoe upper in FIGS. 1 through 7 is for illustrative purposes only and forms no part of the claimed design.

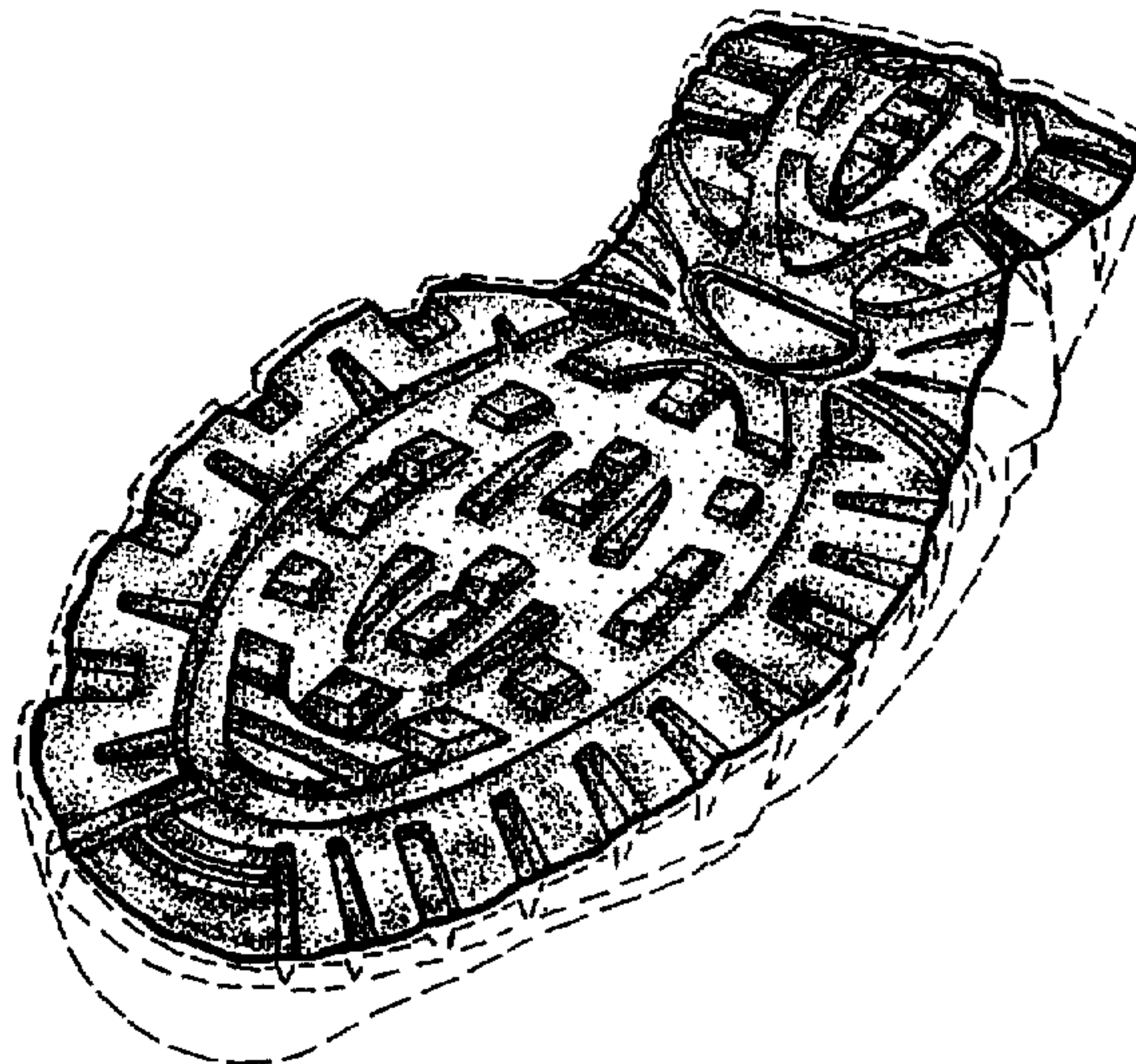

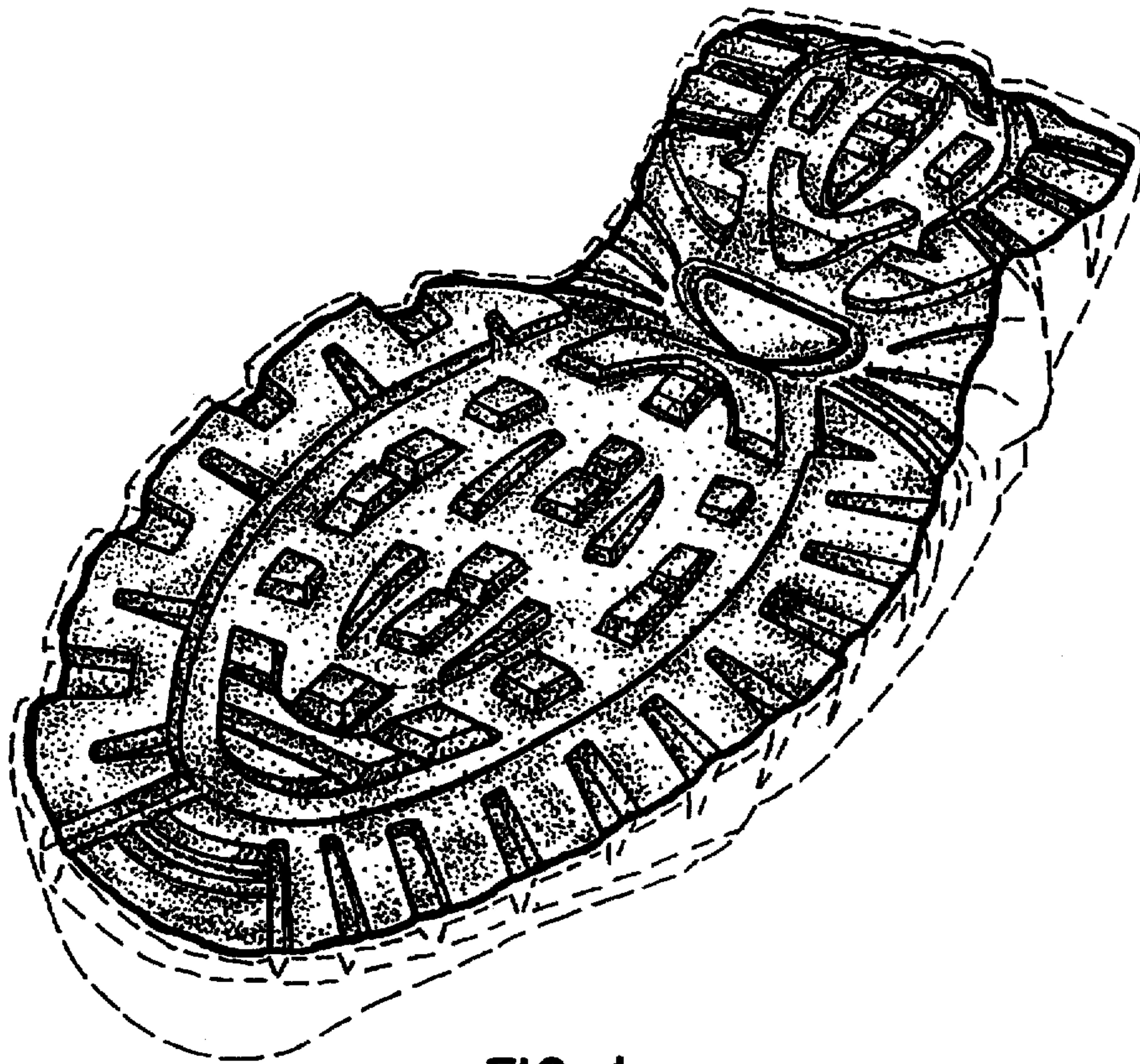

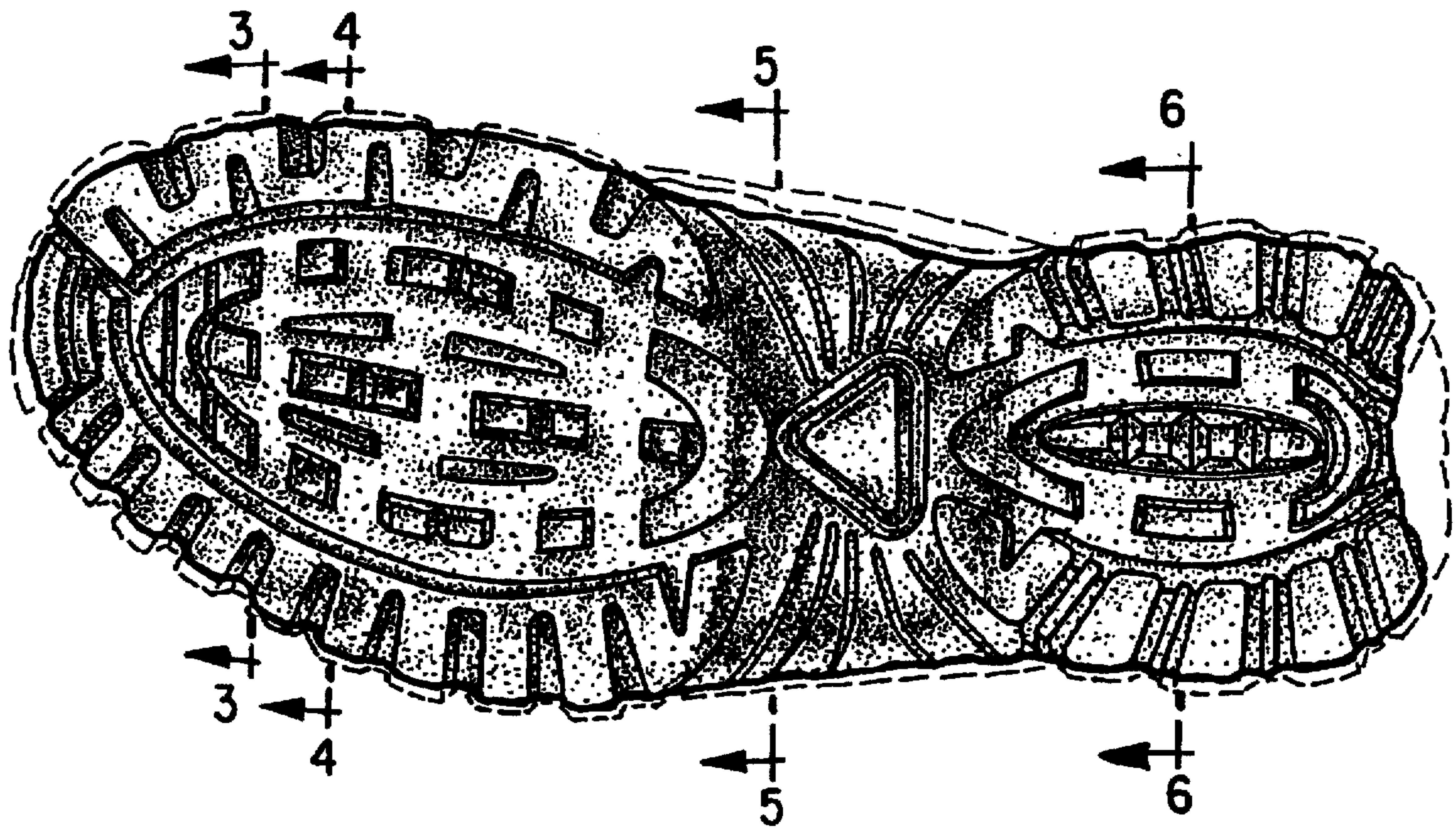

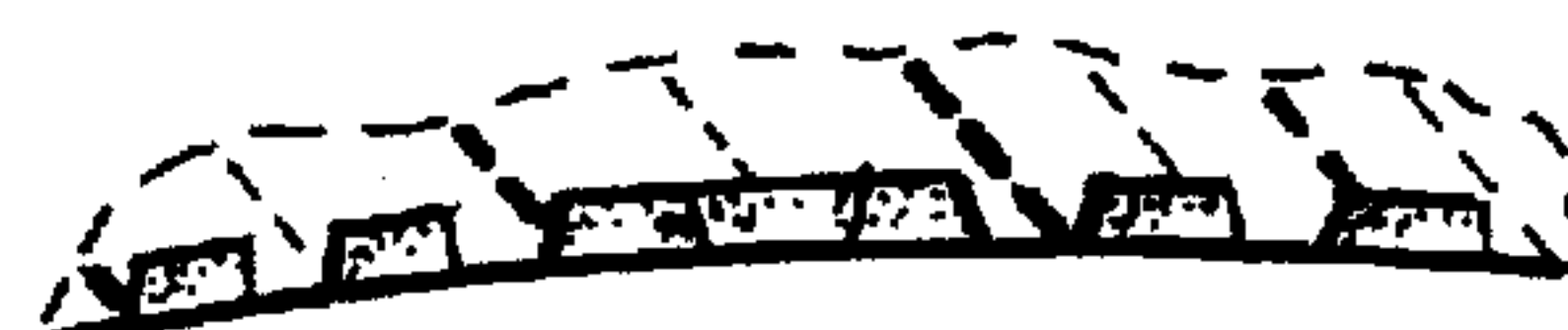

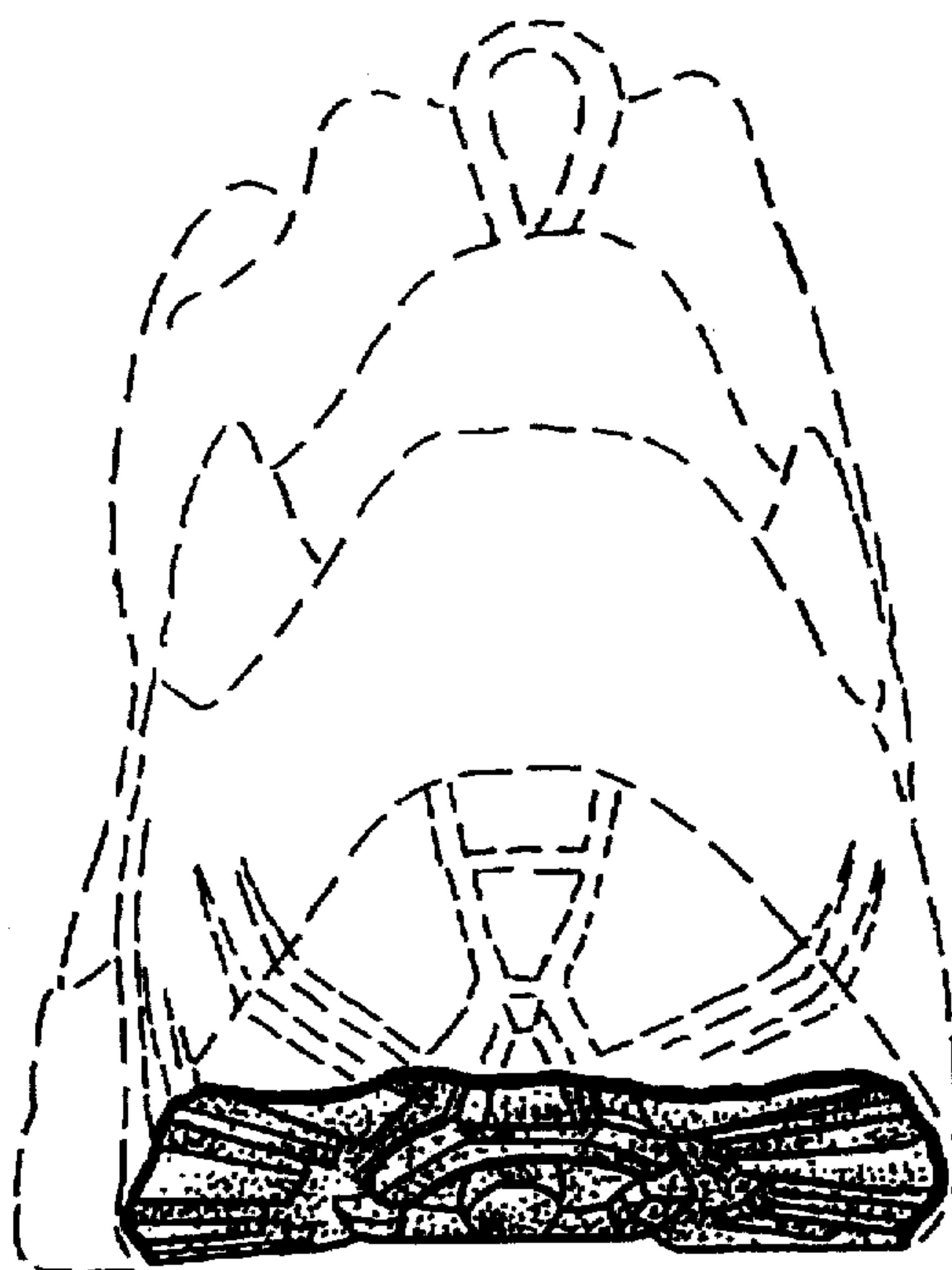
