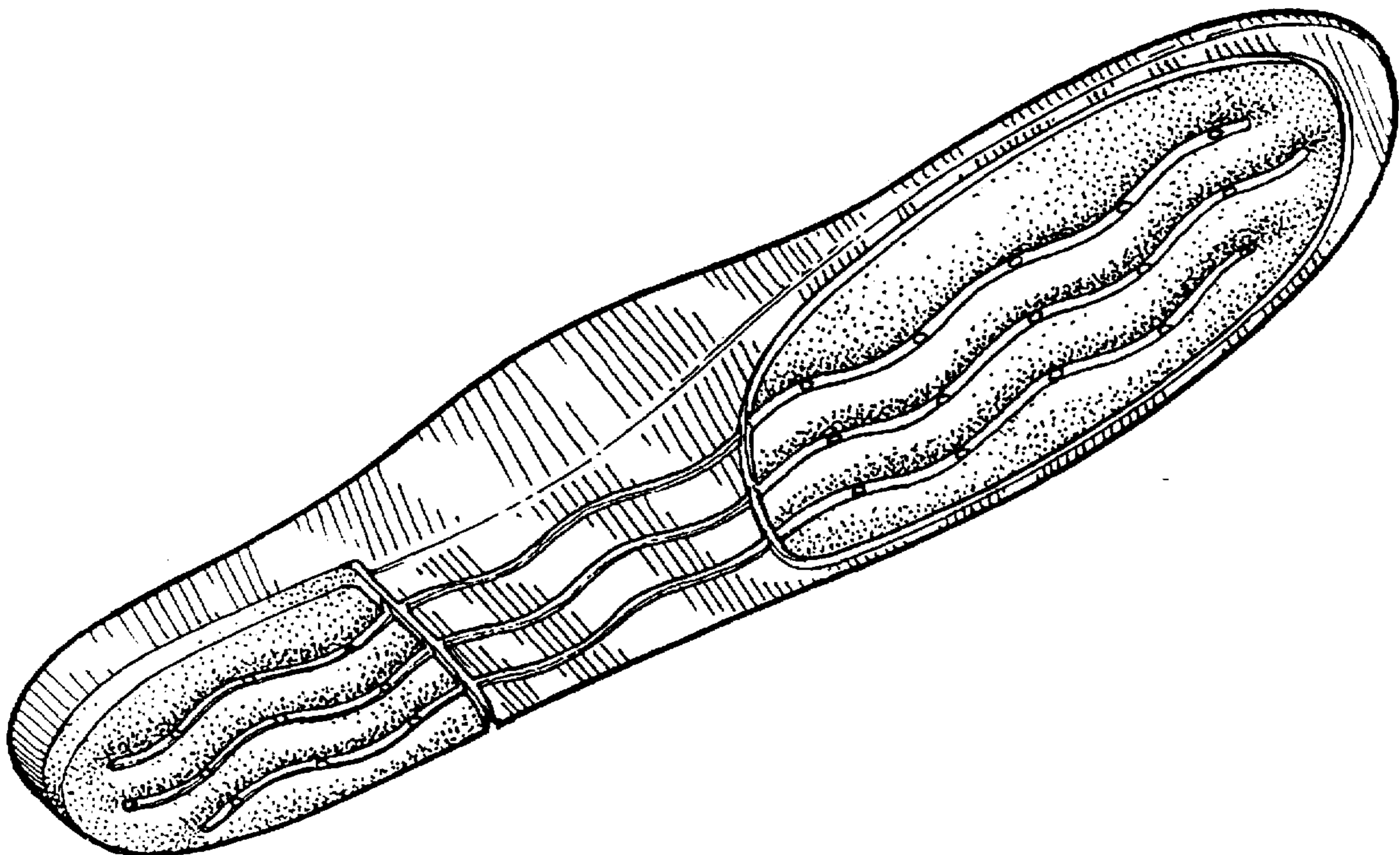
[57] CLAIM

The ornamental design for footwear insole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottom of a footwear insole, showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is an enlarged sectional view thereof taken along line 8—8 of FIG. 7.

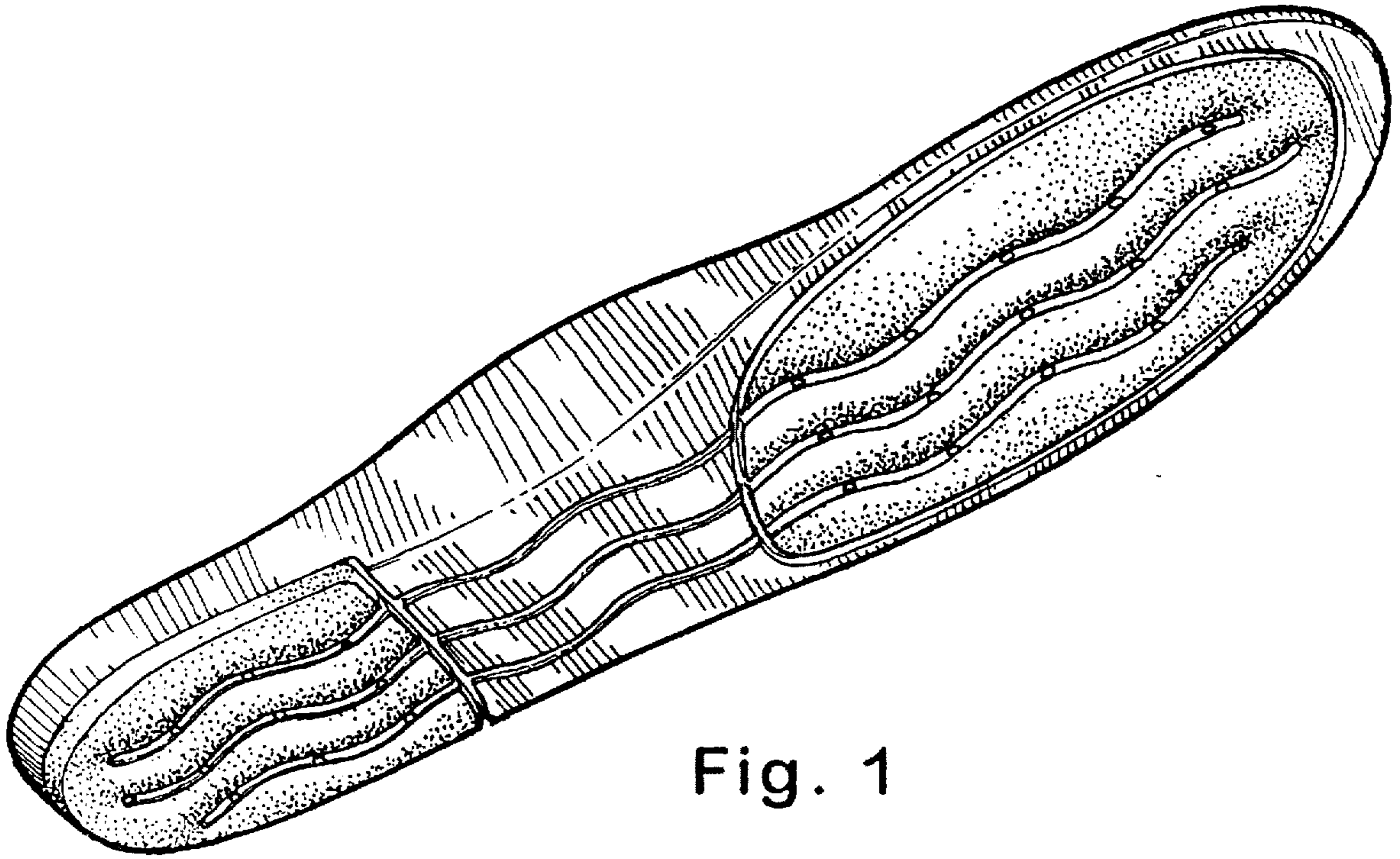

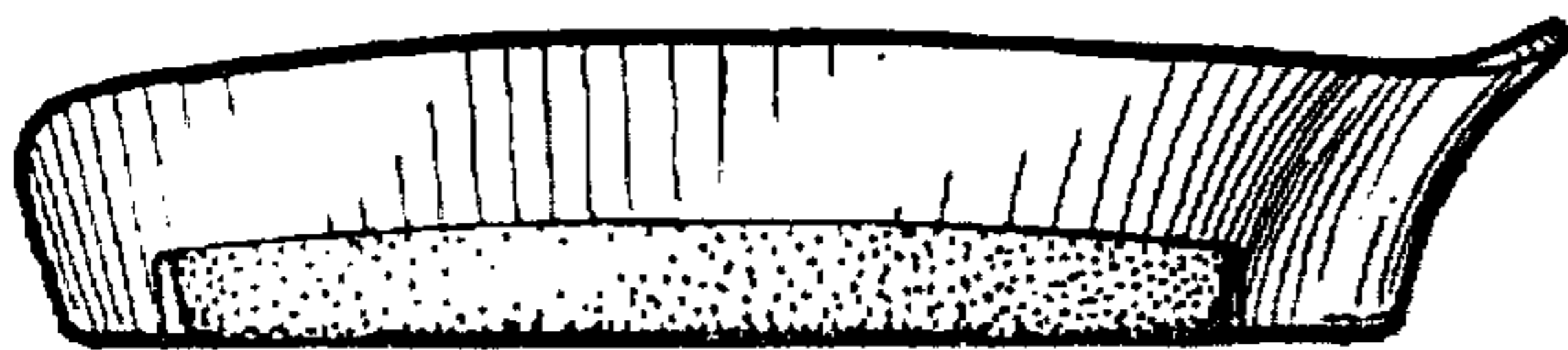

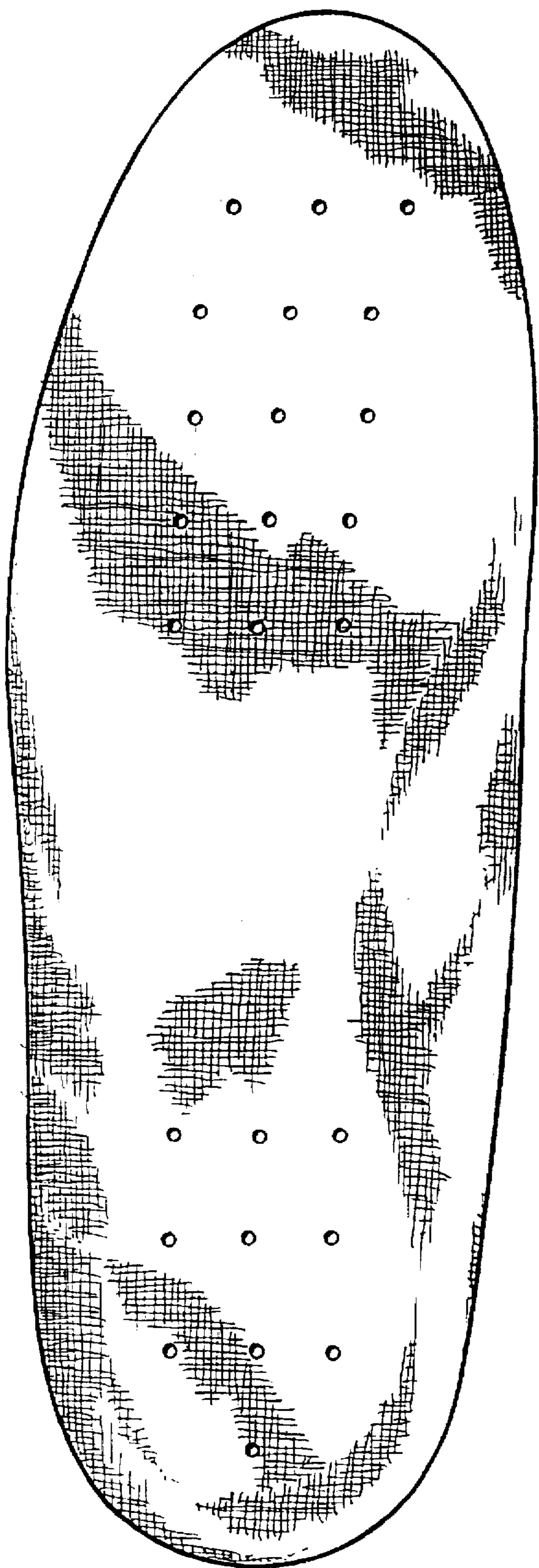

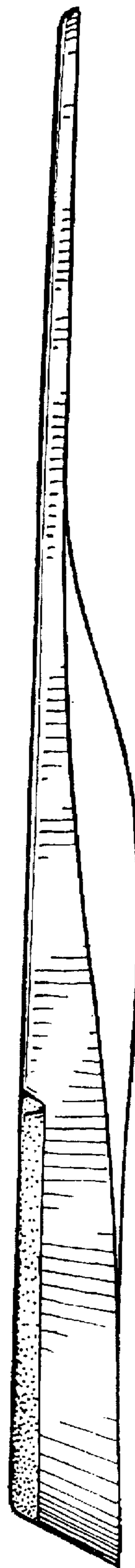

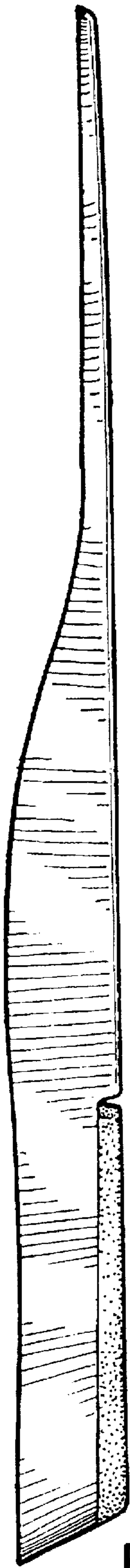

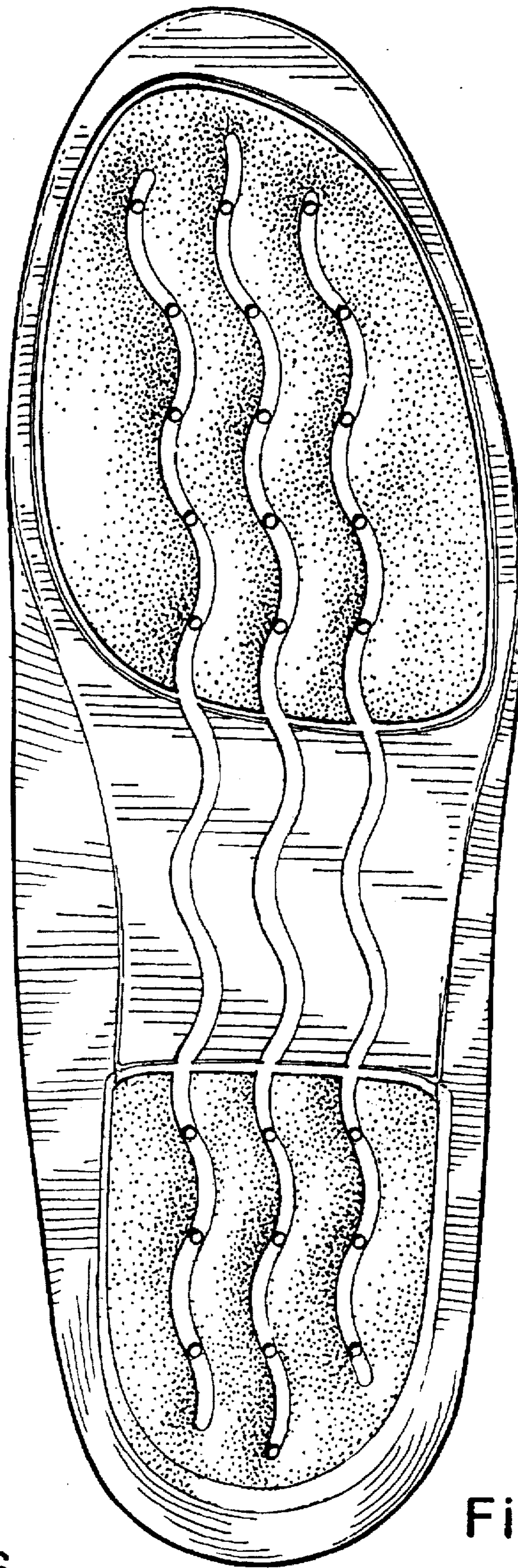
