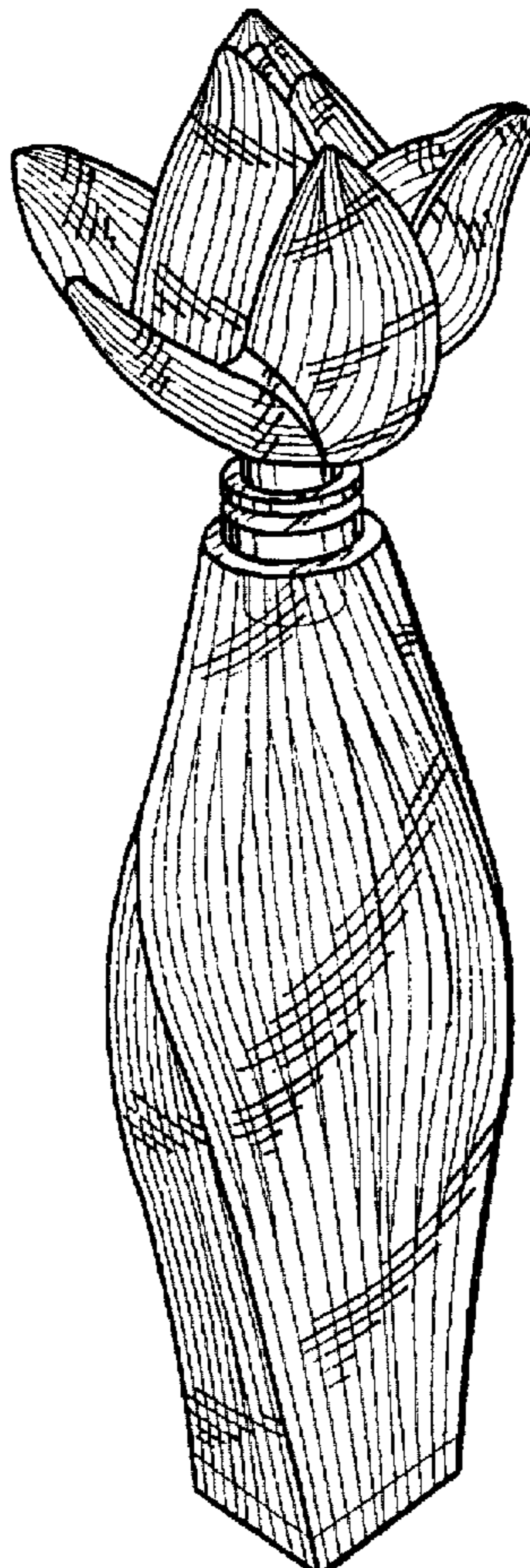
FIG. 1 is a top and side perspective view of a perfume bottle showing my new design;

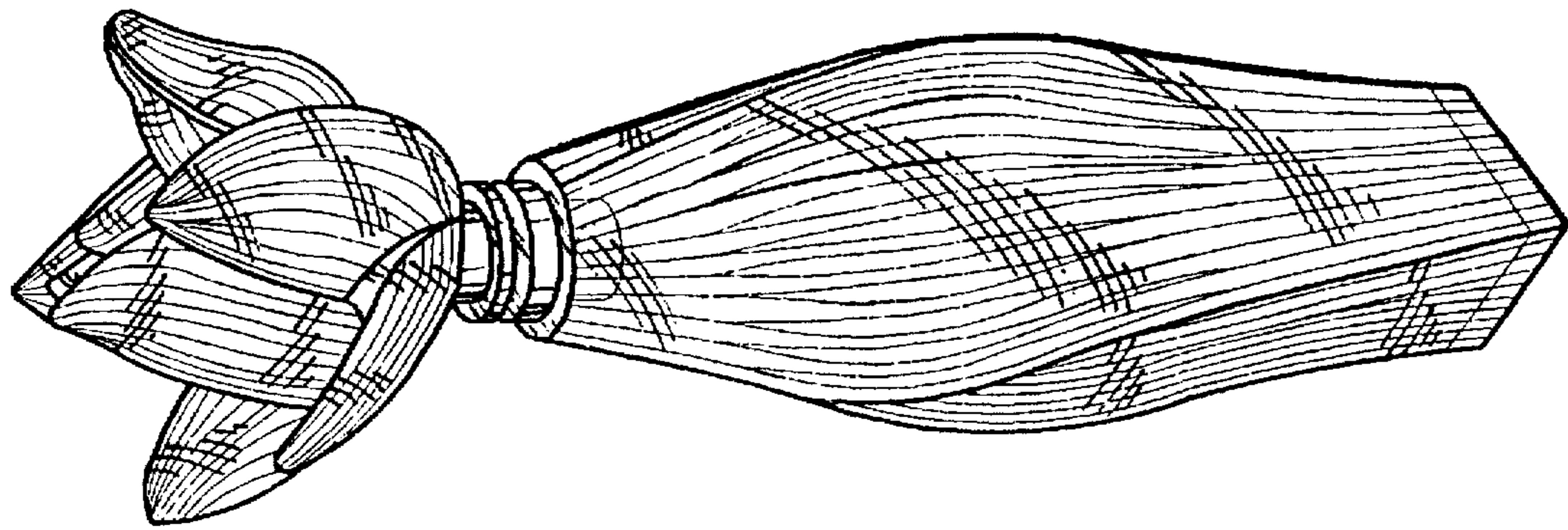

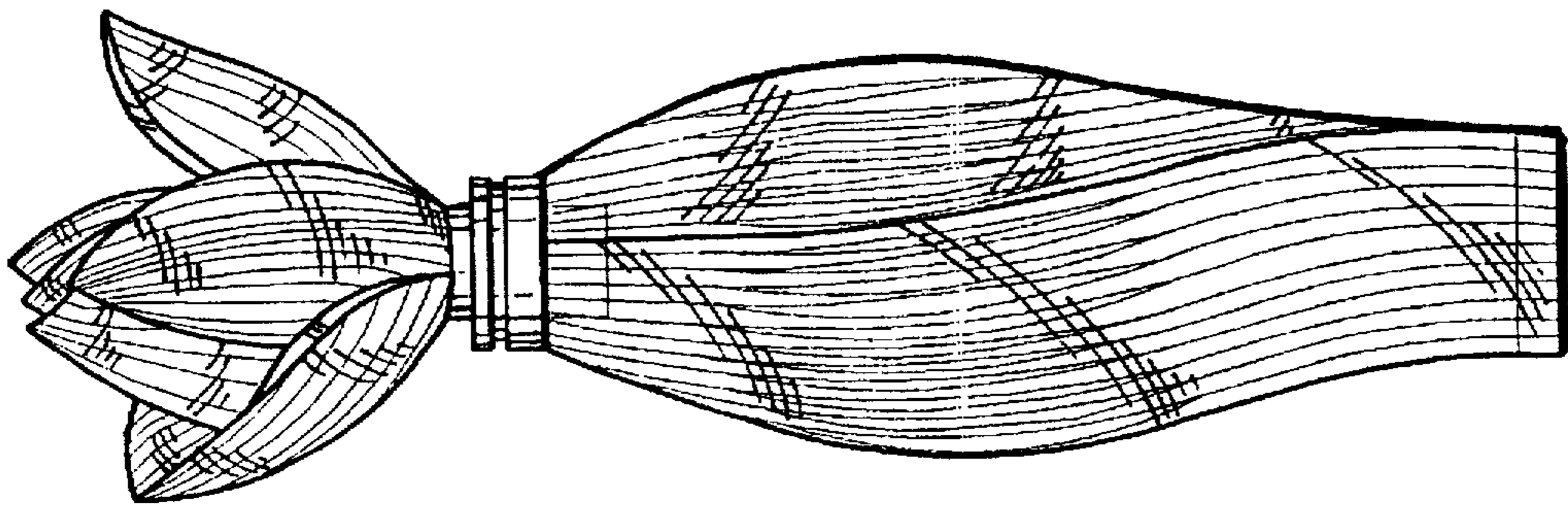

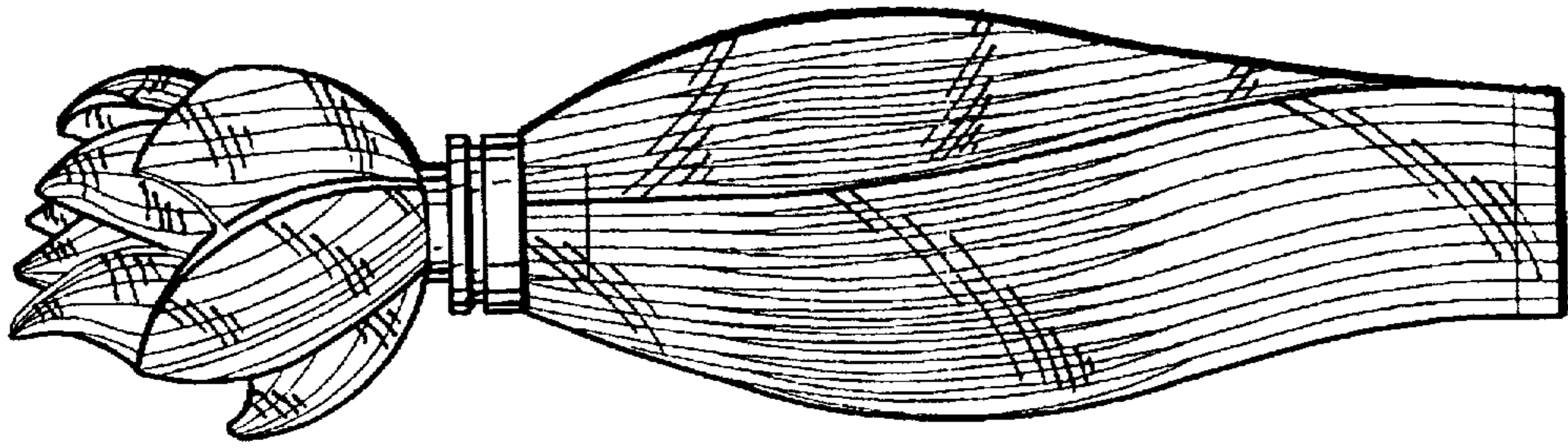

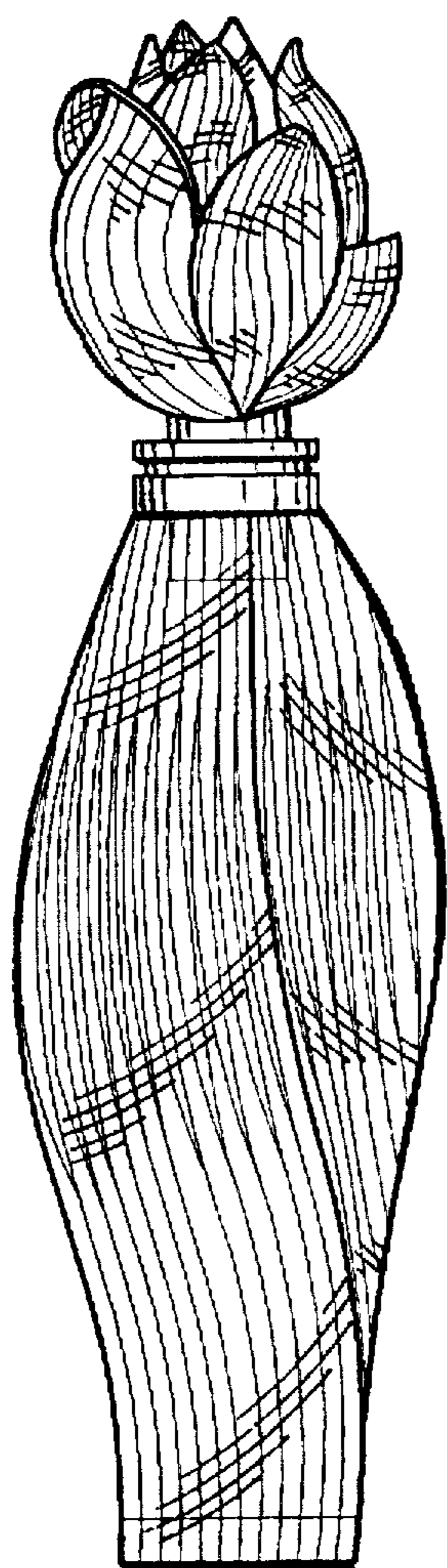

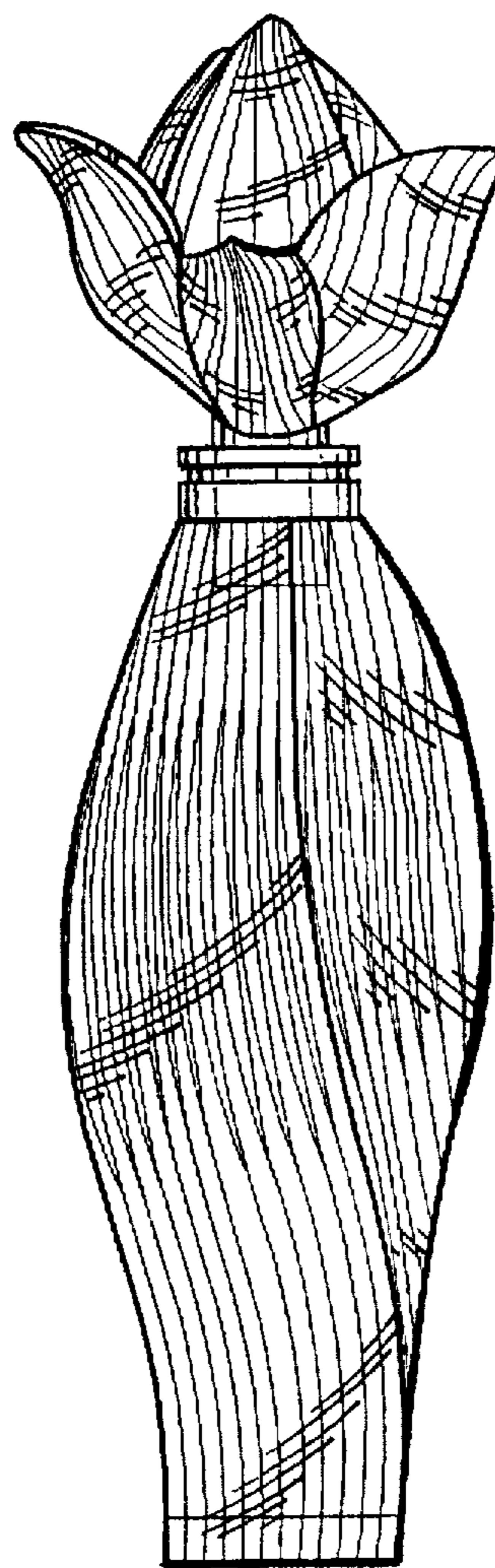

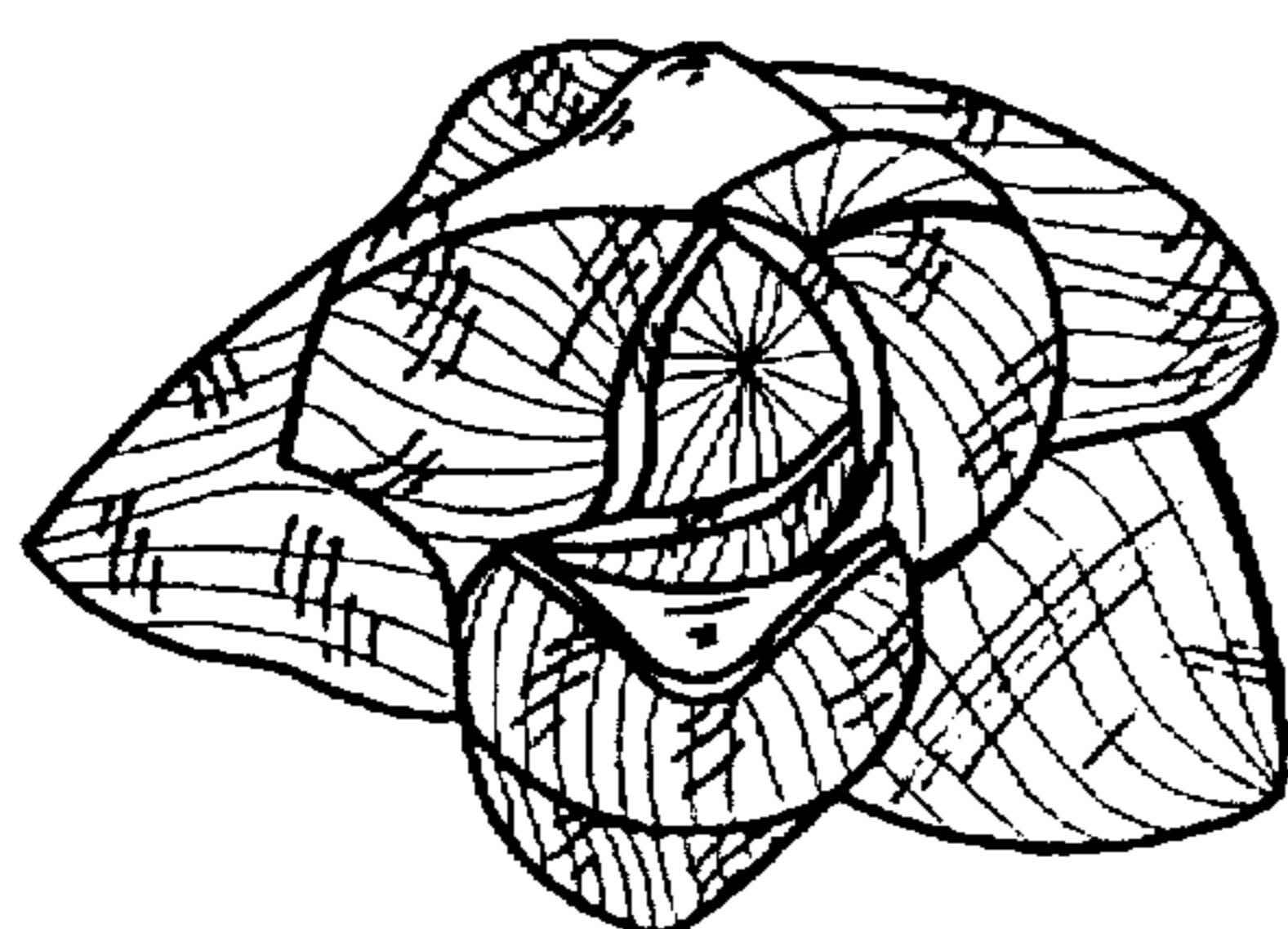

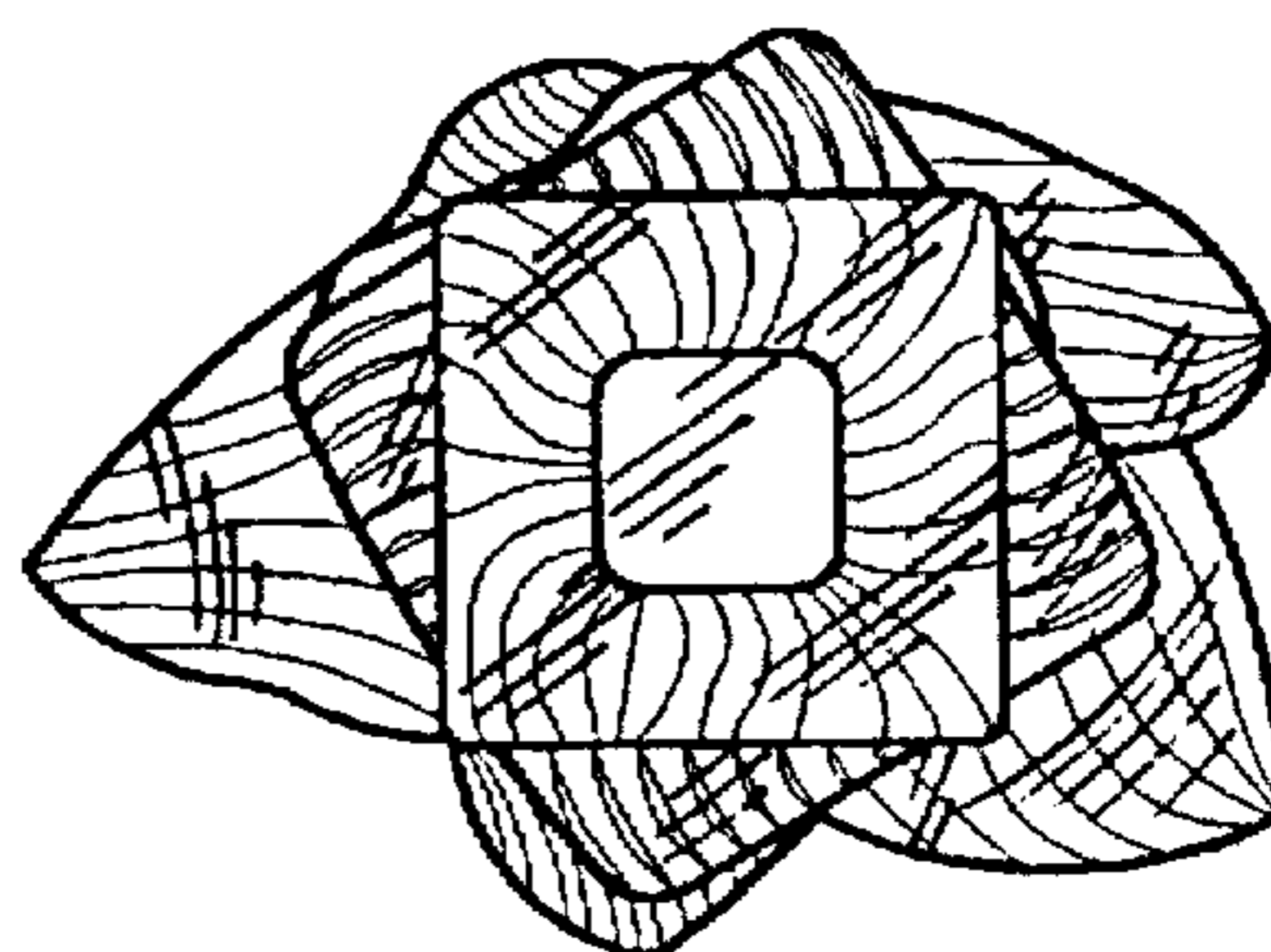
