FIG. 16 is a sectional elevational view thereof; taken along line 16—16 of FIG. 7; and,

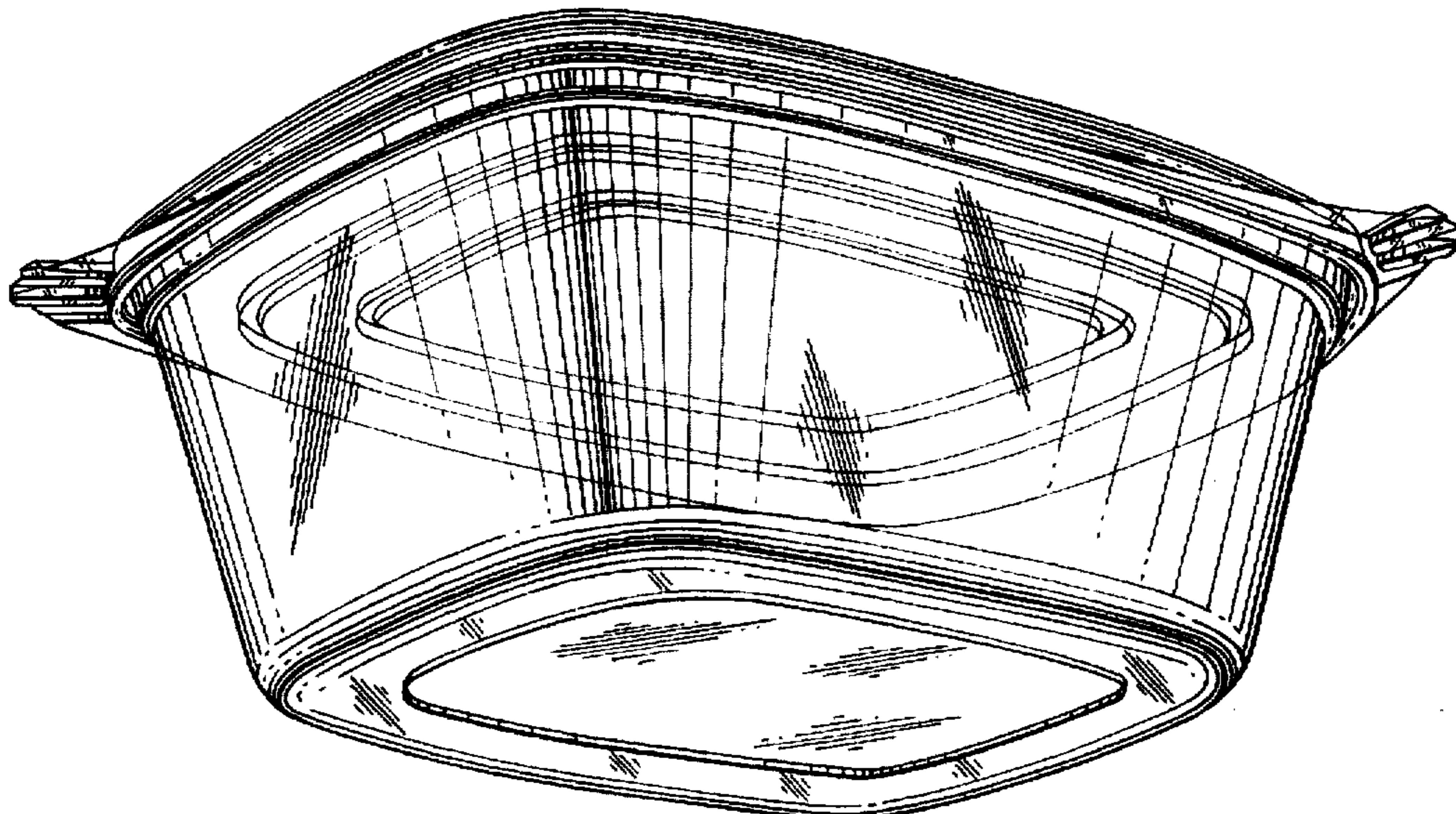
FIG. 17 is a sectional elevational view thereof; taken along line 17—17 of FIG. 12.

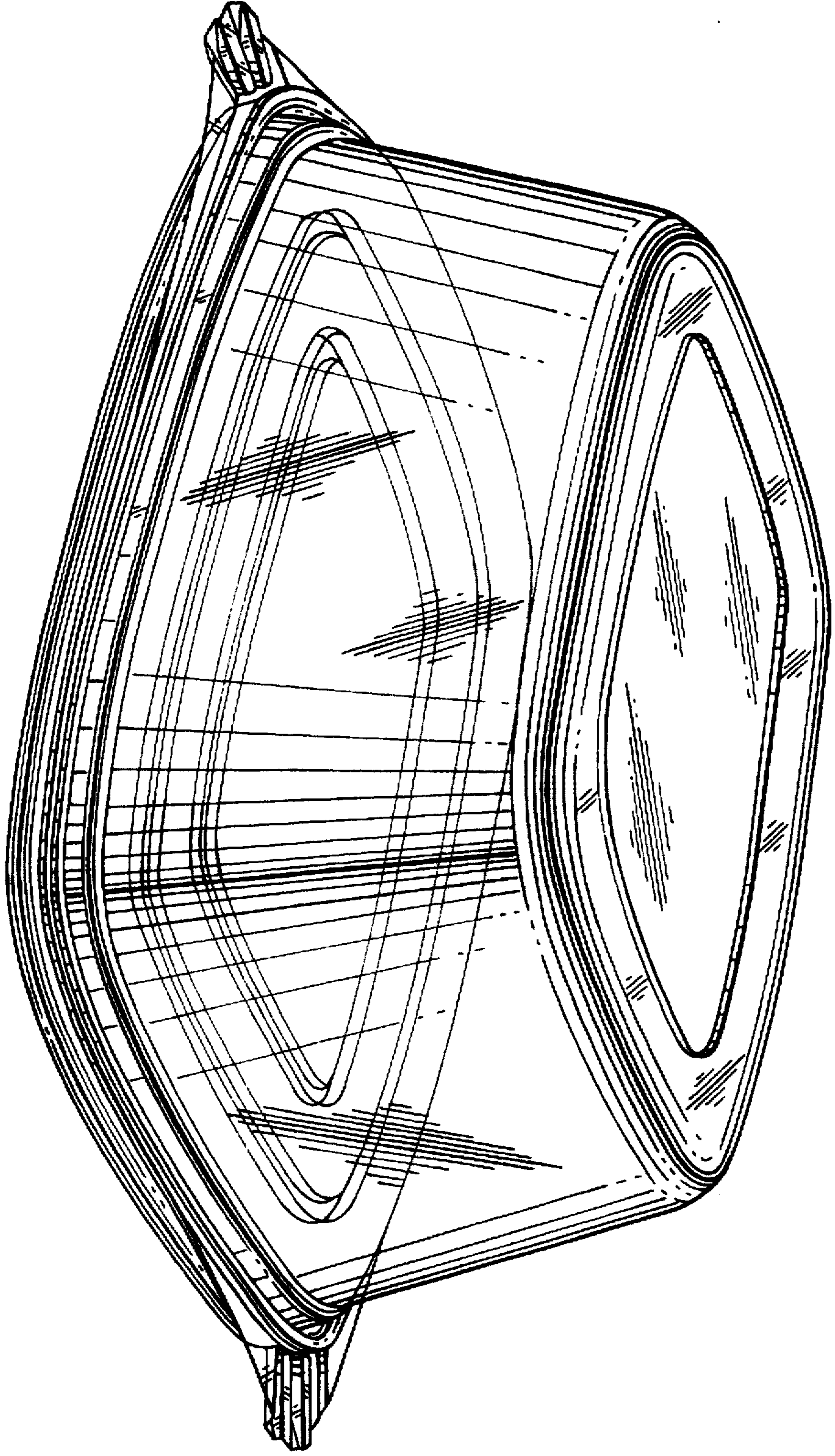

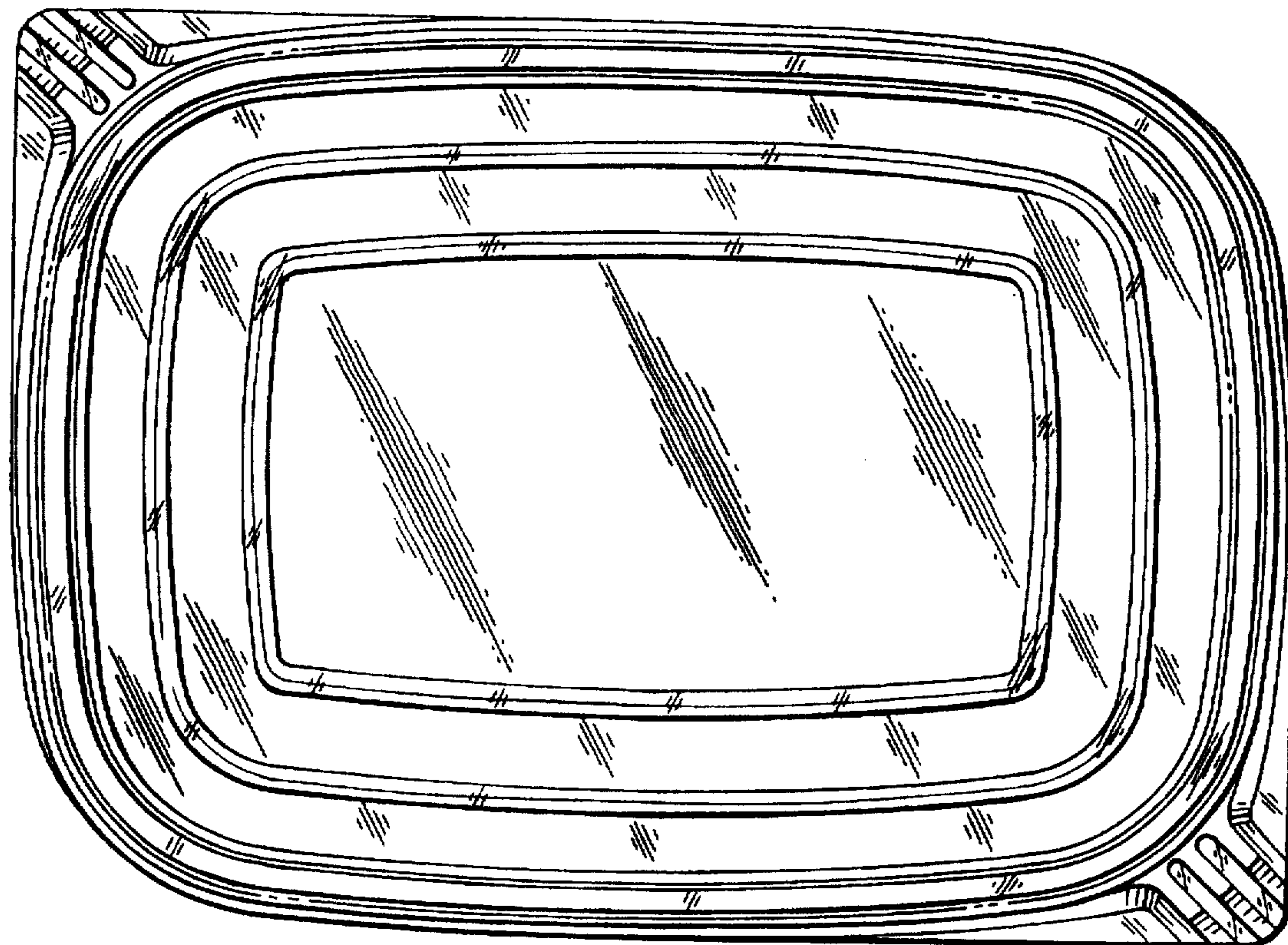
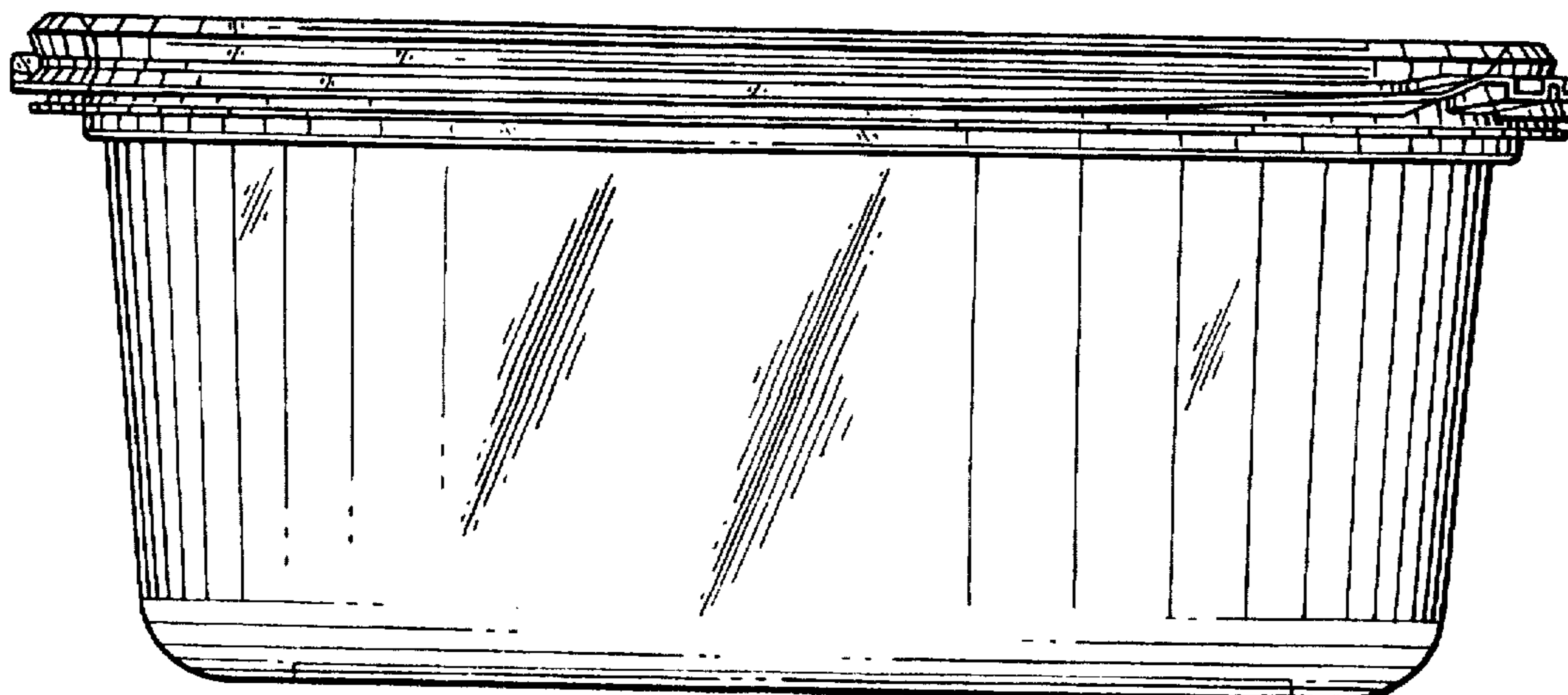

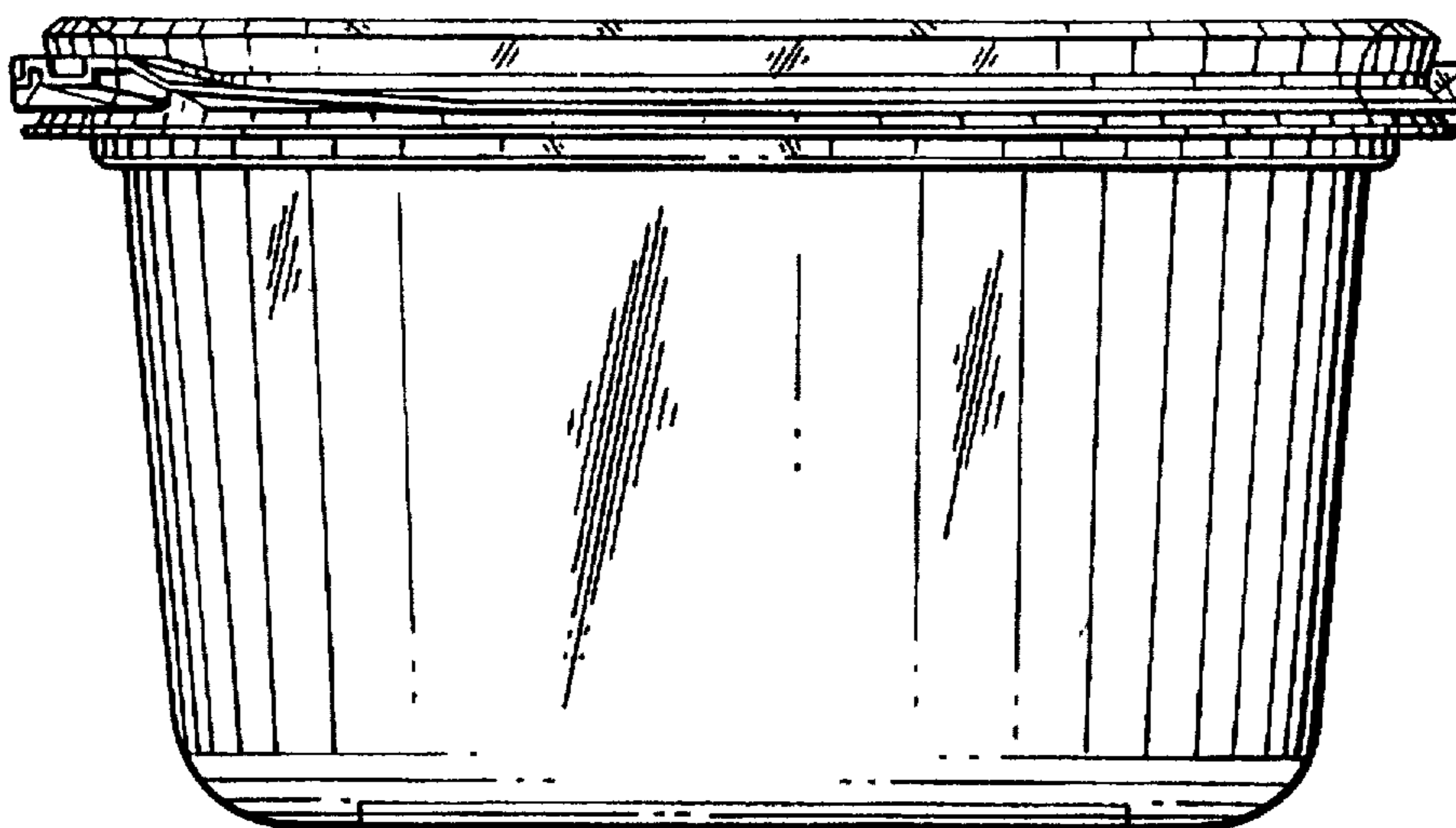
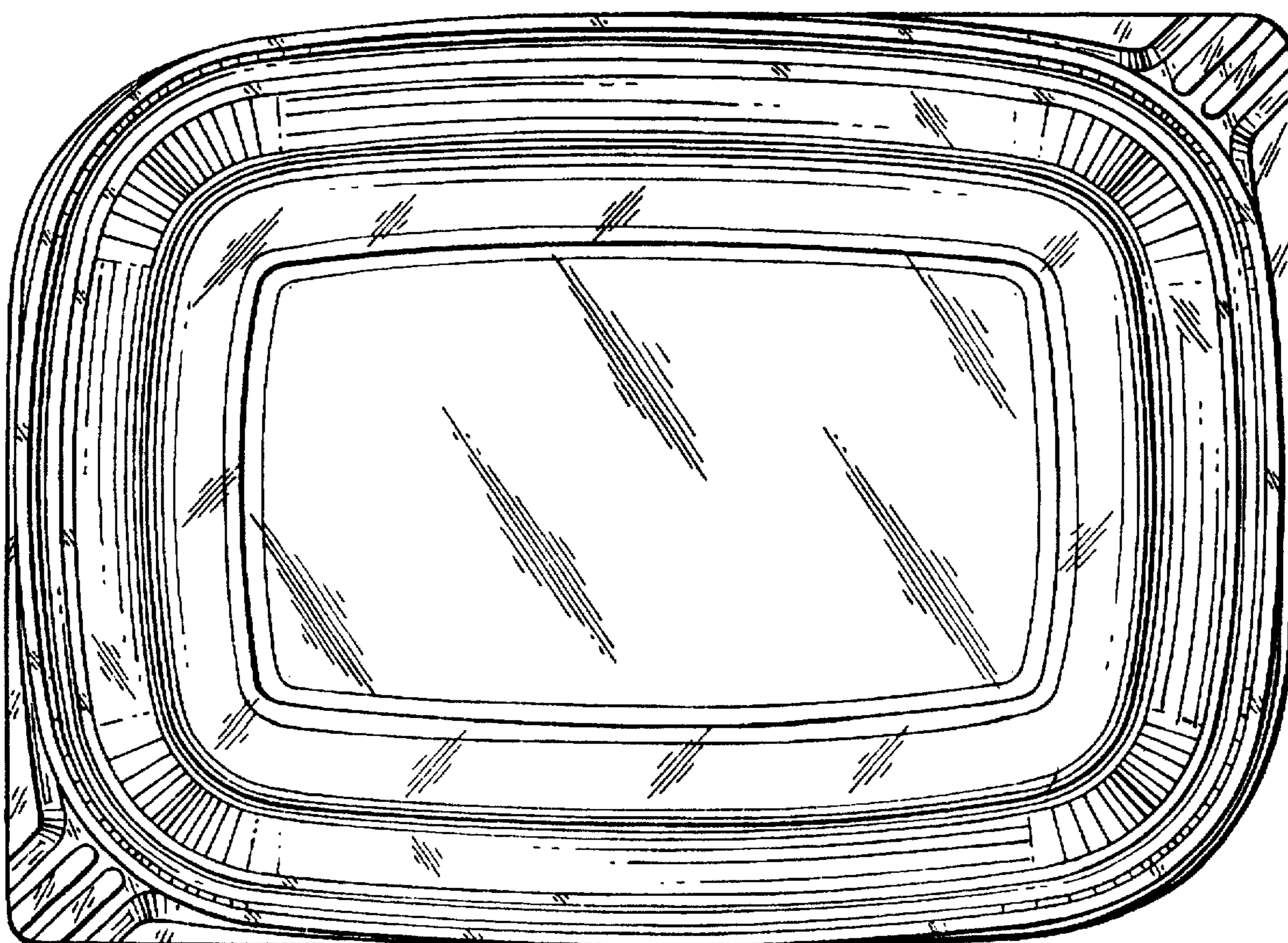

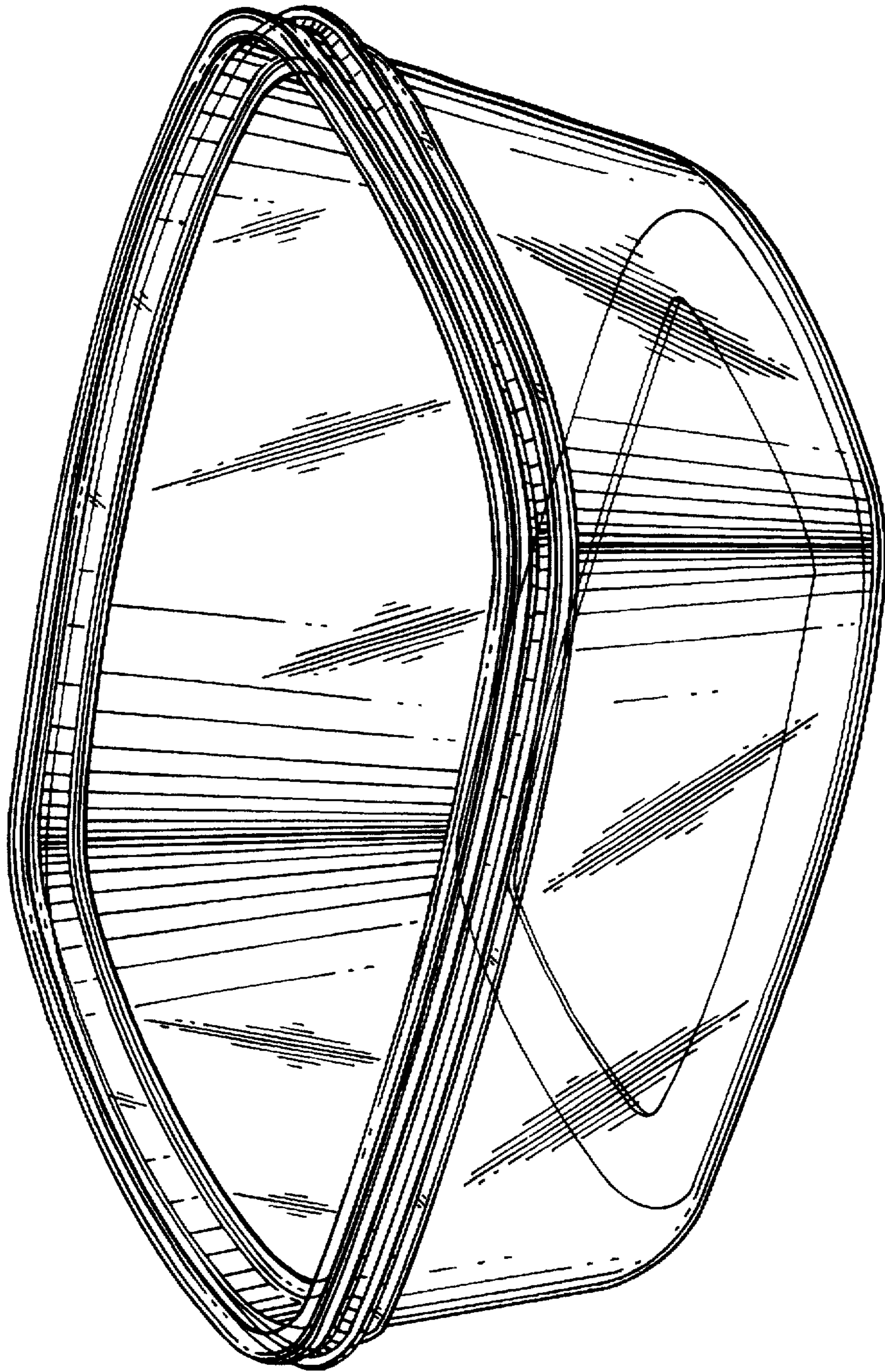

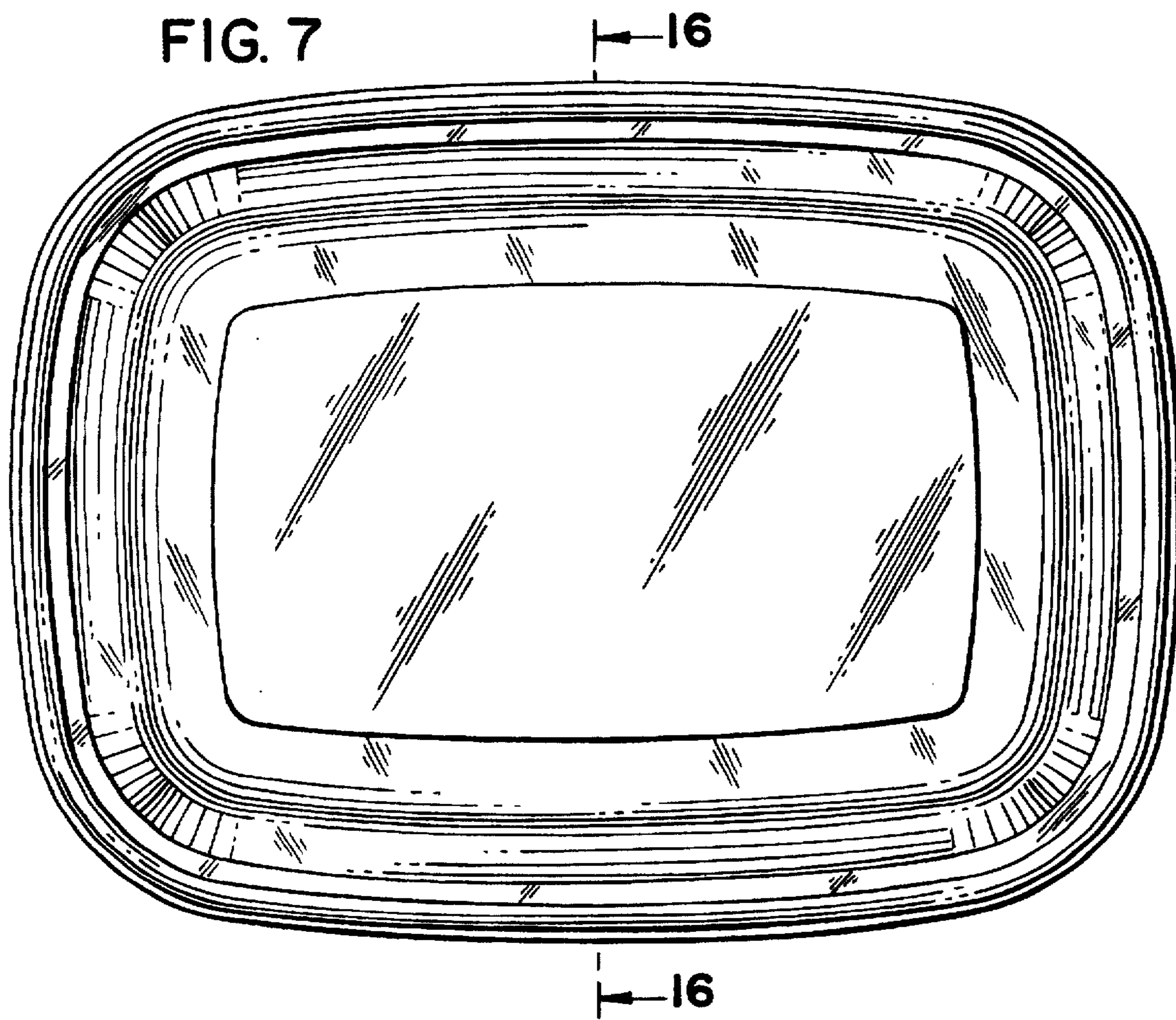
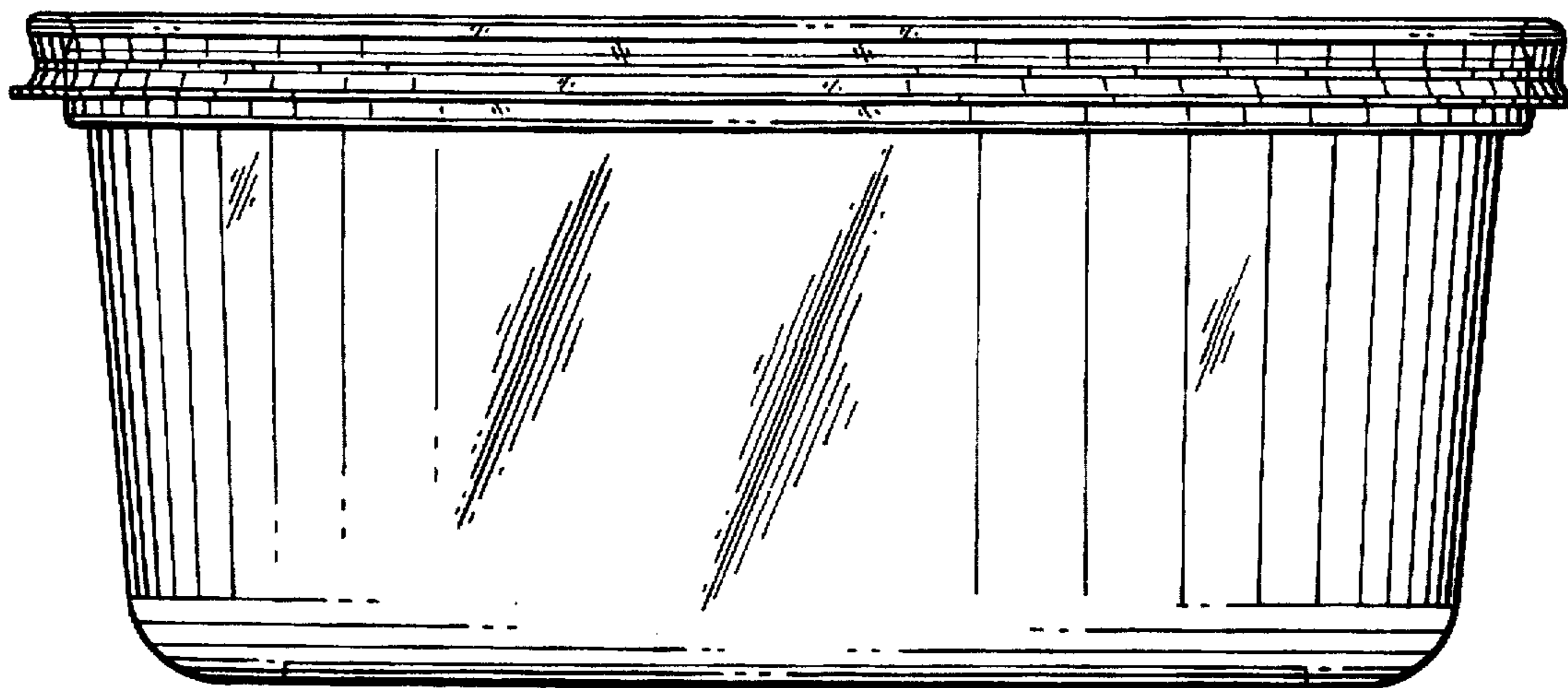

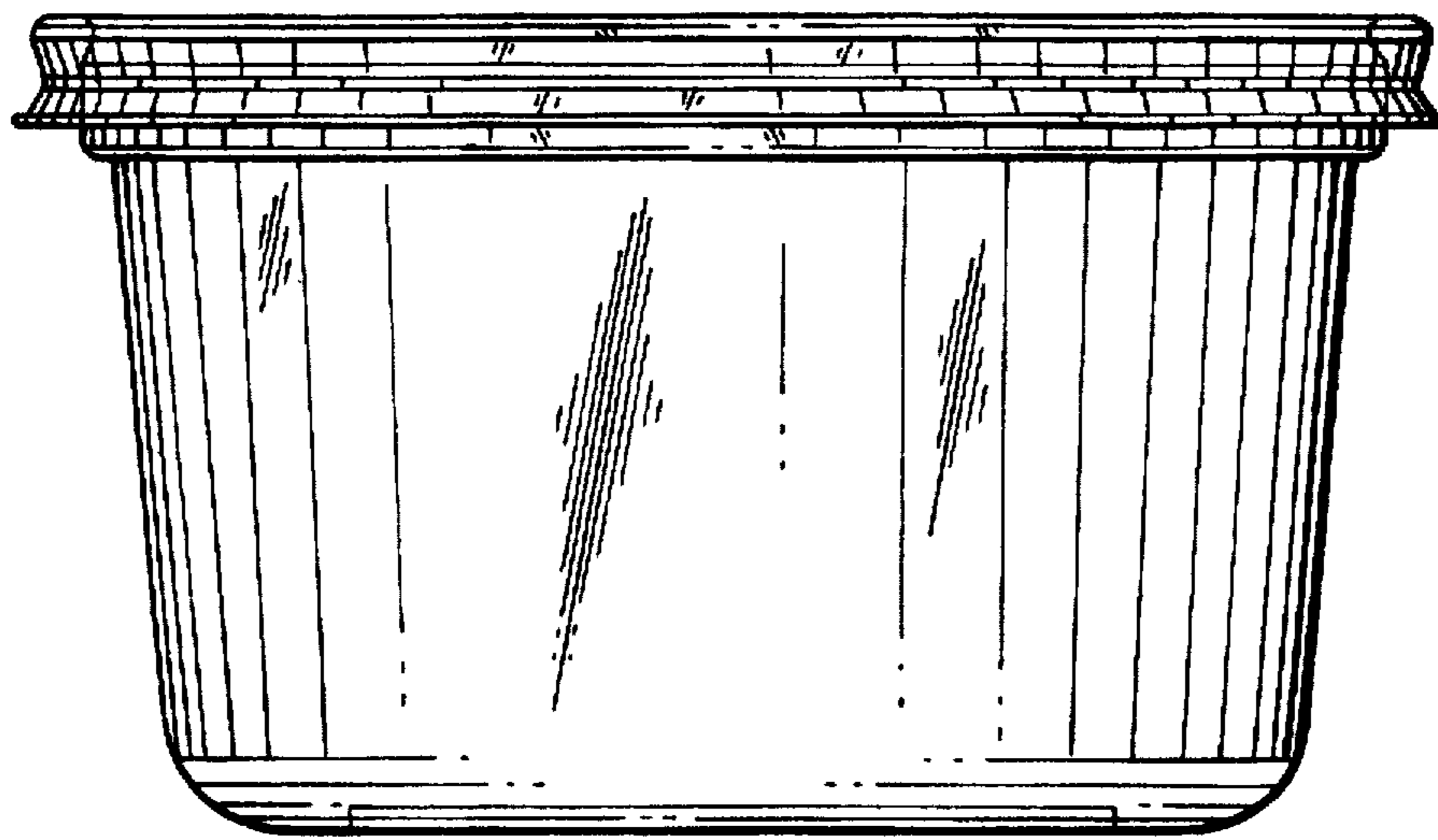
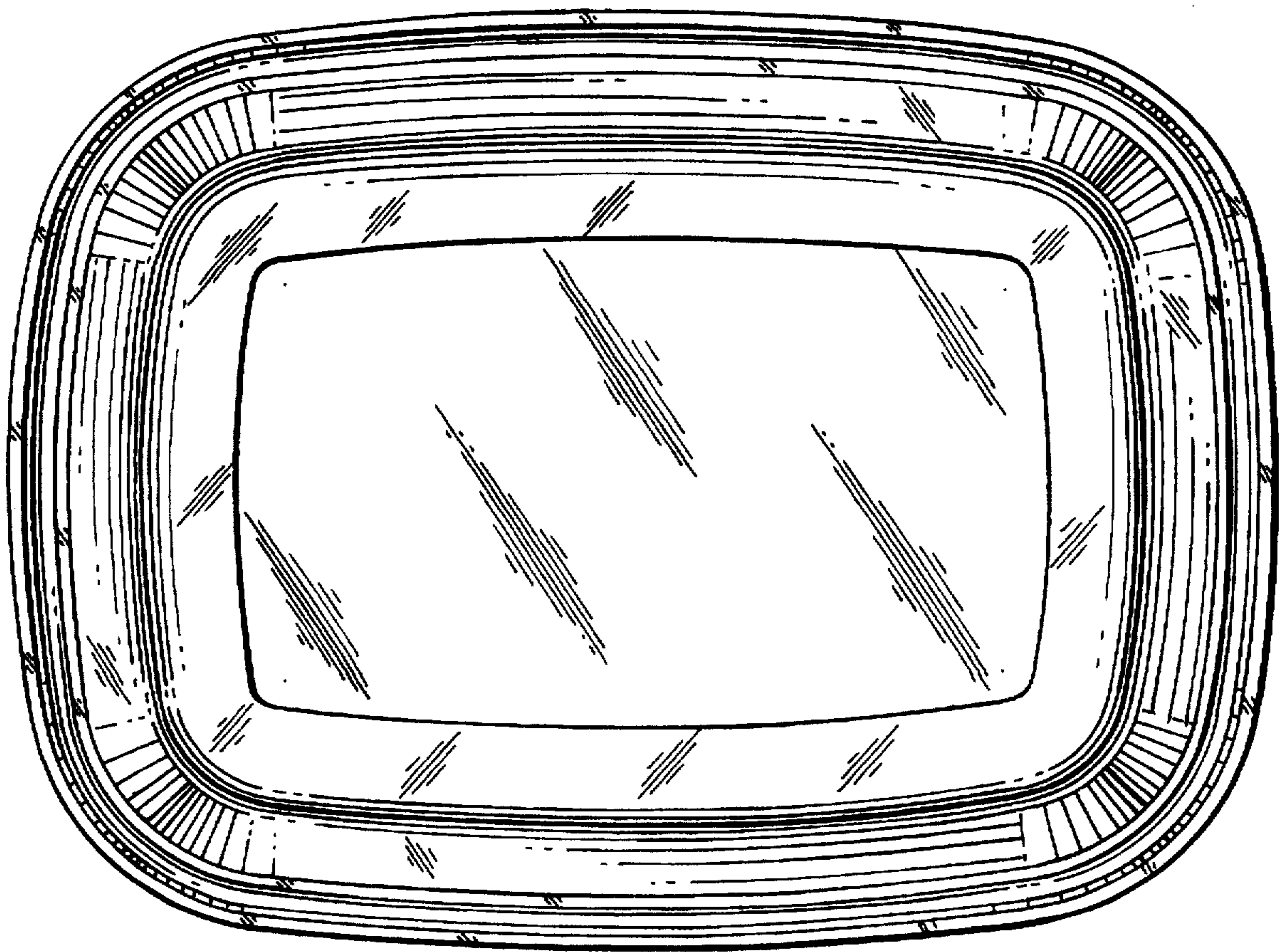

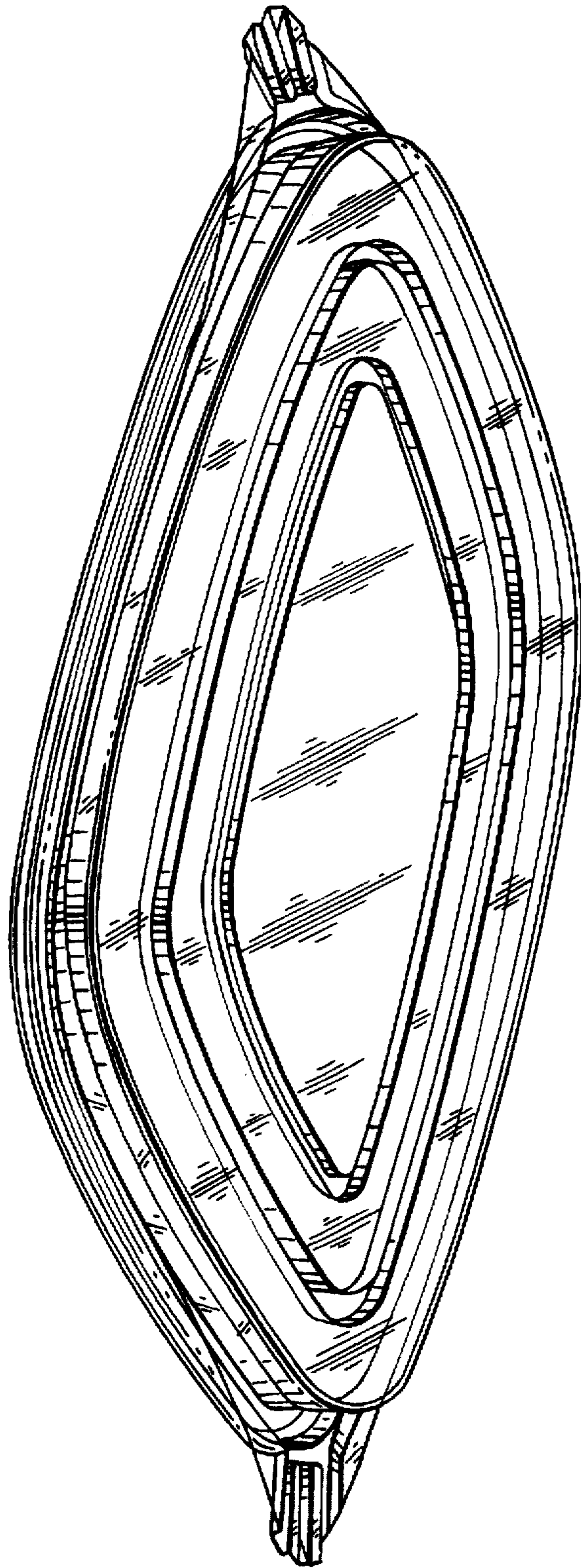
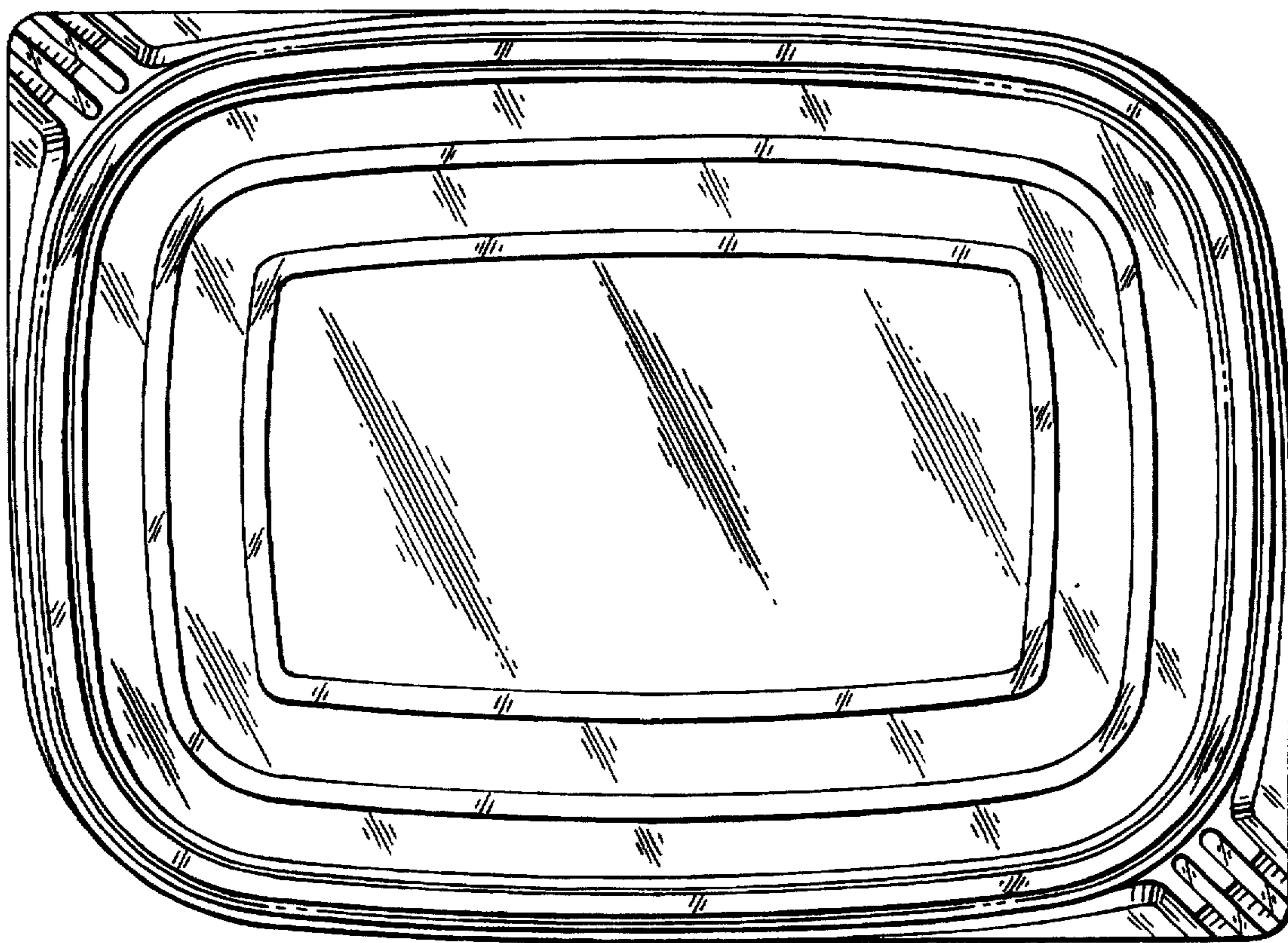

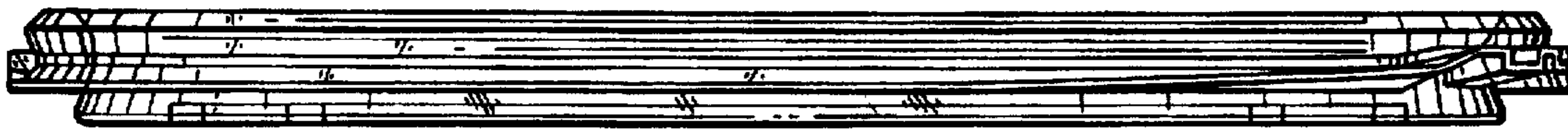

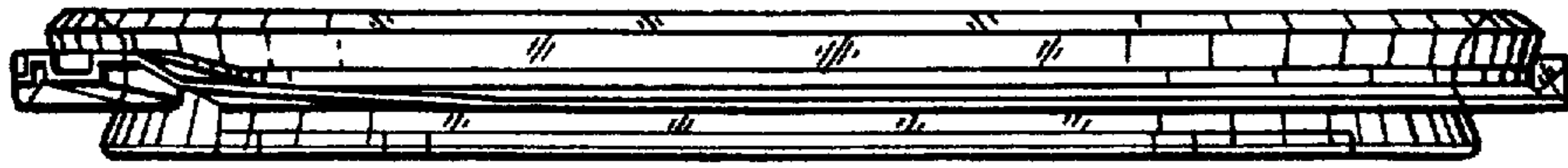

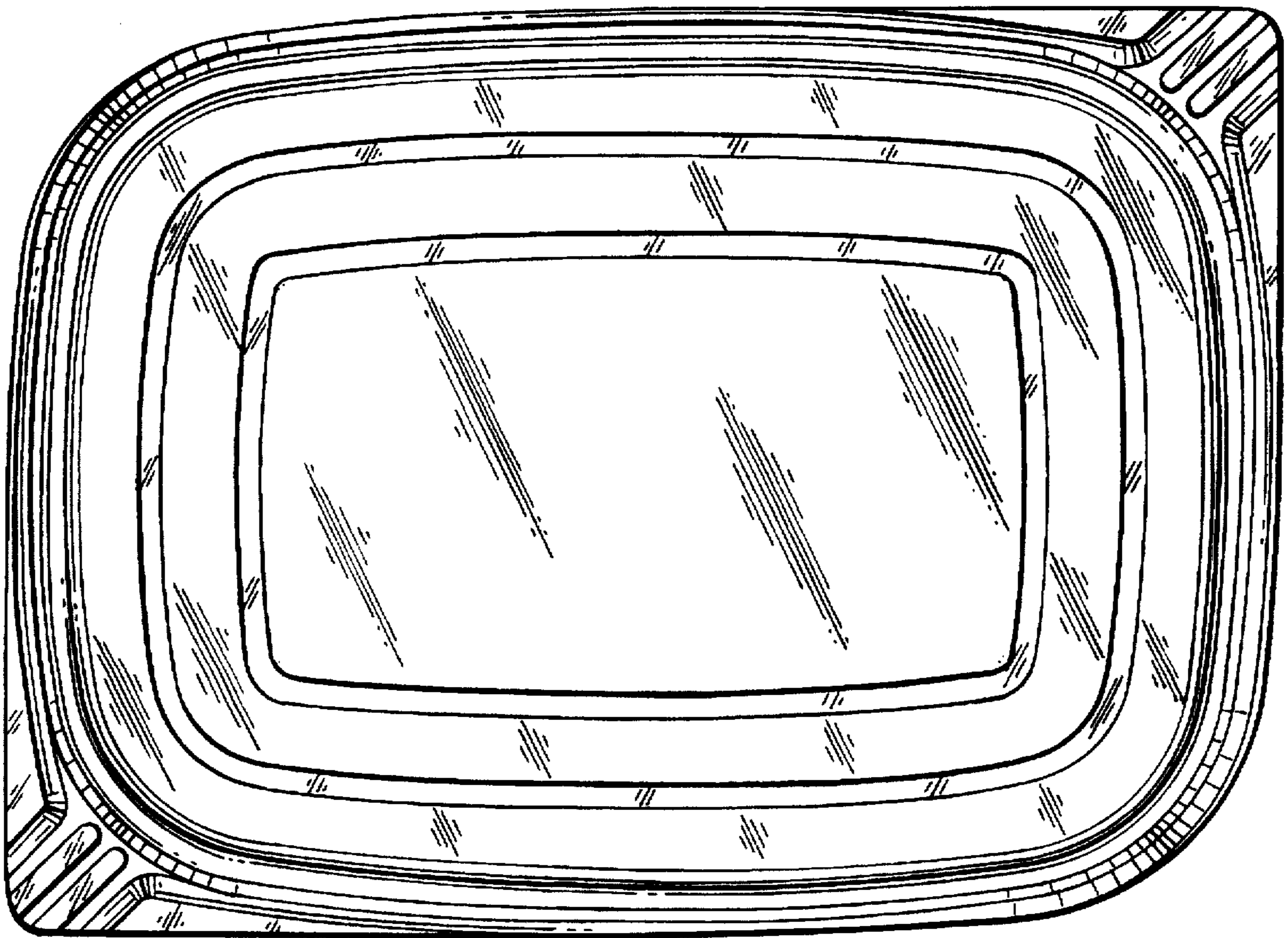

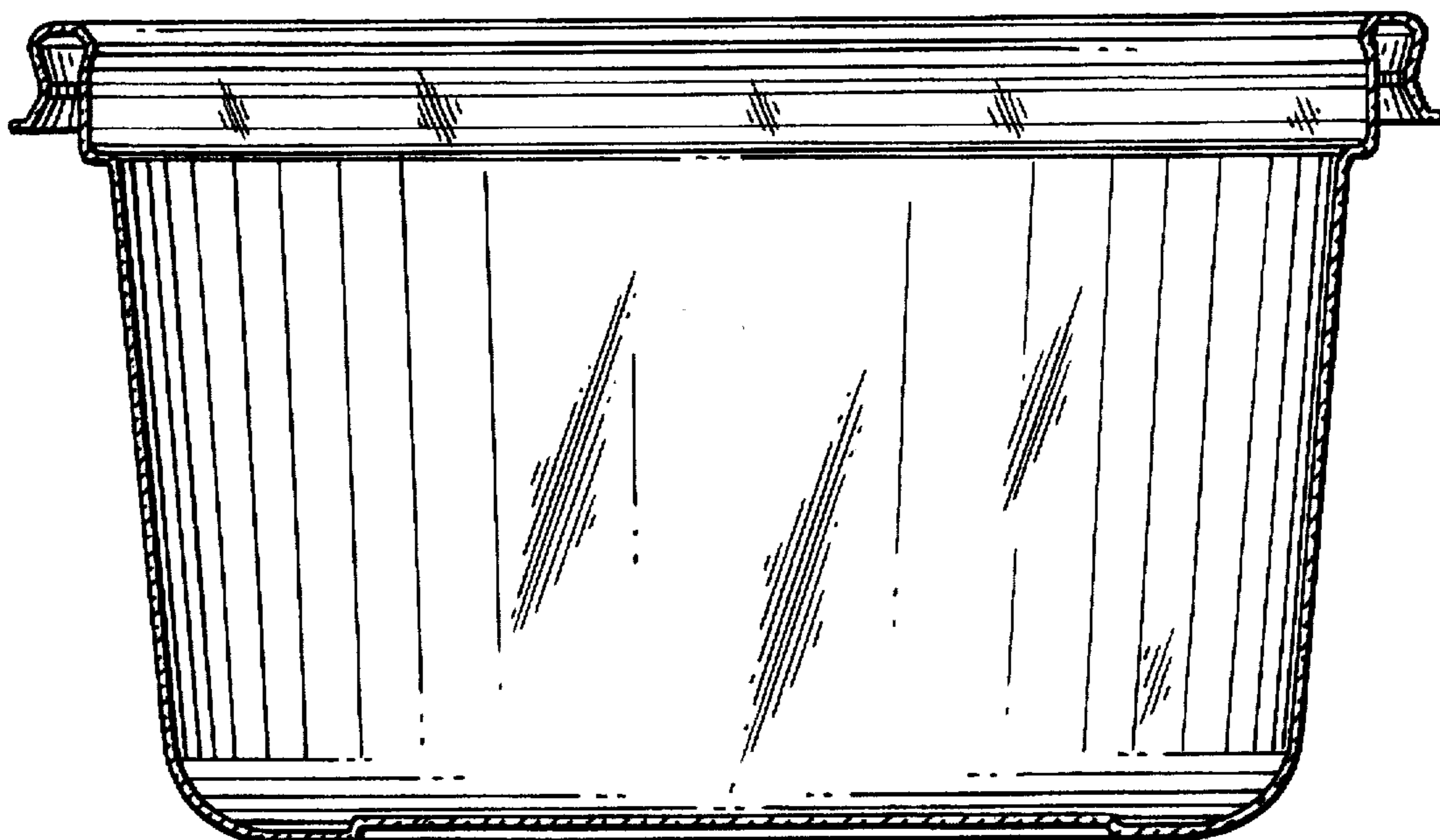
