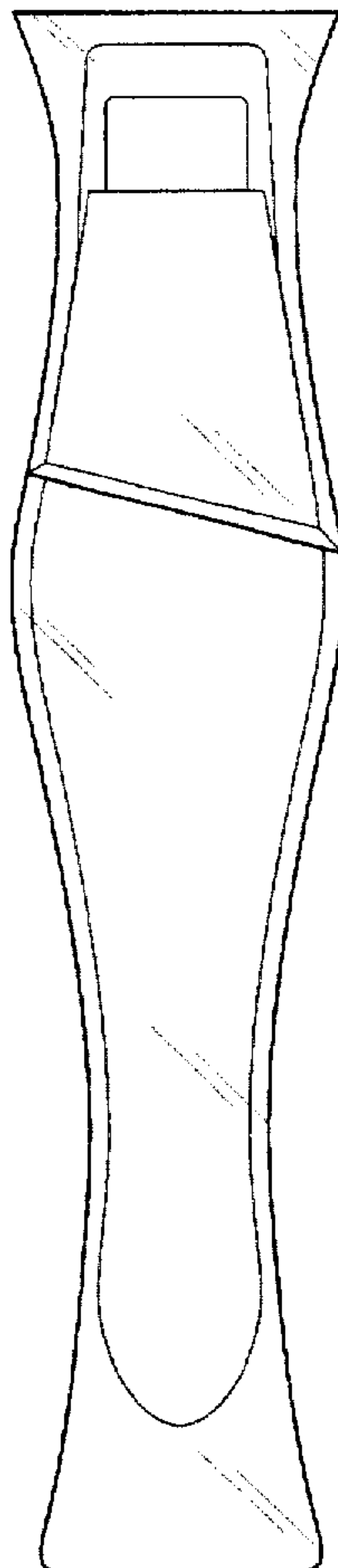
[57] **CLAIM**

The ornamental design for a combined fragrance container and cap, as shown and described.

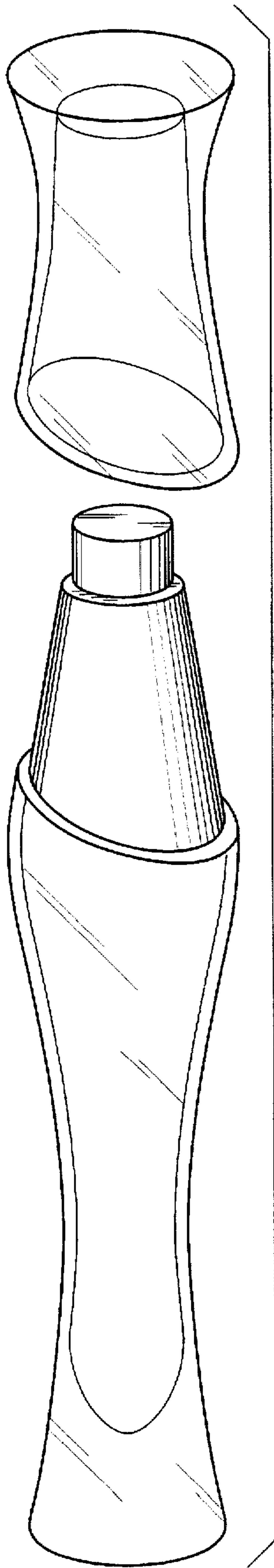
**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a combined fragrance container and cap showing my new design in an exploded condition;  
 FIG. 2 is a top, front and right side perspective view of the combined fragrance container and cap shown assembled;  
 FIG. 3 is a front elevation, the rear elevation is a mirror image thereto;  
 FIG. 4 is a right side elevation;  
 FIG. 5 is a left side elevation;  
 FIG. 6 is a top plan view of the container with the lid in place; and,  
 FIG. 7 is a bottom plan view of the container with the lid in place.

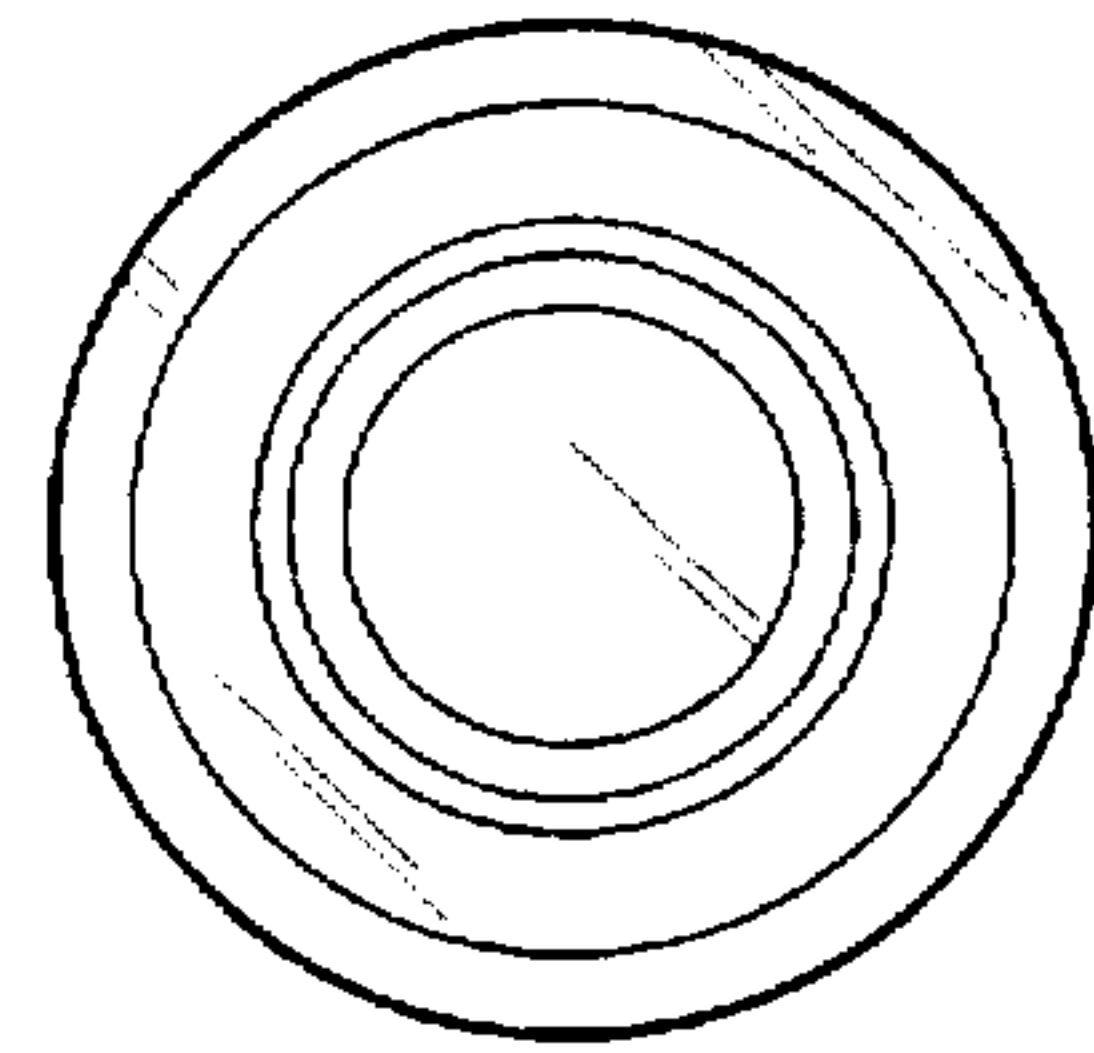

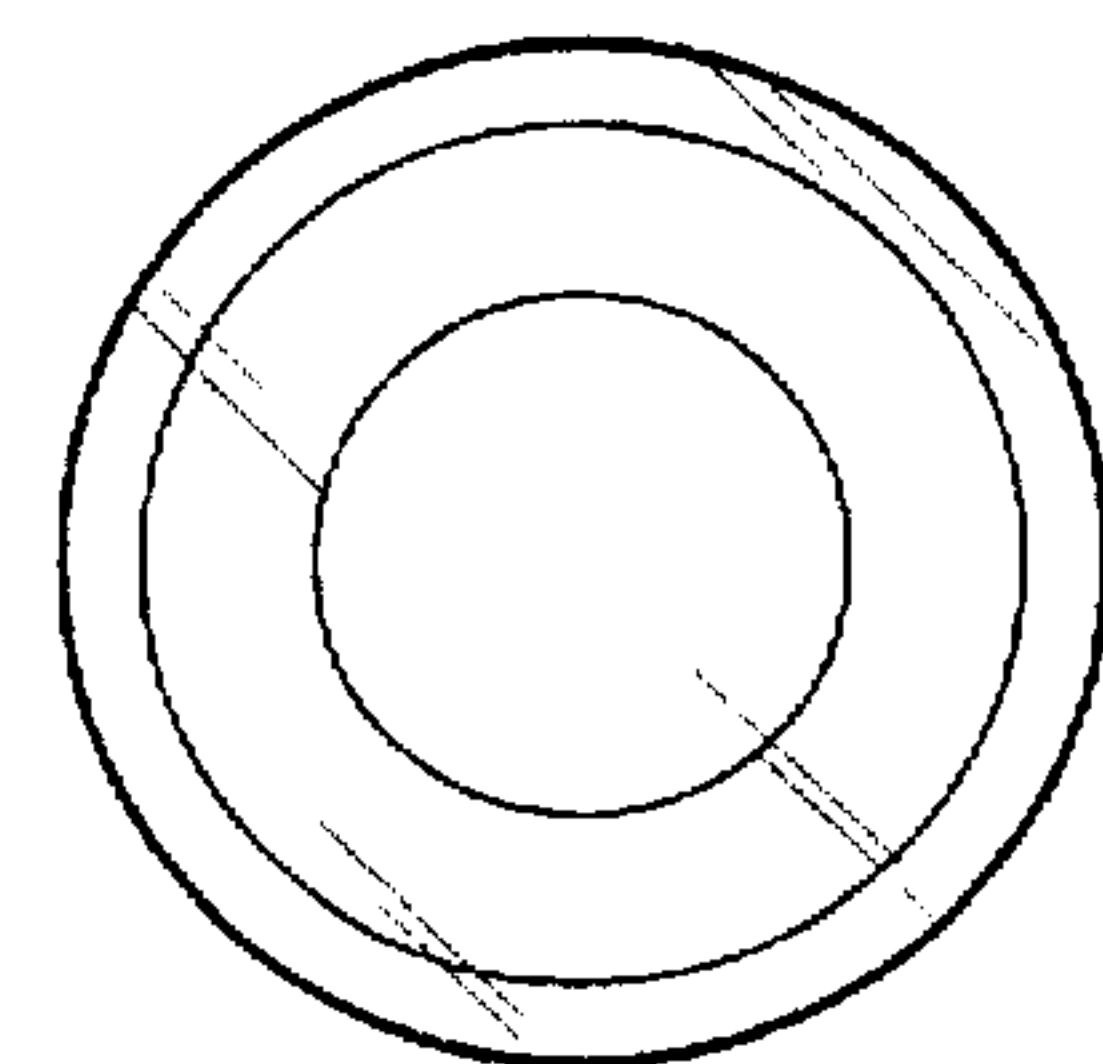

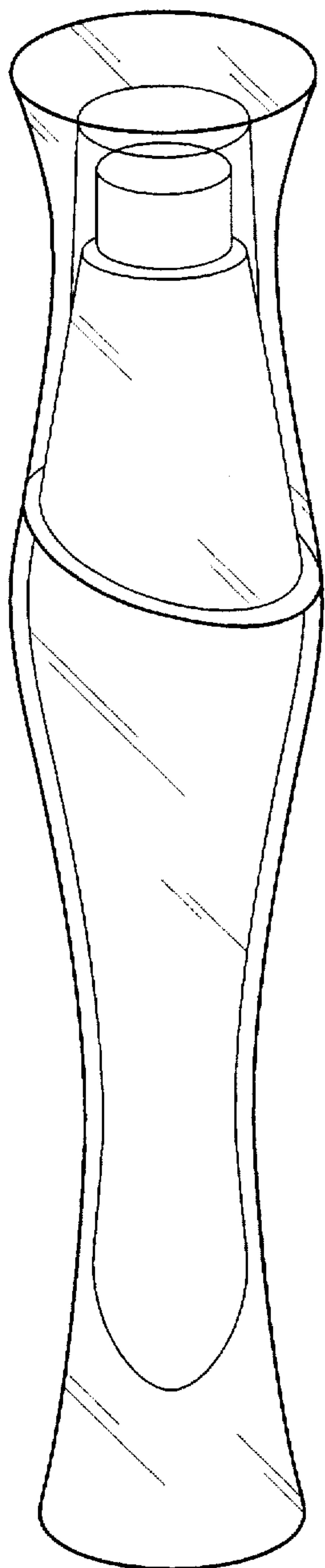

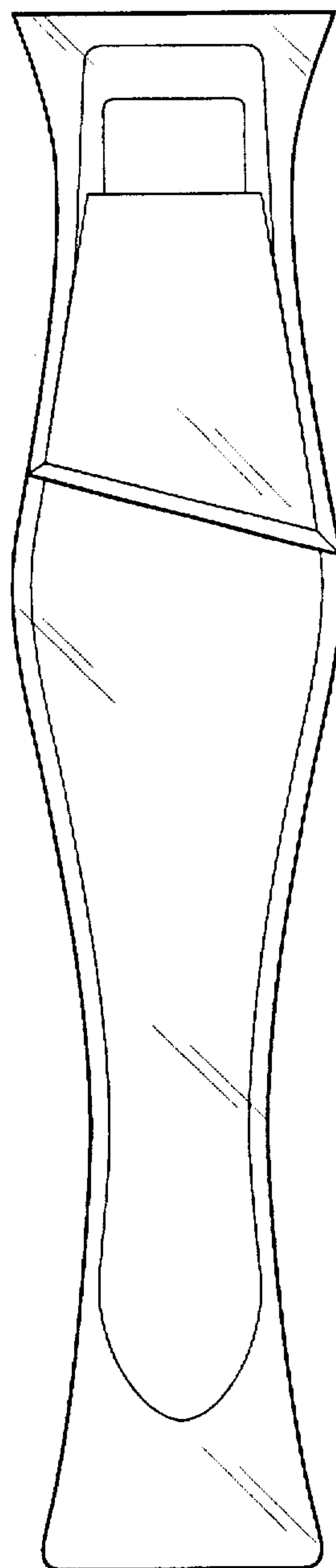

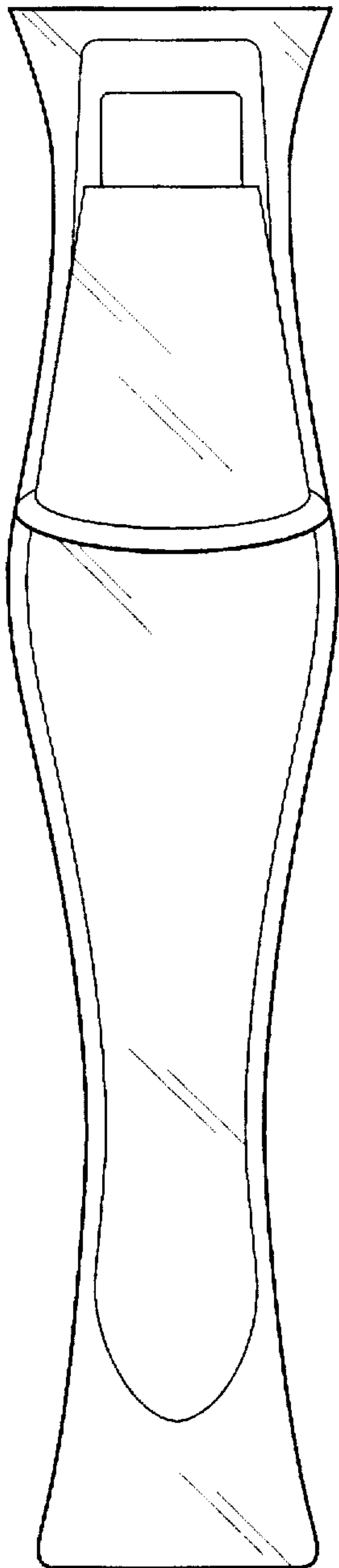
