[57] **CLAIM**

The ornamental design for a combined pendant and necklace, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged front view of a pendant-head portion of a combined pendant and necklace showing my design; FIG. 2 is an enlarged perspective view of a pendant-head portion of a partial necklace of FIG. 1; FIG. 3 is a front view of a combined pendant and necklace showing my design; FIG. 4 is a left-side view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a plan view thereof; and, FIG. 8 is a bottom view thereof.

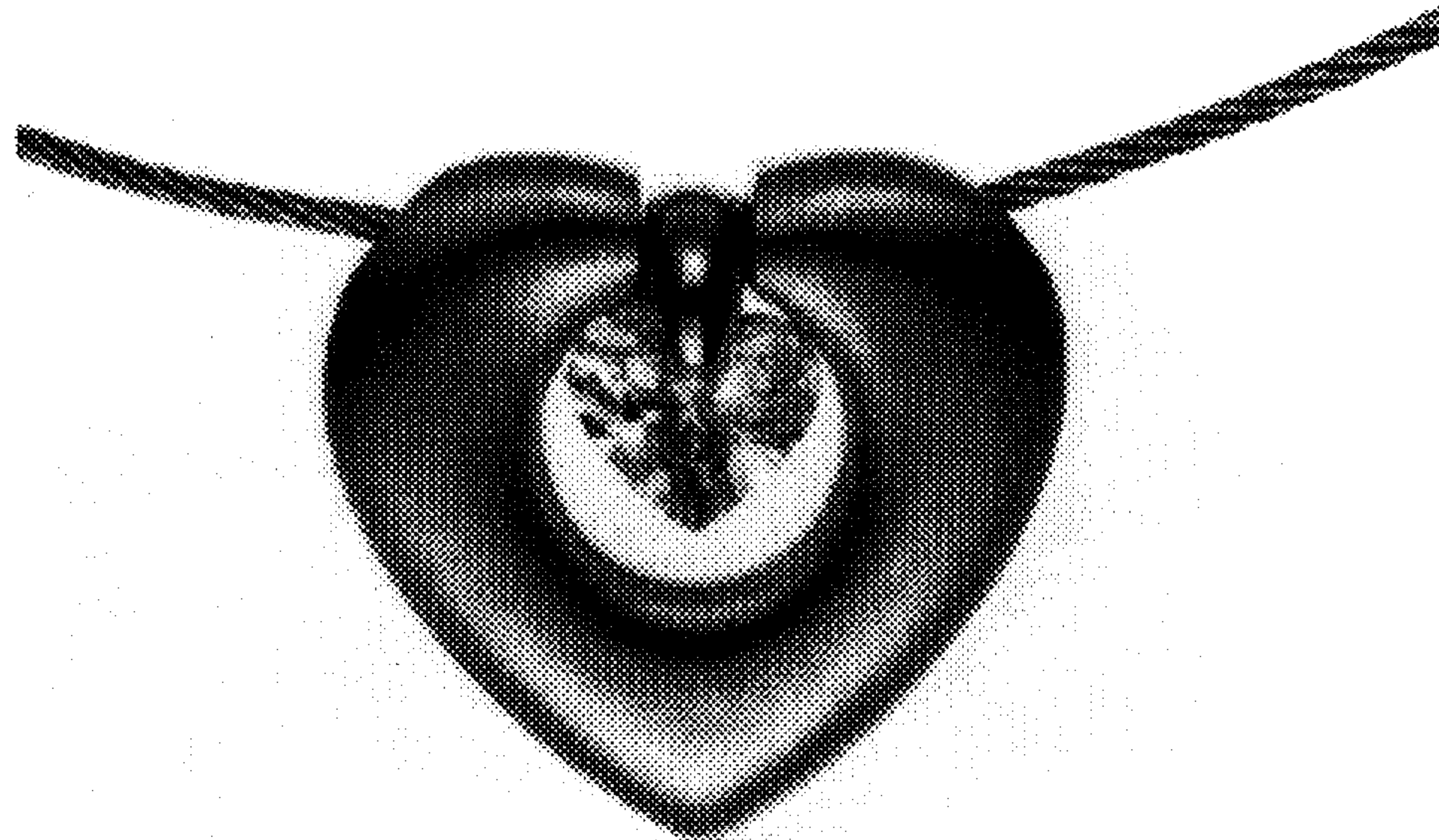

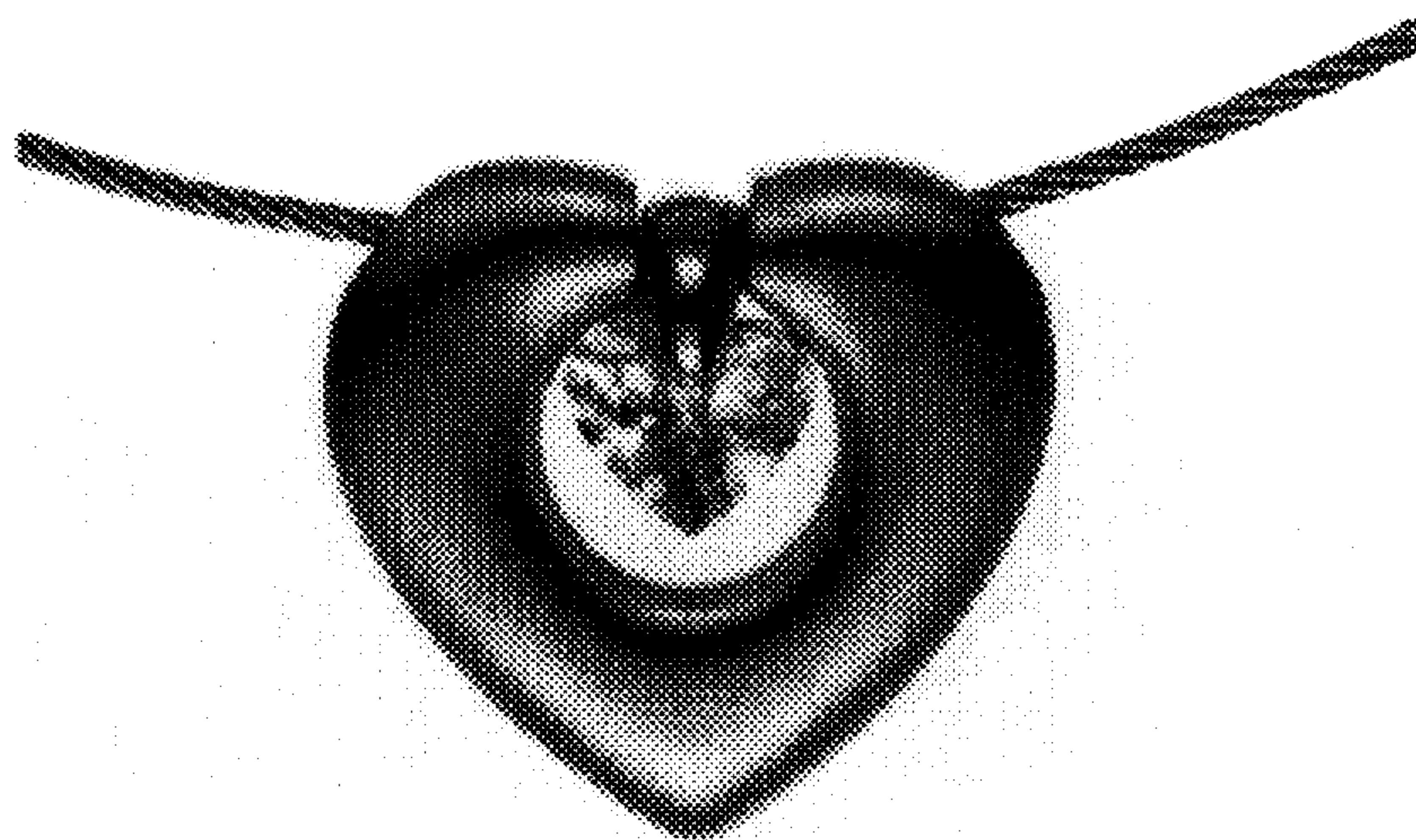

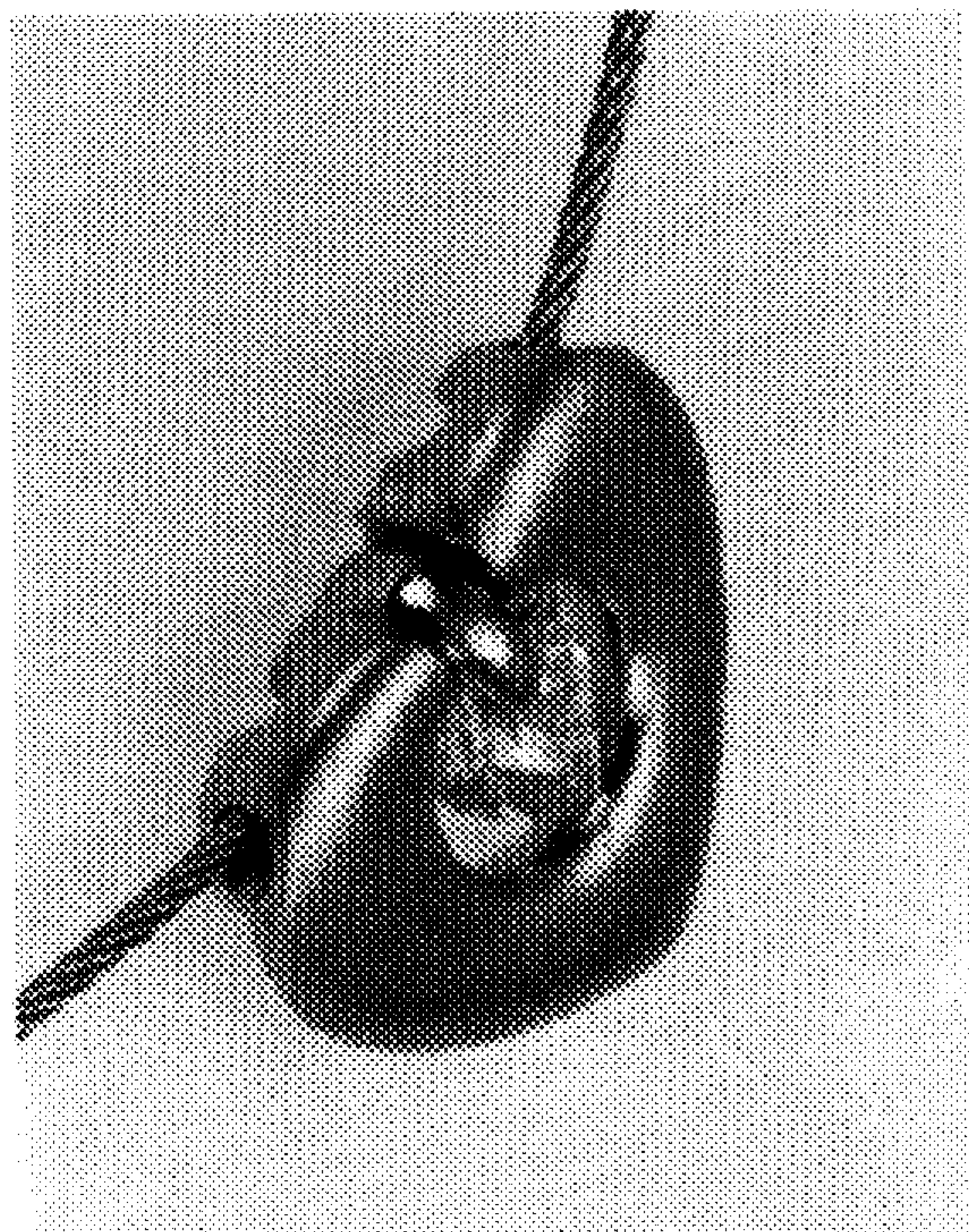

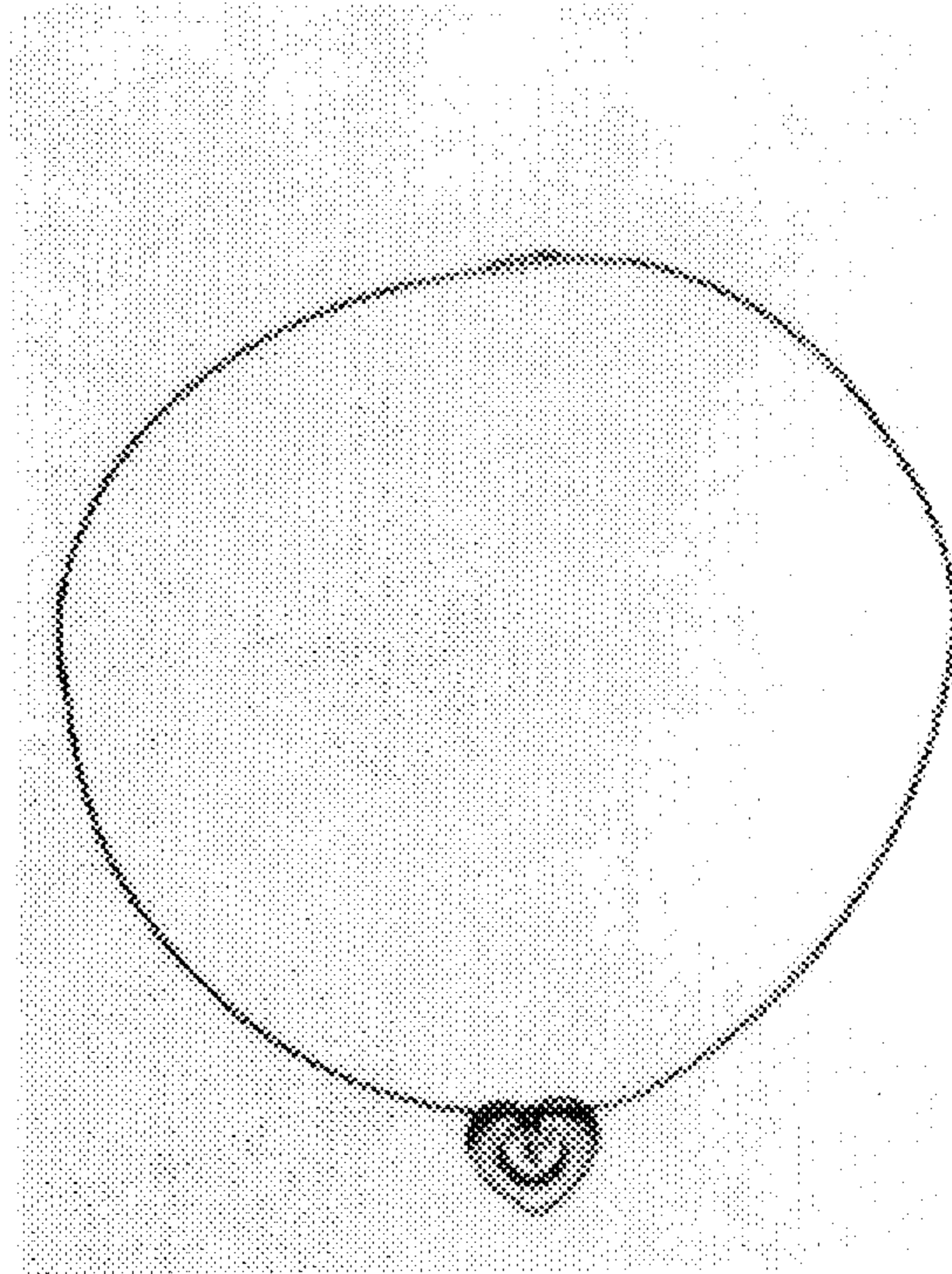

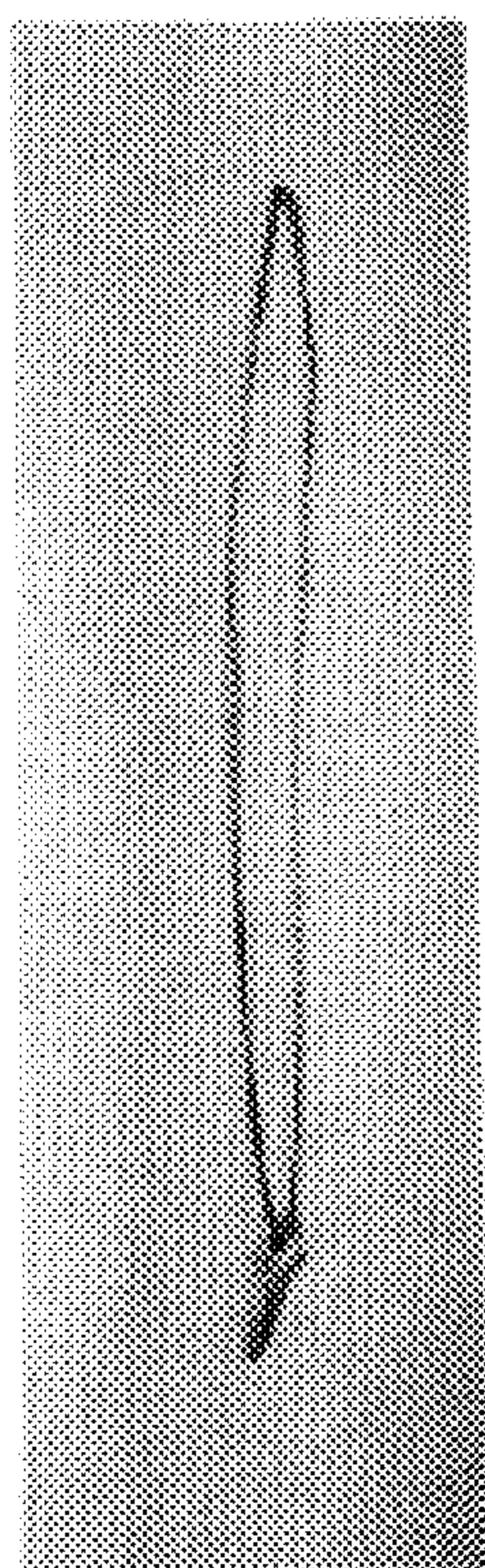

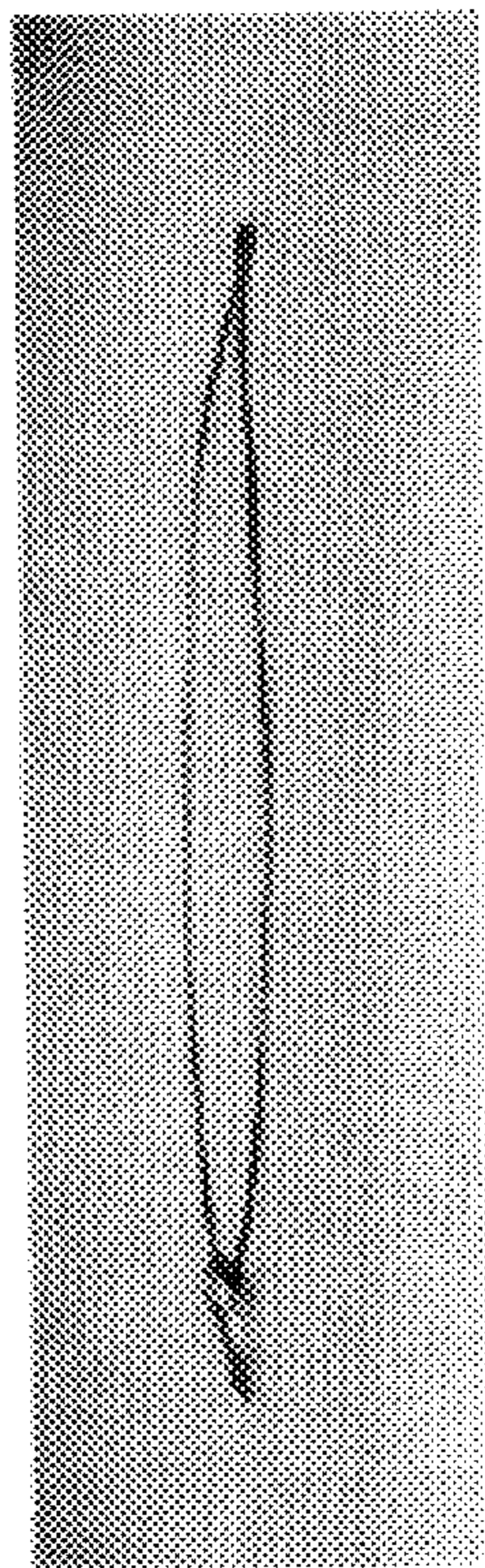

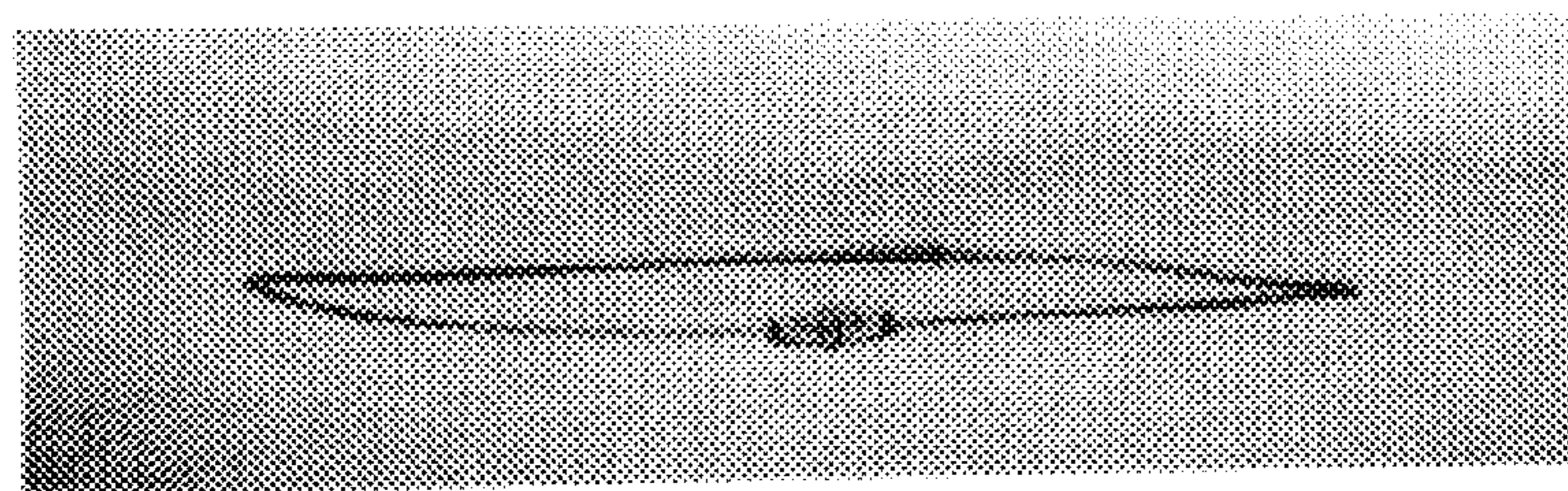
