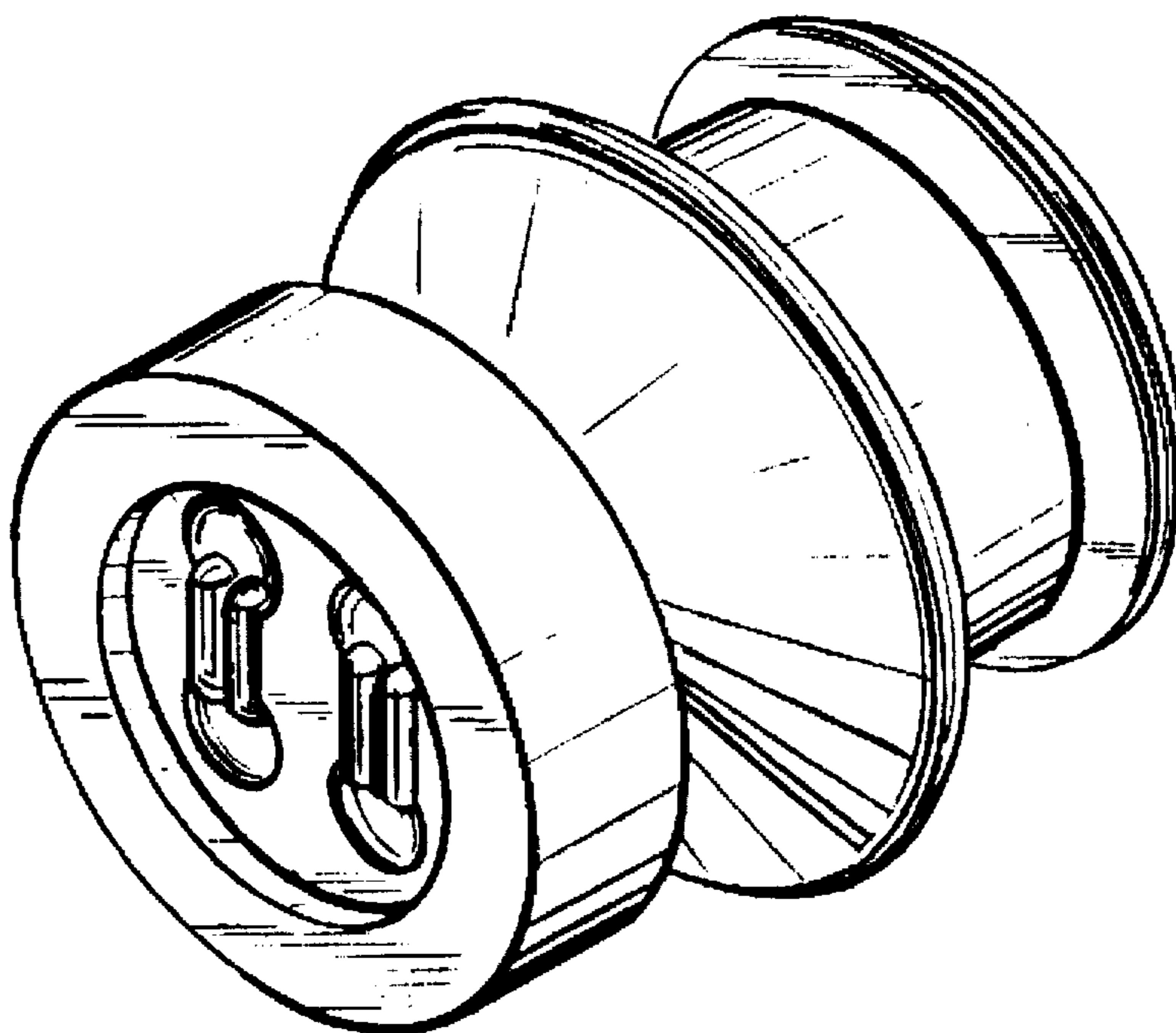

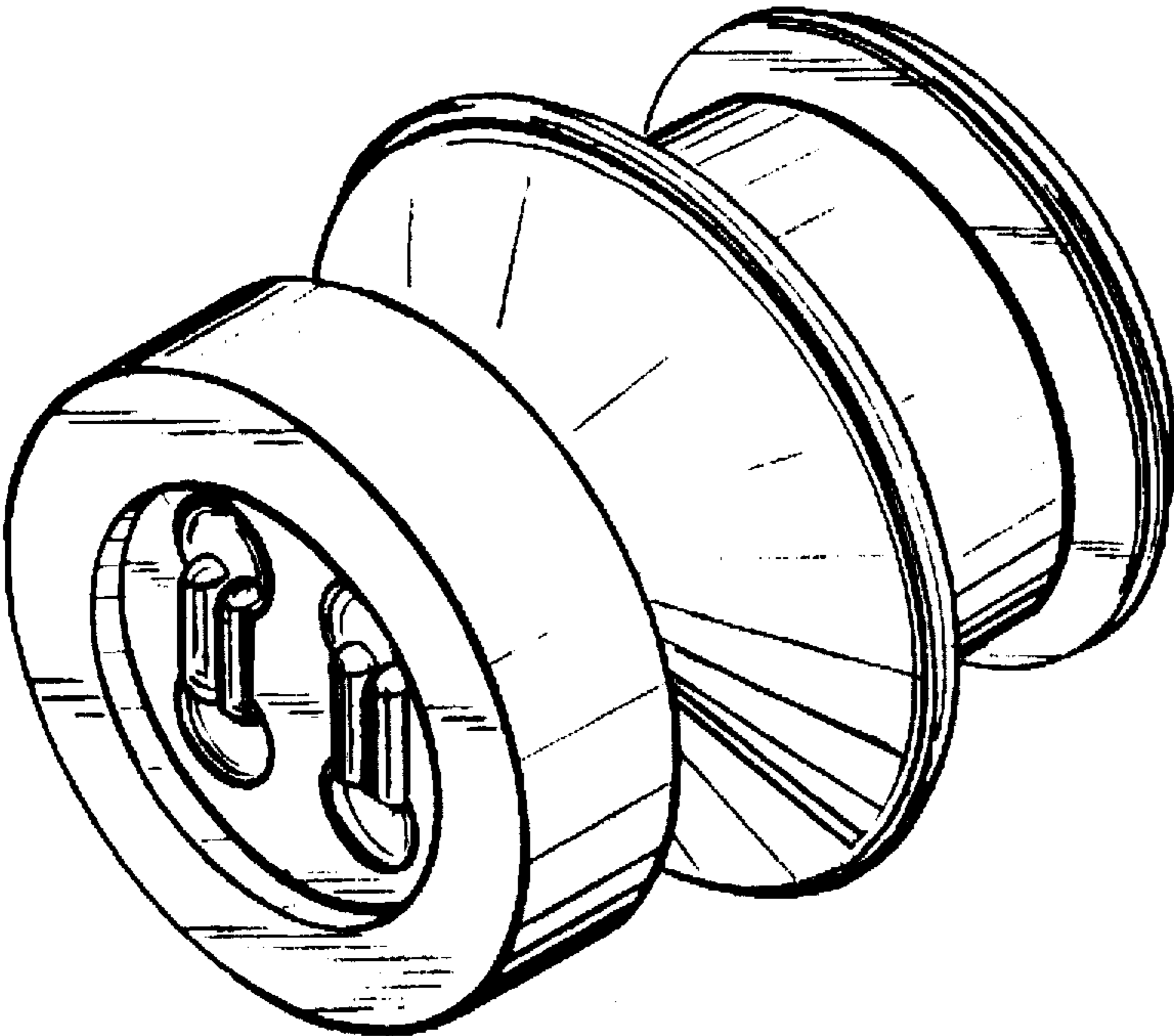
The ornamental design for a releasably locking button pin, as shown and described.

**DESCRIPTION**

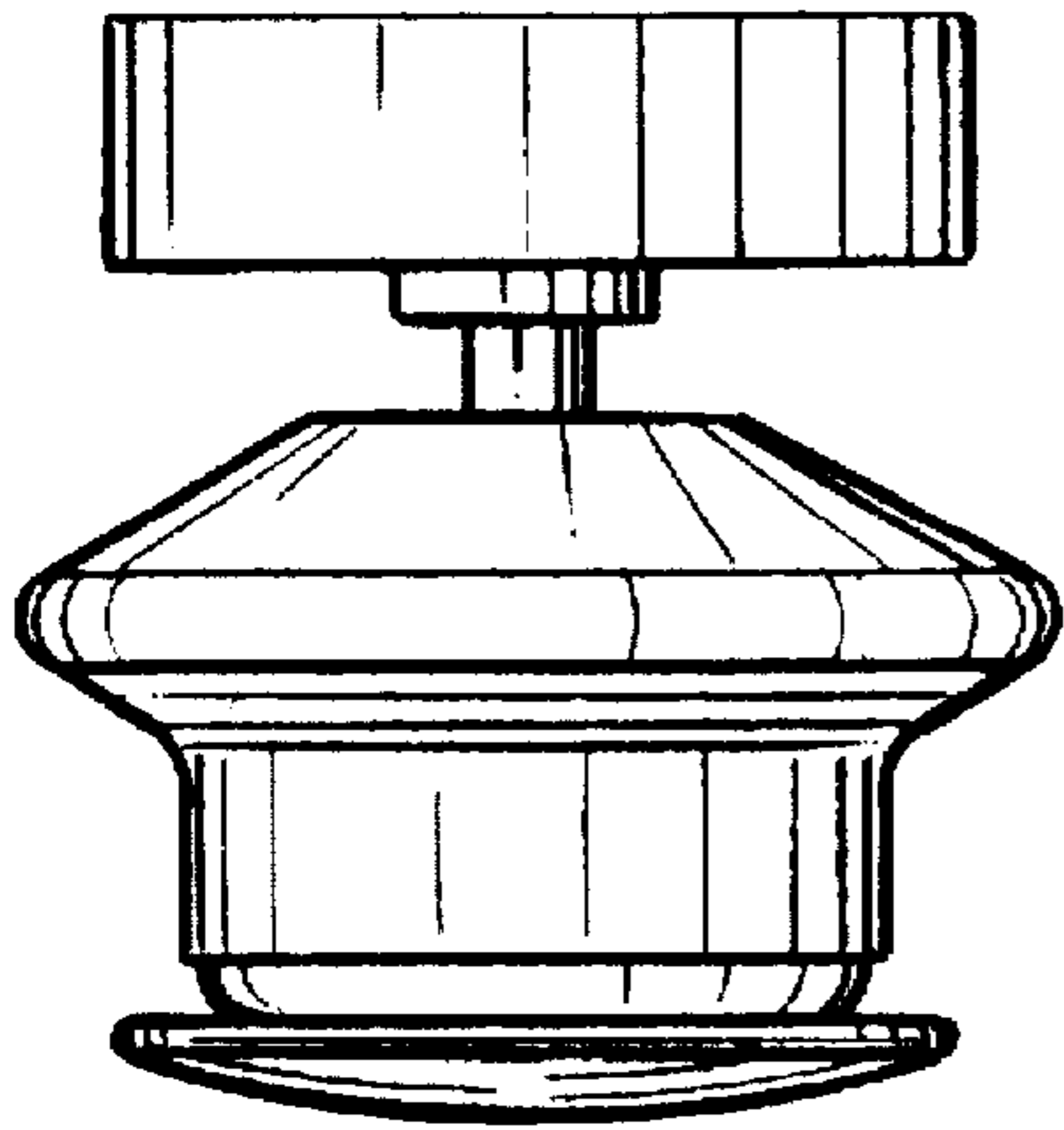
FIG. 1 is a perspective view of our releasably locking button pin;

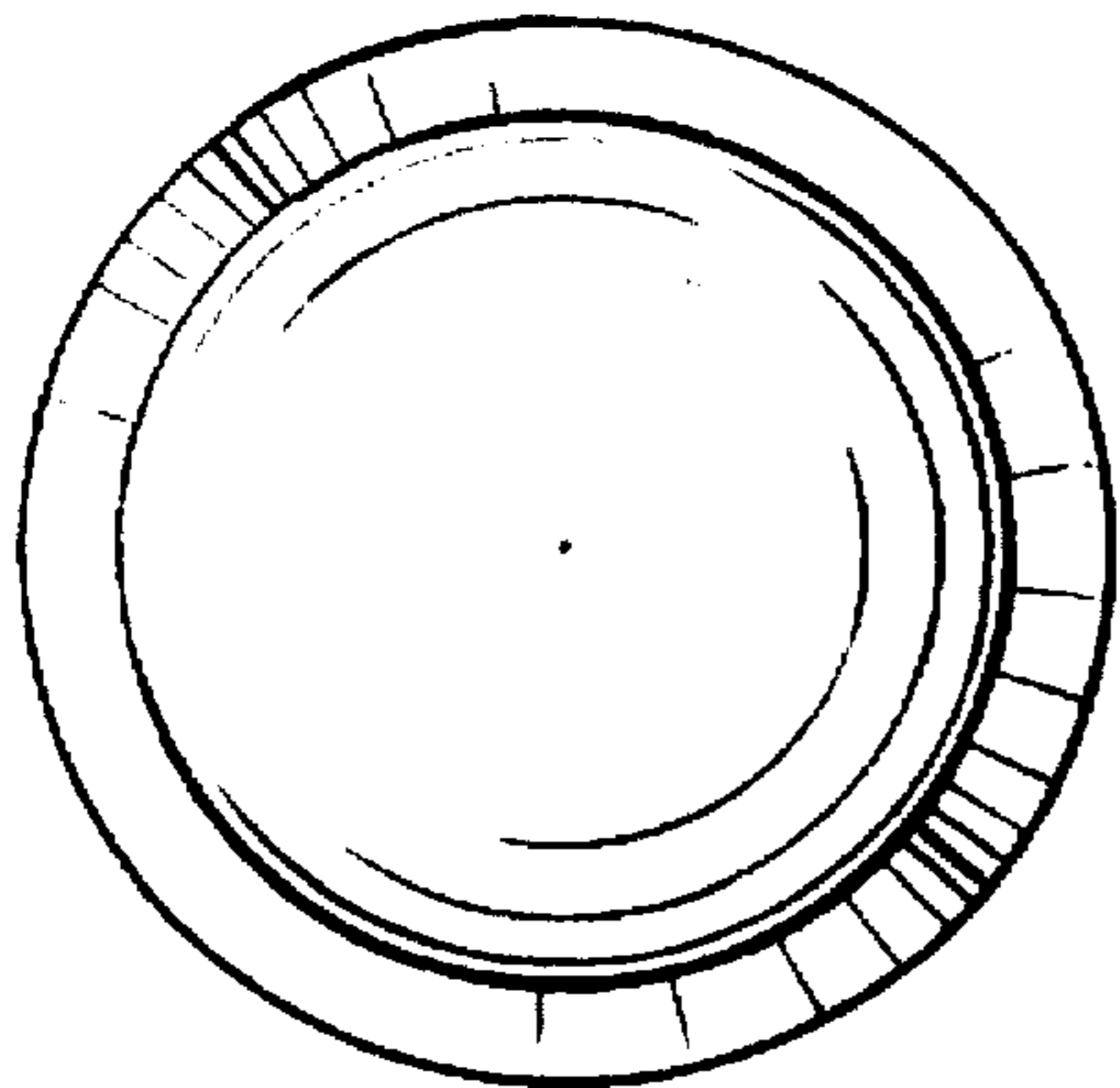
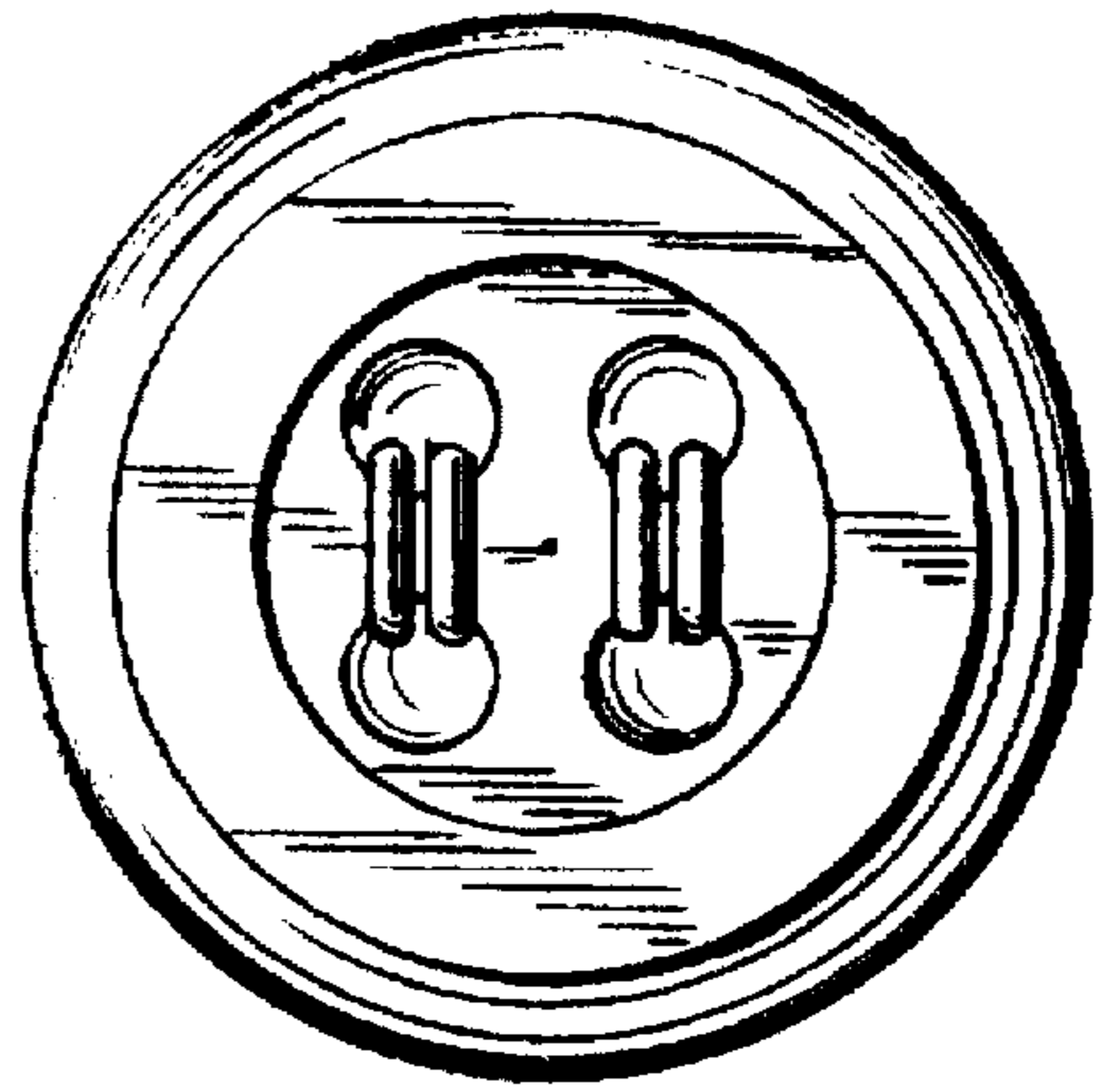
