**DESCRIPTION**

FIG. 1 is a top perspective view of a card reader showing my new design;  
FIG. 2 is a bottom perspective view of the card reader of FIG. 1;

FIG. 4 is a right side elevational view of the card reader of FIG. 1;

FIG. 7 is a bottom plan view of the card reader of FIG. 1; and,  
FIG. 8 is a back end elevational view of the card reader of FIG. 1.

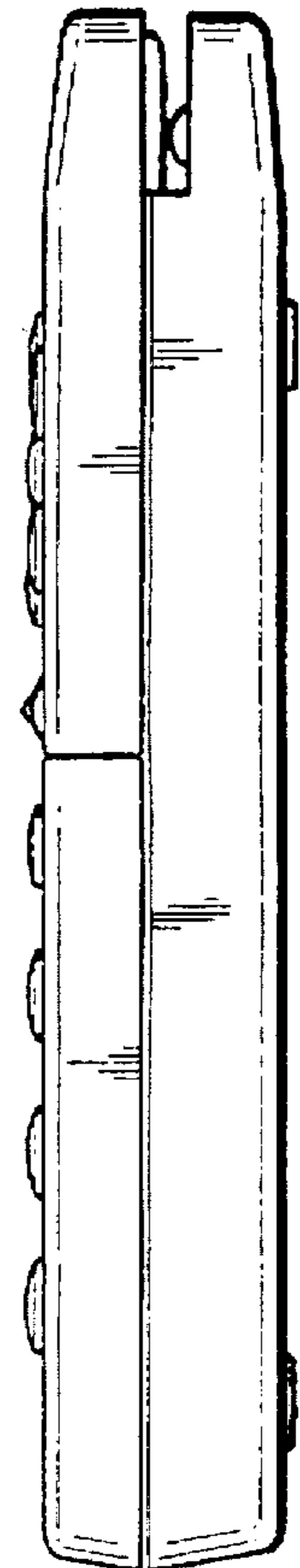
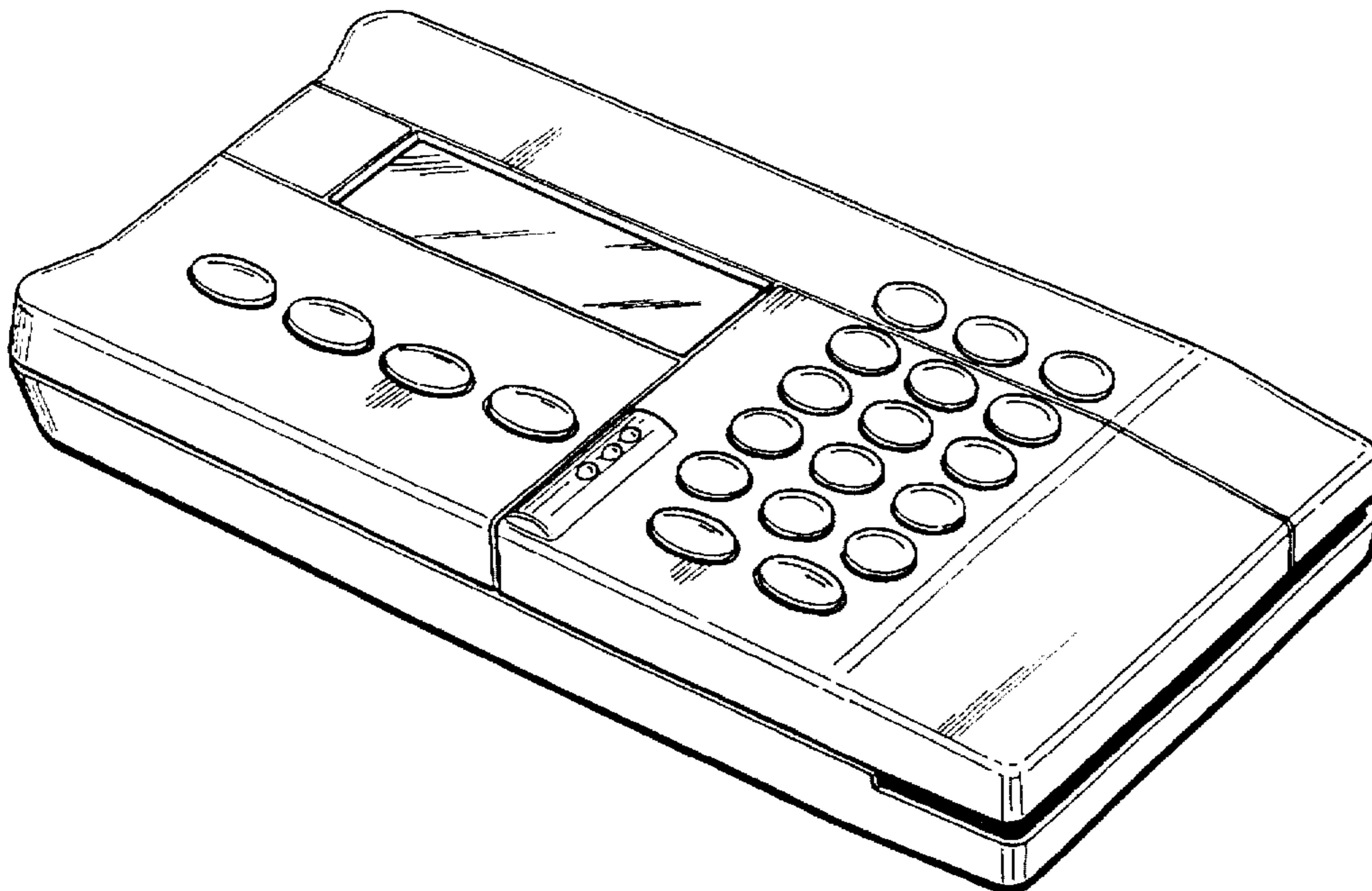

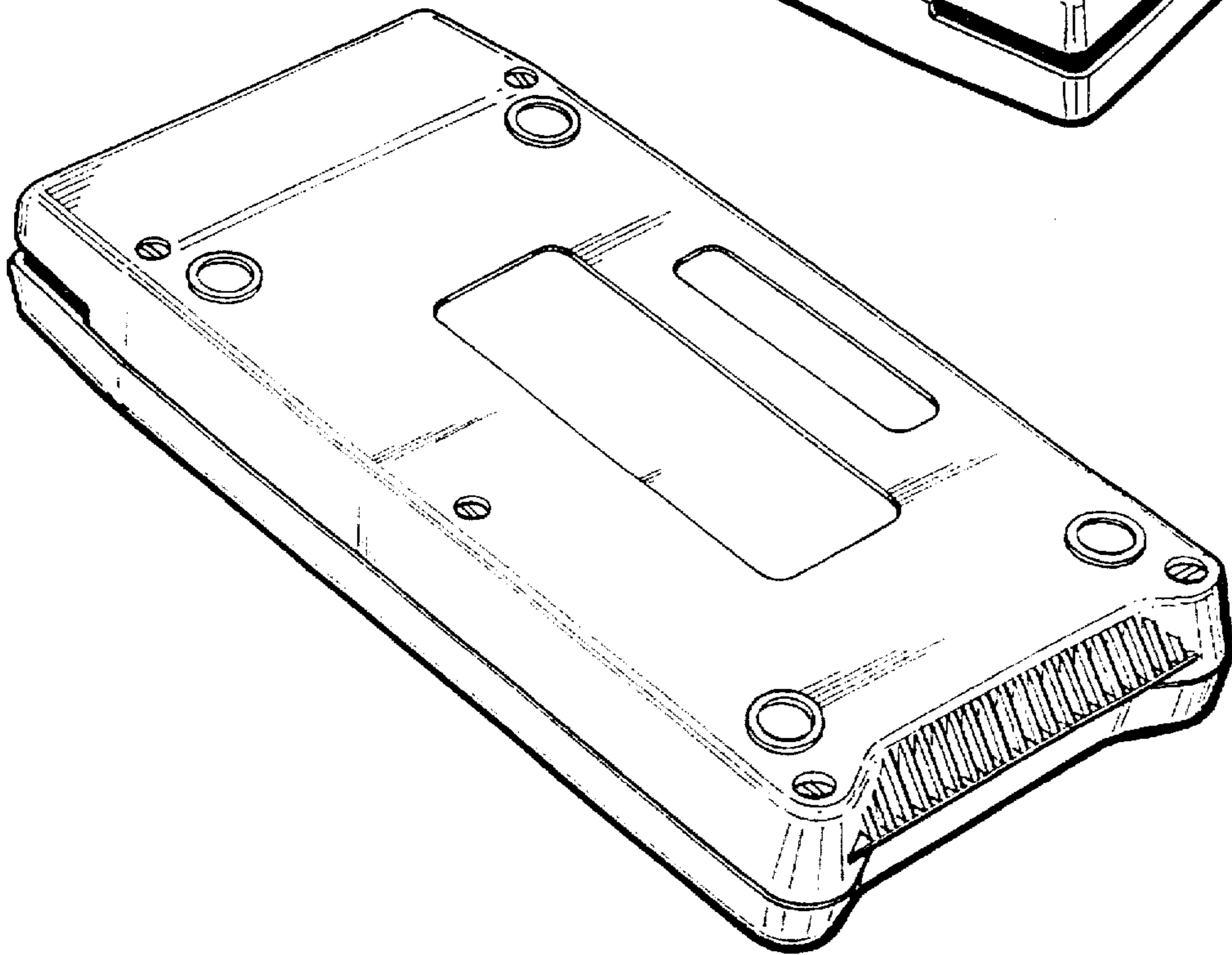
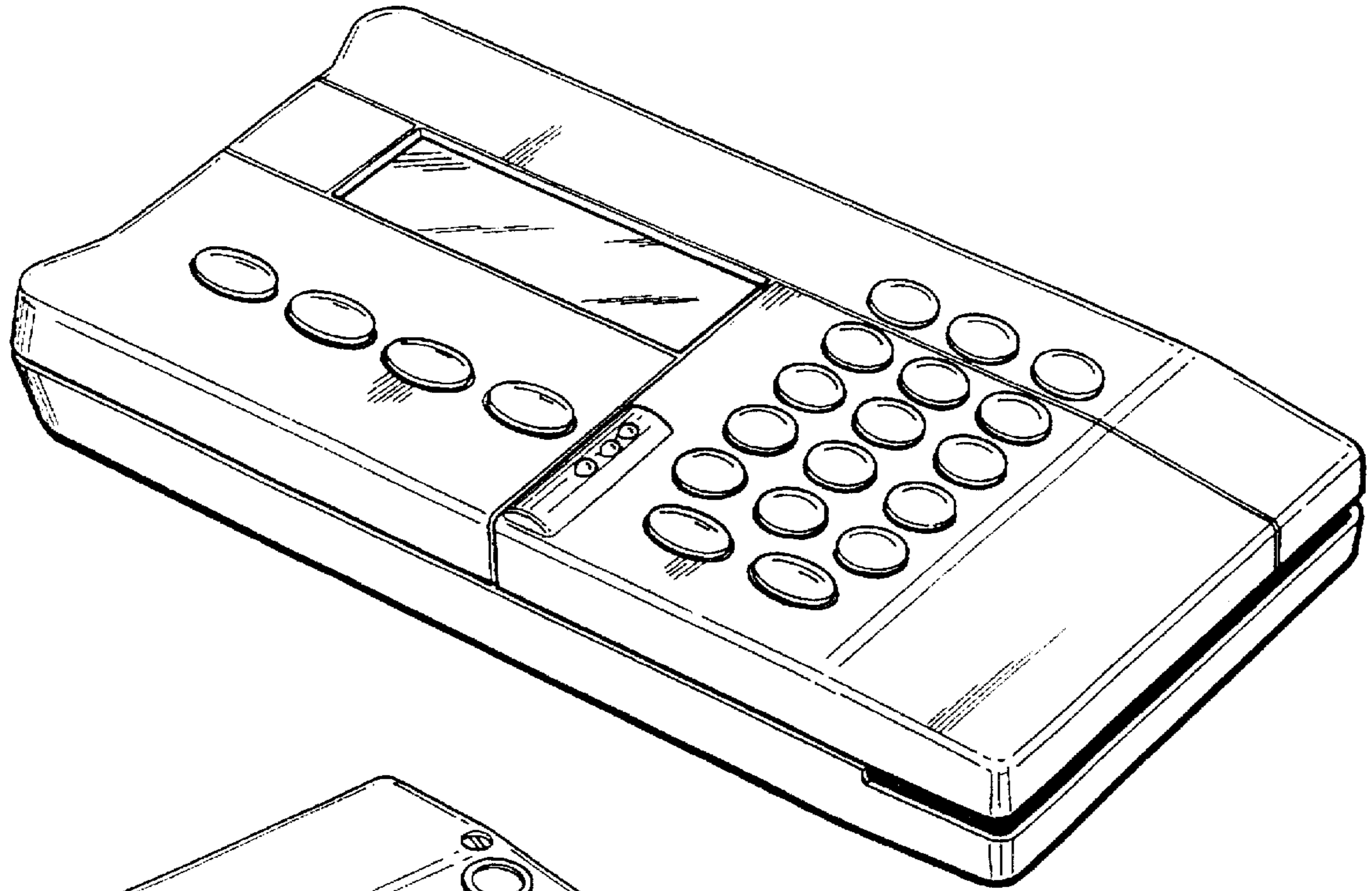

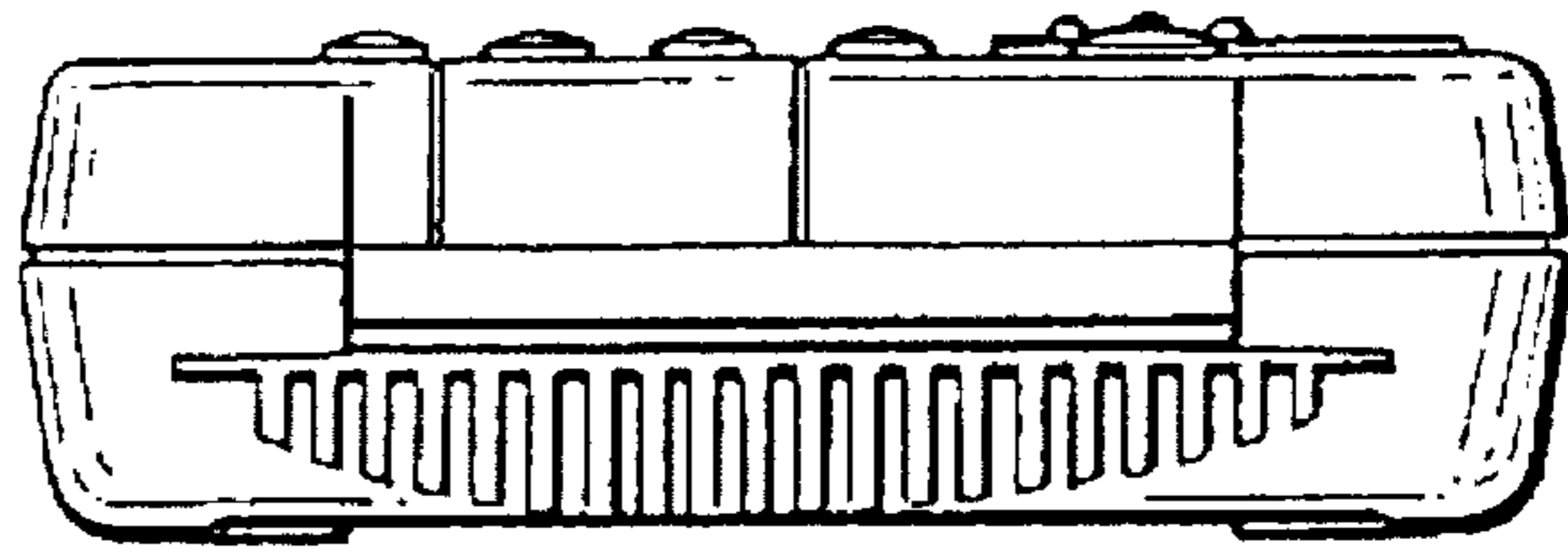

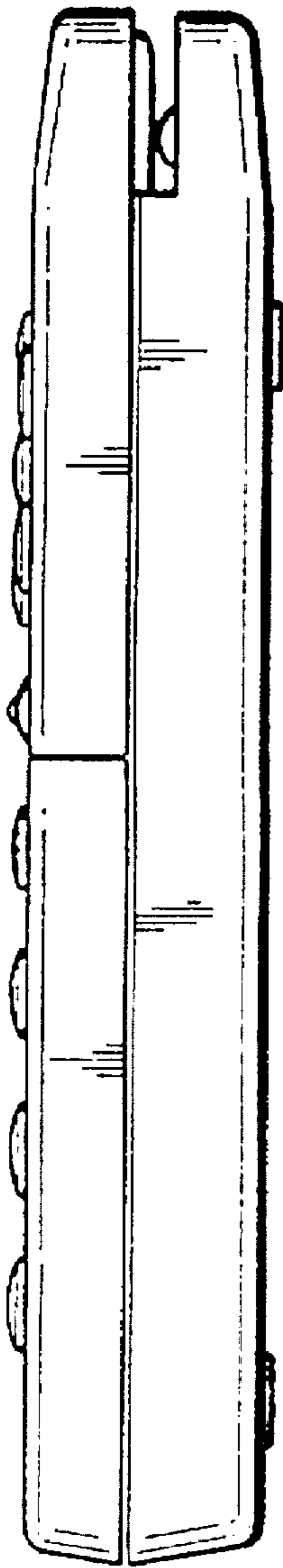

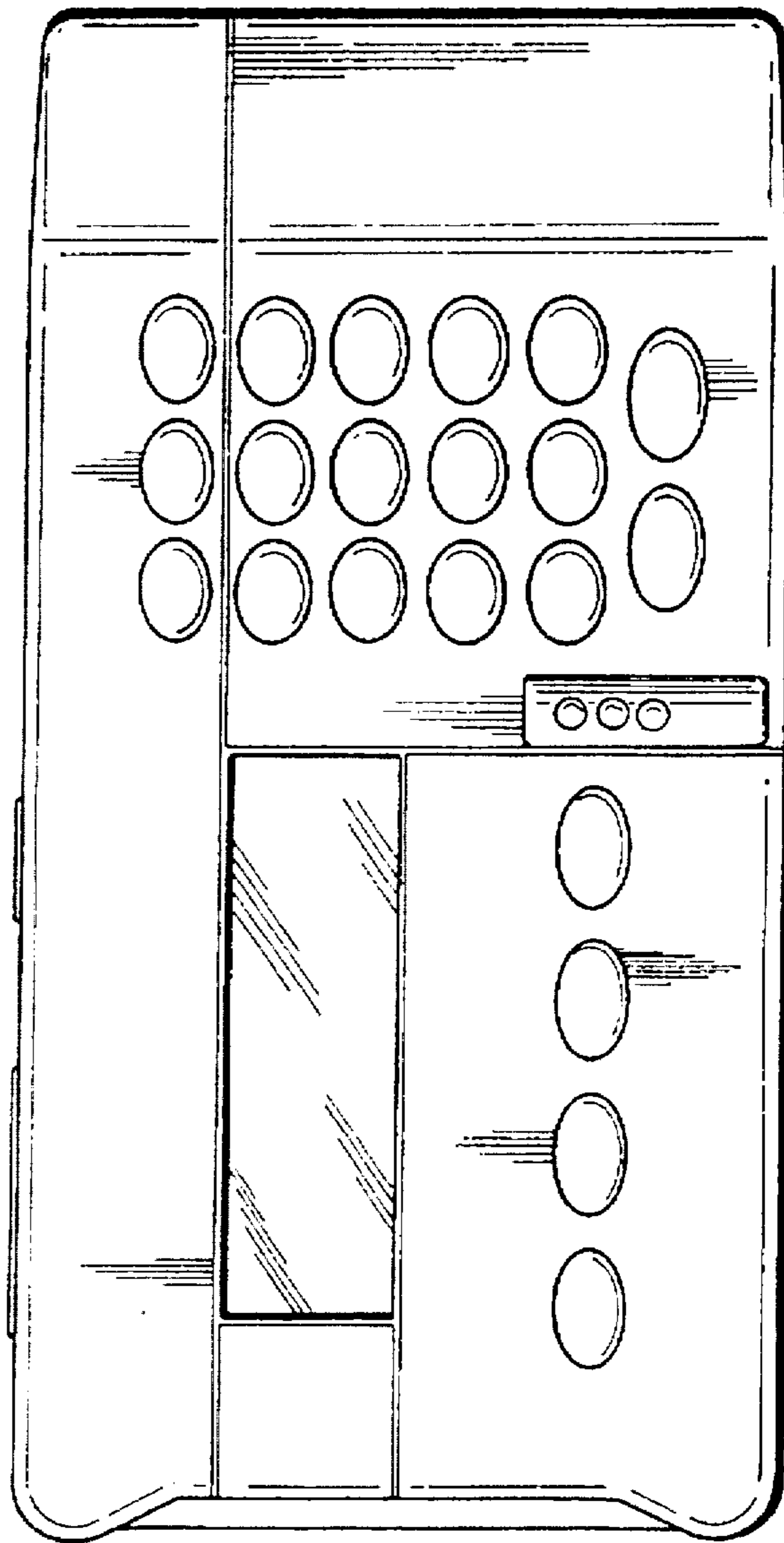

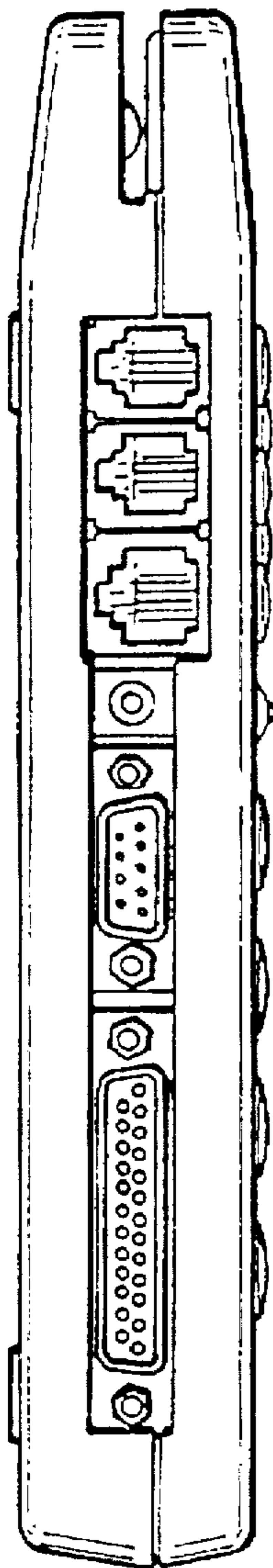

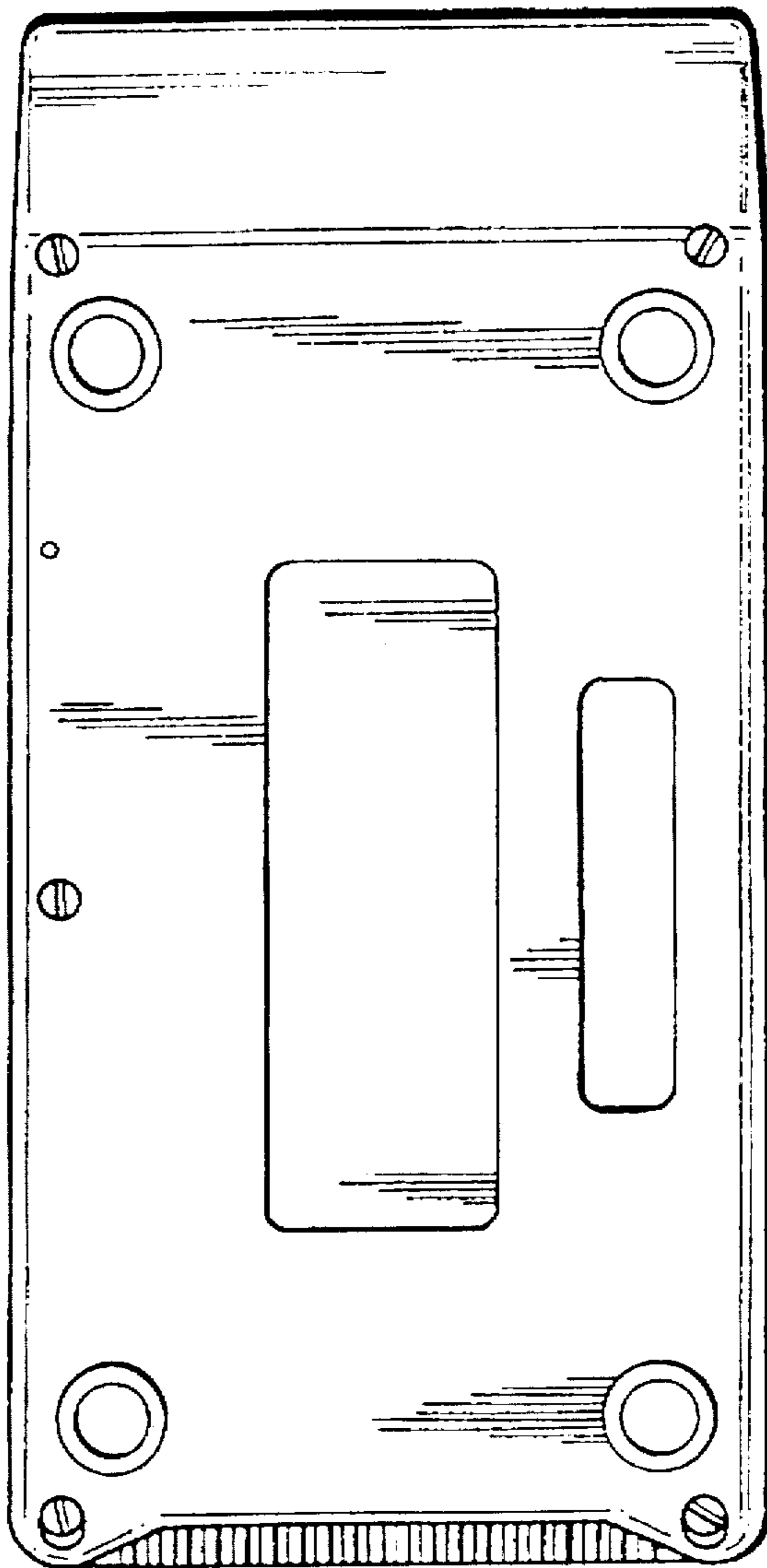

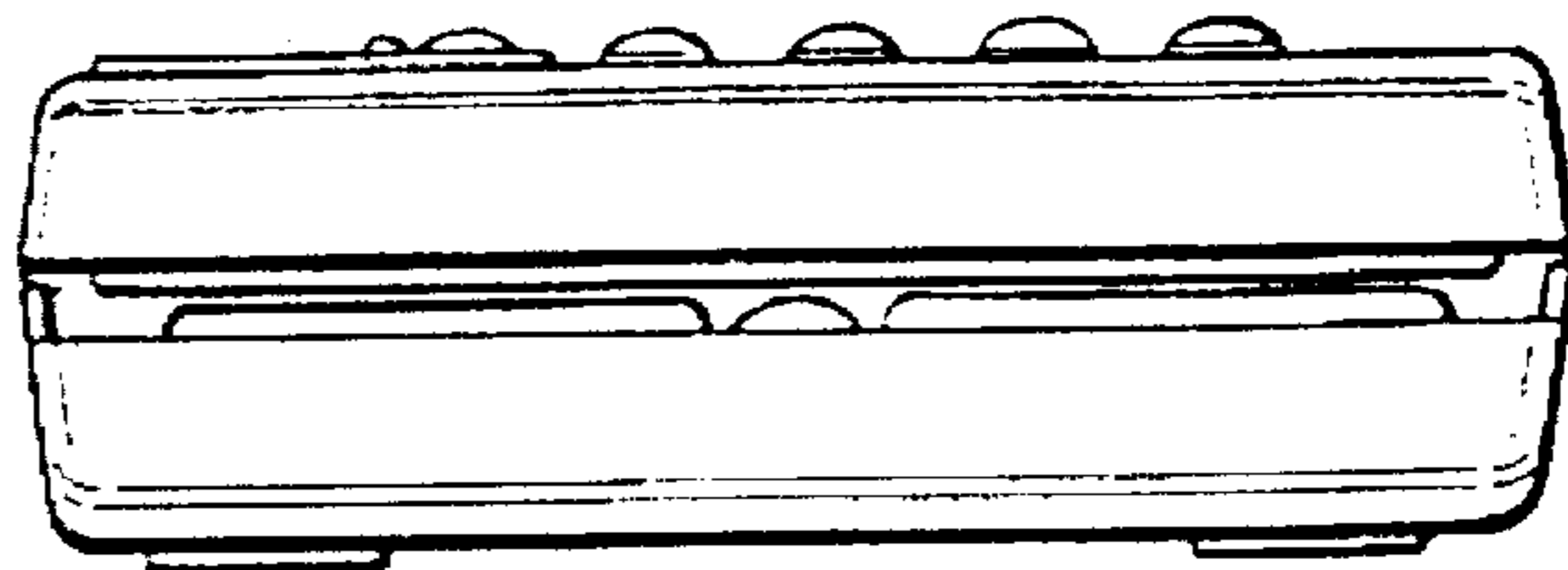
