DESCRIPTION

FIG. 1 is a perspective view of a camcorder according to the present invention;
FIG. 2 is a front elevational view thereof;

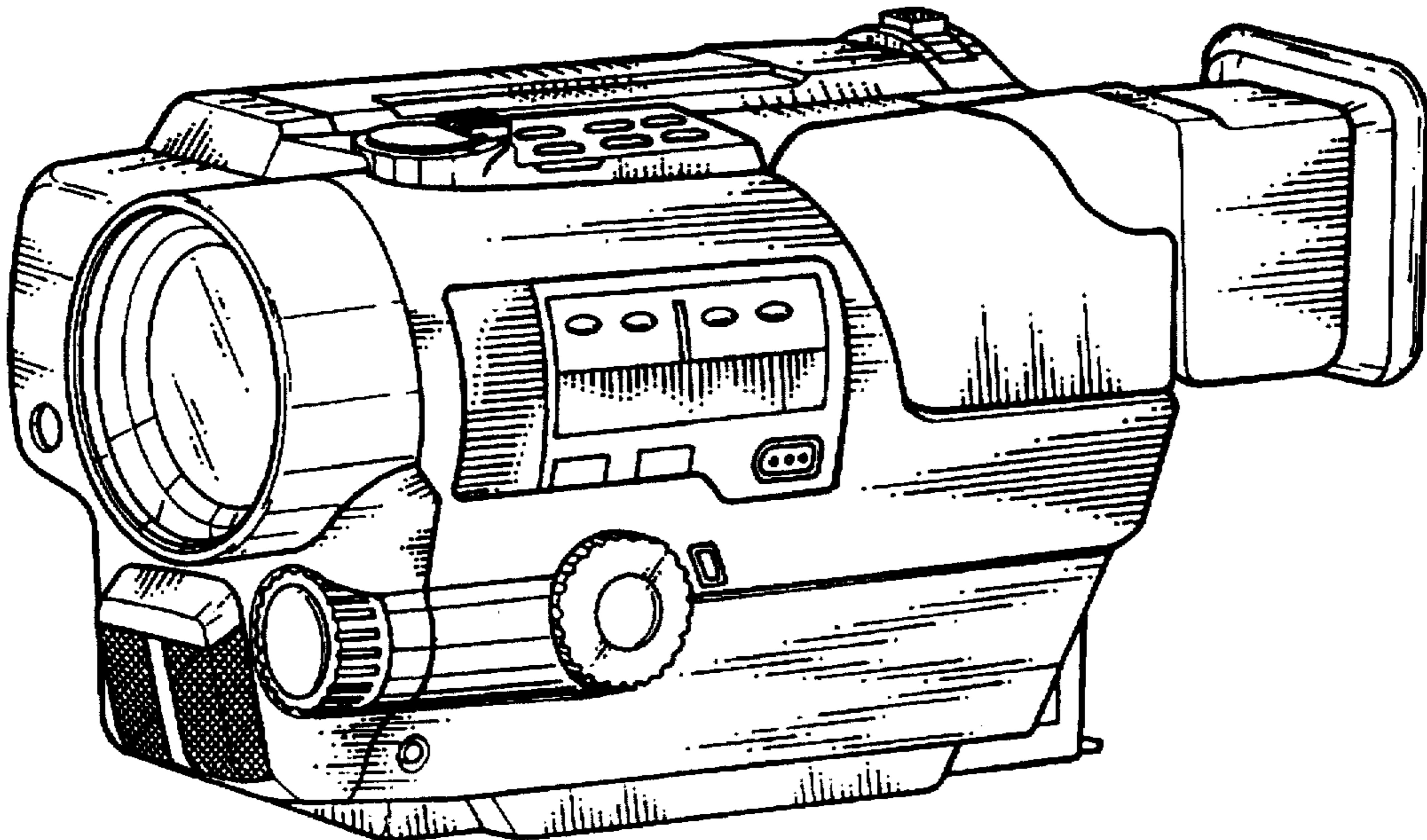

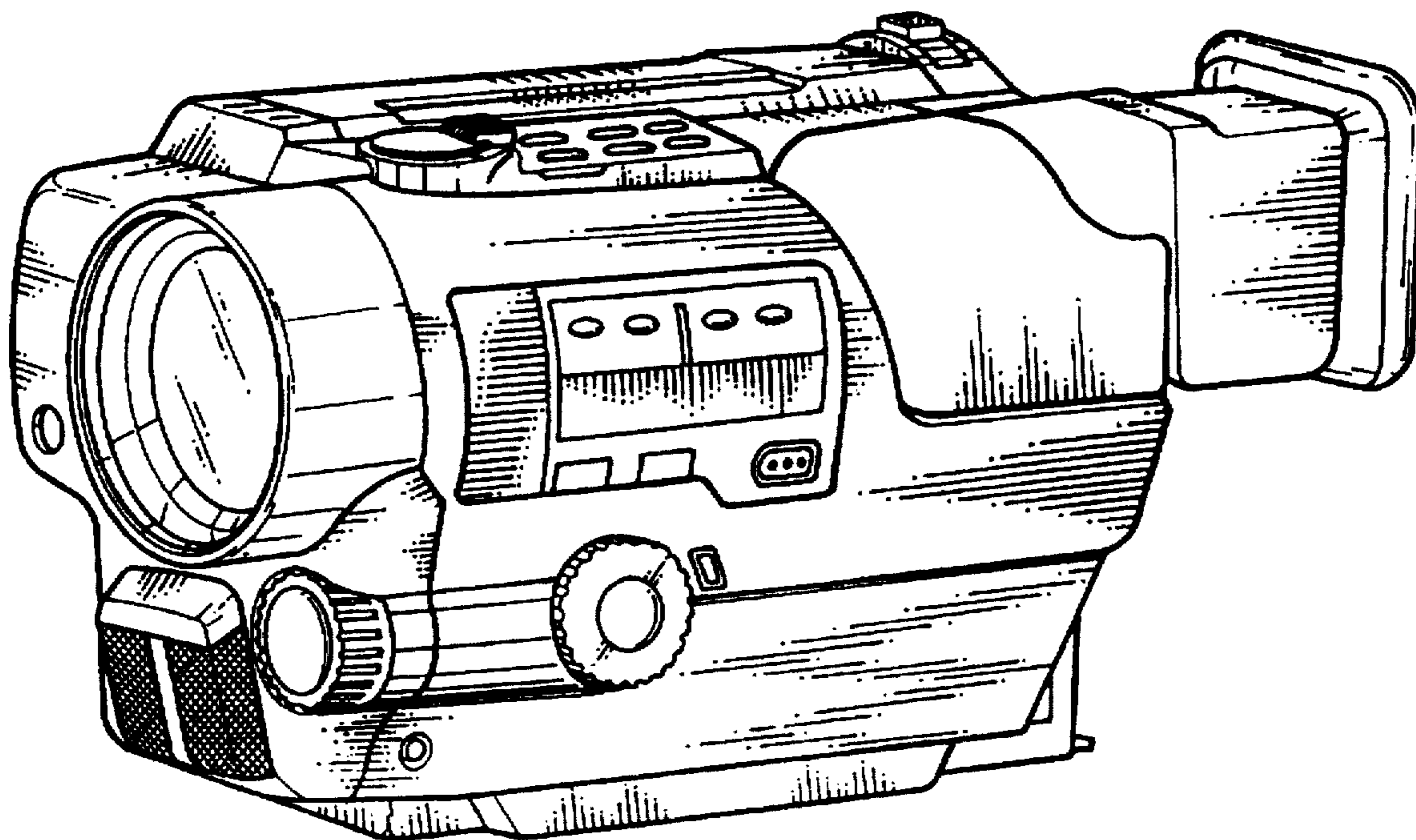

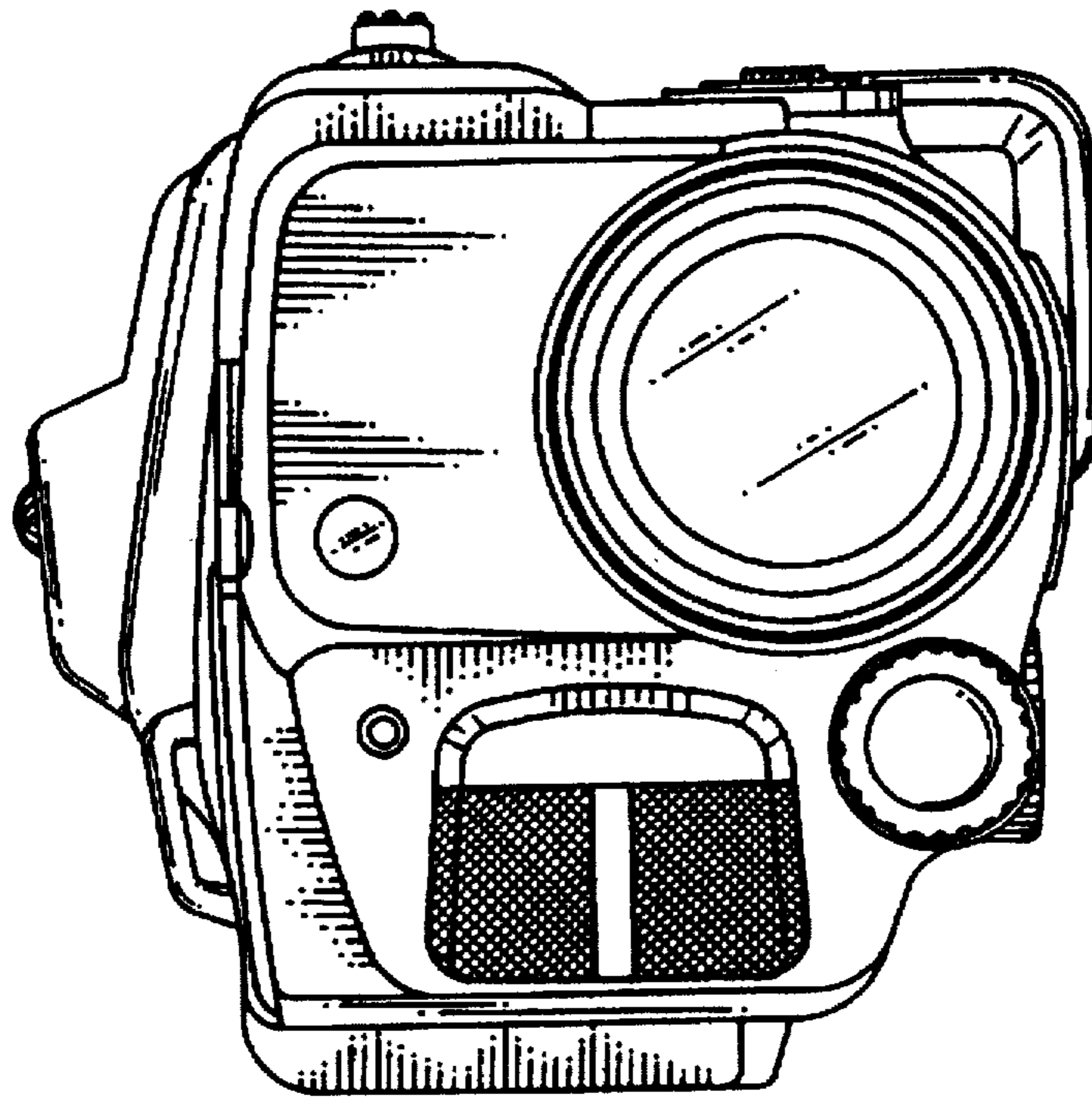

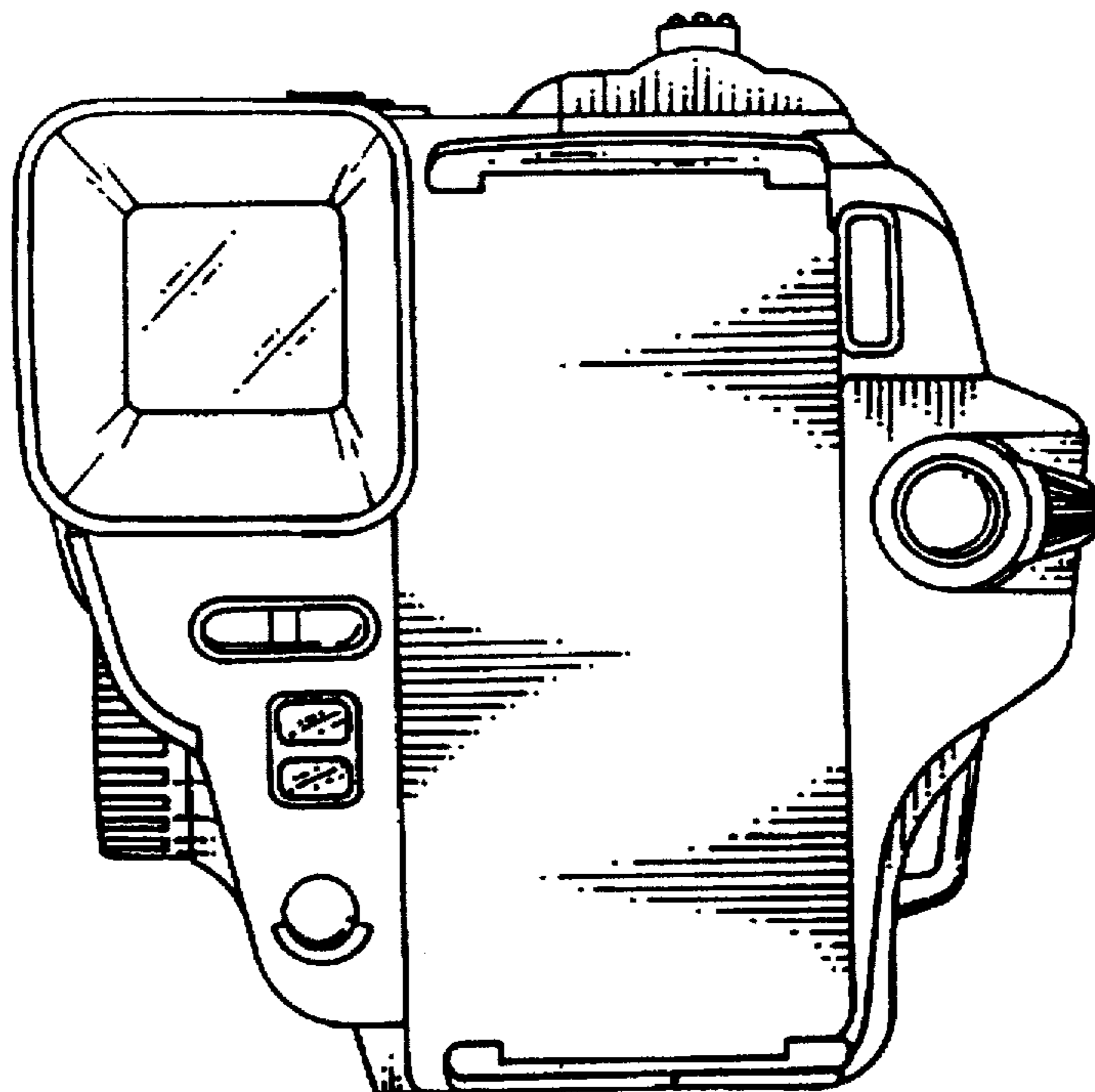

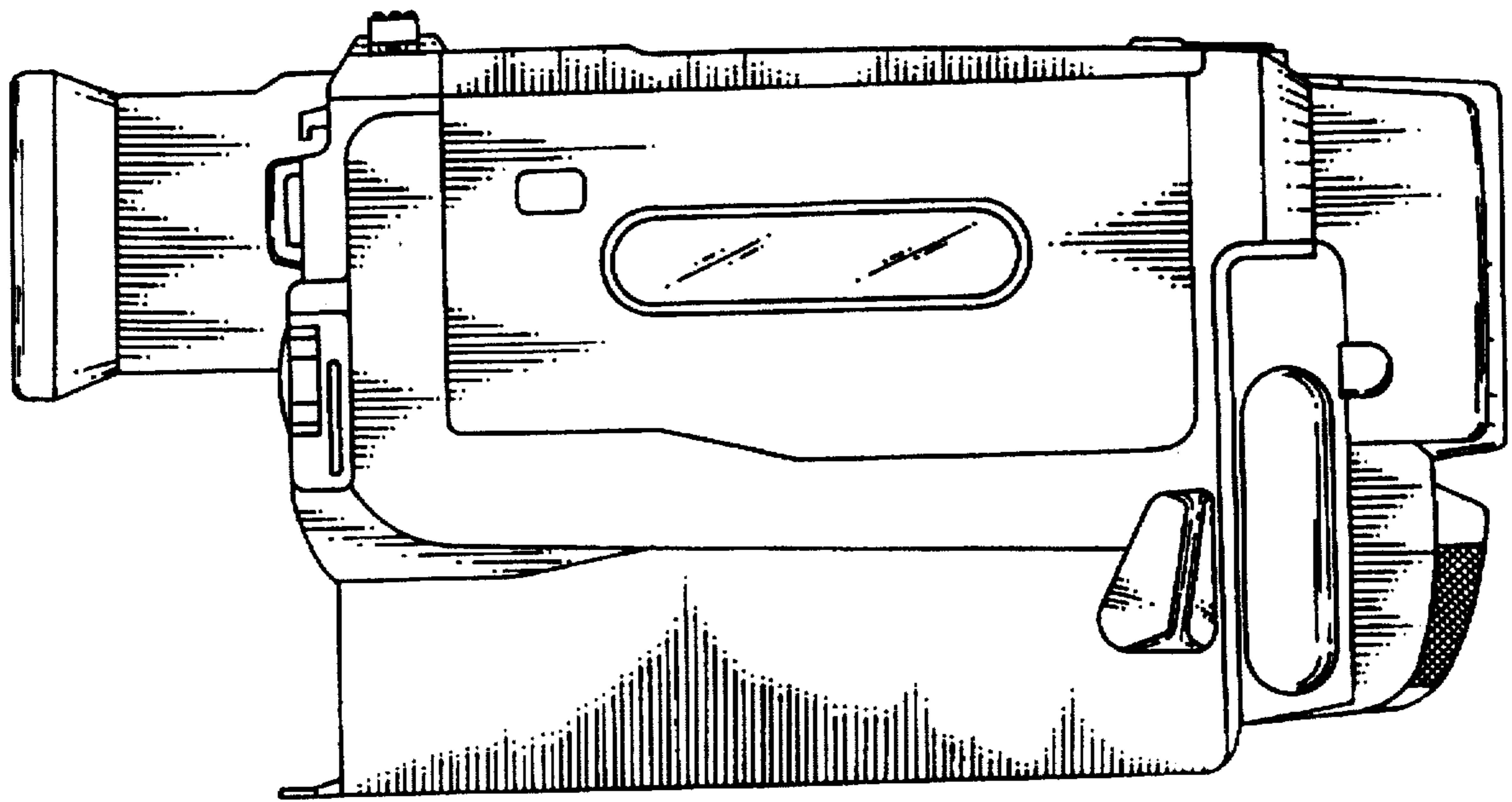

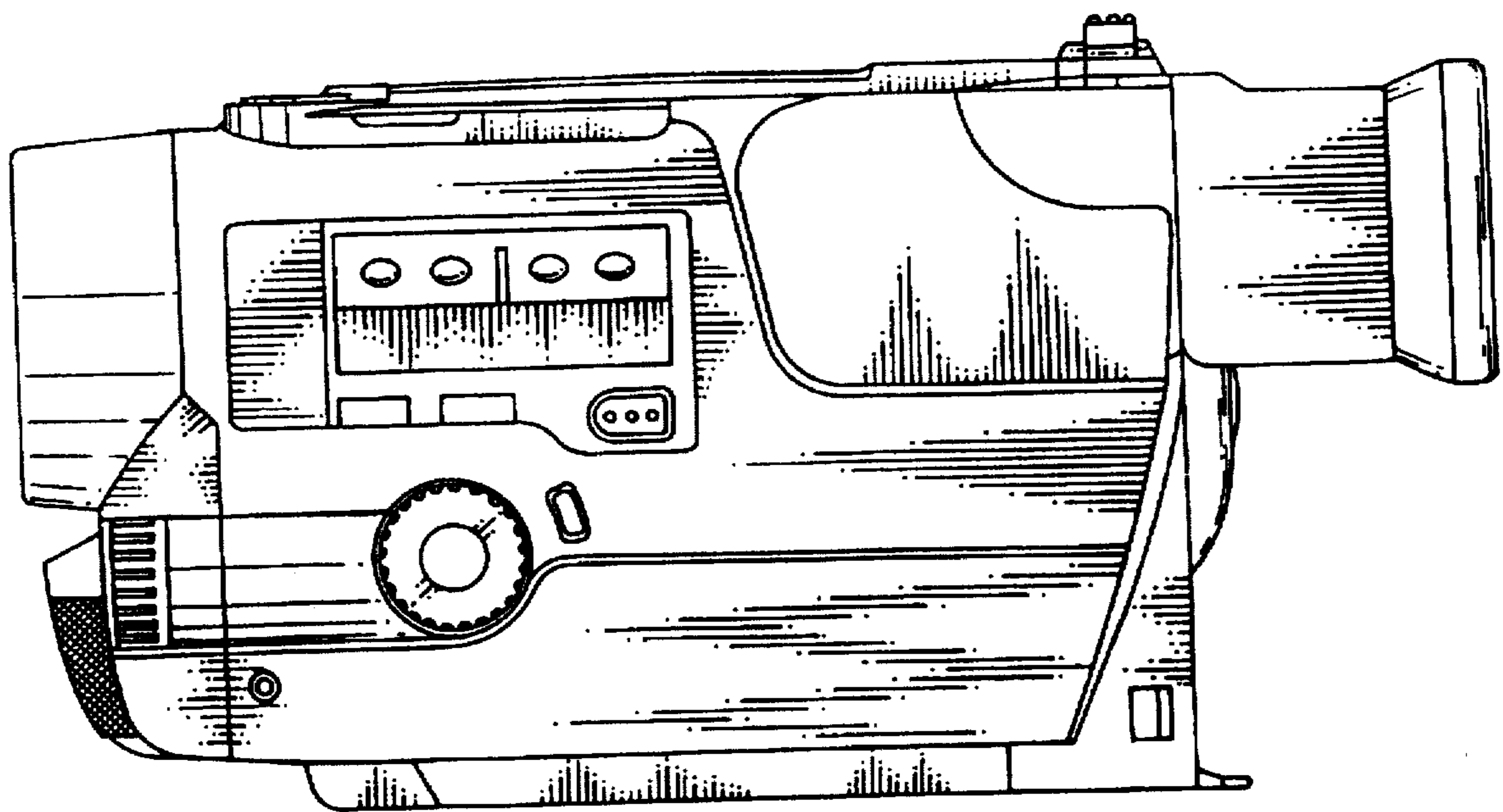

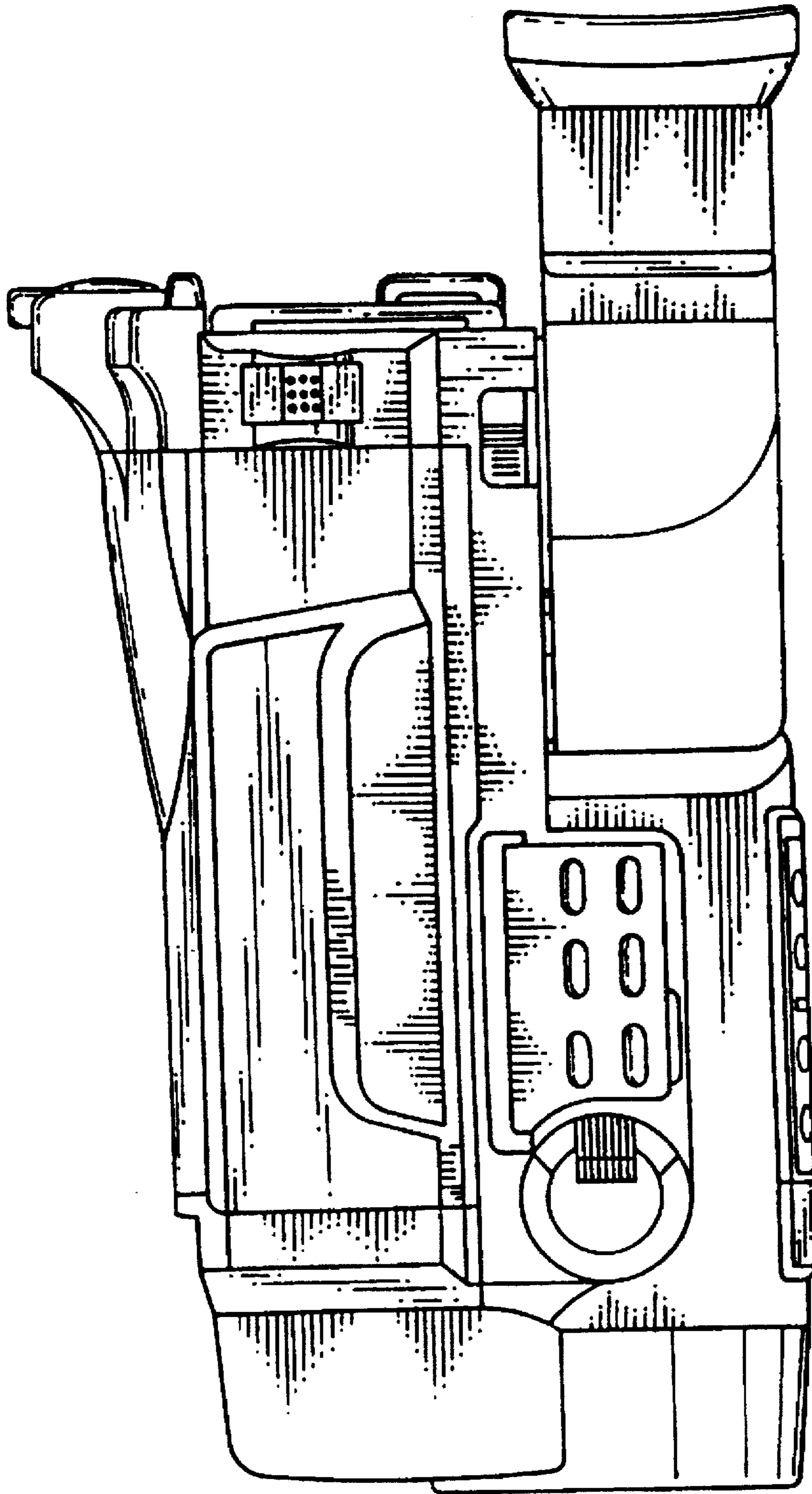
