The ornamental design for a desktop organizer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a desktop organizer showing our new design, the implements depicted by means of broken lines being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is an elevational view of one side thereof;

FIG. 6 is an elevational view of the other side thereof; and,

FIG. 7 is a bottom plan view thereof.

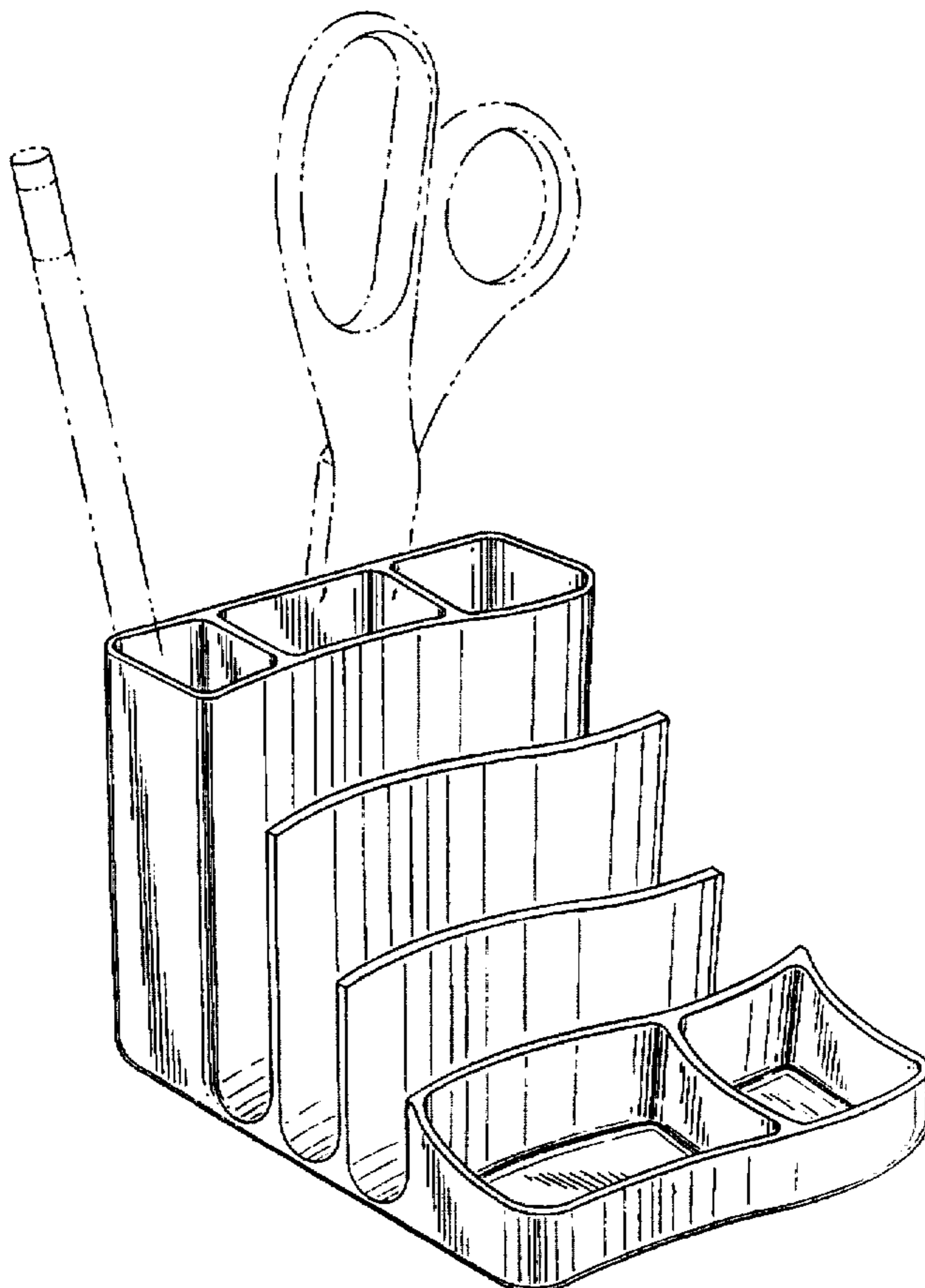

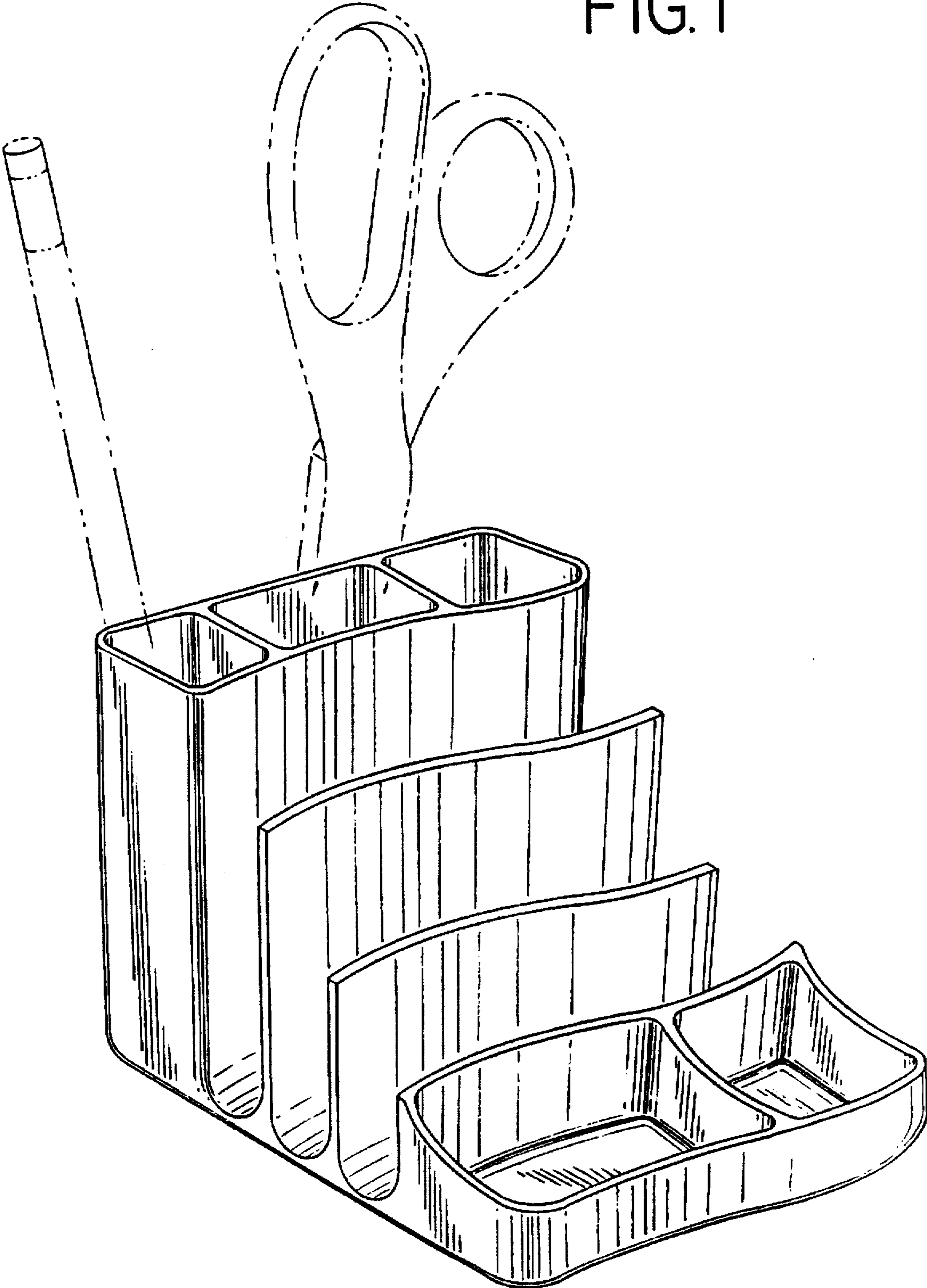

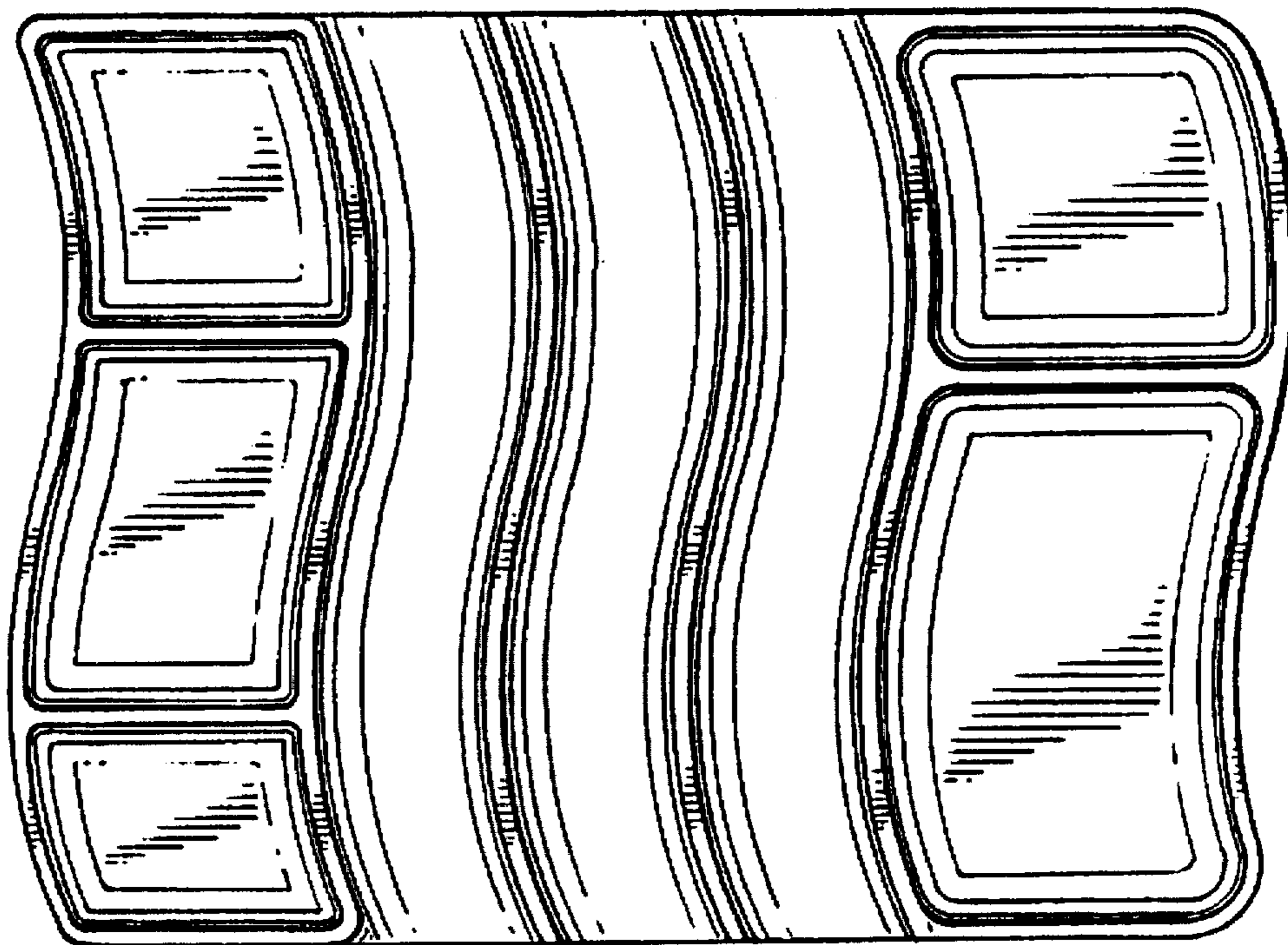

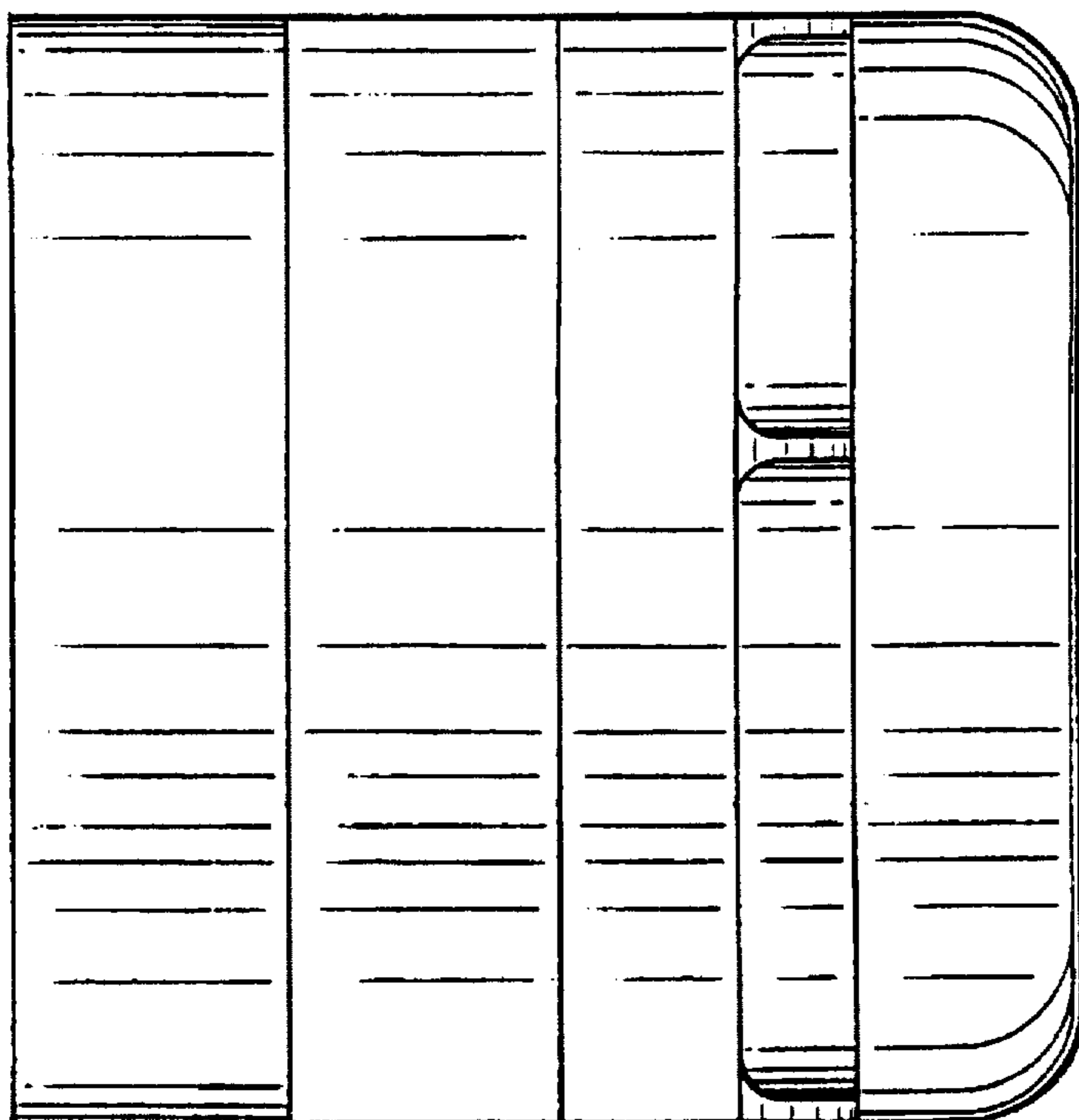

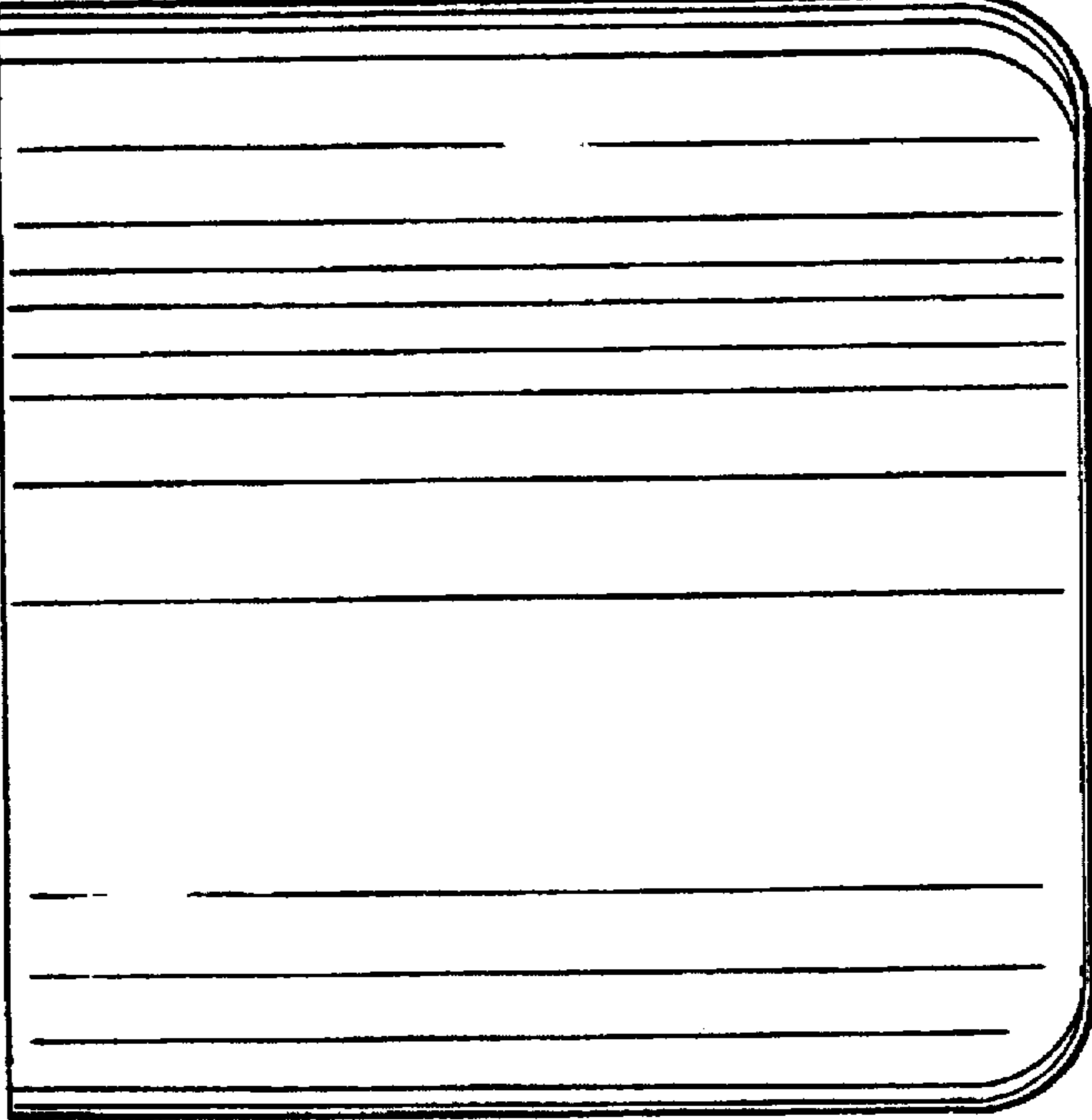

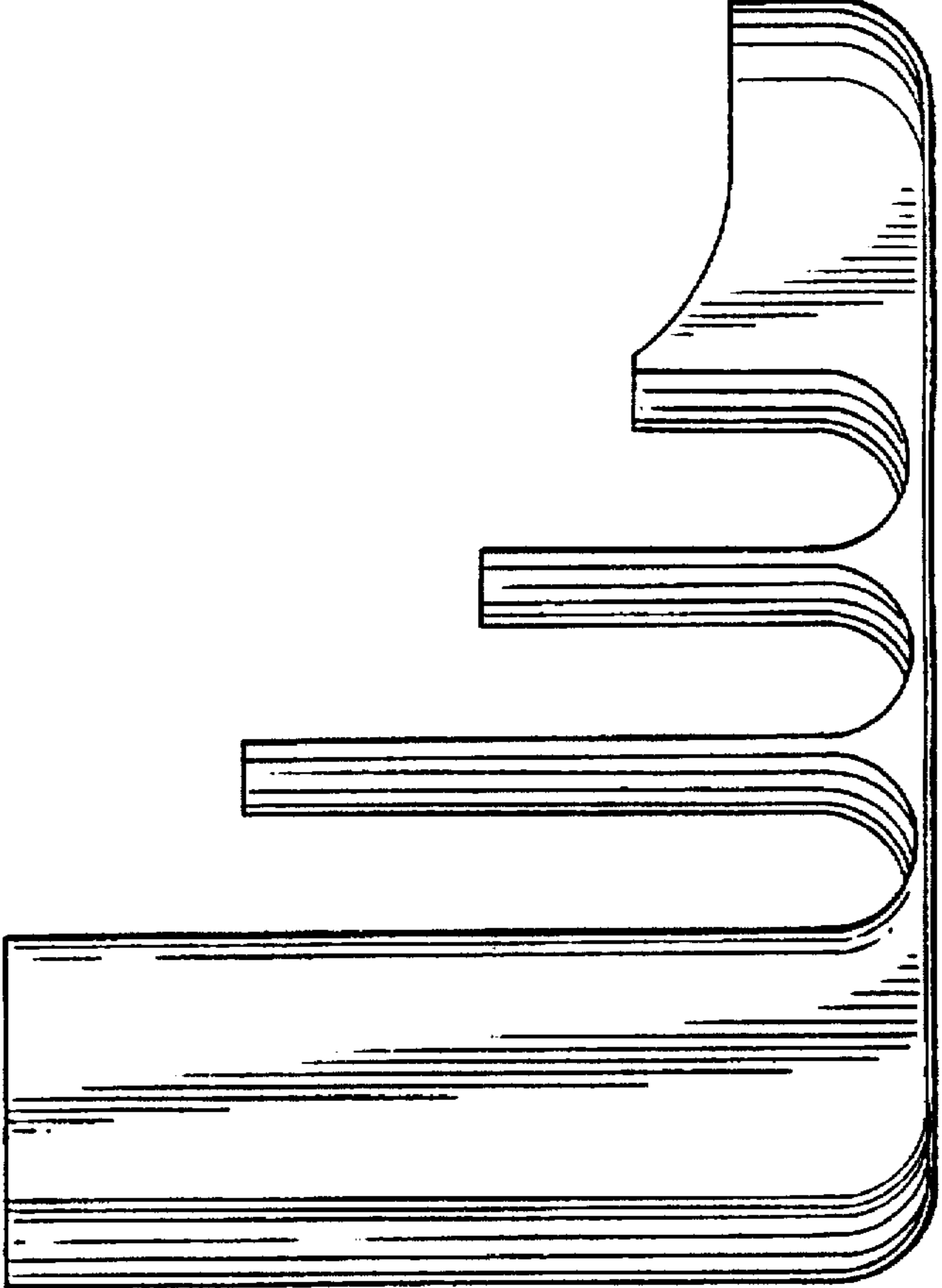

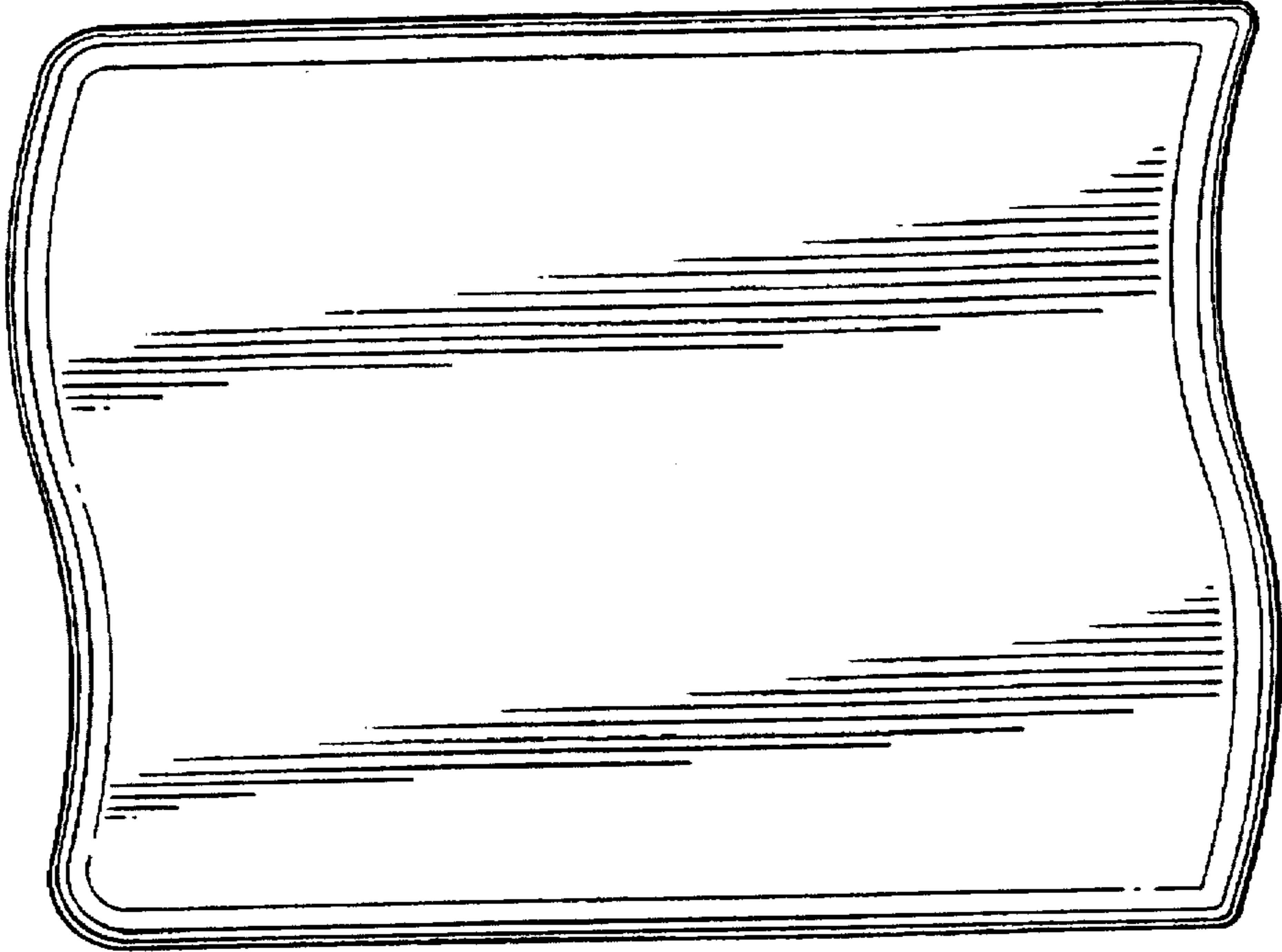
