The ornamental design for an organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front, left, top perspective view of an organizer showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side view thereof, the left side view being a mirror image;
FIG. 5 is a rear view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a sectional view thereof, taken along line 7—7 in FIG. 5.

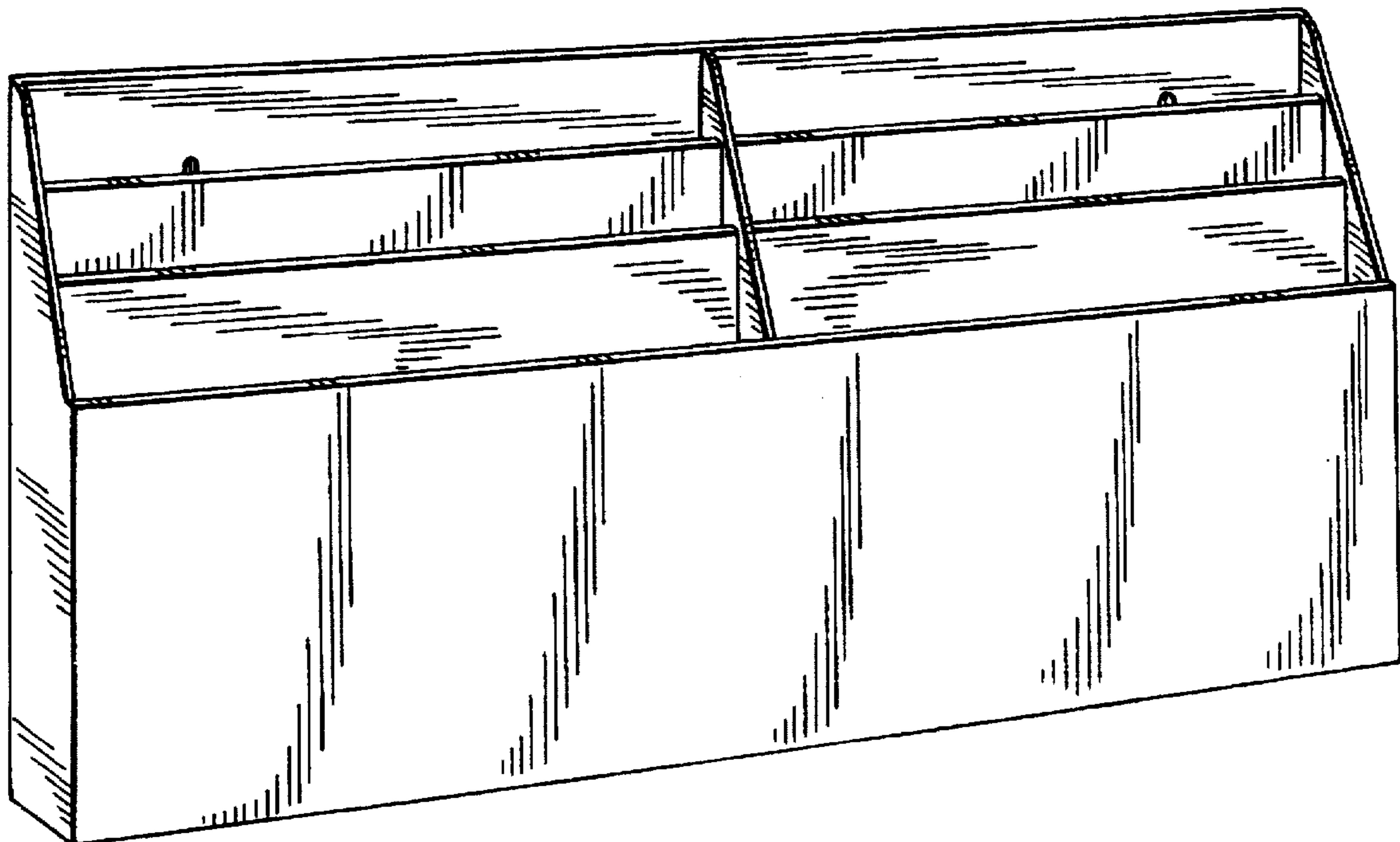
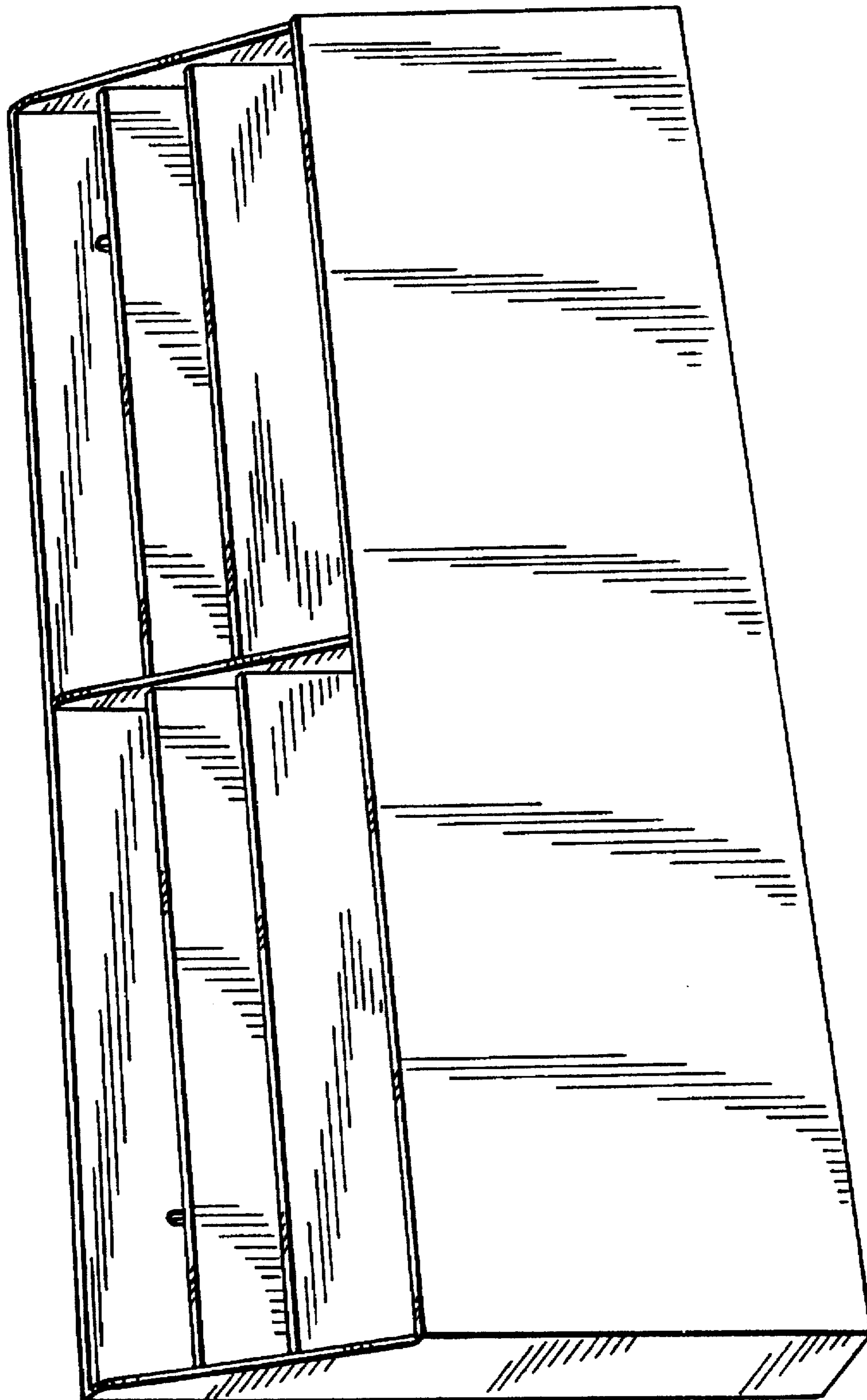

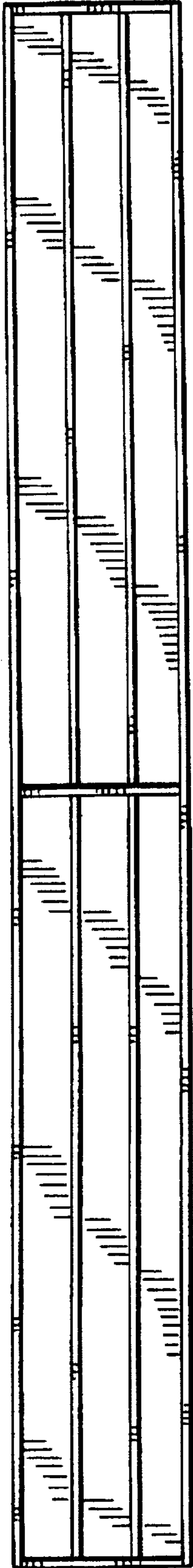

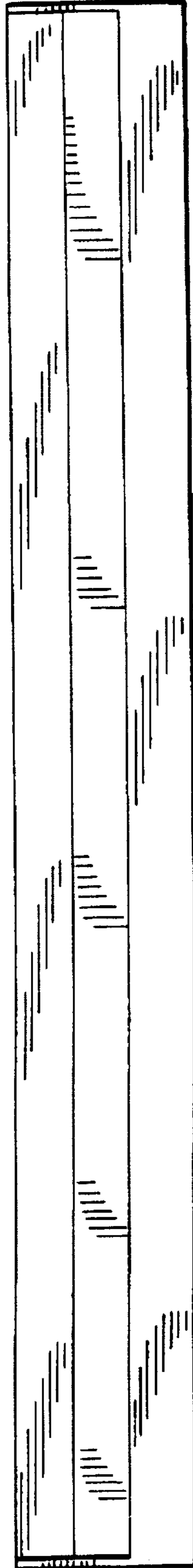
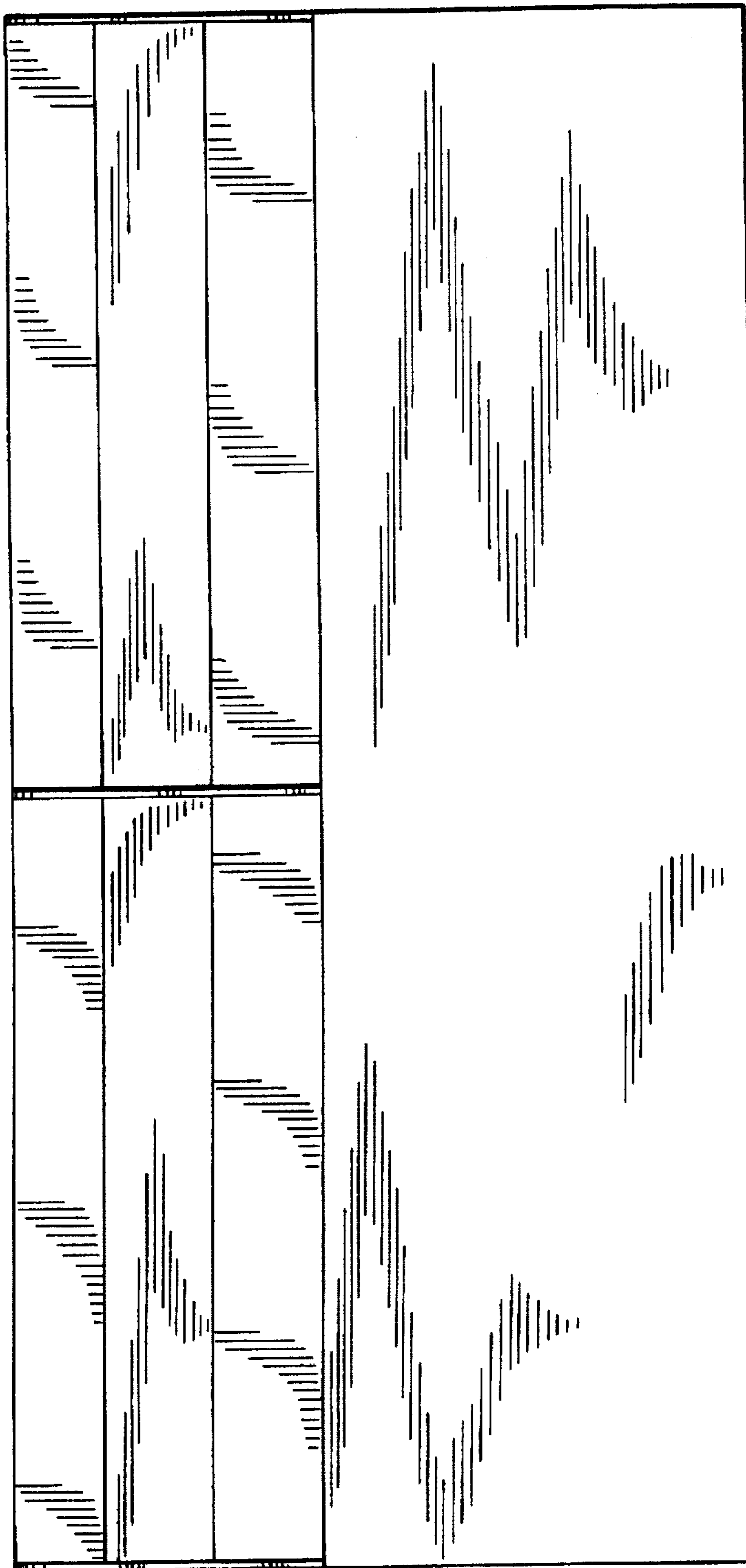

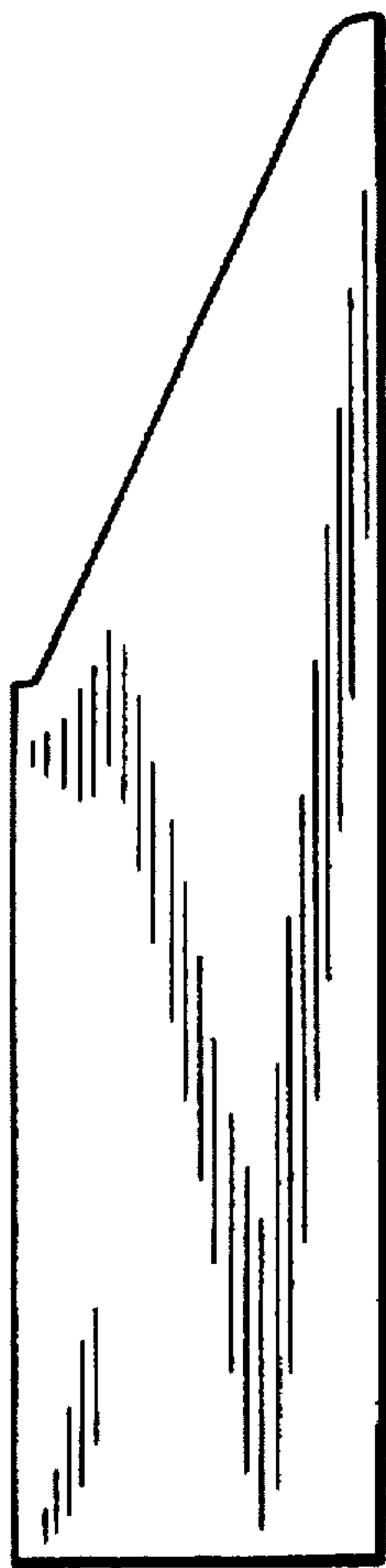

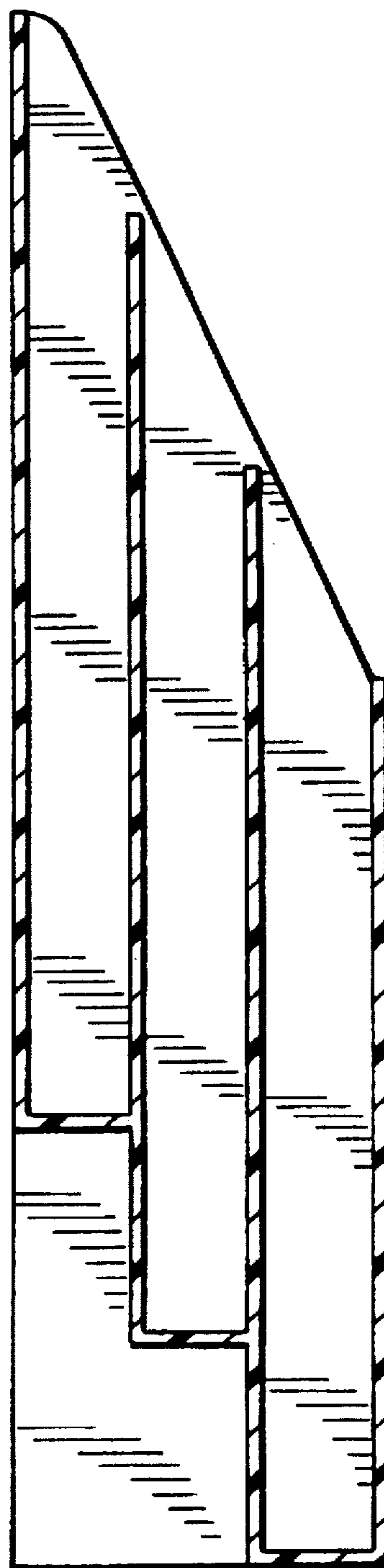

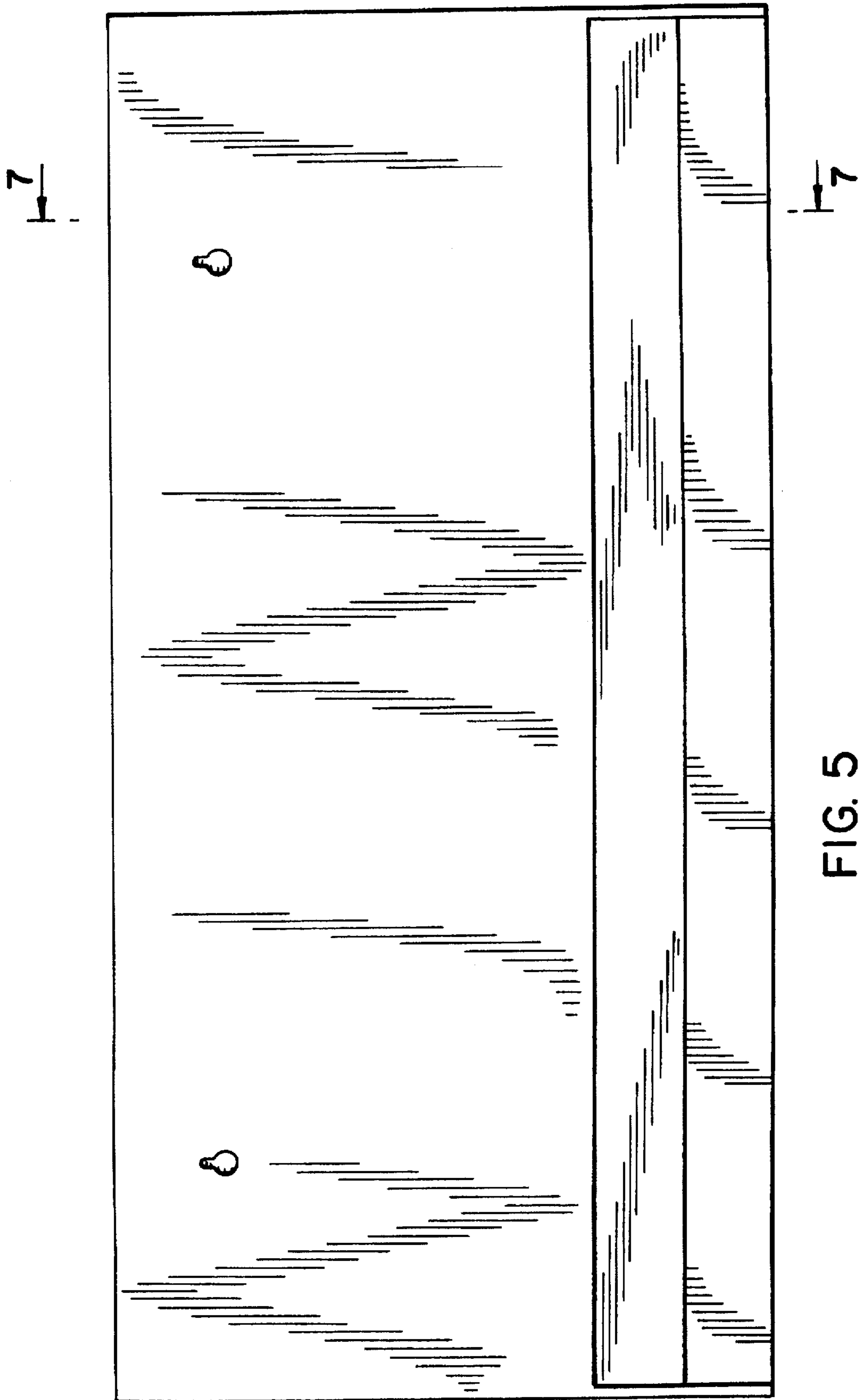
