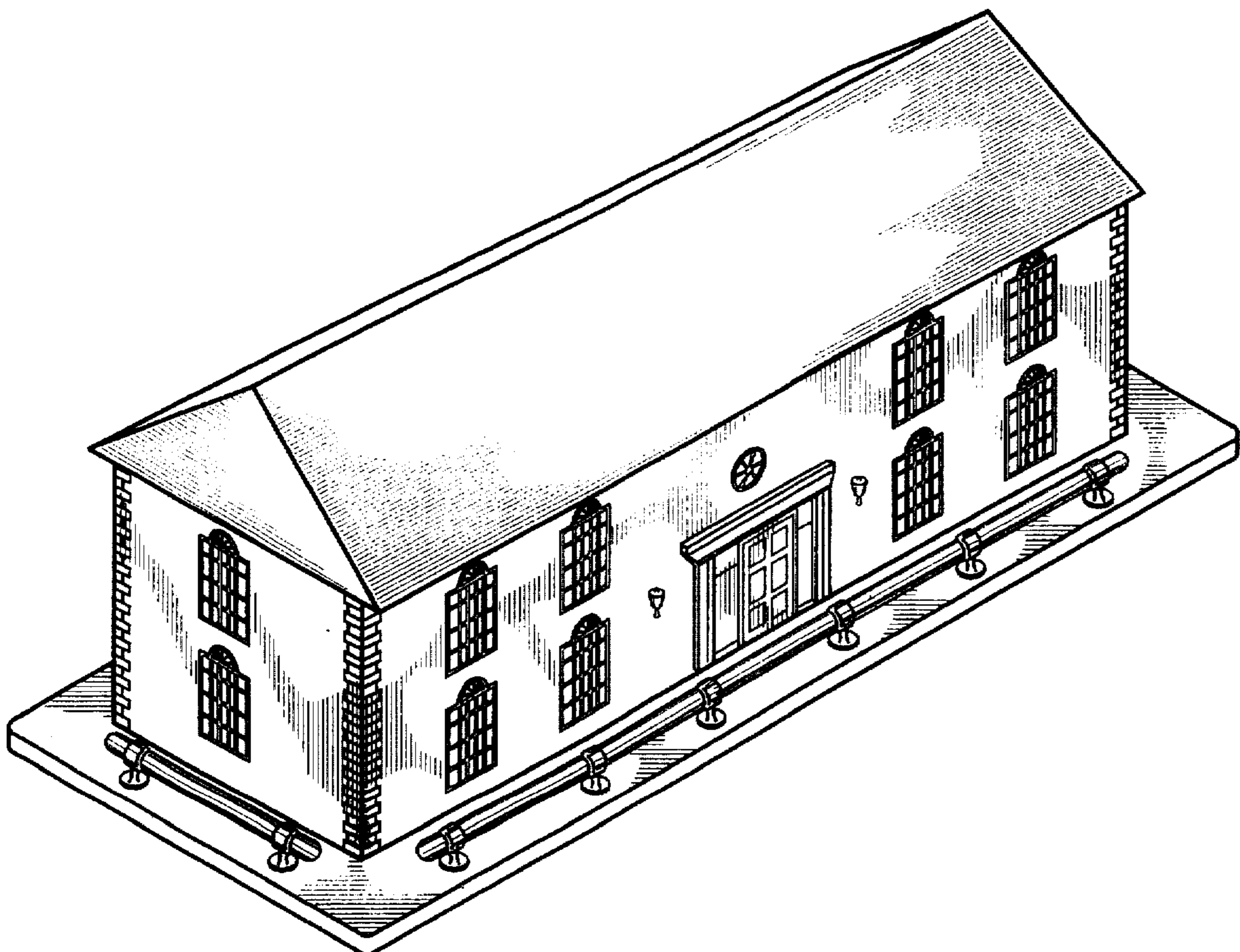
[57] **CLAIM**

The ornamental design for a burial casket, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a burial casket showing my design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a right side elevational view thereof, the left side being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and
FIG. 6 is a perspective view thereof.

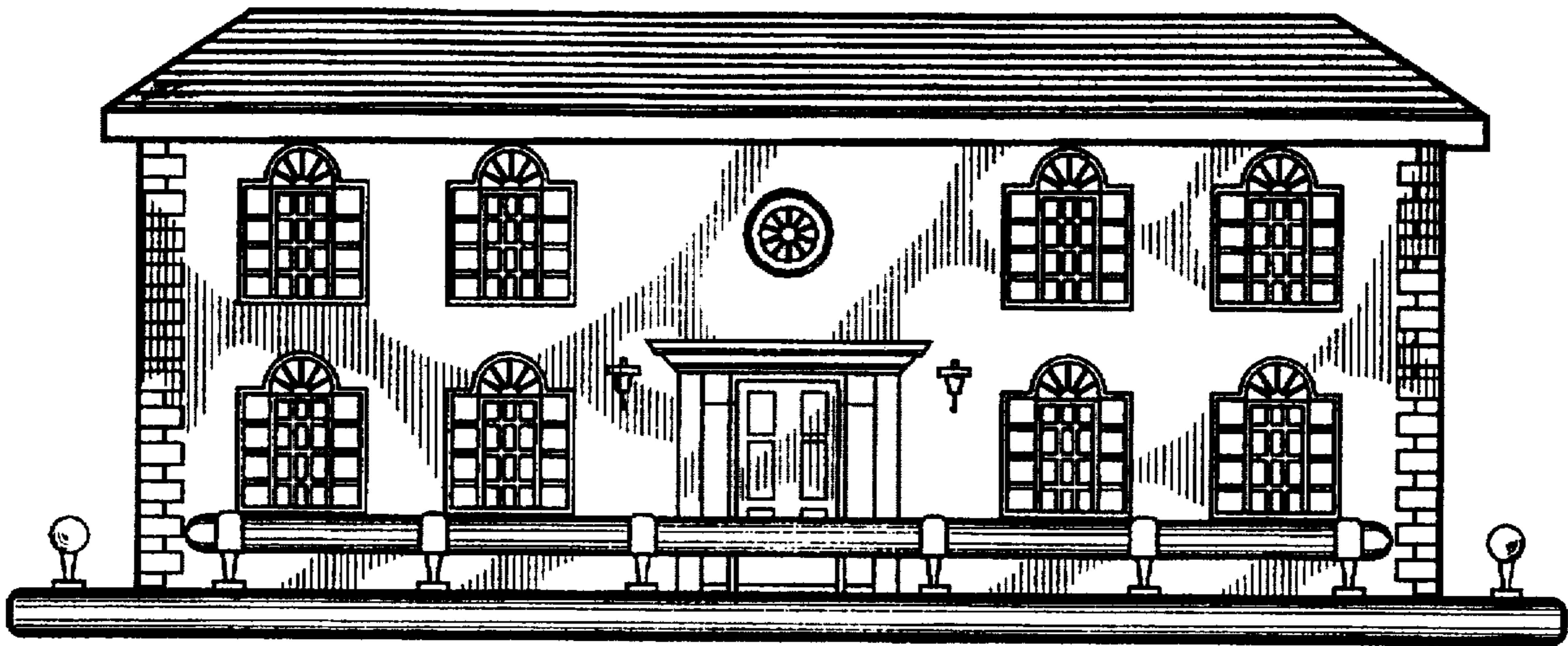

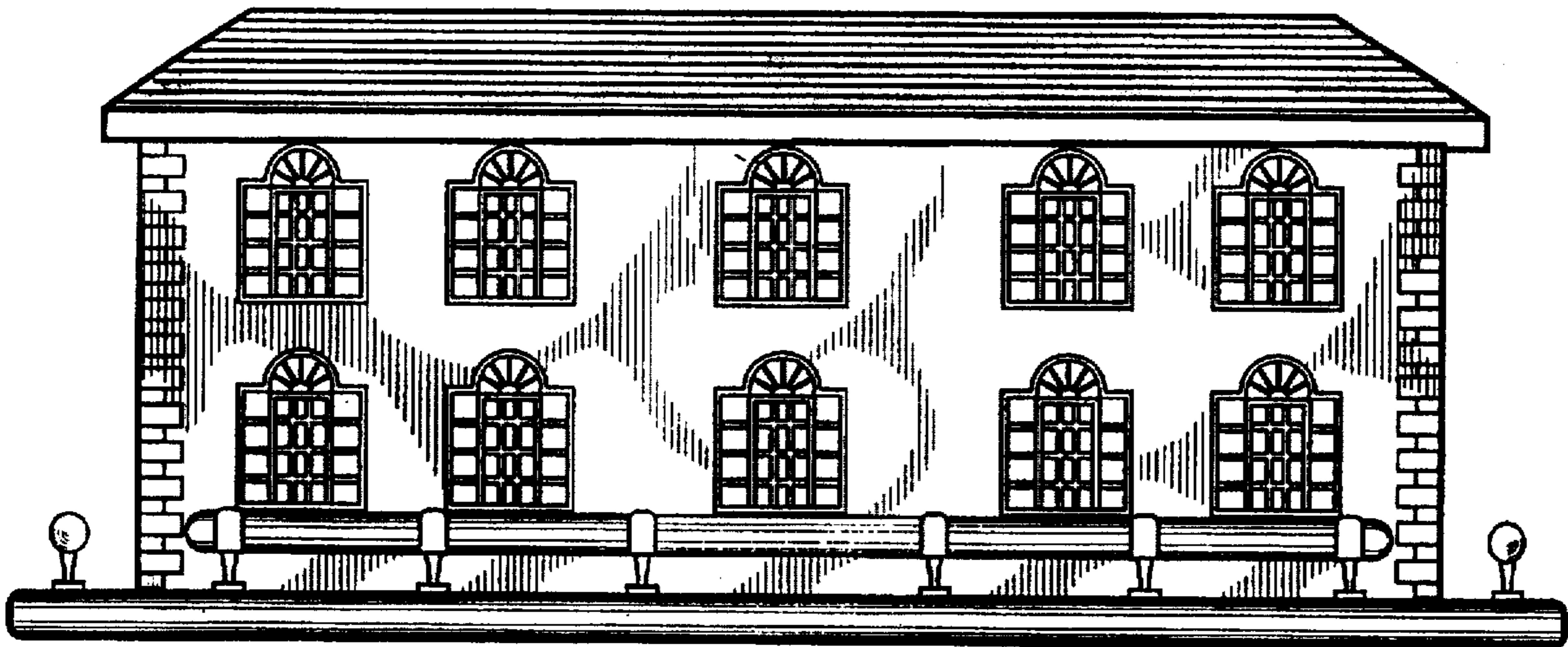

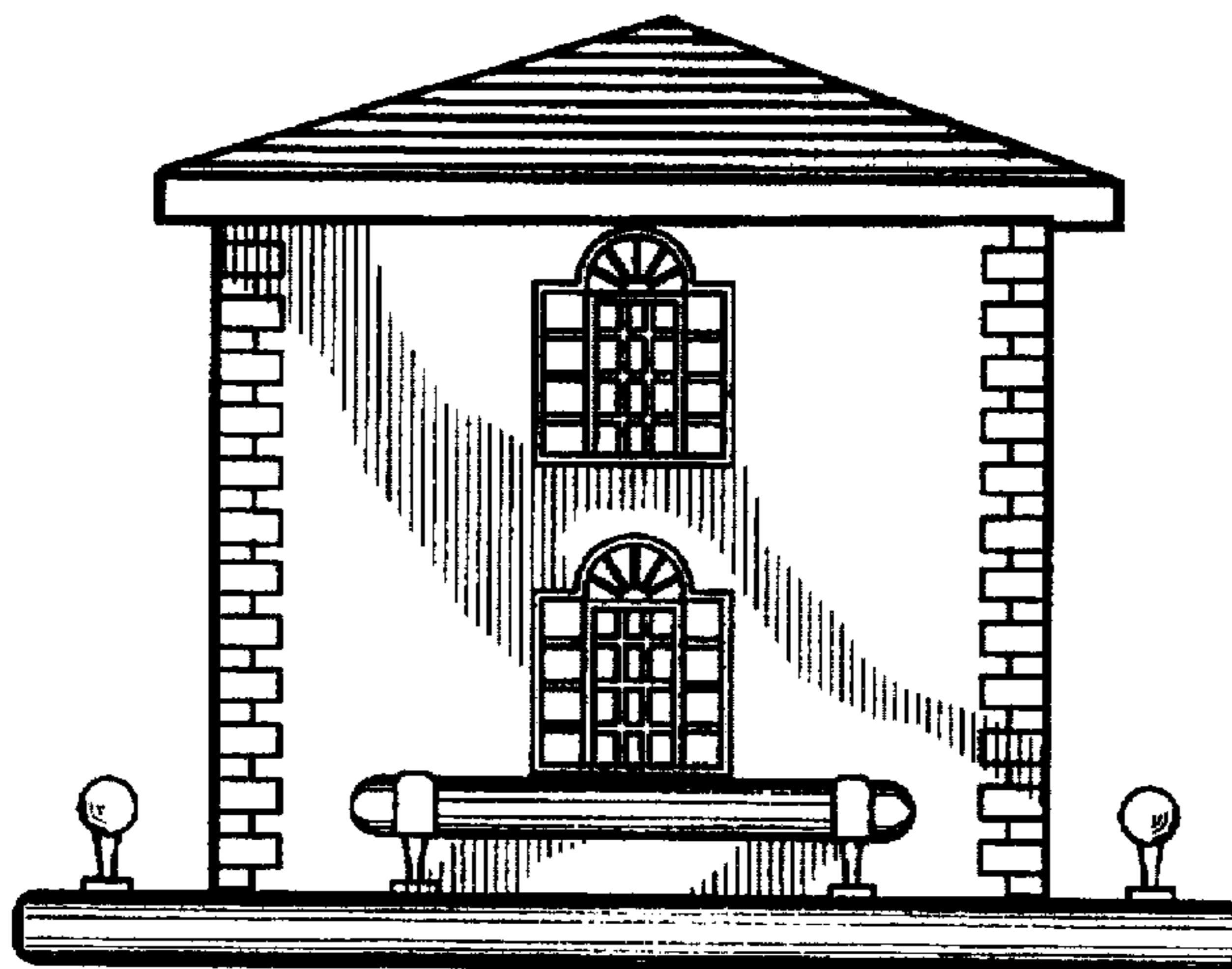

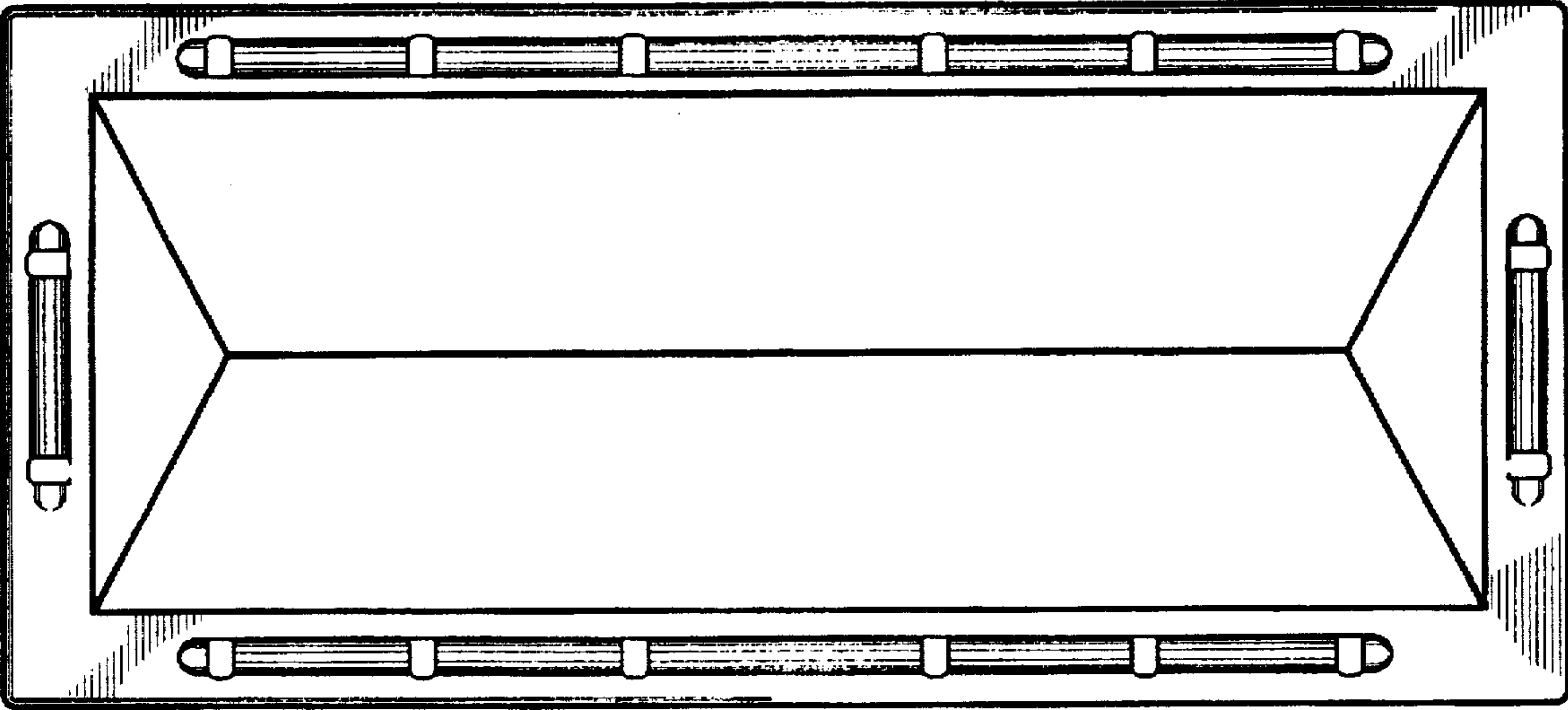

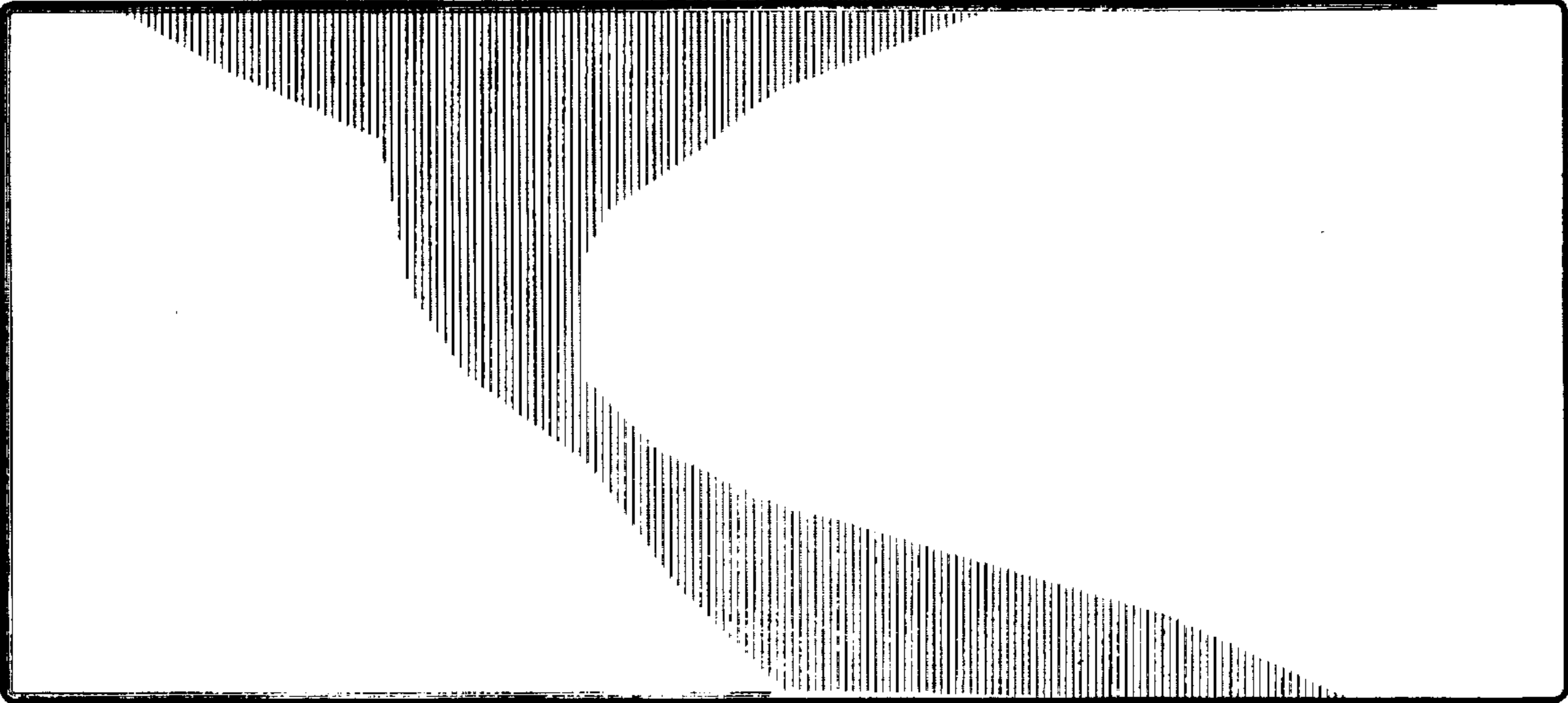

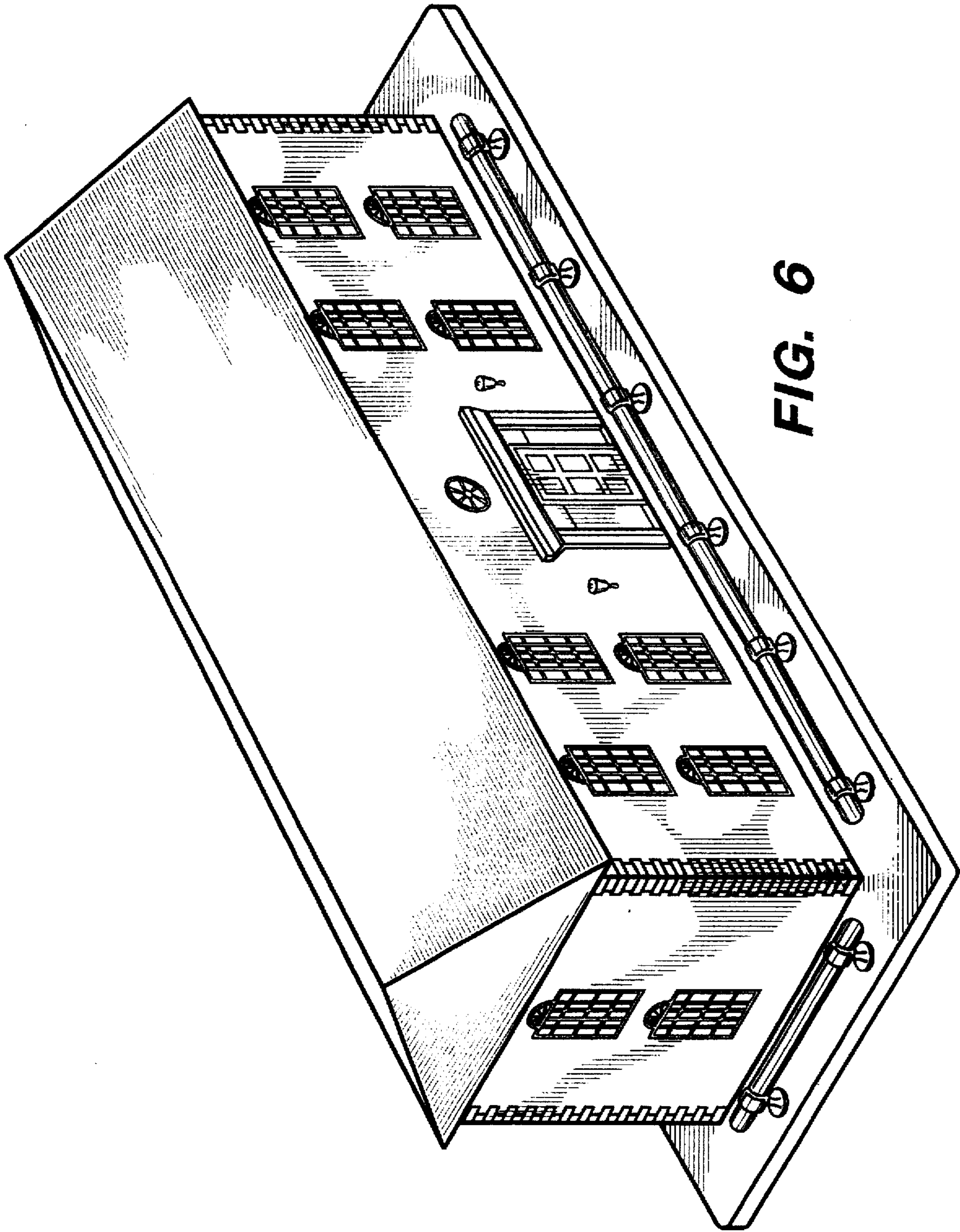
