The ornamental design for a cap with leather band, as shown and described.

DESCRIPTION

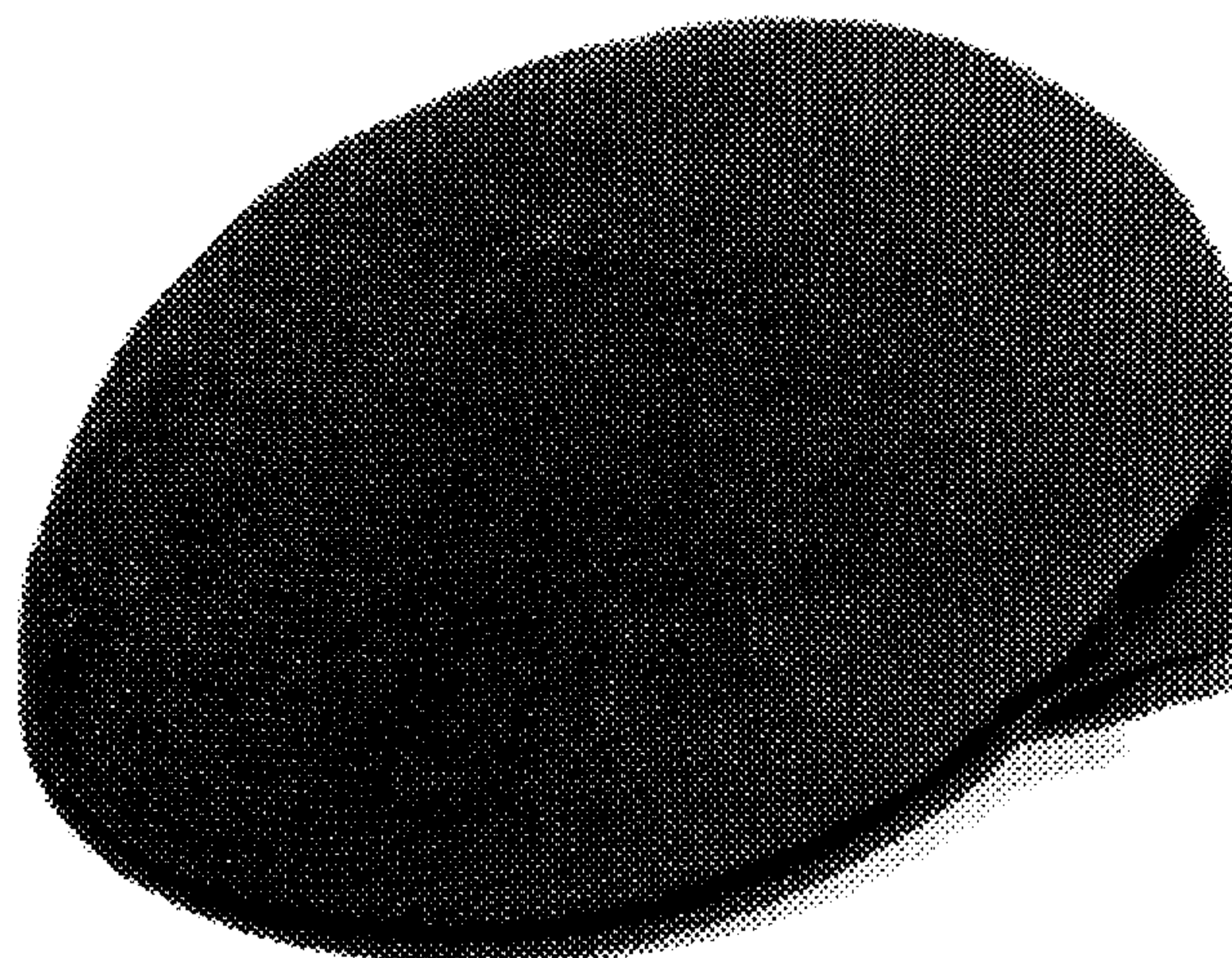

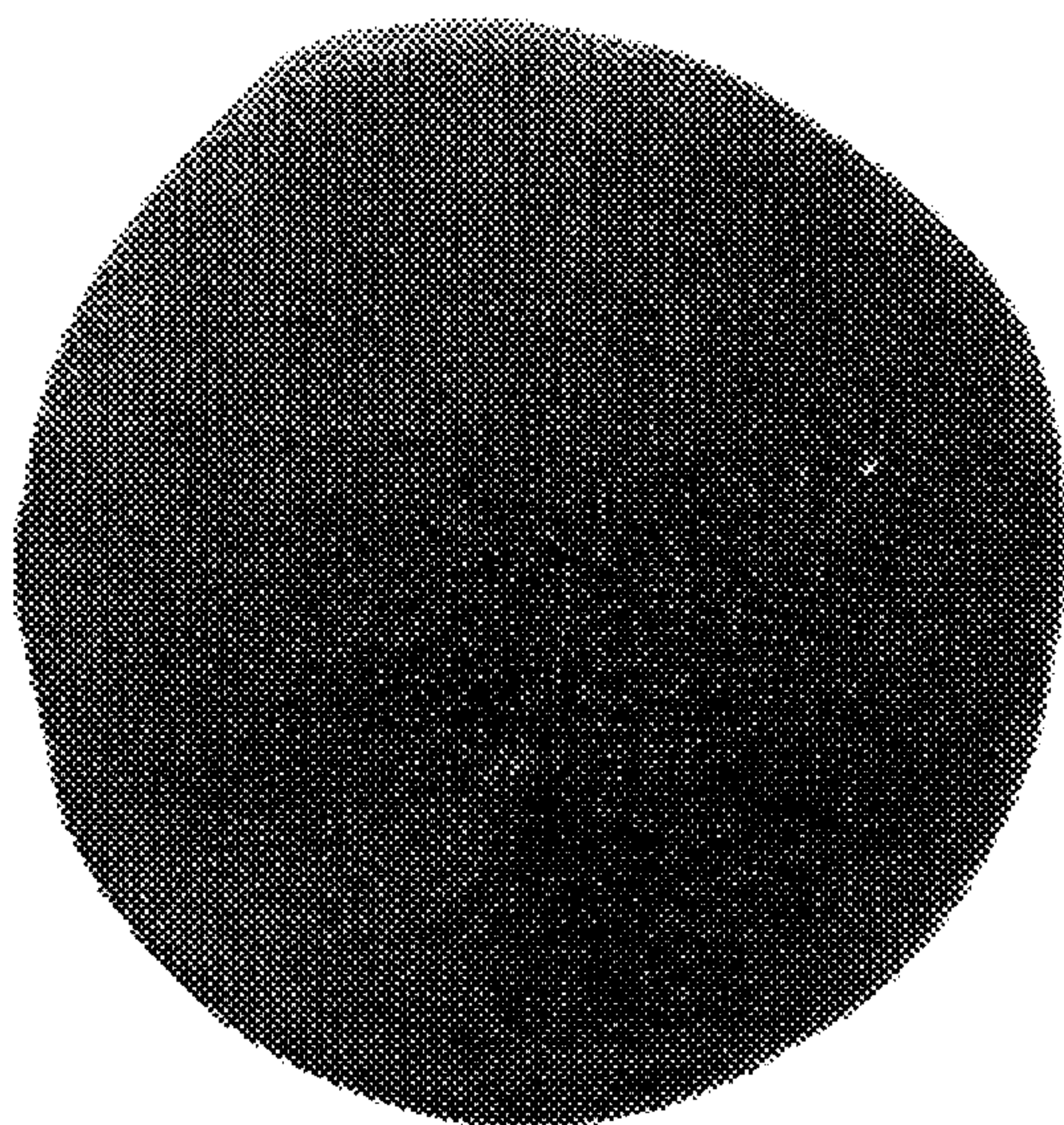

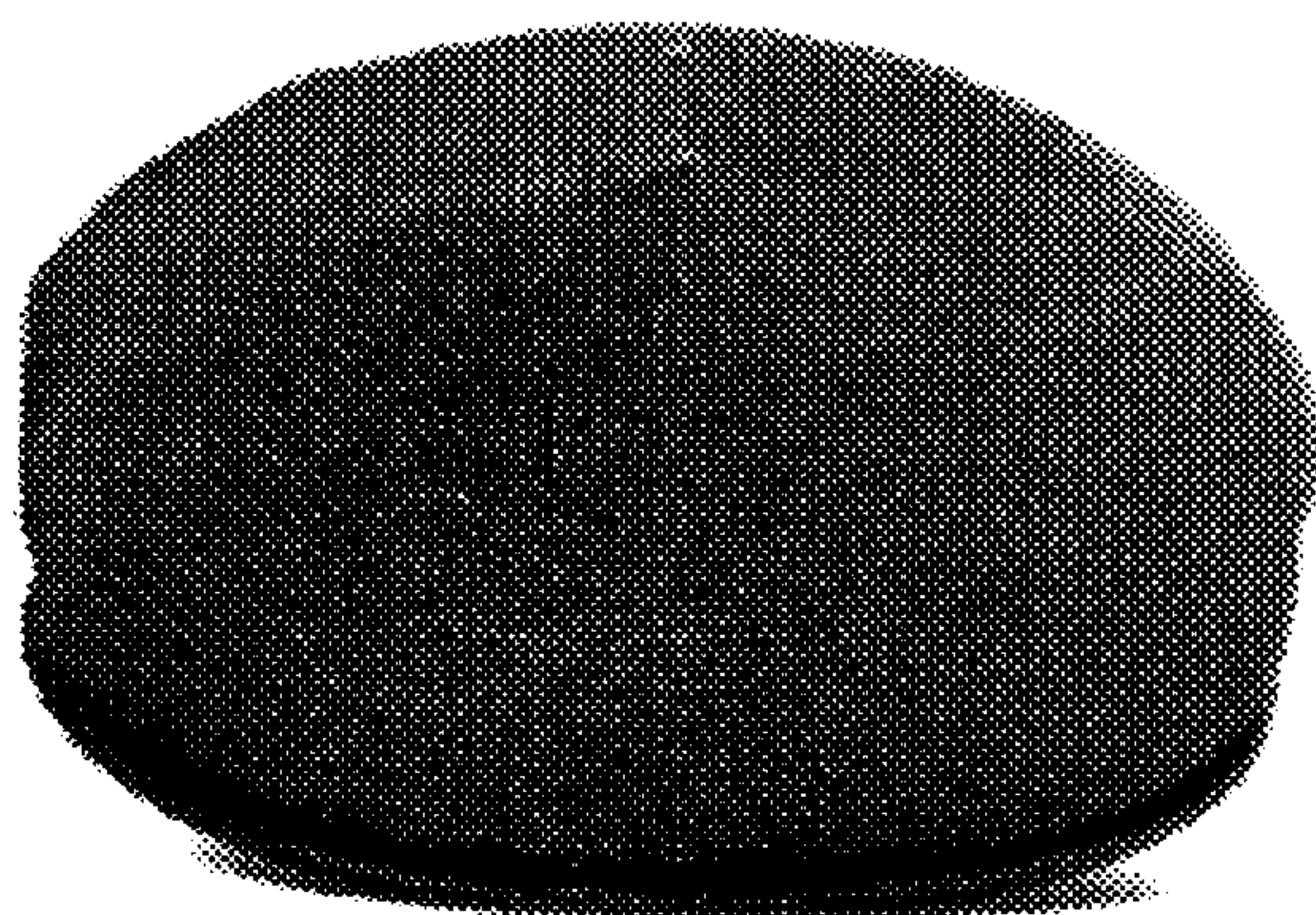

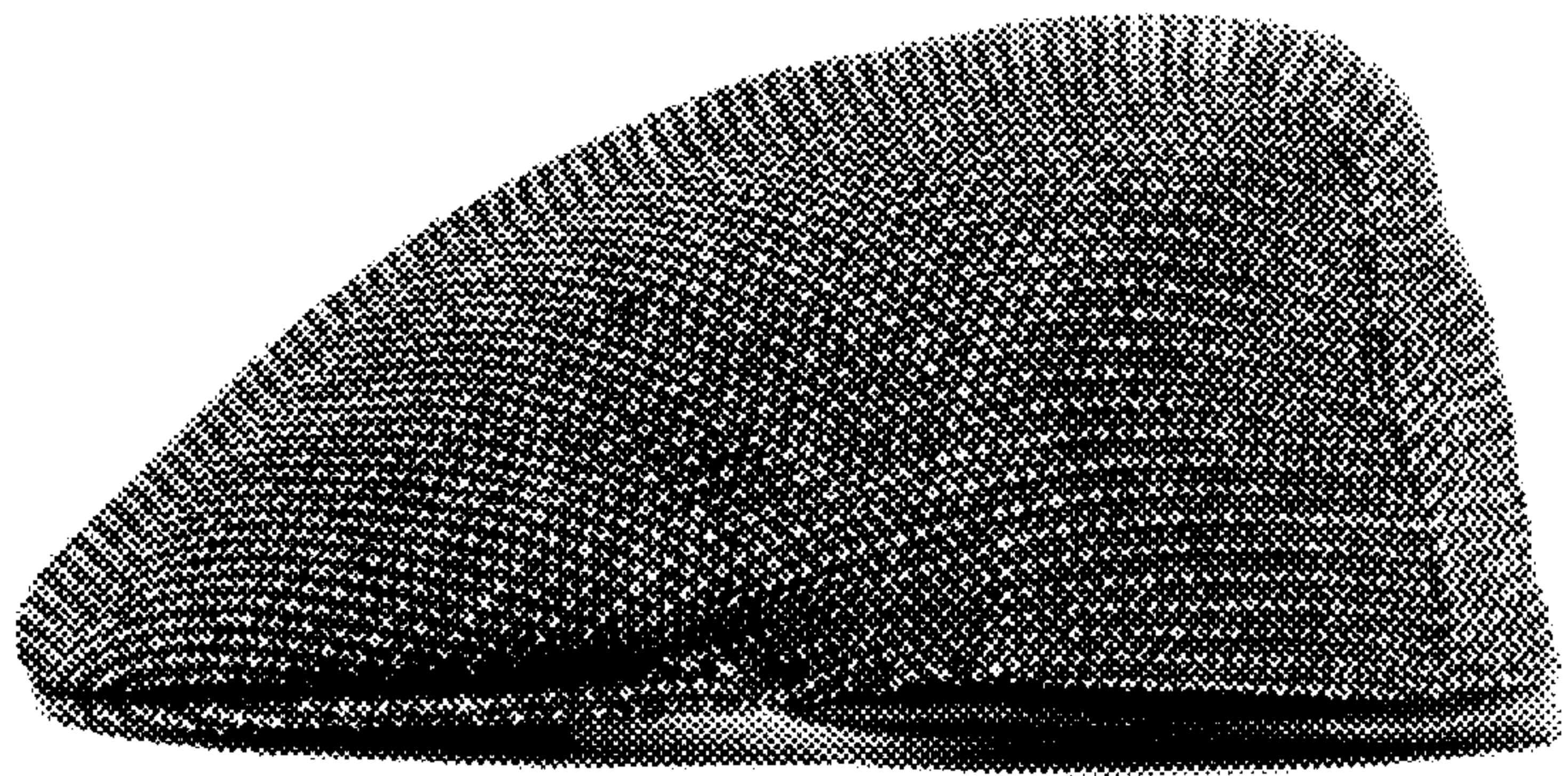

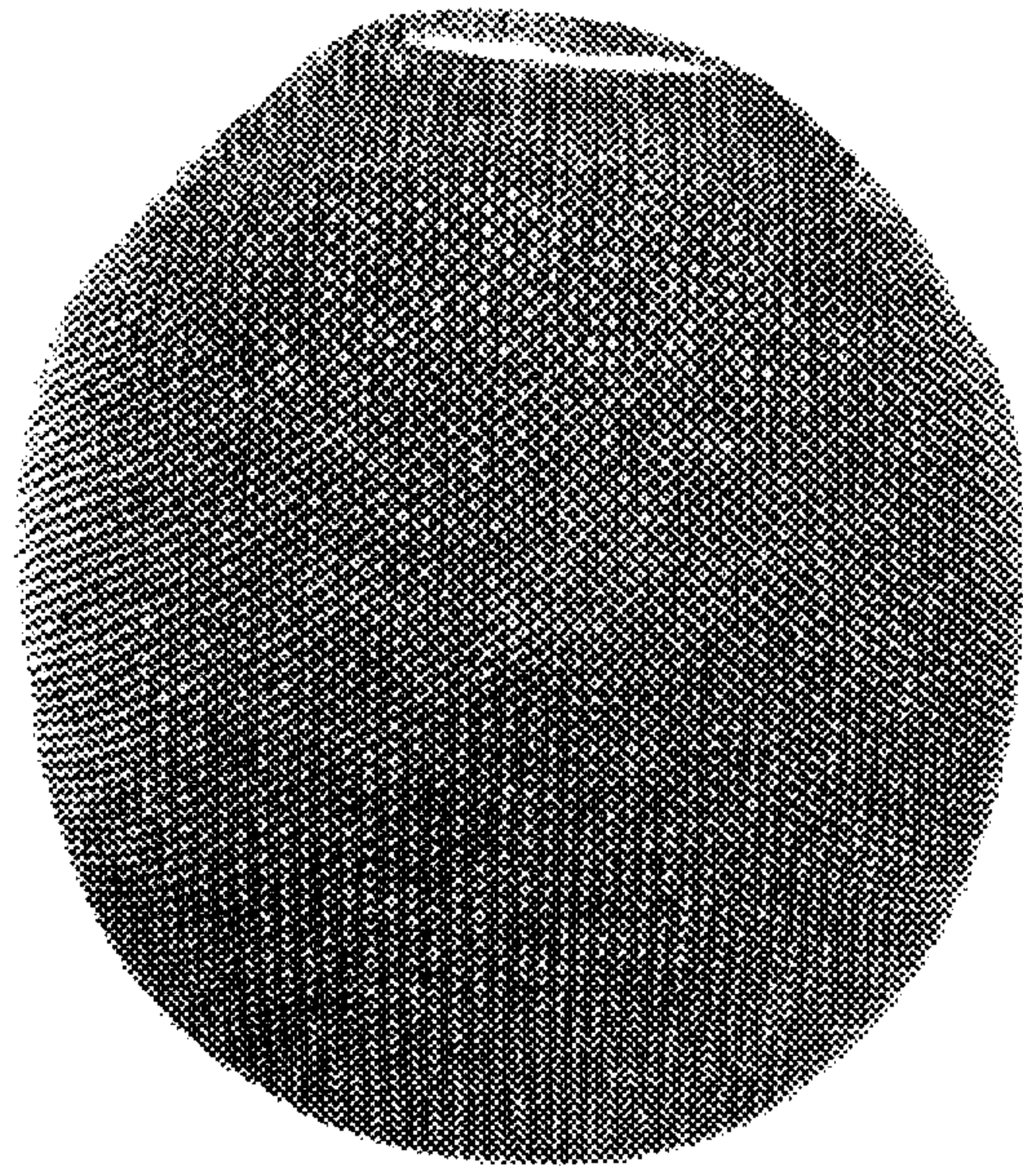

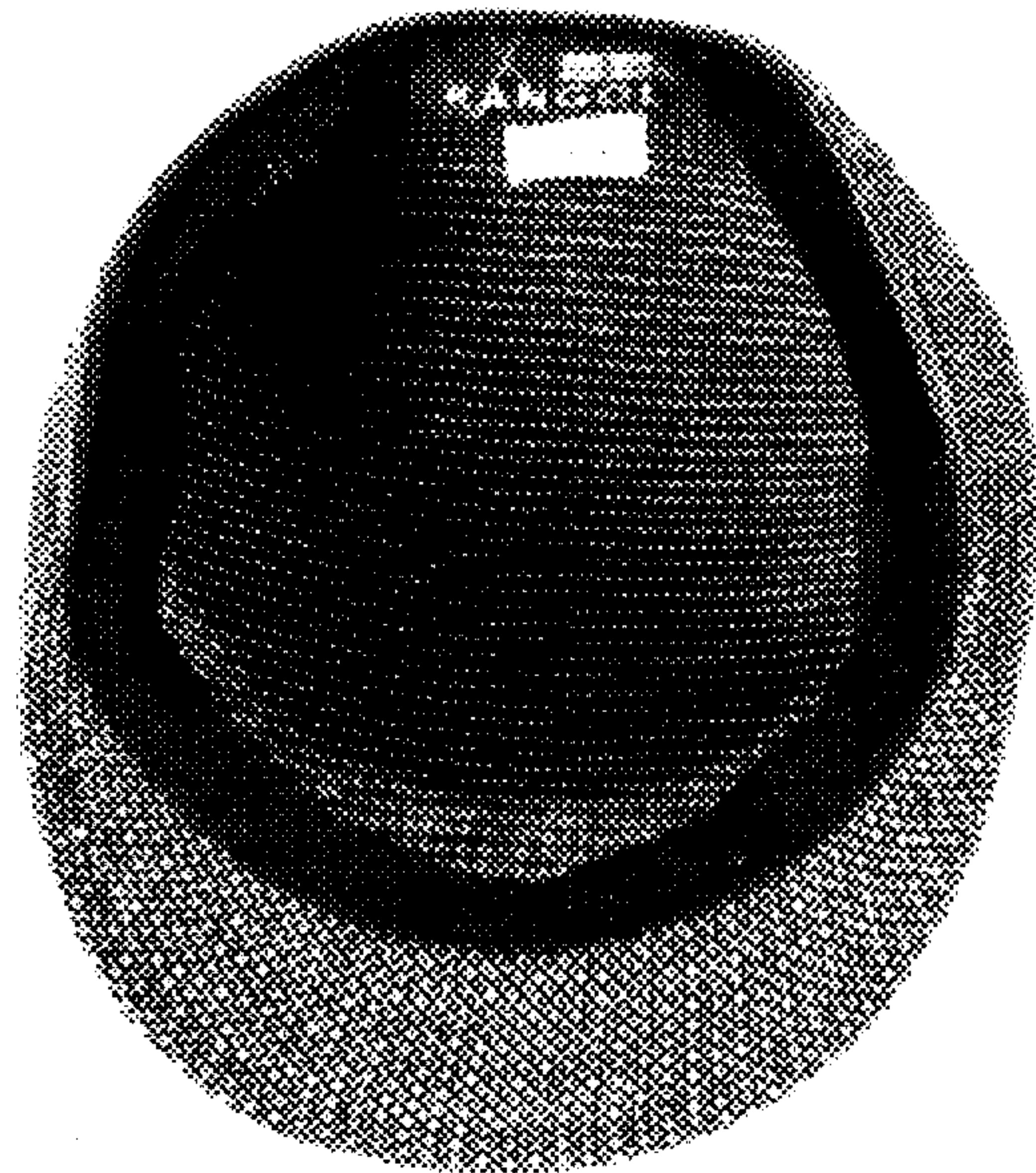

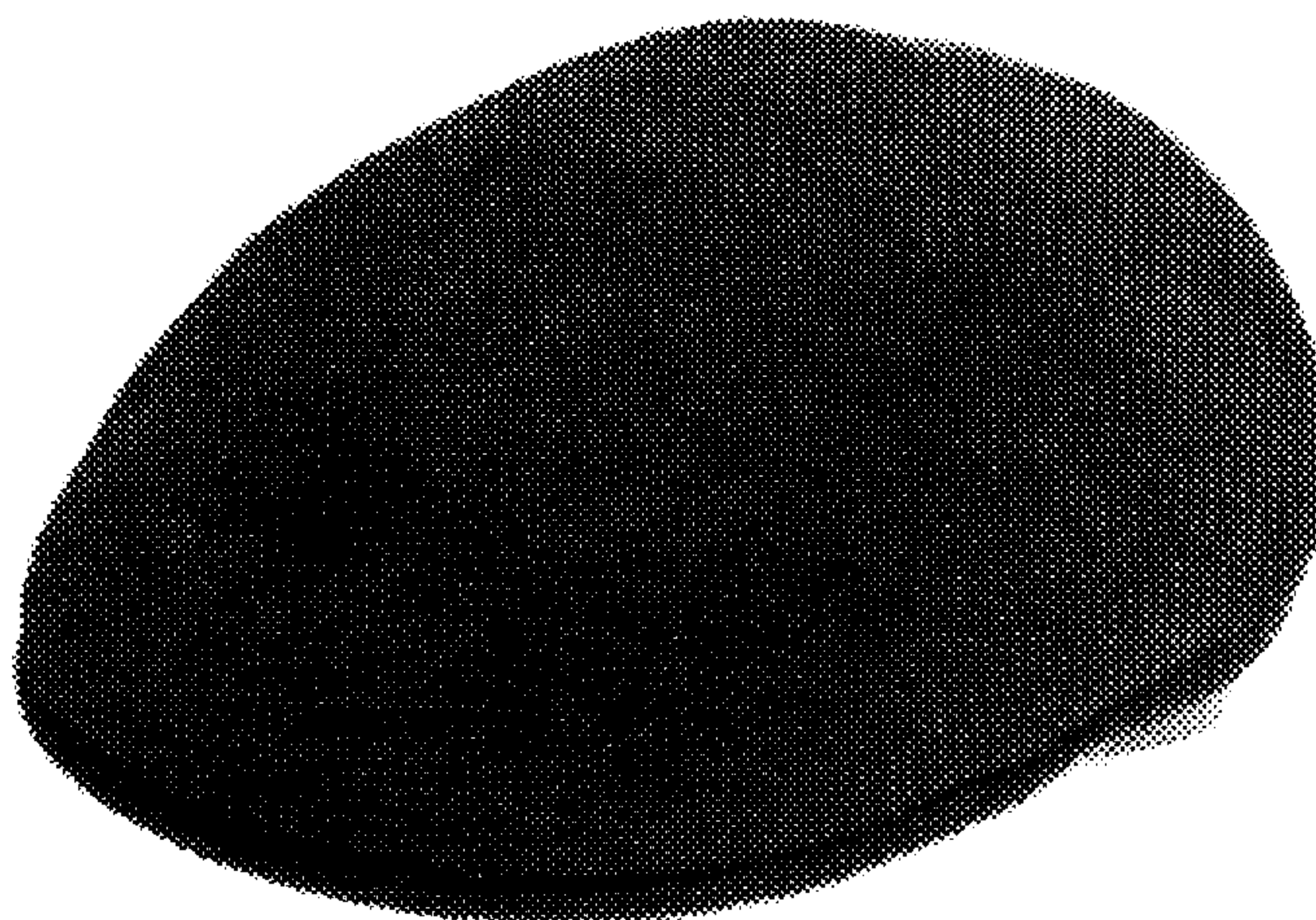

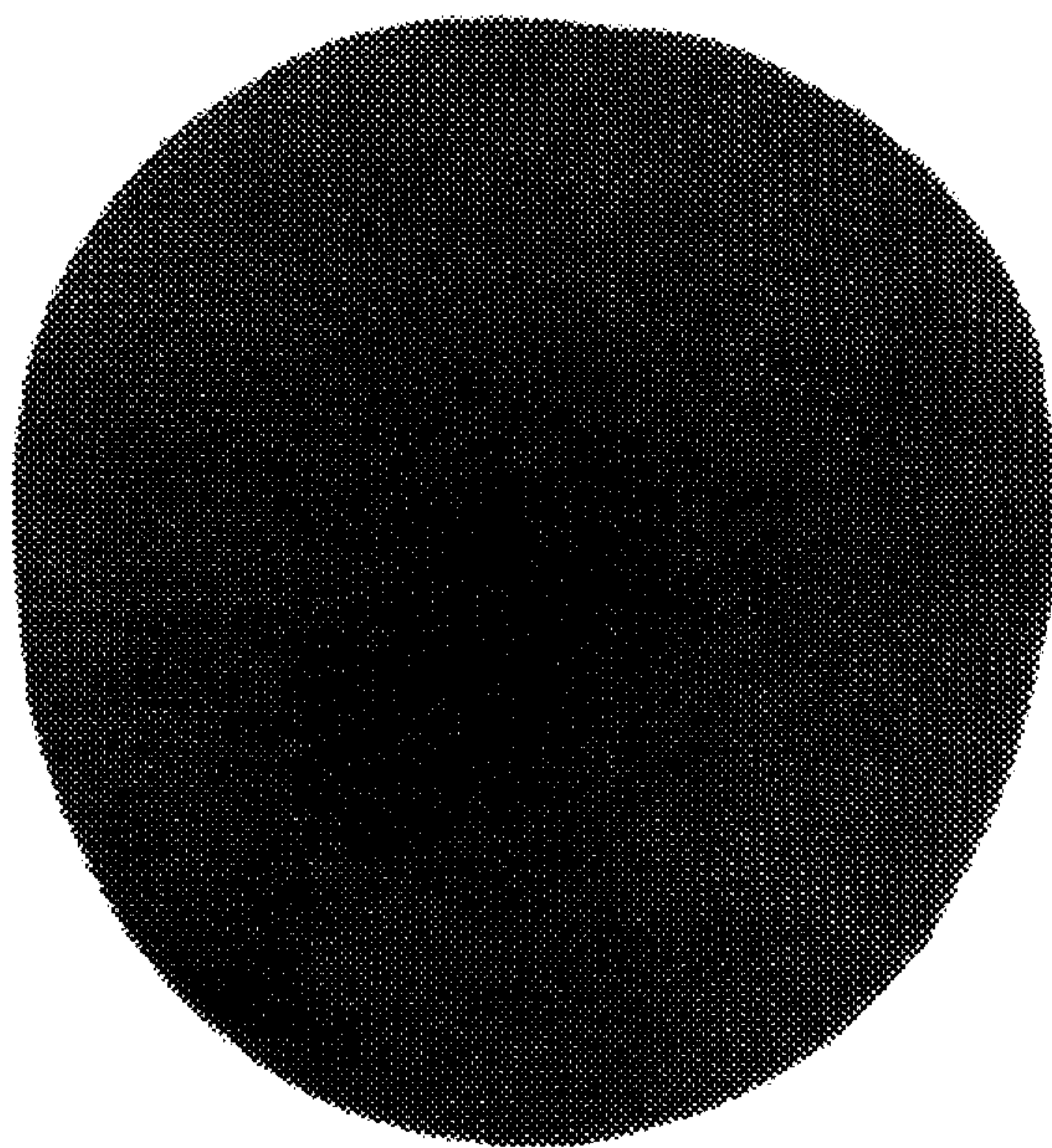

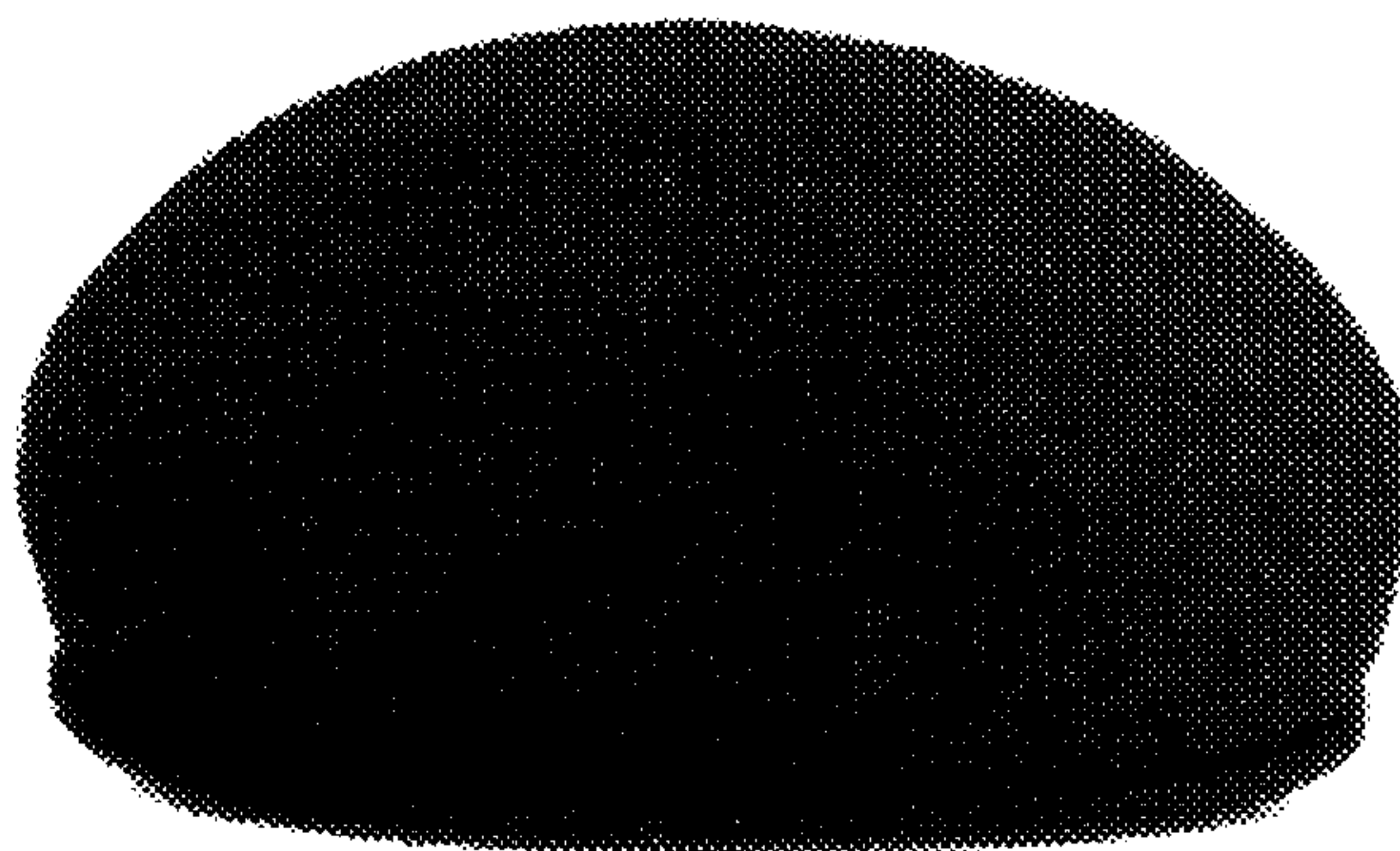
