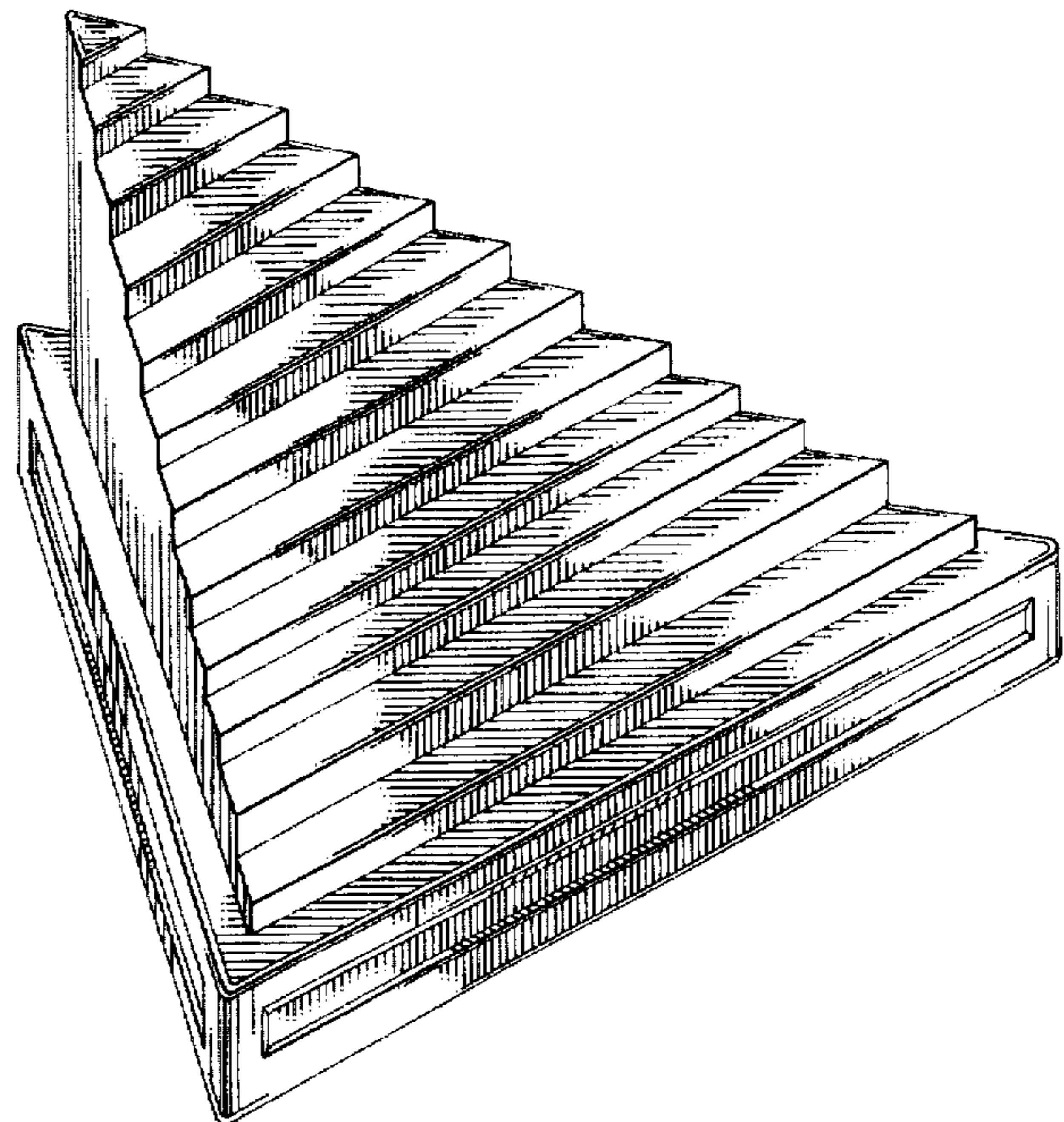
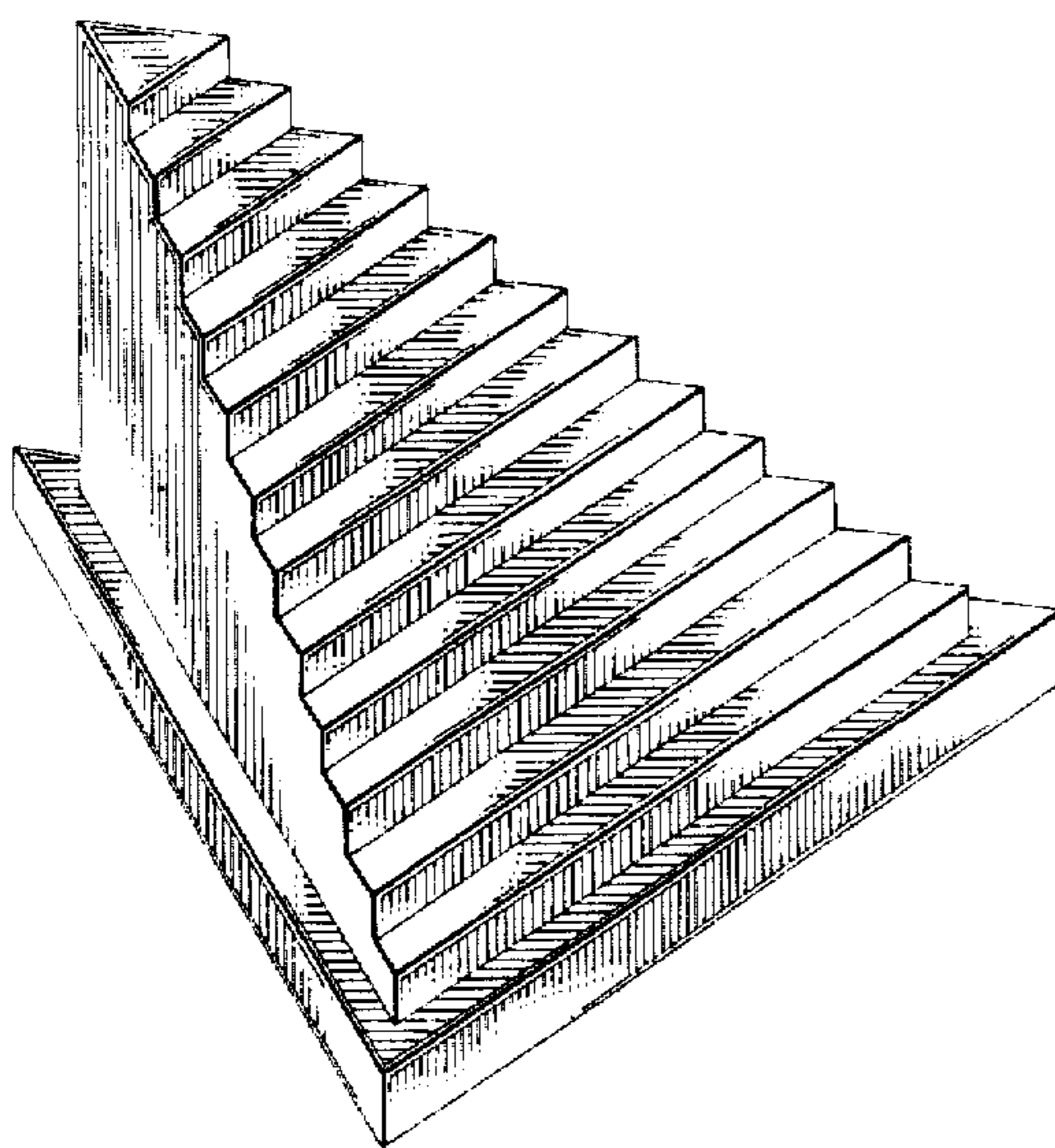
[57] **CLAIM**

The ornamental design for a pedestal, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper left front perspective view of a pedestal embodying my new ornamental design;  
FIG. 2 is a right side elevational view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a front upper left perspective view of a second embodiment of a pedestal;  
FIG. 8 is a front elevational view of FIG. 7;  
FIG. 9 is a top view of FIG. 7;  
FIG. 10 is a right side elevational view of FIG. 7;  
FIG. 11 is a rear elevational view of FIG. 7; and,  
FIG. 12 is a bottom view of FIG. 7 on a reduced scale.

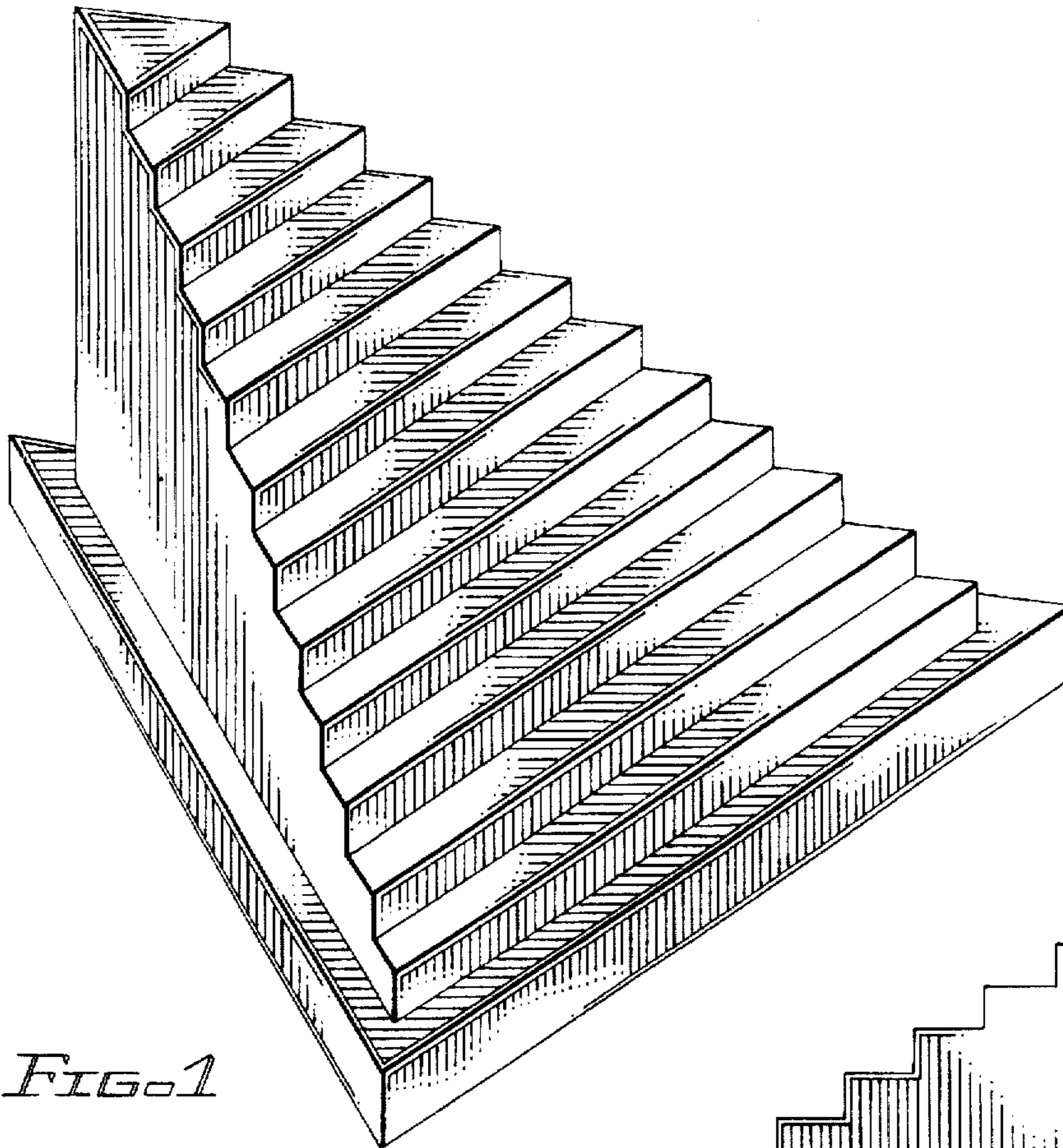

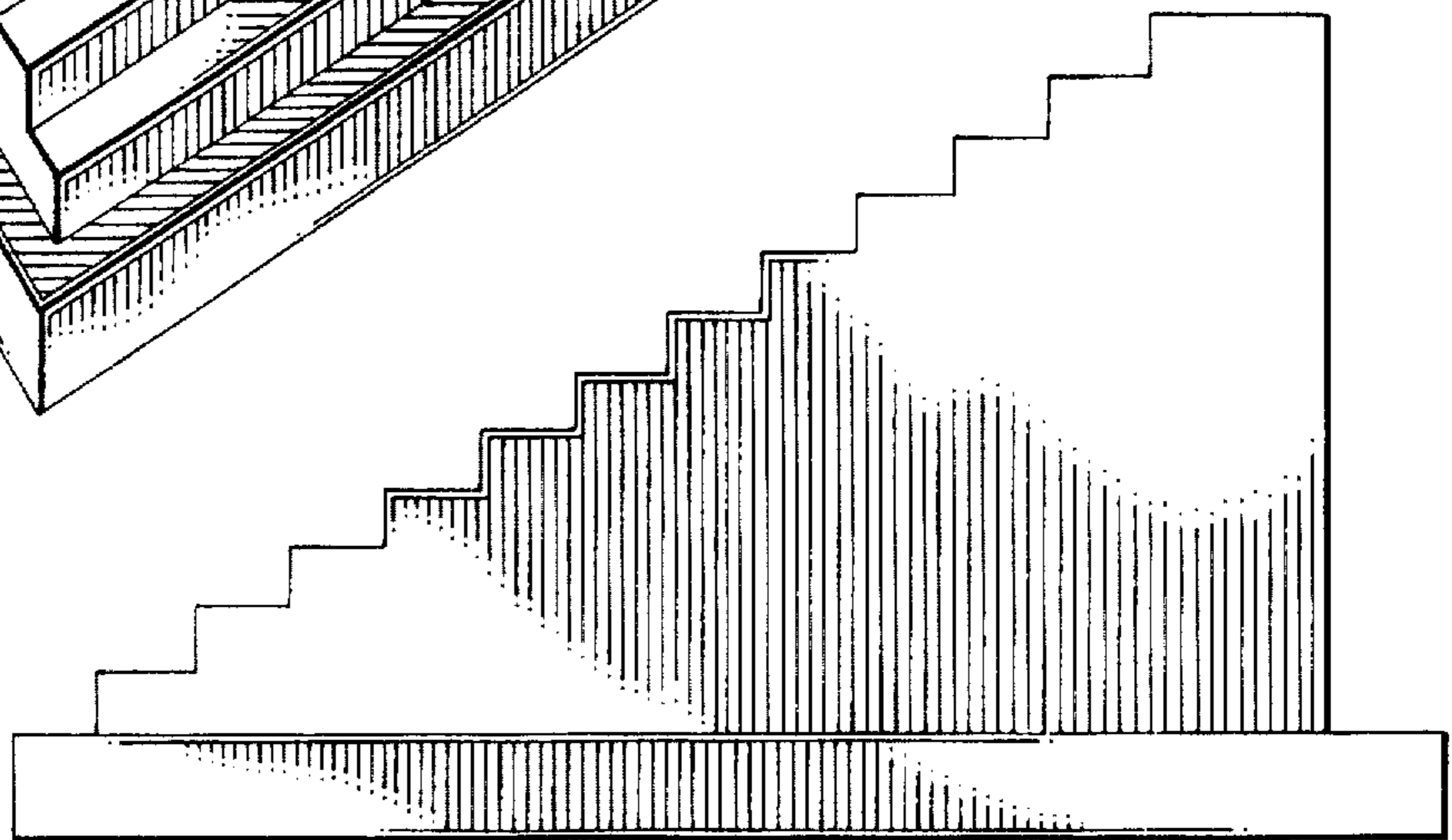

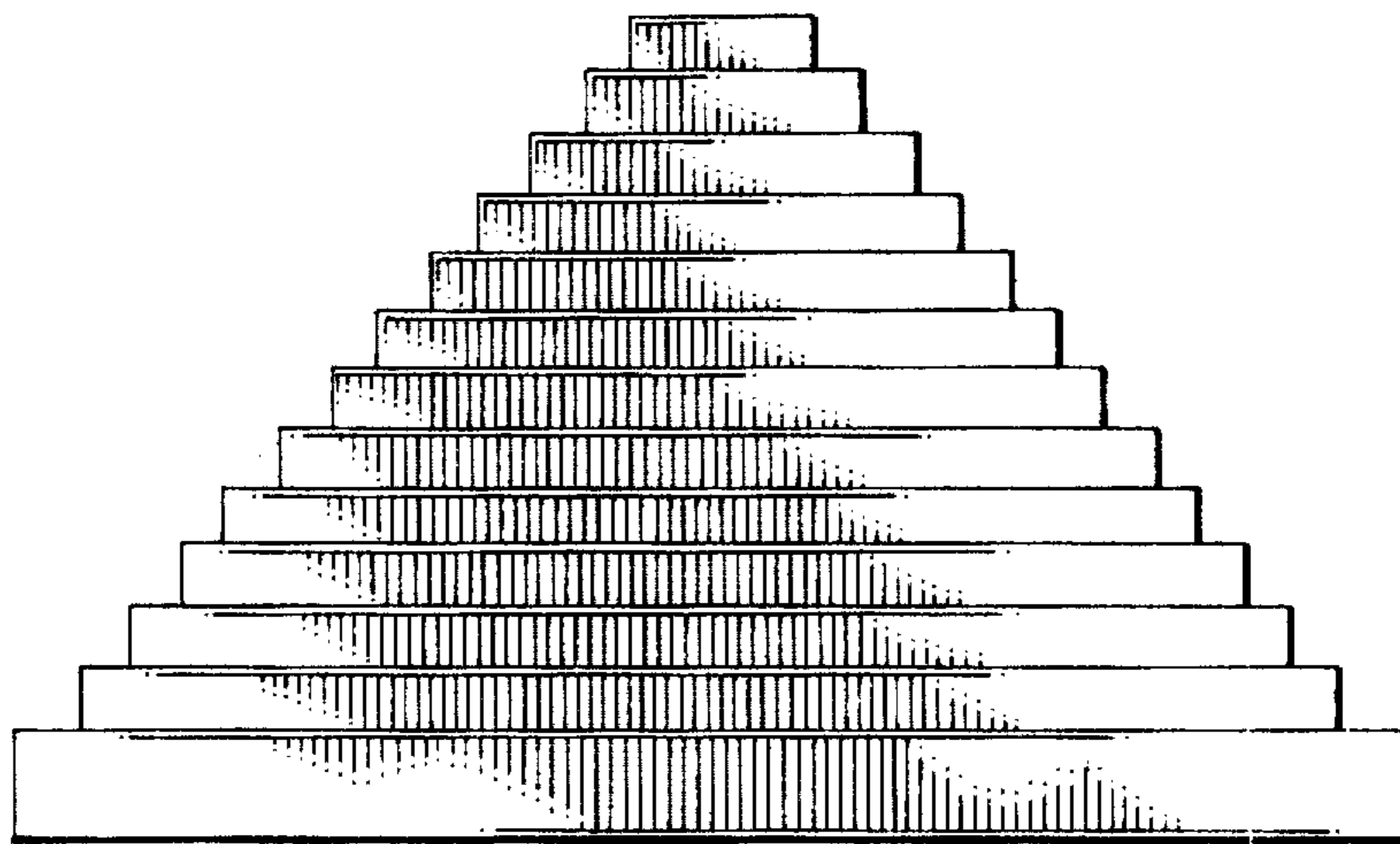

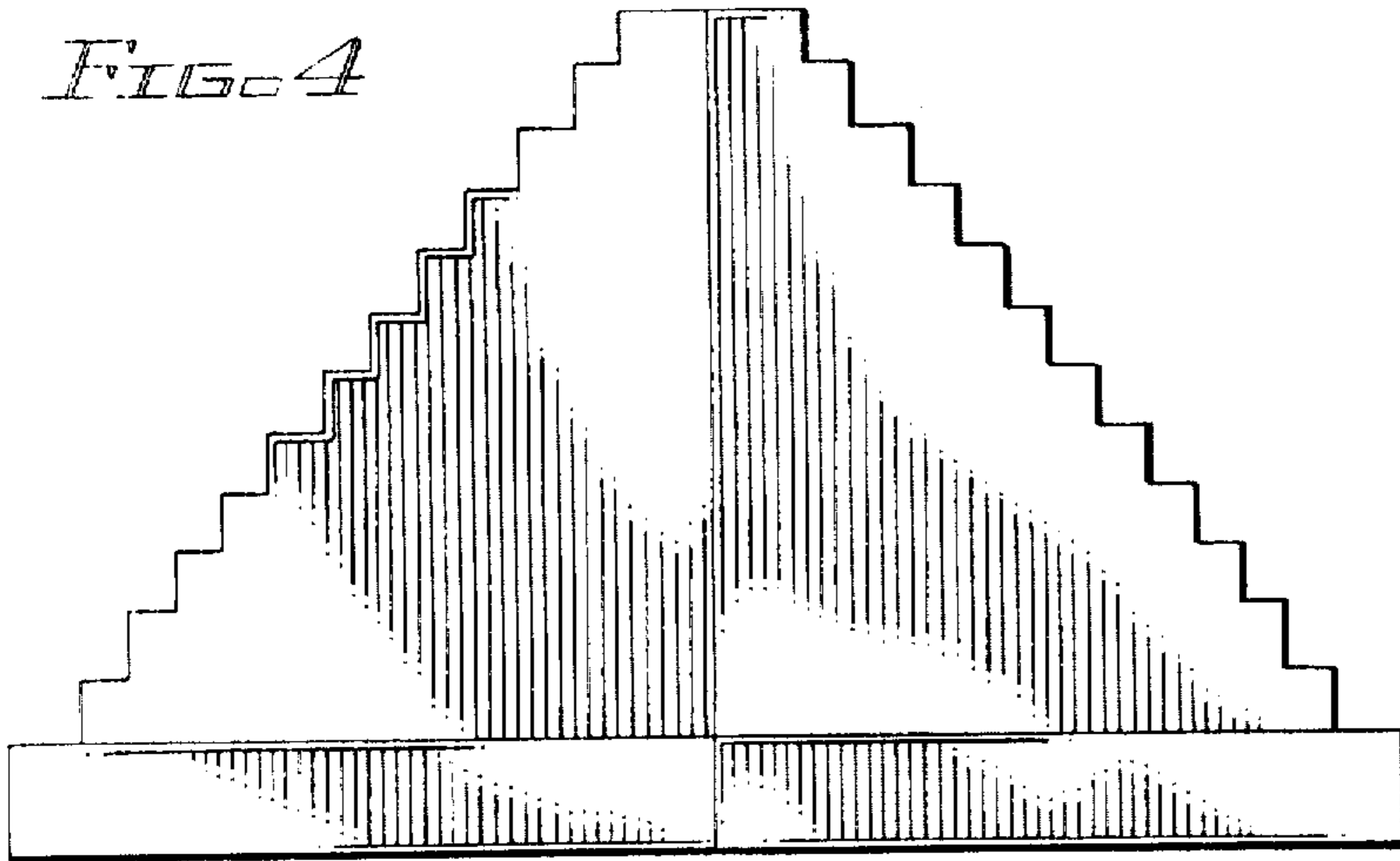

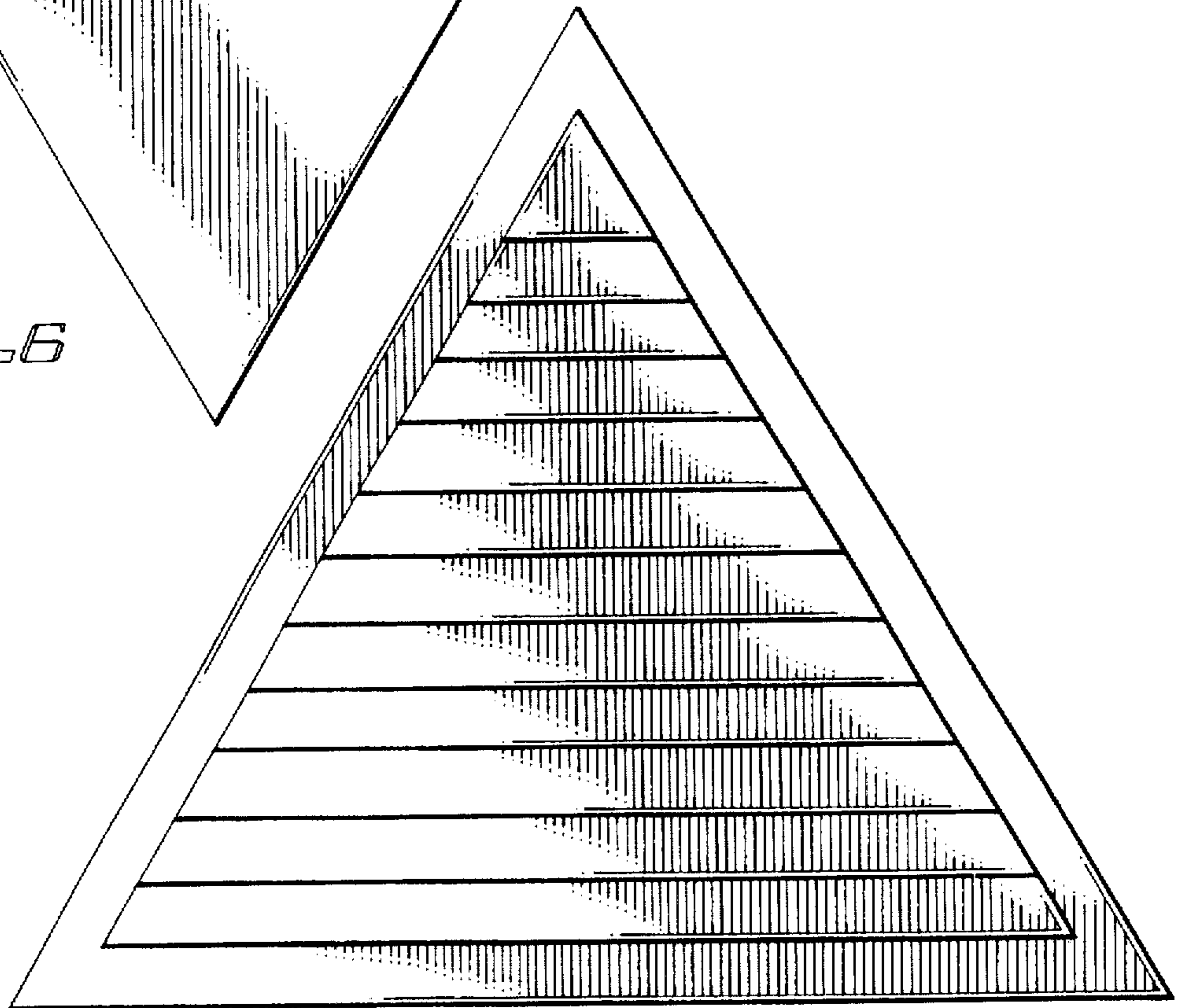
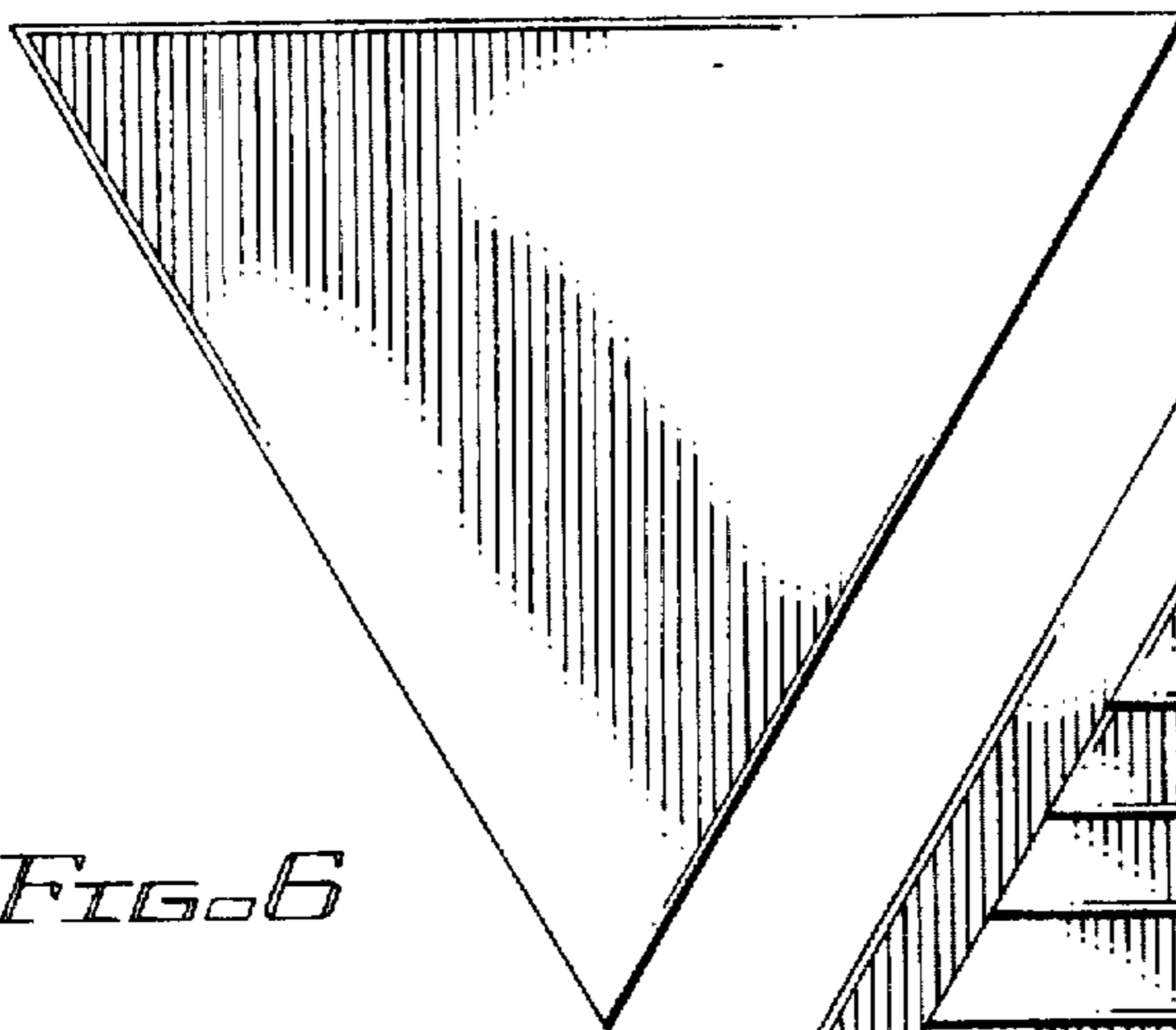

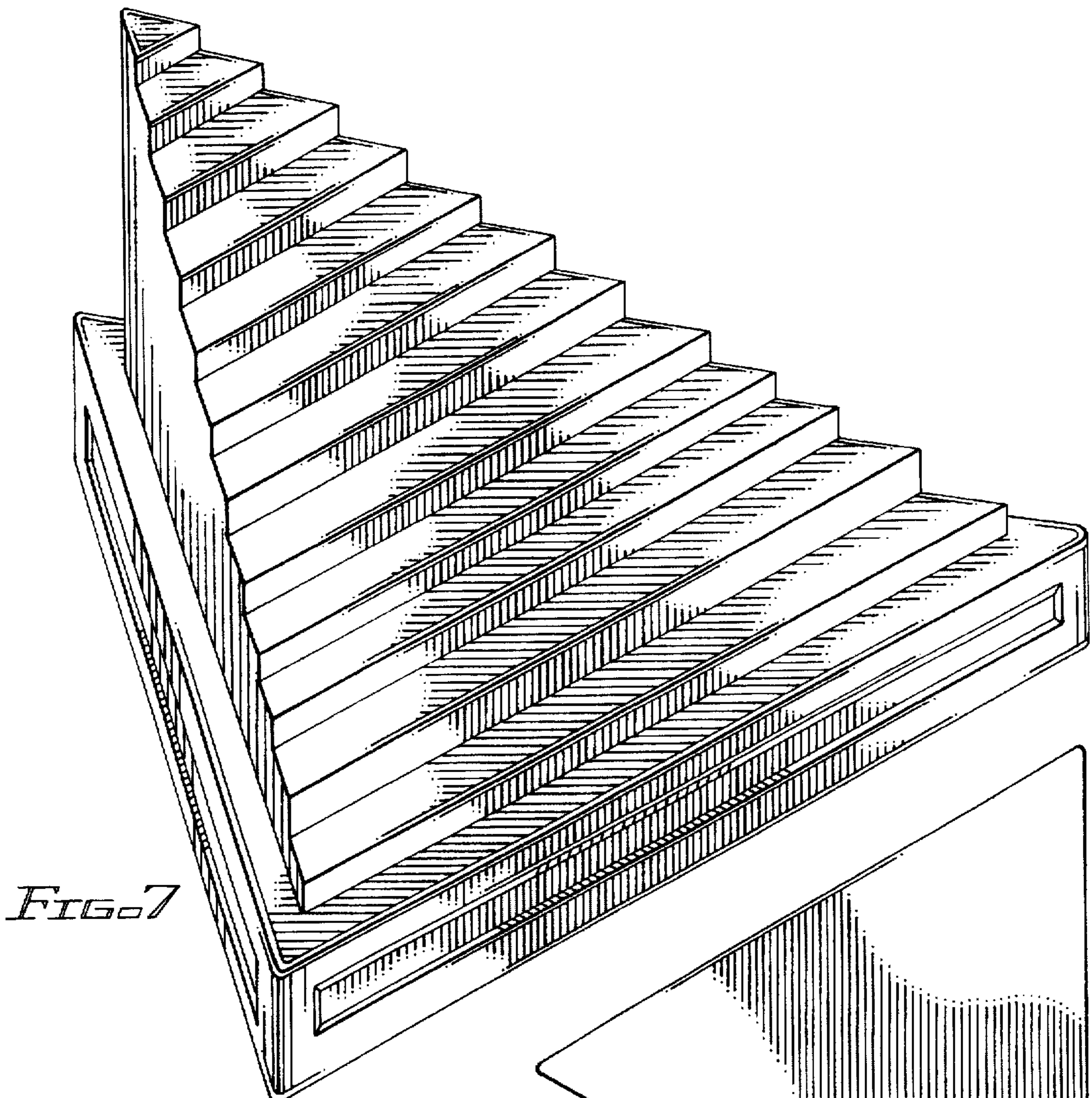

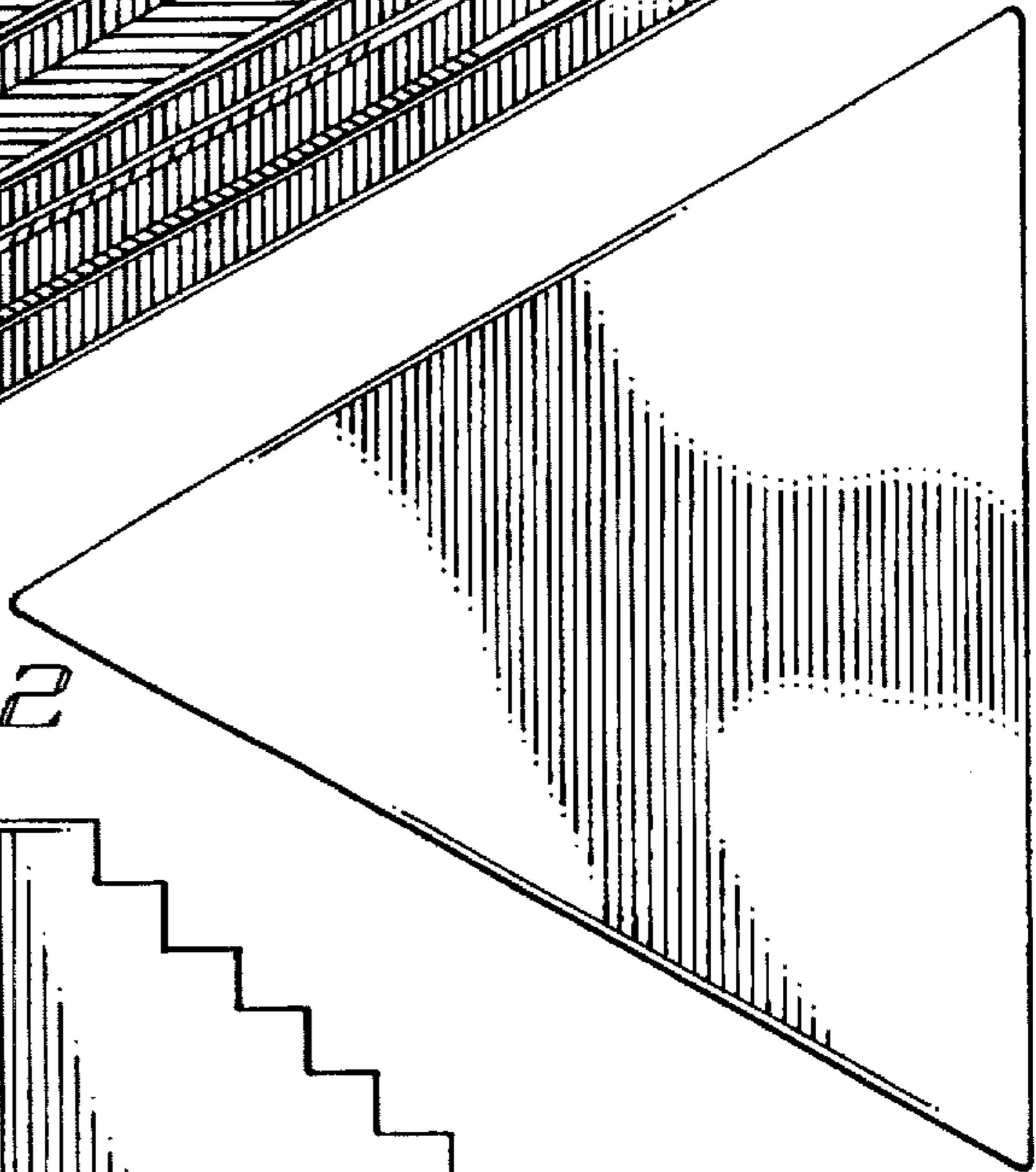

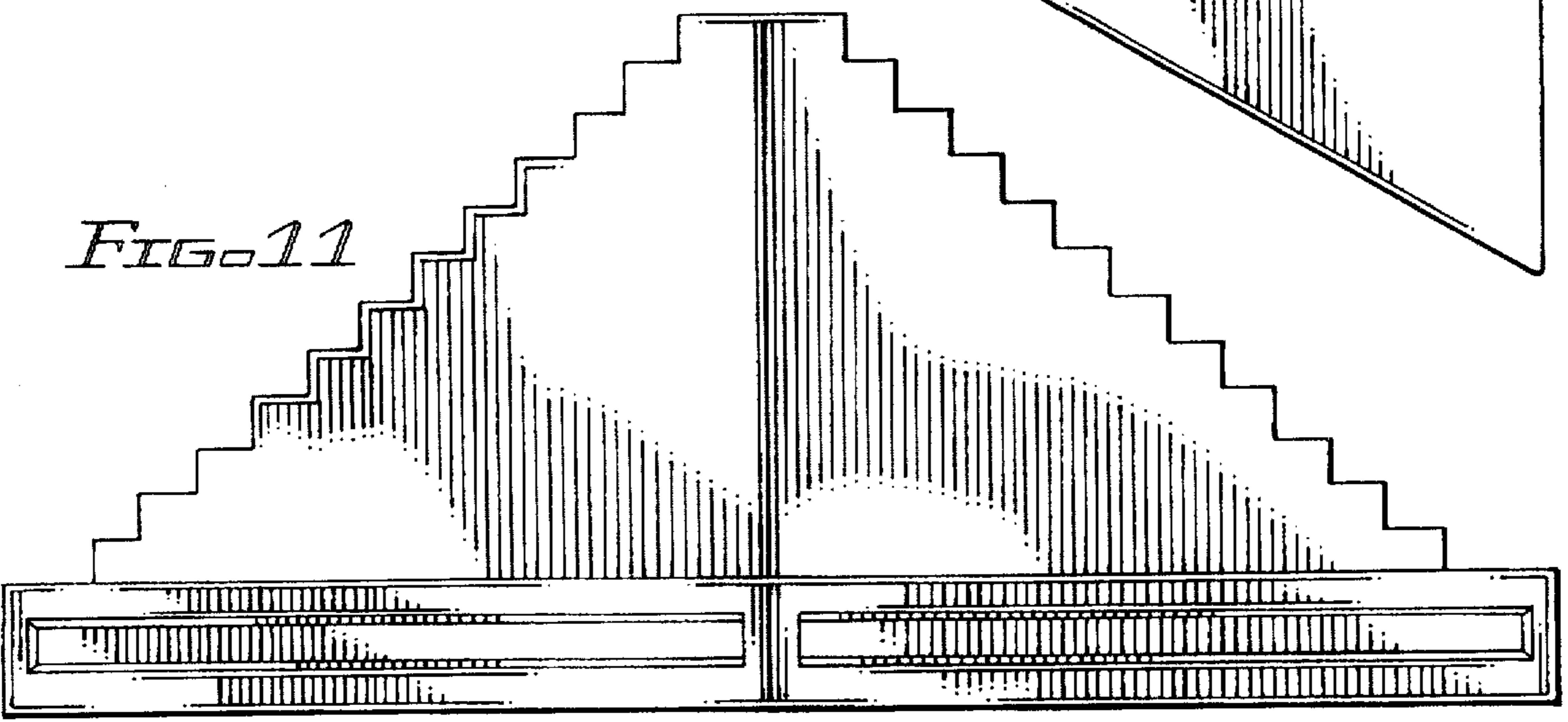

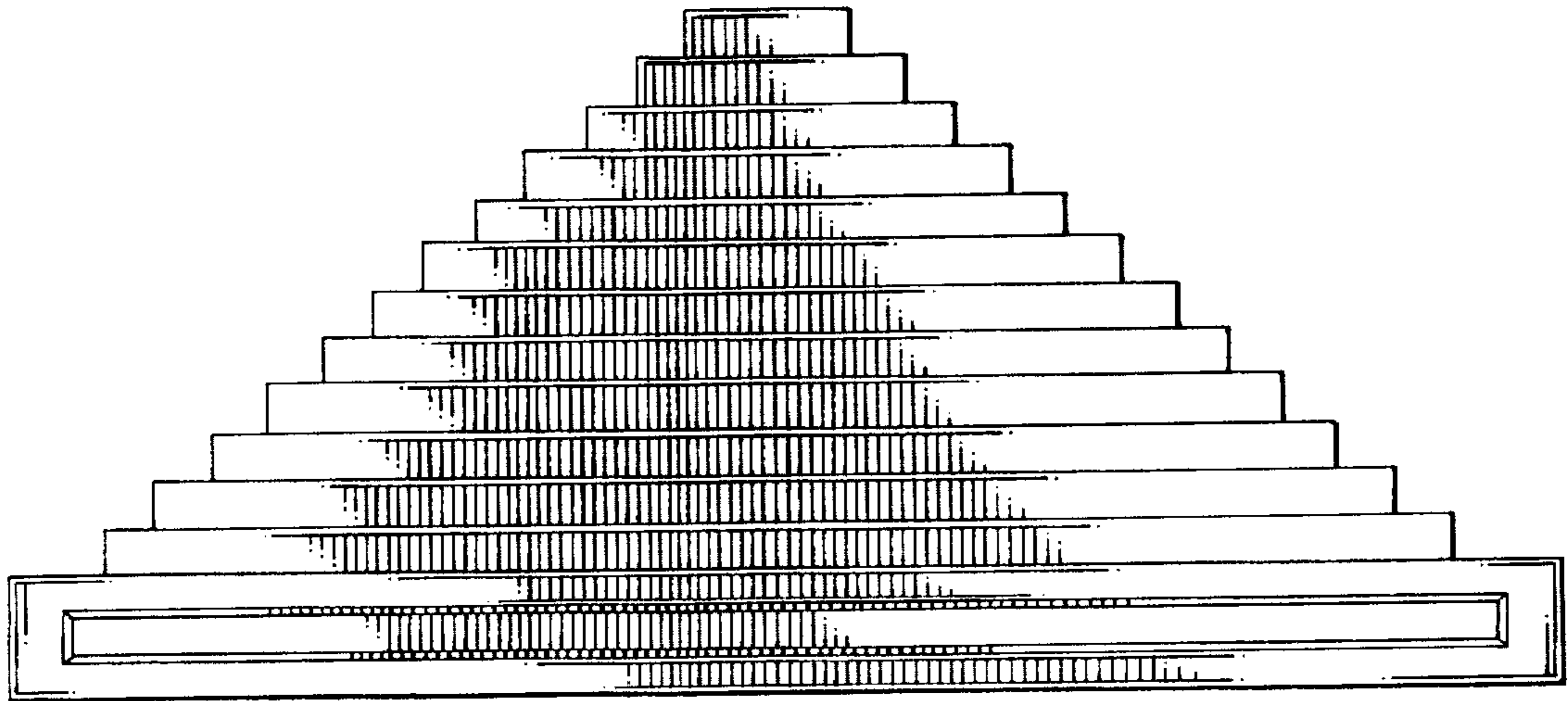

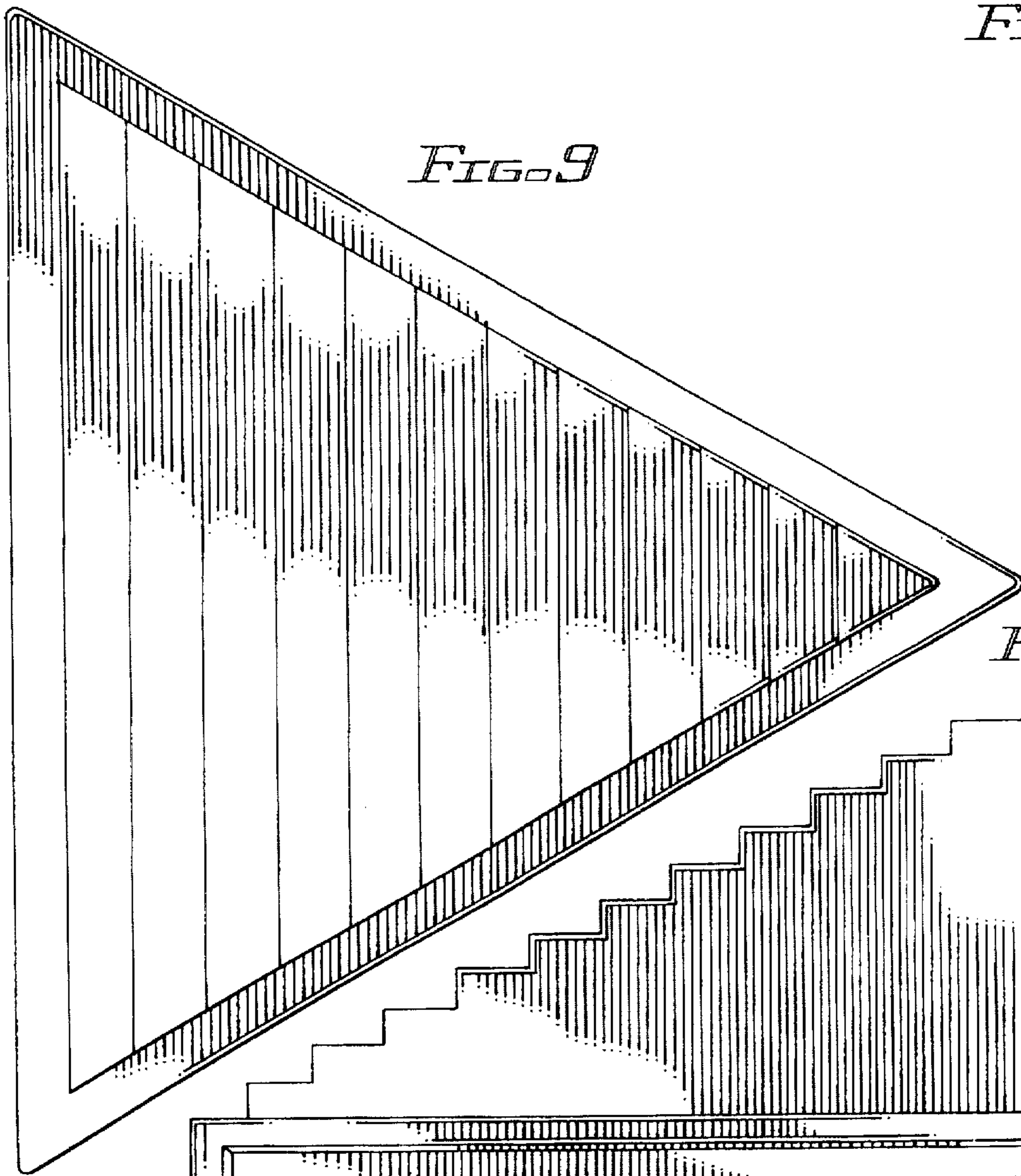
