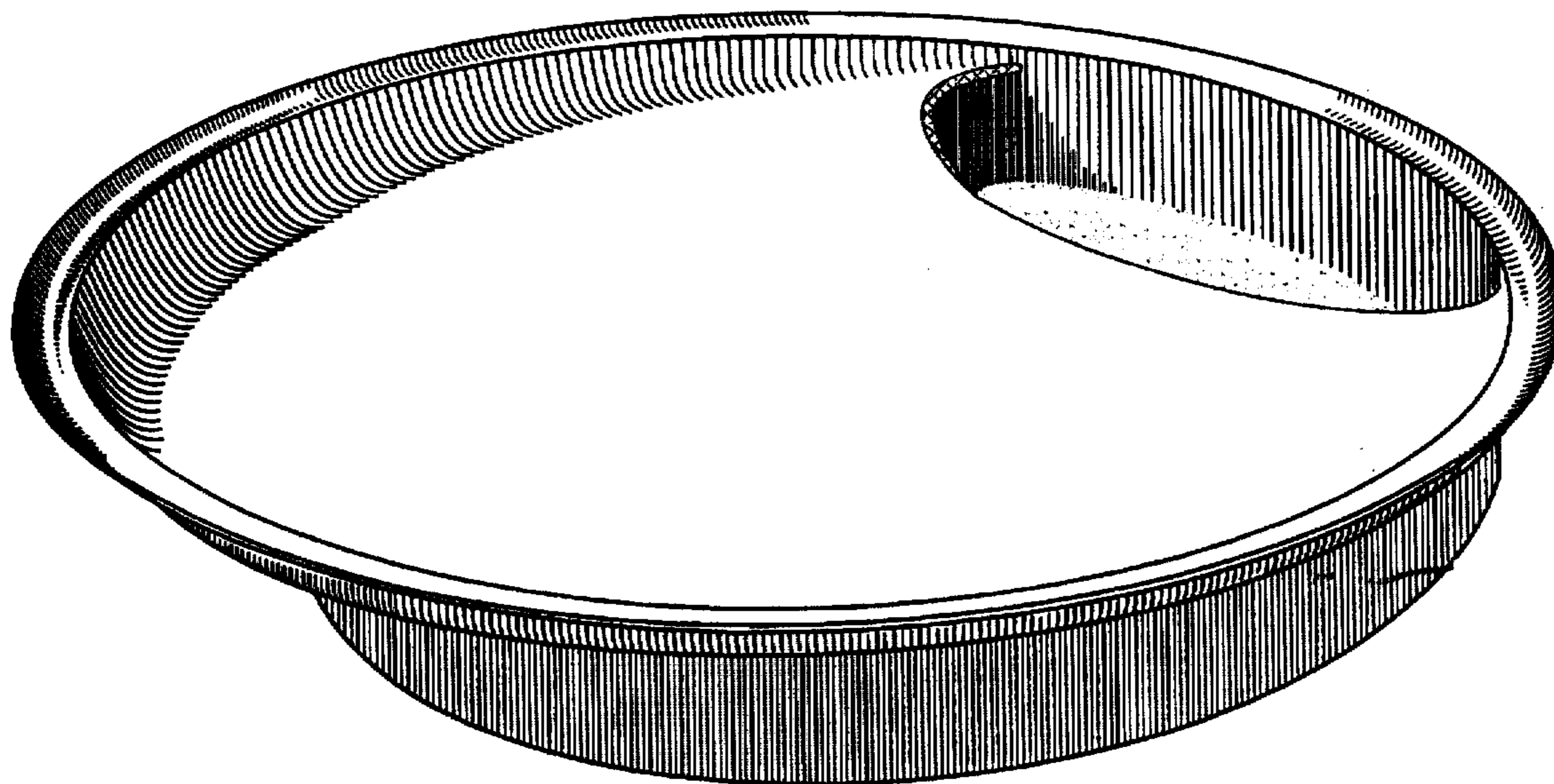
FIG. 1 is a top perspective view of a bowl having an internal shelf showing our new design;

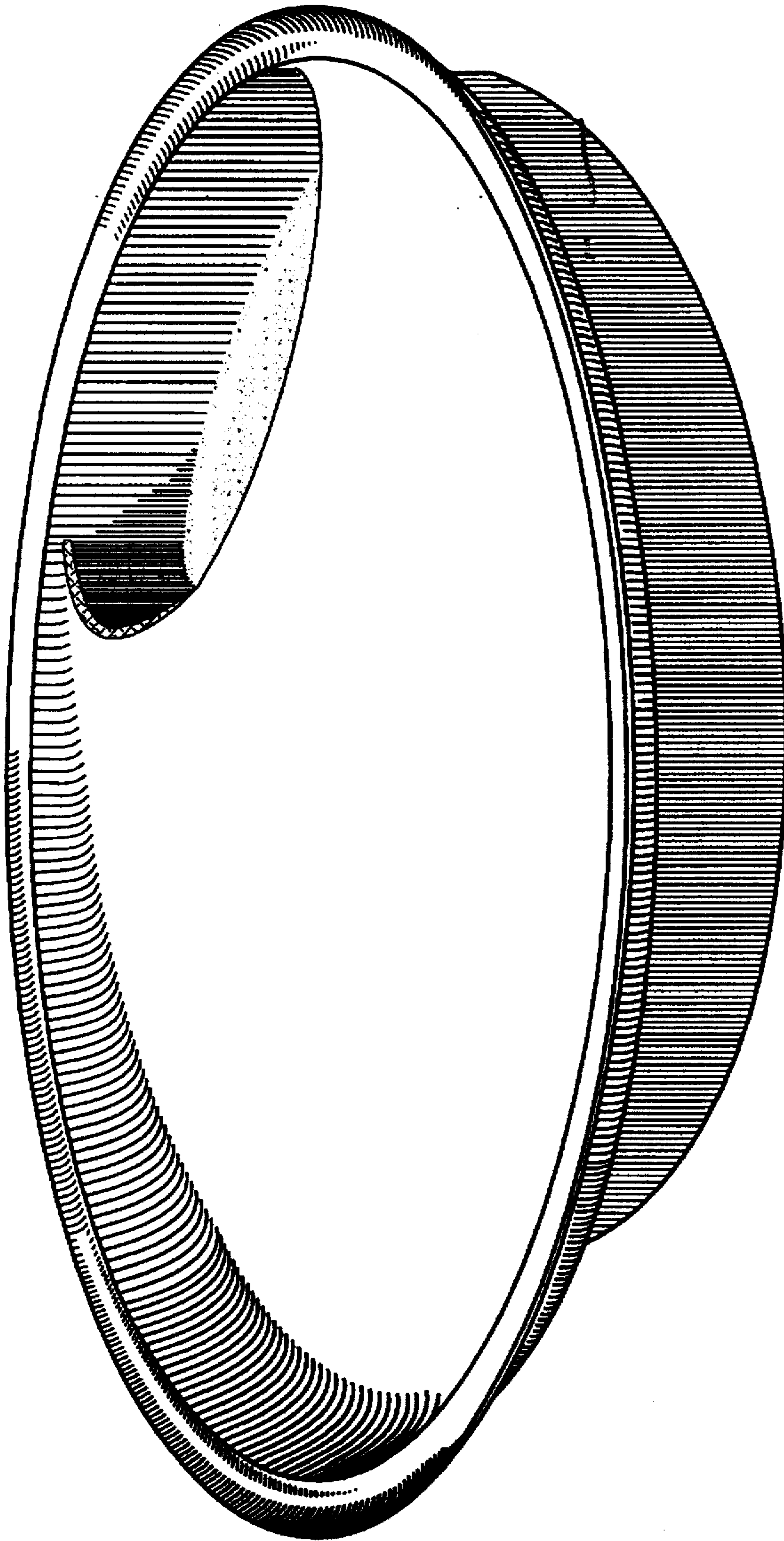

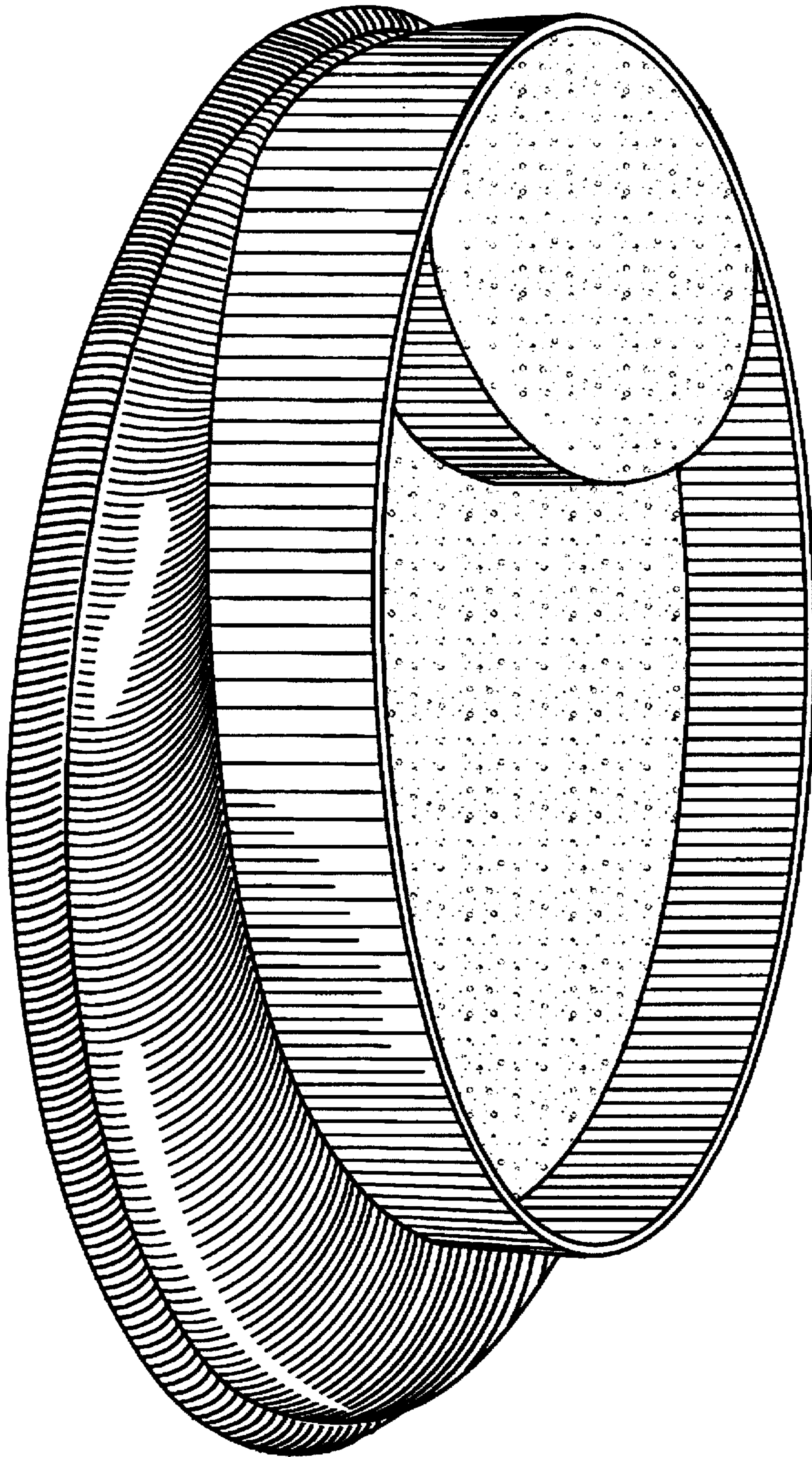

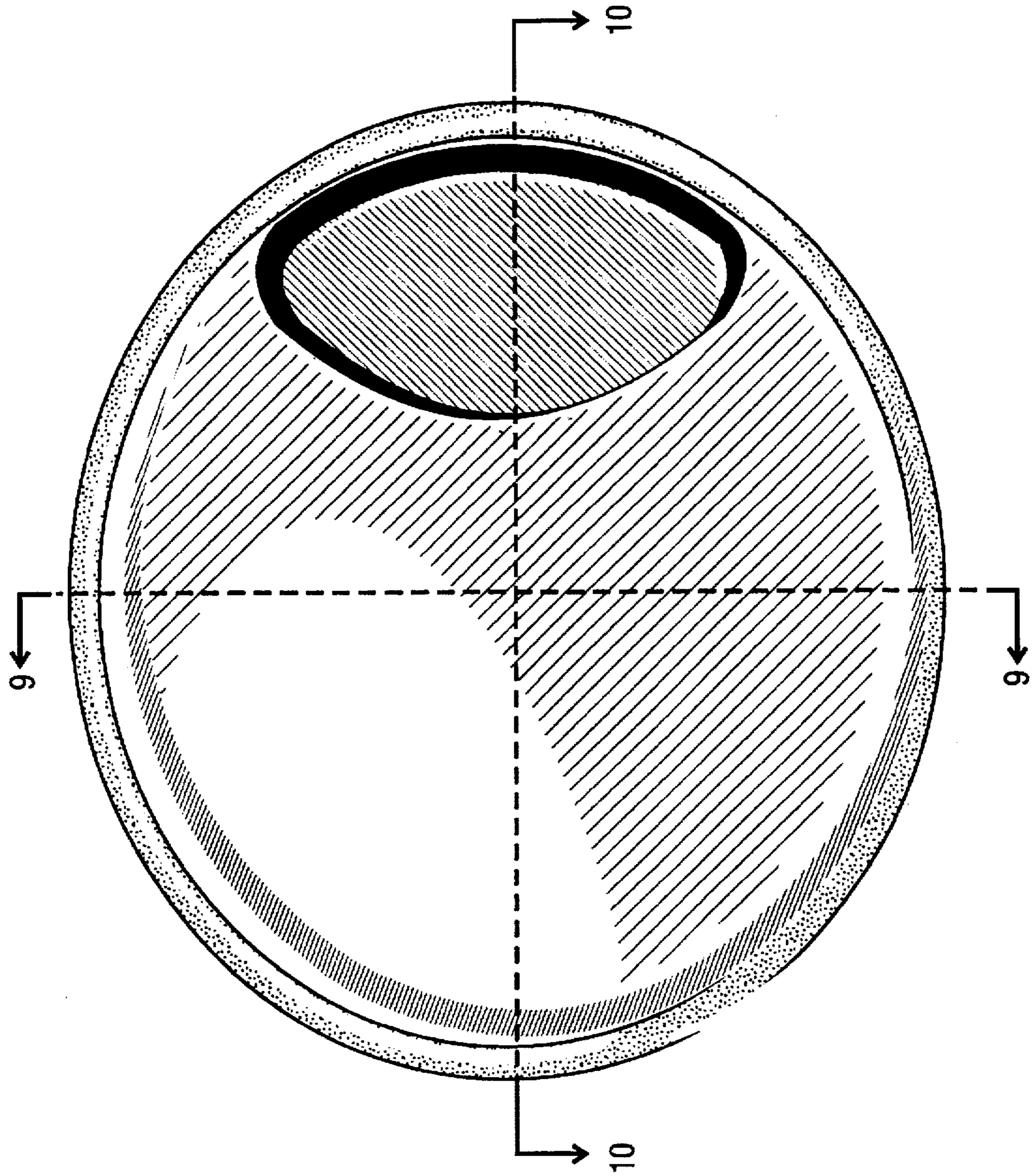

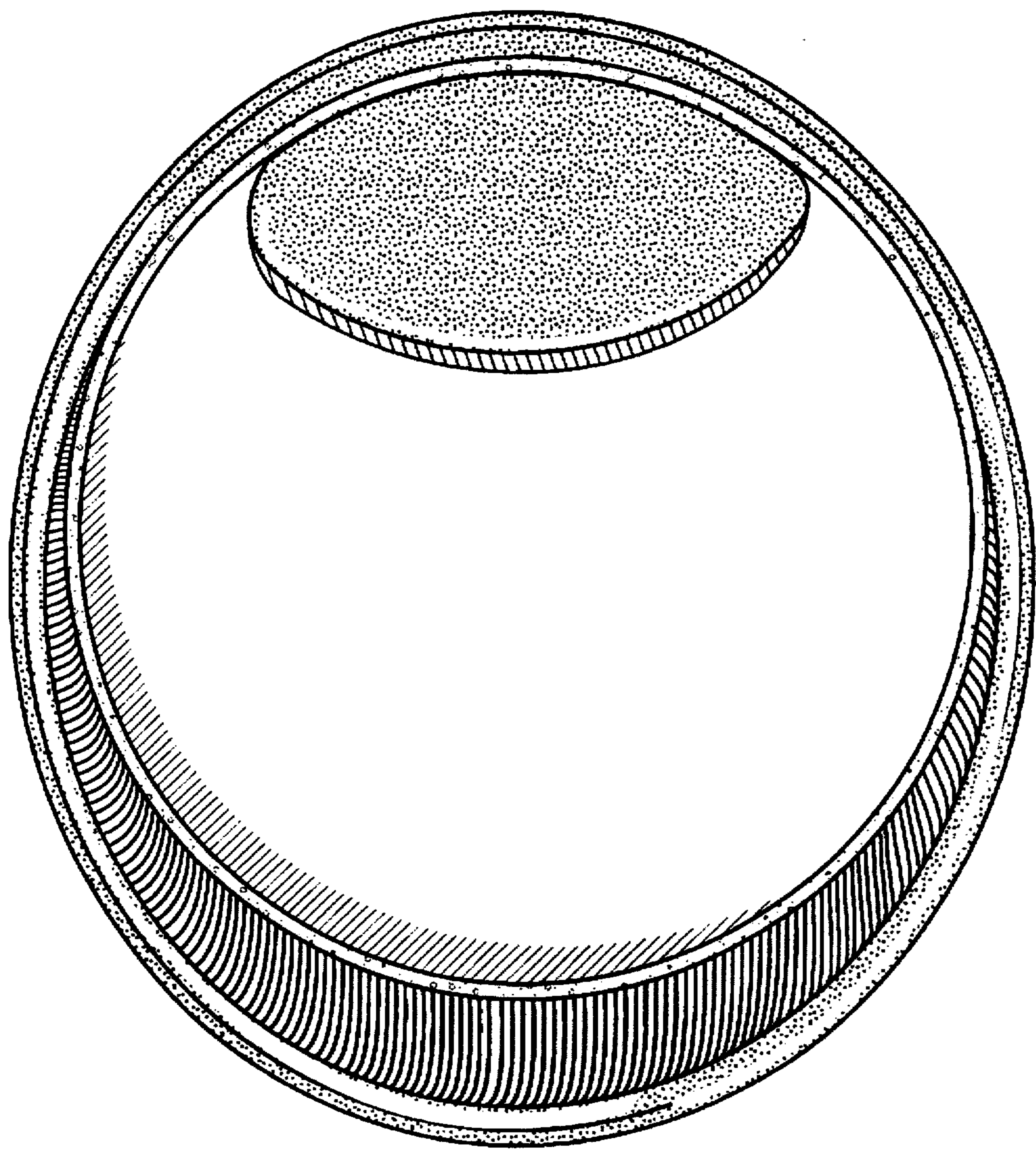

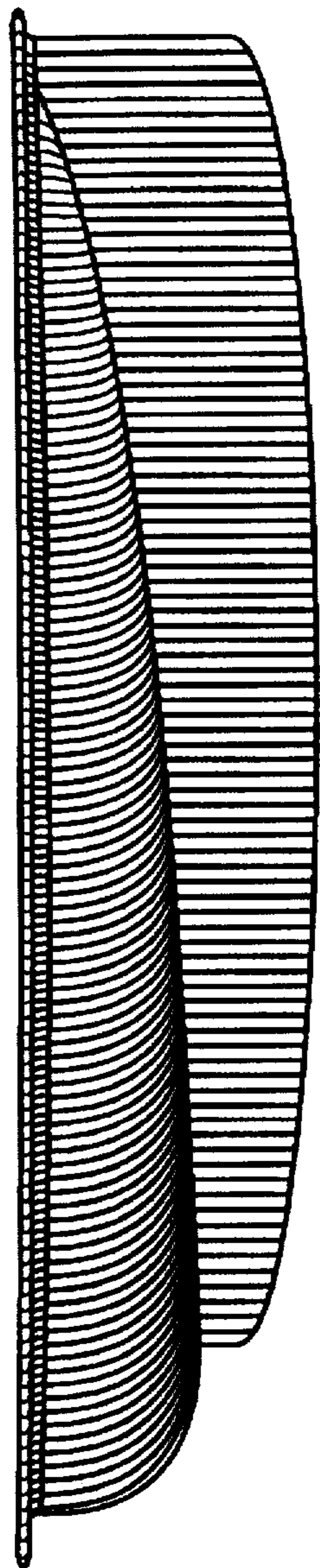

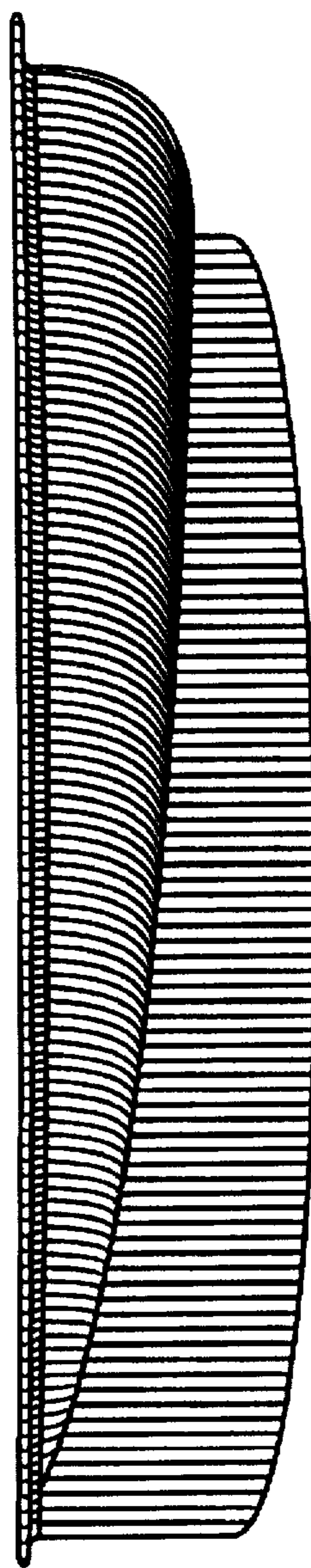

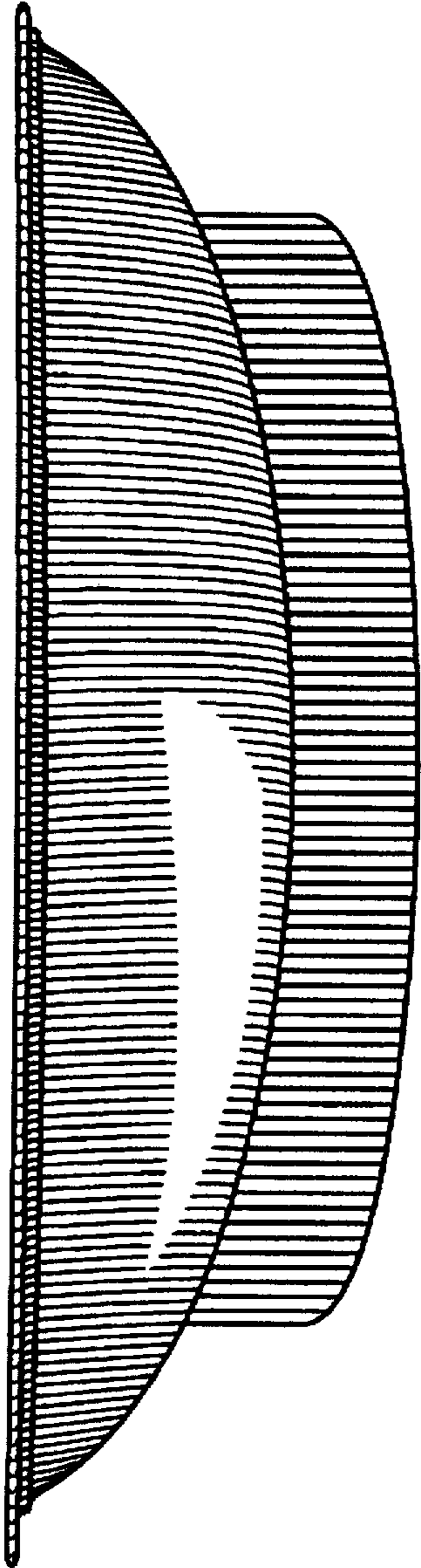

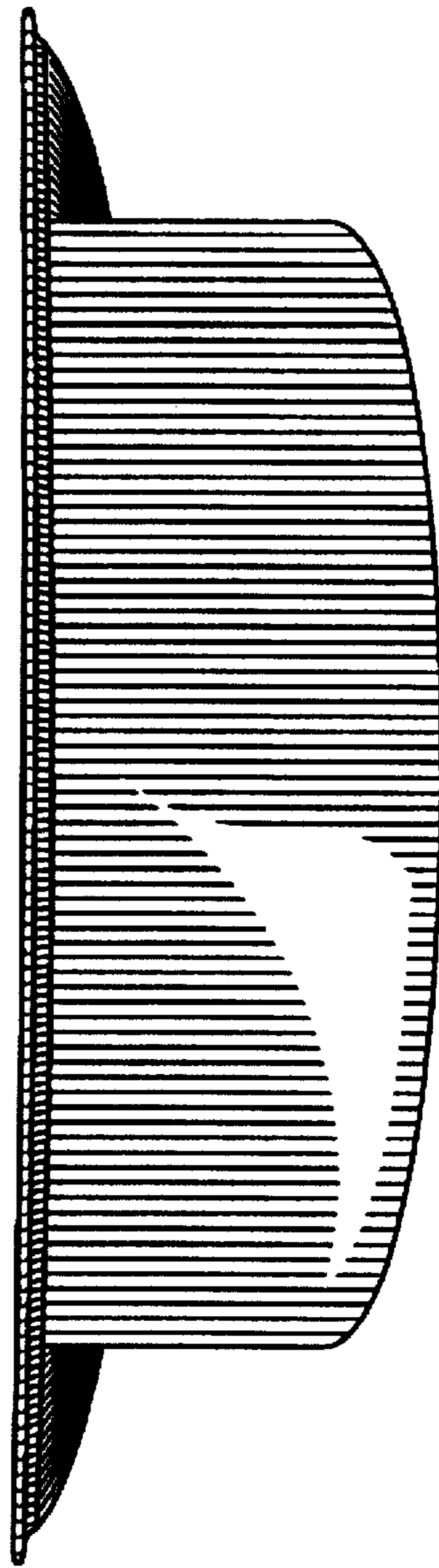

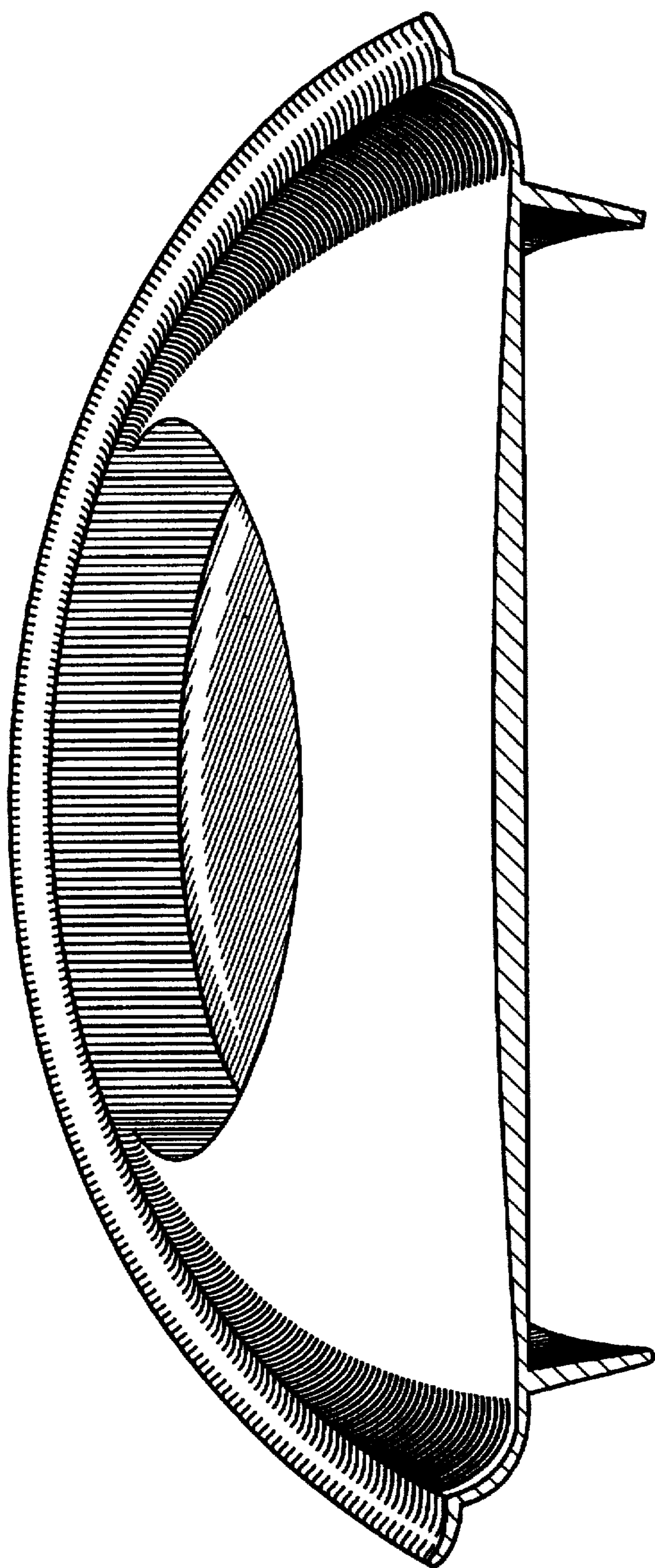

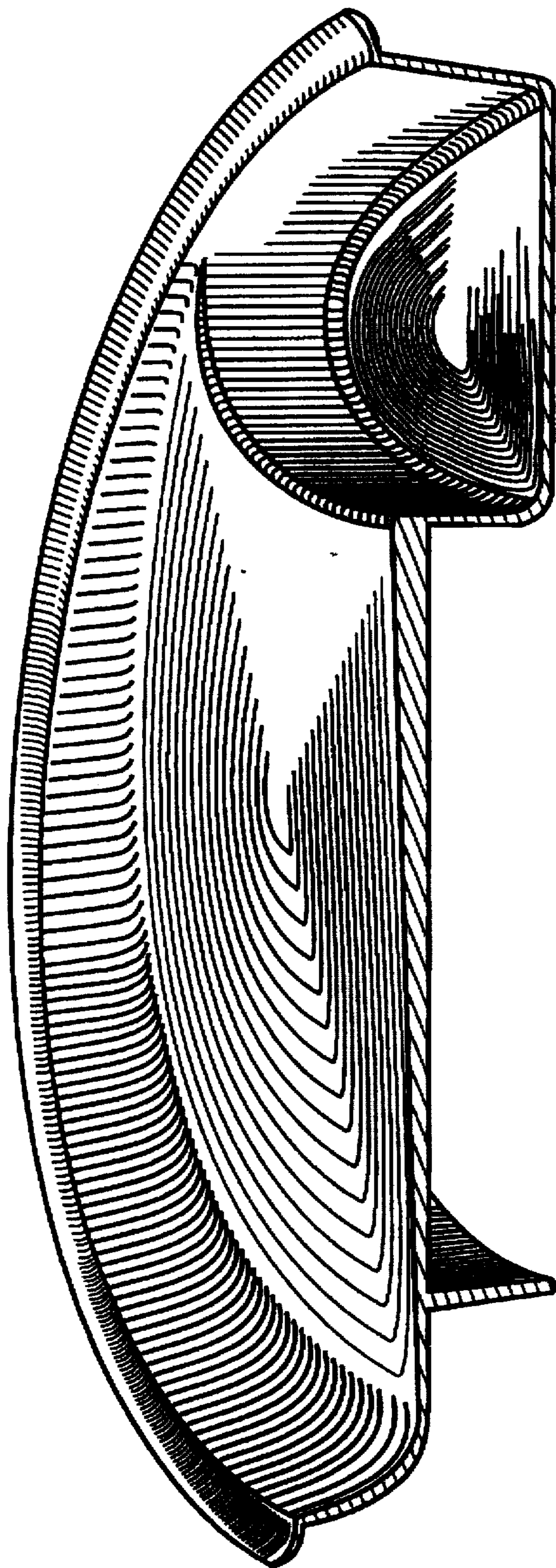
