The ornamental design for a one legged torchfoot, as shown.

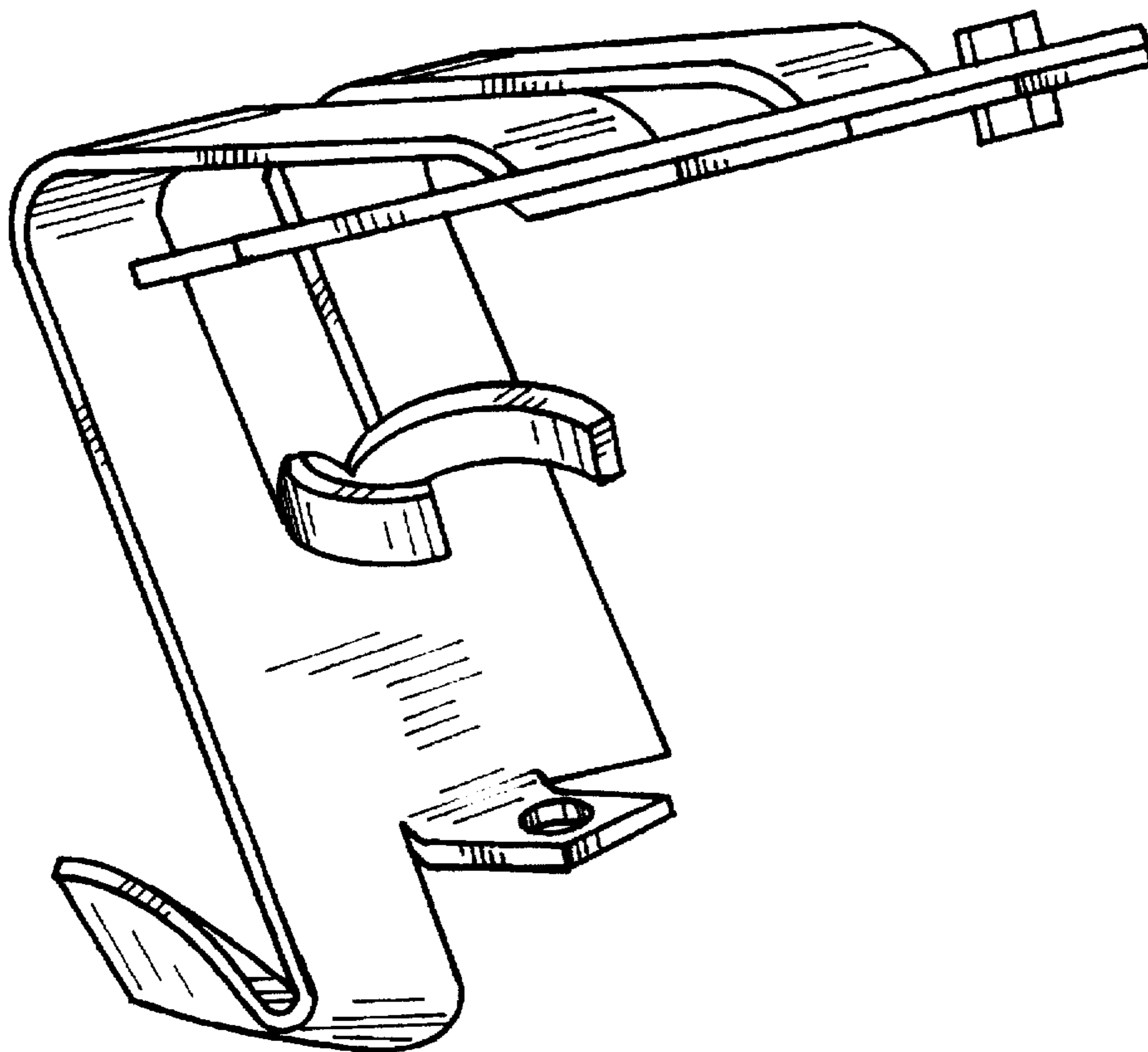
DESCRIPTION

FIG. 1 is a rear view of a left handed, rear grip torchfoot showing my new design;
FIG. 2 is a left side elevational view thereof, the broken line showing of a cutting torch being for illustrative purposes only and forming no part of the claimed design;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view elevational view thereof.

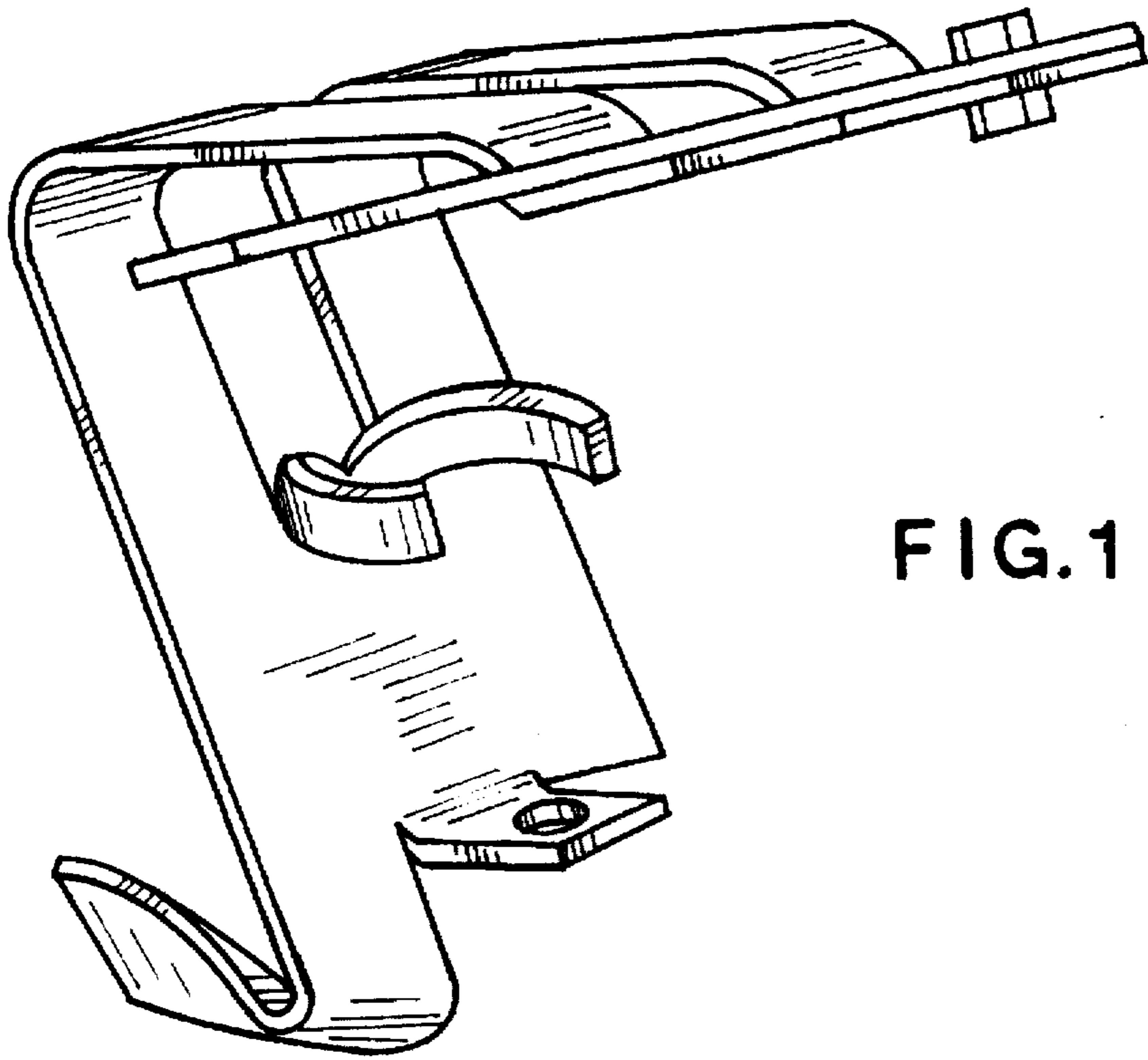

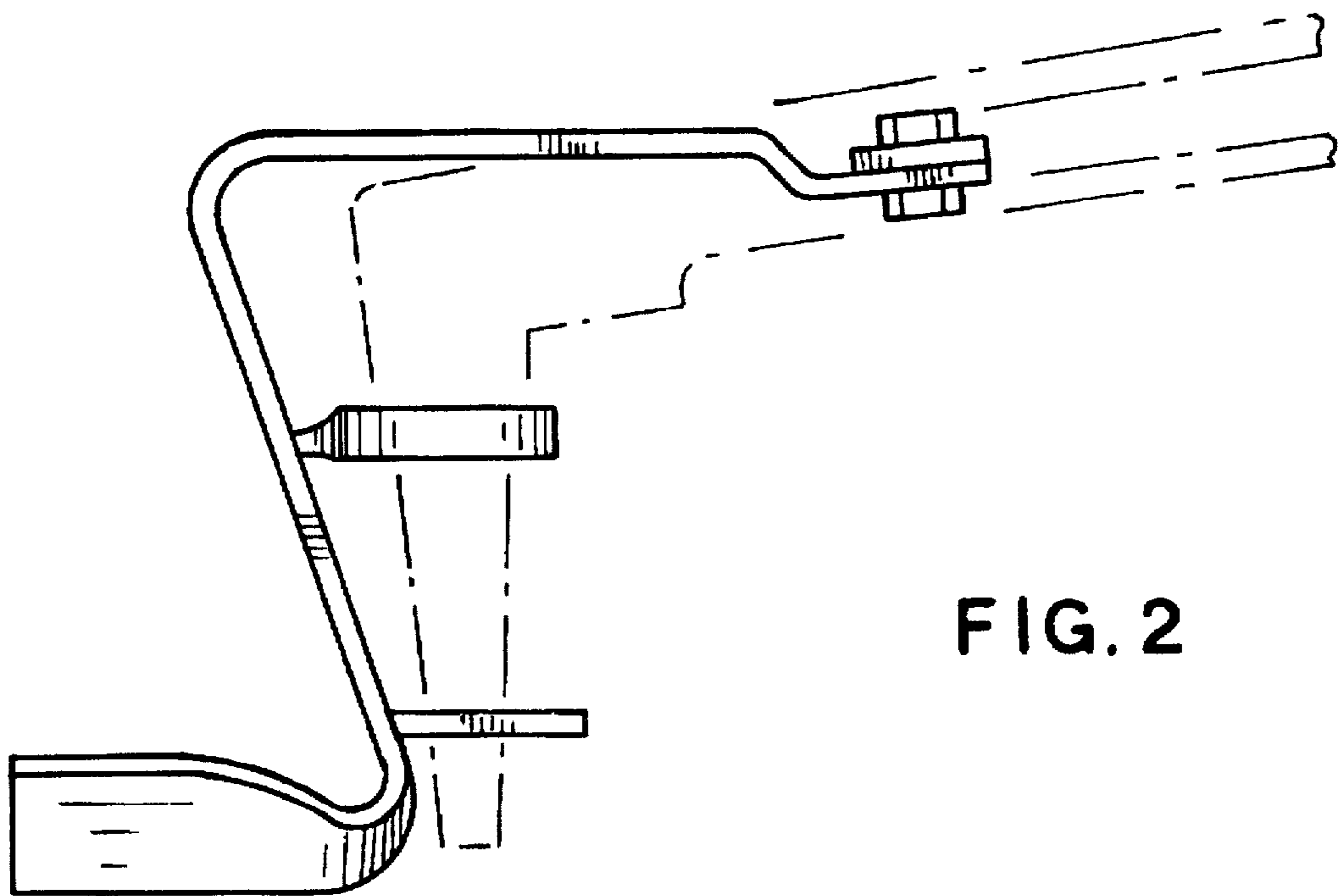

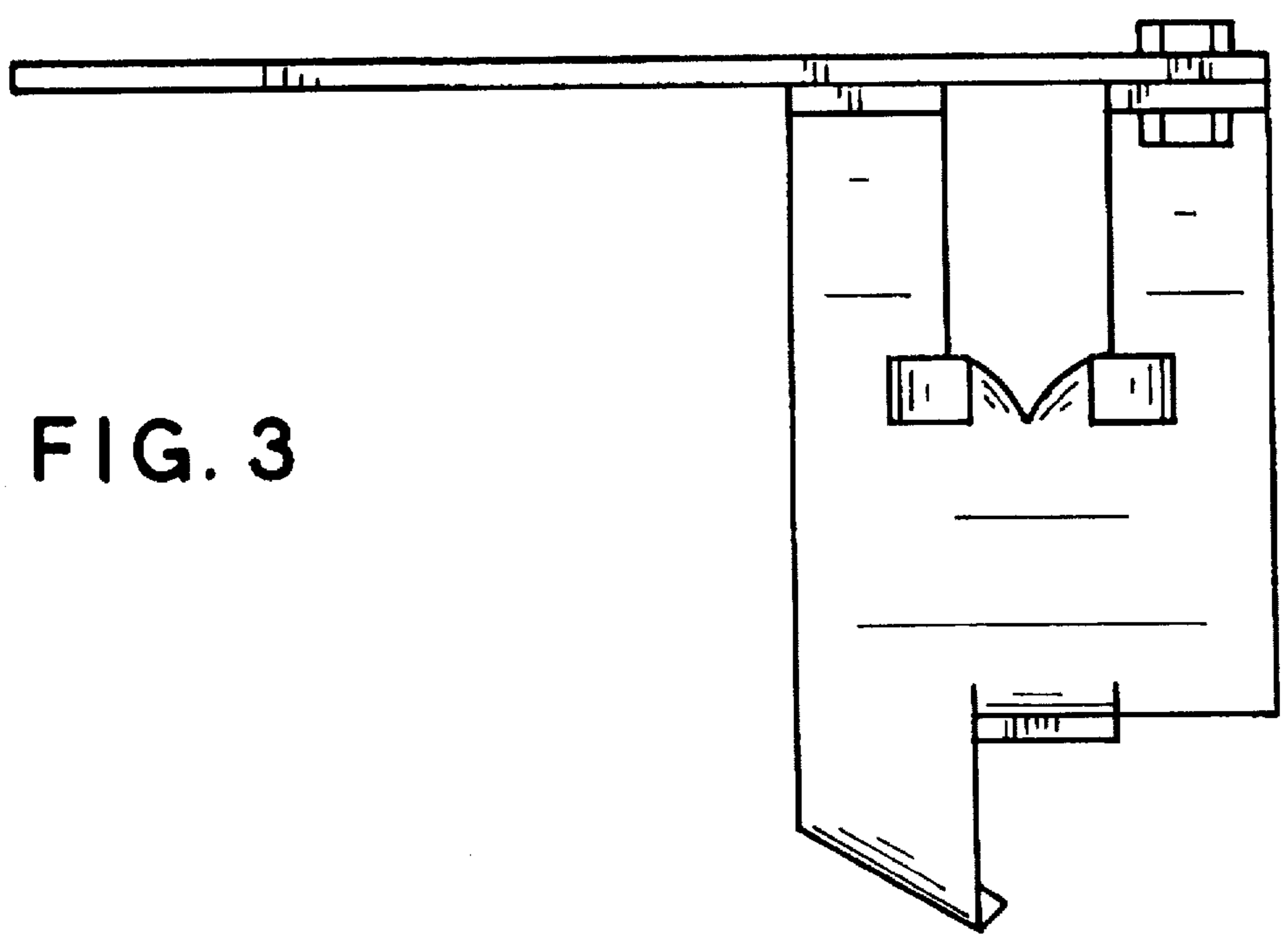

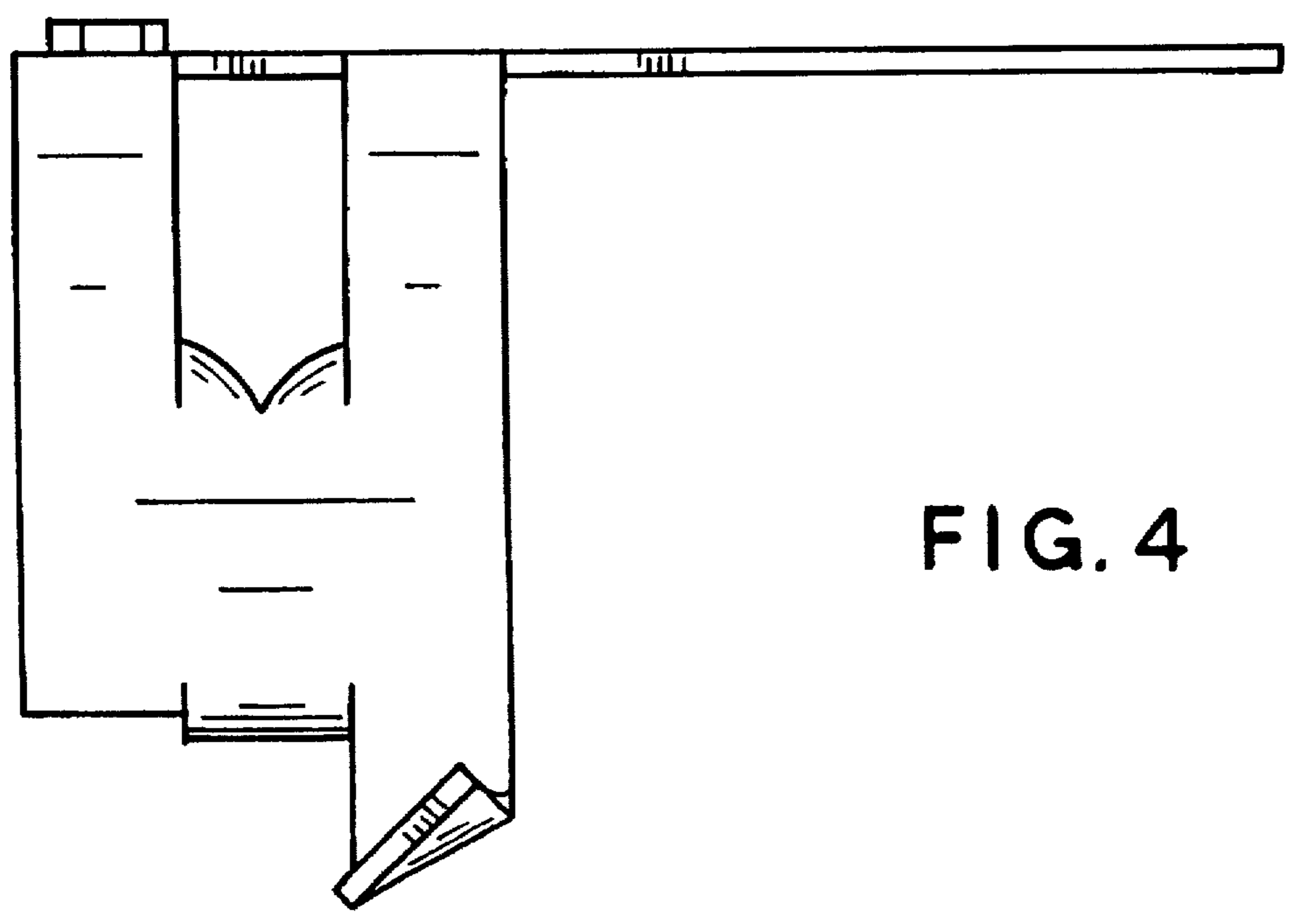

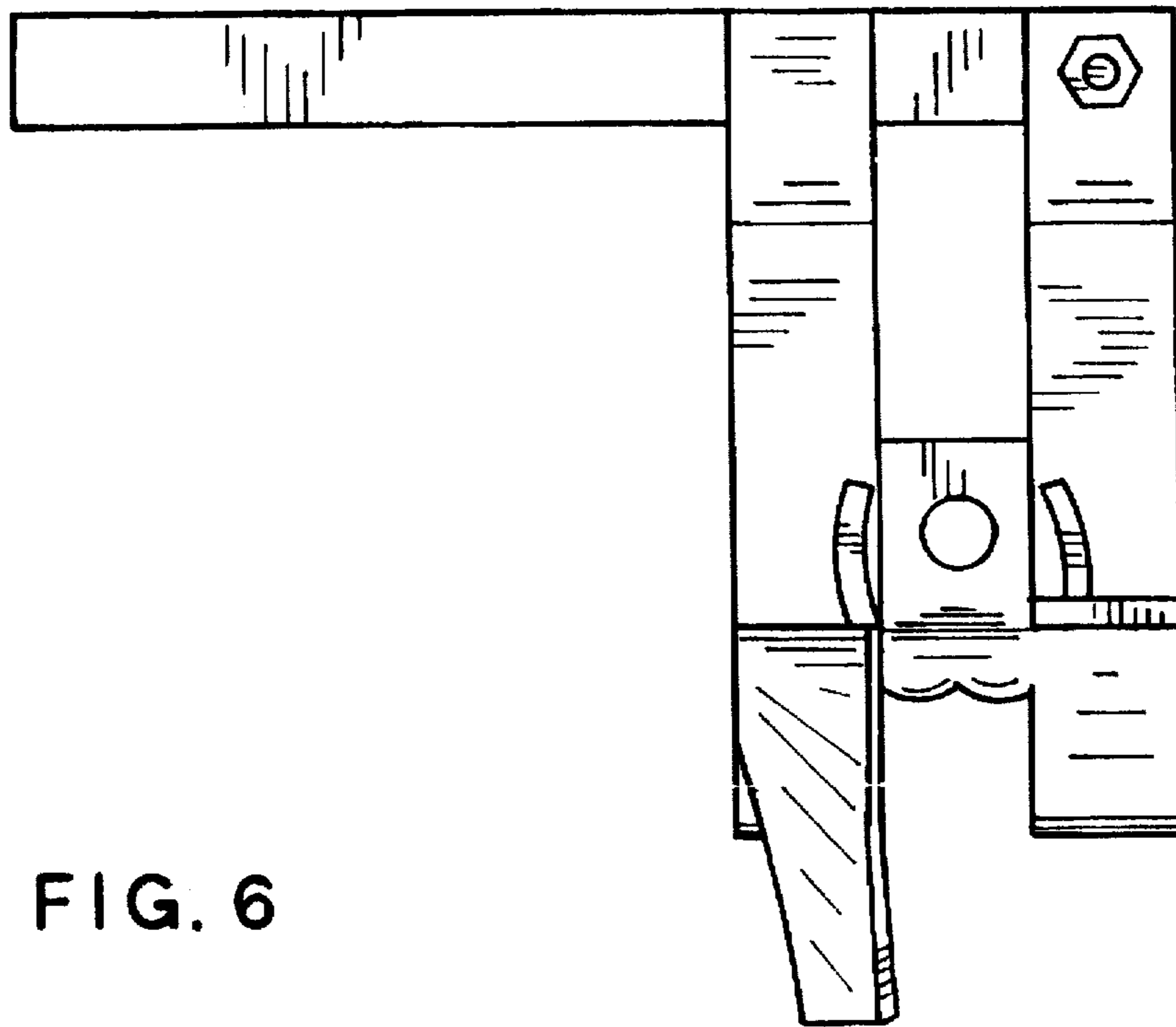
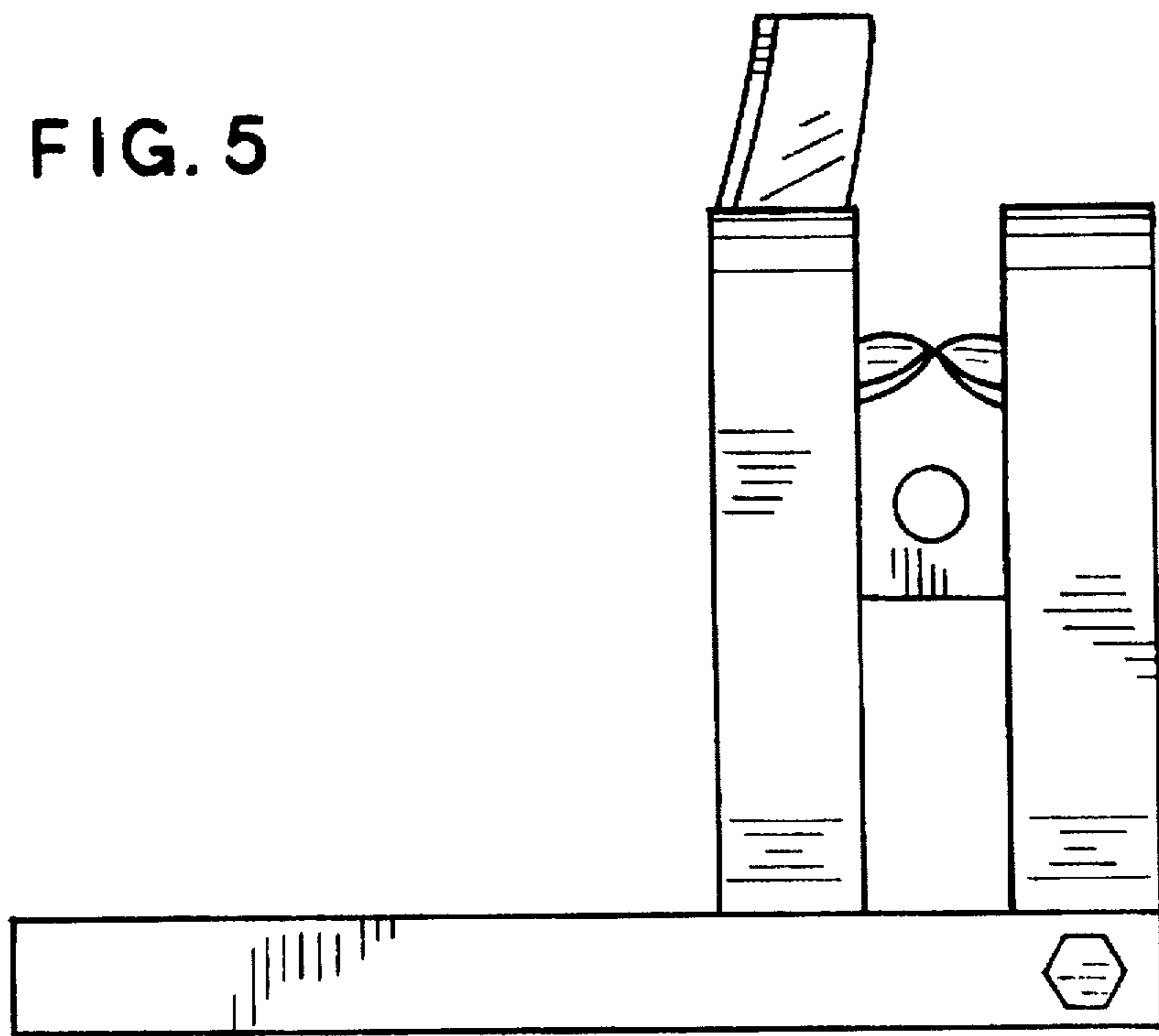
