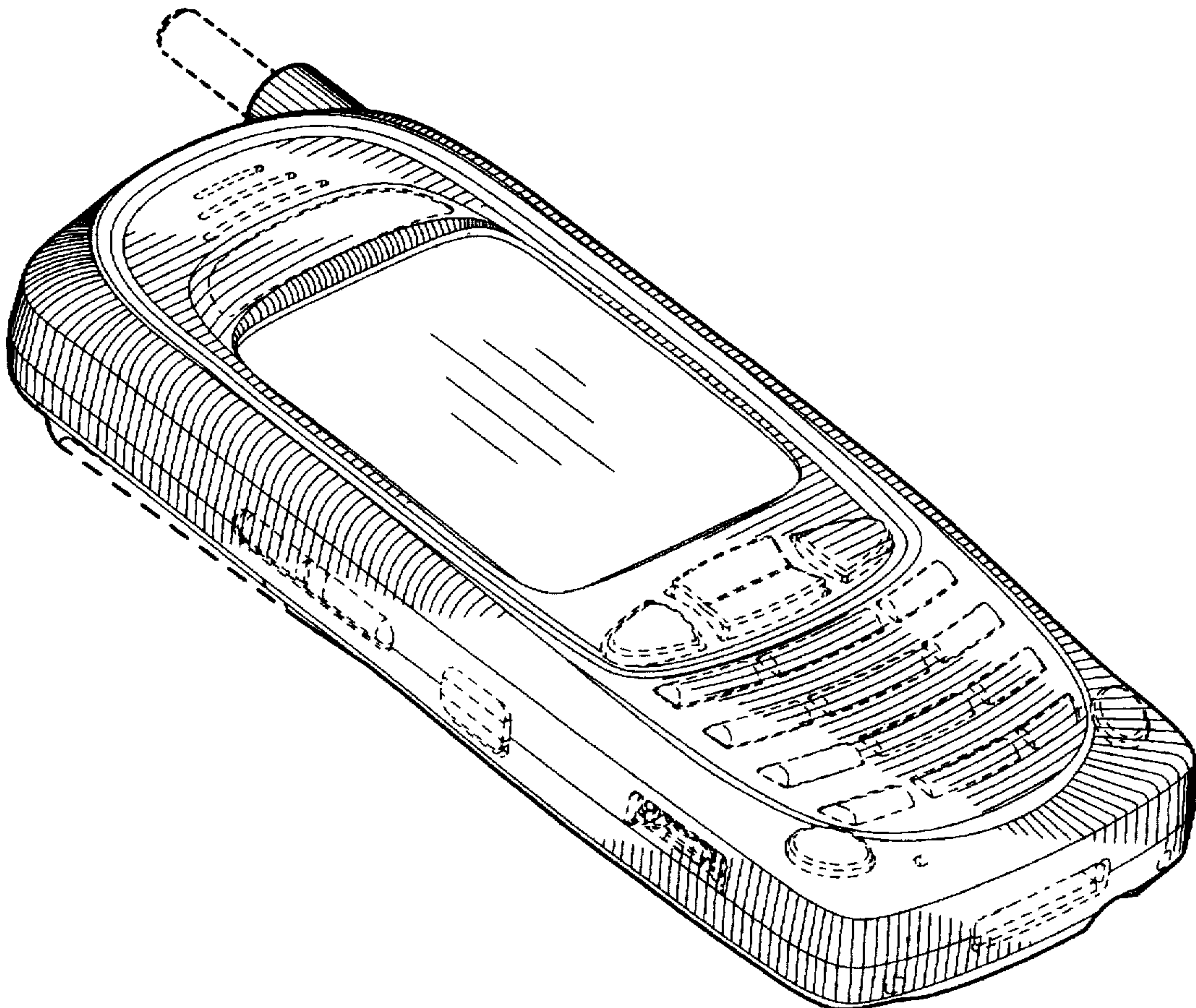

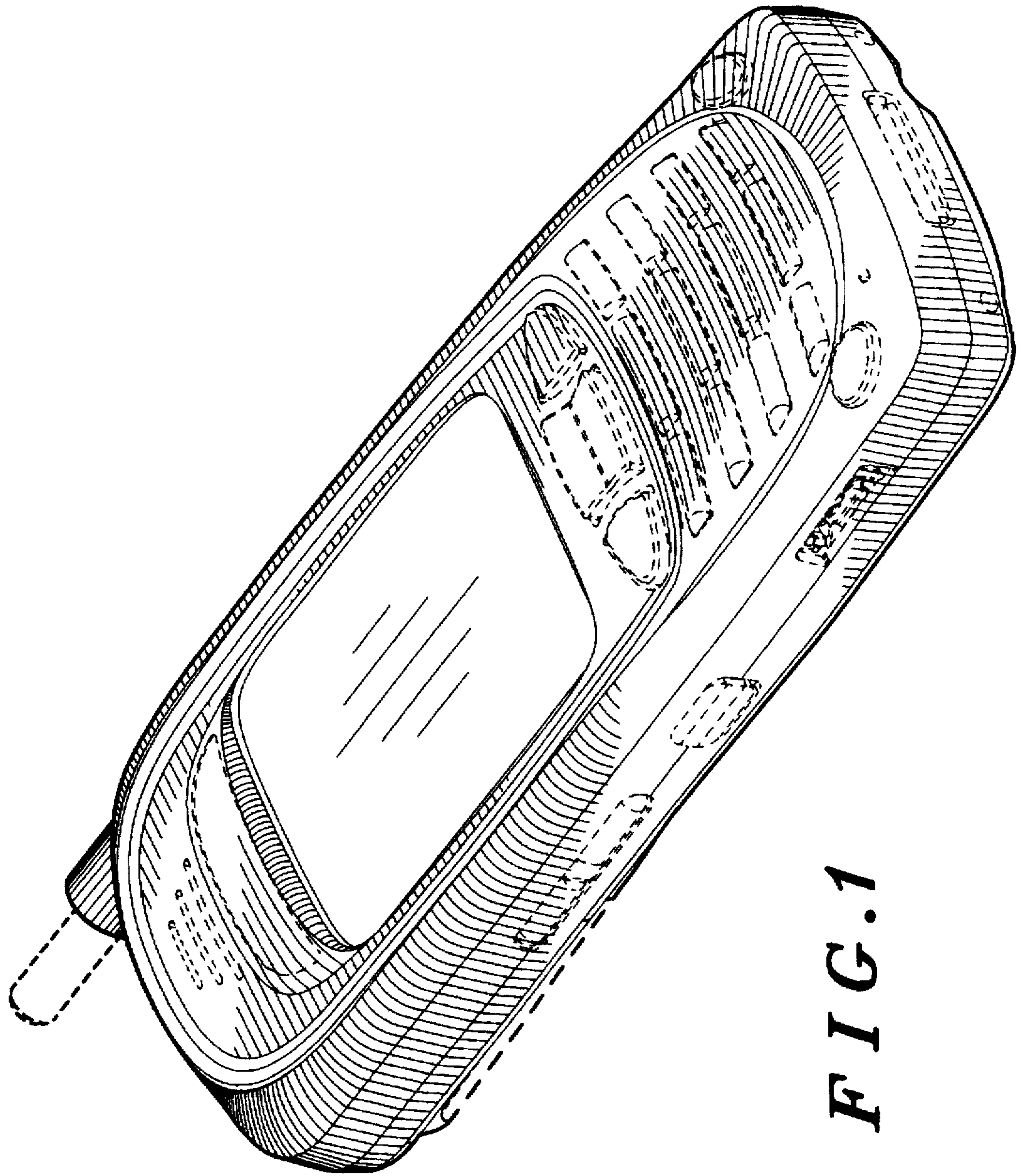
The ornamental design for a portable telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom, and right side perspective view showing our new design for a portable telephone with broken line matter being for illustrative purposes only and forming no part of the claimed design;

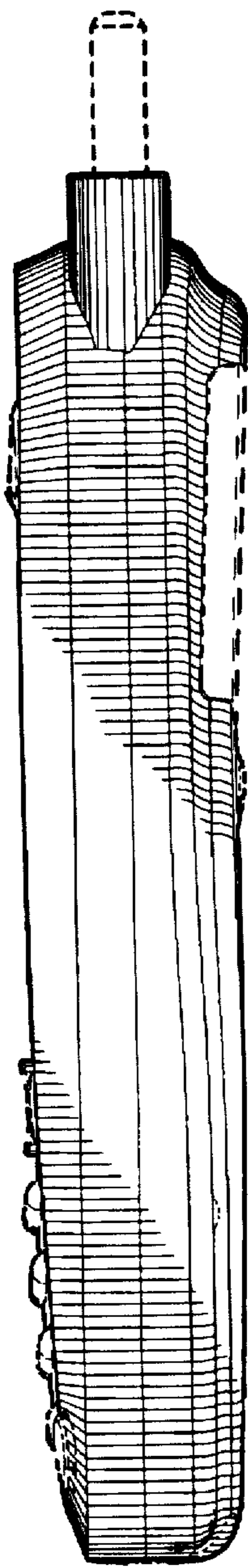
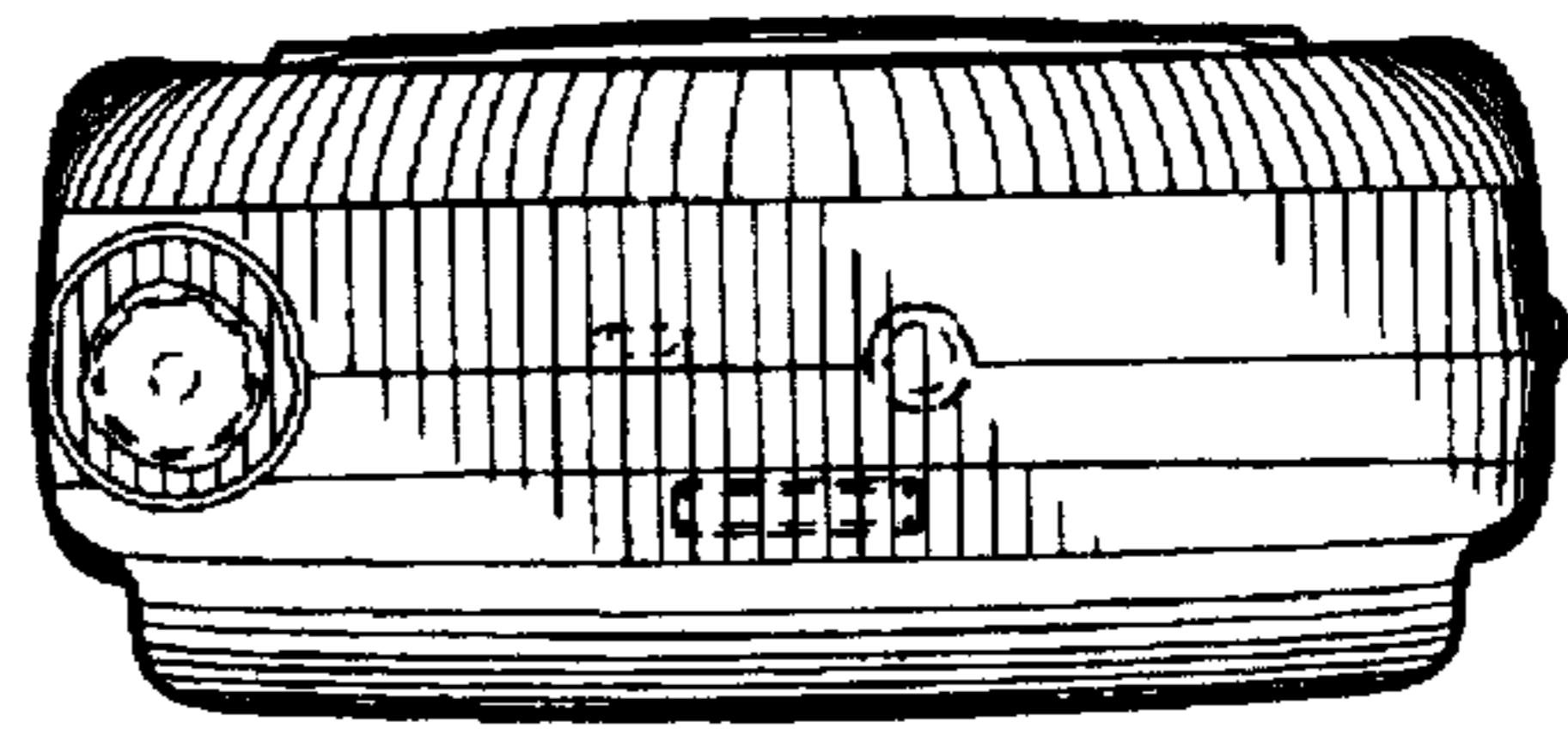




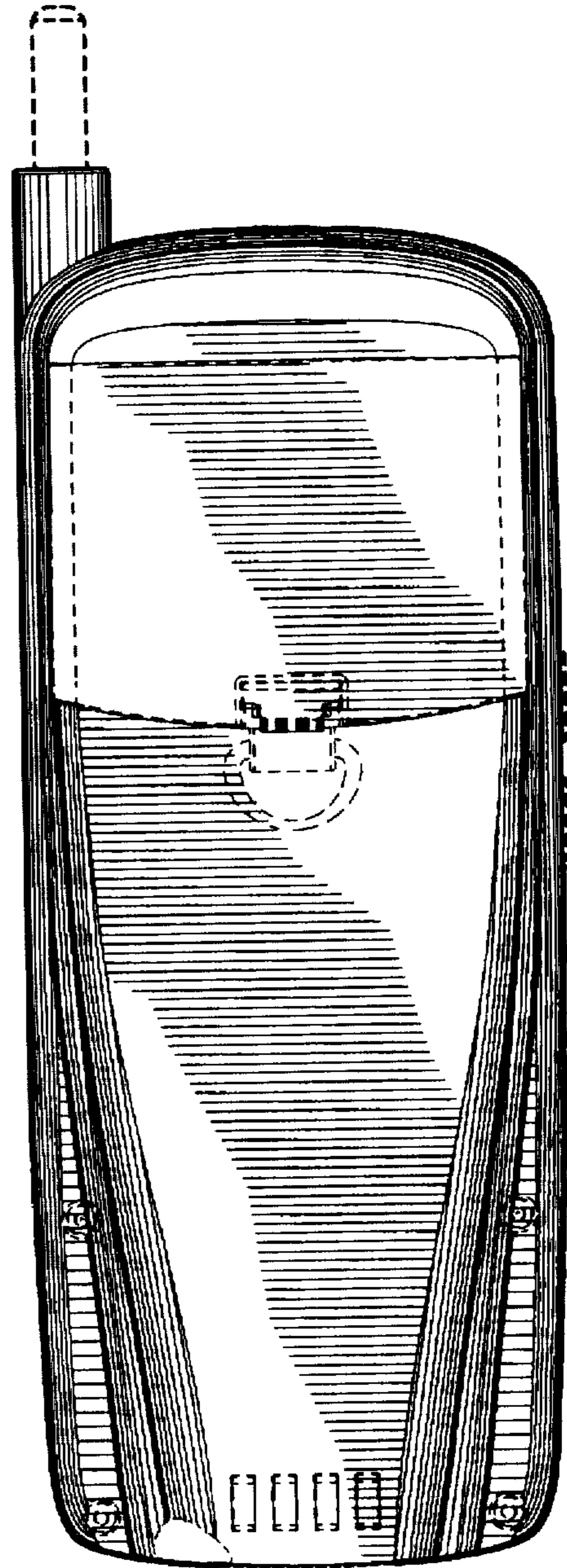
