The ornamental design for a portable radio telephone, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a portable radio telephone of the present design;  
FIG. 2 is a front elevational view;  
FIG. 3 is a rear elevational view;  
FIG. 4 is a left side elevational view;  
FIG. 5 is a right side elevational view;

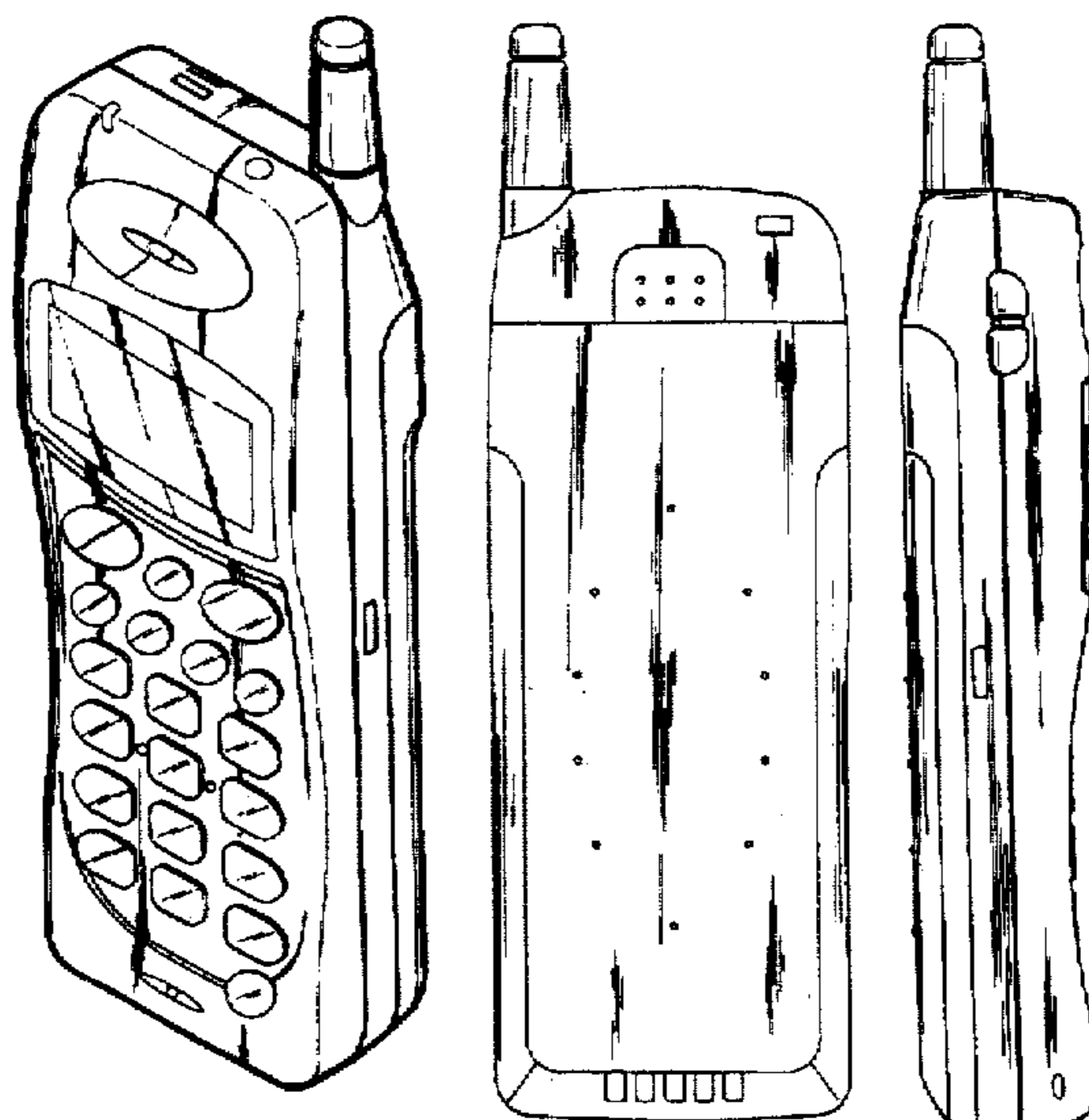

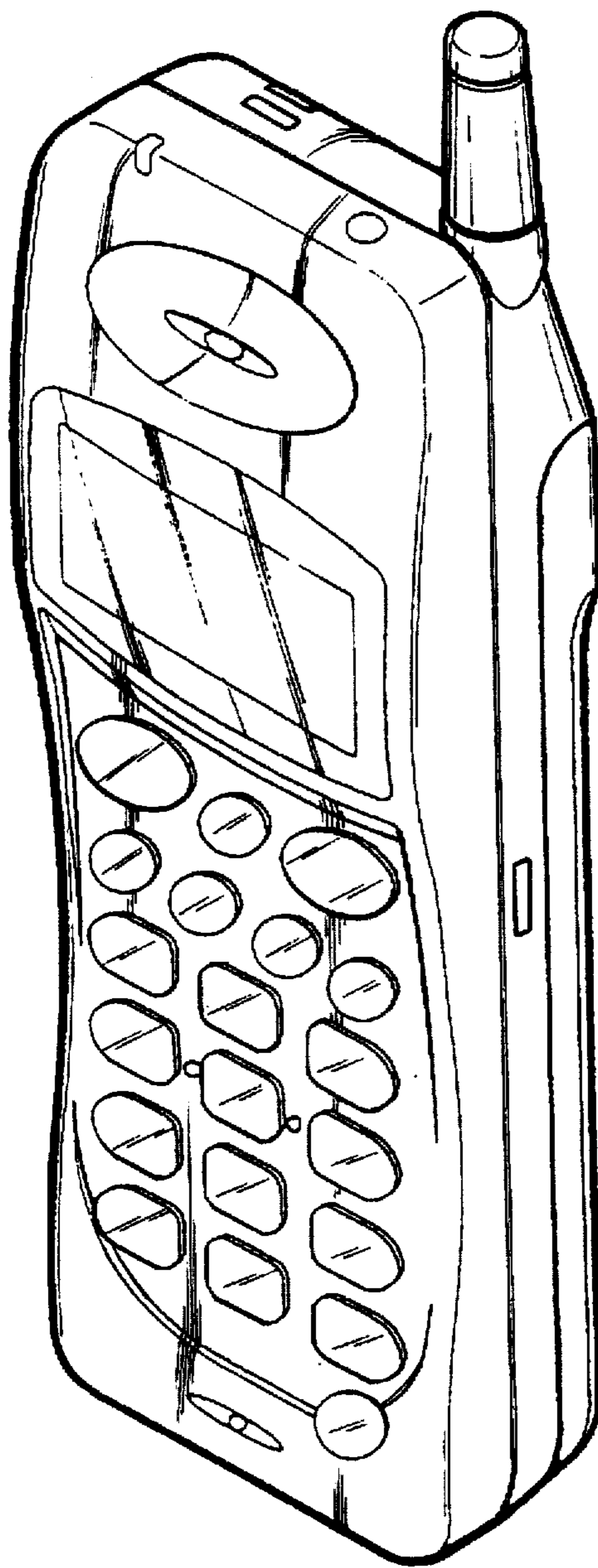

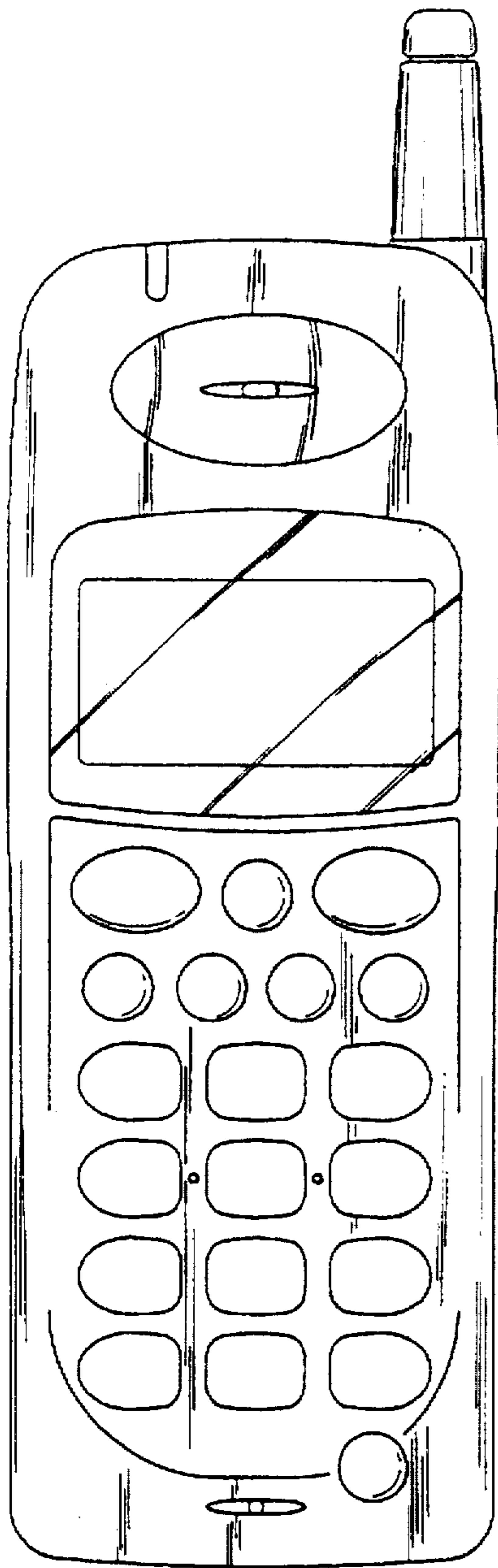

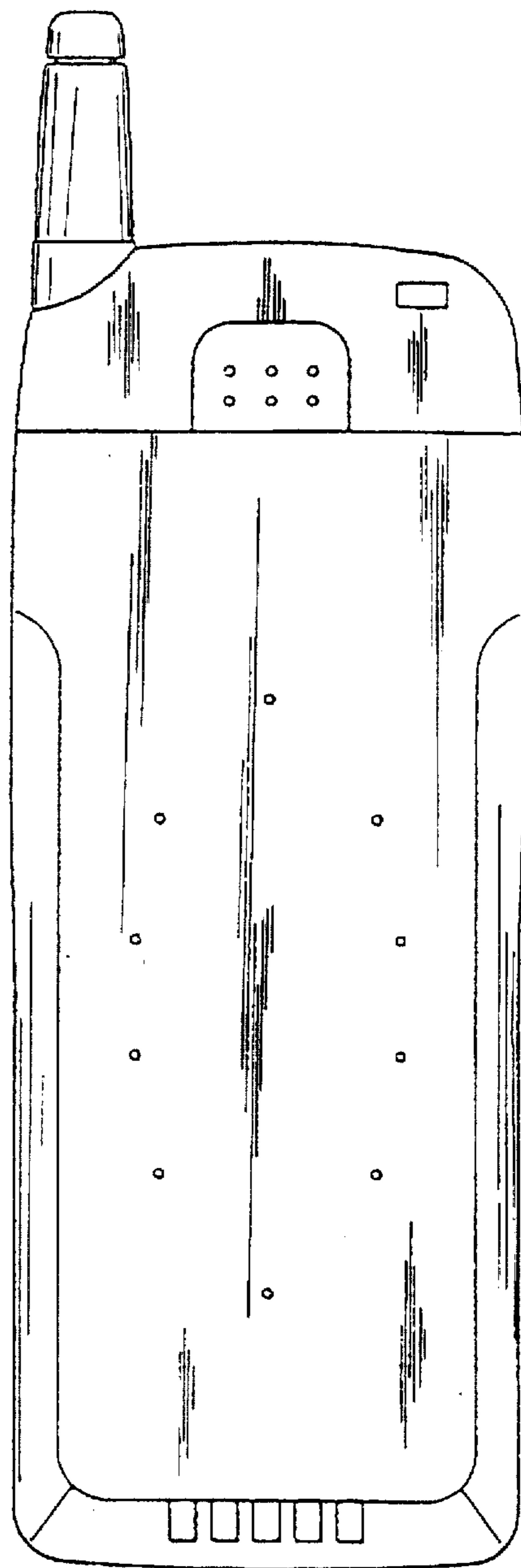

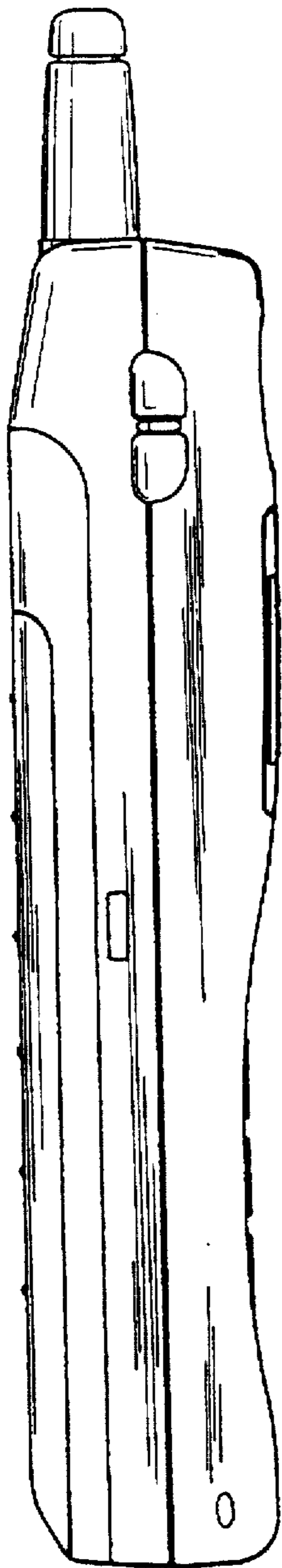

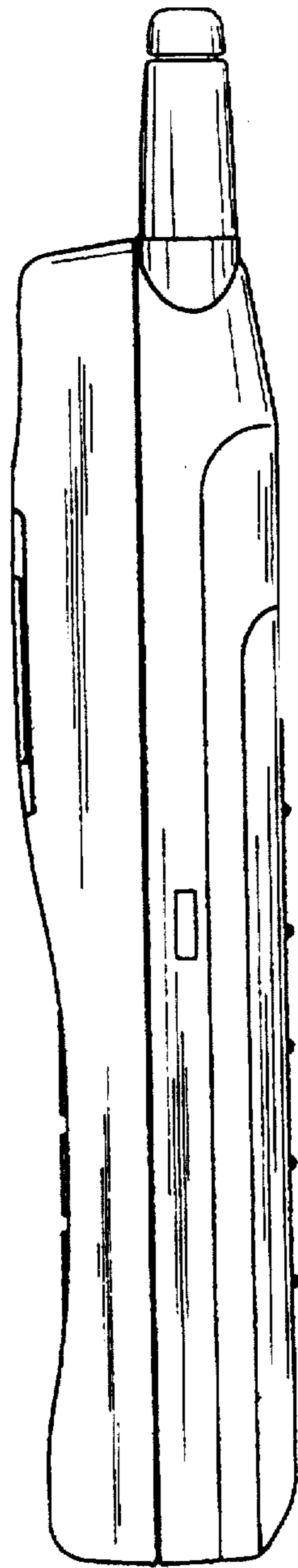

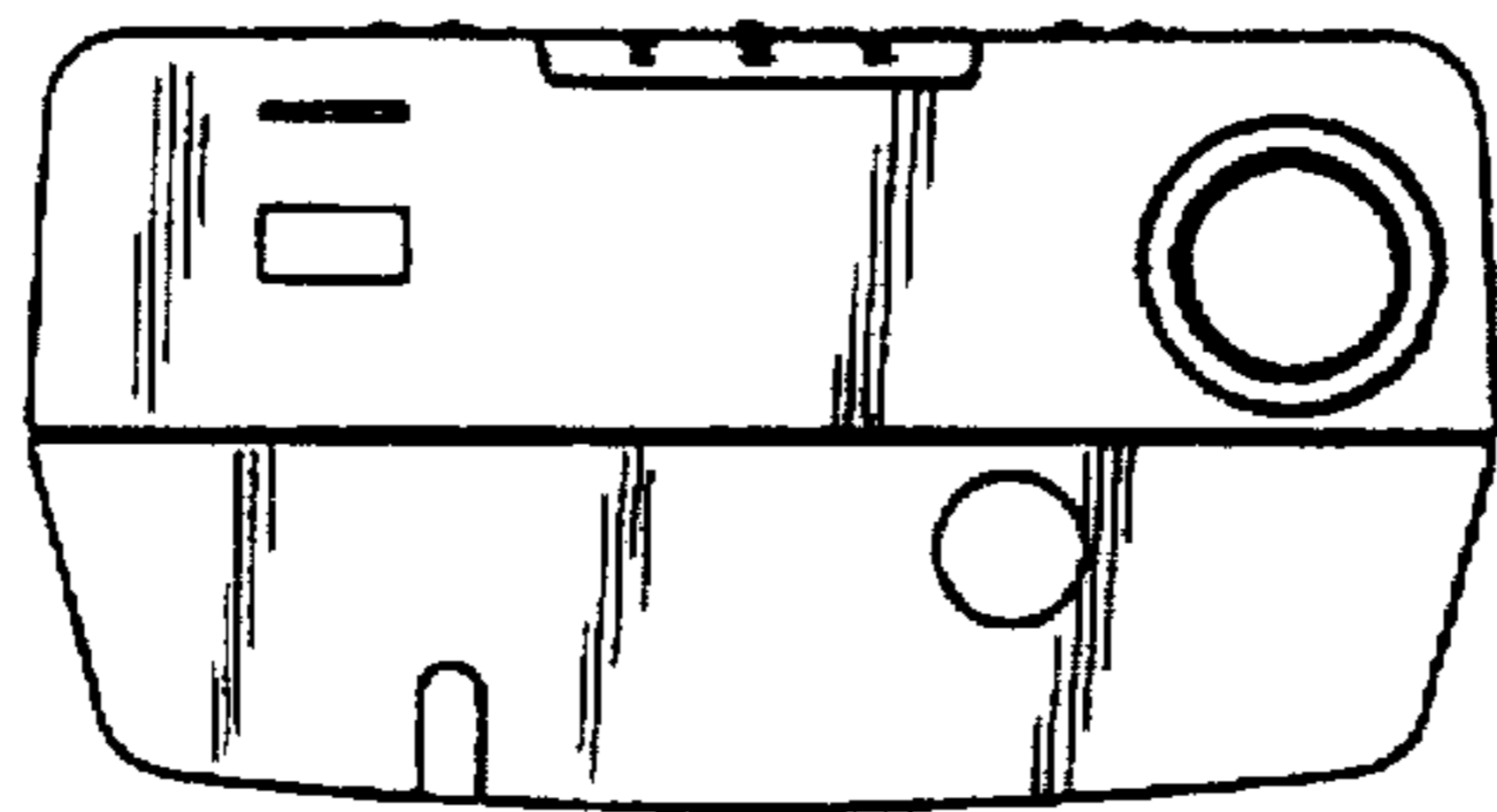
