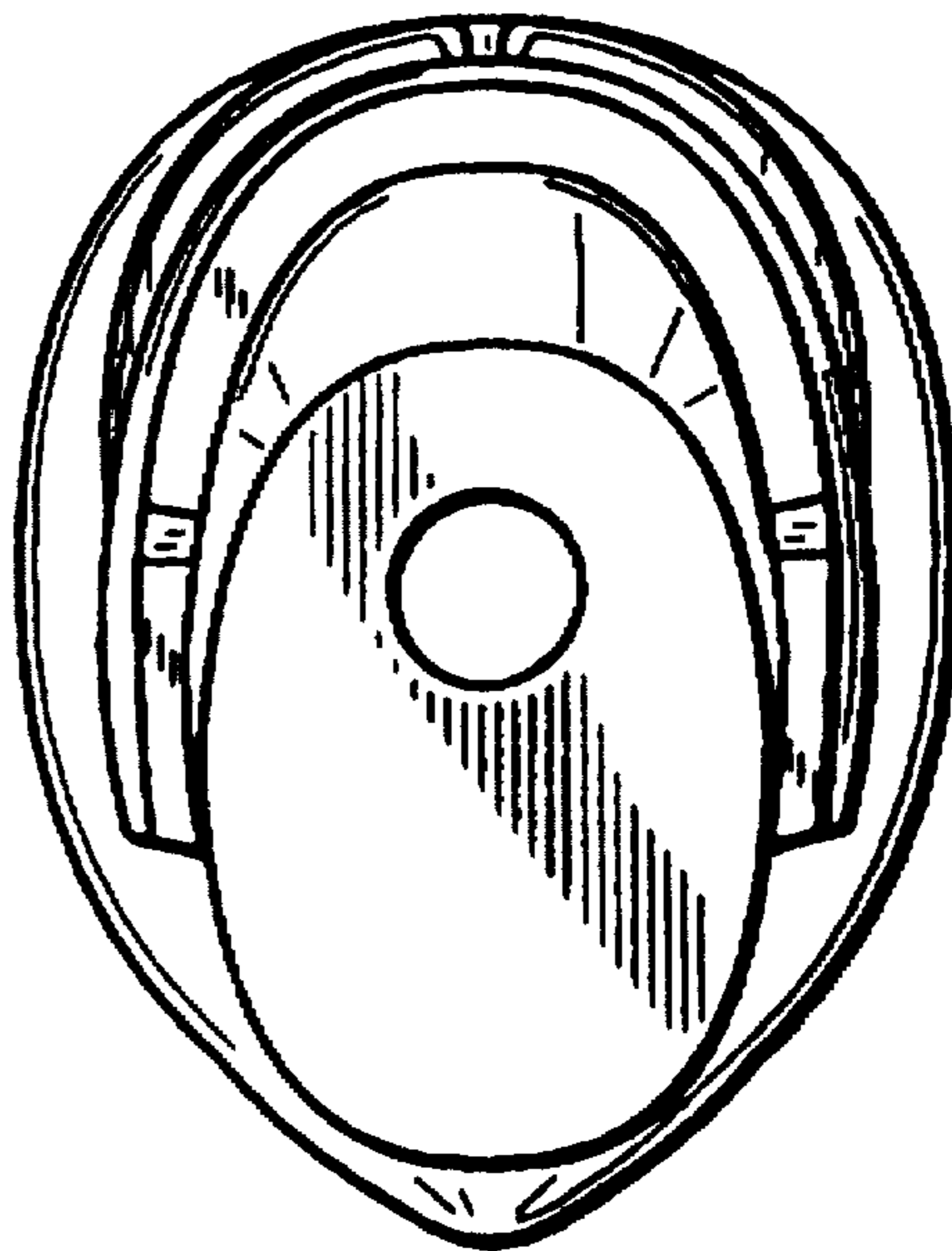
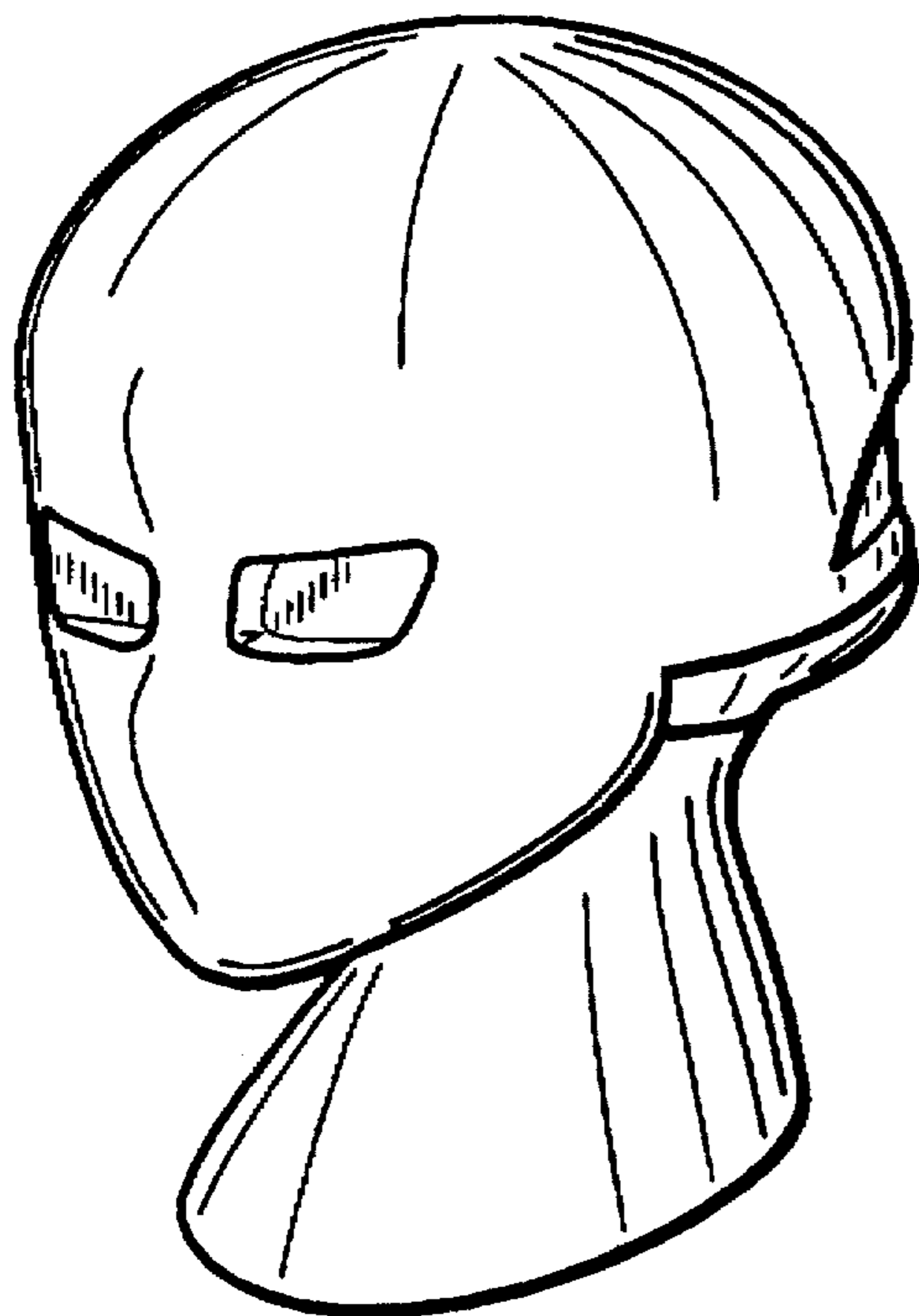

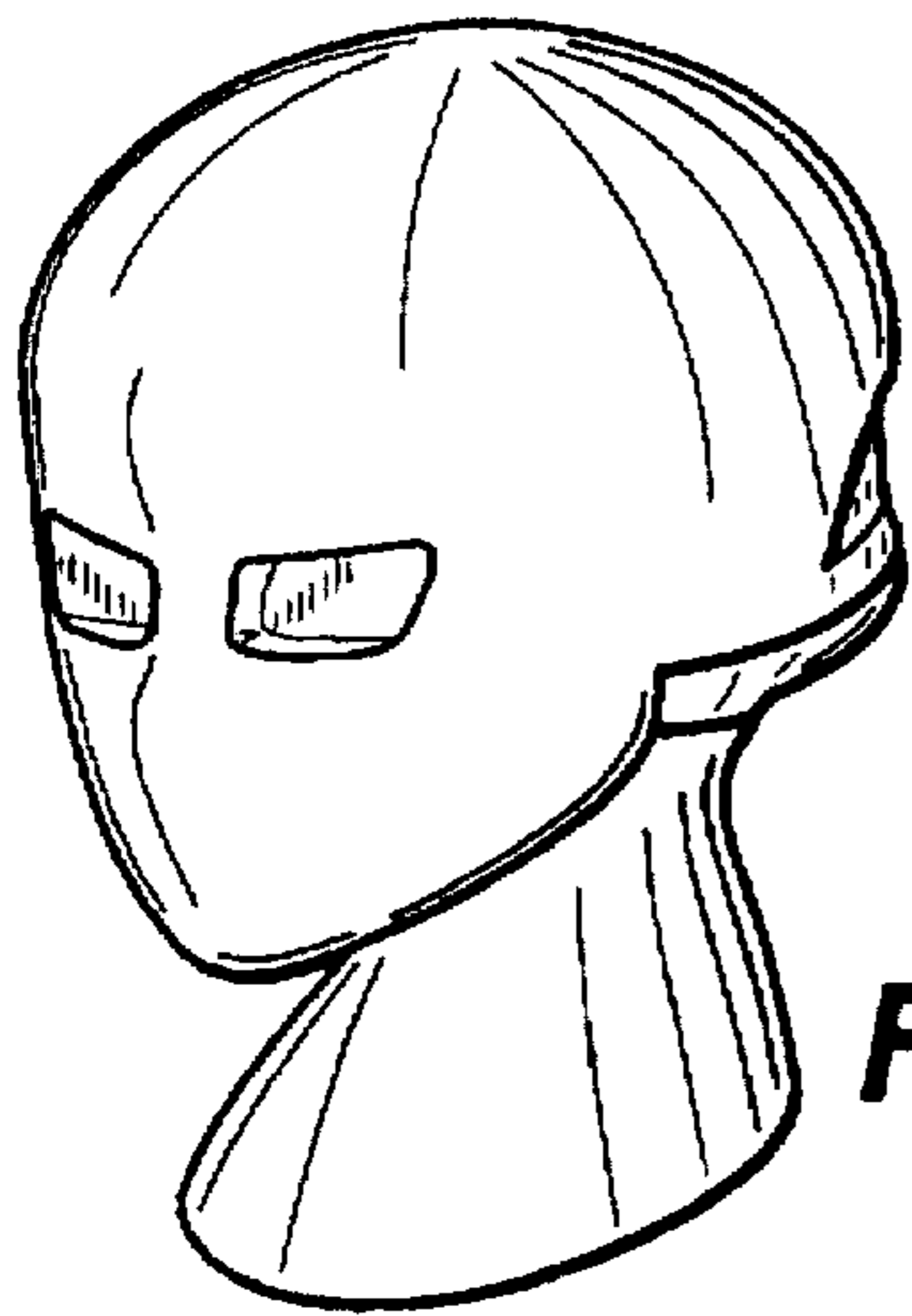
The ornamental design for an automobile antenna ornament, as shown and described.

### DESCRIPTION

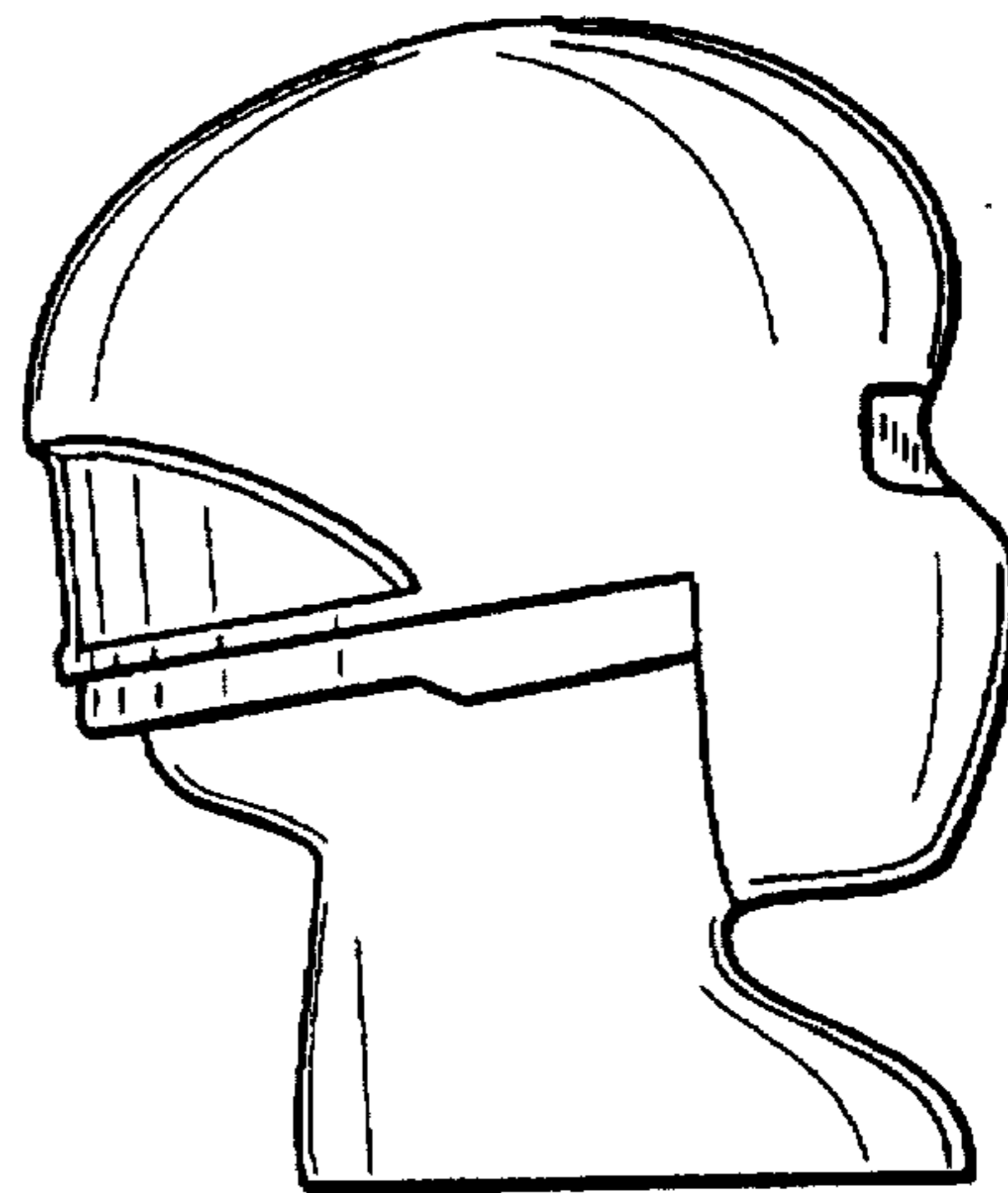
FIG. 1 is a perspective view of an automobile antenna ornament showing our new design;

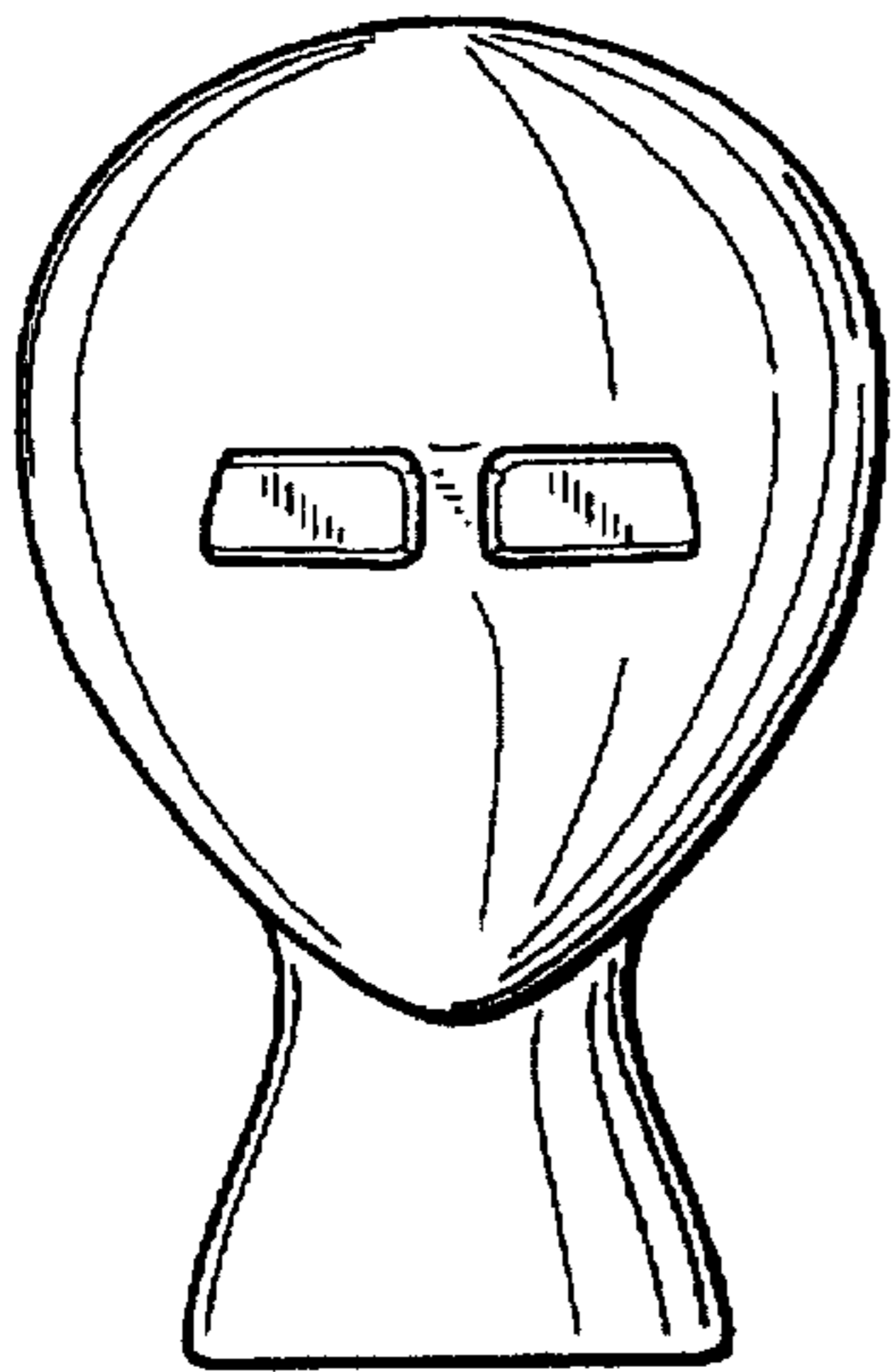




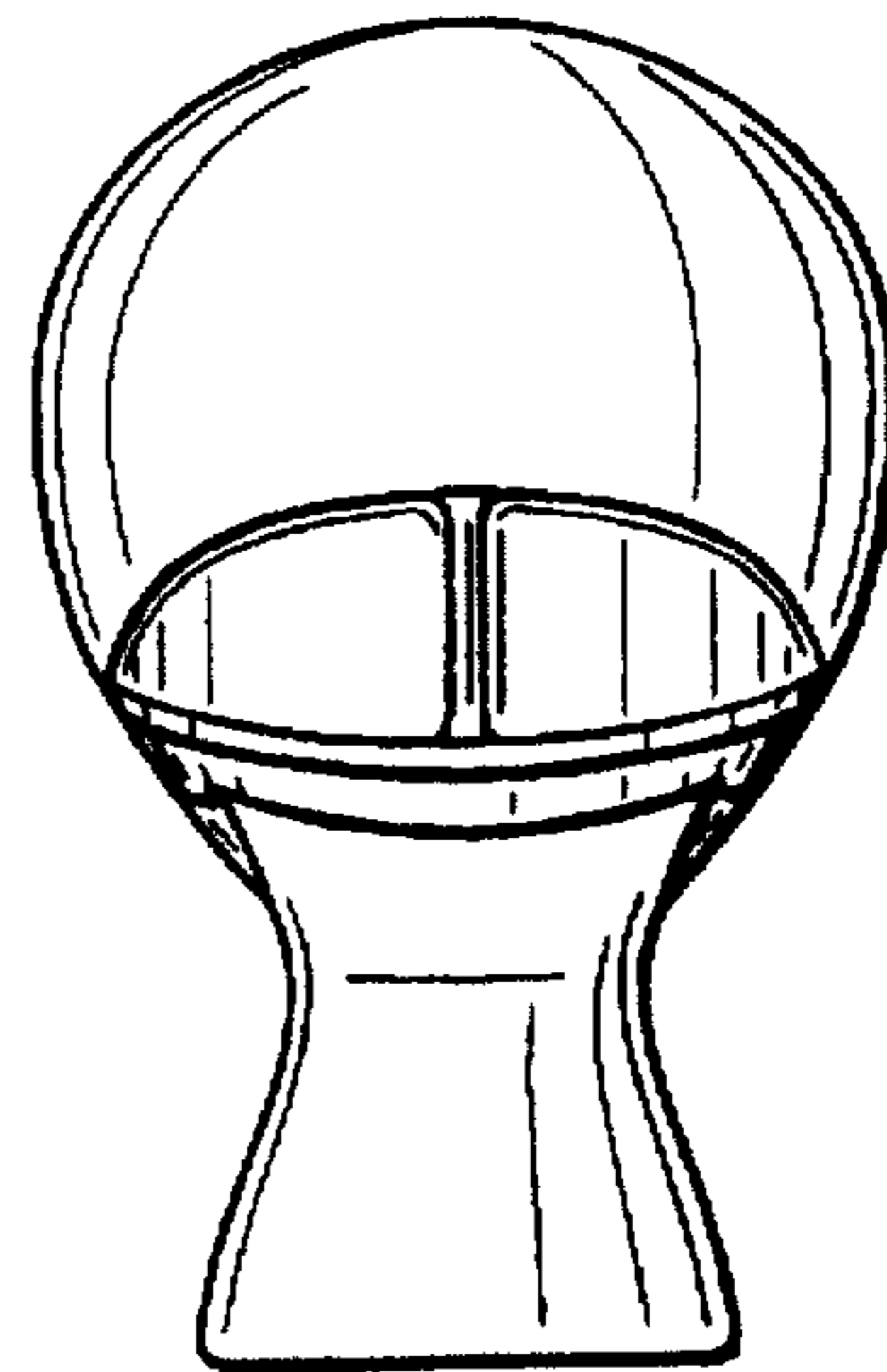

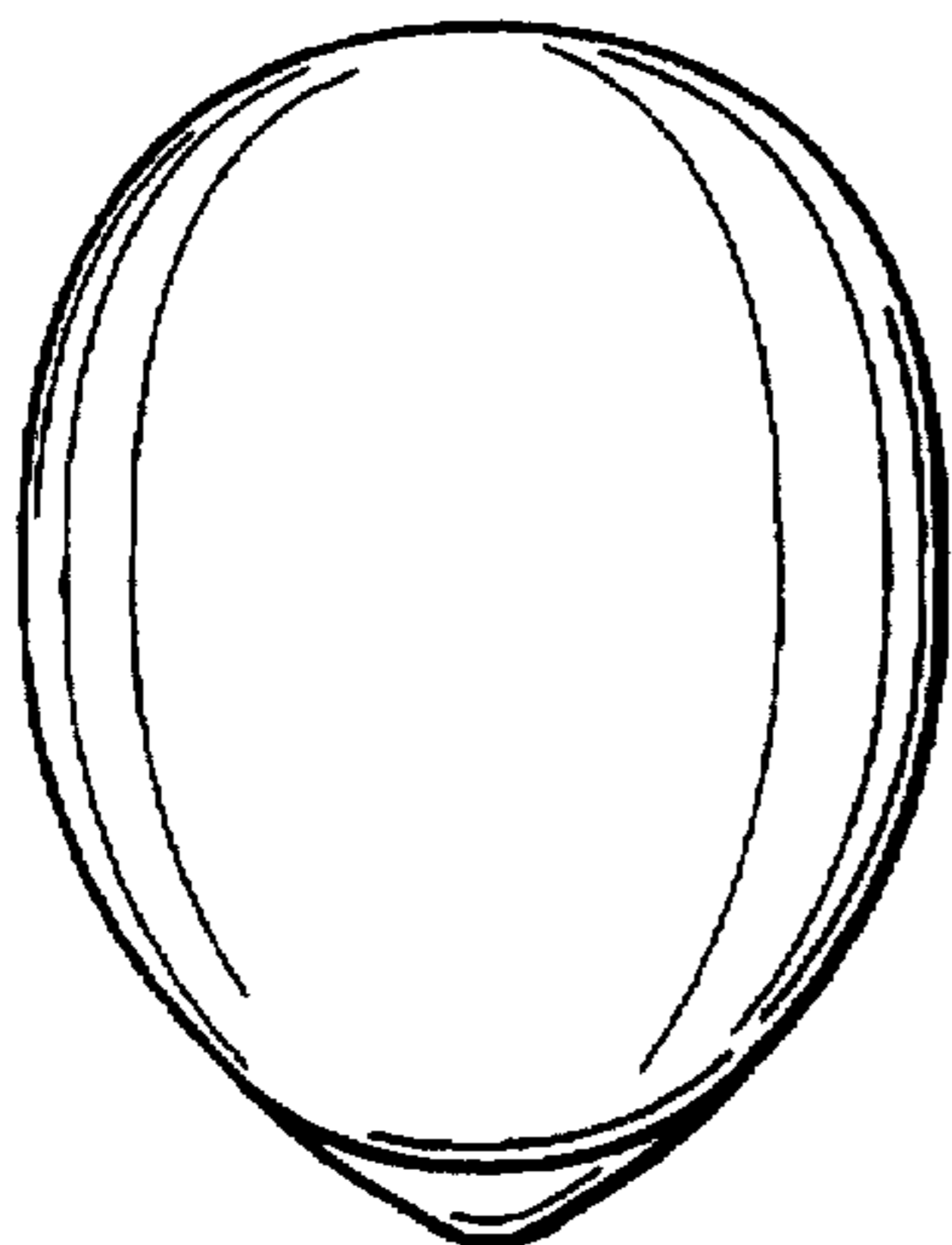

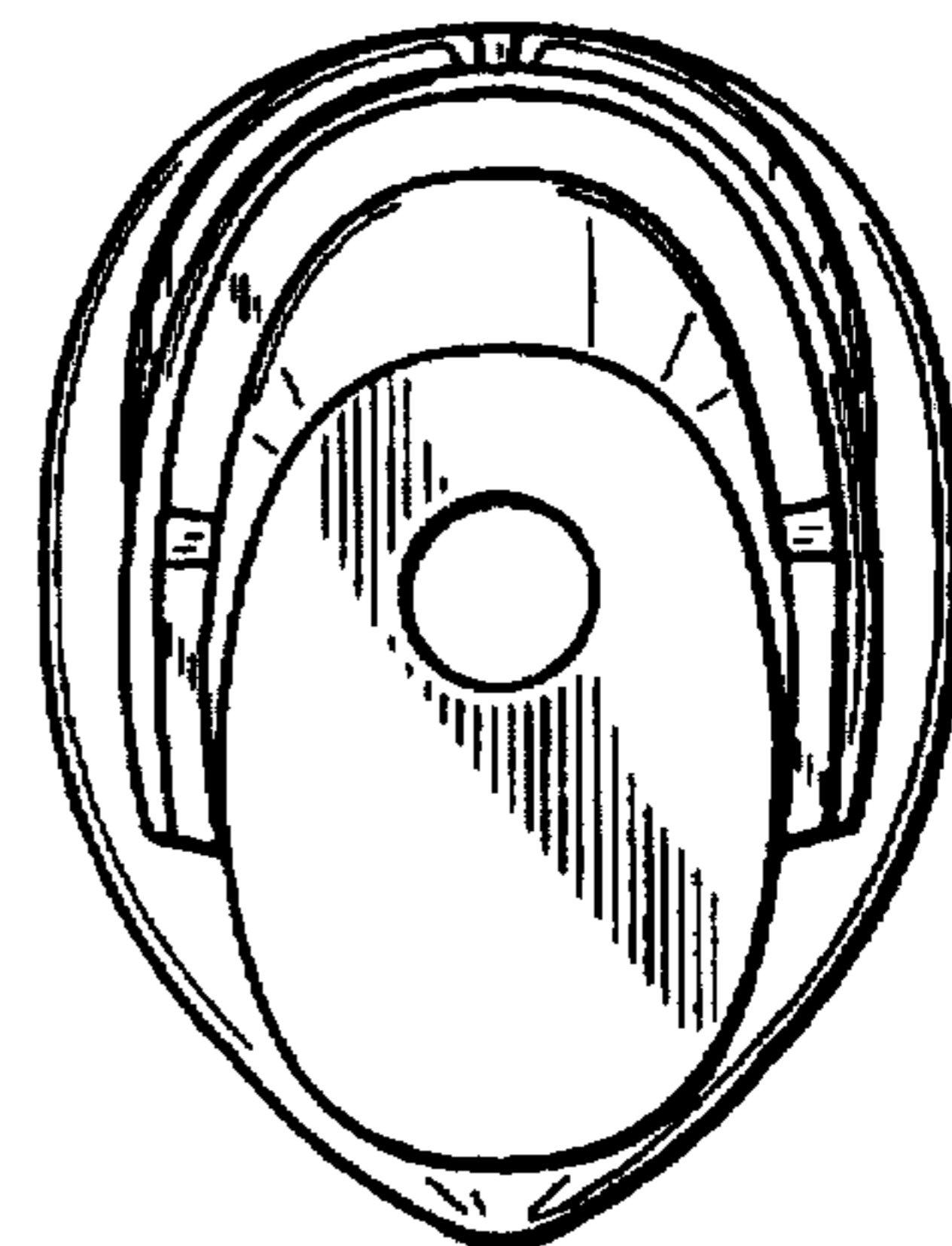
