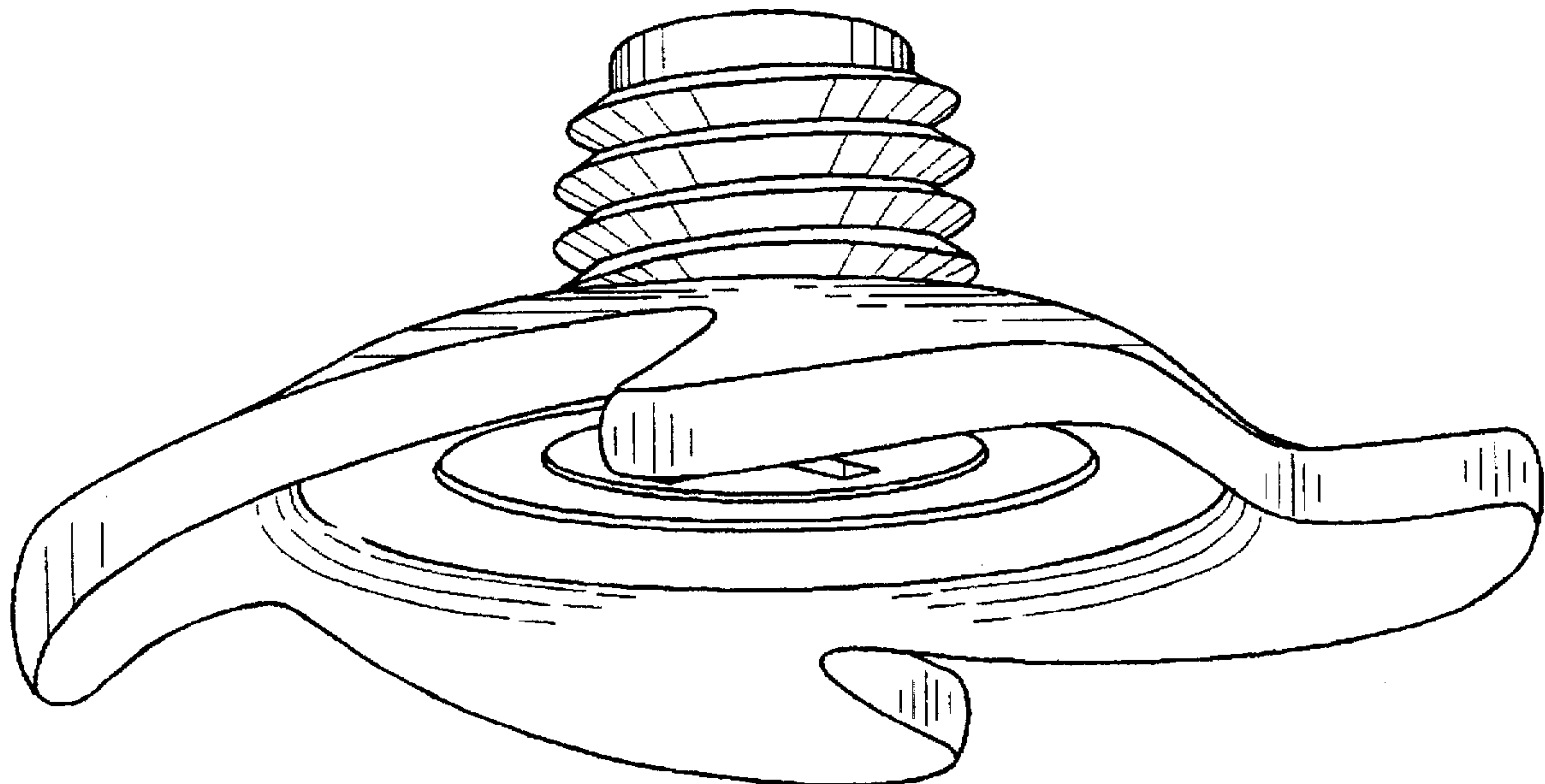

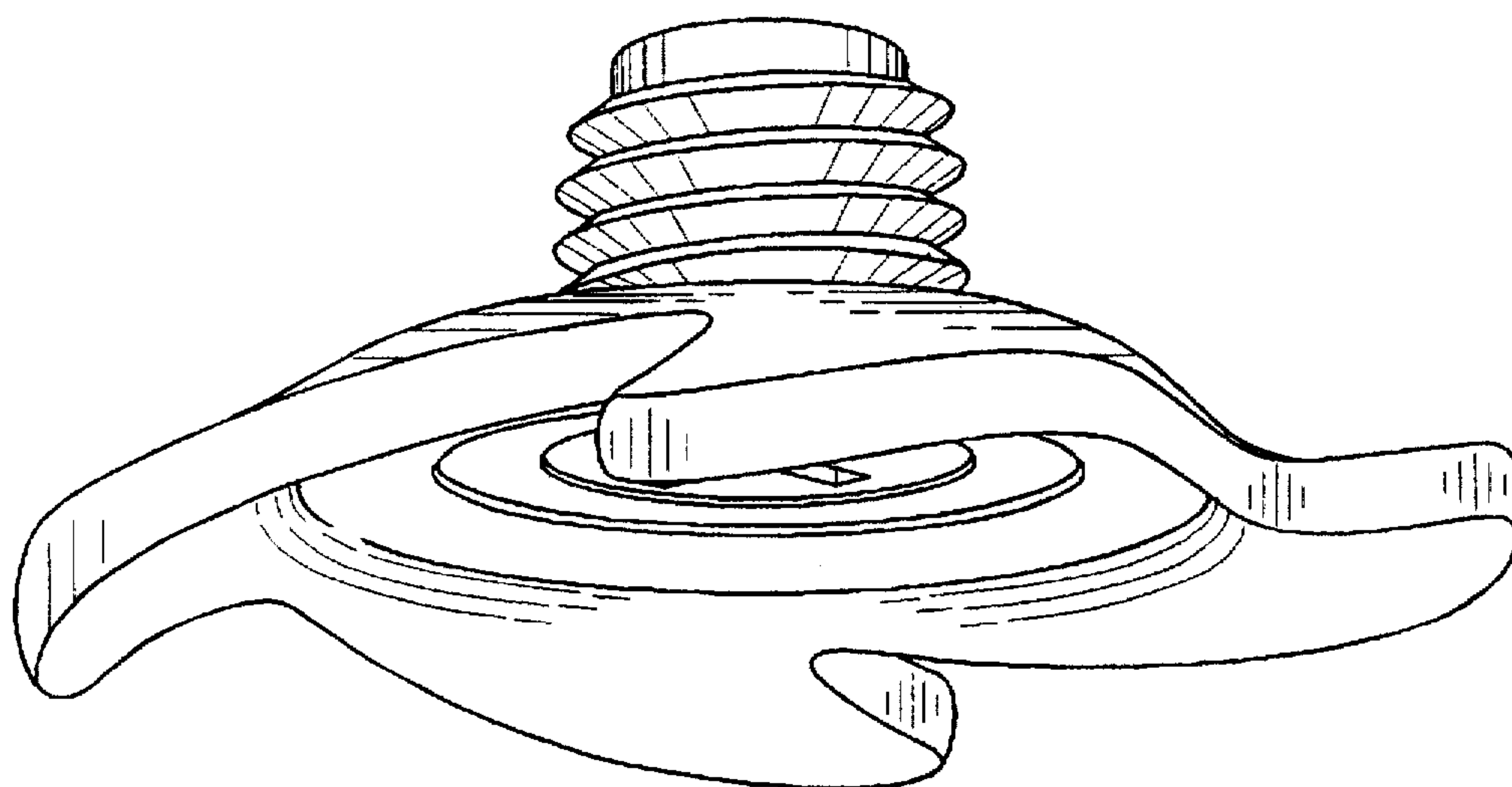
The ornamental design for a footwear cleat, as shown and described.

**DESCRIPTION**

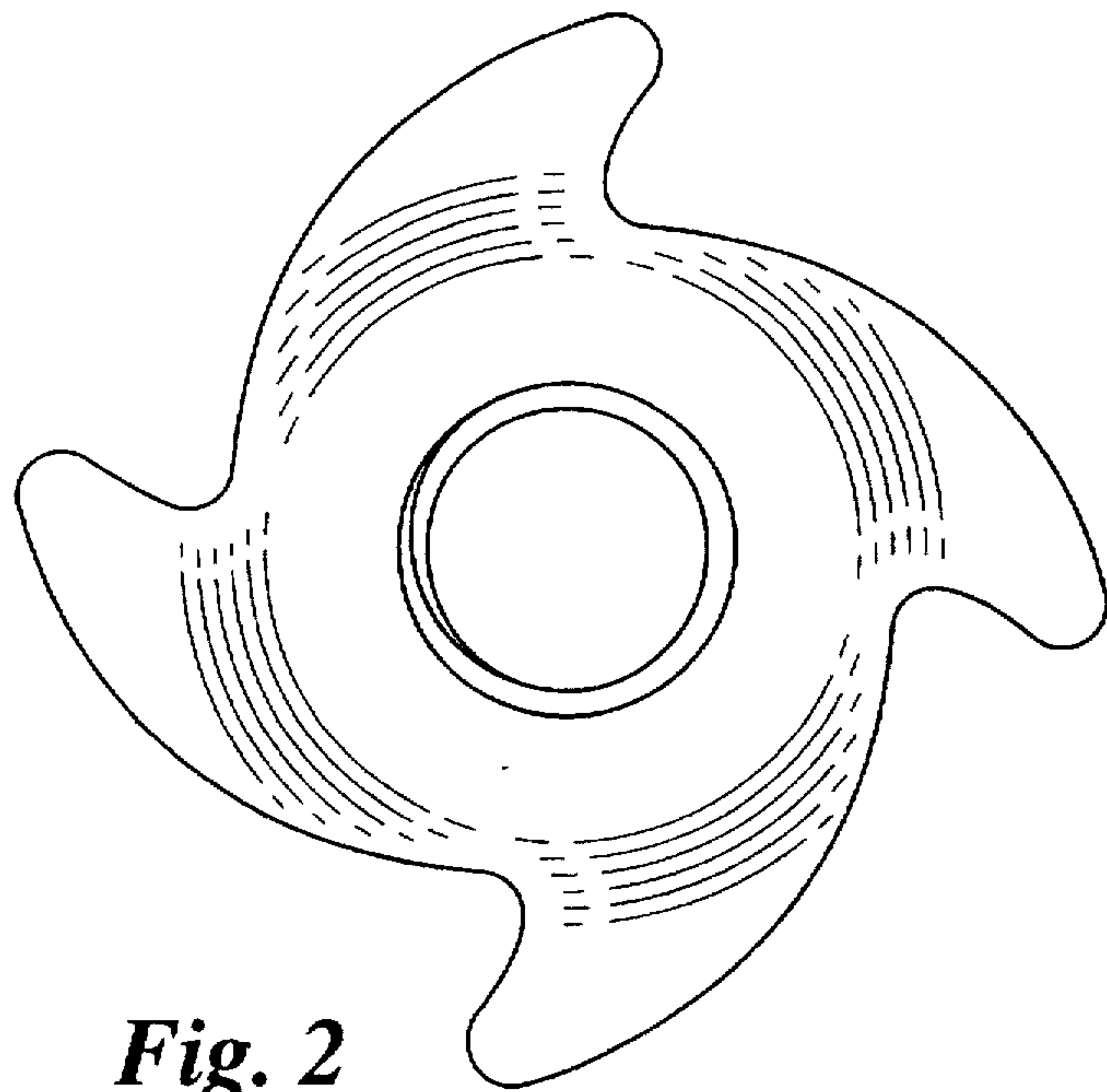
FIG. 1 is a perspective view of a footwear cleat showing the new design;

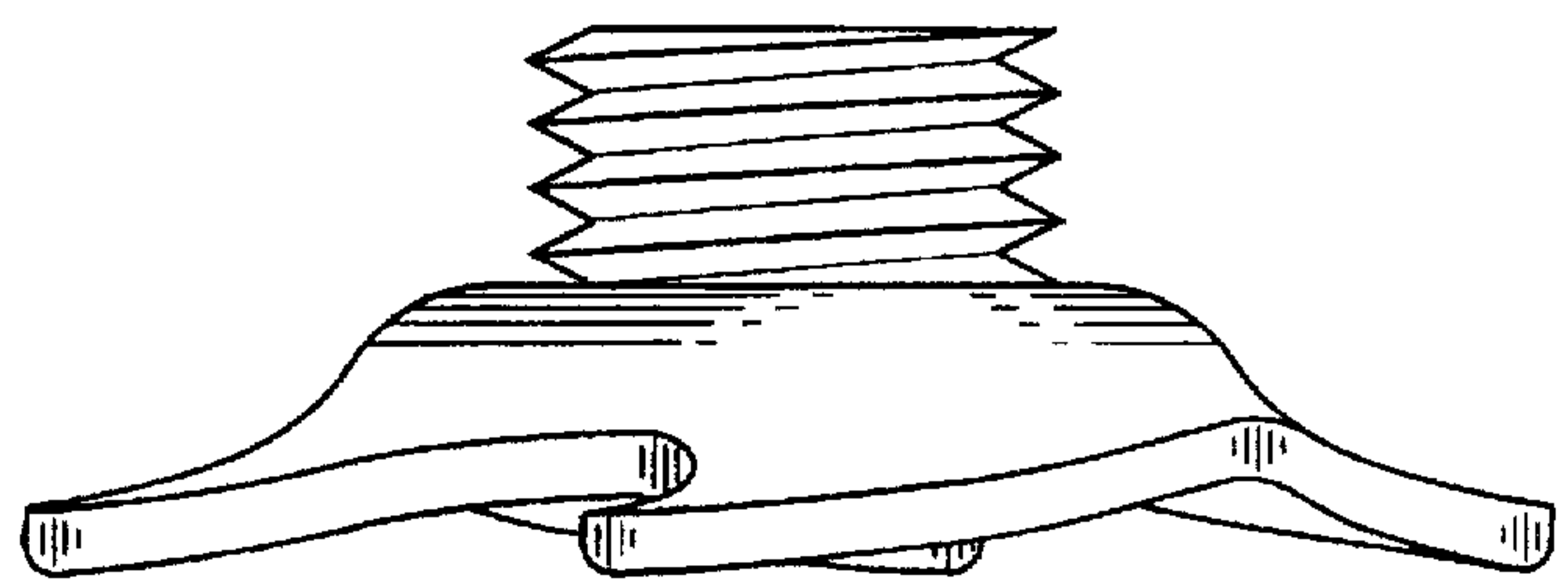




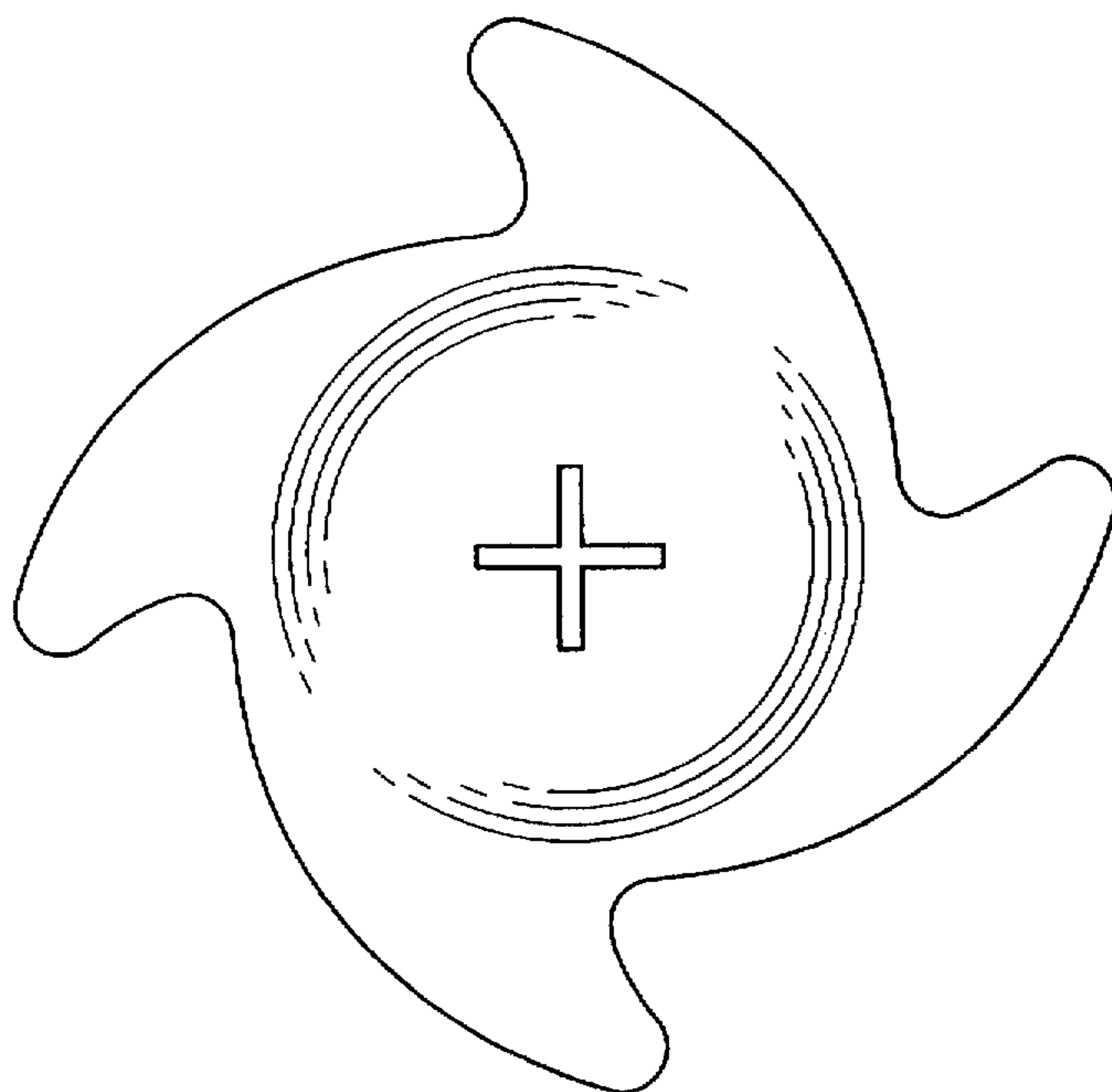
