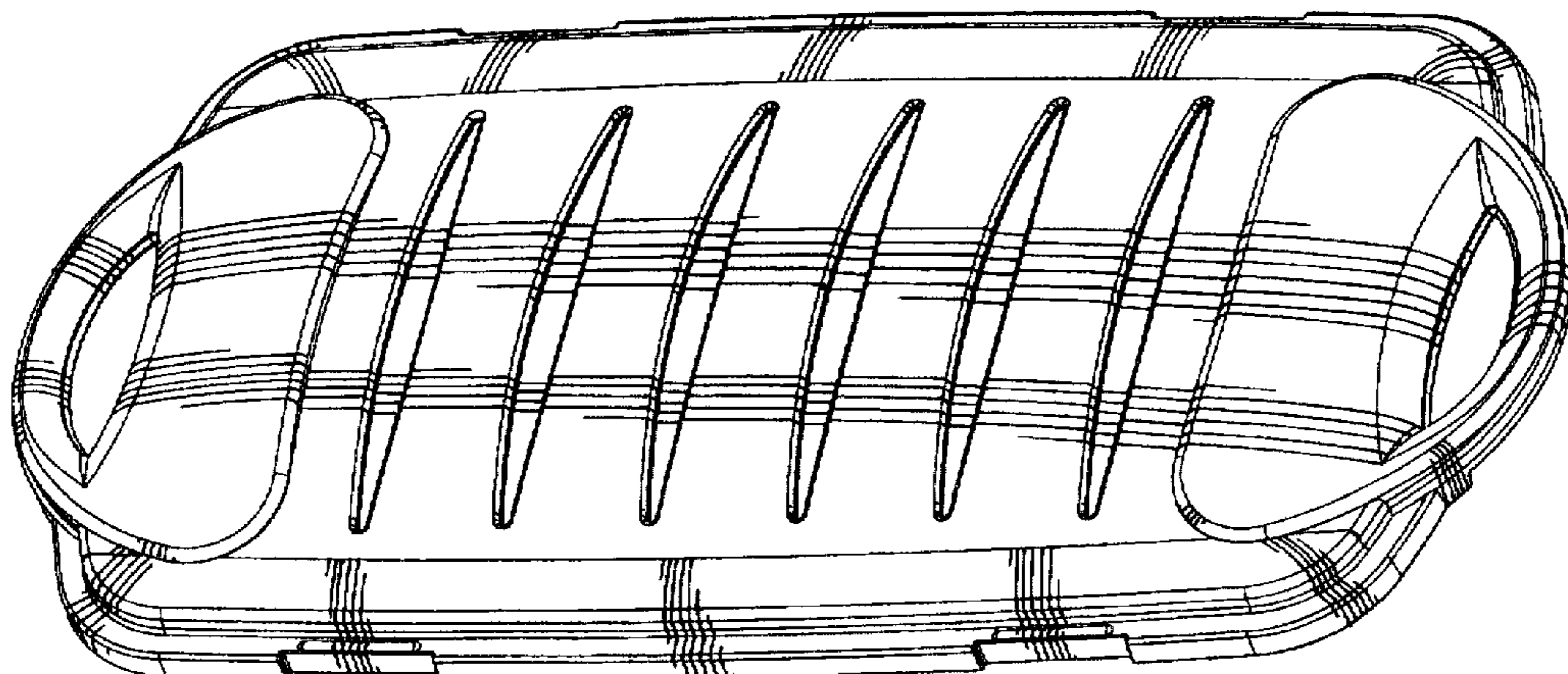
[57] **CLAIM**

The ornamental design for a lid for container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top right front perspective view of a lid for container showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a front elevational view thereof; the rear elevational being a mirror image;  
 FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image; and,  
 FIG. 5 is a bottom plan view thereof.

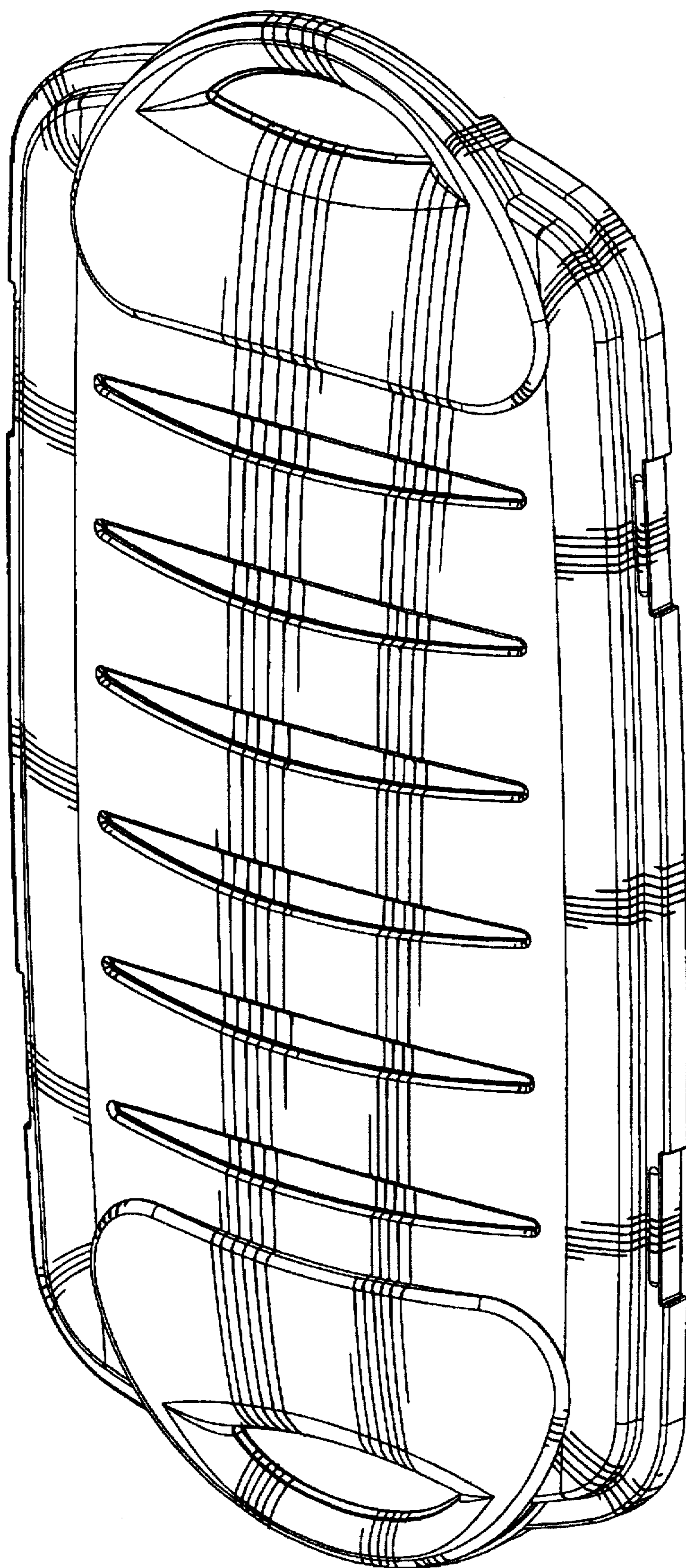

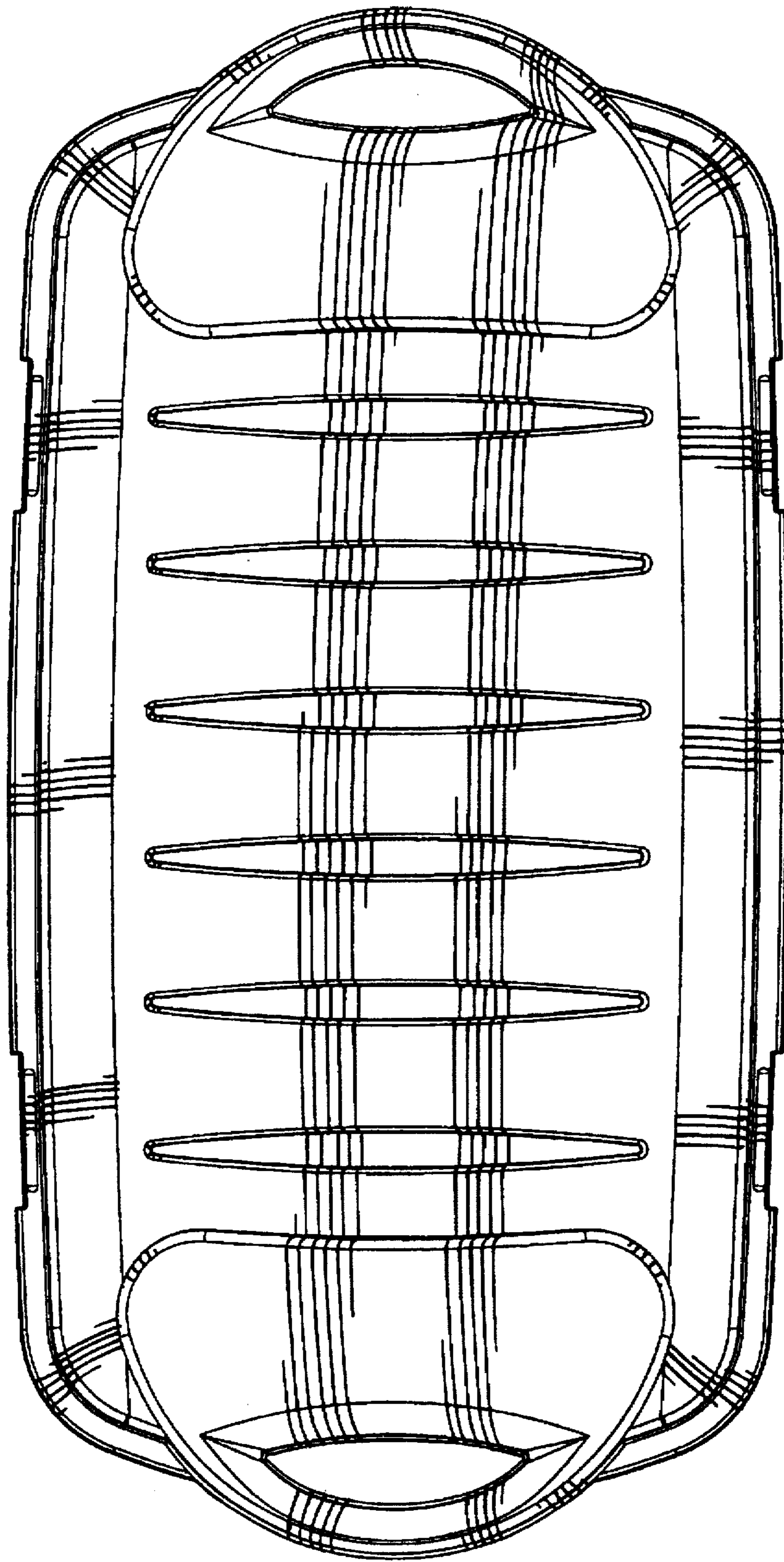

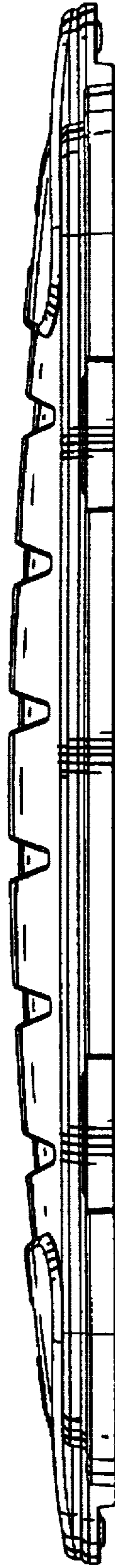

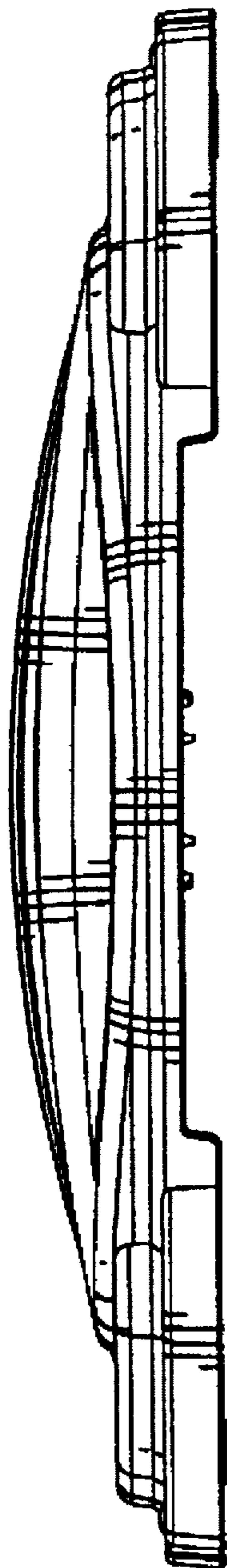

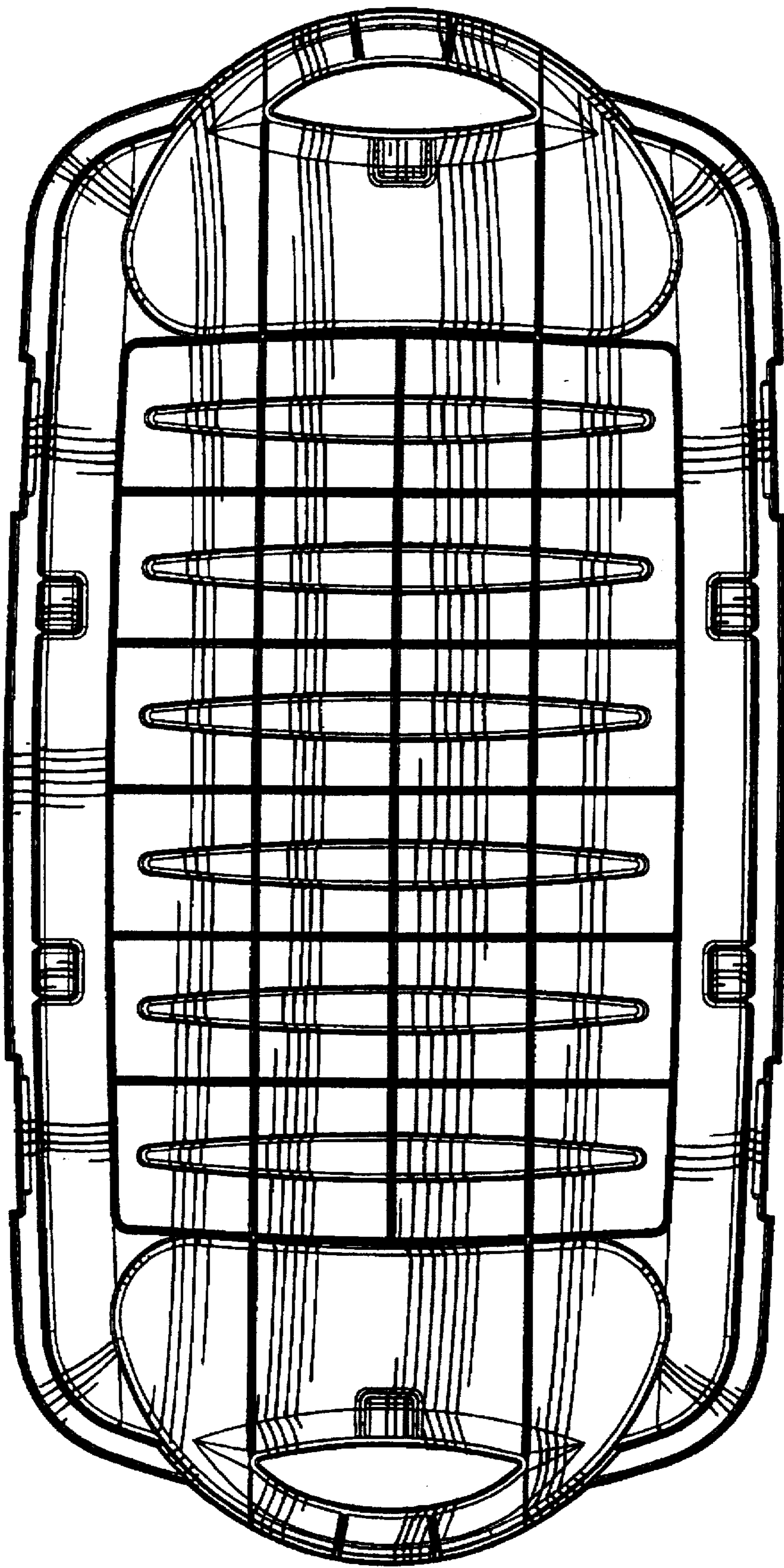
