#### DESCRIPTION

FIG. 1 is a front/left side perspective view of the pull of the present invention;


FIG. 2 is a top plan view of the pull of the present invention;

FIG. 3 is a cross-sectional view taken substantially through lines 3—3 of FIG. 4;

FIG. 4 is a front elevational view of the pull of the present invention; and,

FIG. 5 is right side elevational view of the pull of the present invention, the left side elevational view being a mirror image thereof.




