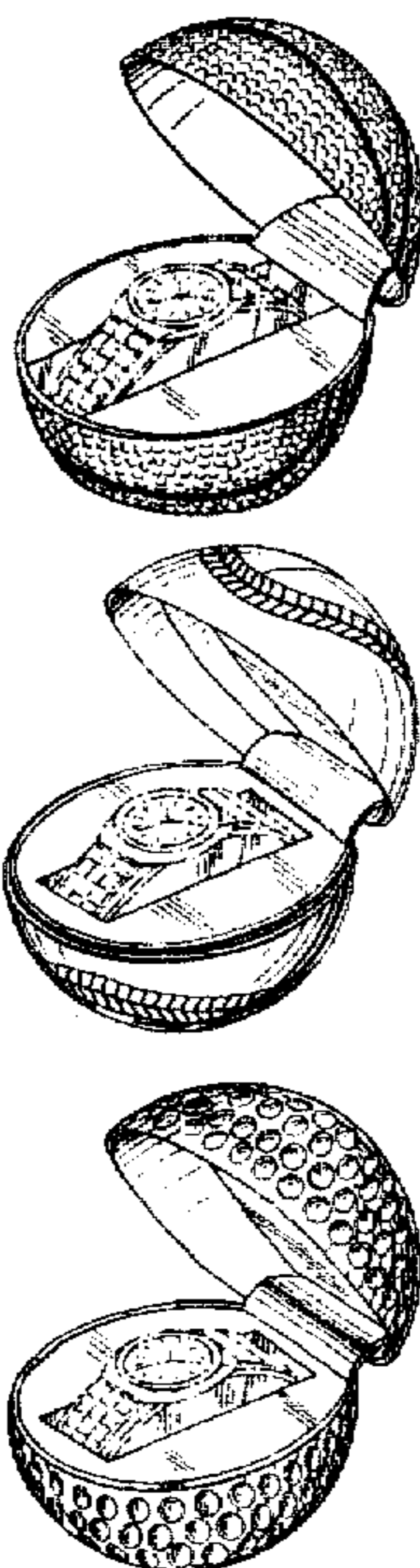
## [57] CLAIM

The ornamental design for a watch case, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of a watch case showing my new design;  
 FIG. 2 is a top elevation view thereof;  
 FIG. 3 is a front side elevation view thereof;  
 FIG. 4 is a left side elevation view thereof, the right side being an identical image thereto;  
 FIG. 5 is a rear view thereof;  
 FIG. 6 is a bottom view thereof;  
 FIG. 7 is a perspective view of a watch case showing a second embodiment of my new design;  
 FIG. 8 is a top elevation view thereof;  
 FIG. 9 is a front side elevation view thereof;  
 FIG. 10 is a left side elevation view thereof, the right side being an identical image thereto;  
 FIG. 11 is a rear view thereof;

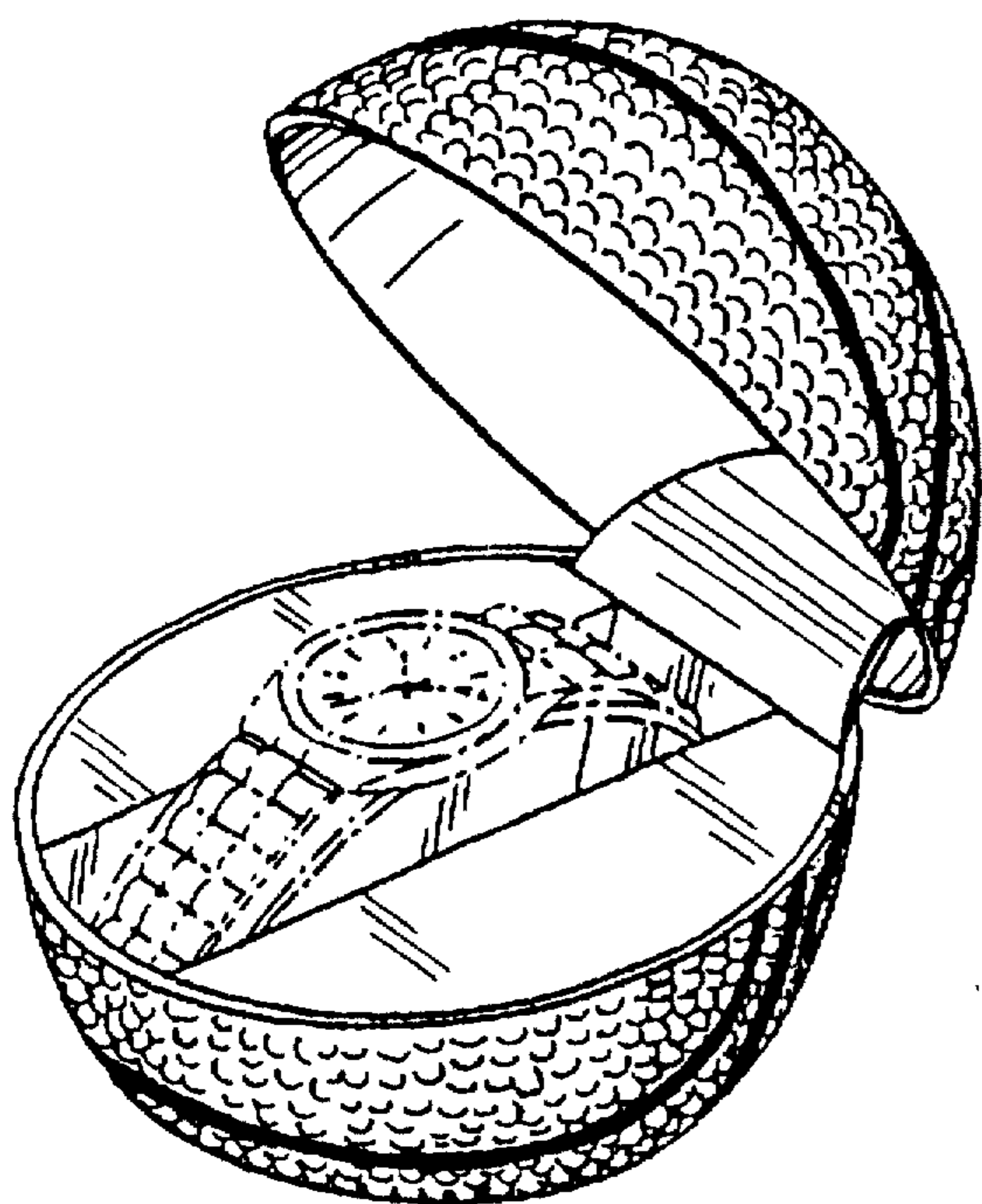

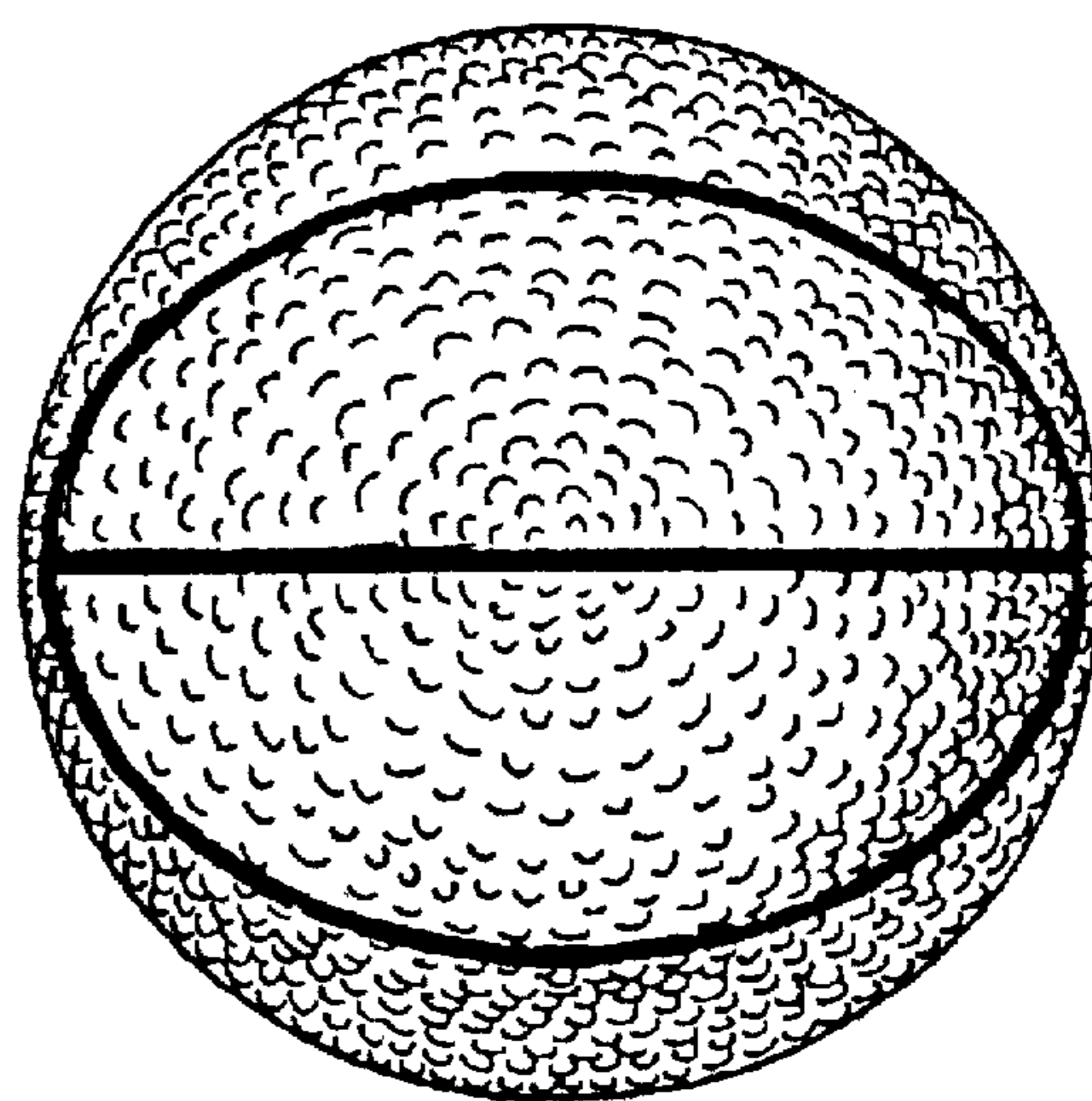

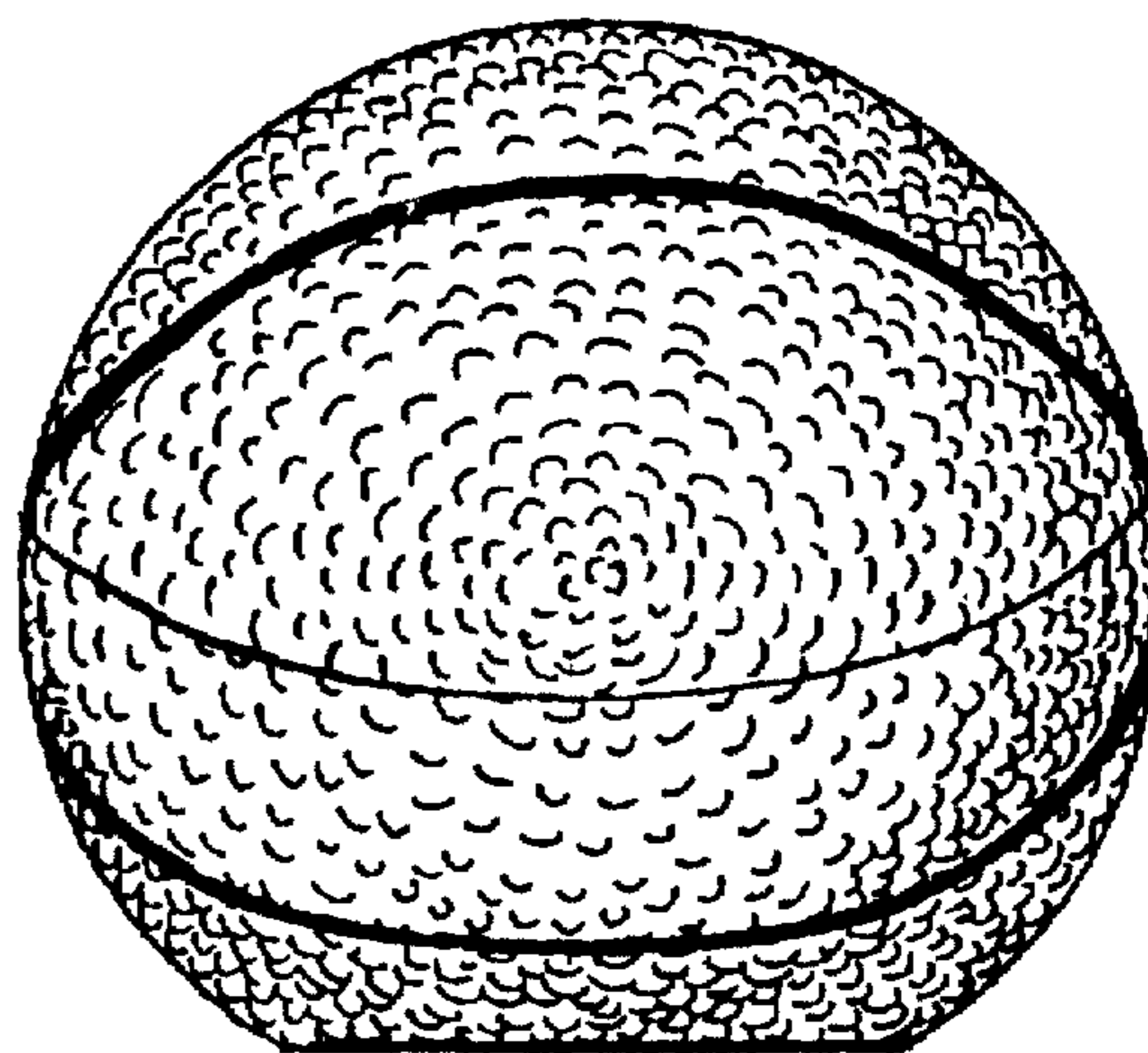

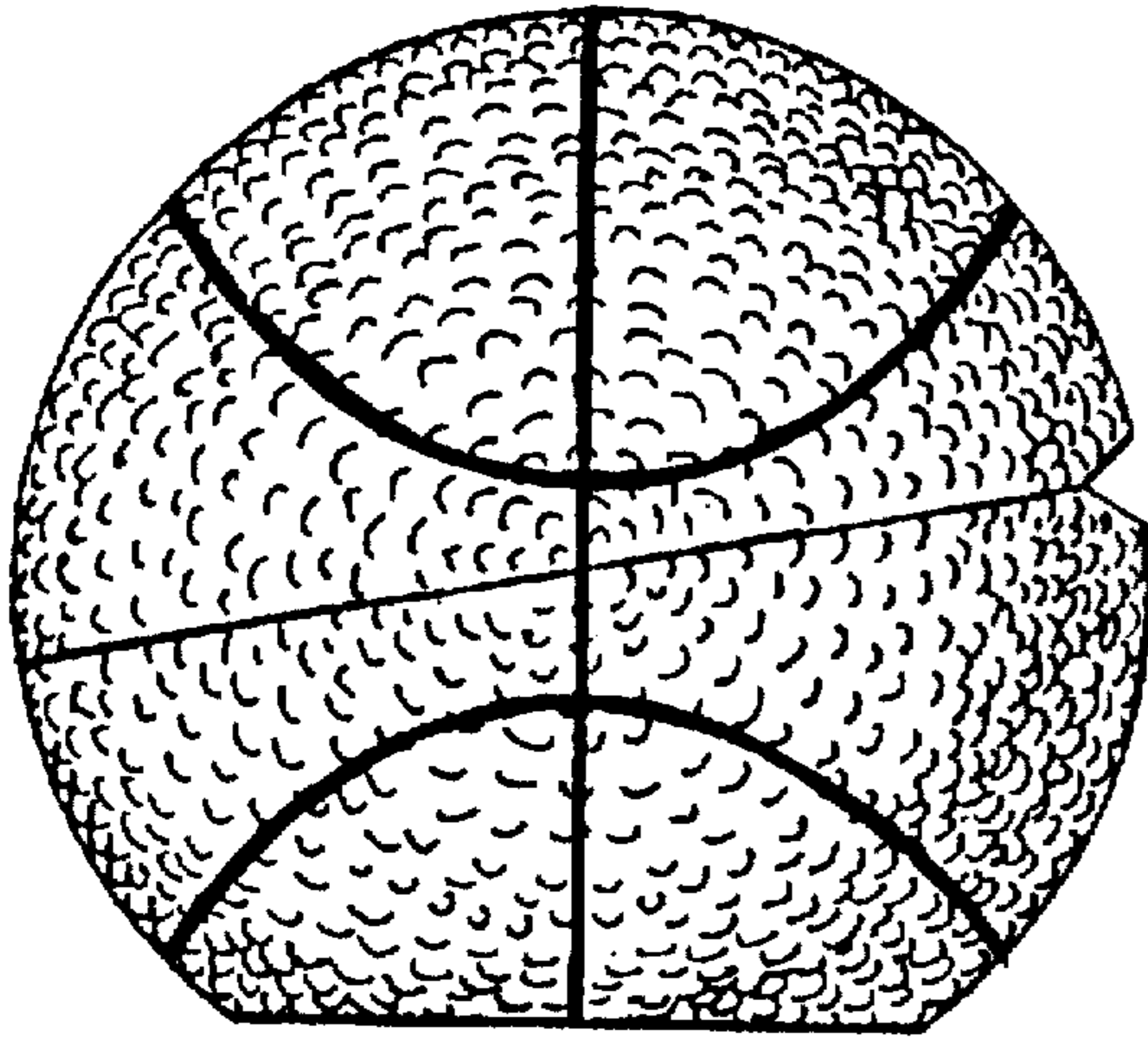

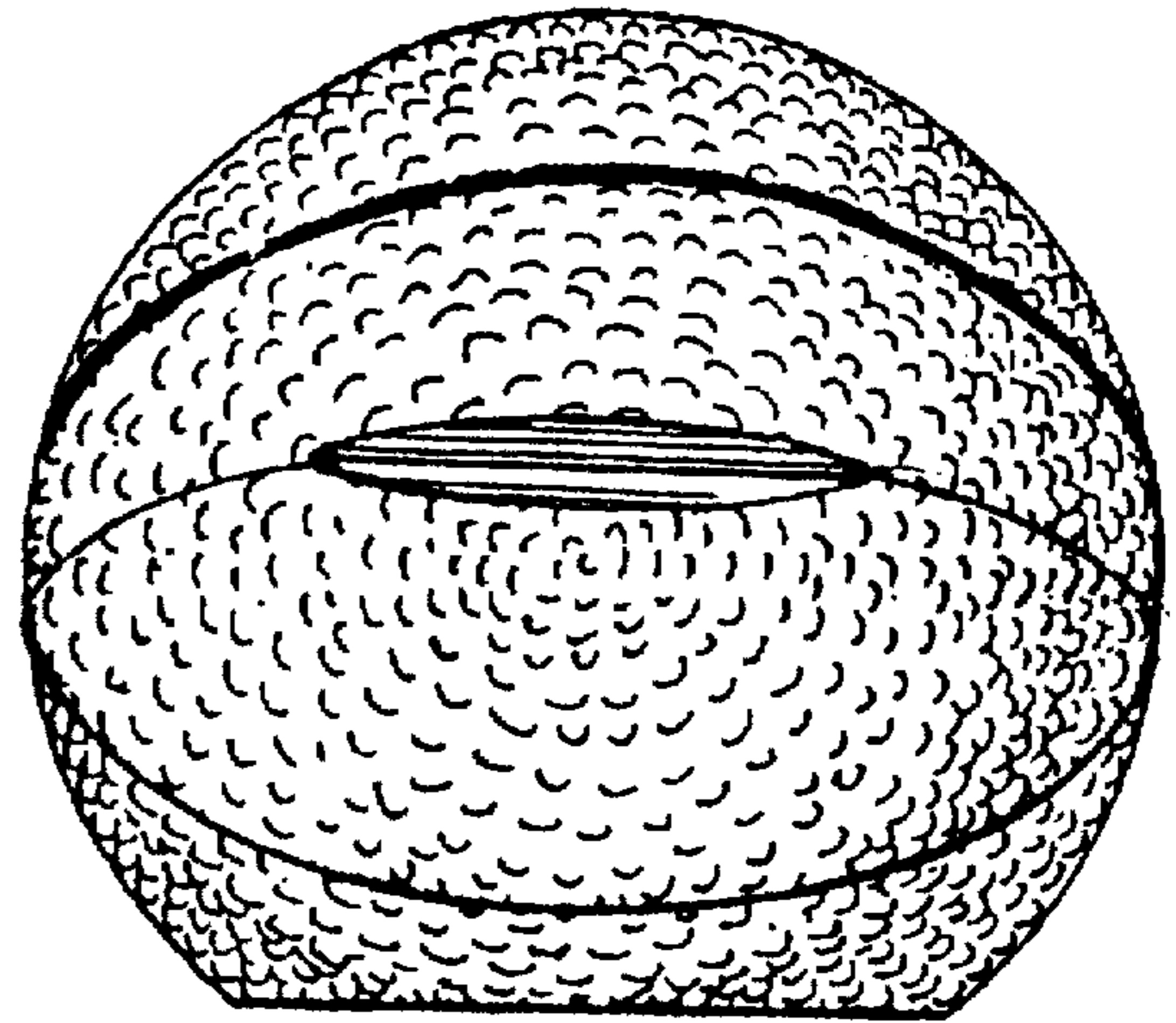

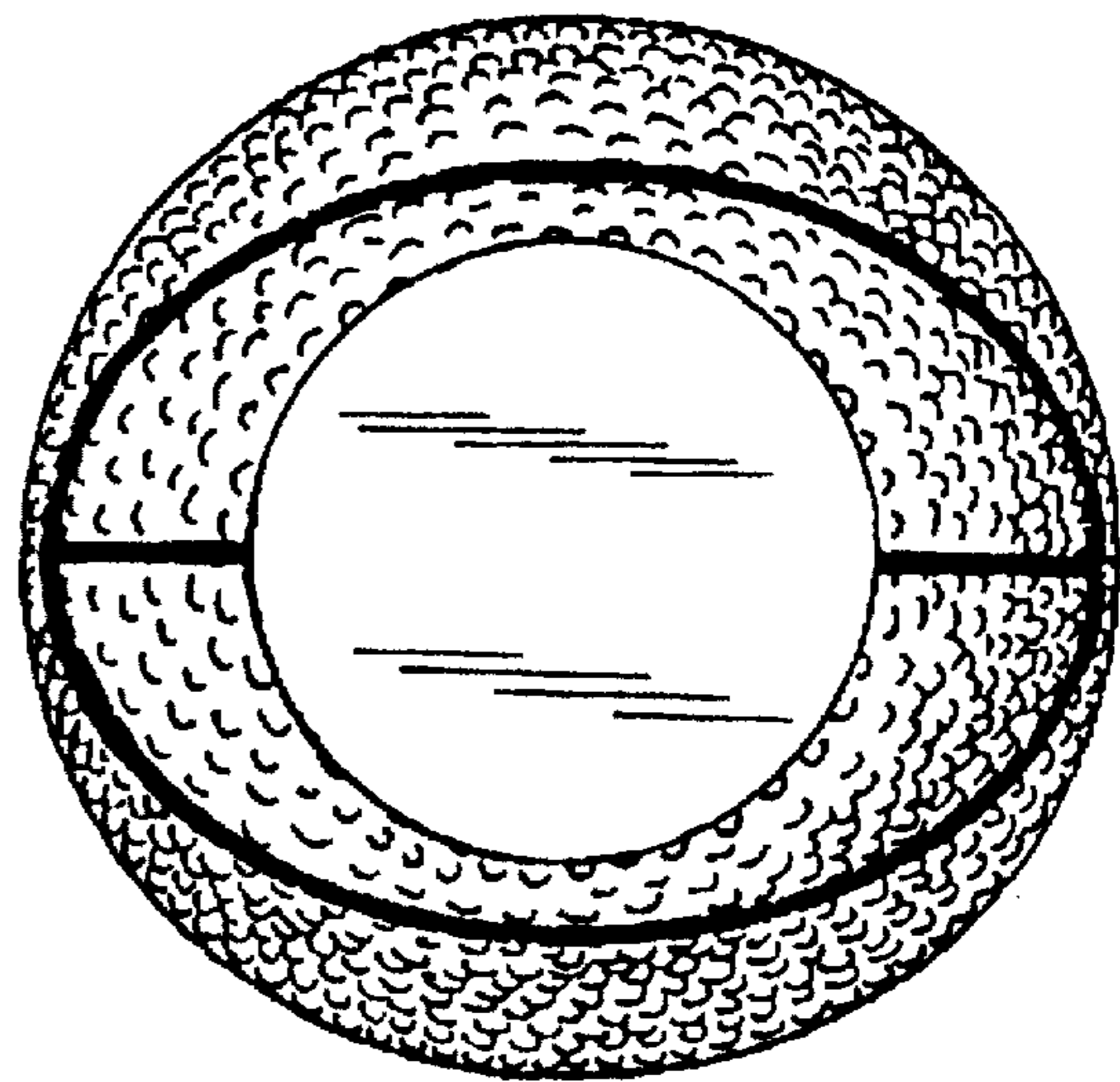

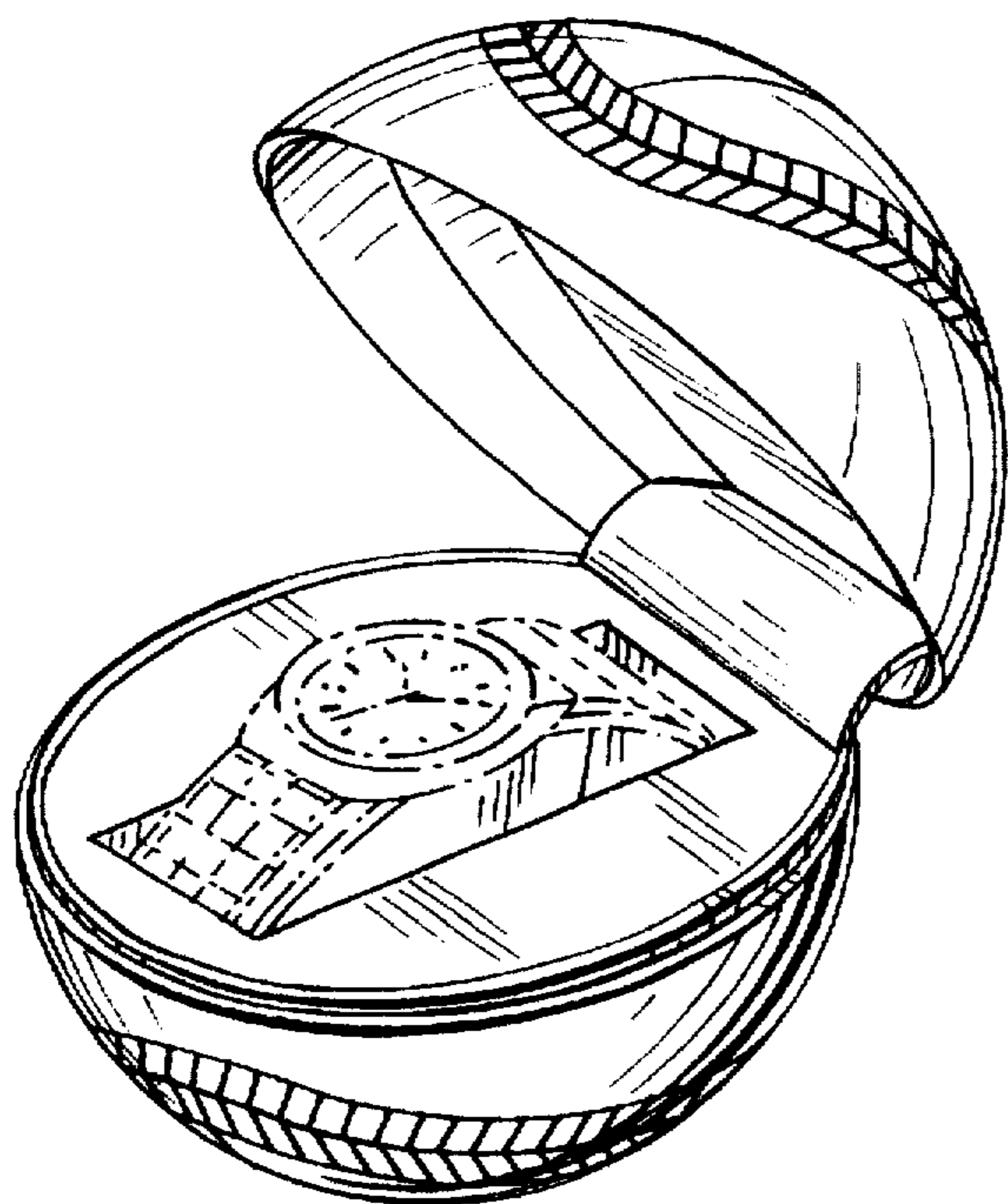

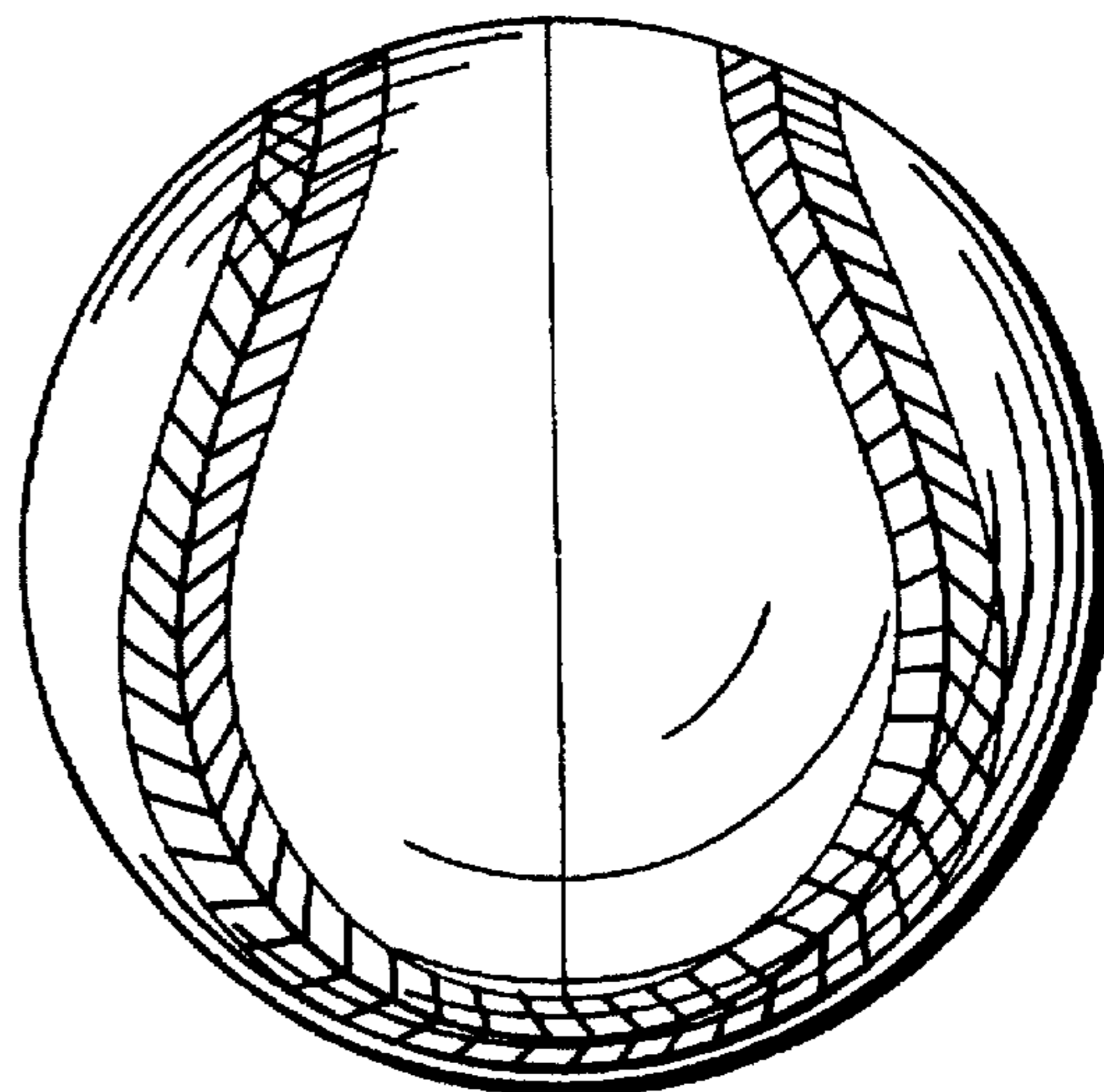

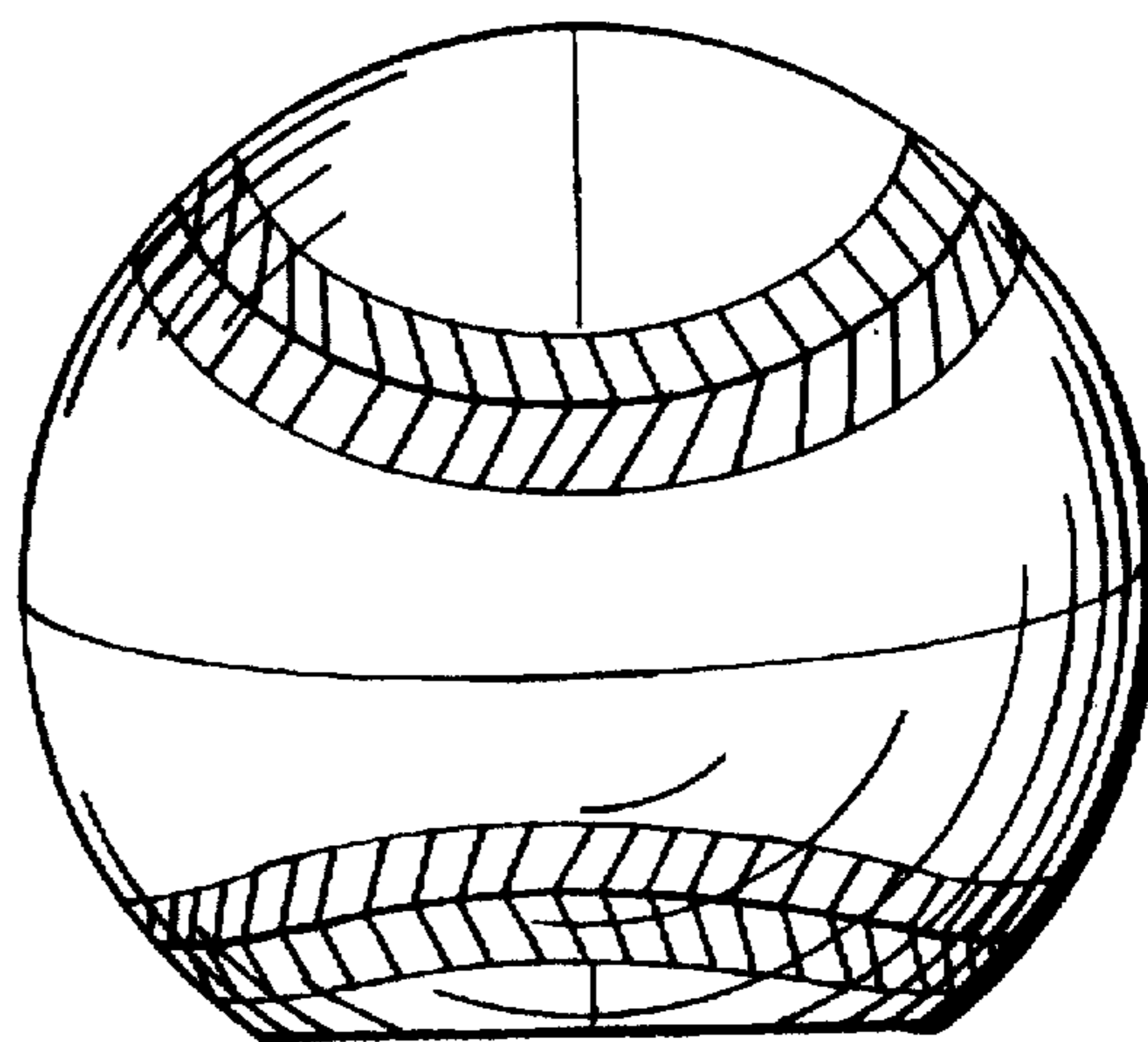

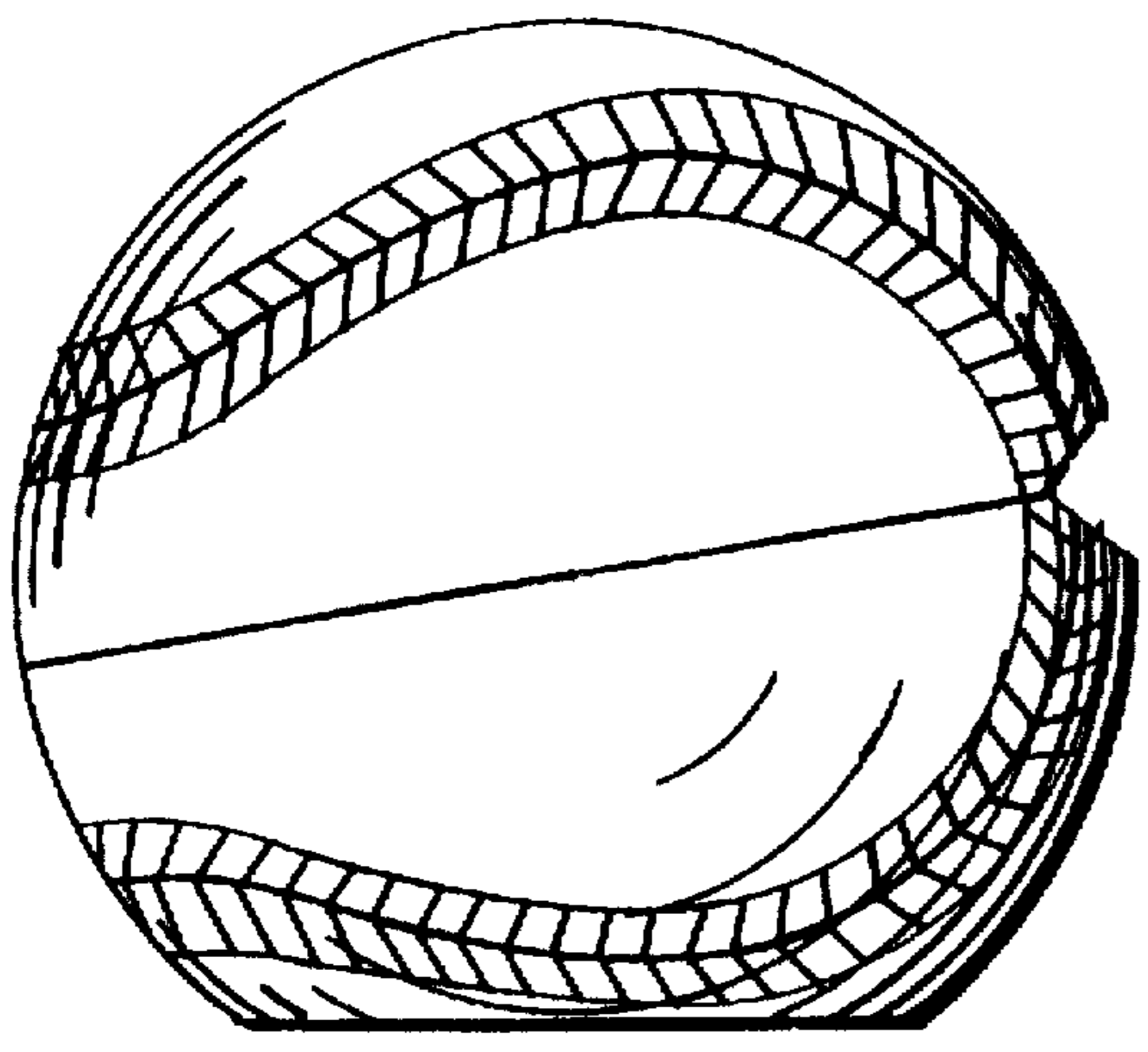

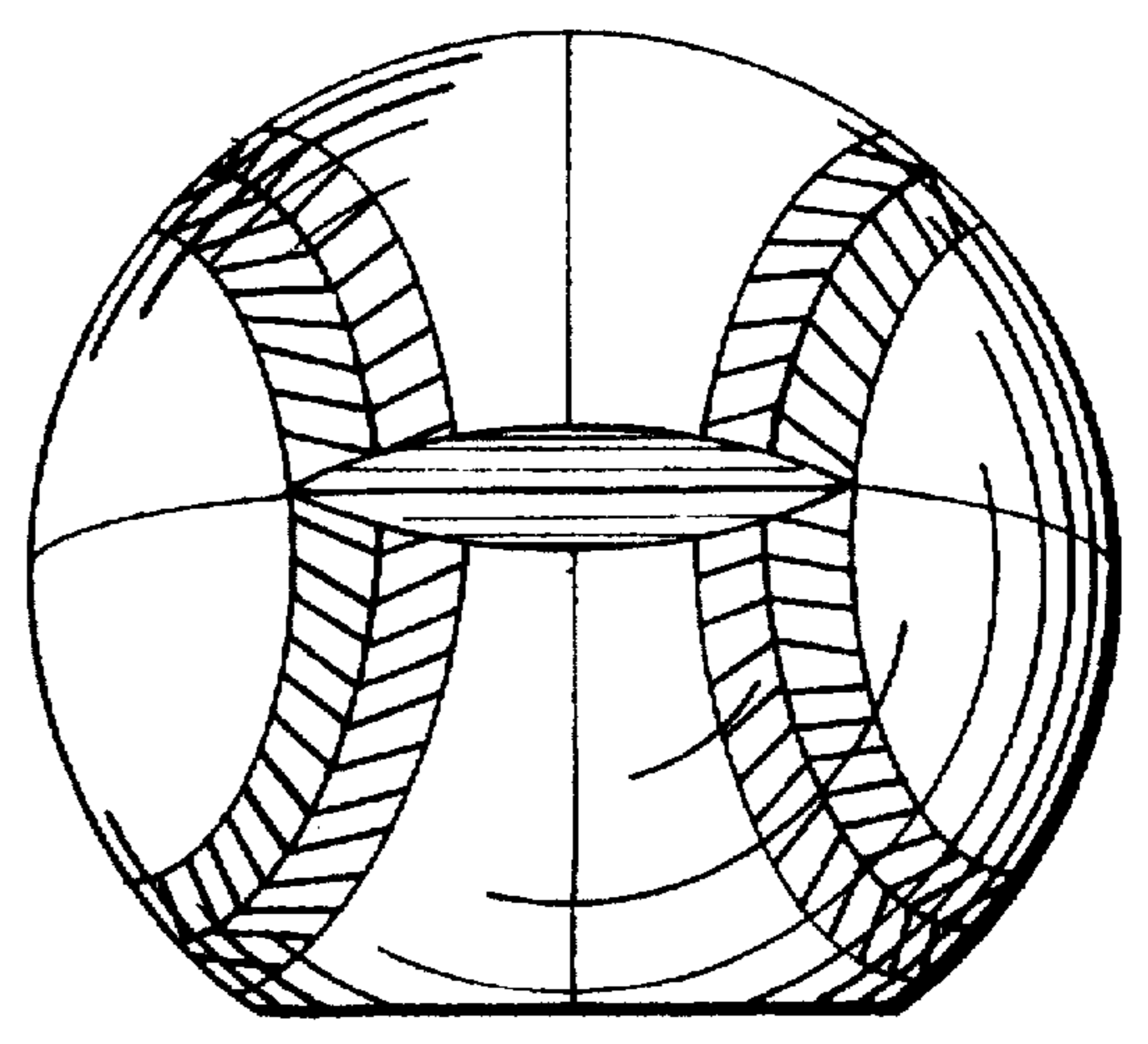

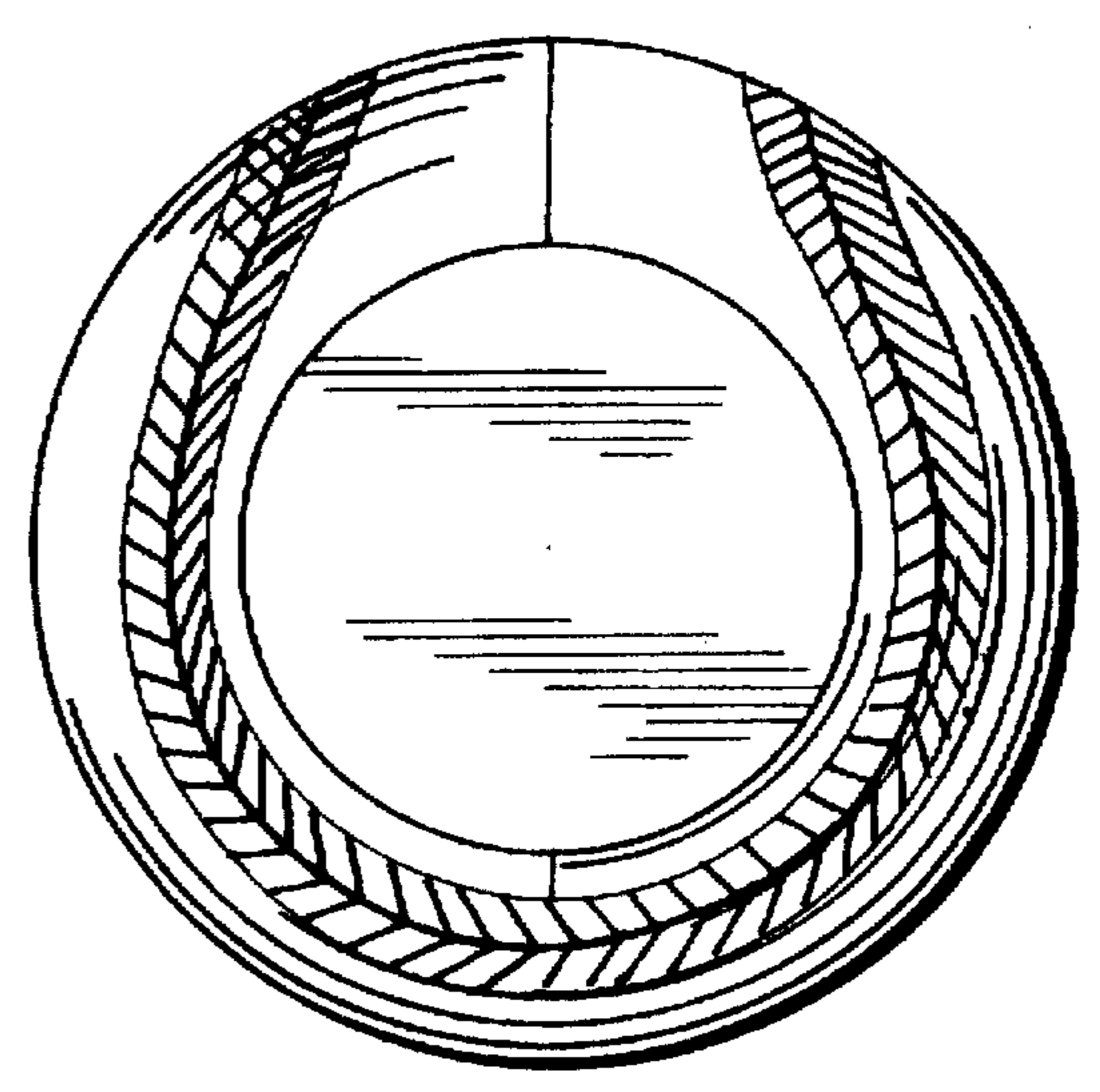

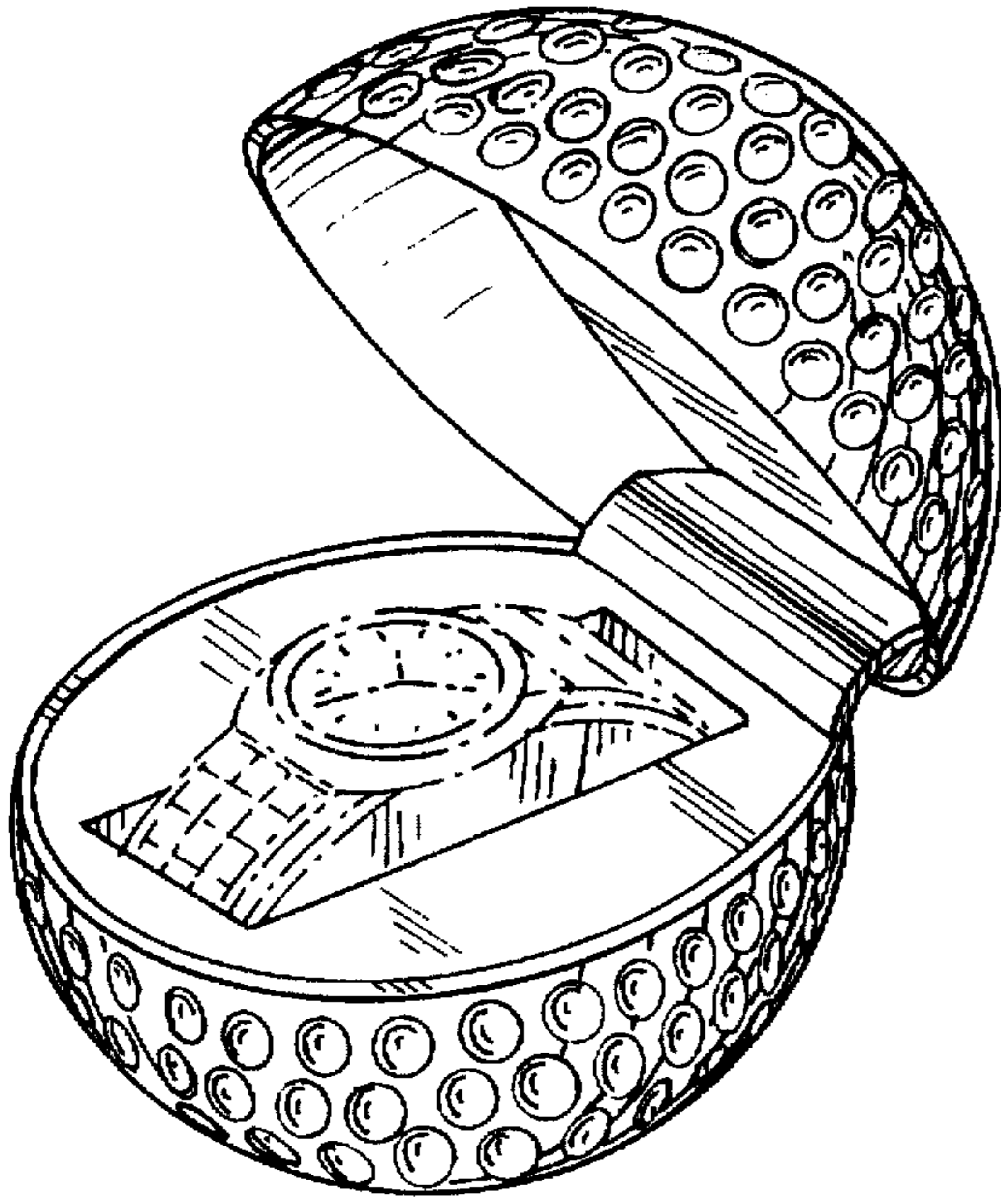

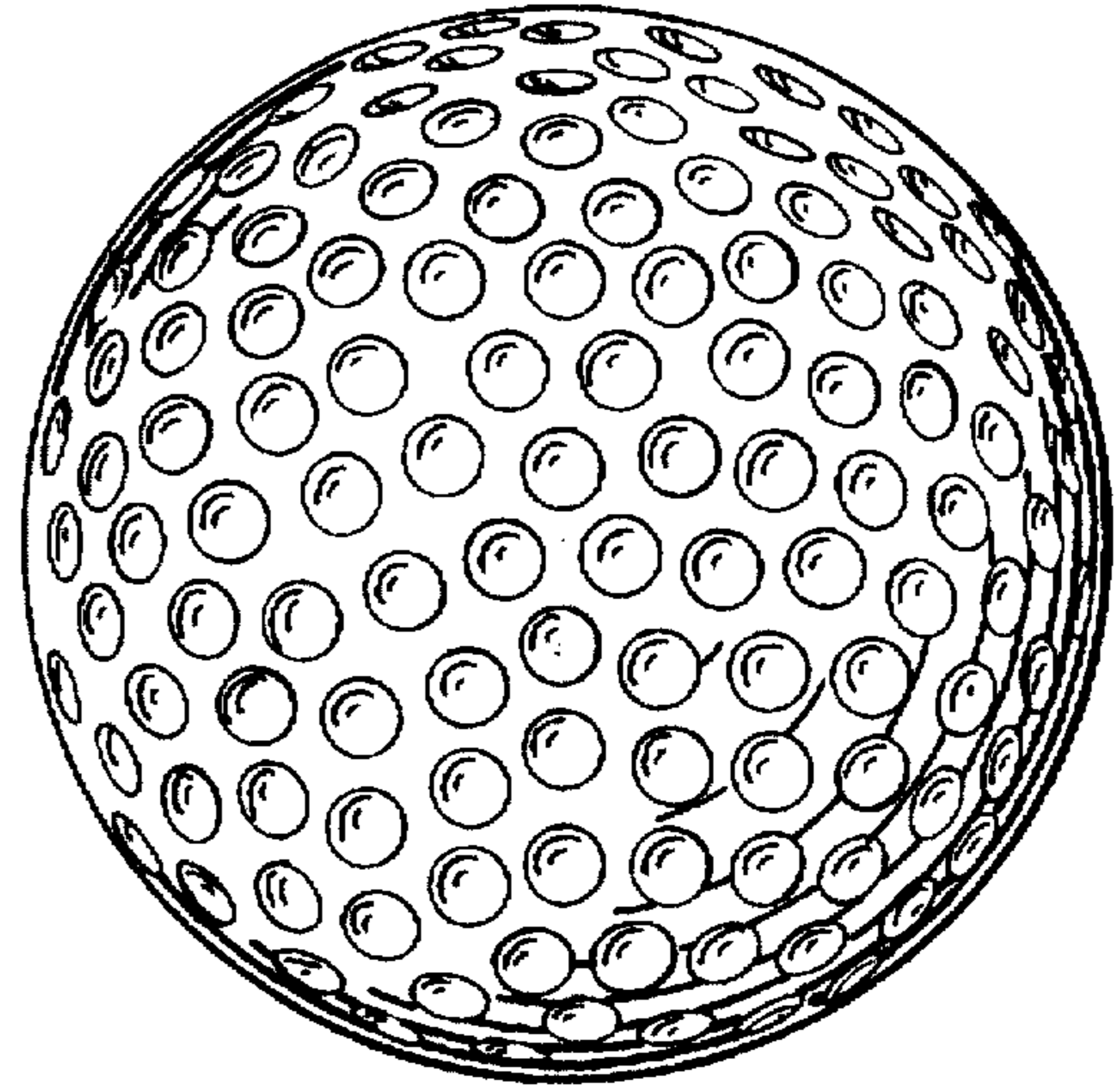

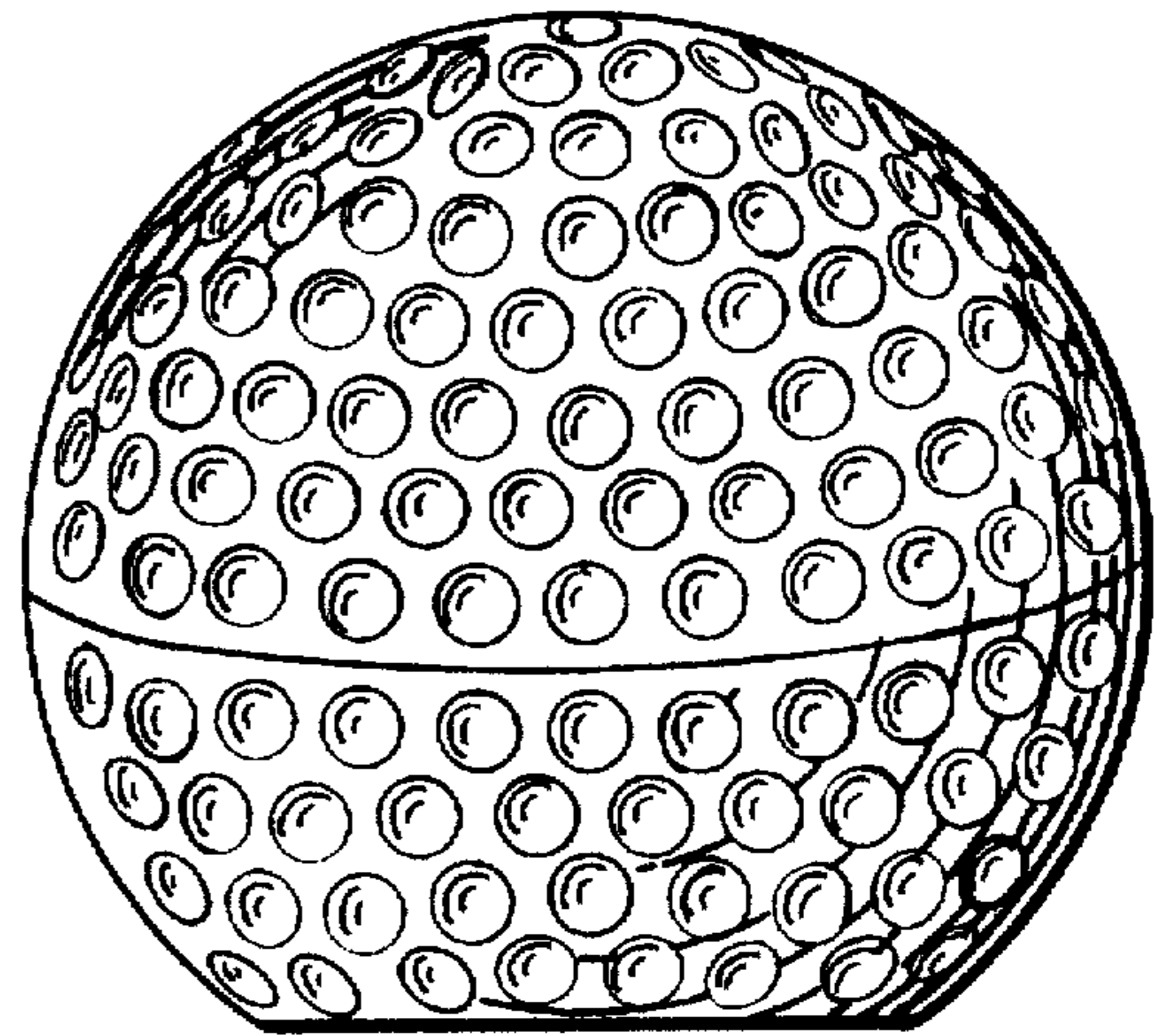

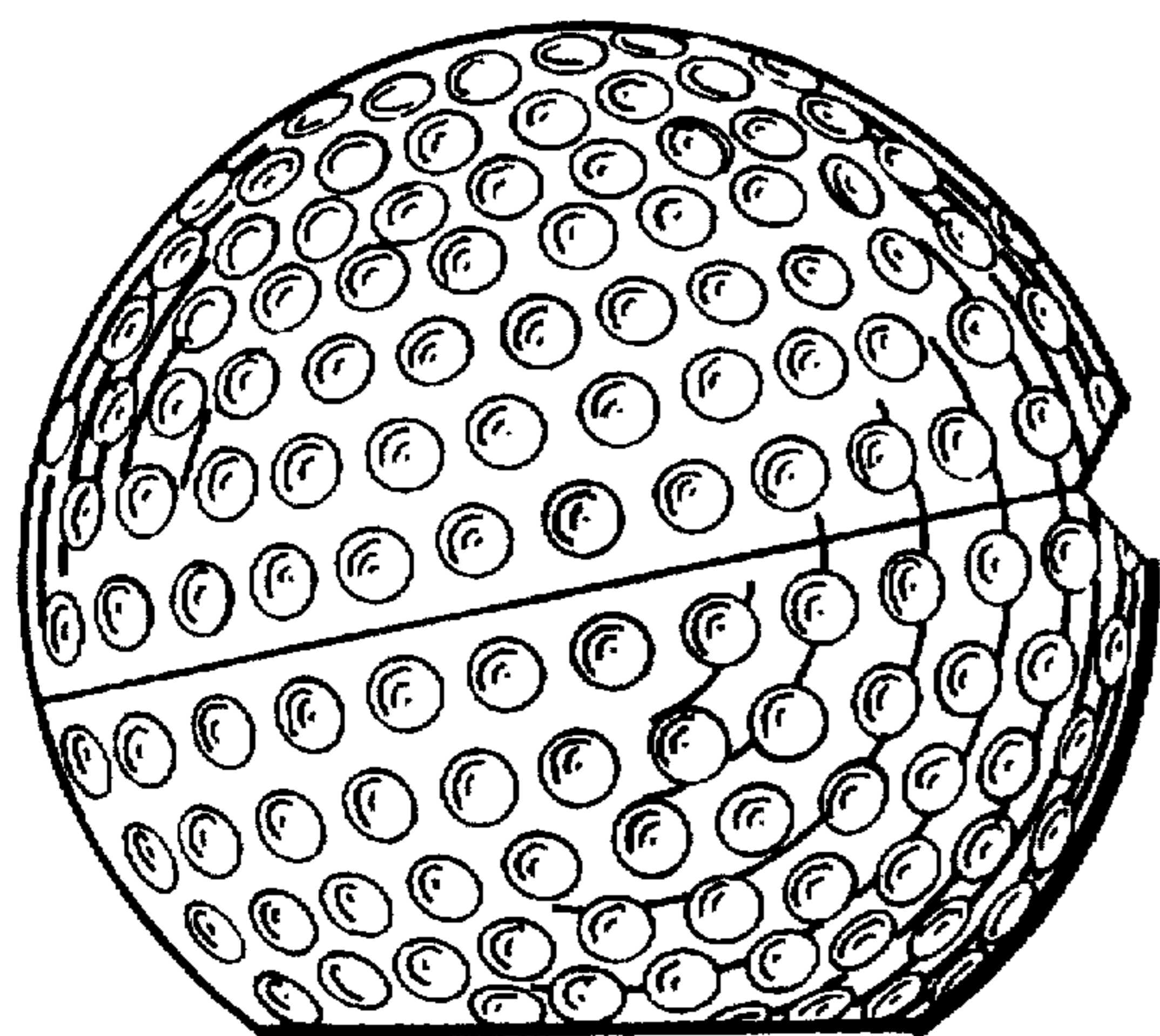

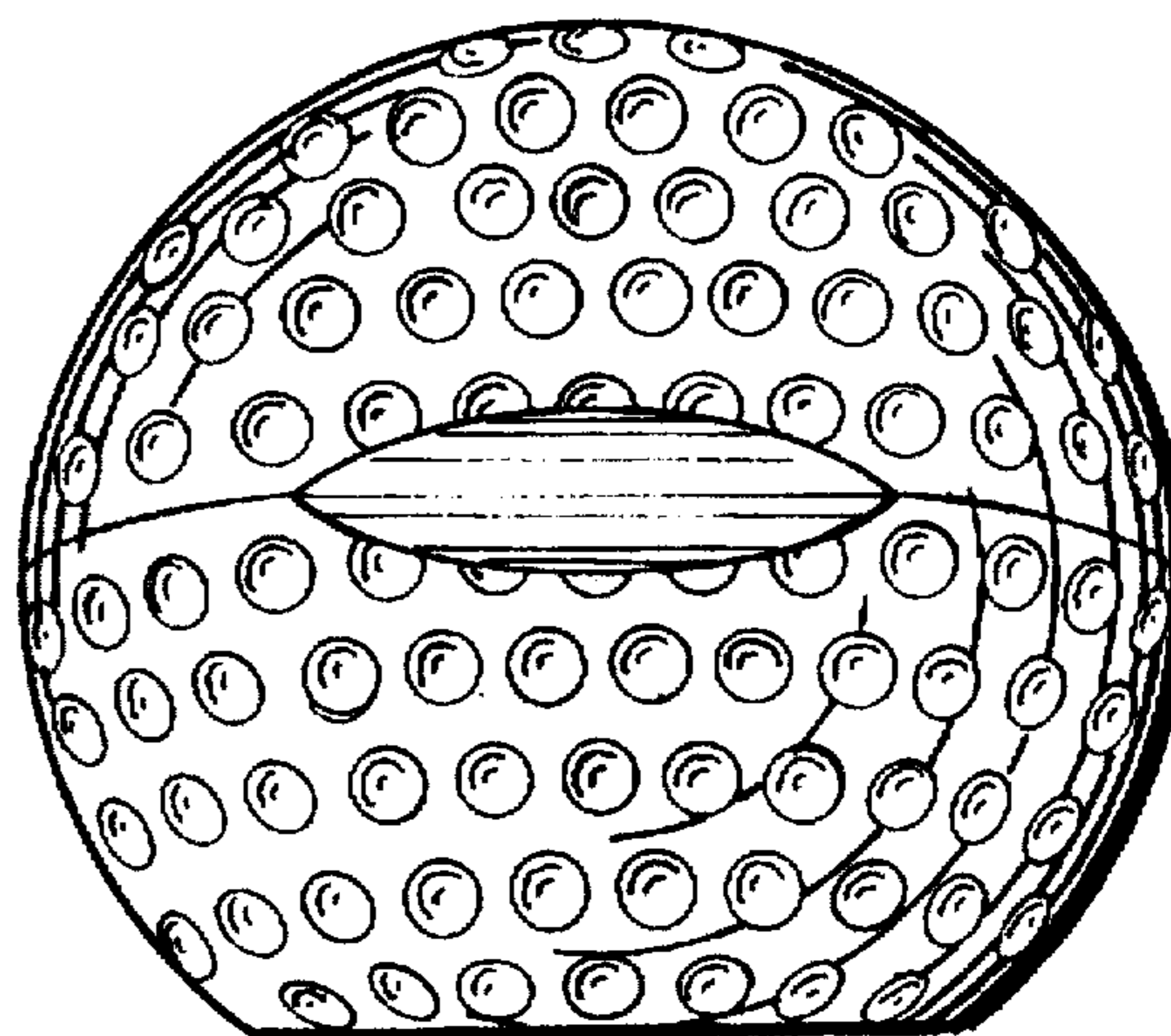

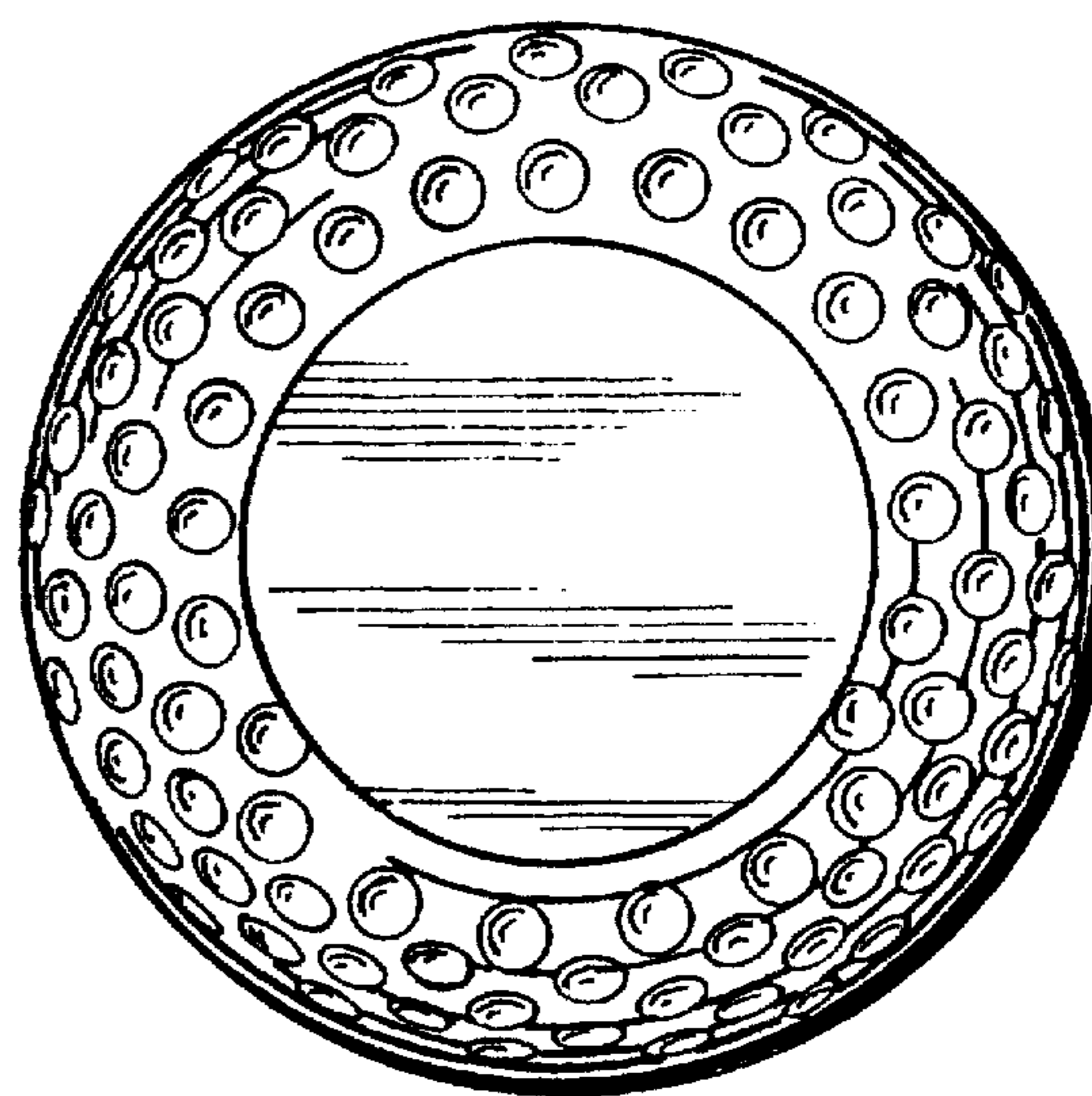
