DESCRIPTION

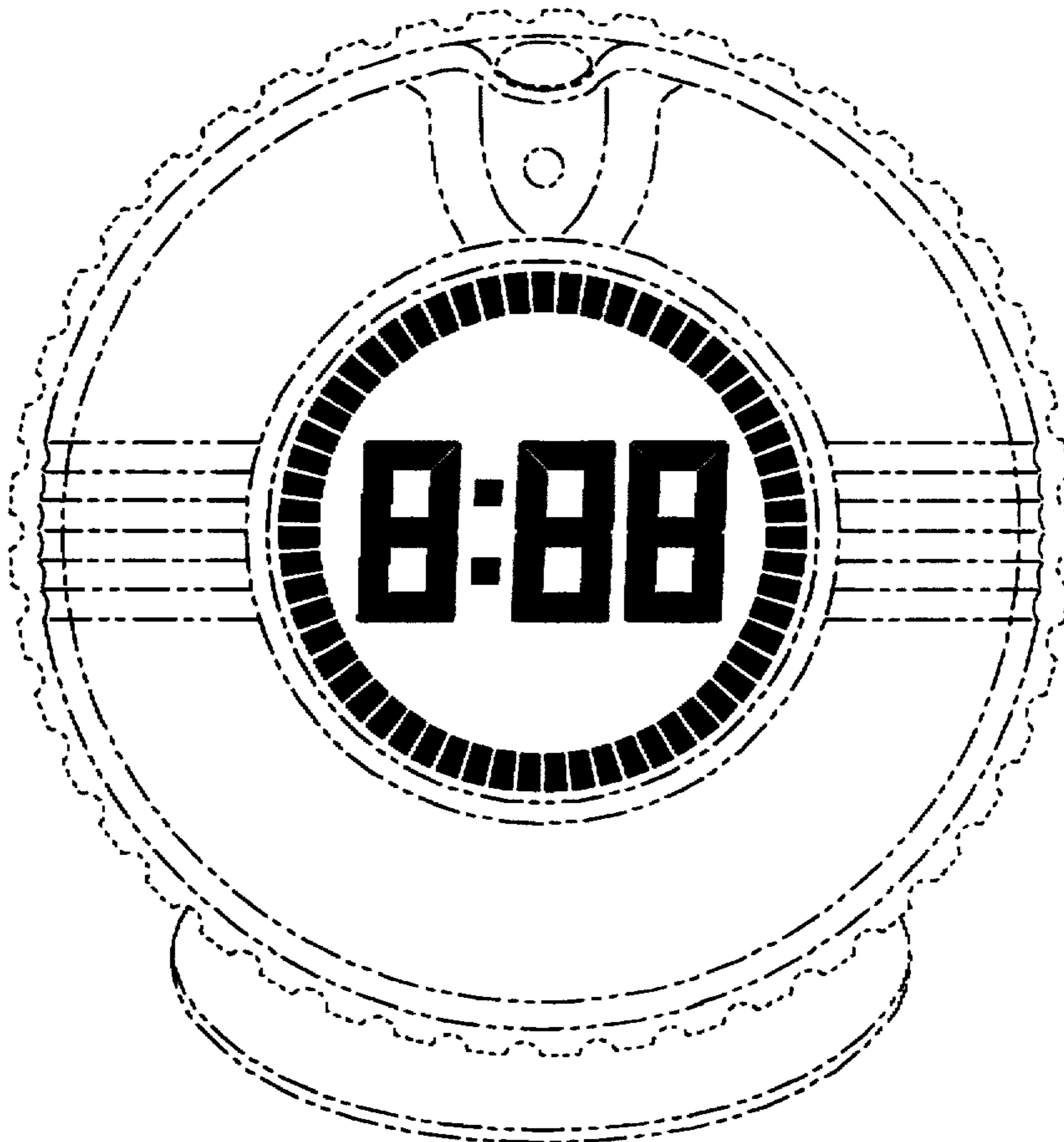
FIG. 1 shows a timer display according to the invention;

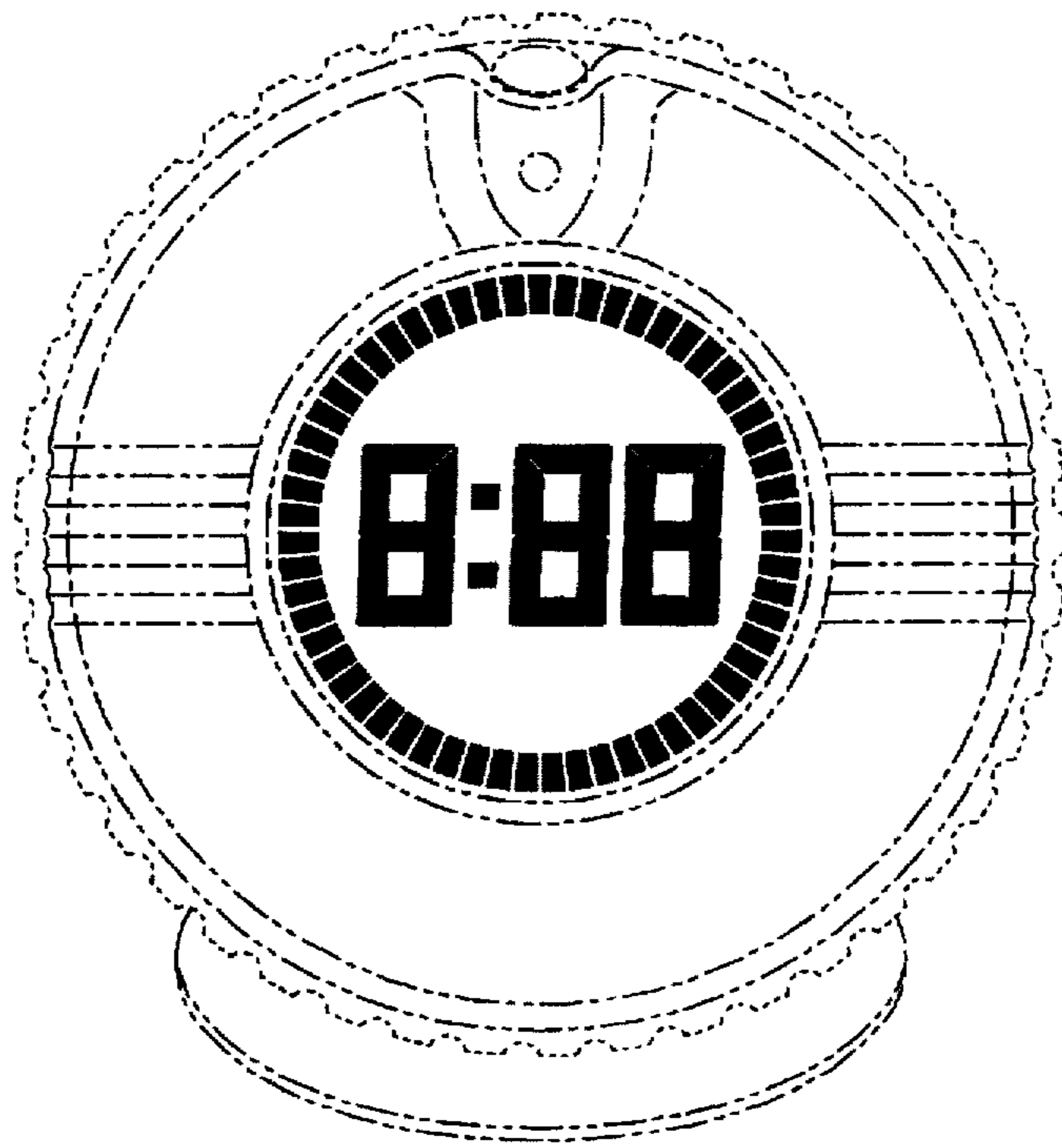

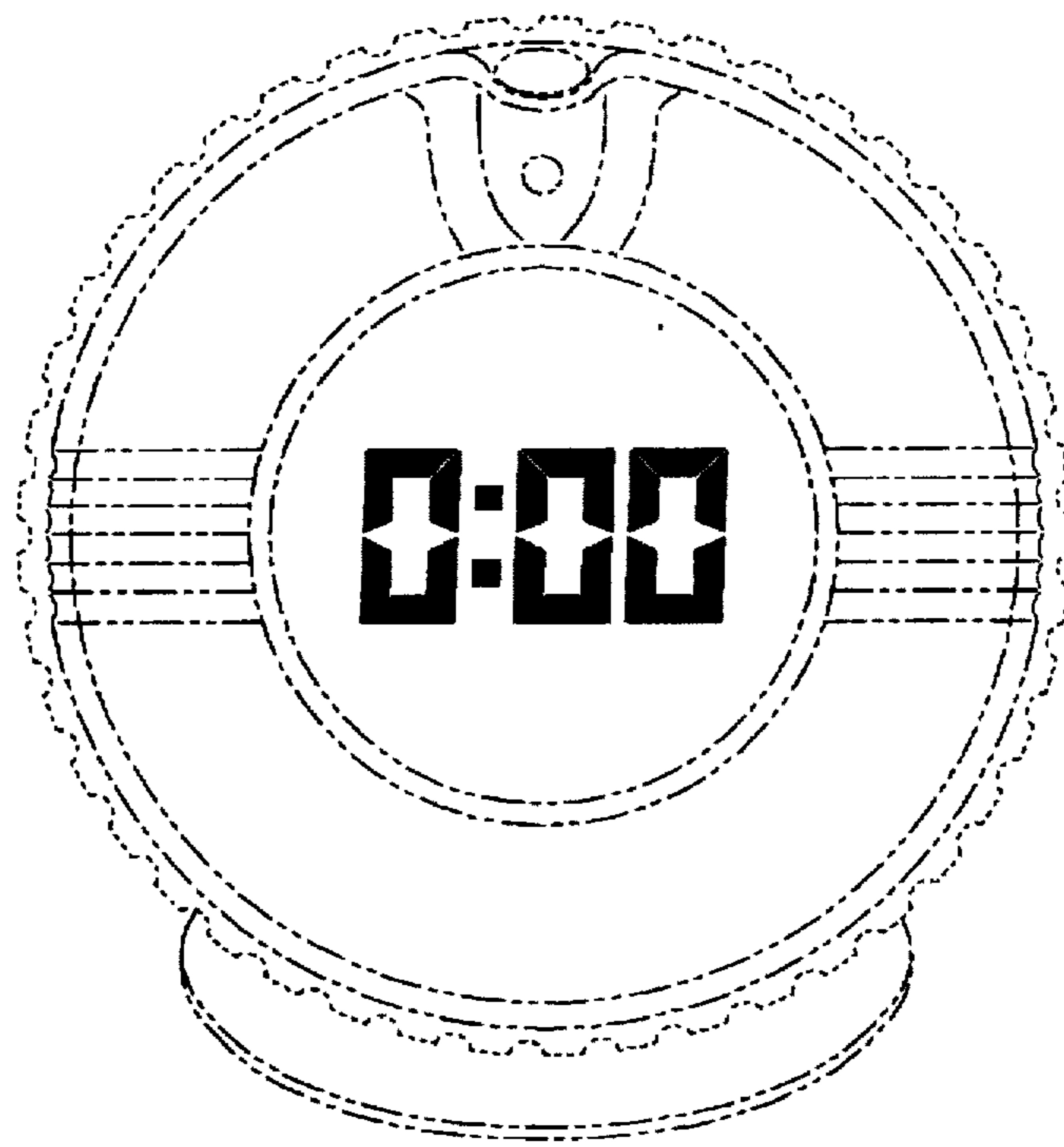

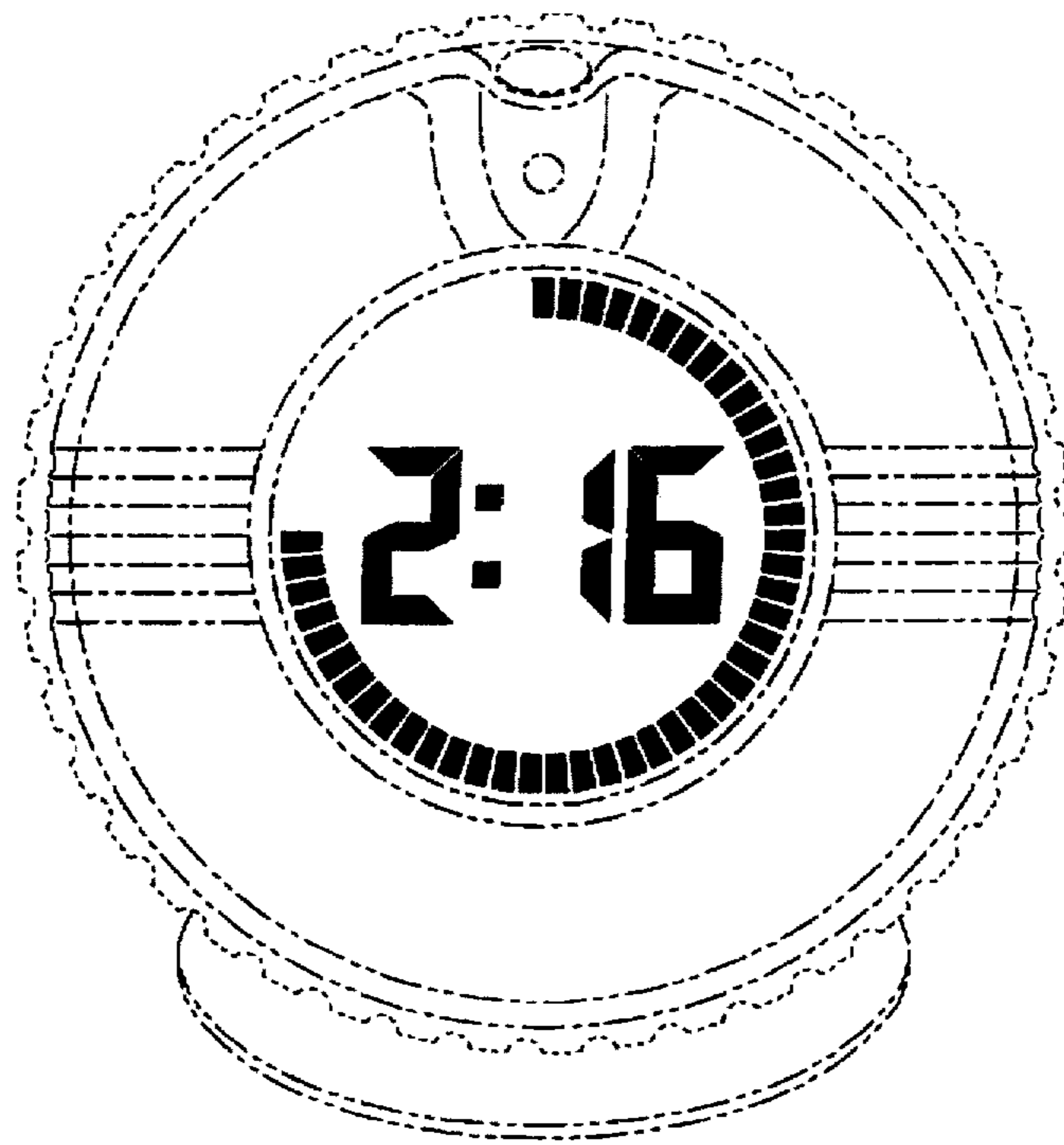

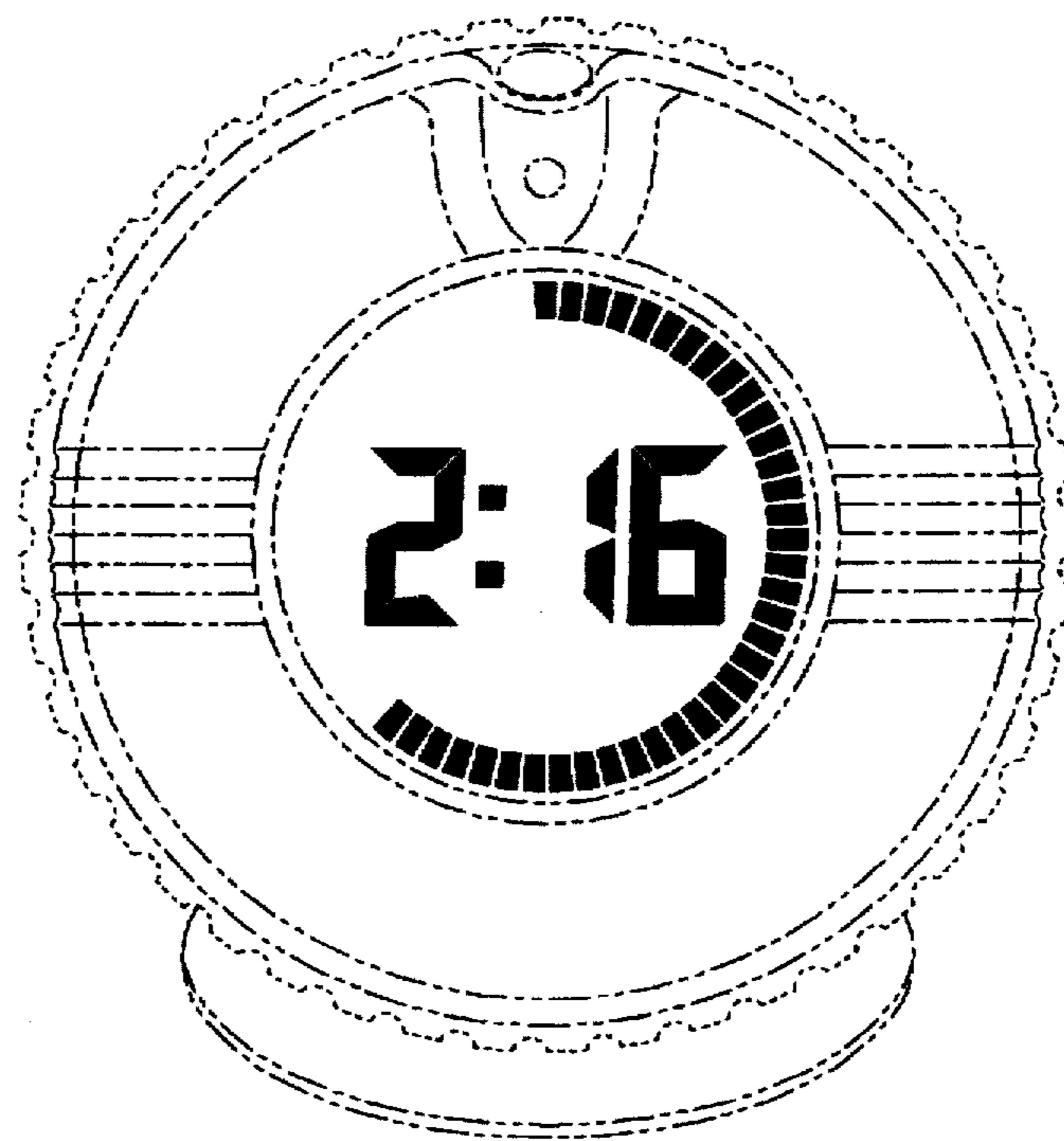

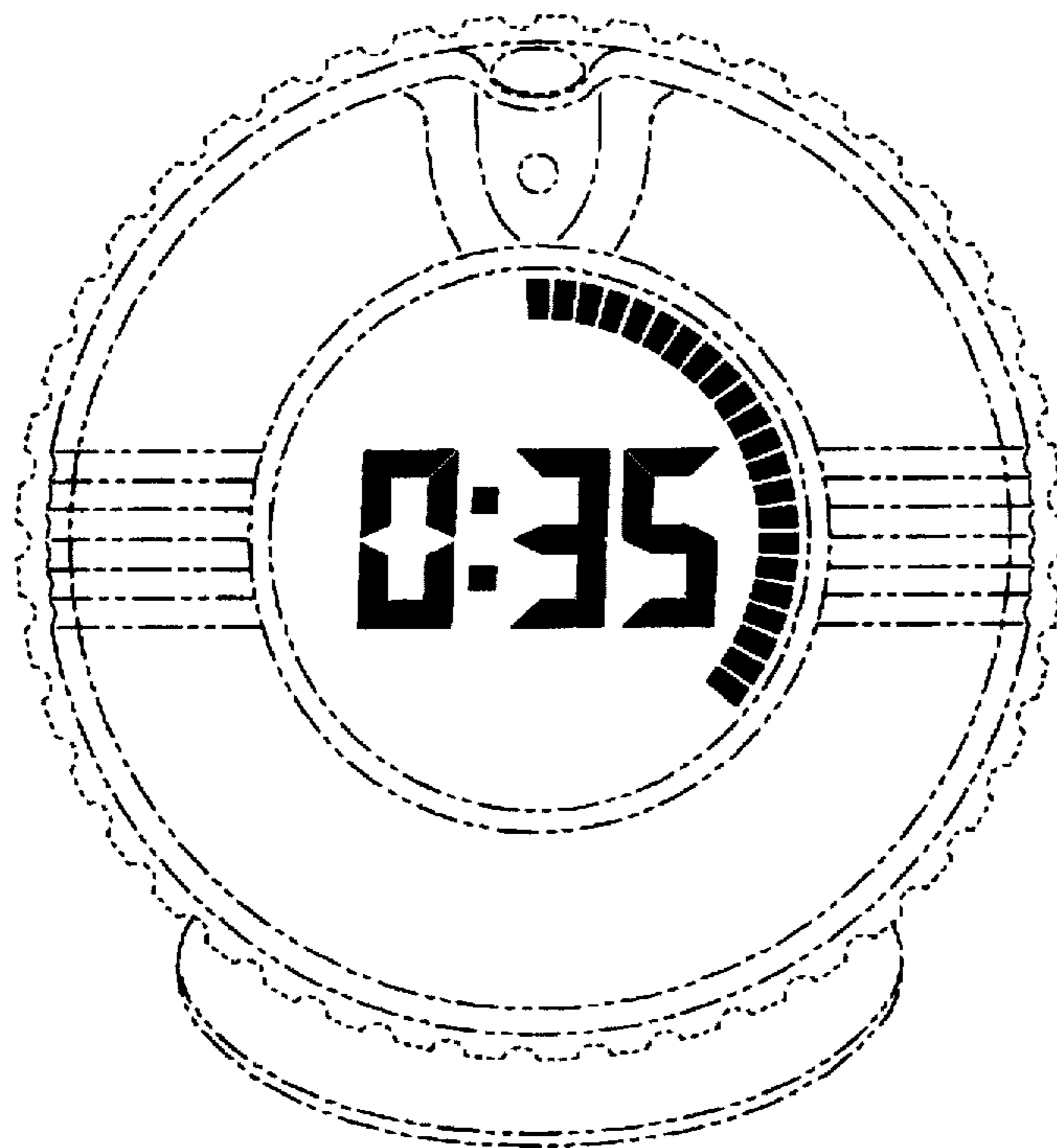

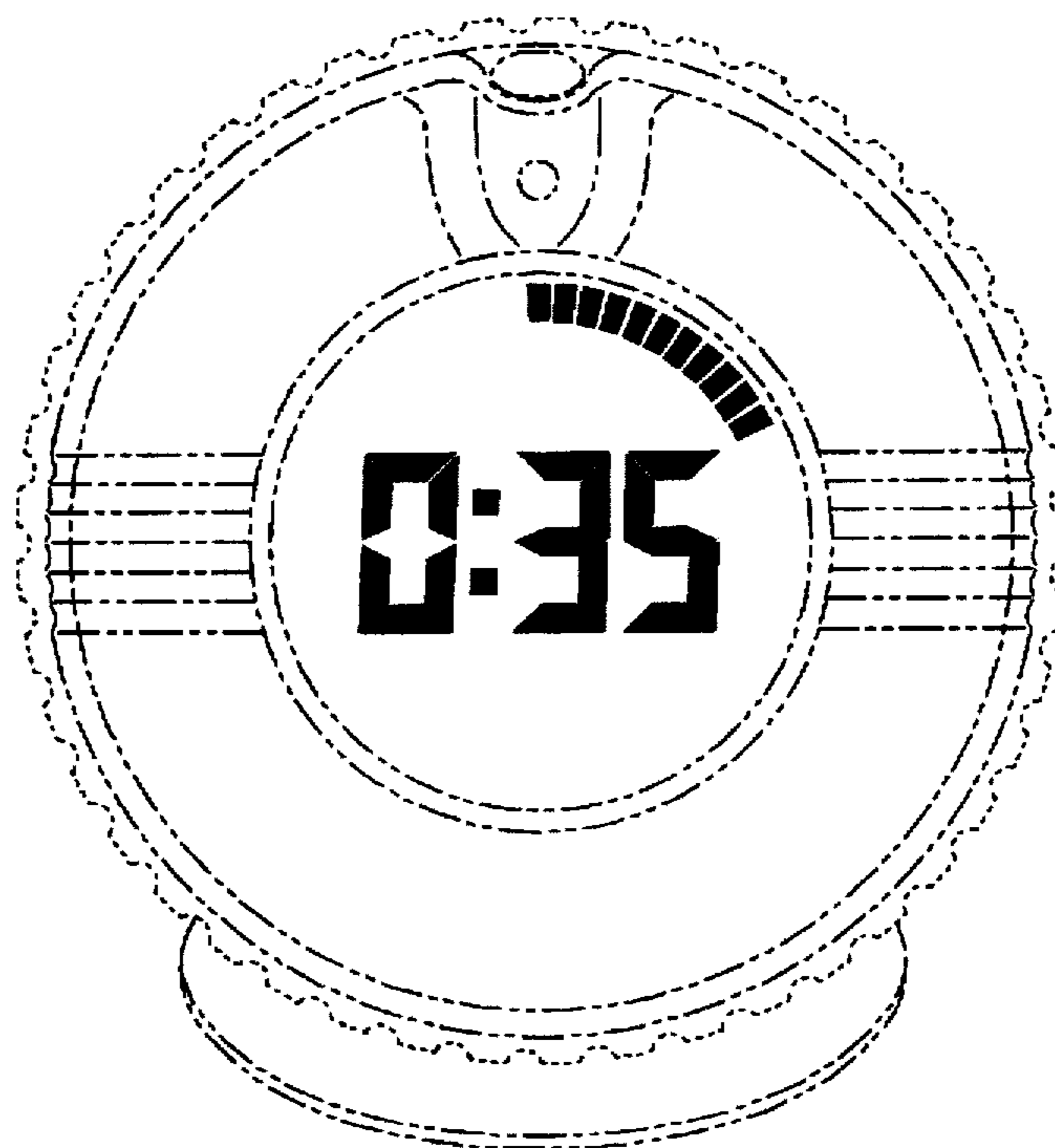
