[57] **CLAIM**

The ornamental design for a supply unit for supplying a developer for a copy machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a supply unit for supplying a developer for a copying machine, showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a left side elevational view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a rear elevational view thereof;  
 FIG. 7 is a bottom plan view thereof; and,  
 FIG. 8 is an enlarged cross-sectional view taken along line 8—8 in FIG. 2, with its internal mechanisms omitted.

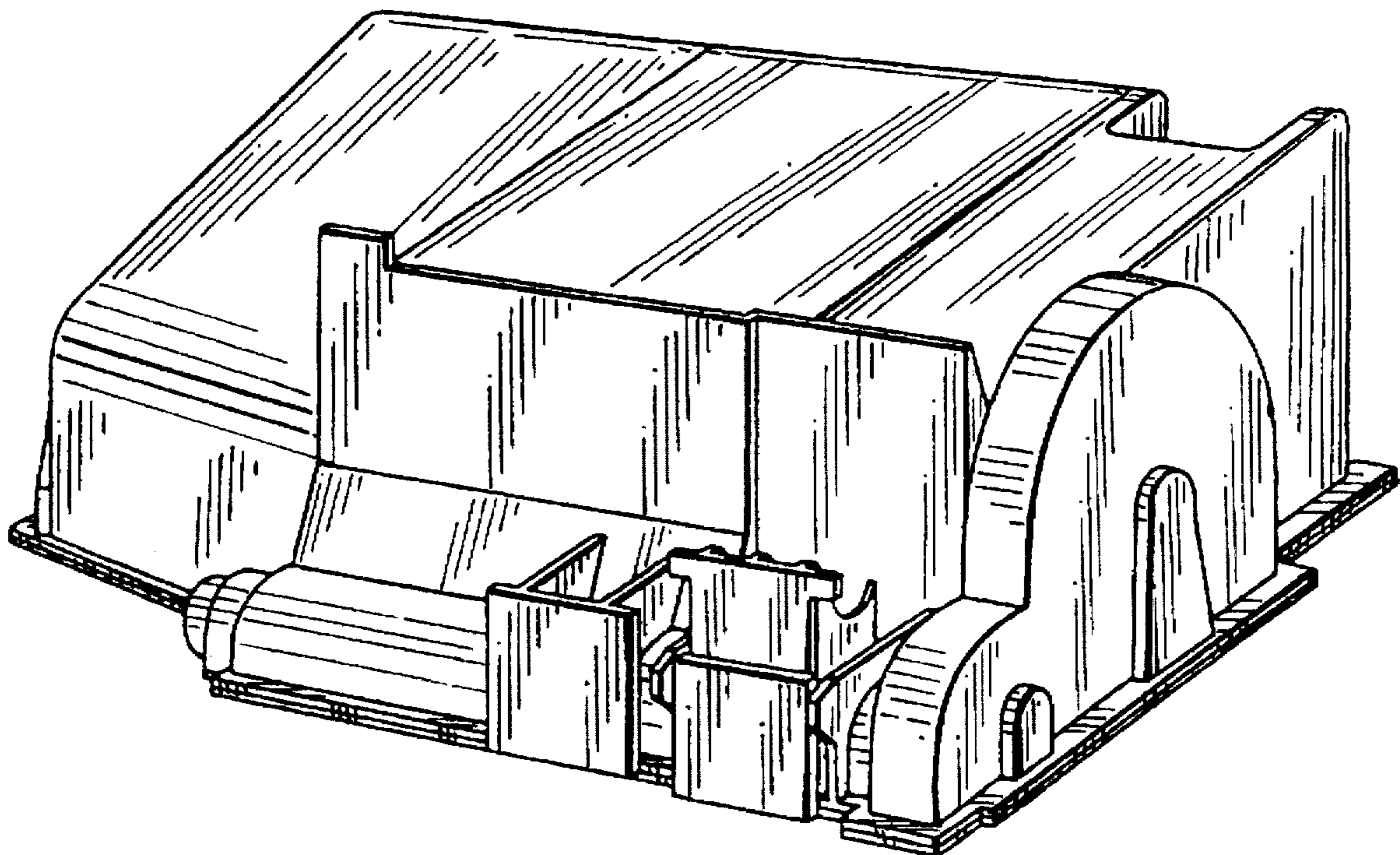

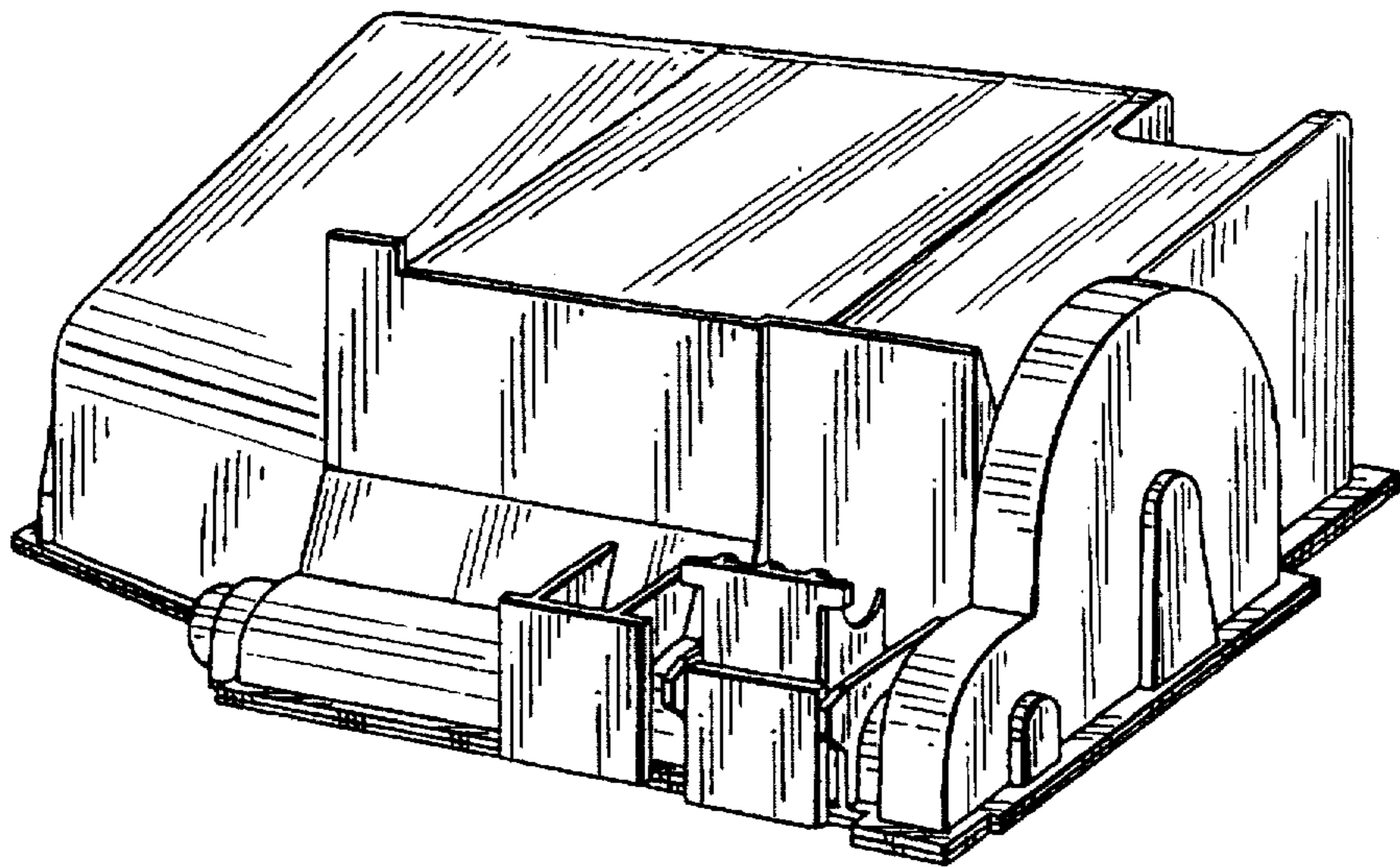

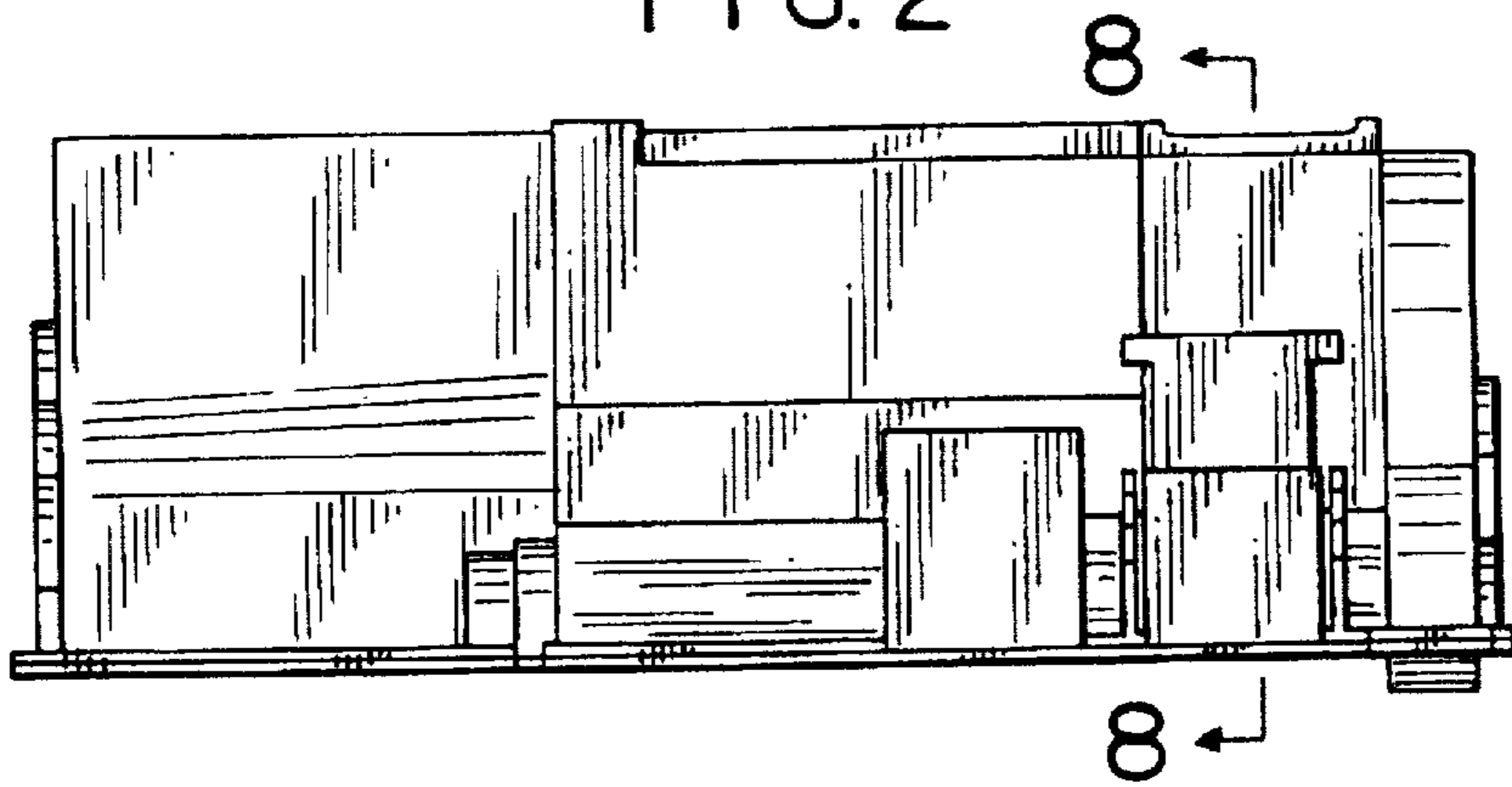

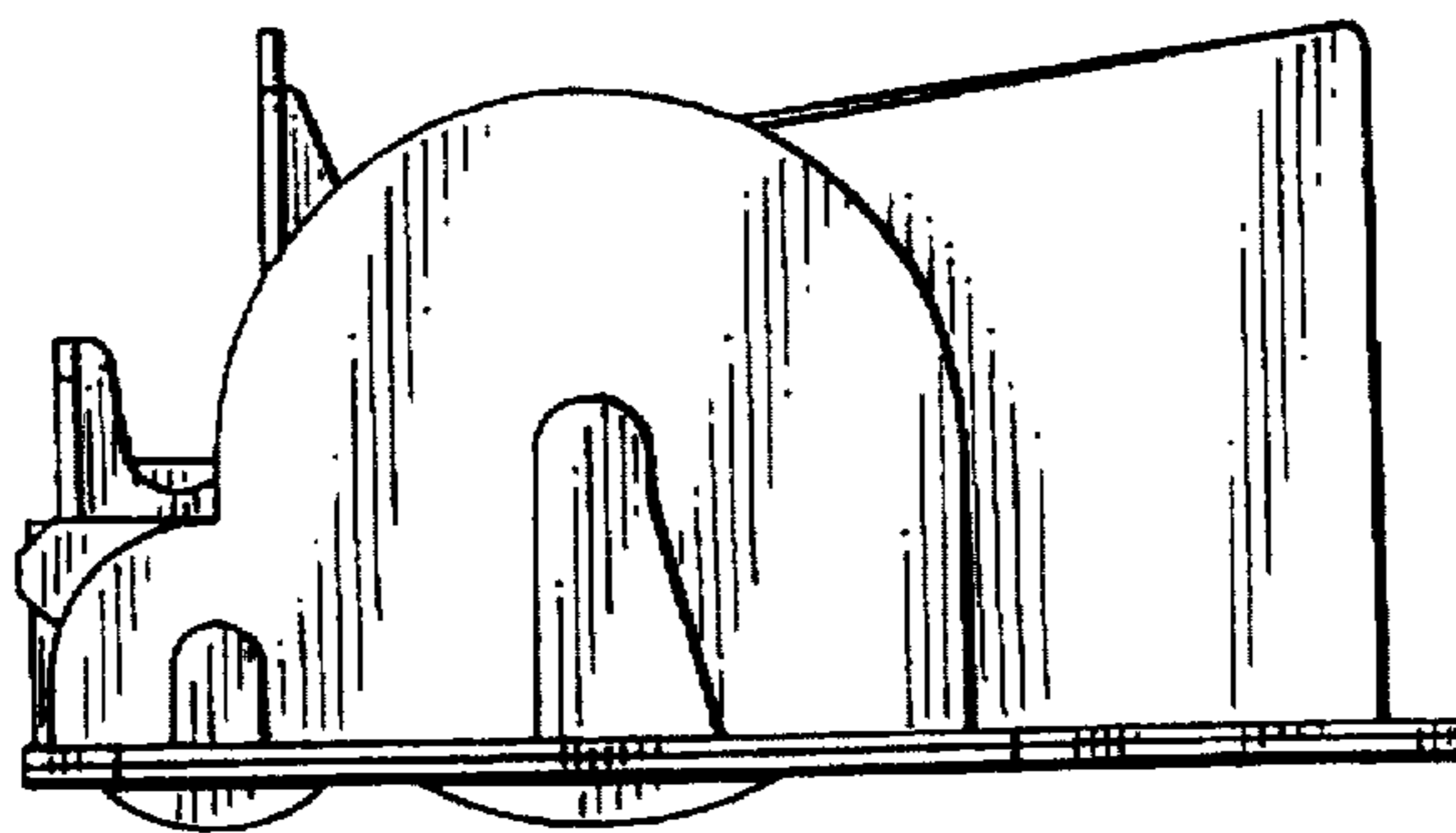

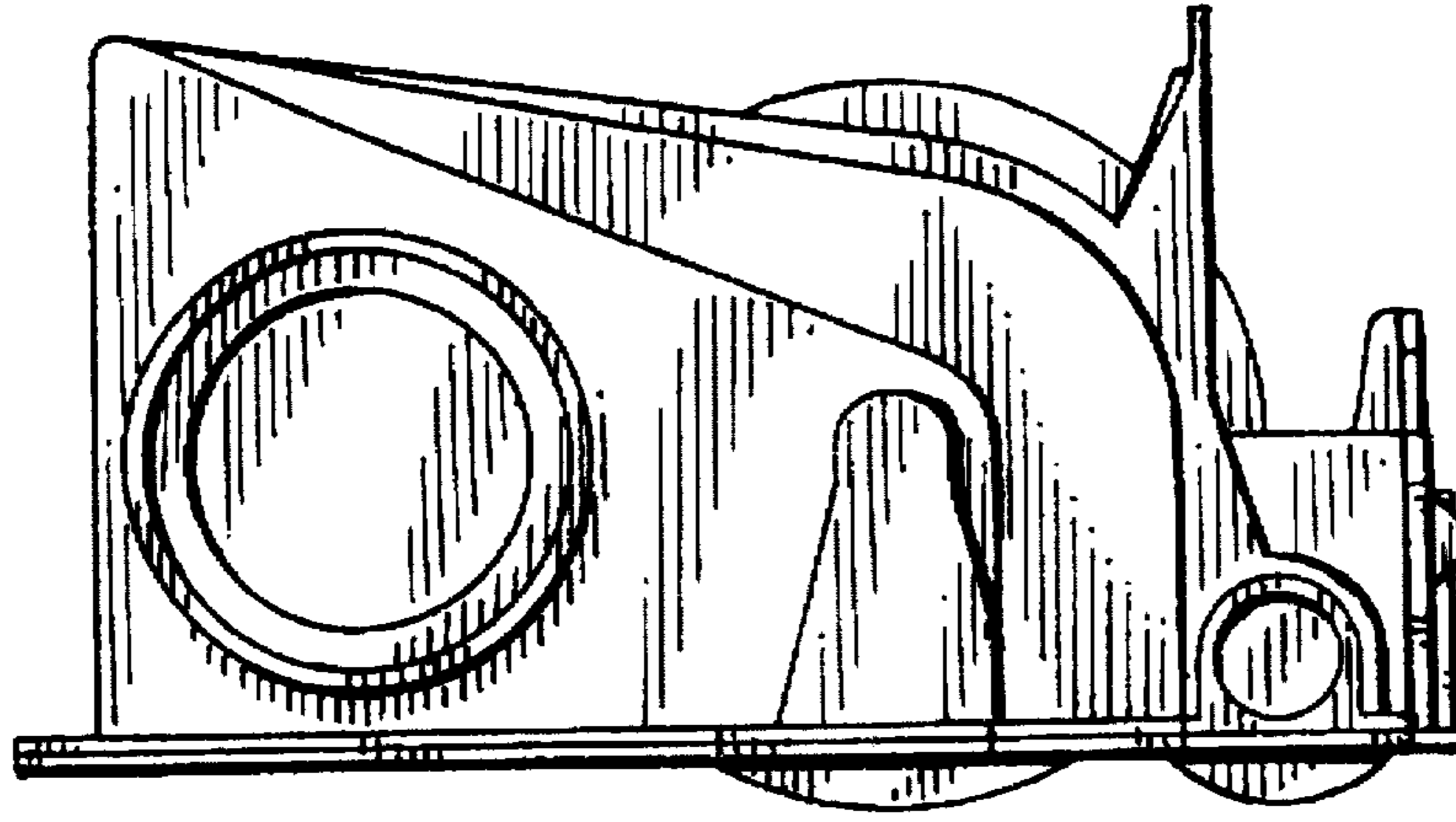

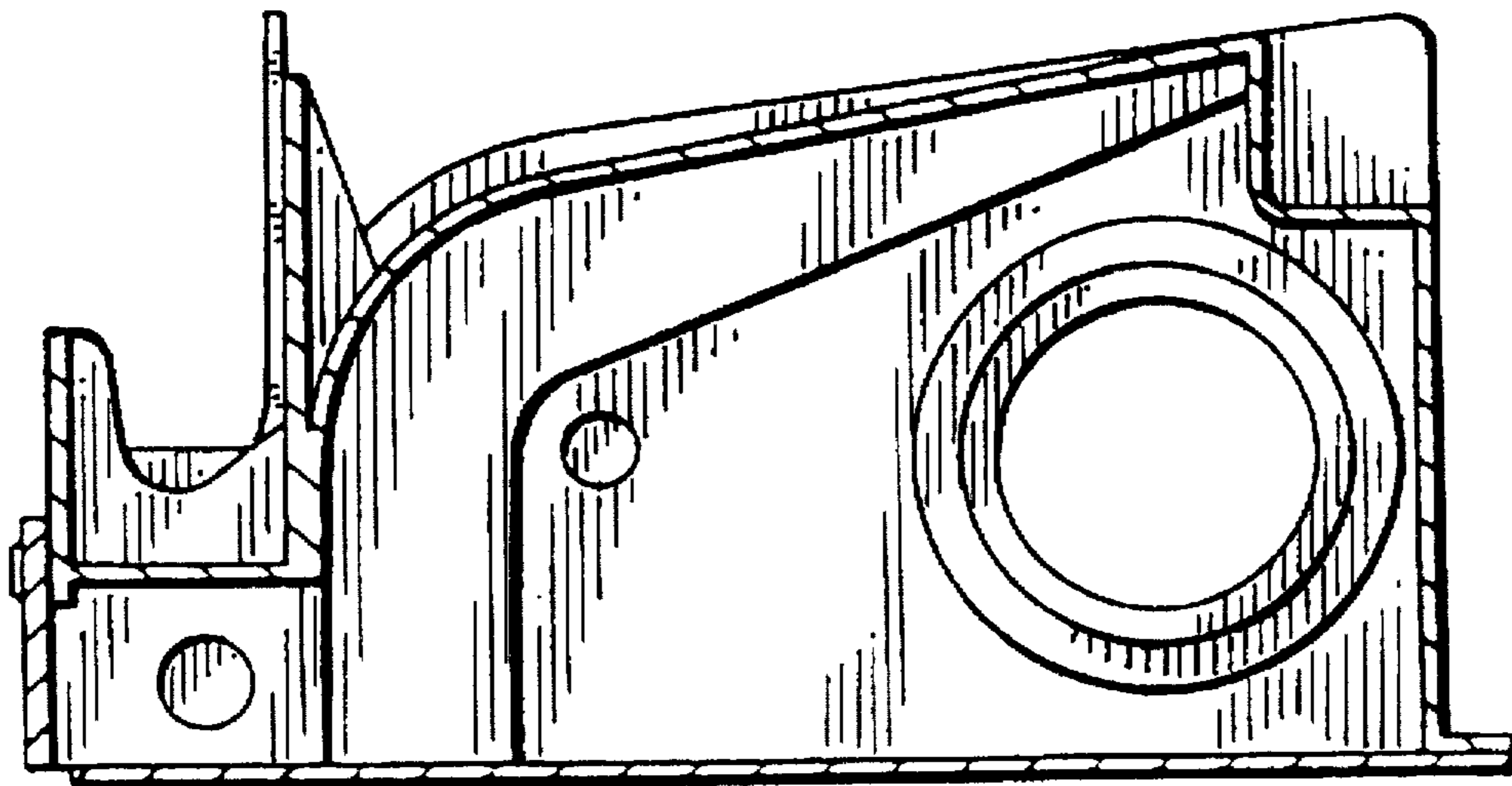

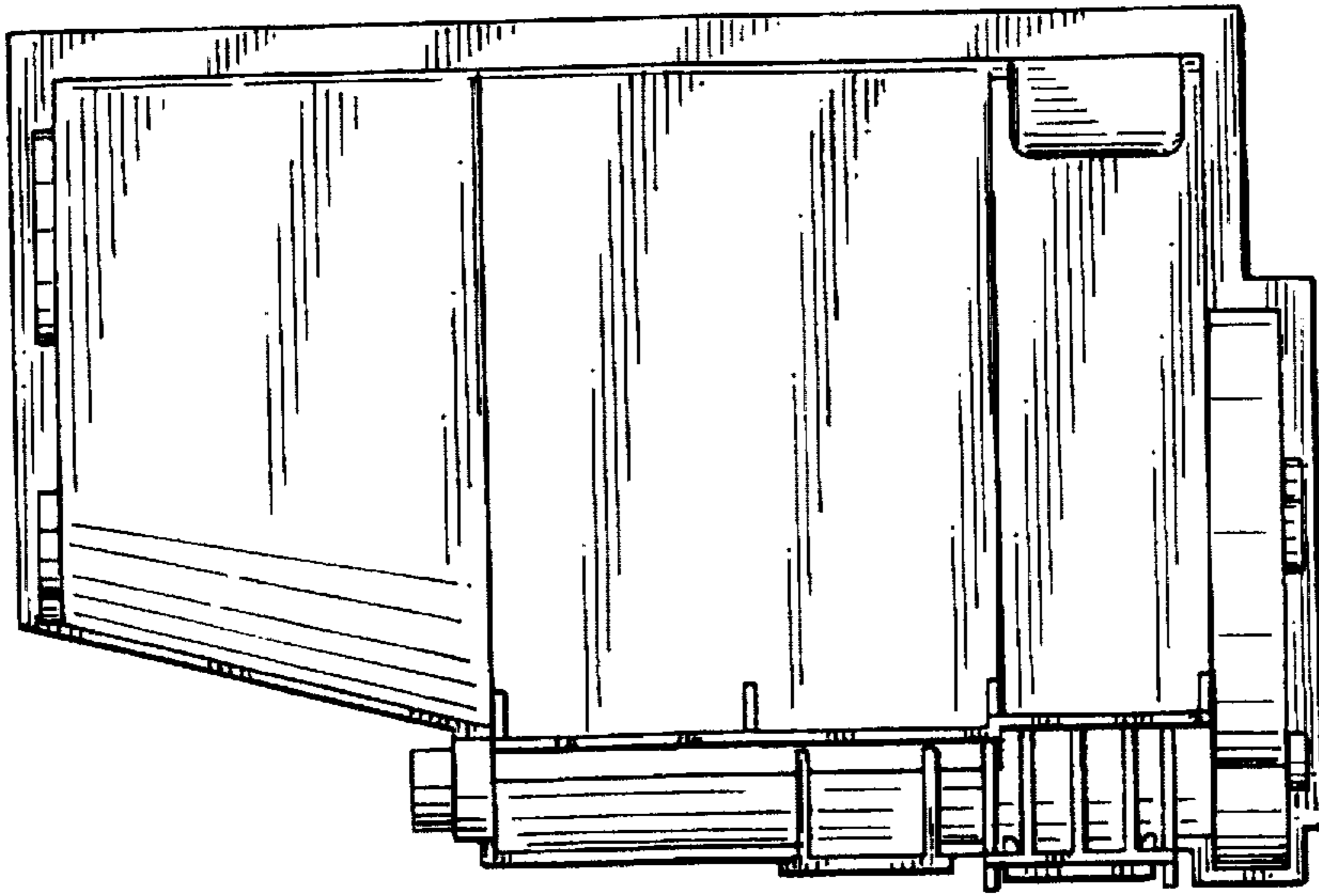

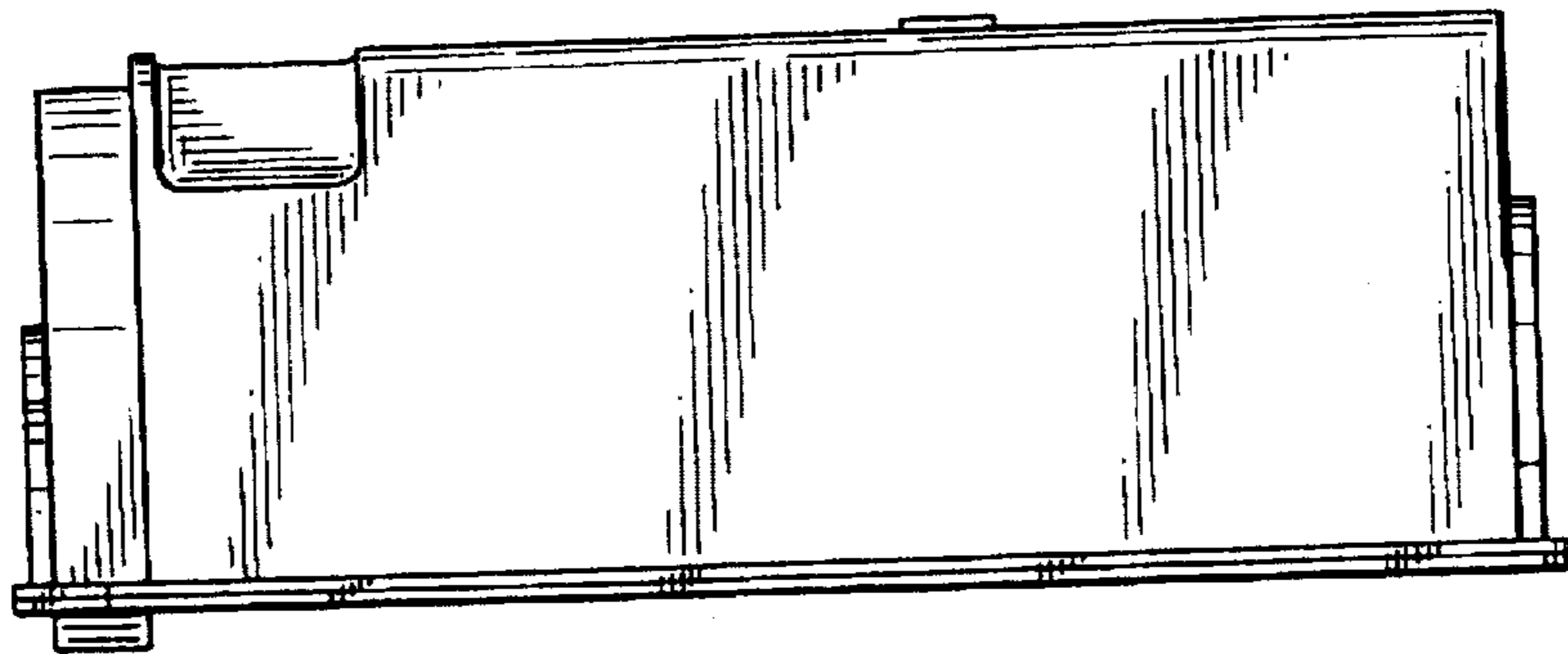
