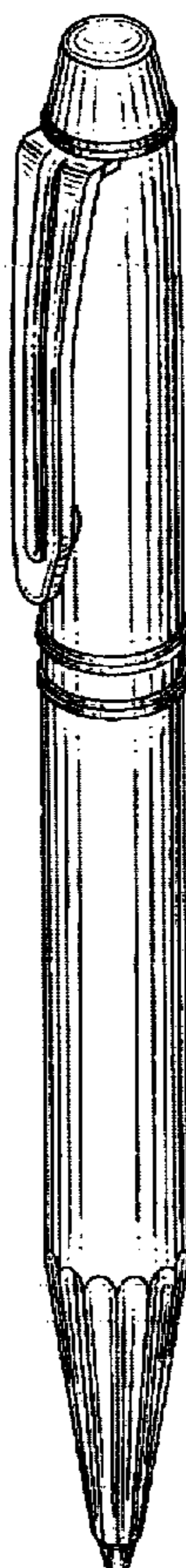
[57] **CLAIM**

The ornamental design for a ball point pen, as shown and described.

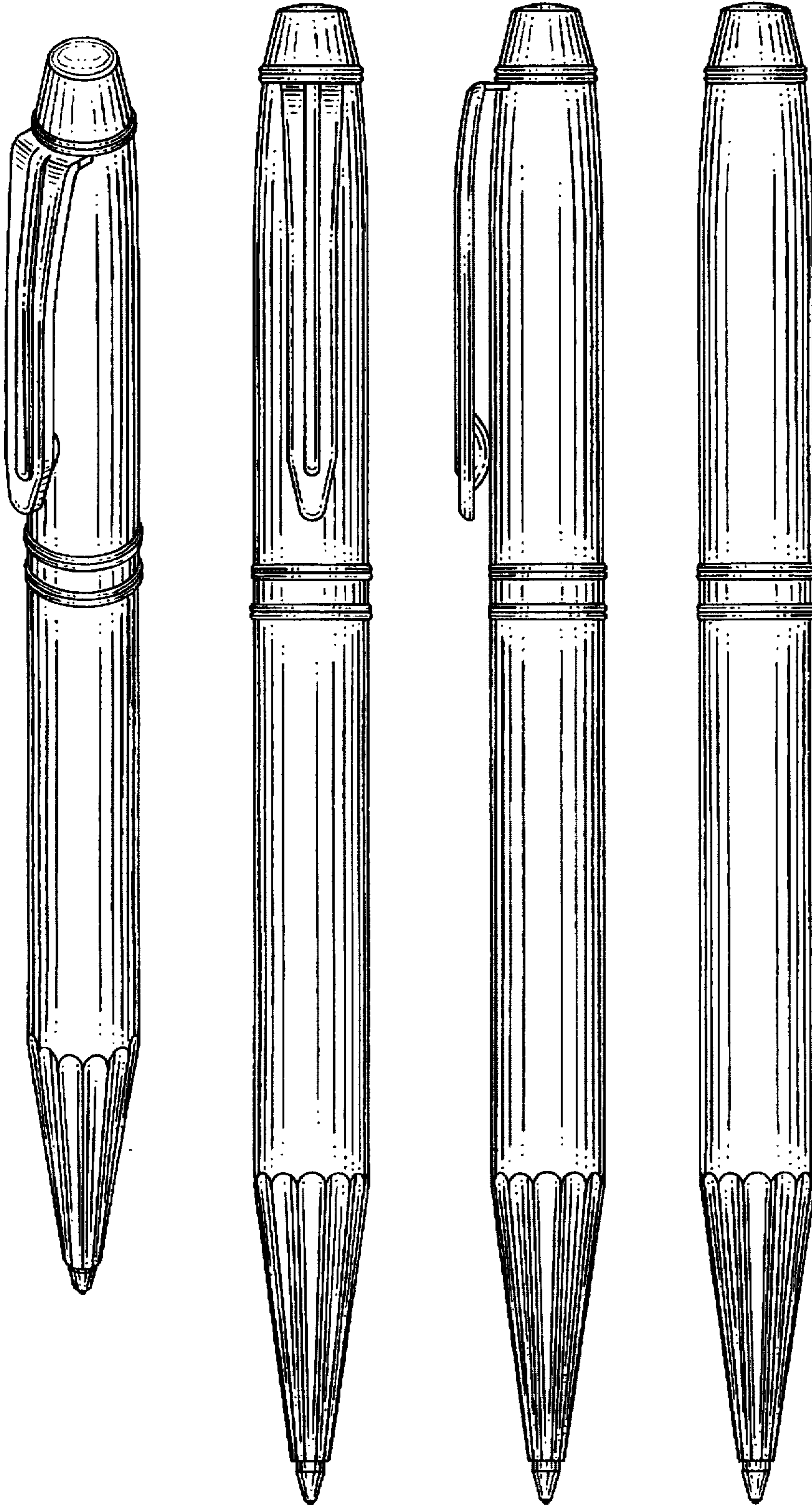
**DESCRIPTION**

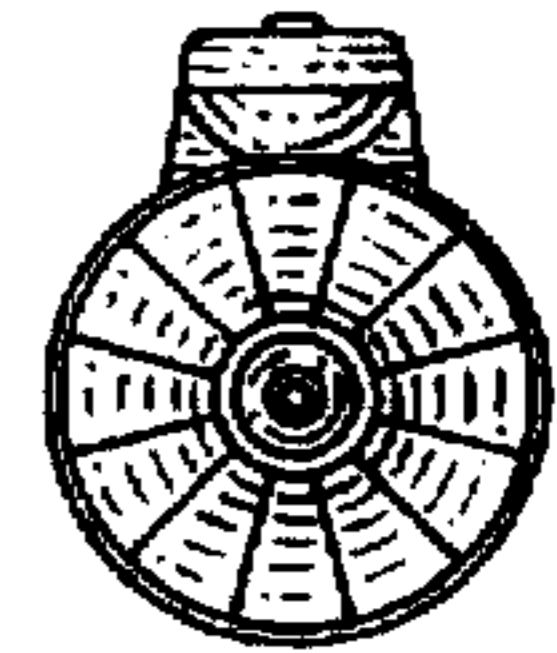
**FIG. 1 FIG. 2 FIG. 3 FIG. 4**

FIG. 1 is a right front perspective view of a ball point pen showing my new design;  
 FIG. 2 is a front elevational view;  
 FIG. 3 is a right side elevational view, the left side being a mirror image thereof;  
 FIG. 4 is a rear elevational view;  
 FIG. 5 is a top plan view;  
 FIG. 6 is a bottom plan view;  
 FIG. 7 is a top plan view of the cap member with the pen body removed for convenience of illustration;  
 FIG. 8 is a bottom plan view of FIG. 7;  
 FIG. 9 is a front elevational view of FIG. 7;  
 FIG. 10 is a right side elevational view of FIG. 7, the left side being a mirror image thereof;  
 FIG. 11 is a rear elevational view of FIG. 7;  
 FIG. 12 is a cross-sectional view of FIG. 7 taken along arrows 12—12 in FIG. 9;  
 FIG. 13 is a front elevational view of FIG. 1 with the writing tip retracted; and,  
 FIG. 14 is a cross-sectional view of FIG. 1 taken on a center vertical line.

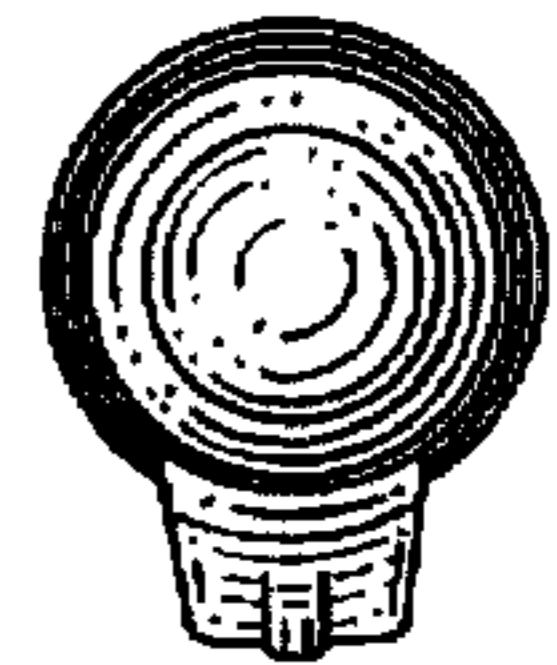

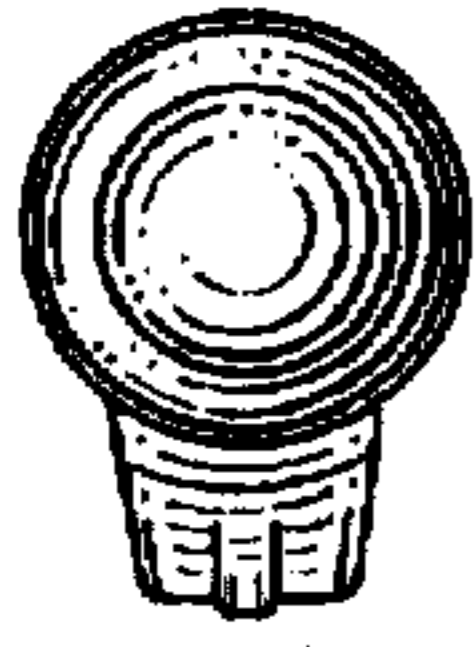

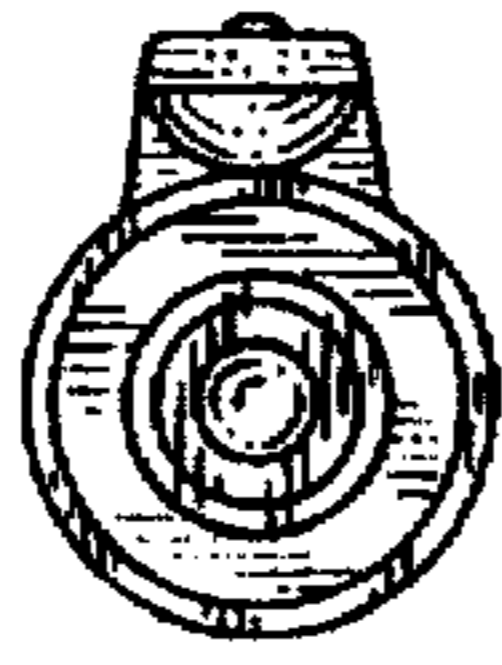

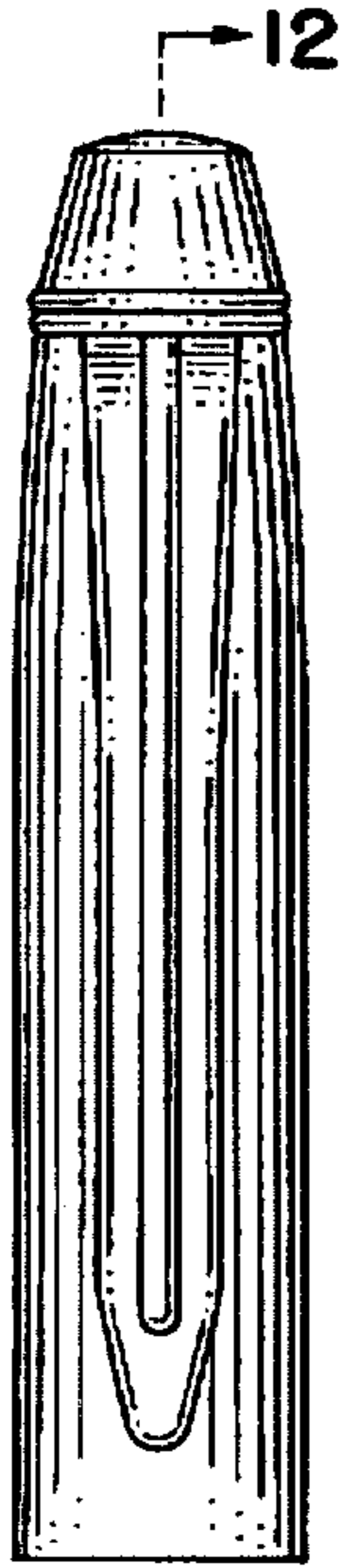

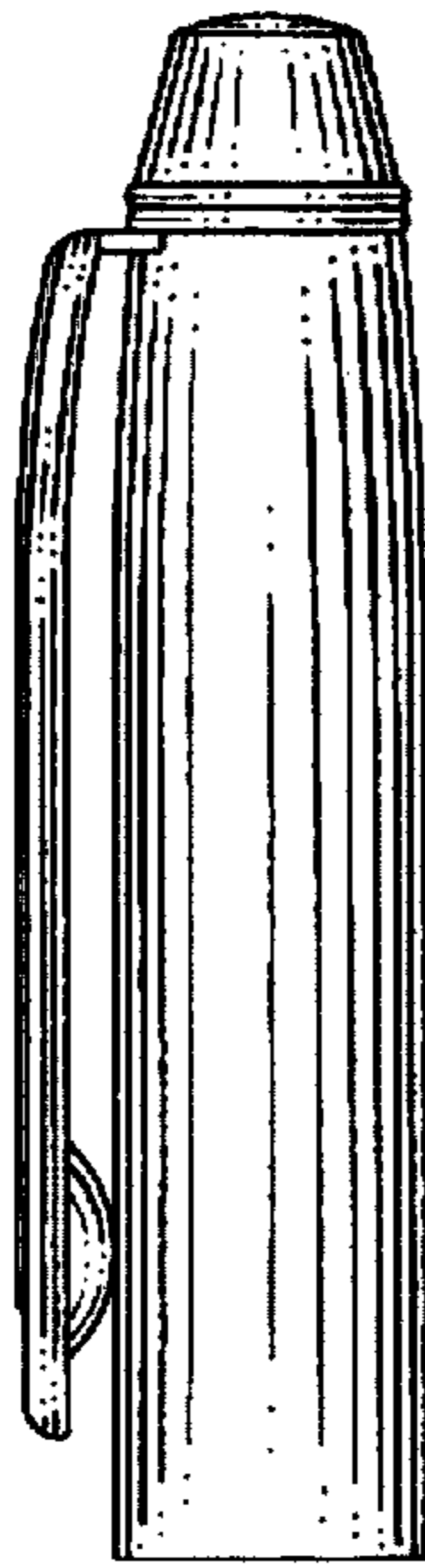

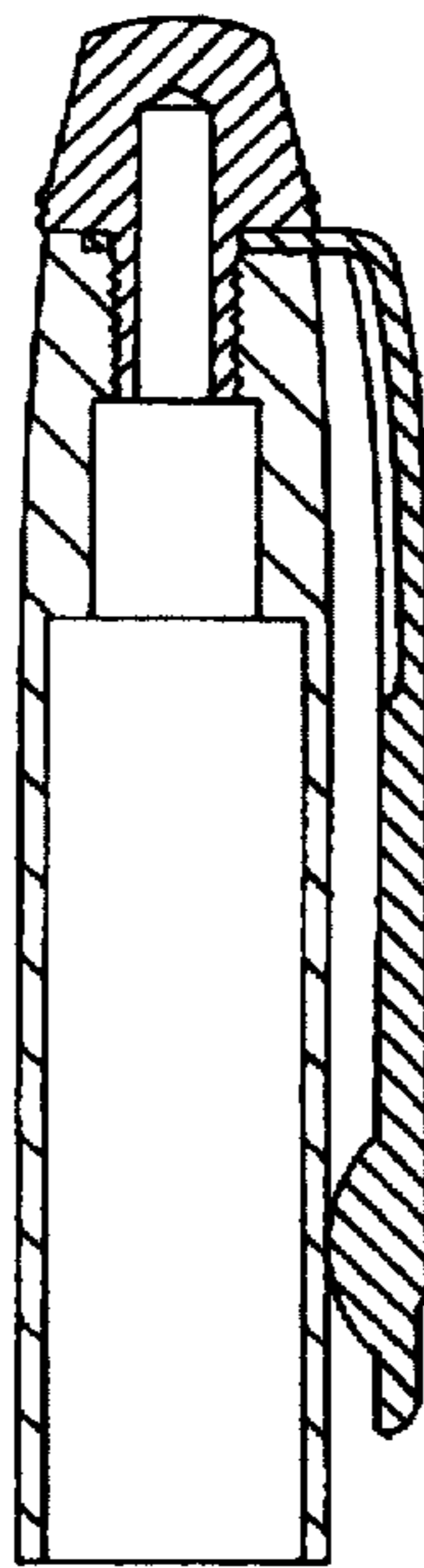
