[57] **CLAIM**

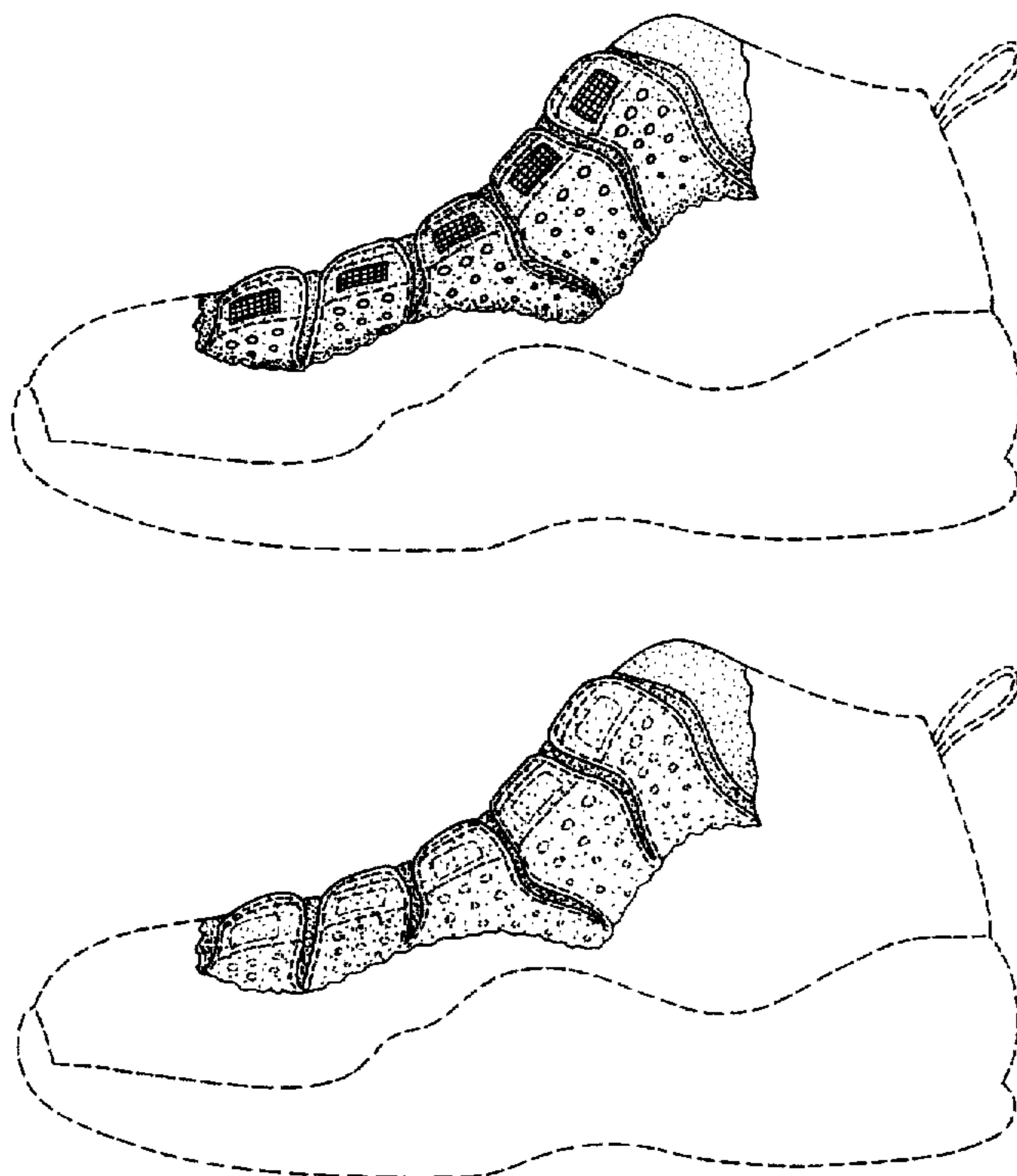
The ornamental design for an element of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a side element of a shoe upper showing my new design;
 FIG. 2 is a front perspective view of the side element of a shoe upper of FIG. 1;
 FIG. 3 is a rear perspective view of the side element of a shoe upper of FIG. 1;
 FIG. 4 is a top plan view of the side element of a shoe upper of FIG. 1;
 FIG. 5 is a side elevational view of a side element of a shoe upper showing another embodiment of my new design;
 FIG. 6 is a front perspective view of the side element of a shoe upper of FIG. 5;
 FIG. 7 is a rear perspective view of the side element of a shoe upper of FIG. 5; and,
 FIG. 8 is a top plan view of the side element of a shoe upper of FIG. 5.

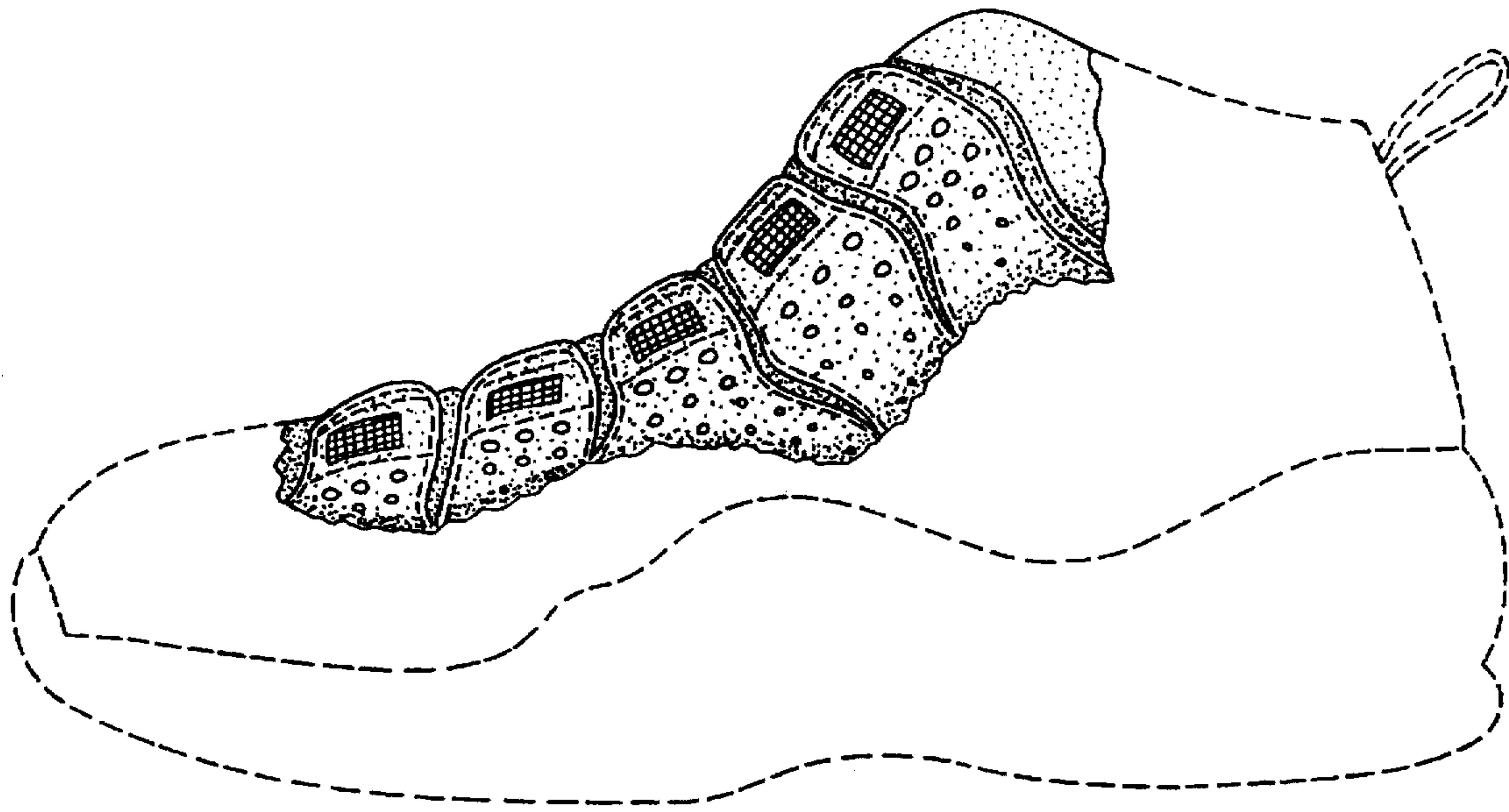

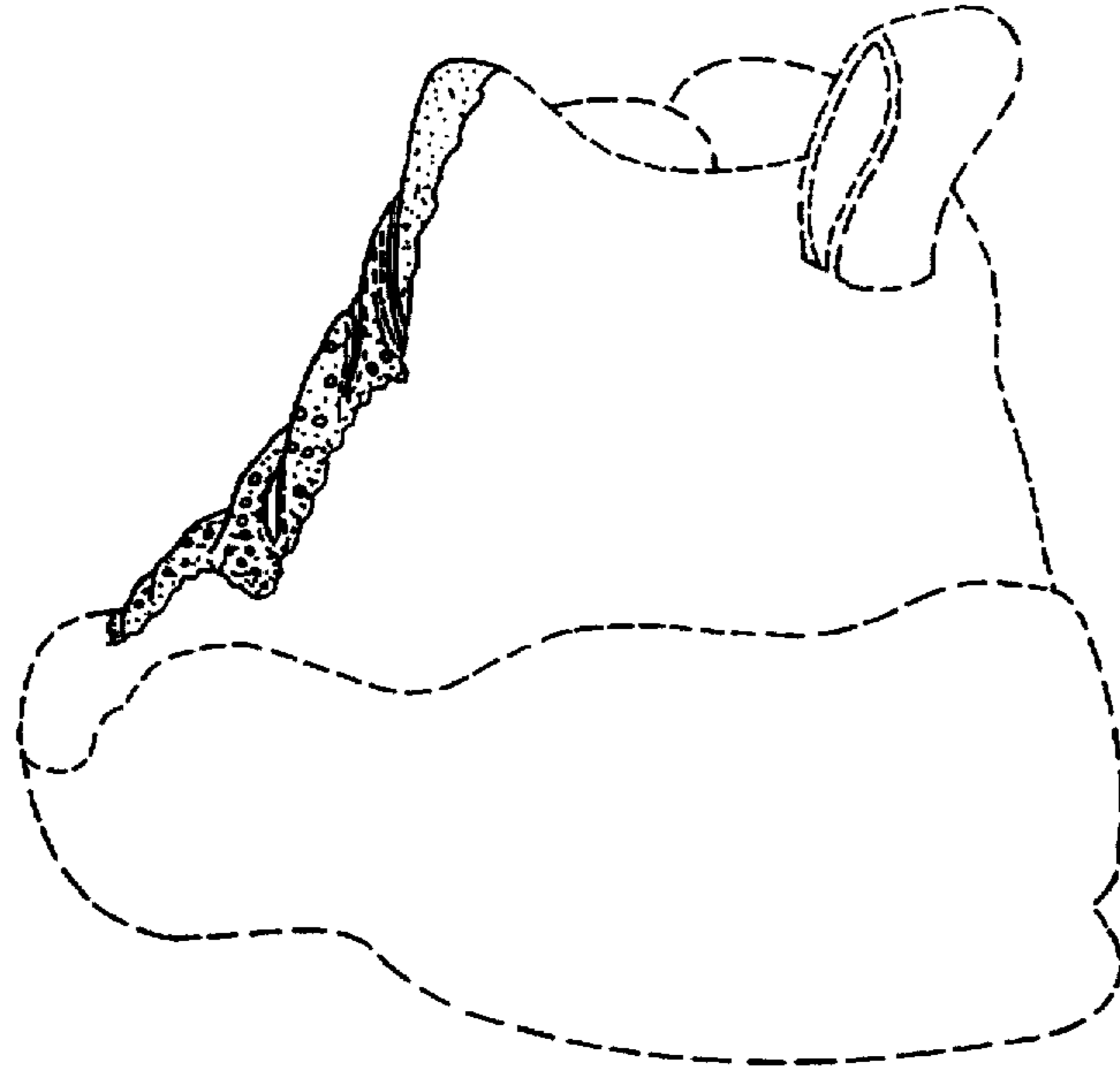

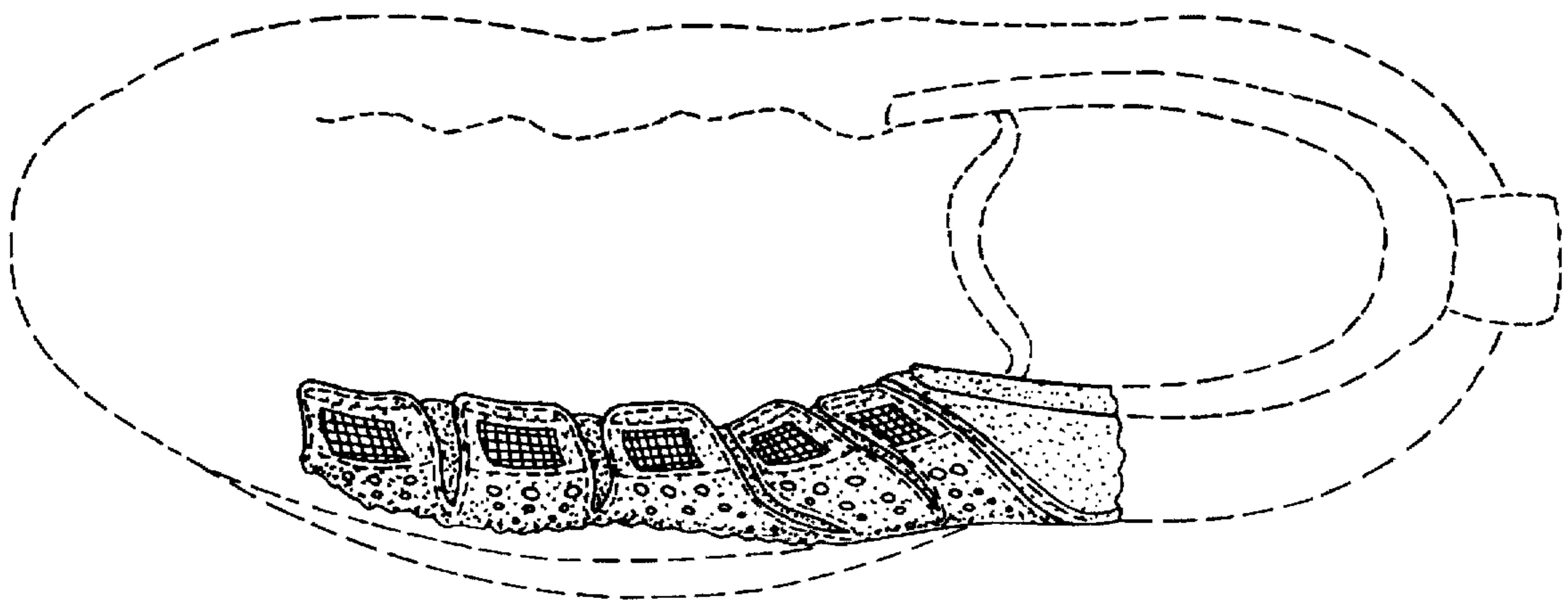

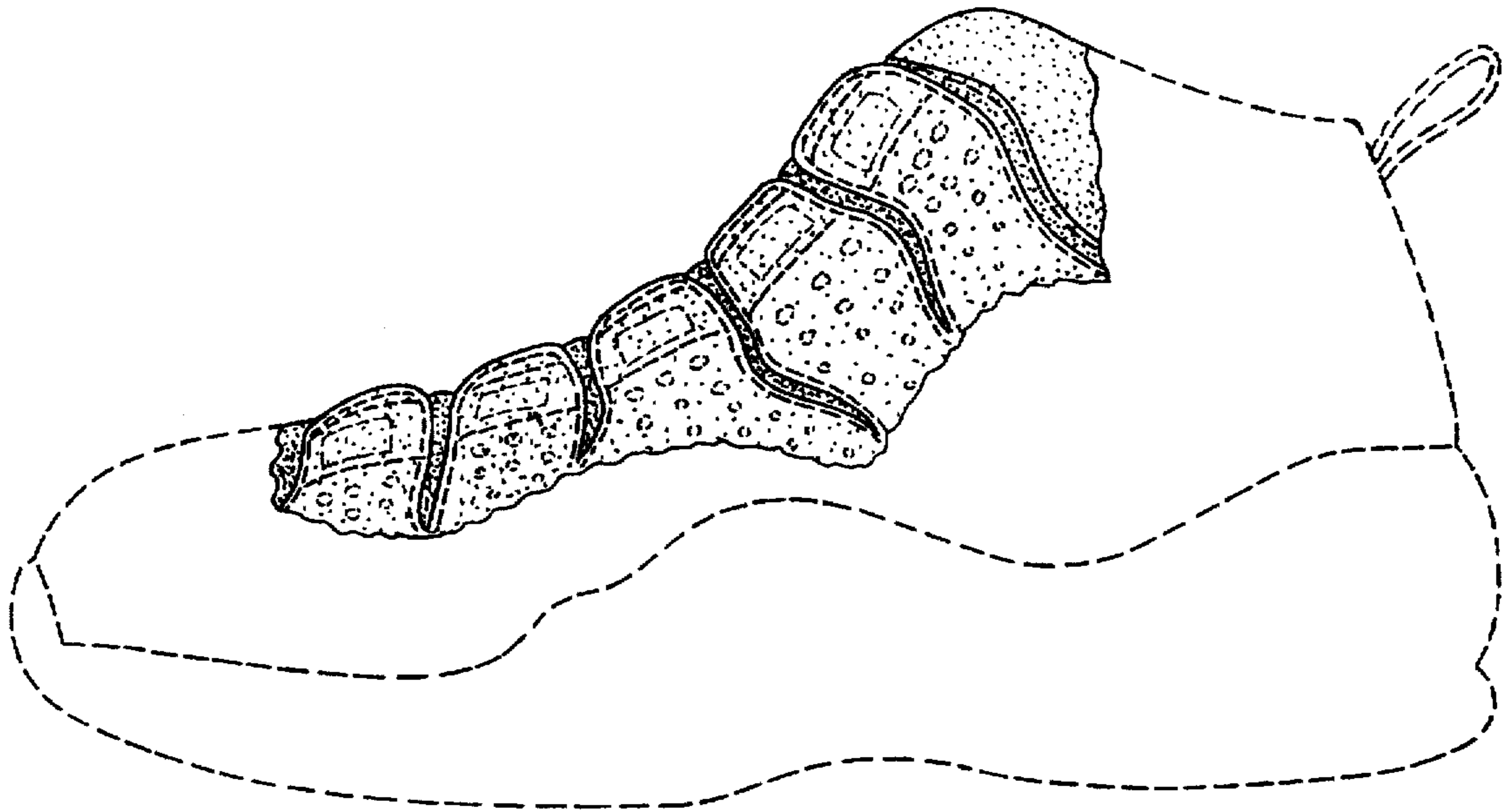

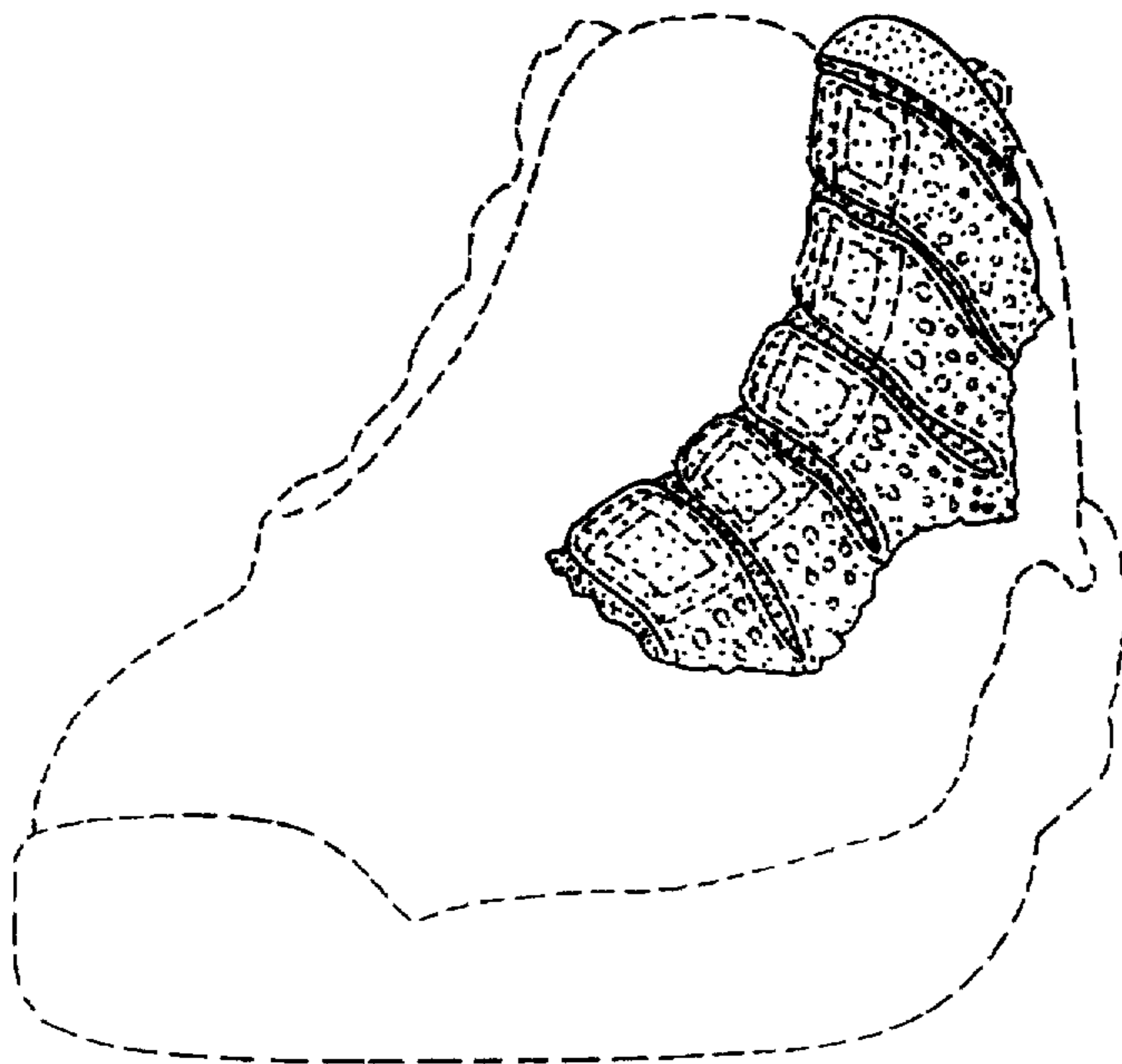

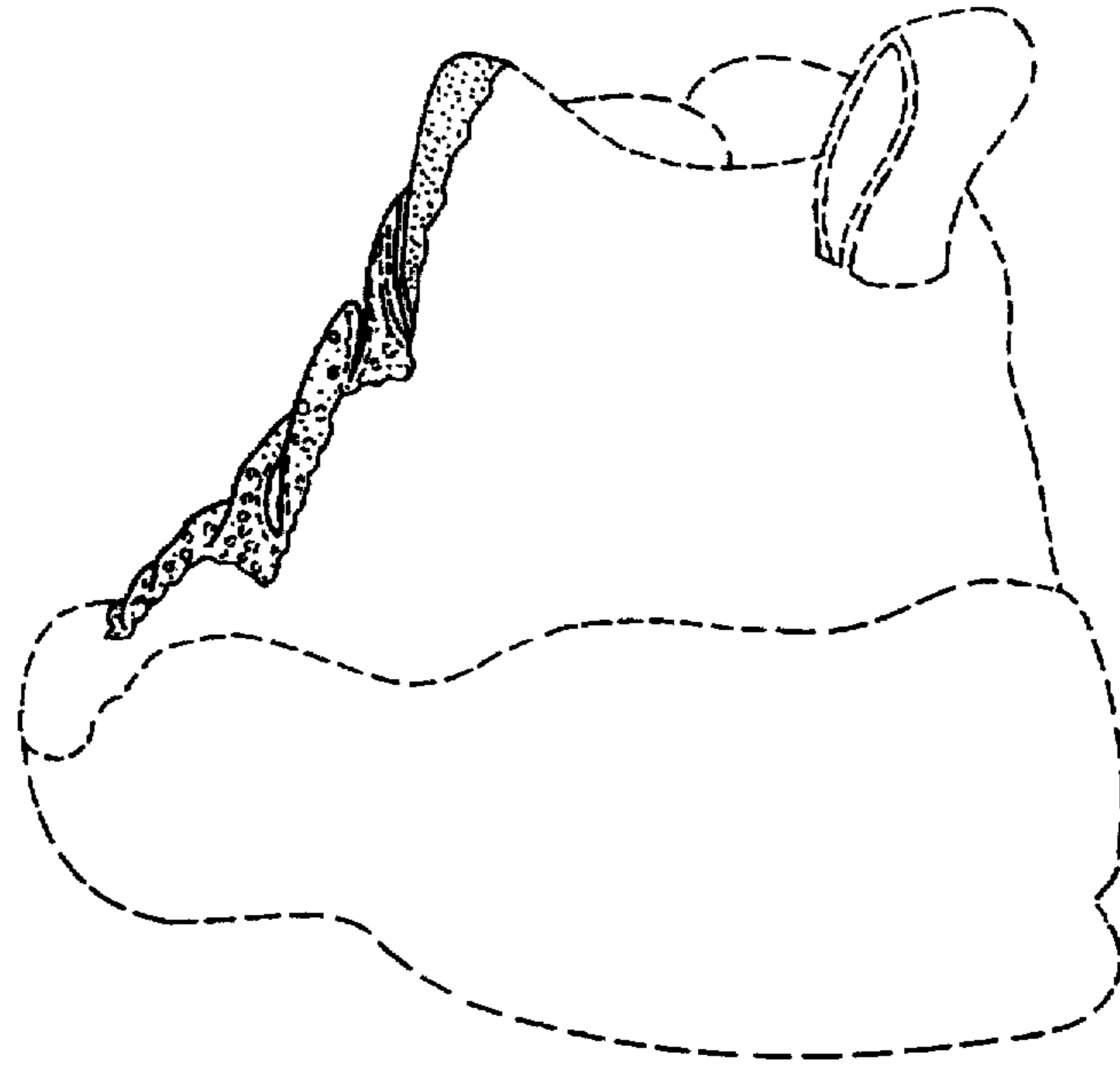

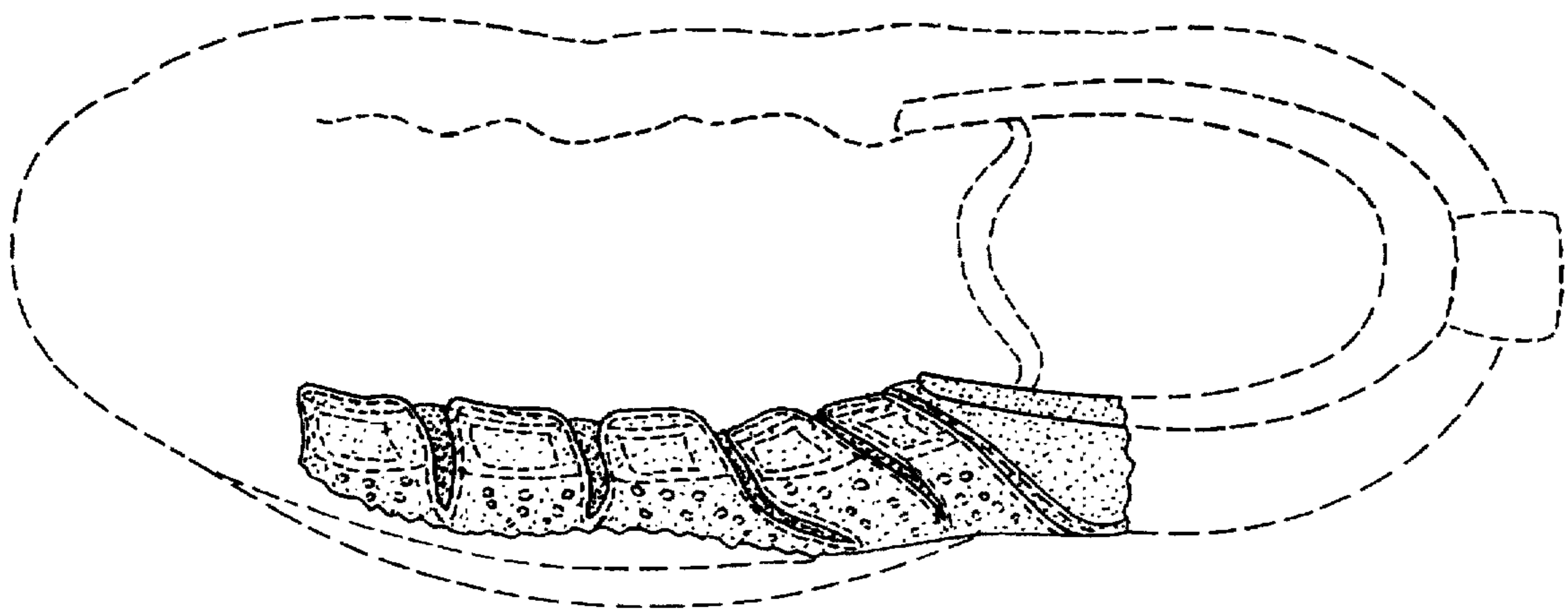
