The ornamental design for an upright support for shelves or the like, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an upright support for shelves or the like showing my new design;

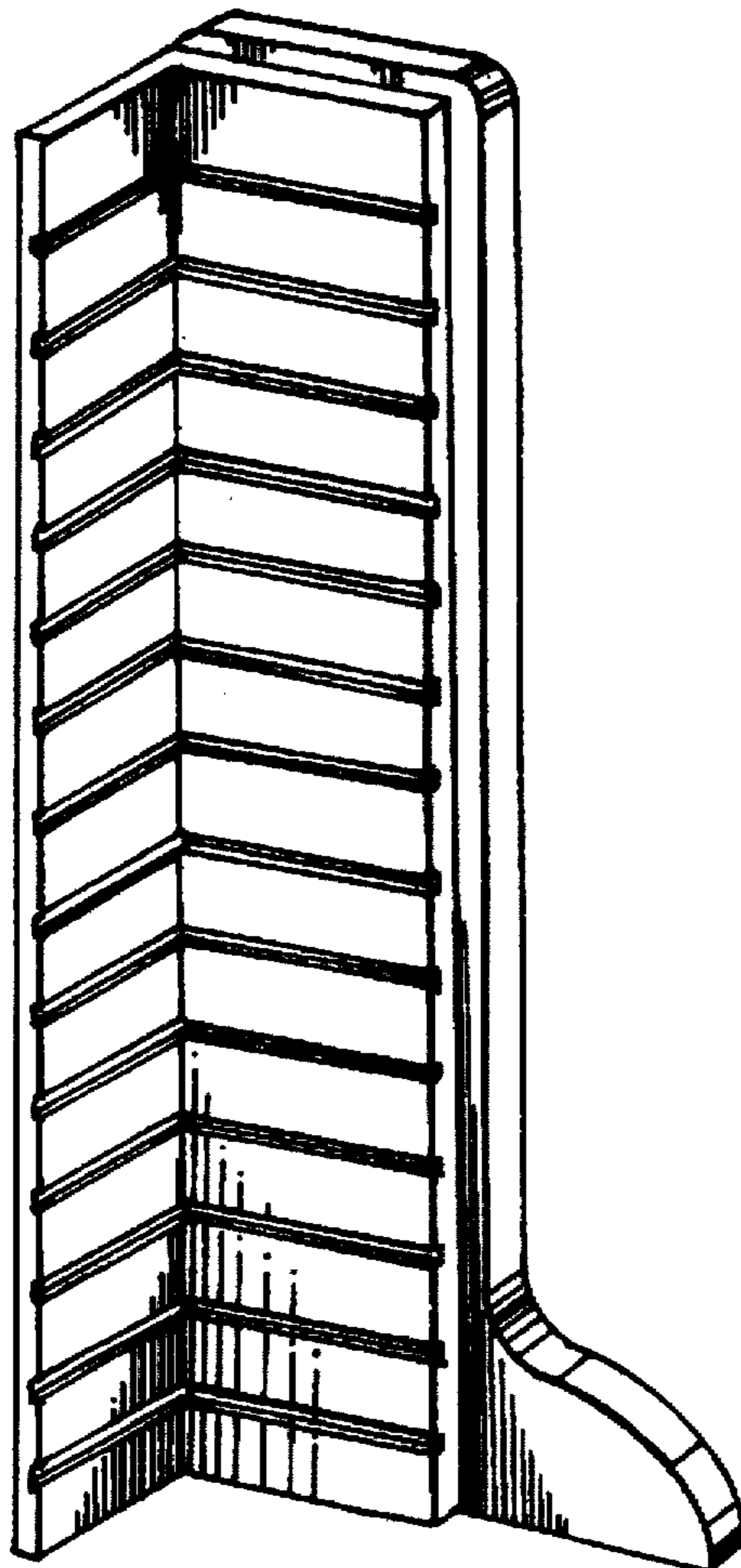

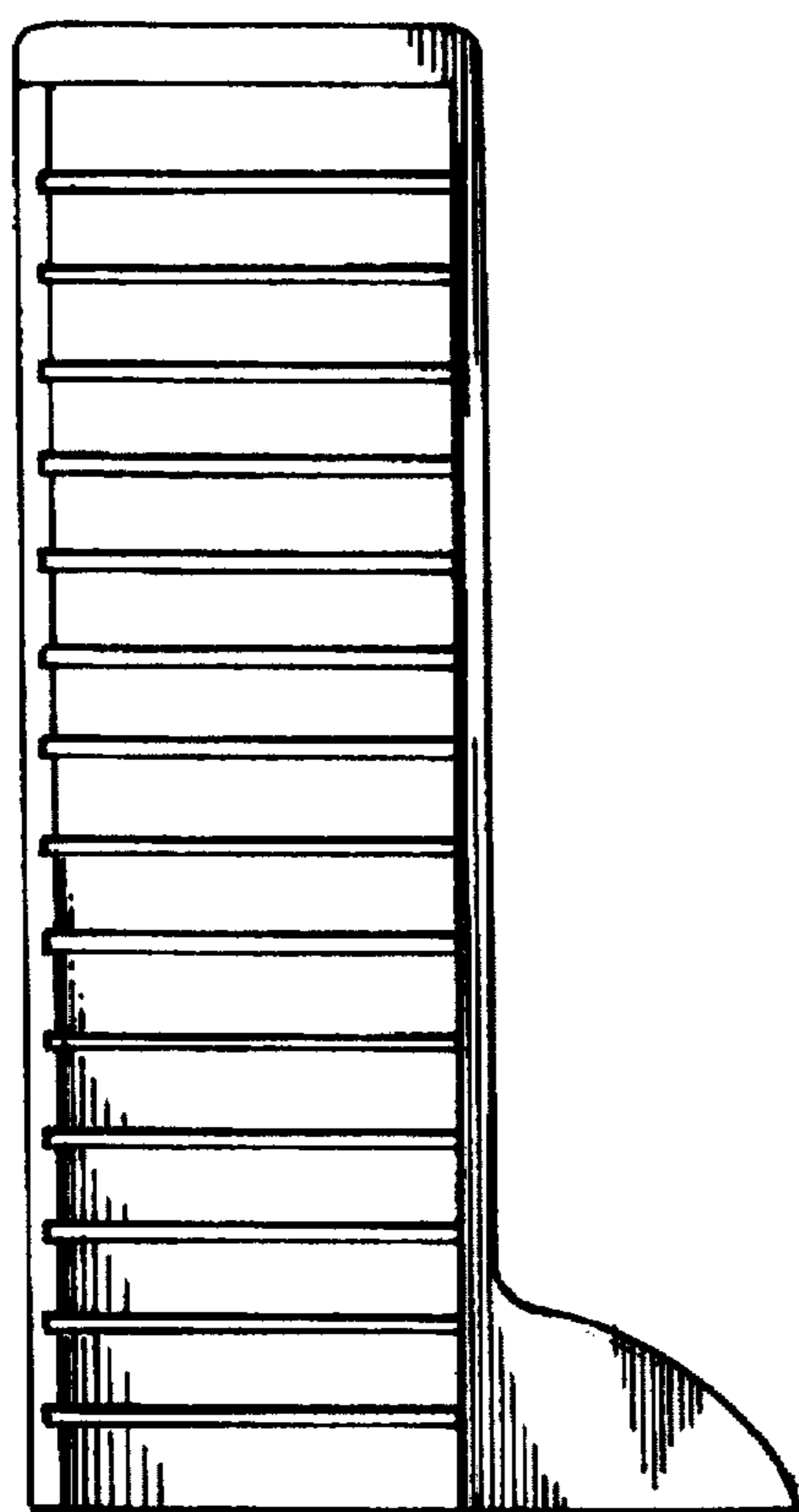
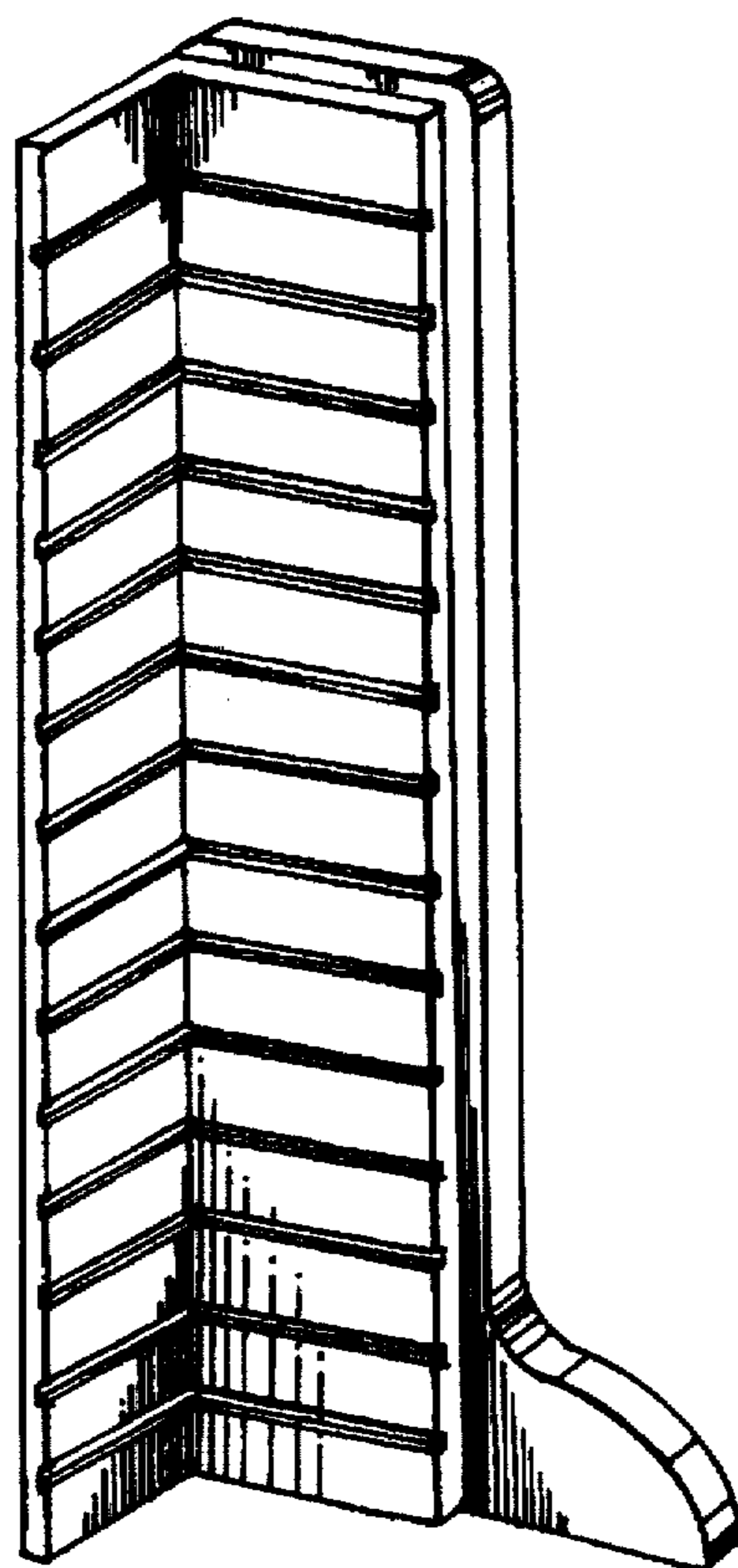

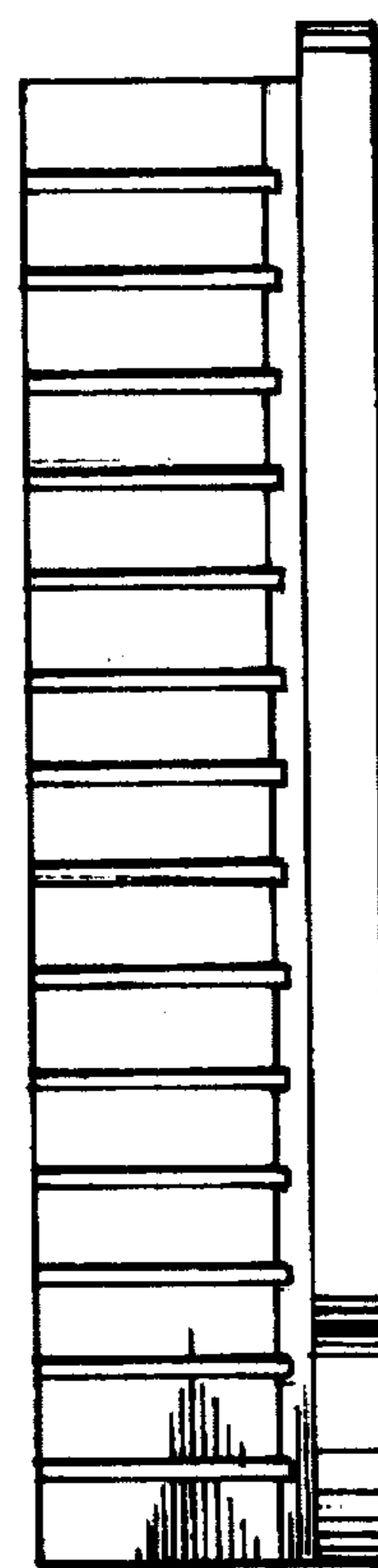

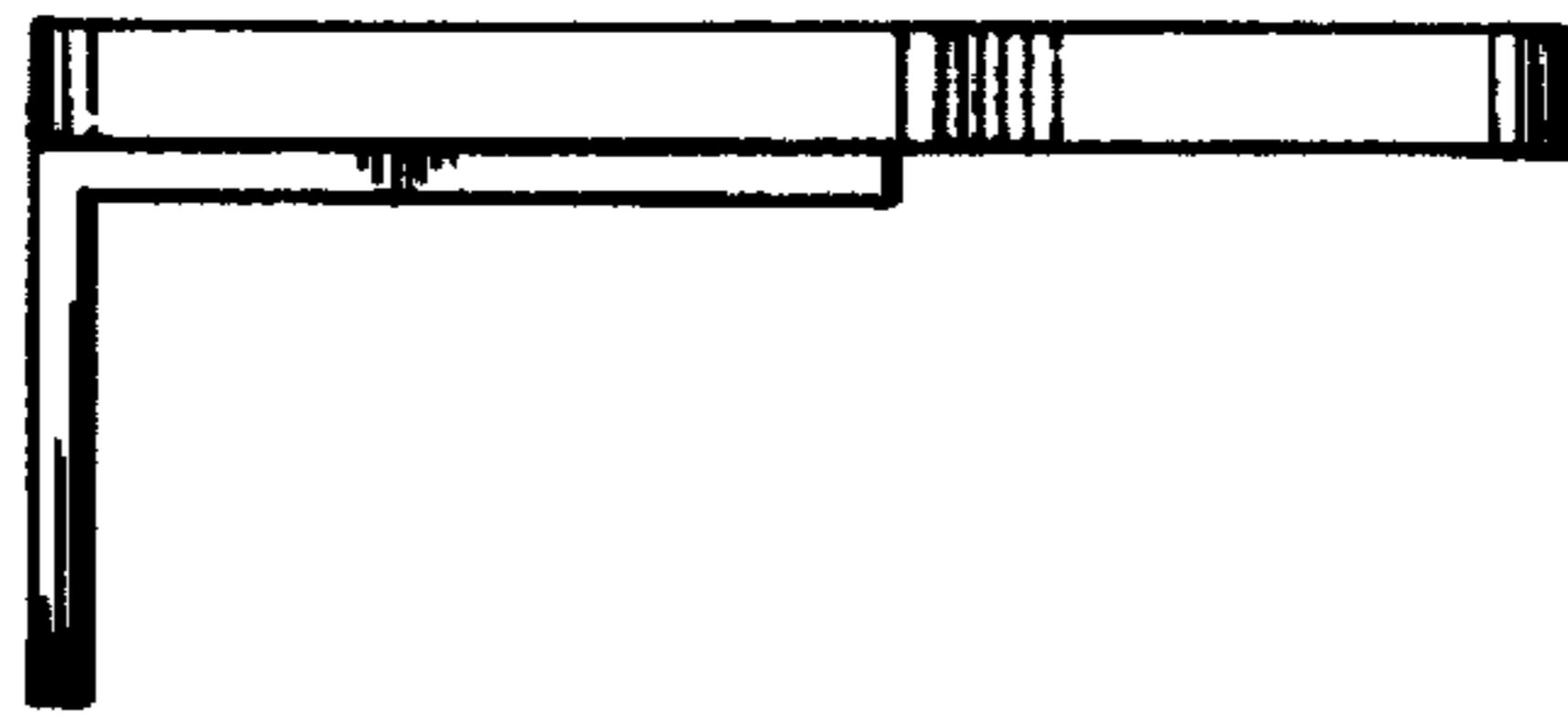

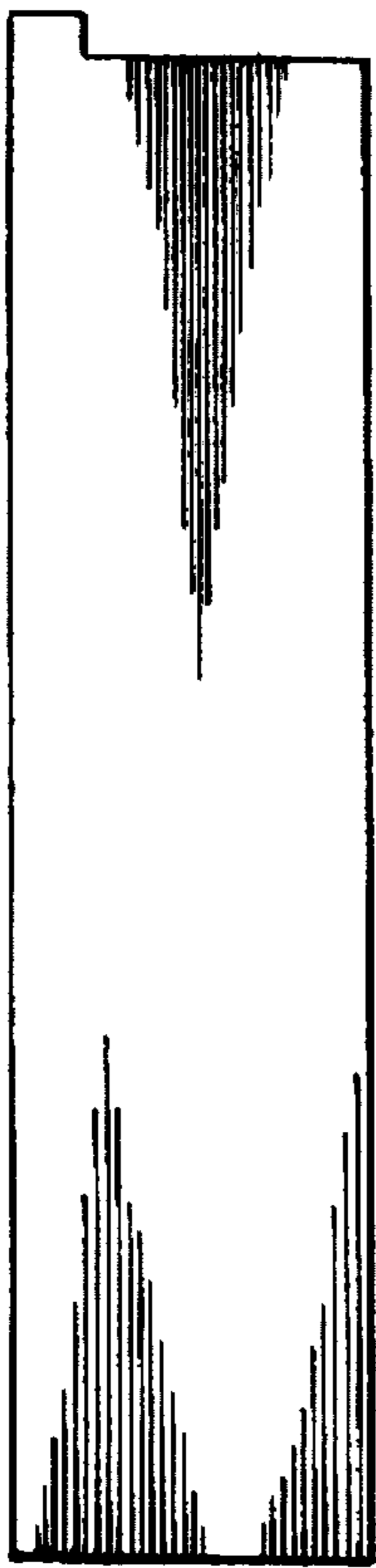

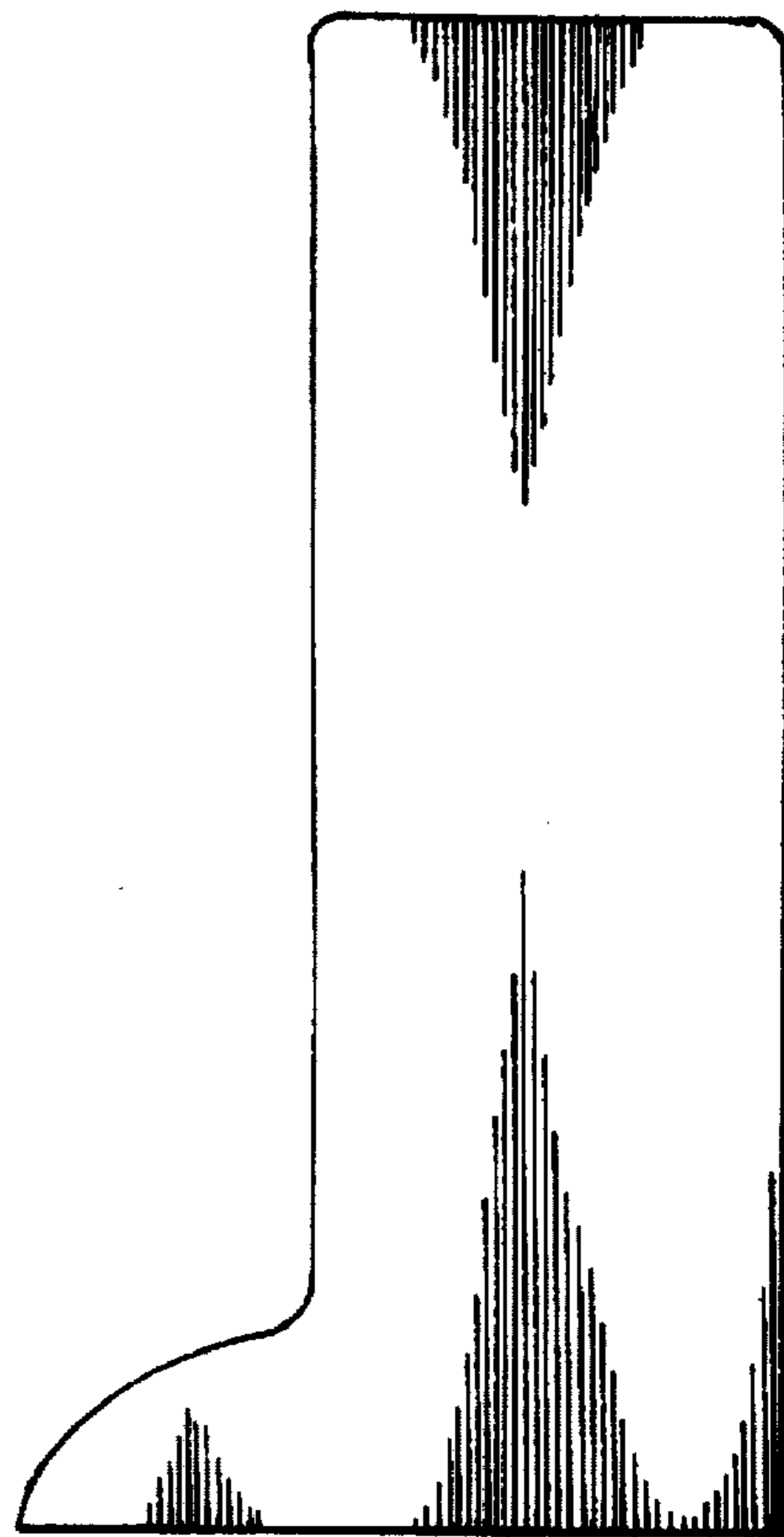
