The ornamental design for a container with cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a container with cap showing my new design;  
FIG. 2 is an exploded right side elevational view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is an exploded front perspective view thereof;  
FIG. 5 is an exploded rear elevational view thereof; and,  
FIG. 6 is a plan view of the top portion of the container base.

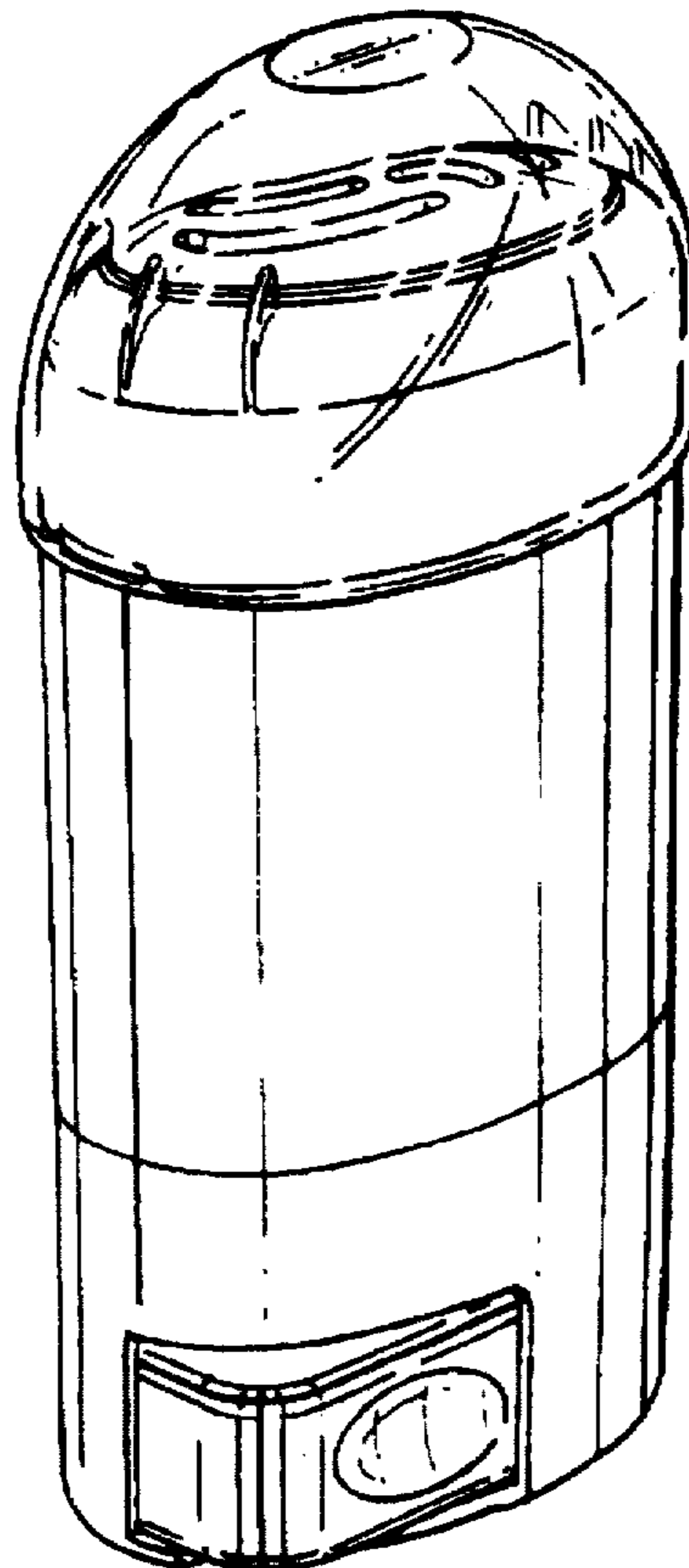

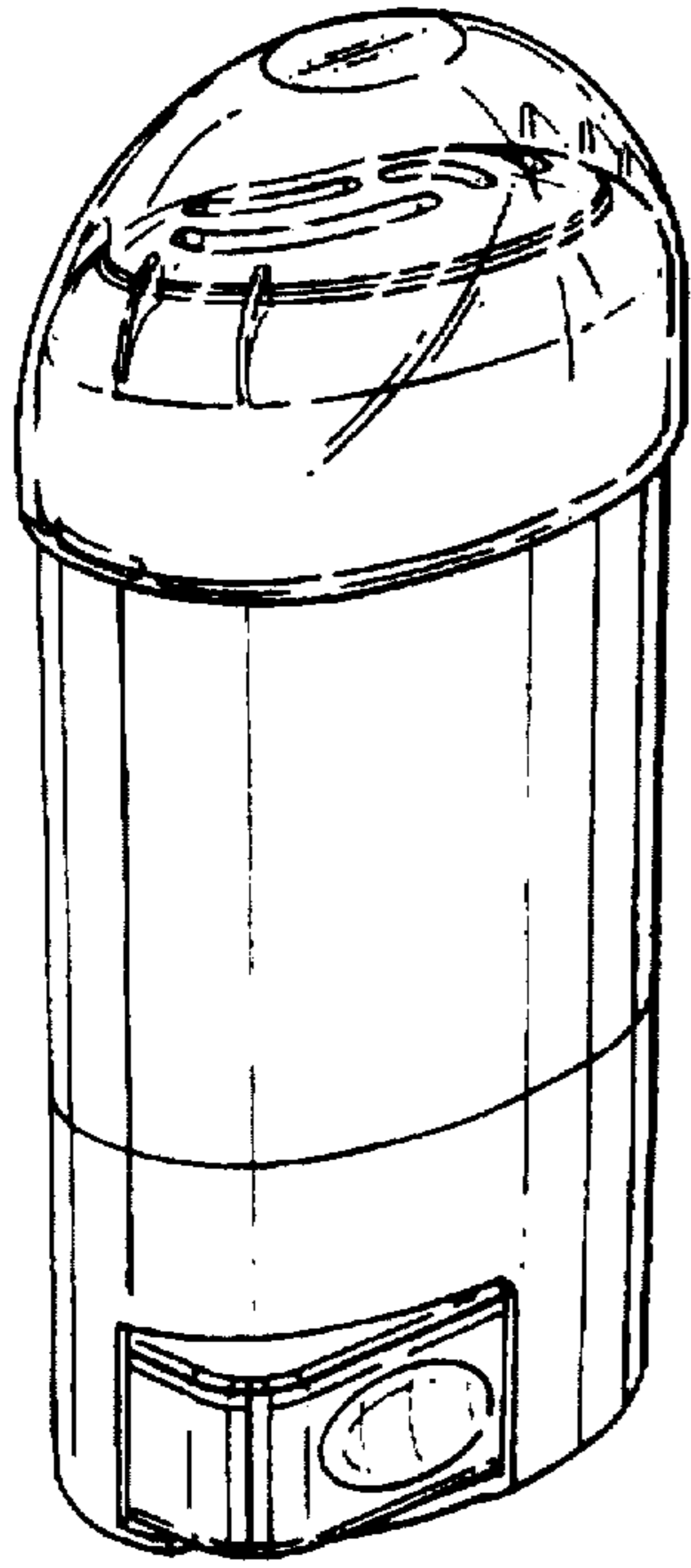

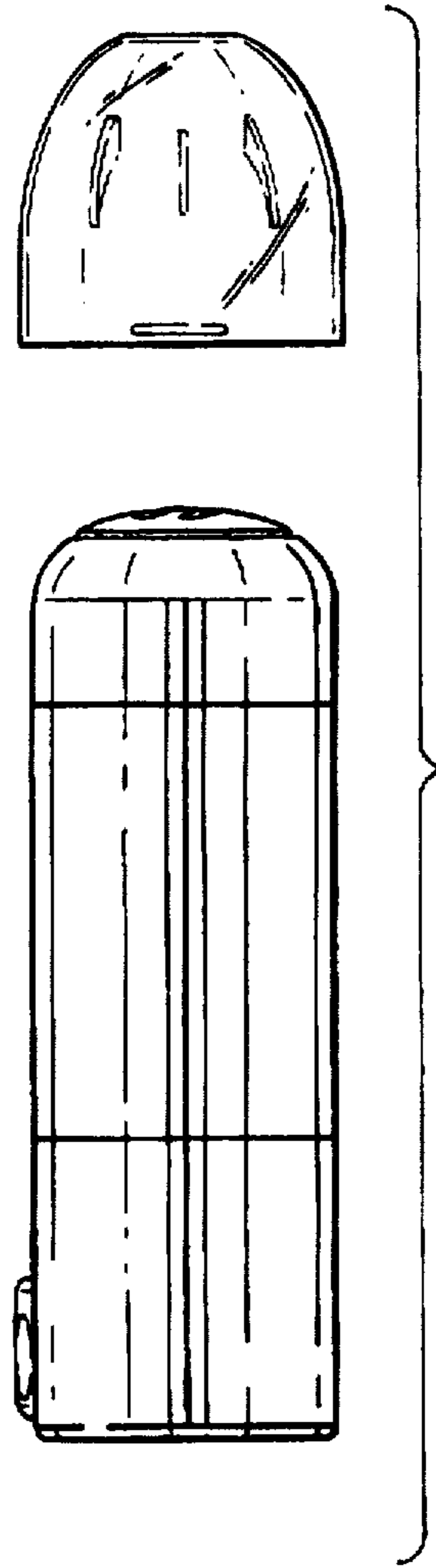

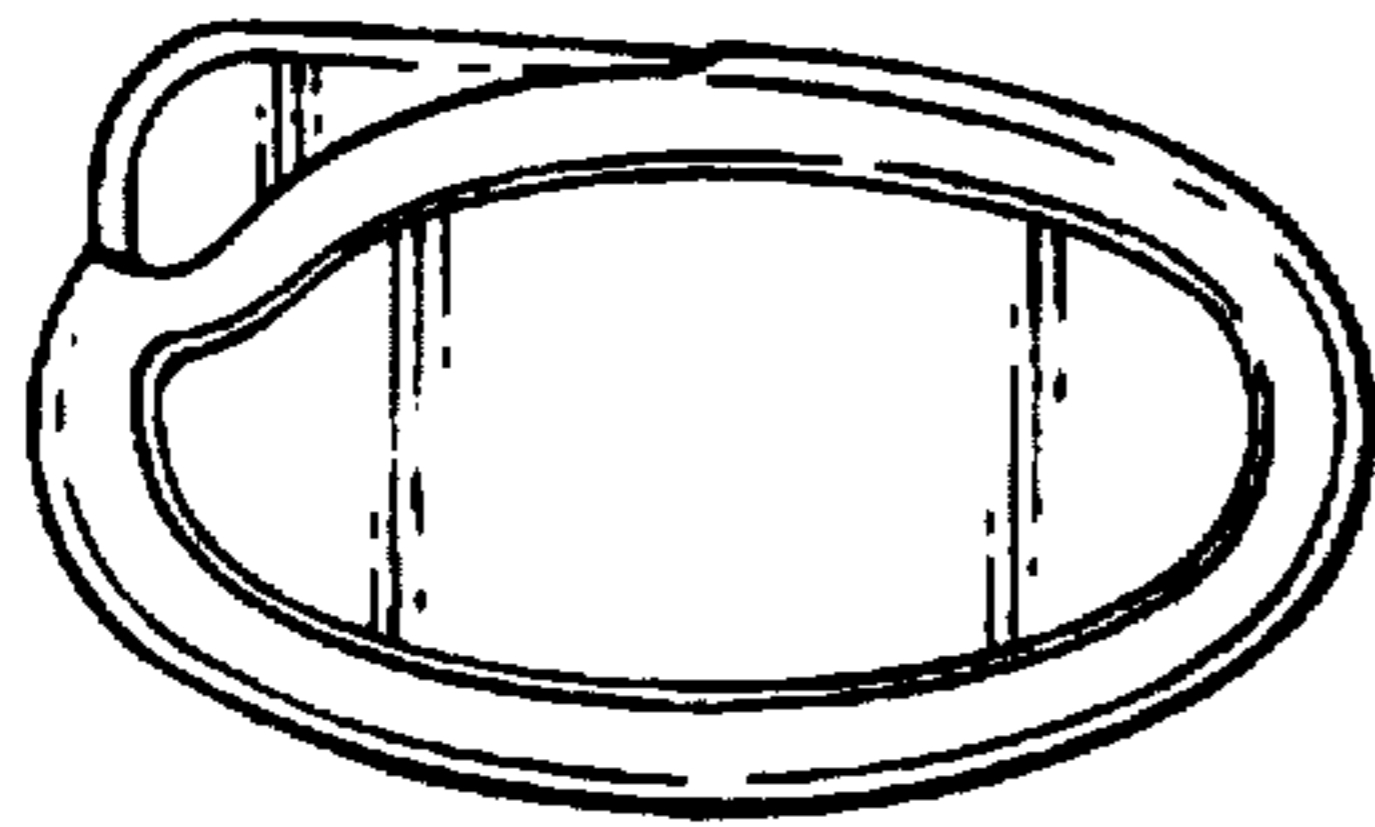

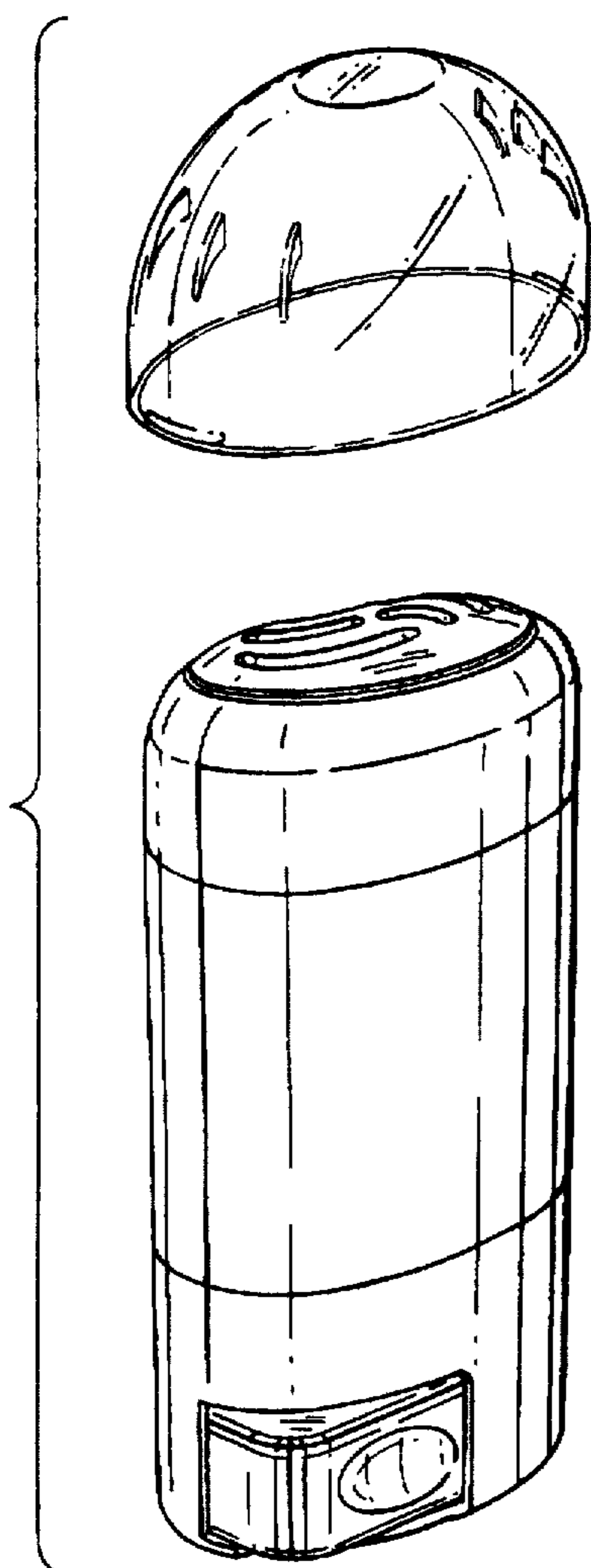

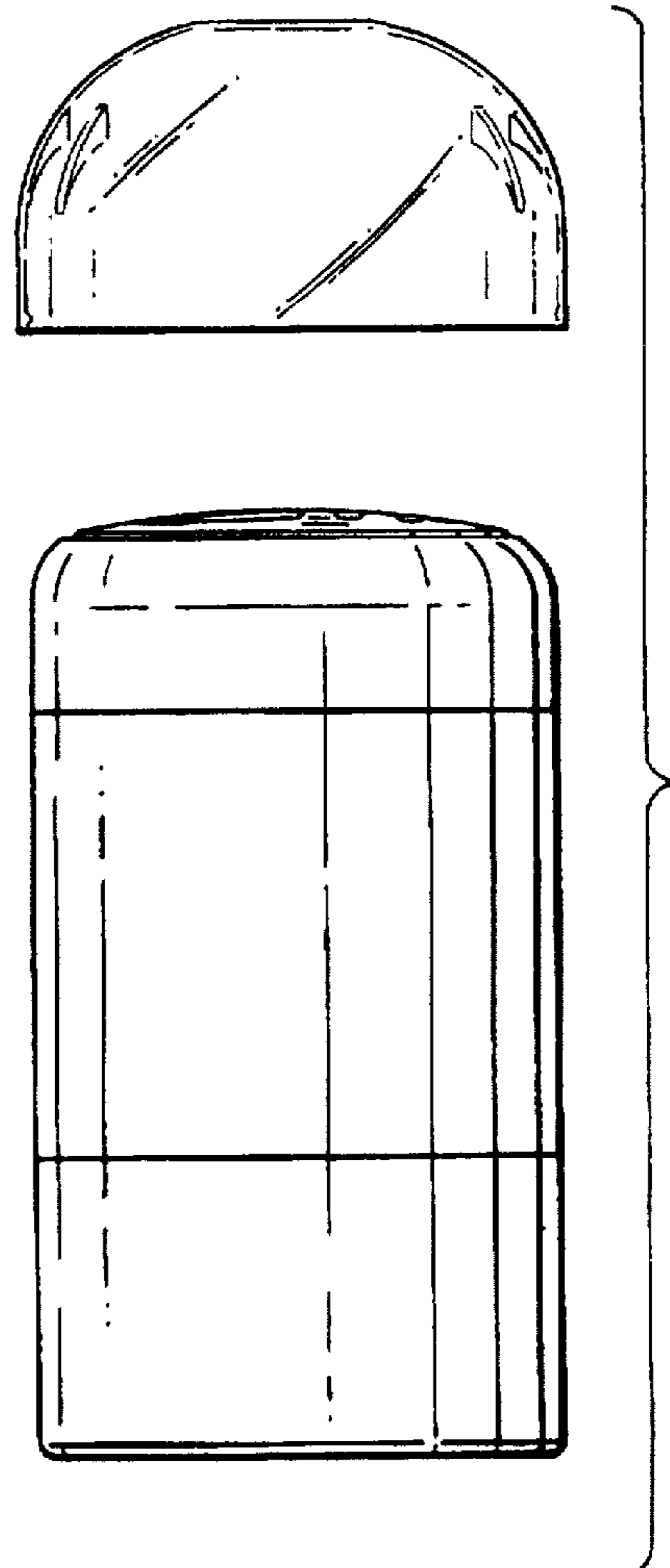
