FIG. 17 is a view looking upward toward the interior of the cap;

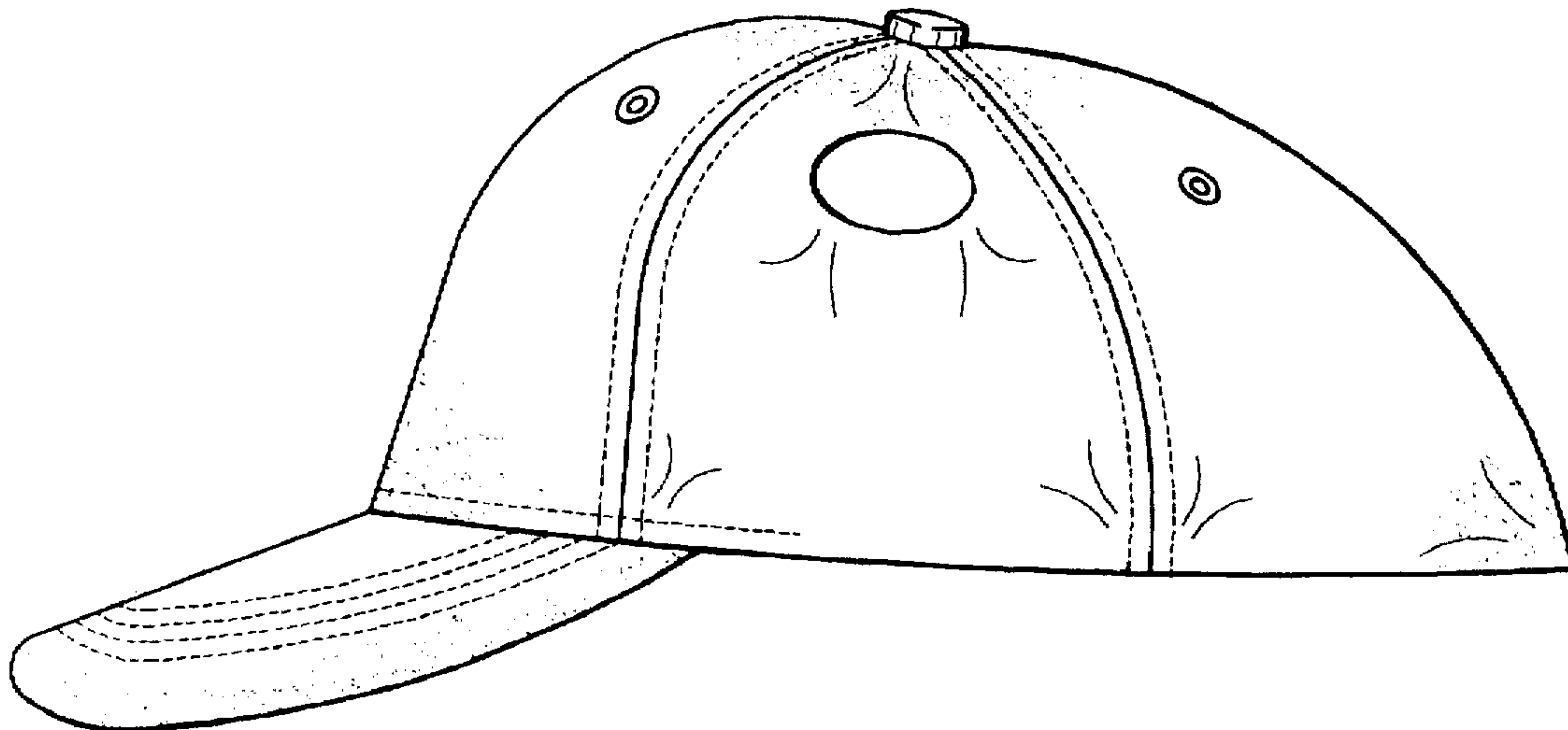
FIG. 18 is a top plan view thereof;

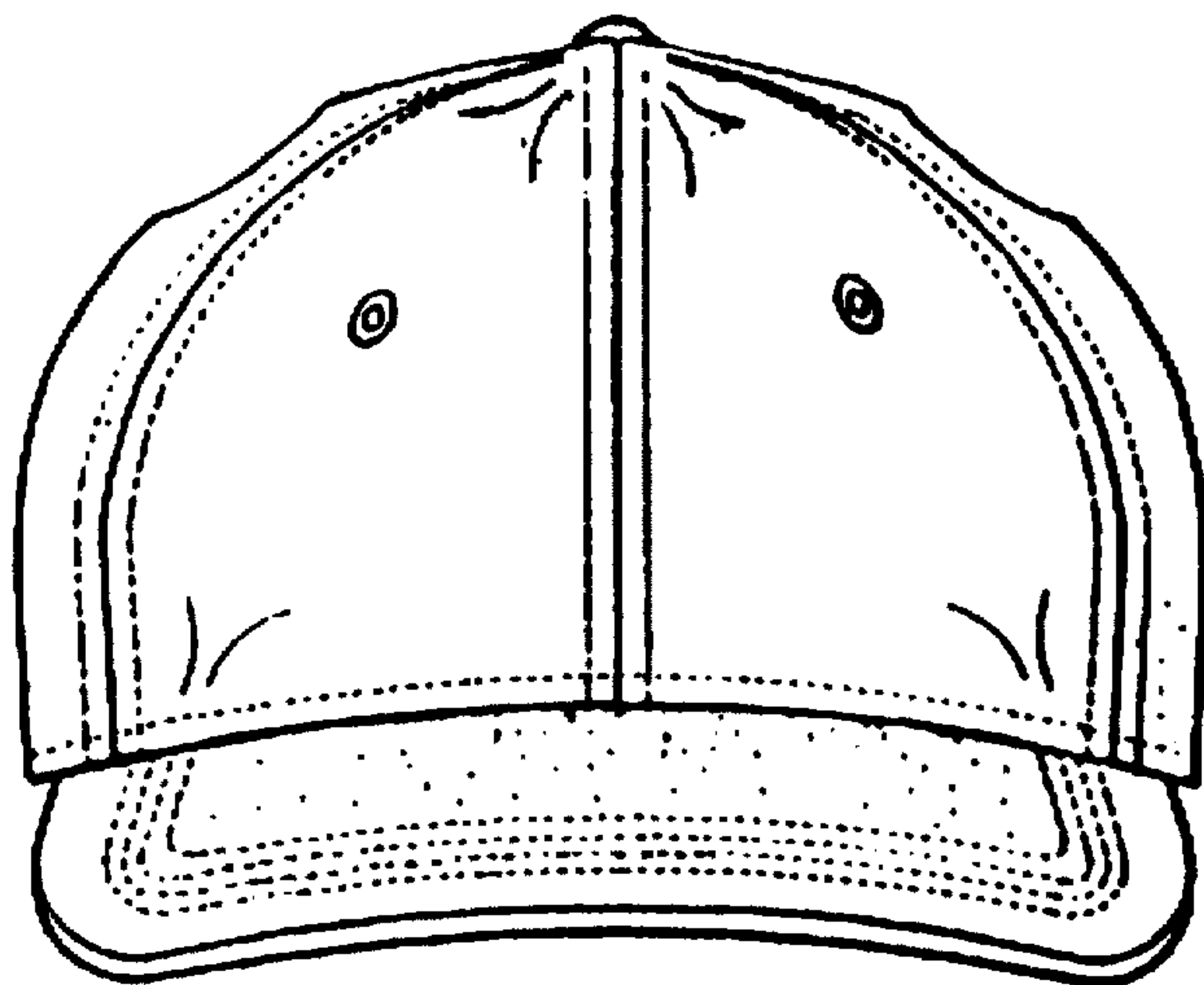

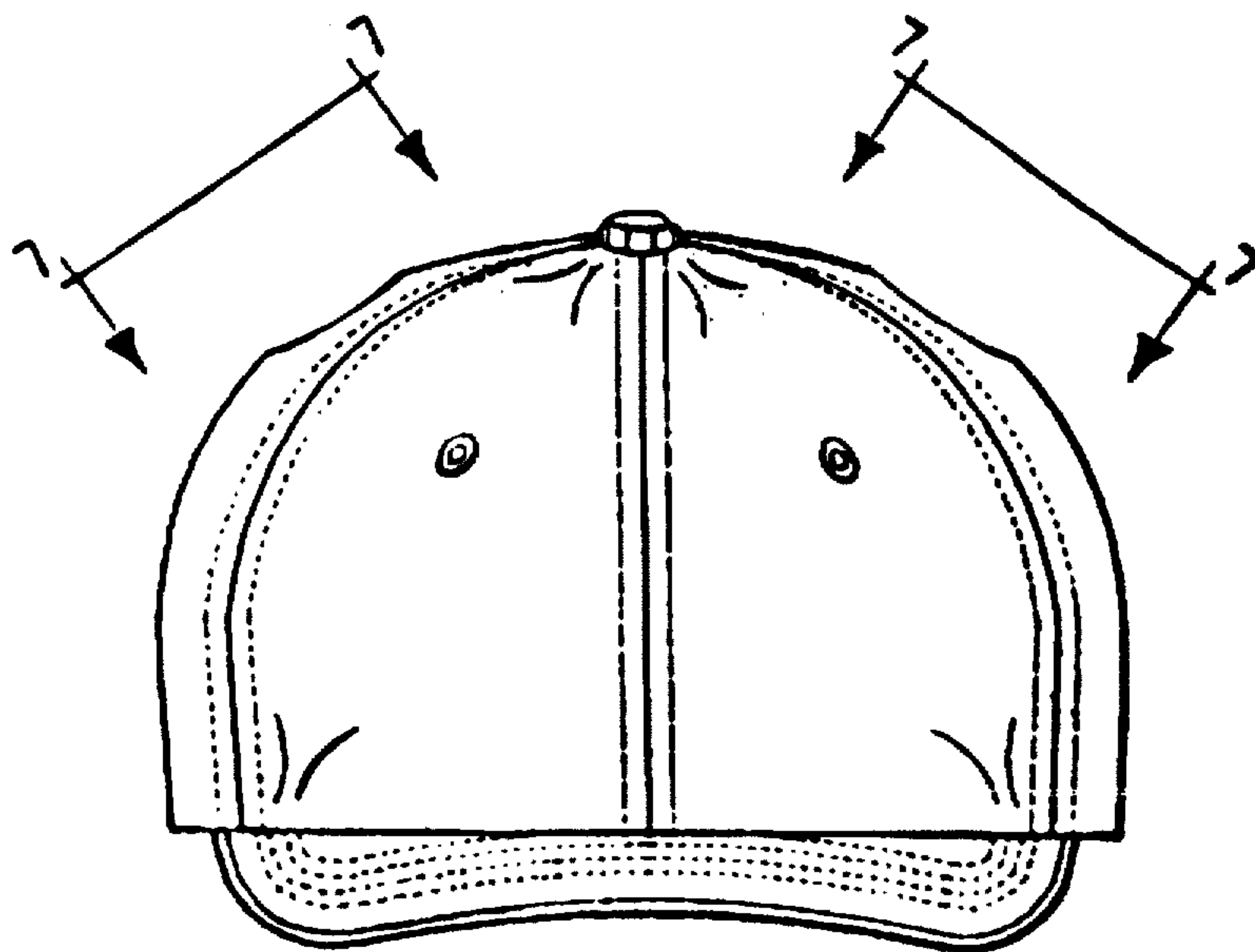

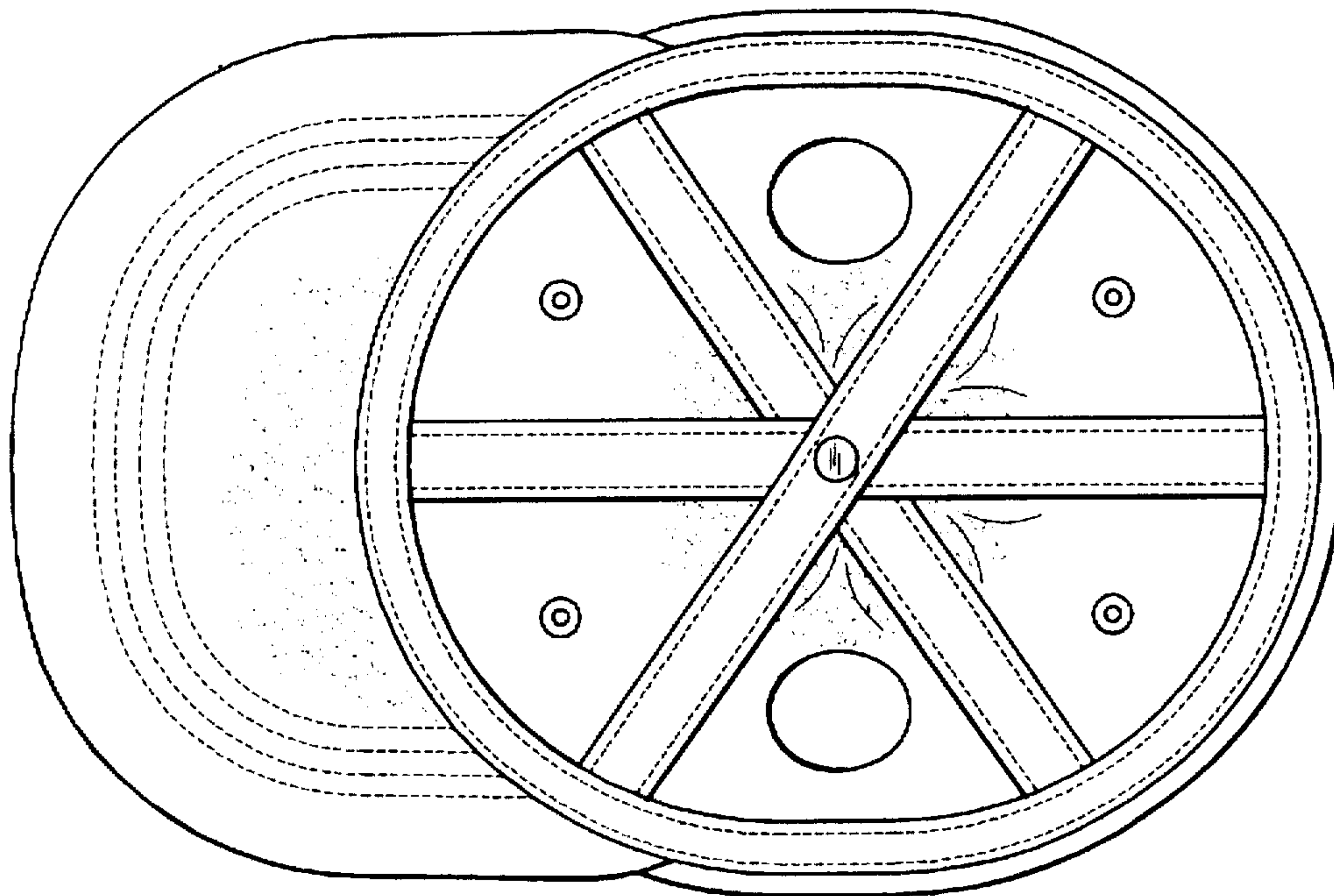

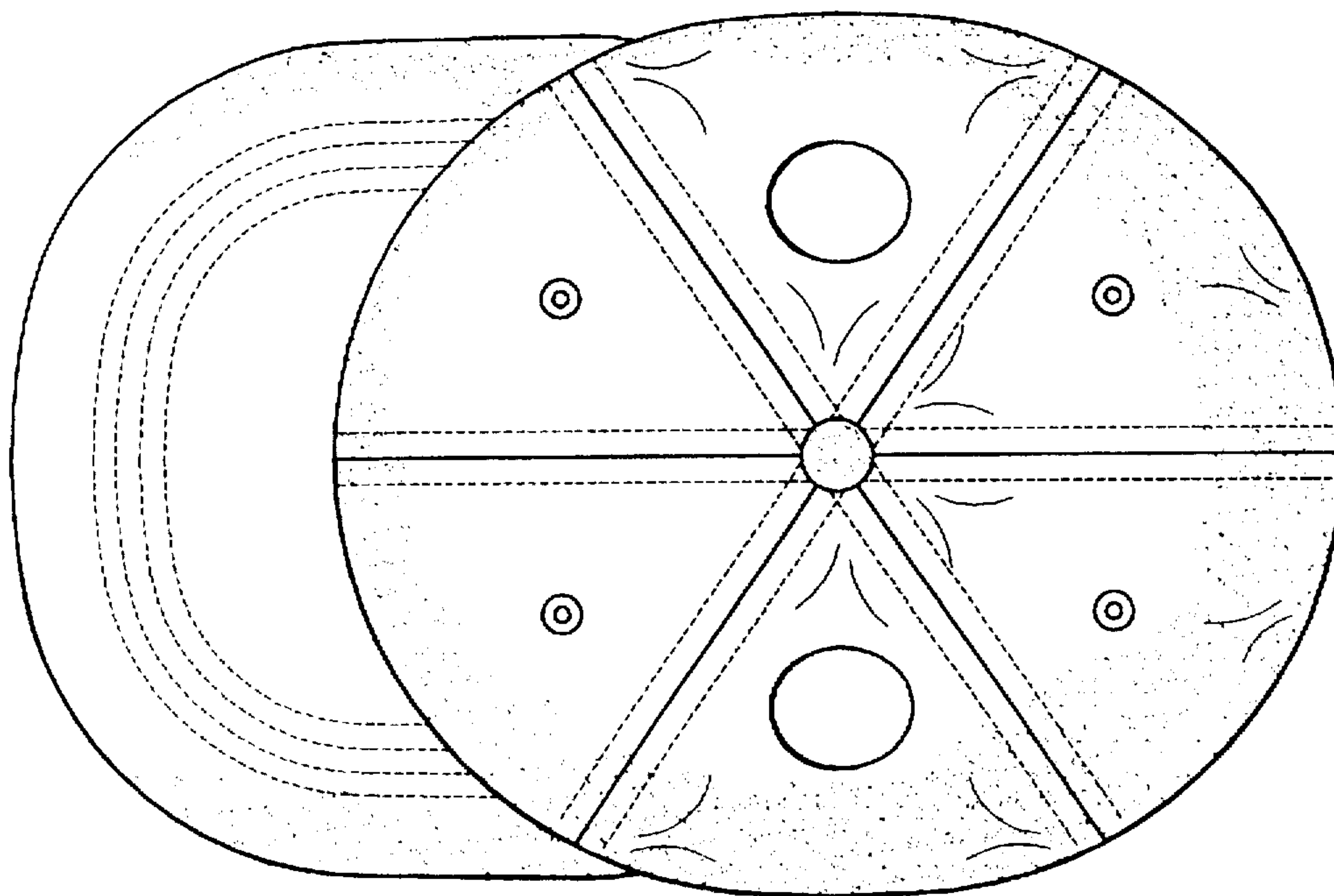

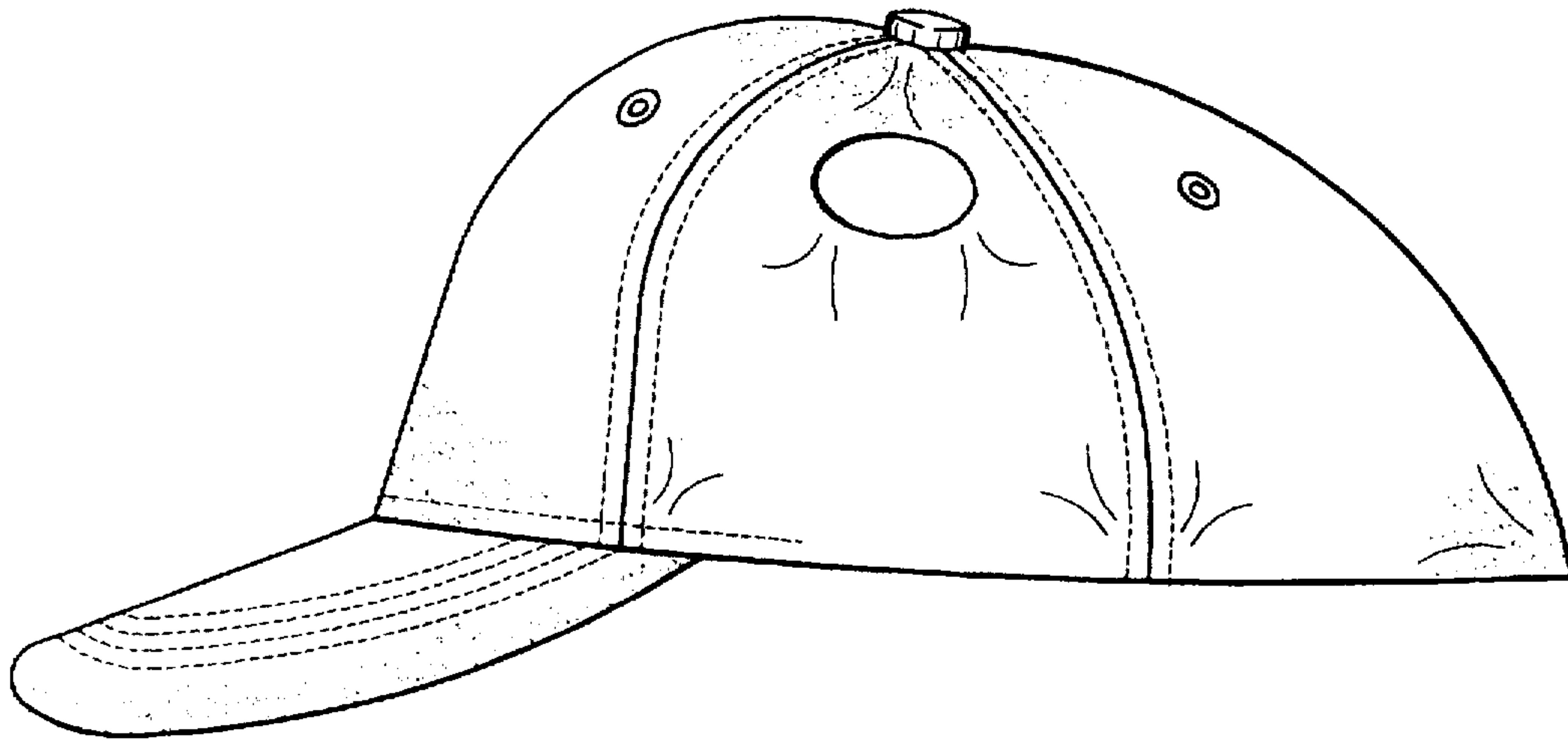

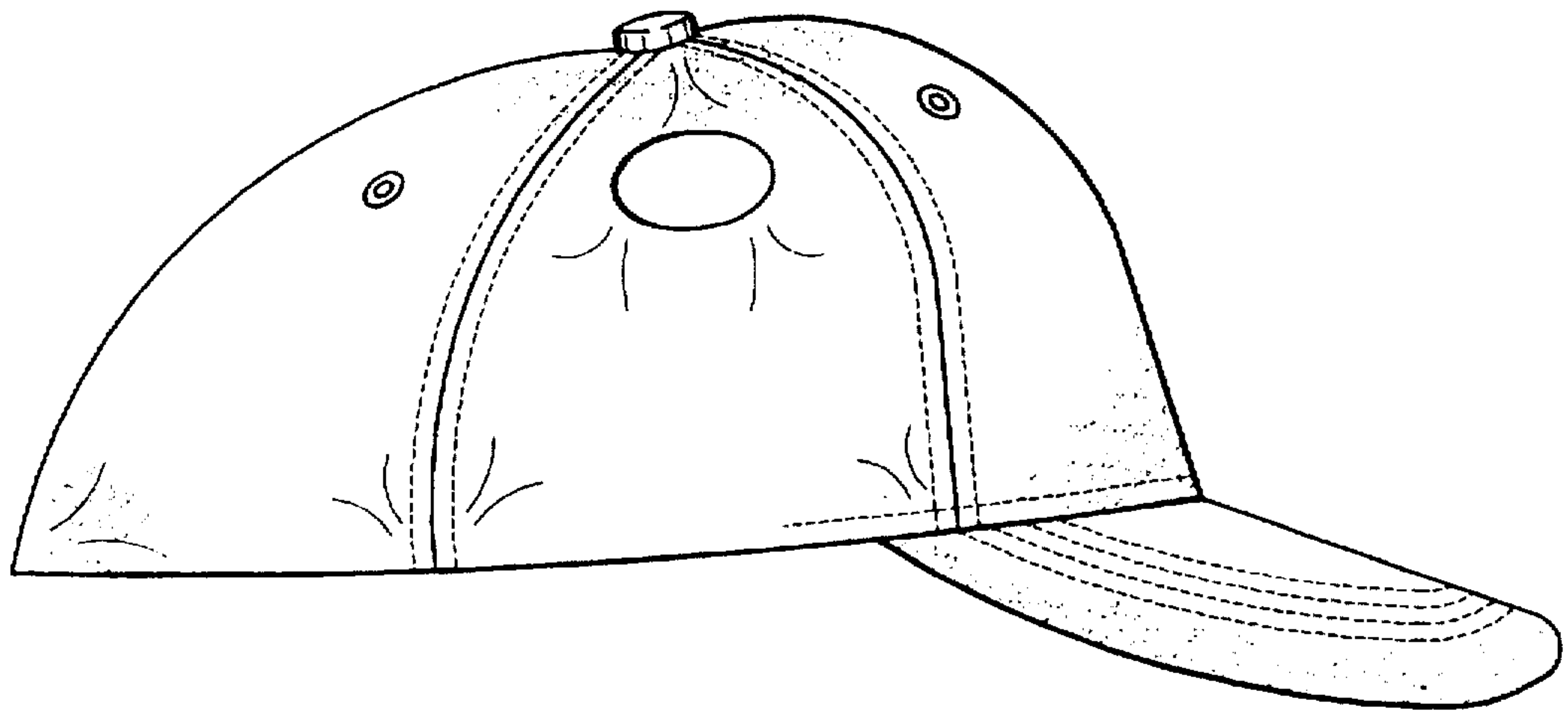

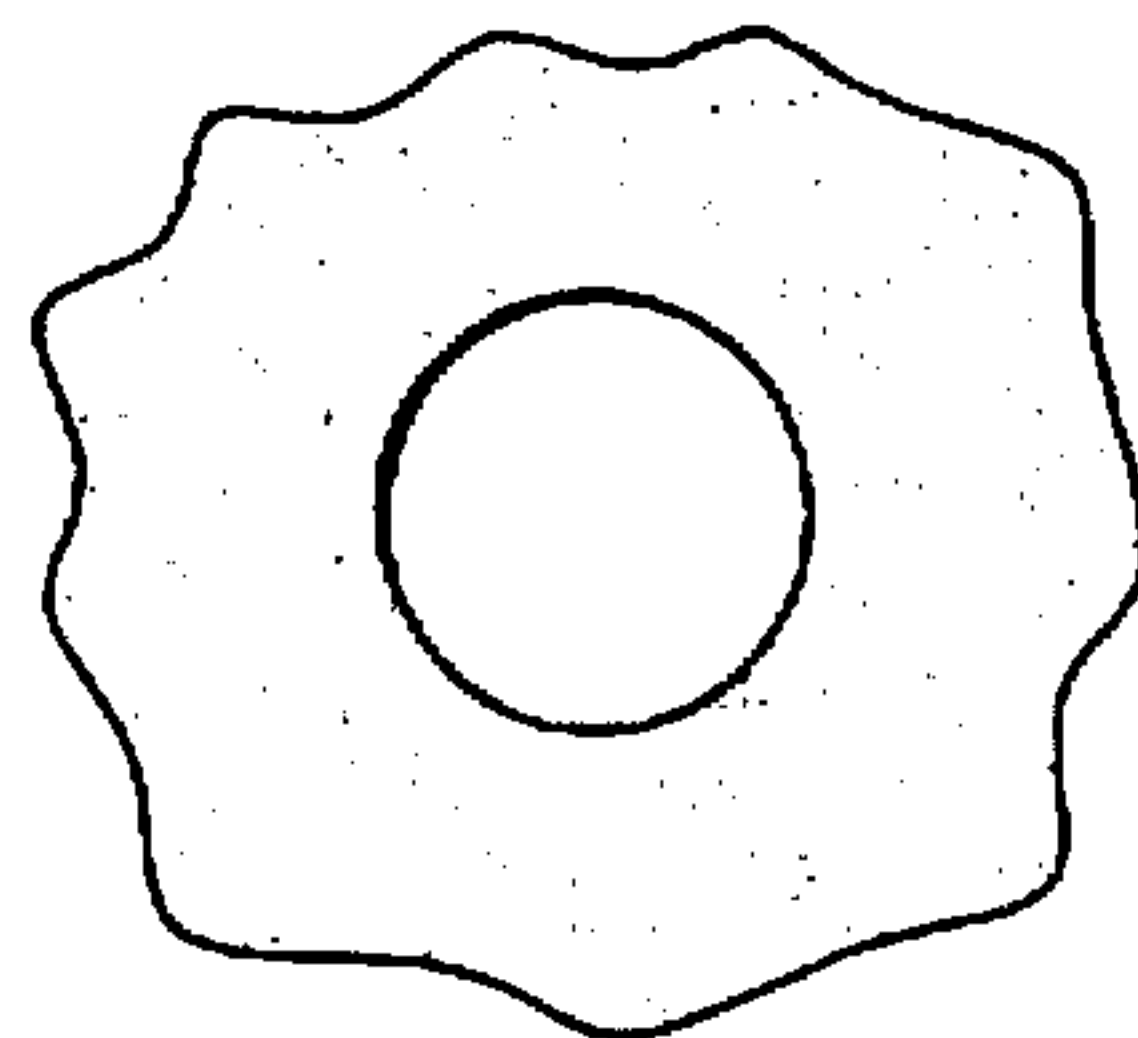

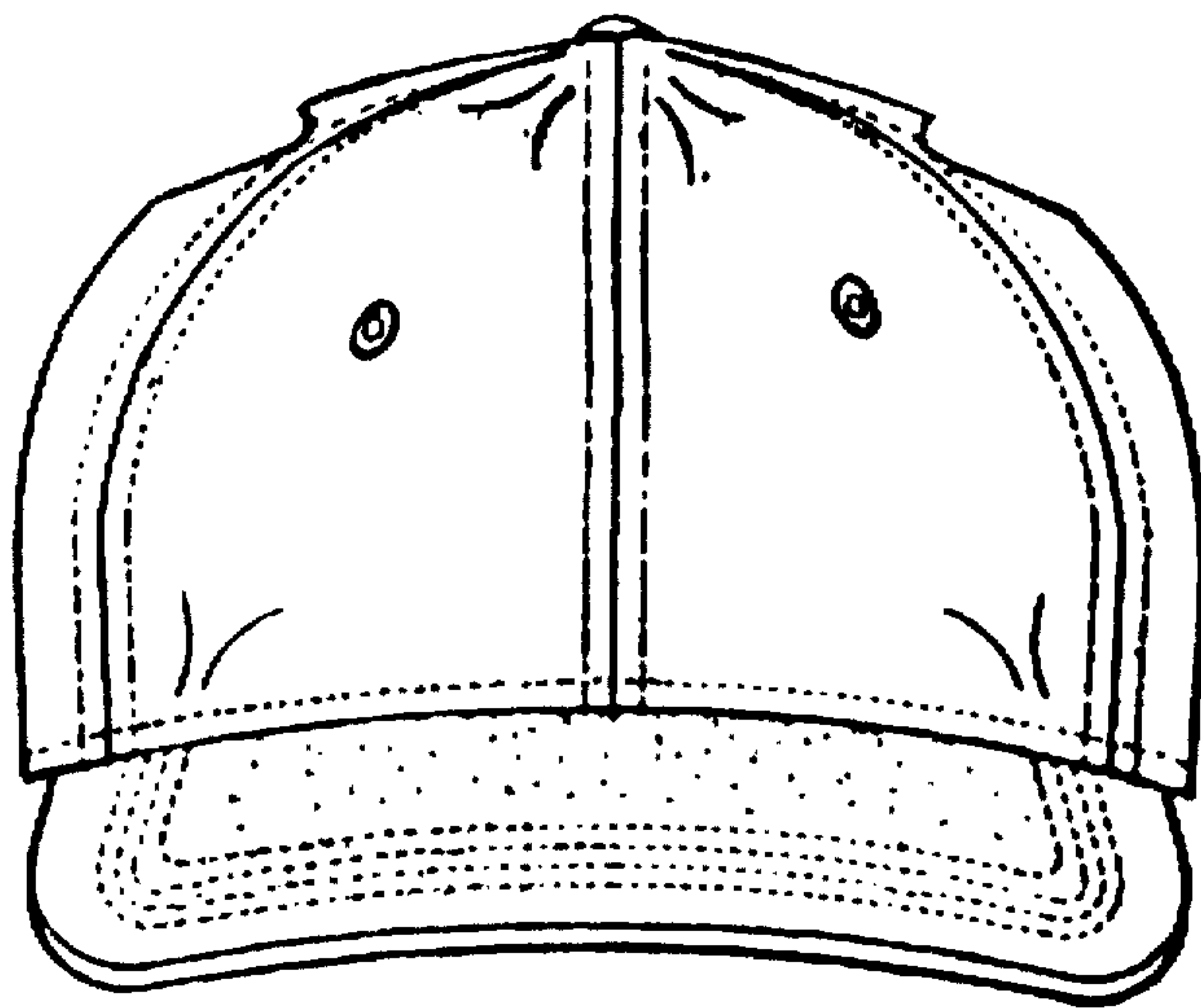

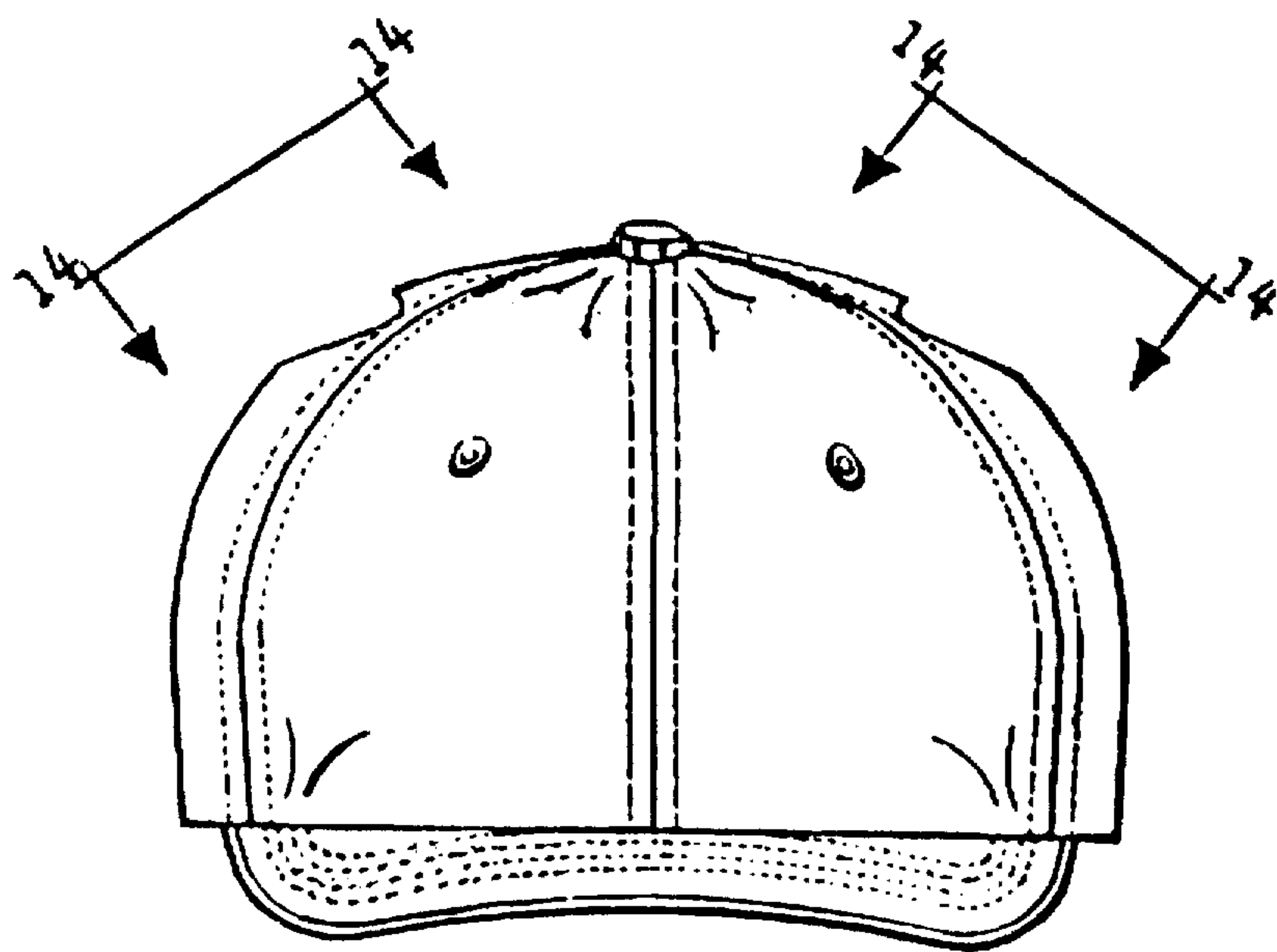

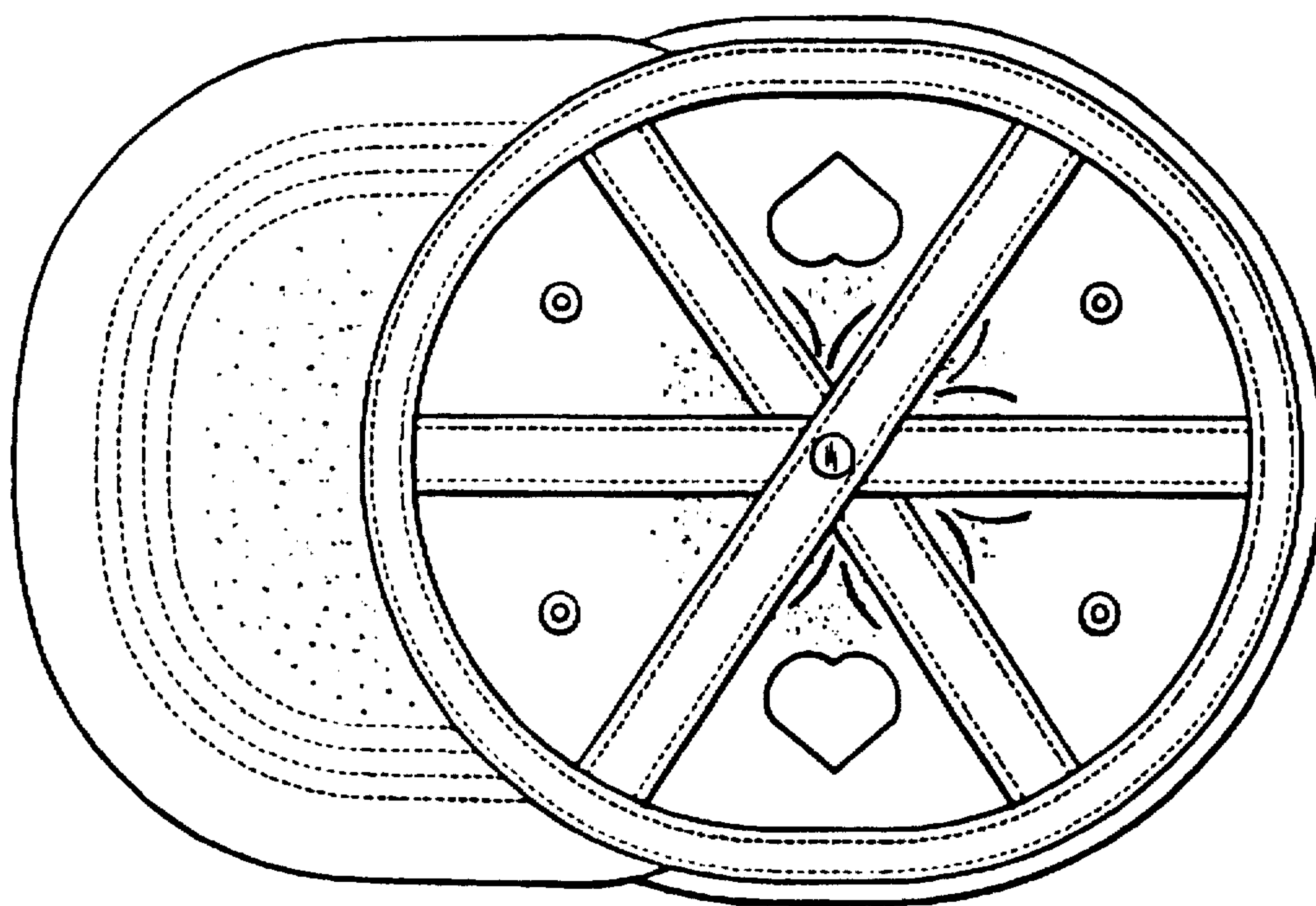

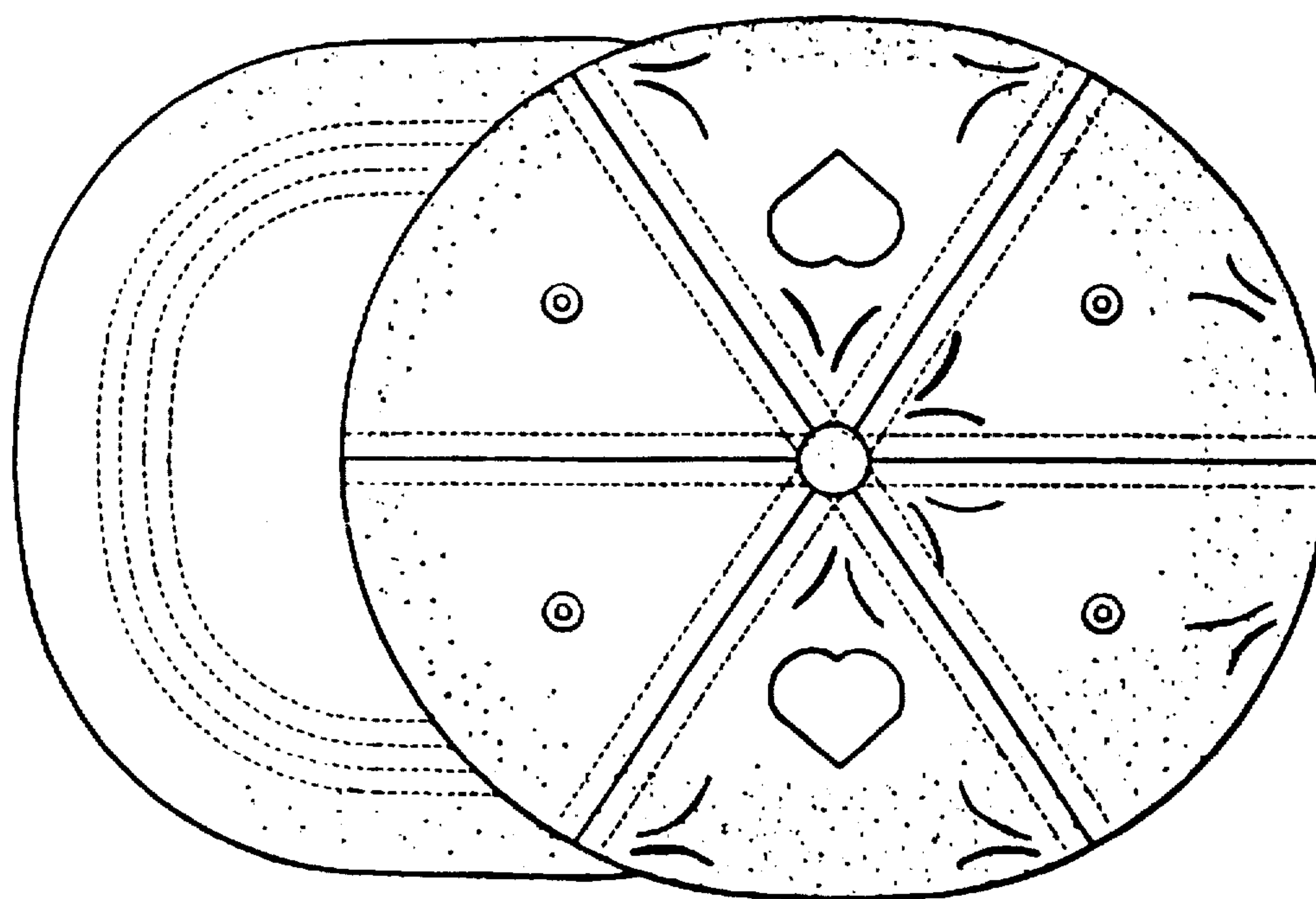

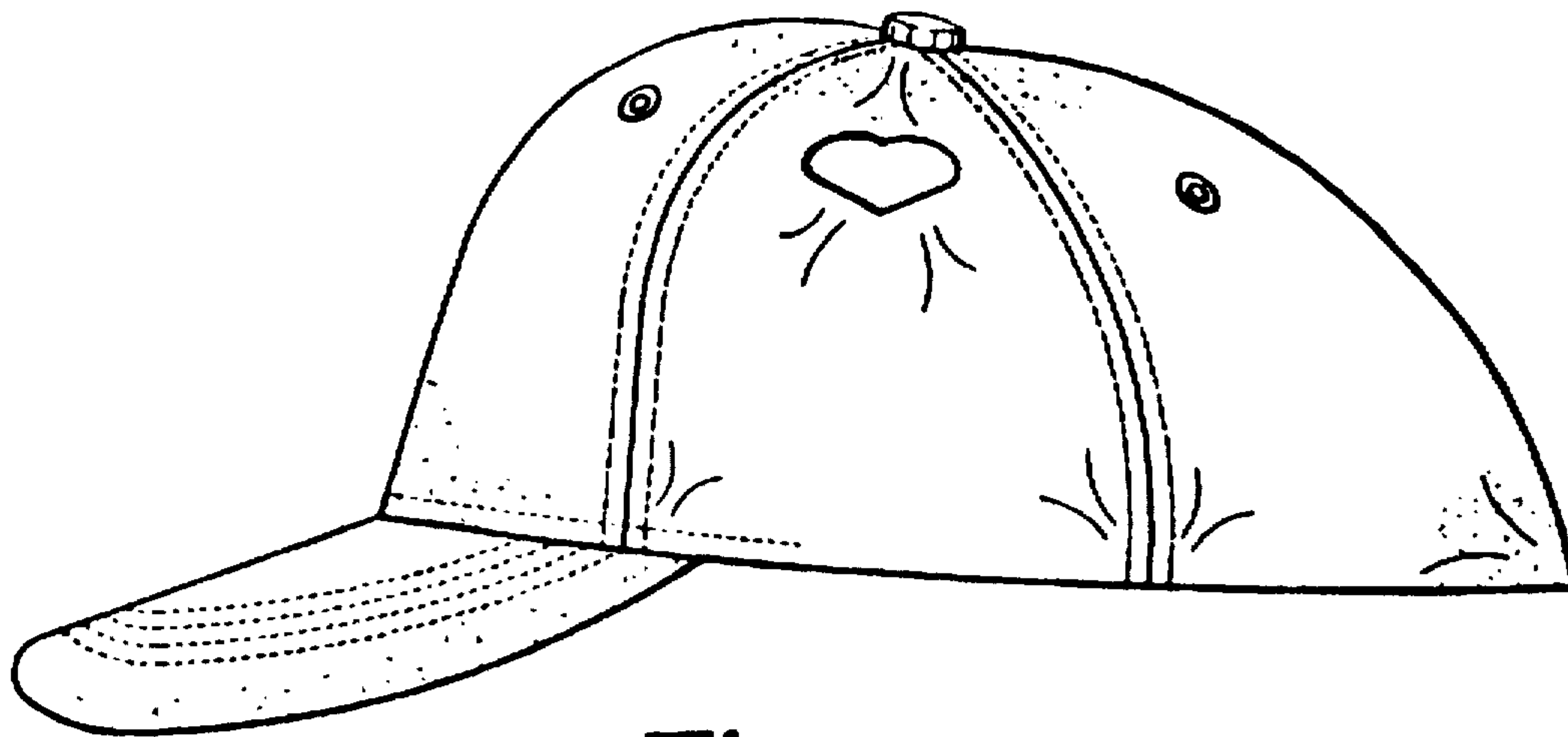

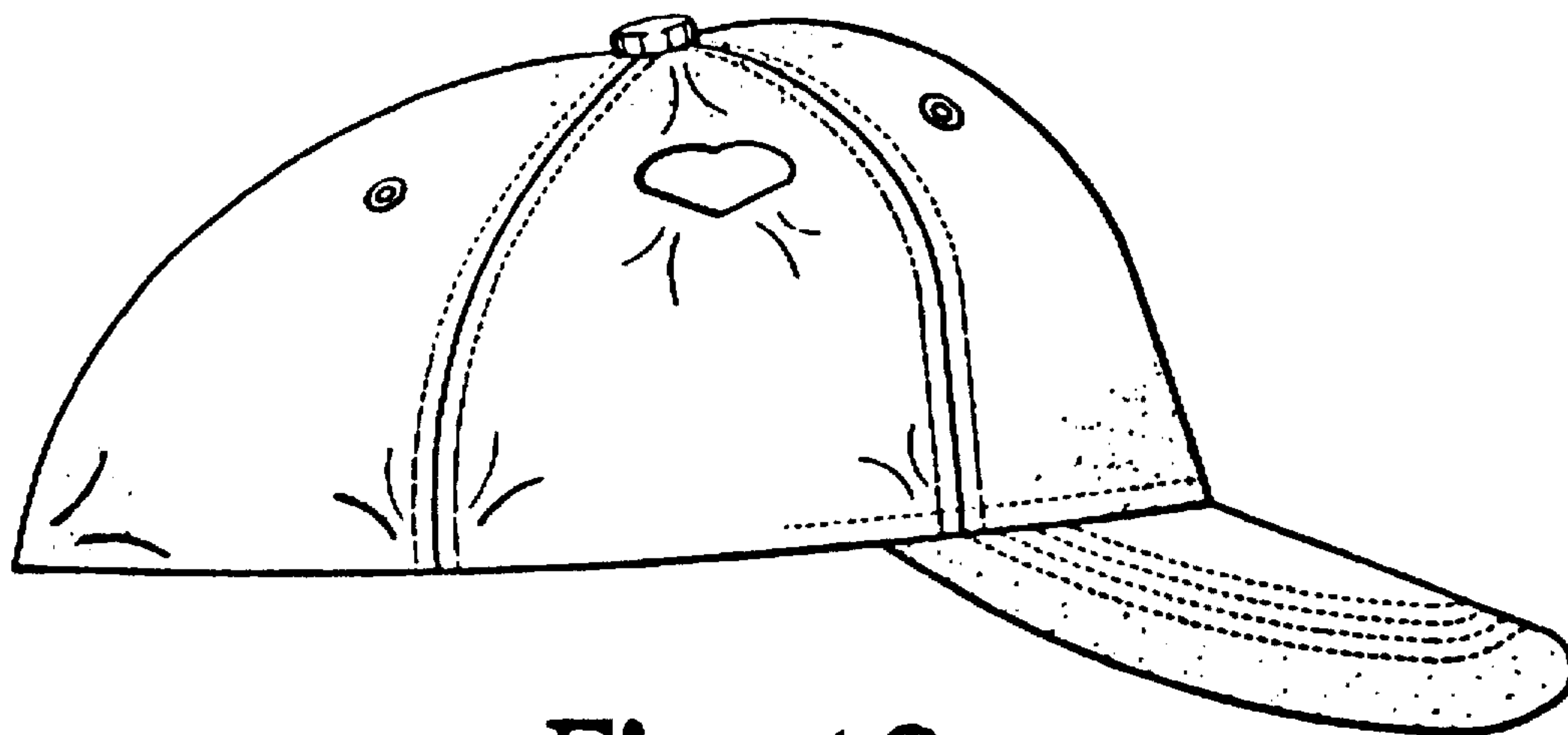

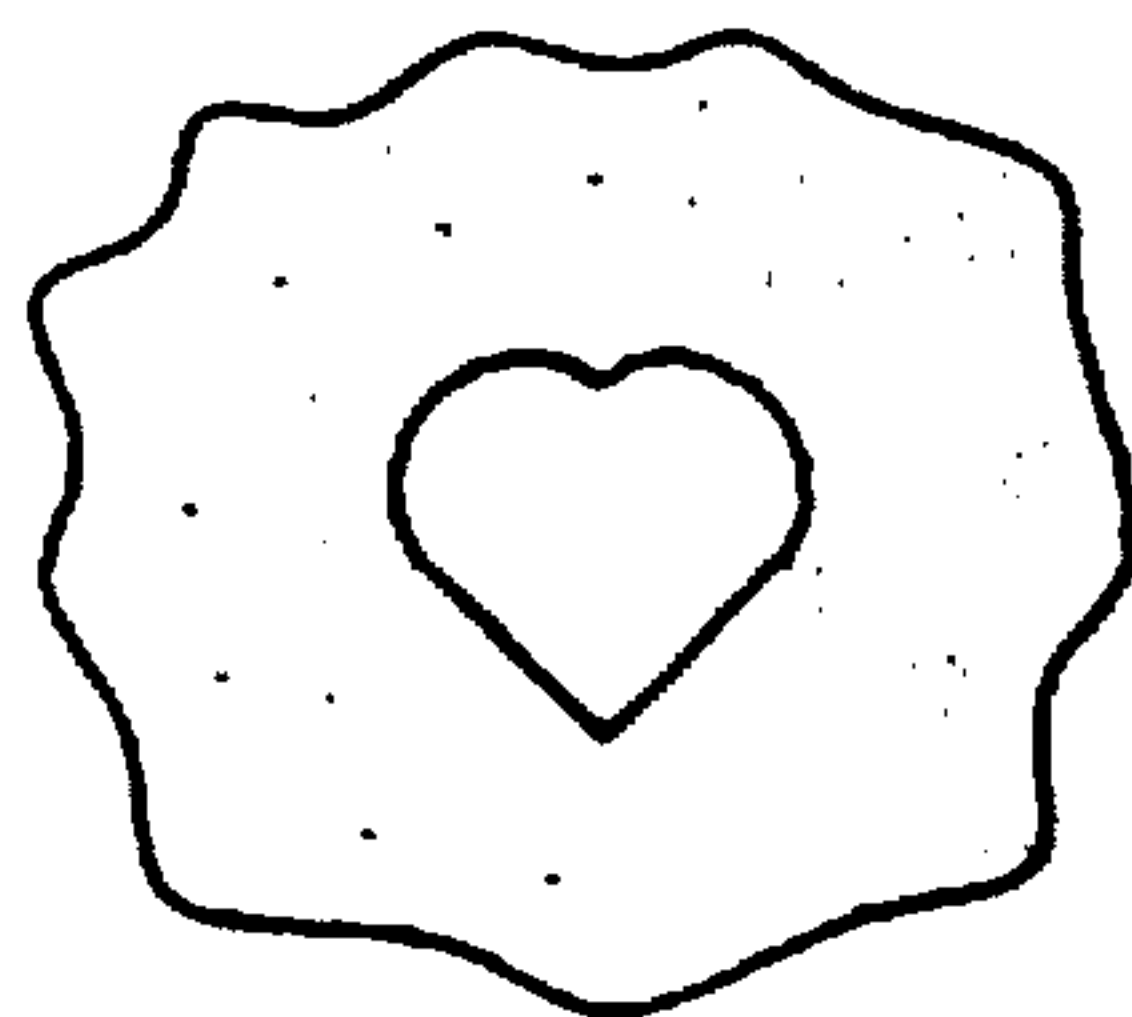

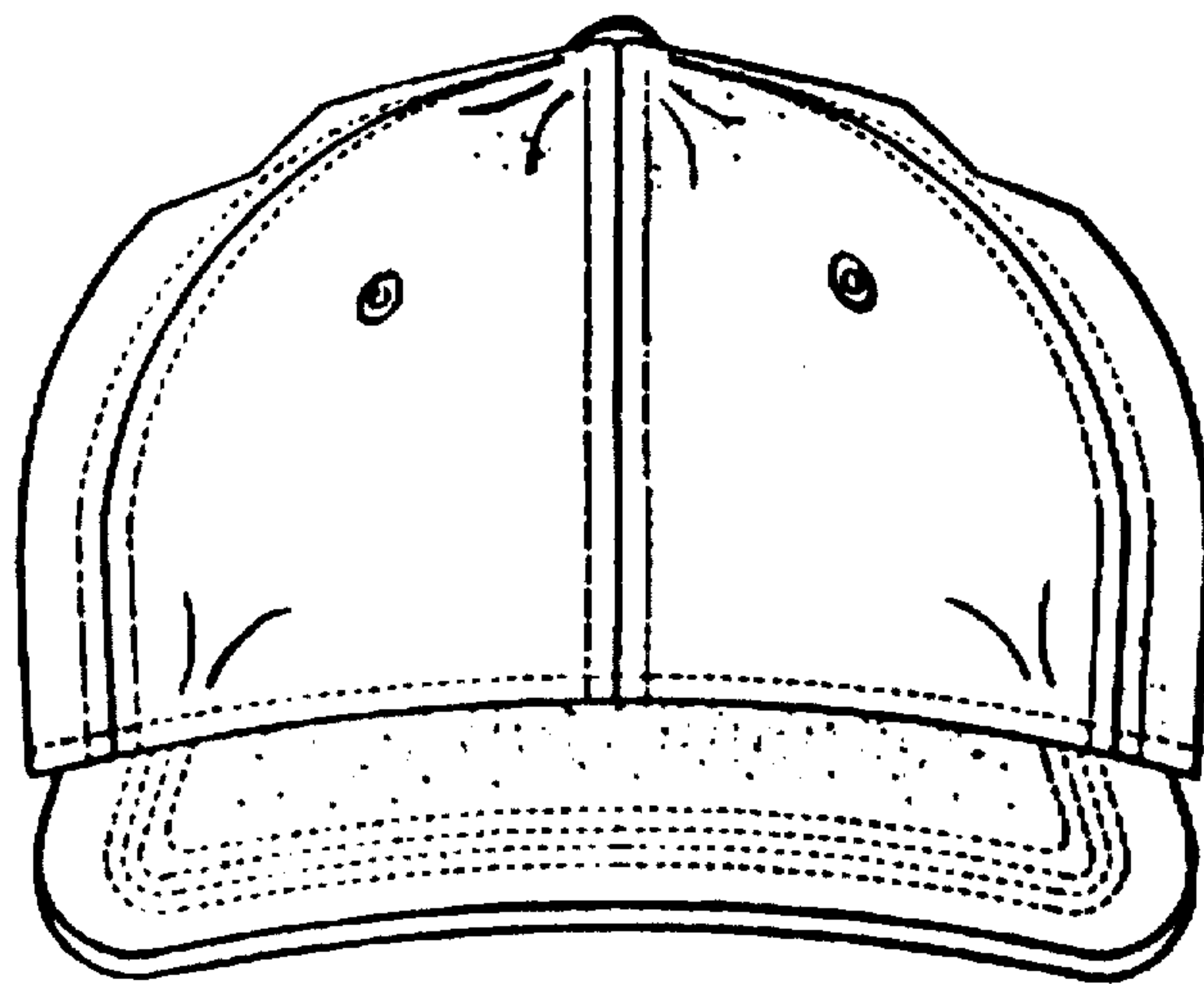

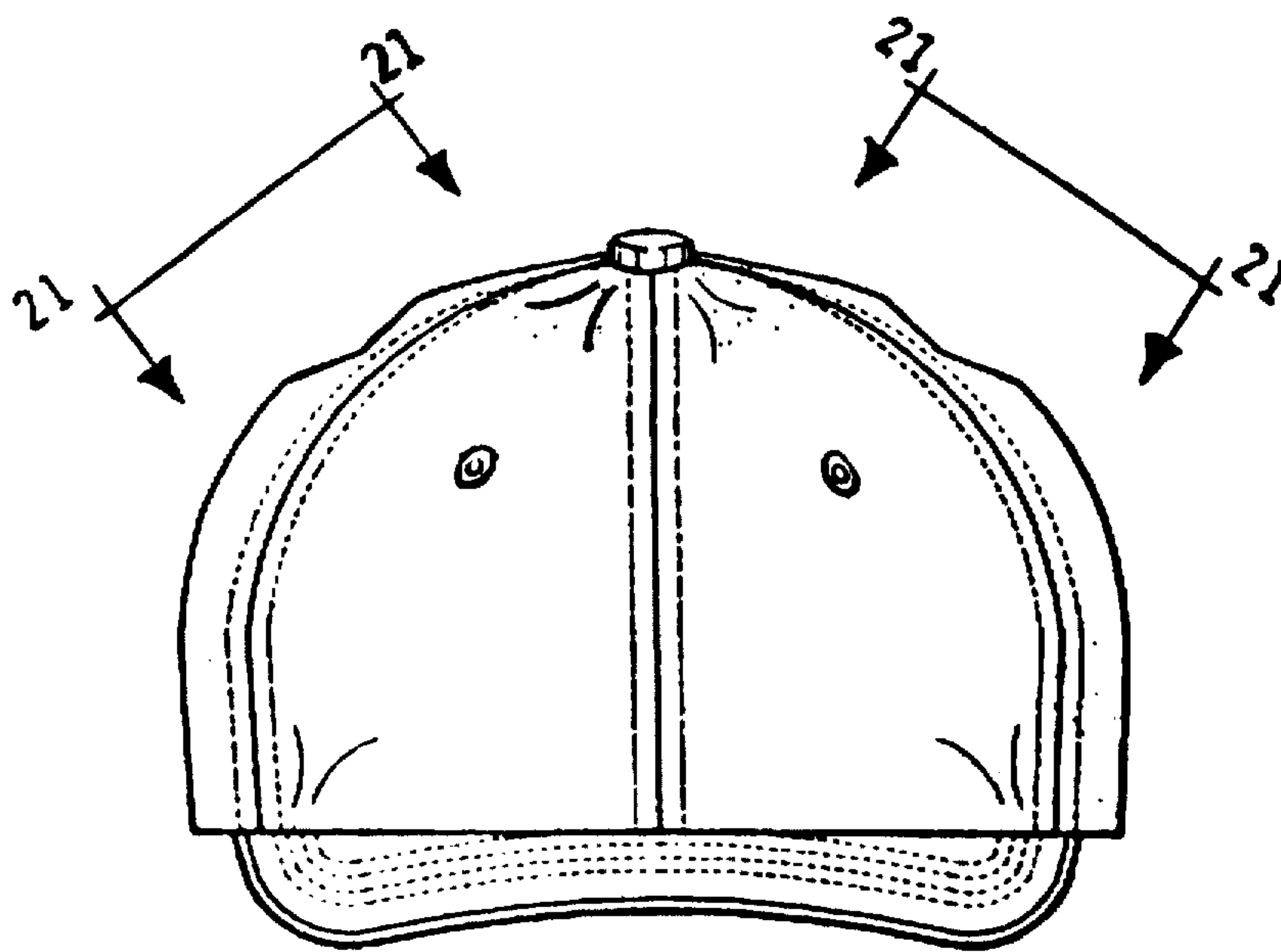

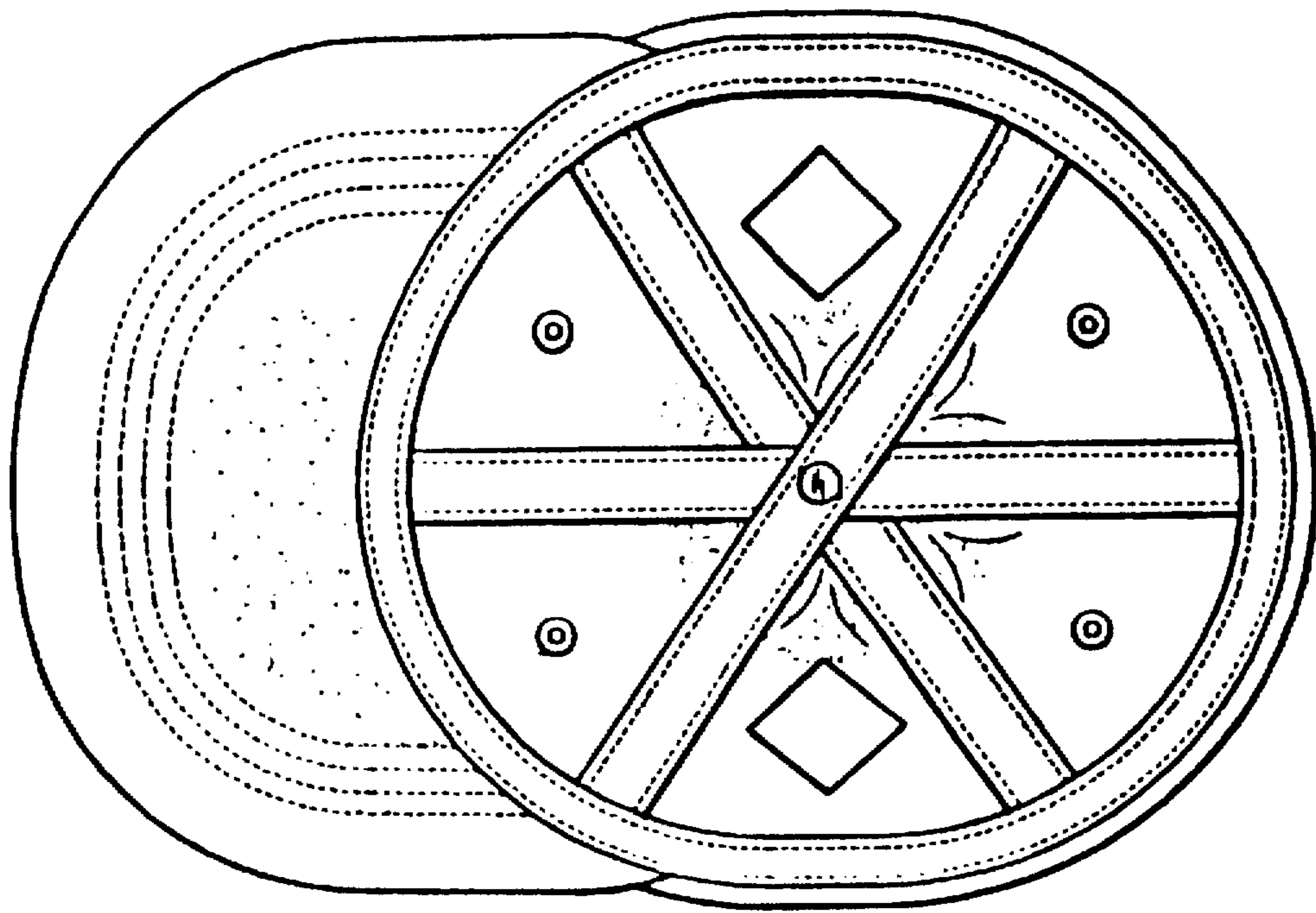

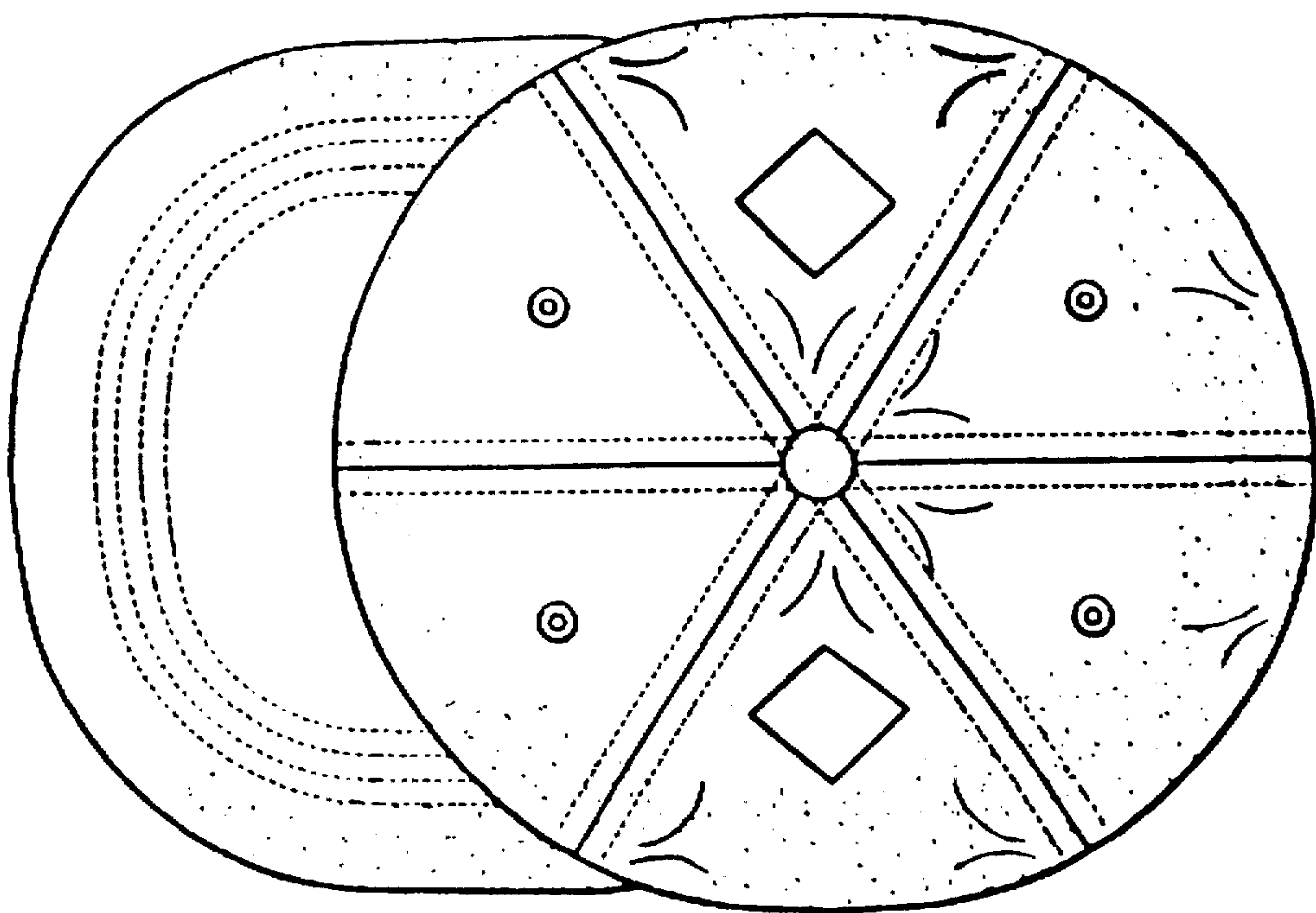

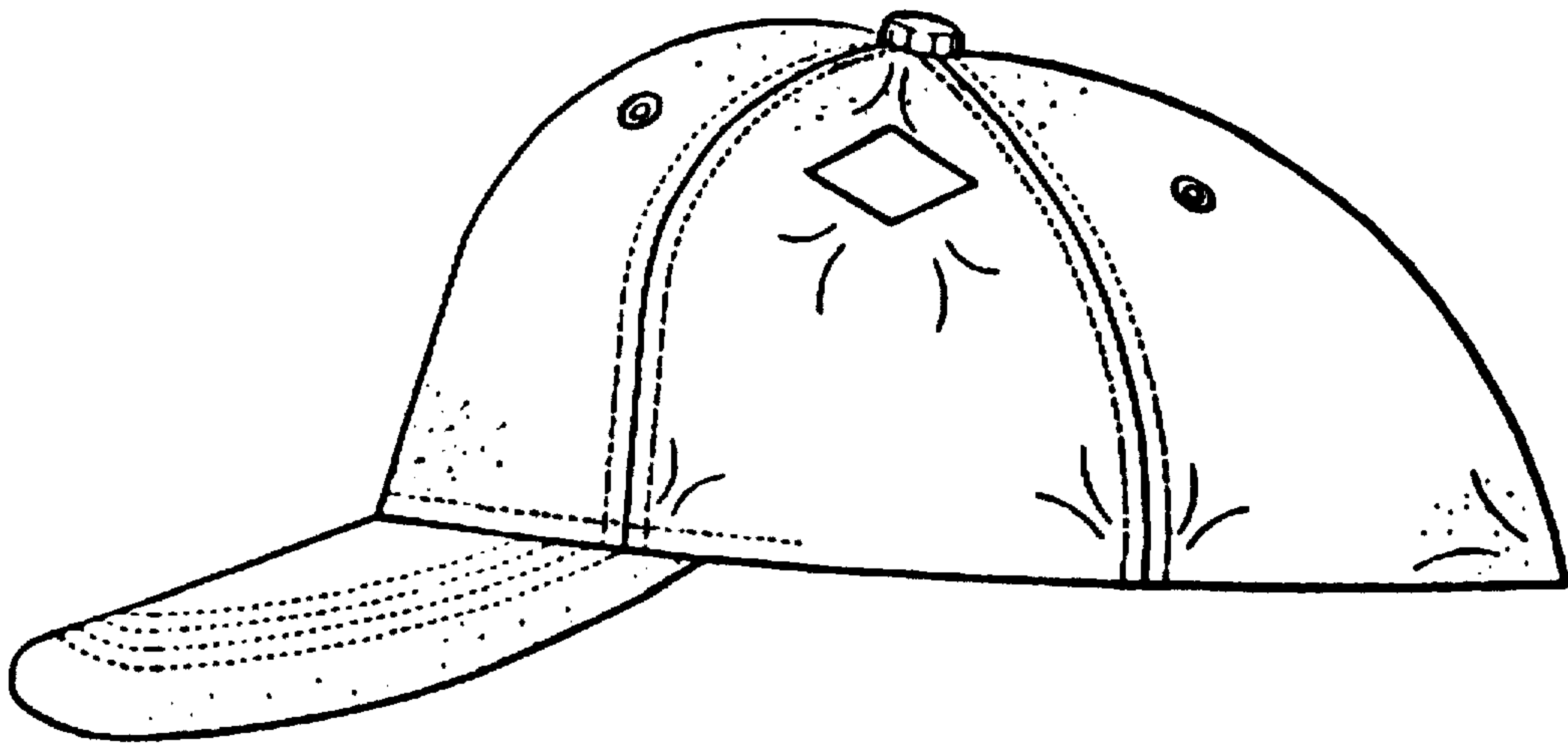

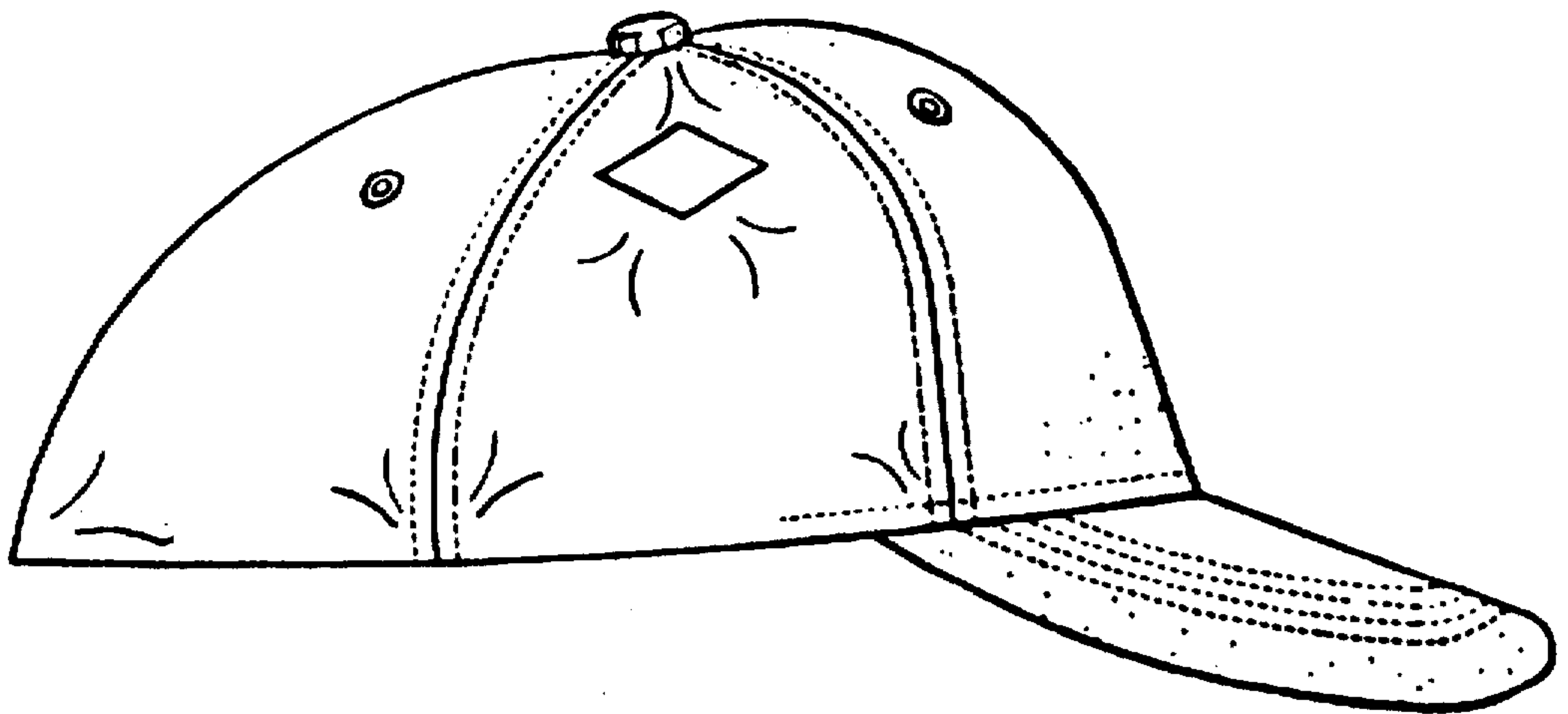

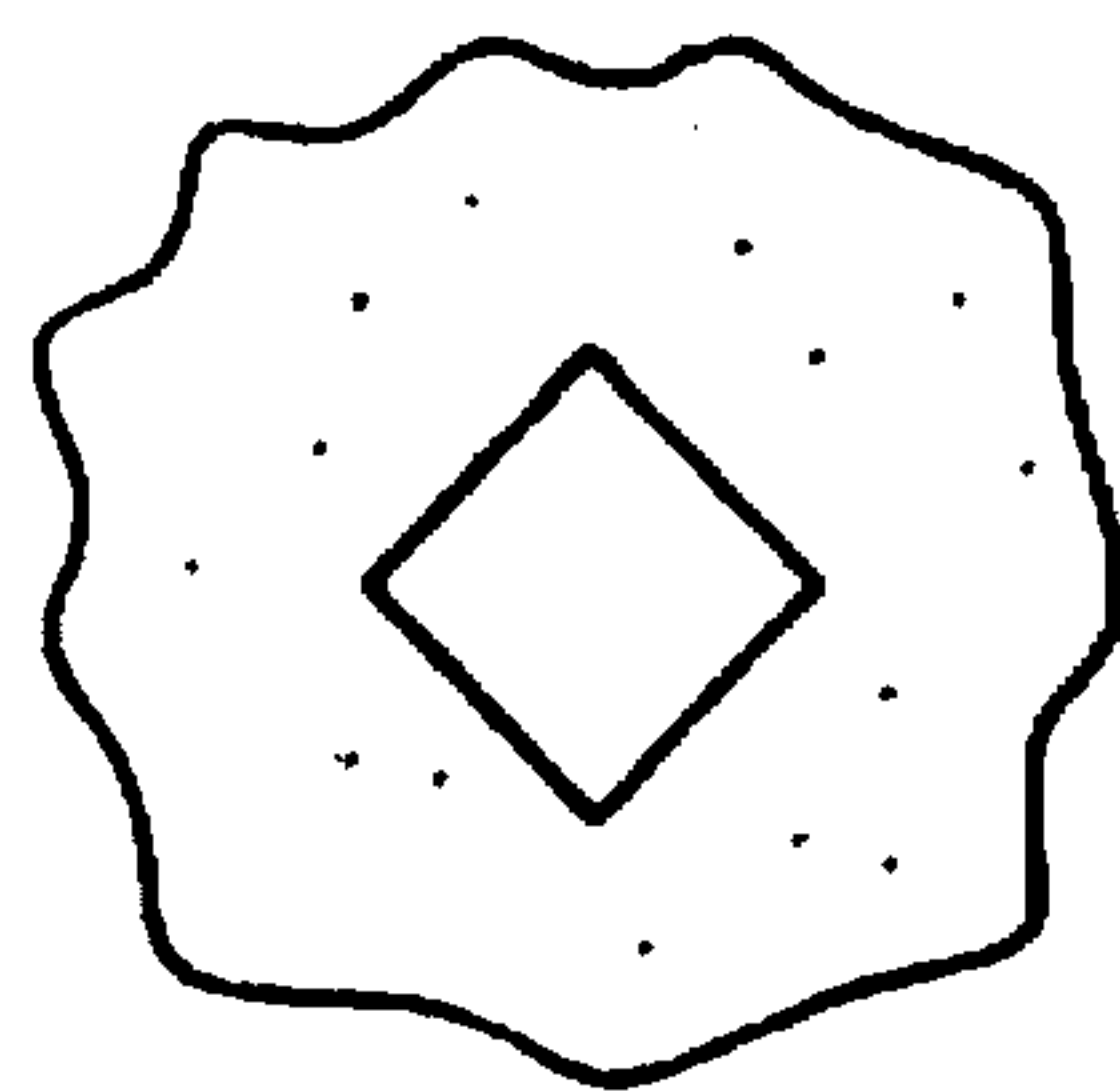
