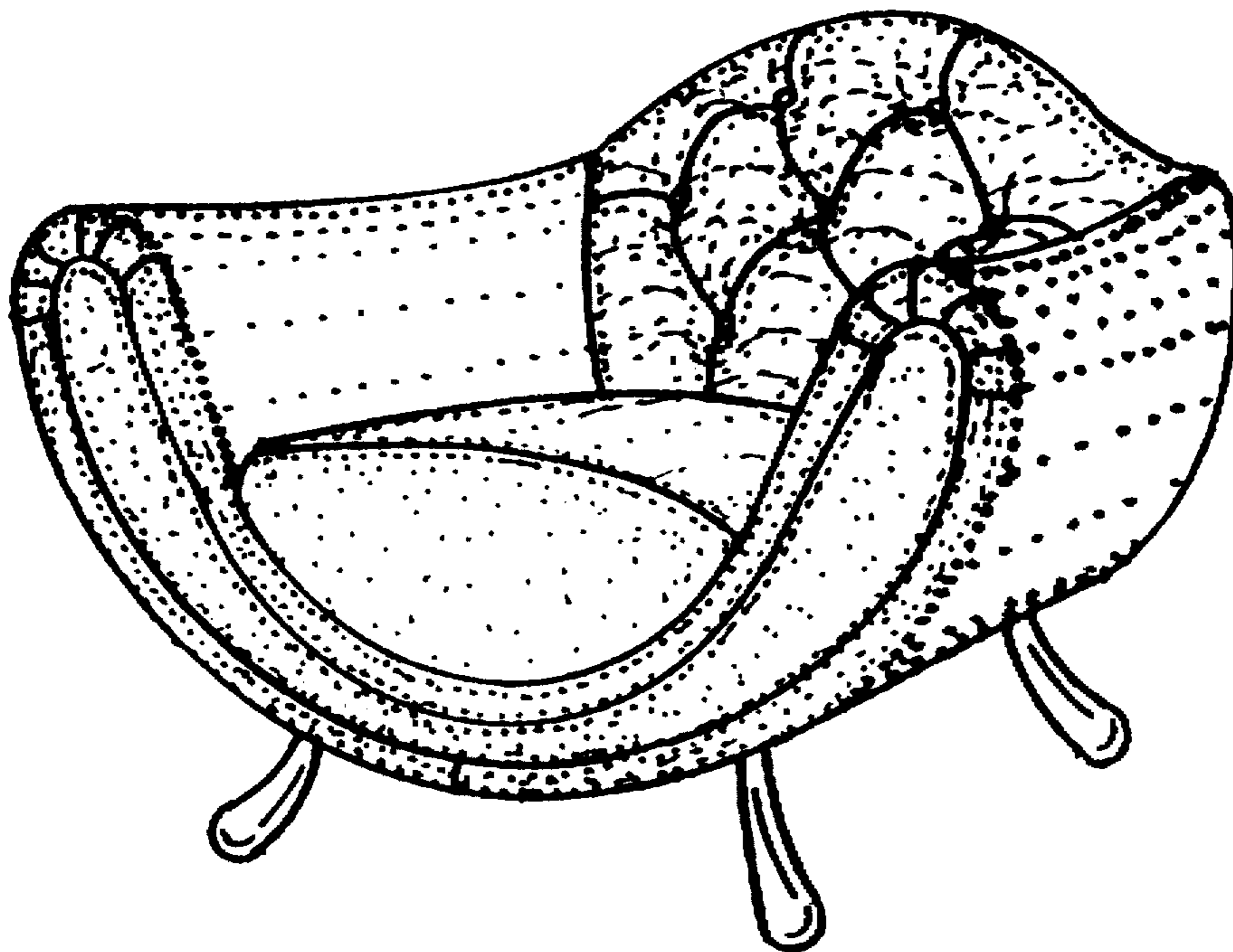

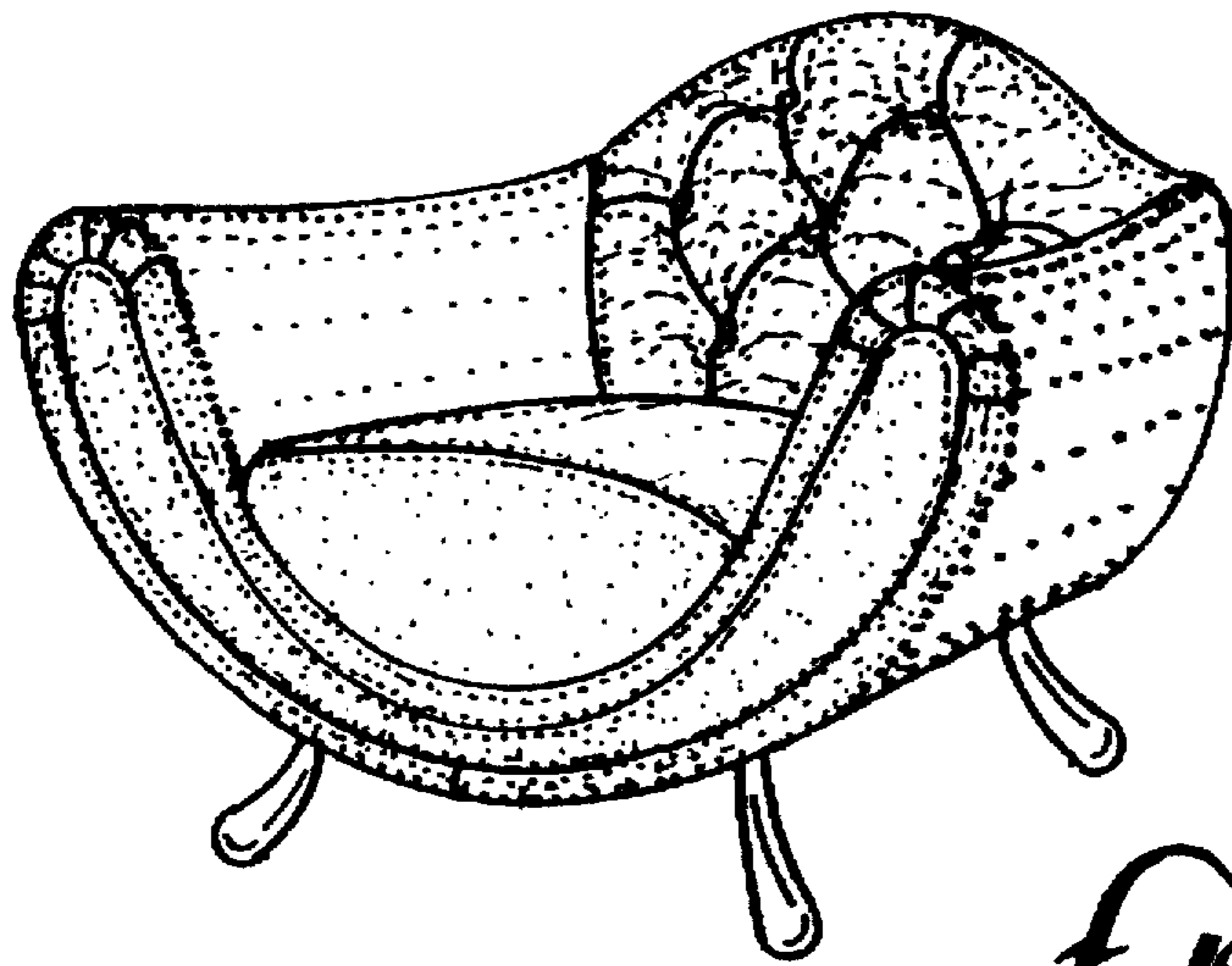
The ornamental design for a seat, as shown and described.

**DESCRIPTION**

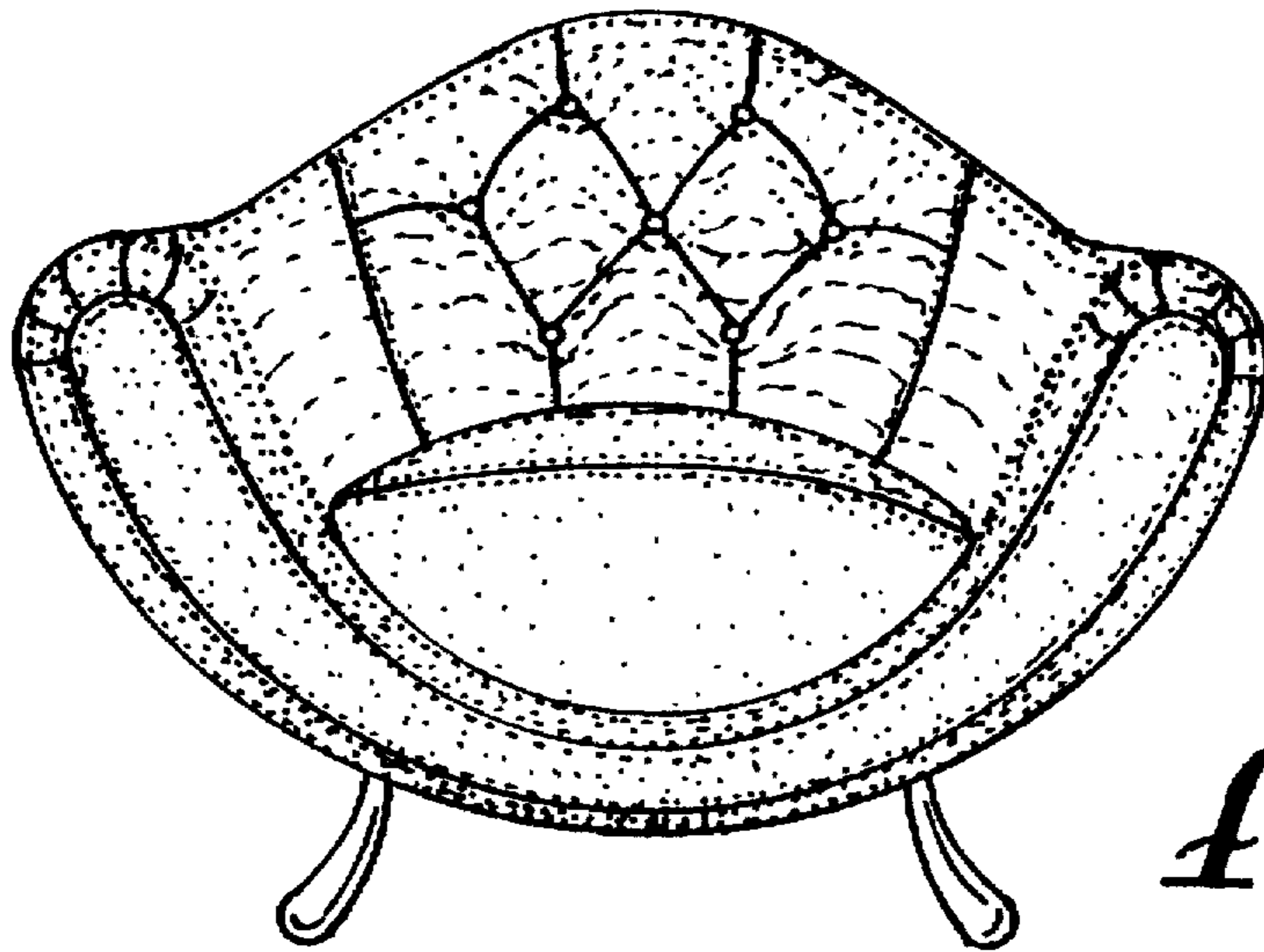
- FIG. 1 is a right side perspective view of a seat in the form of a chair according to my new design;
- FIG. 2 is a front perspective view of the seat shown in FIG. 1;
- FIG. 3 is a top perspective view the seat shown in FIG. 1;
- FIG. 4 is a left side perspective view the seat shown in FIG. 1;
- FIG. 5 is a rear perspective view the seat shown in FIG. 1;

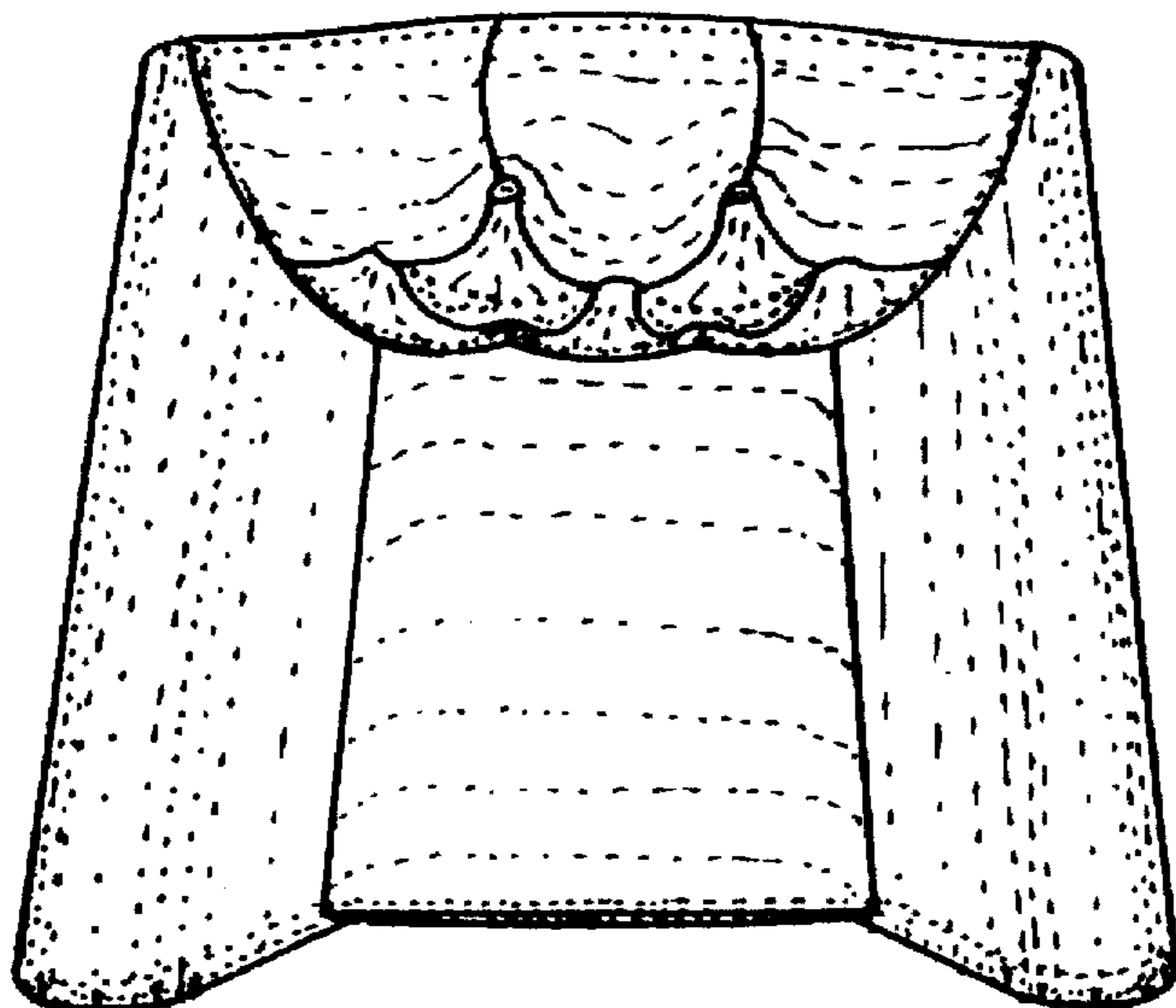




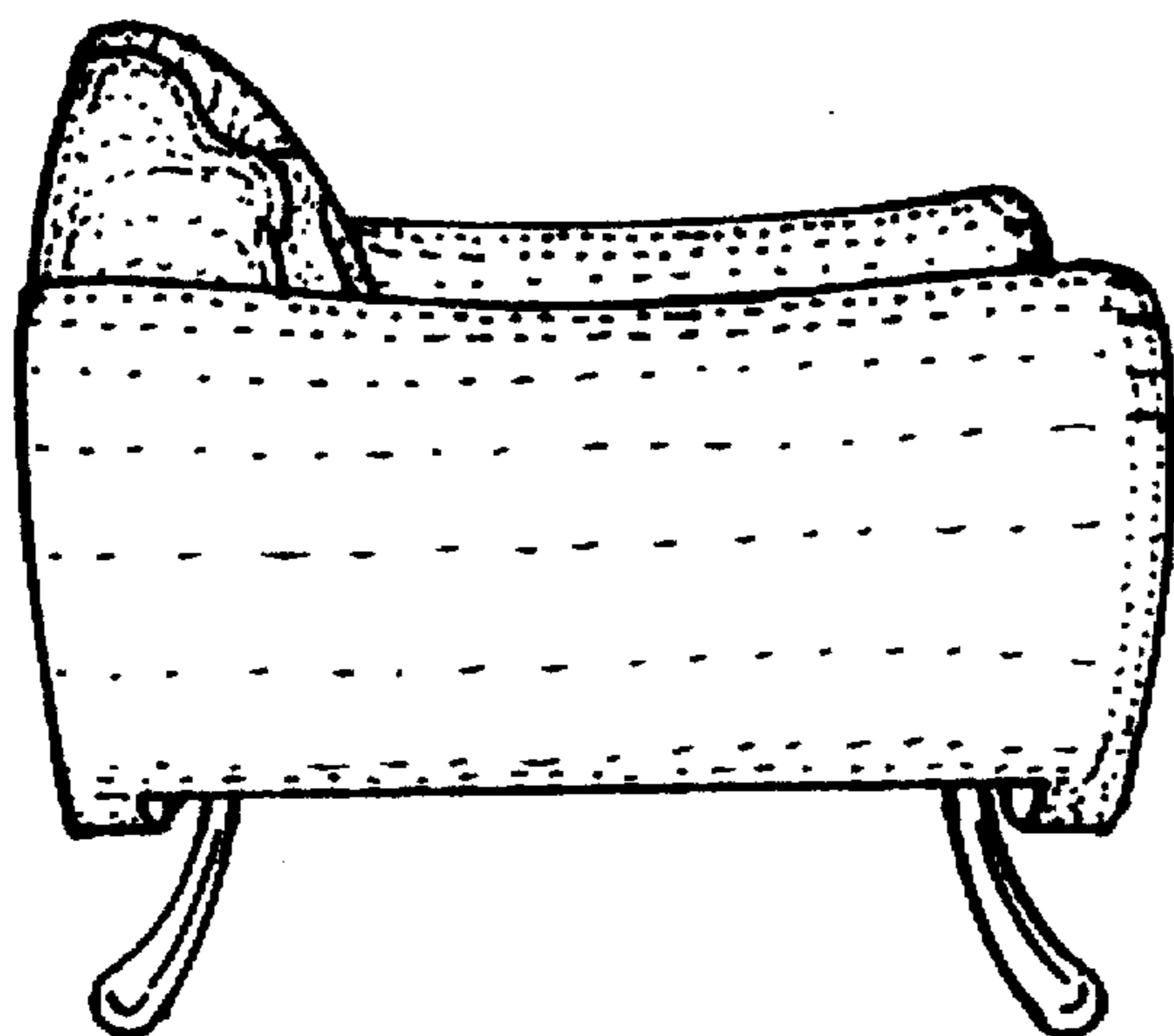

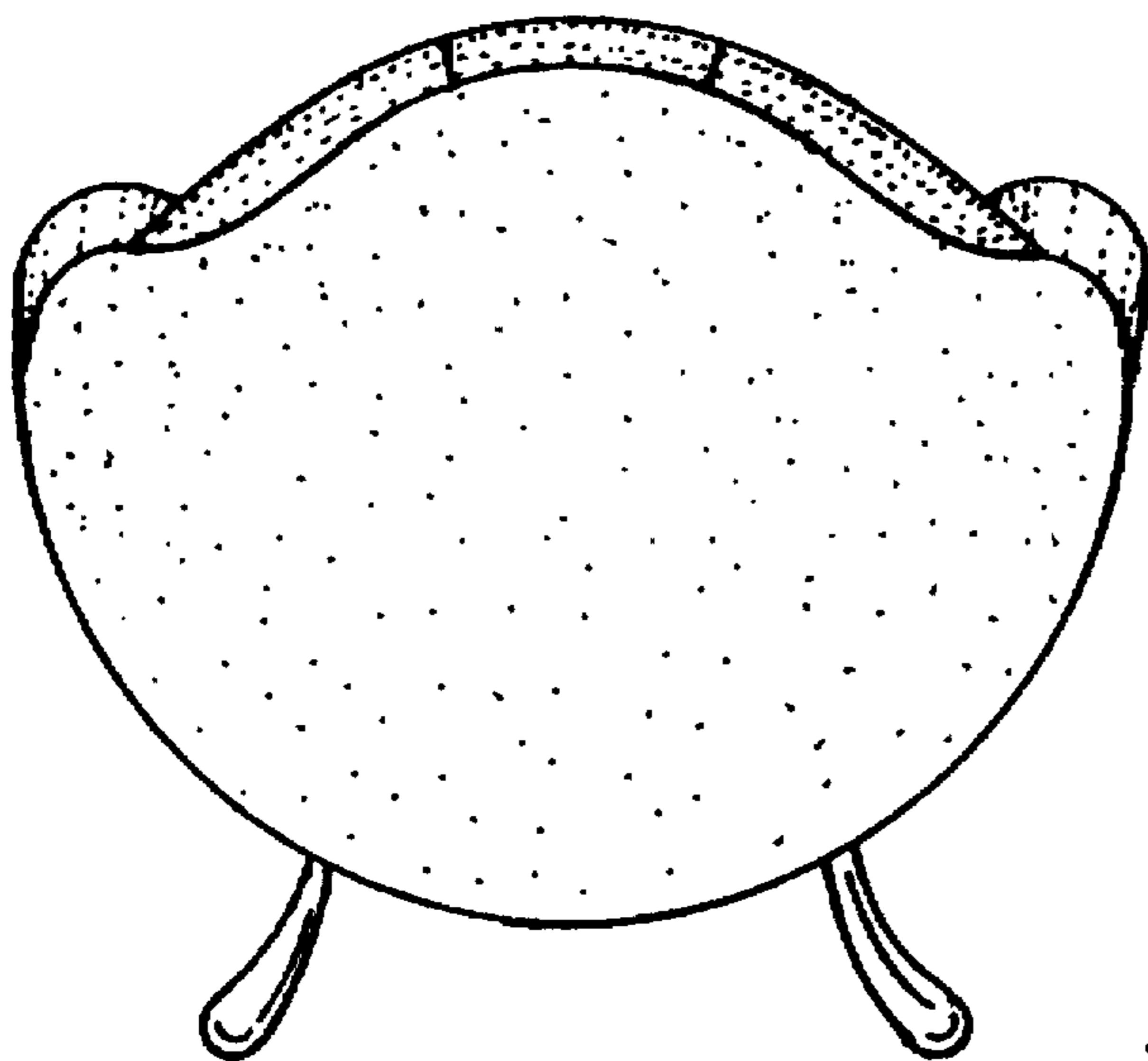

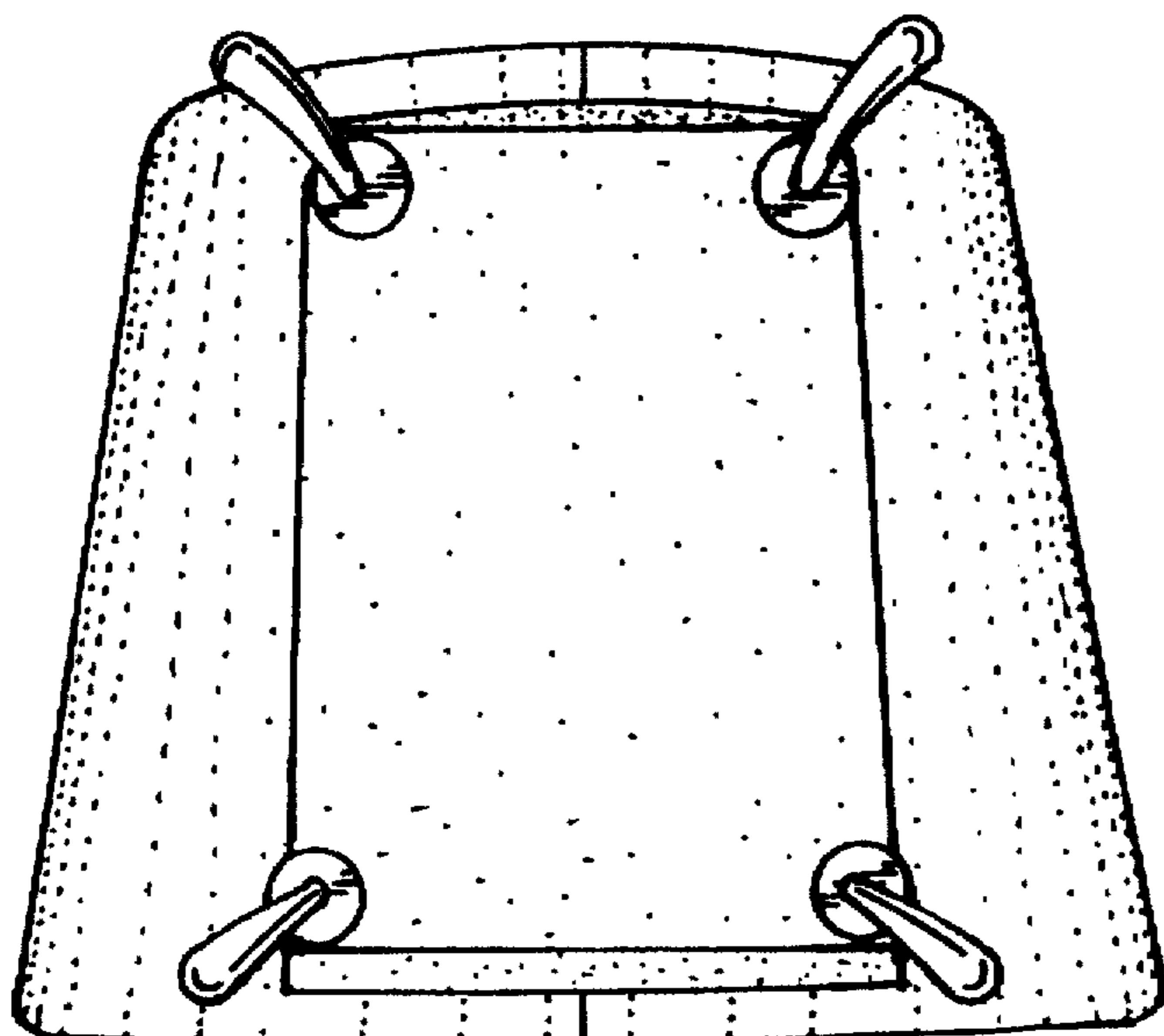

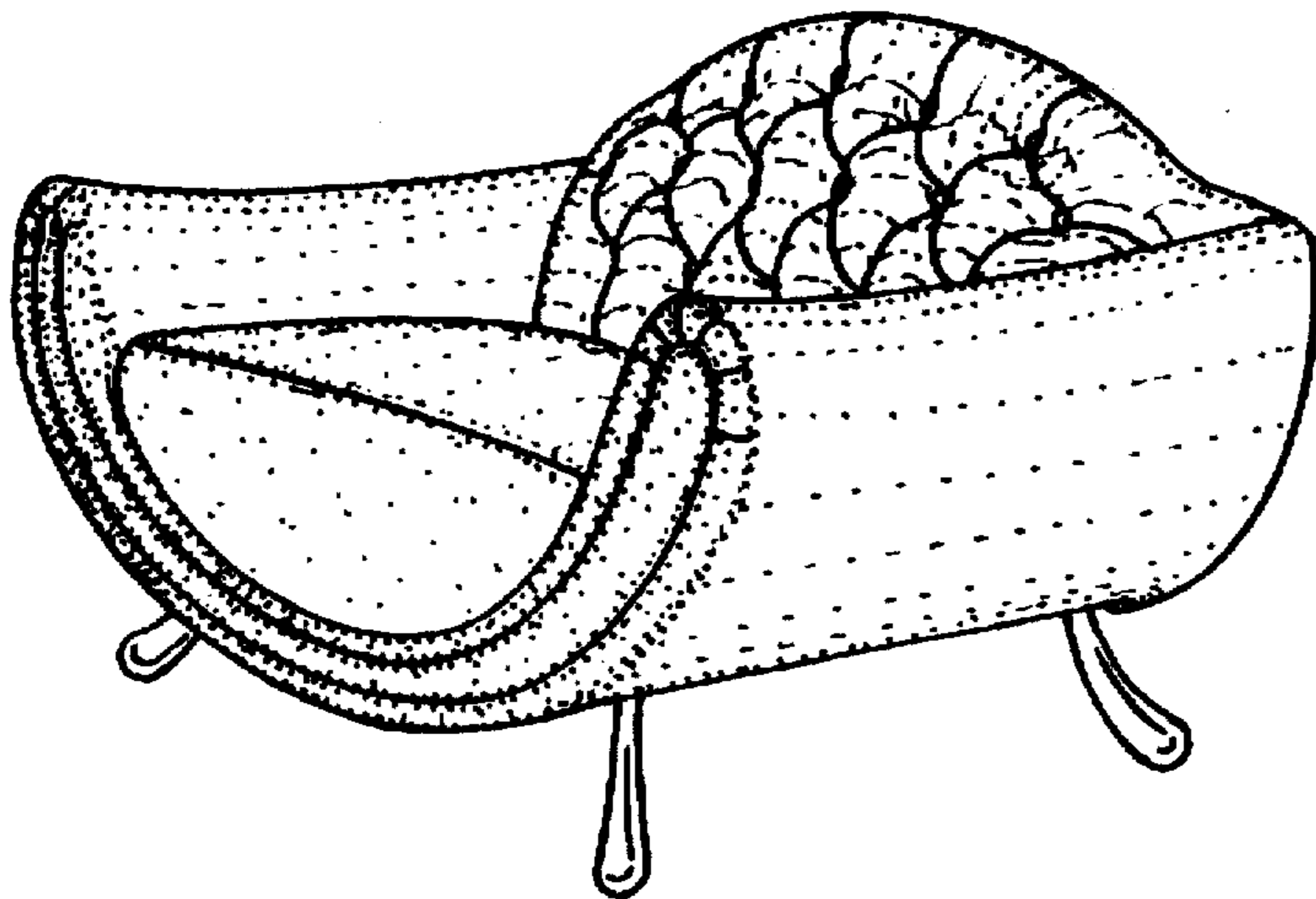

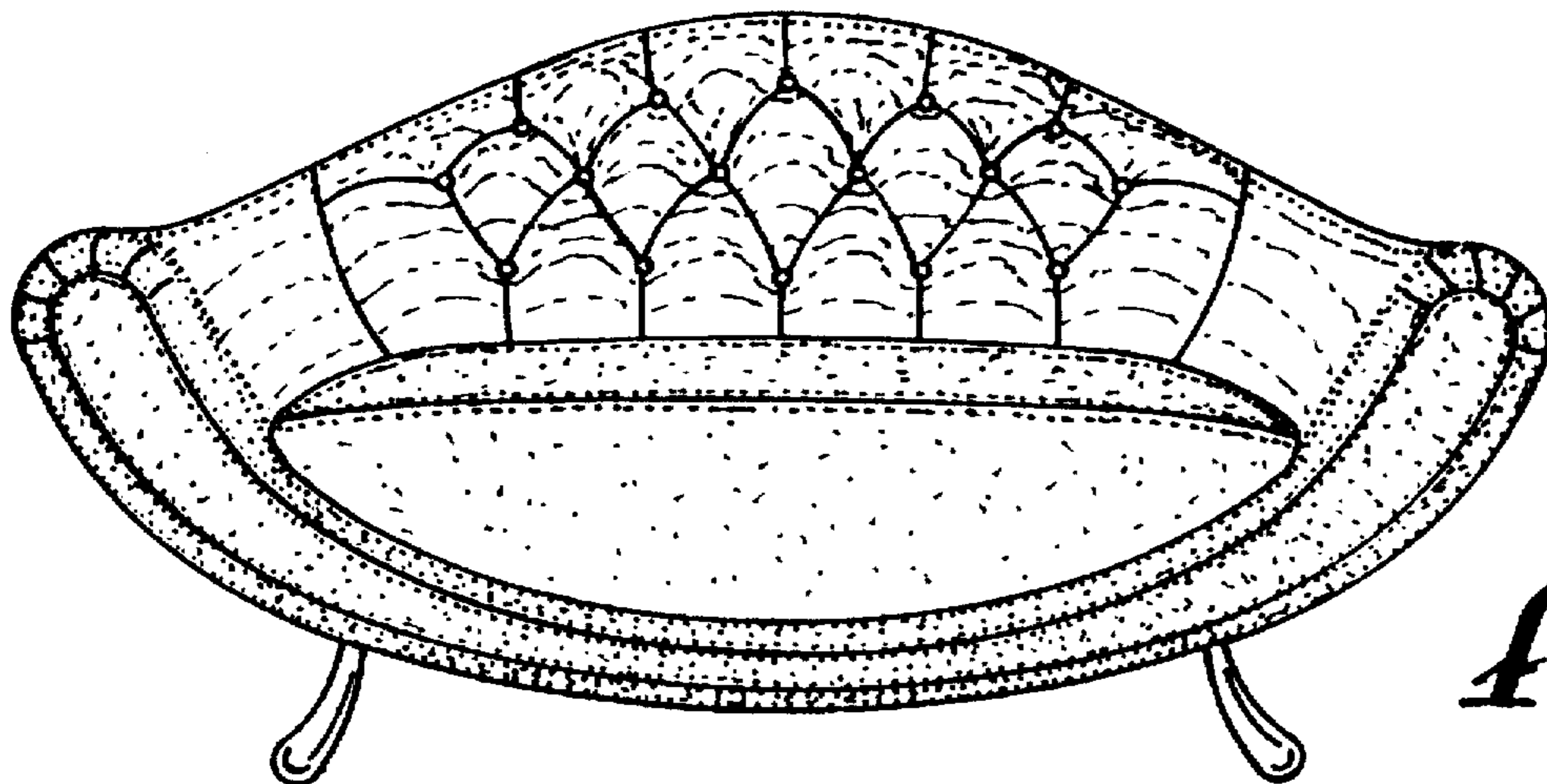

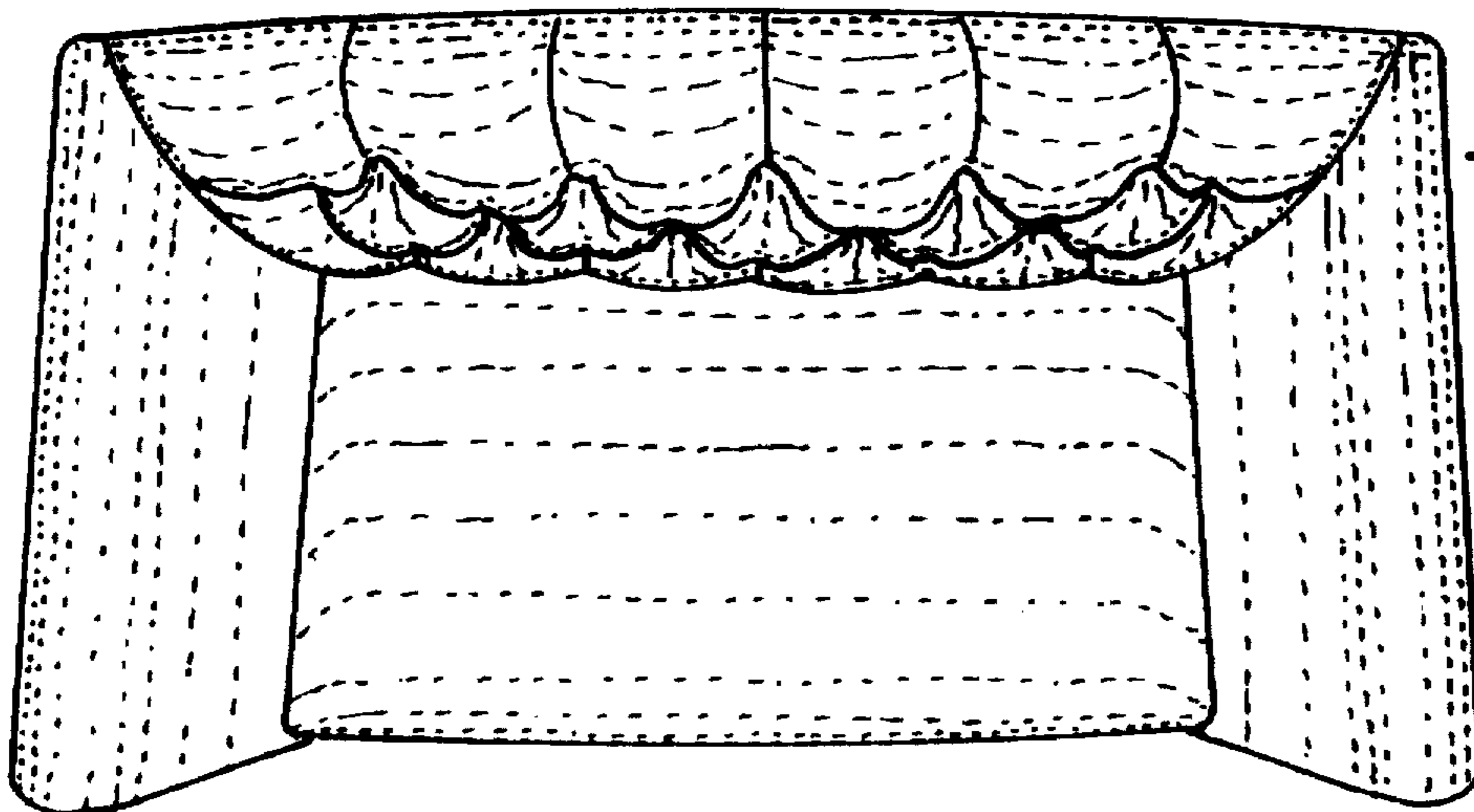

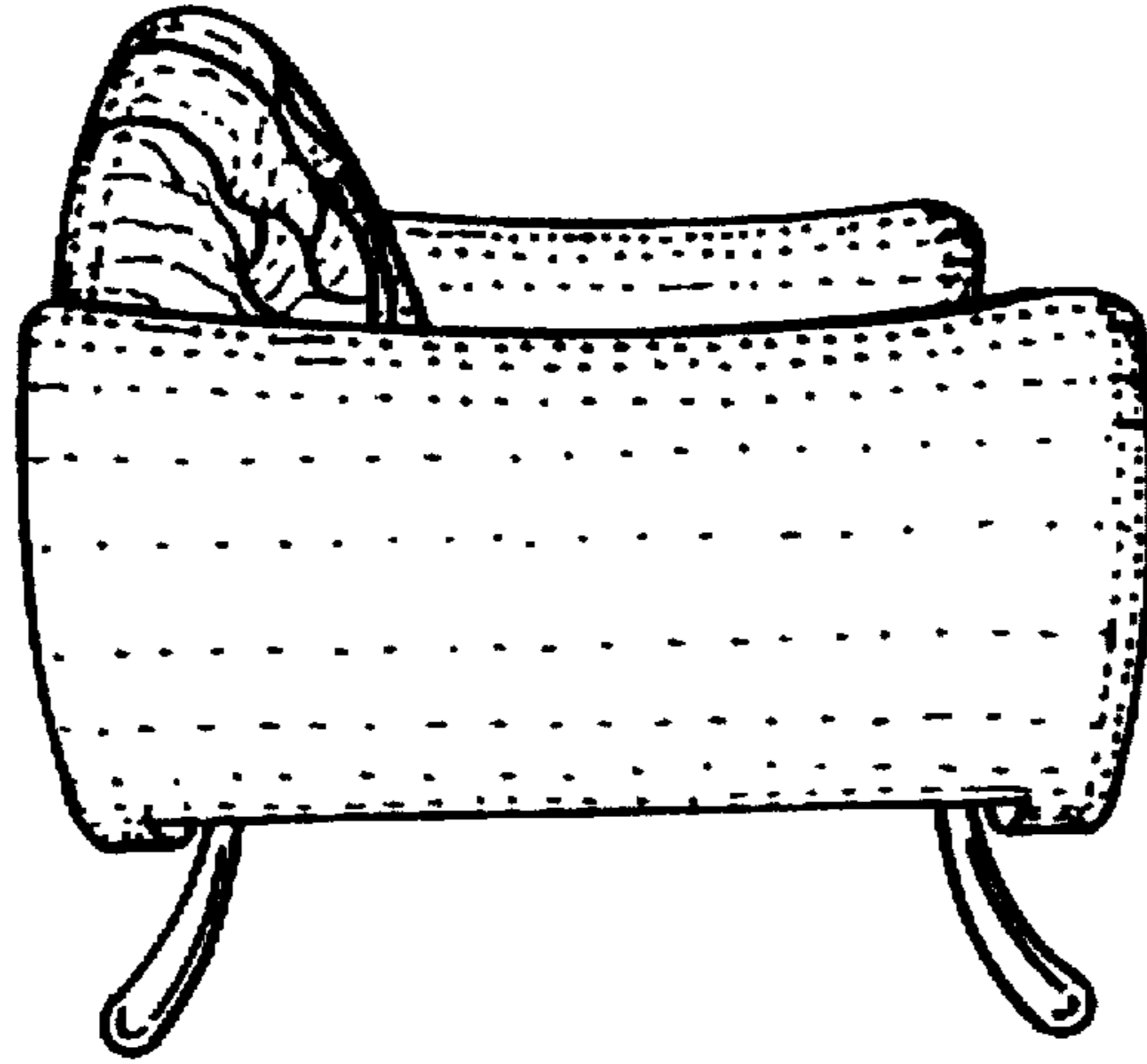

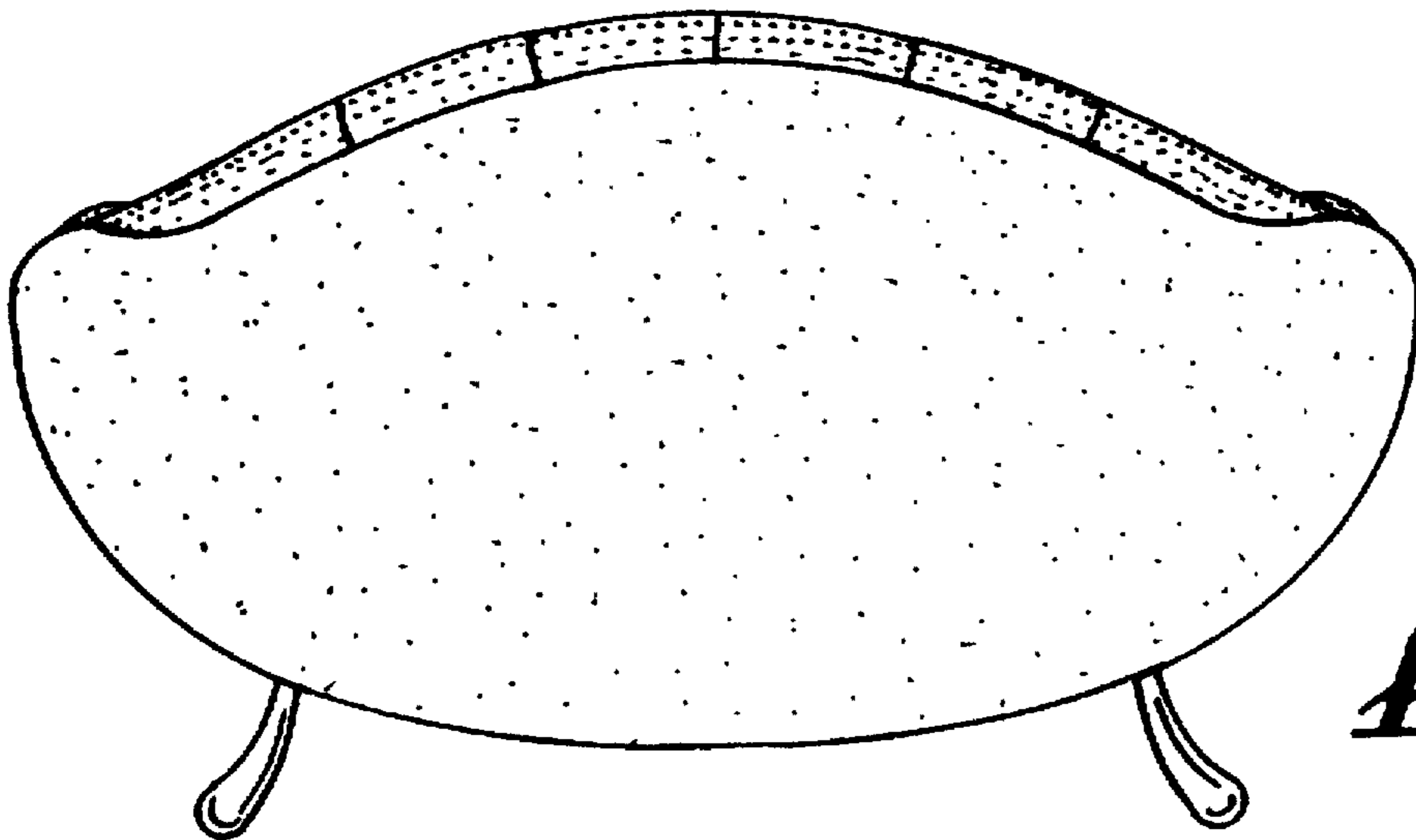

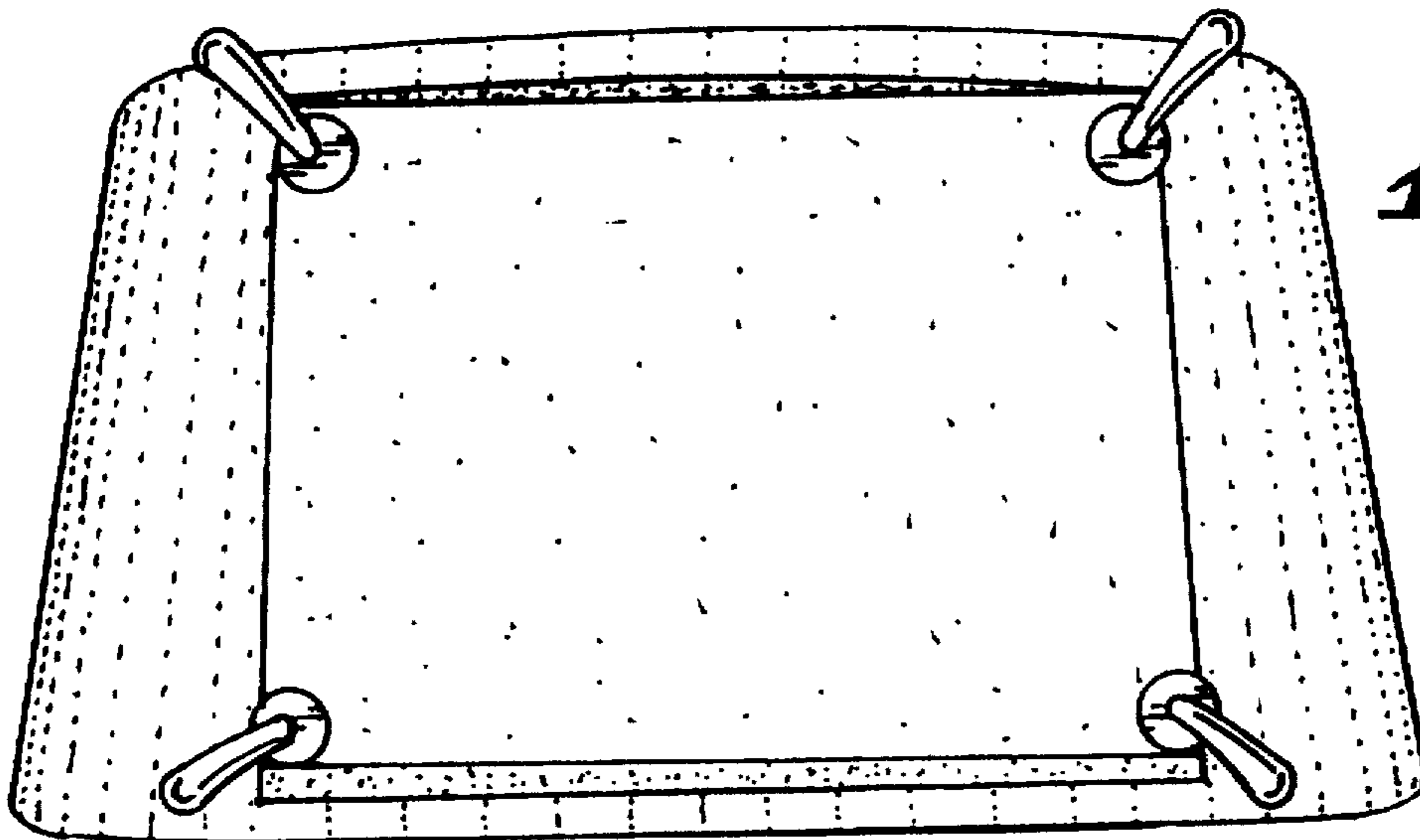
