FIG. 1 is a top right front perspective view of a water cooler showing my new design;

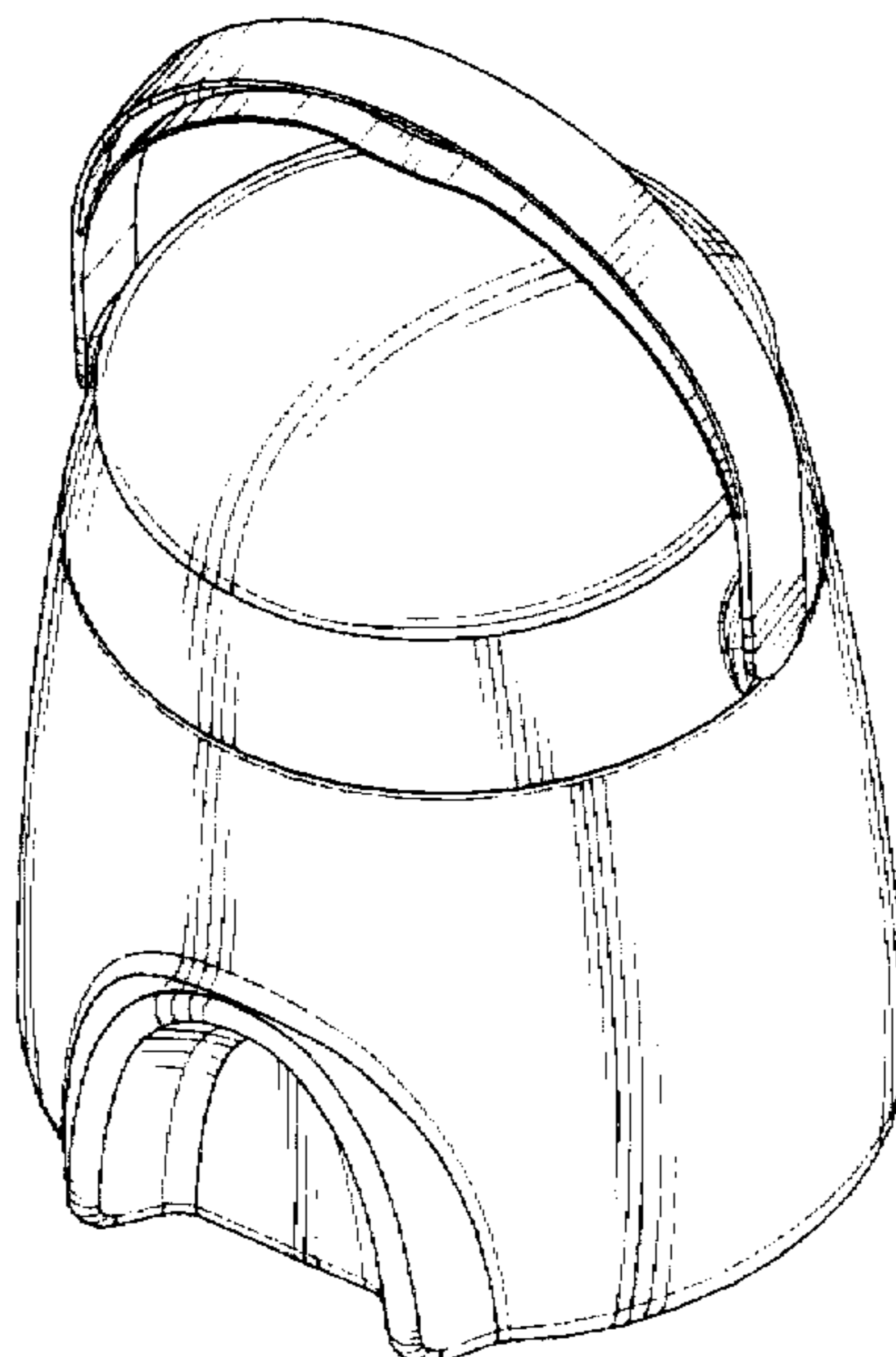
FIG. 2 is a left side elevational view thereof; the right side elevational view being a mirror image;

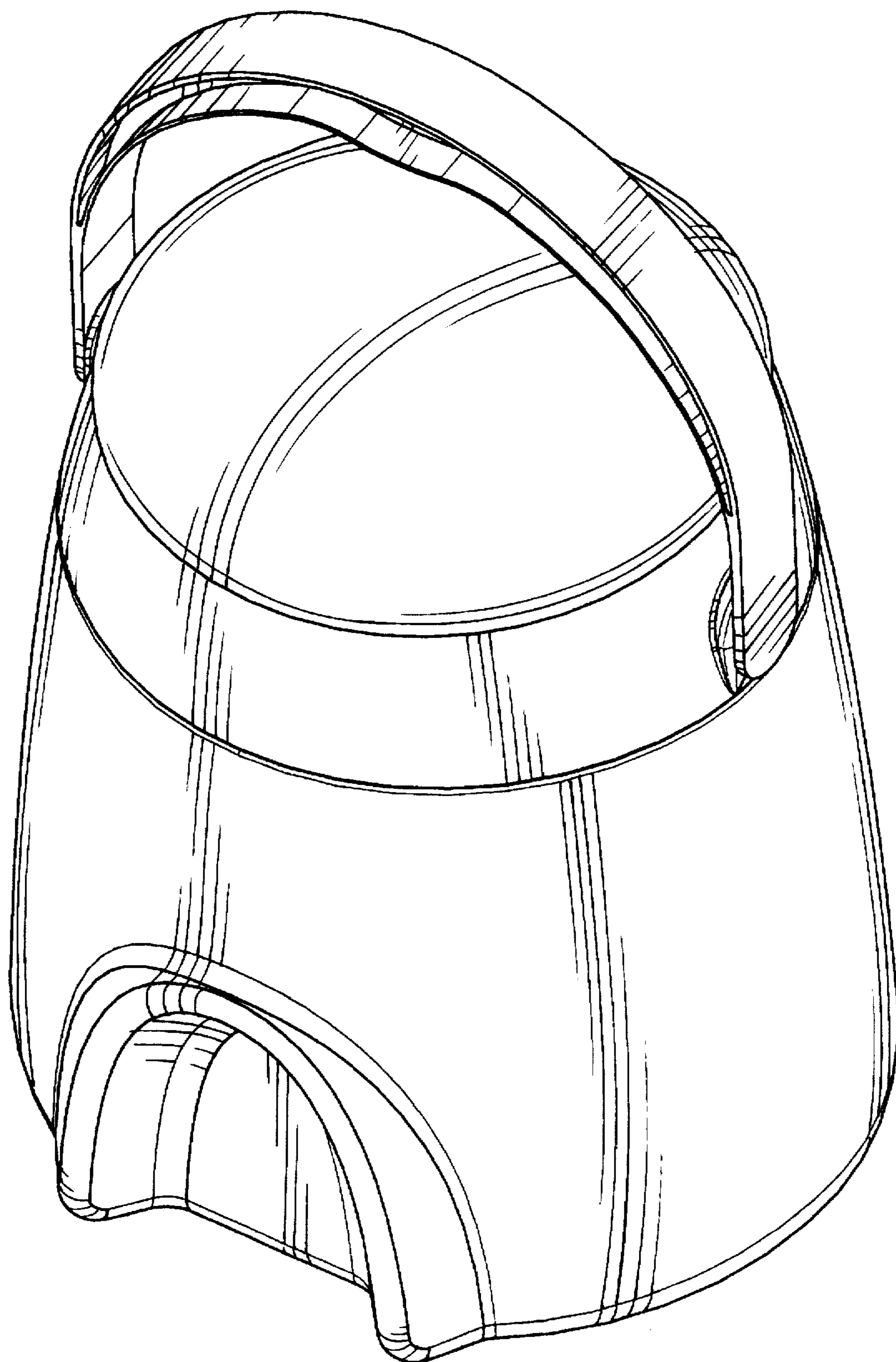

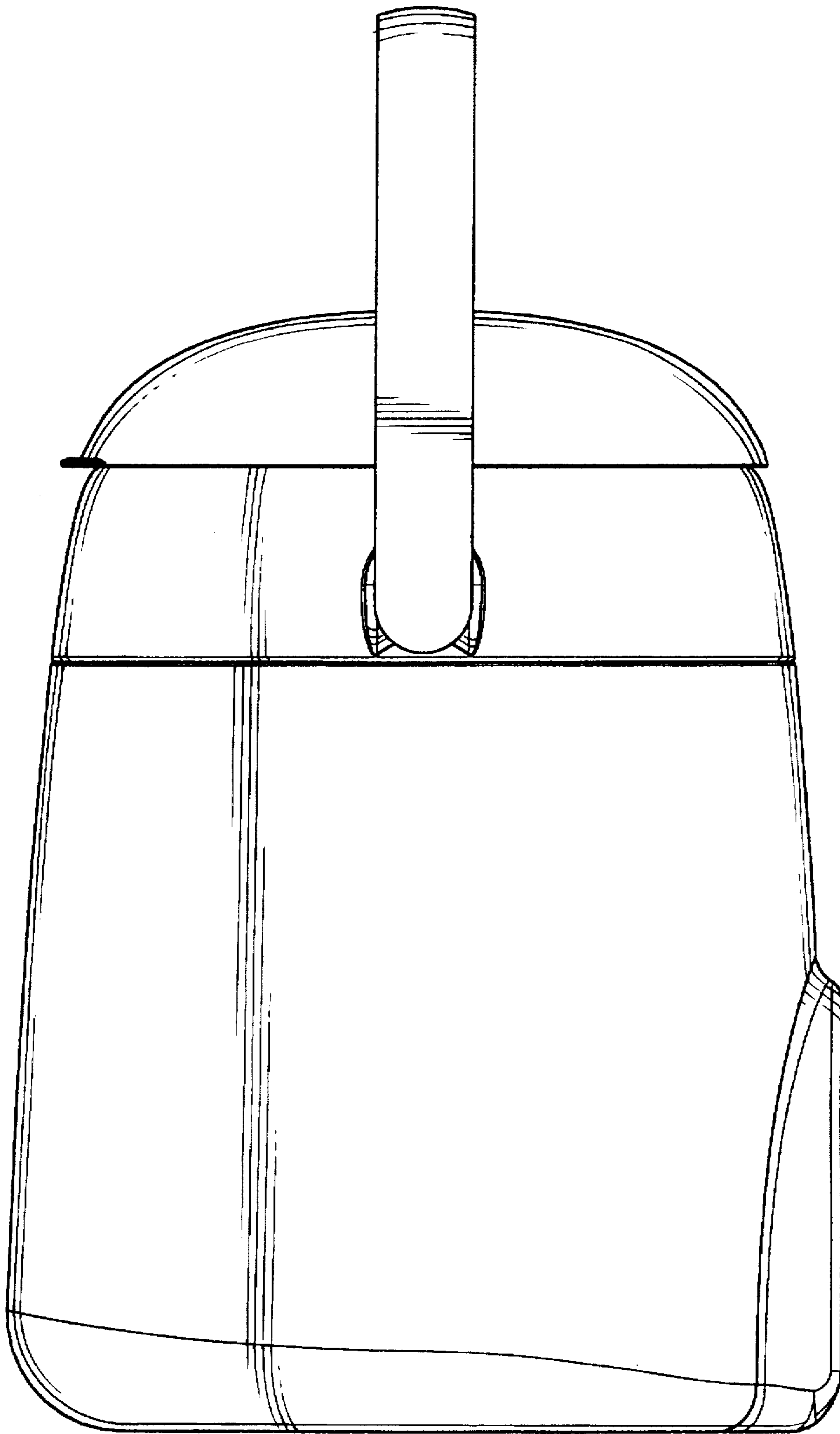

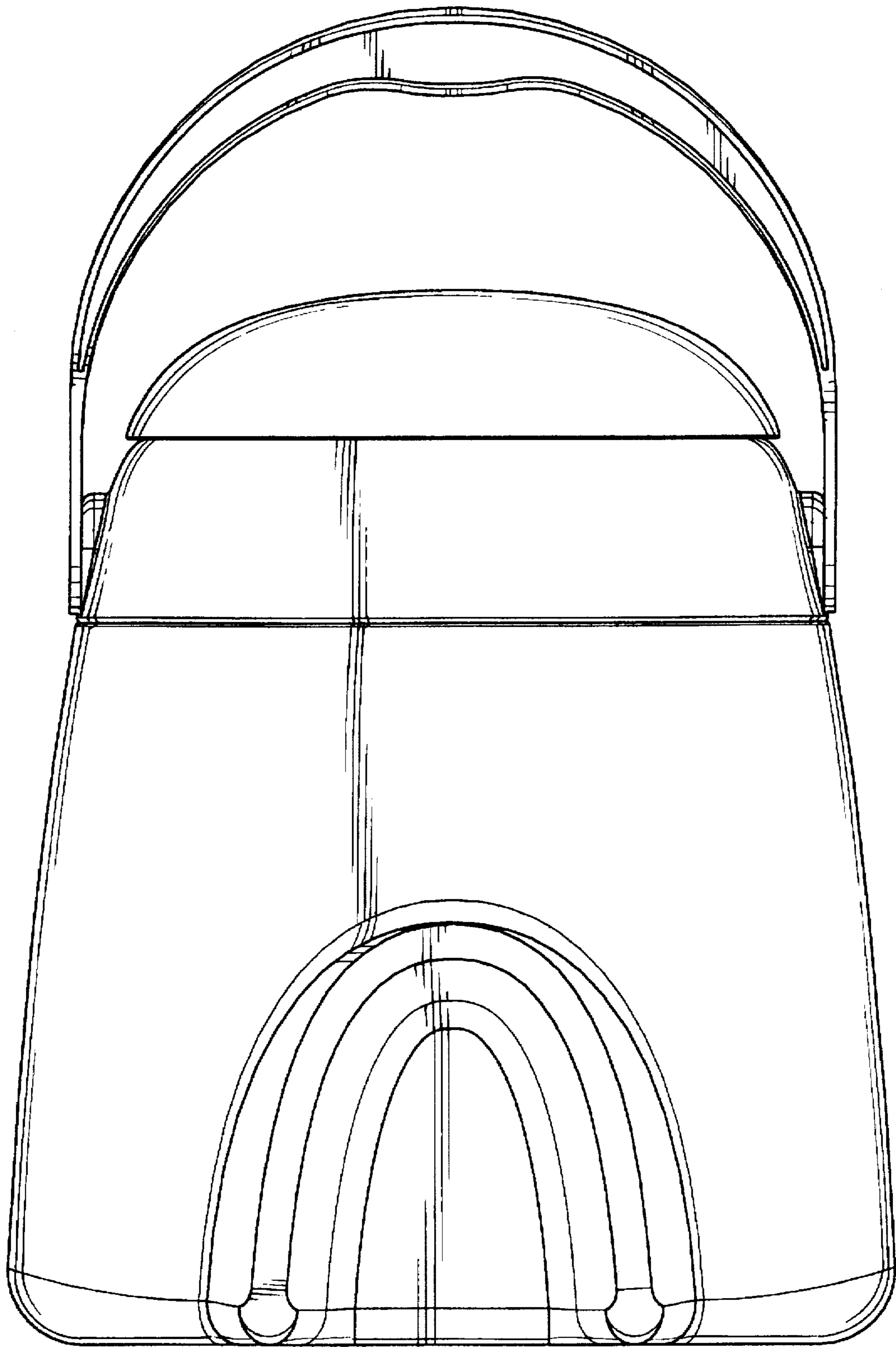

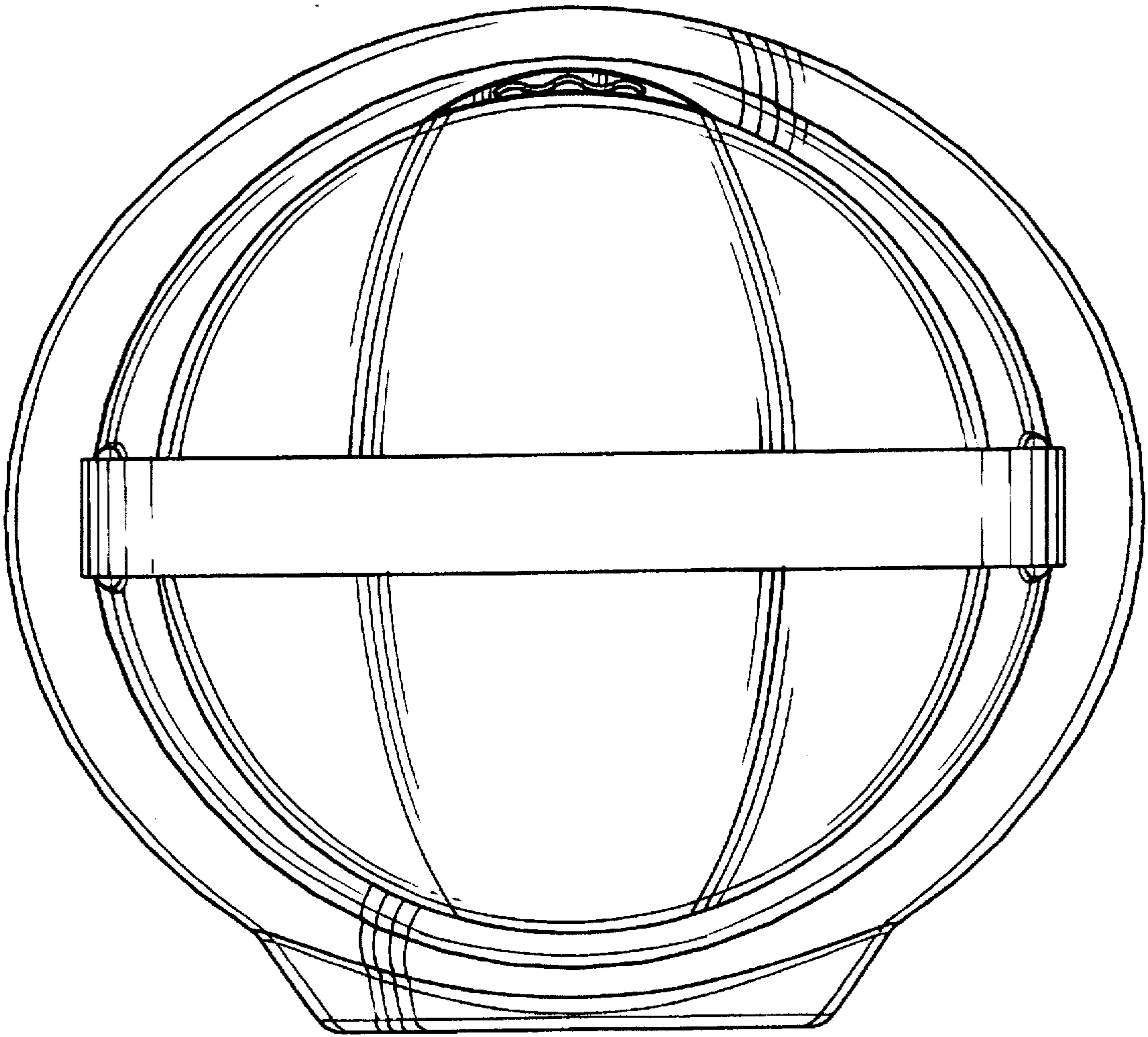

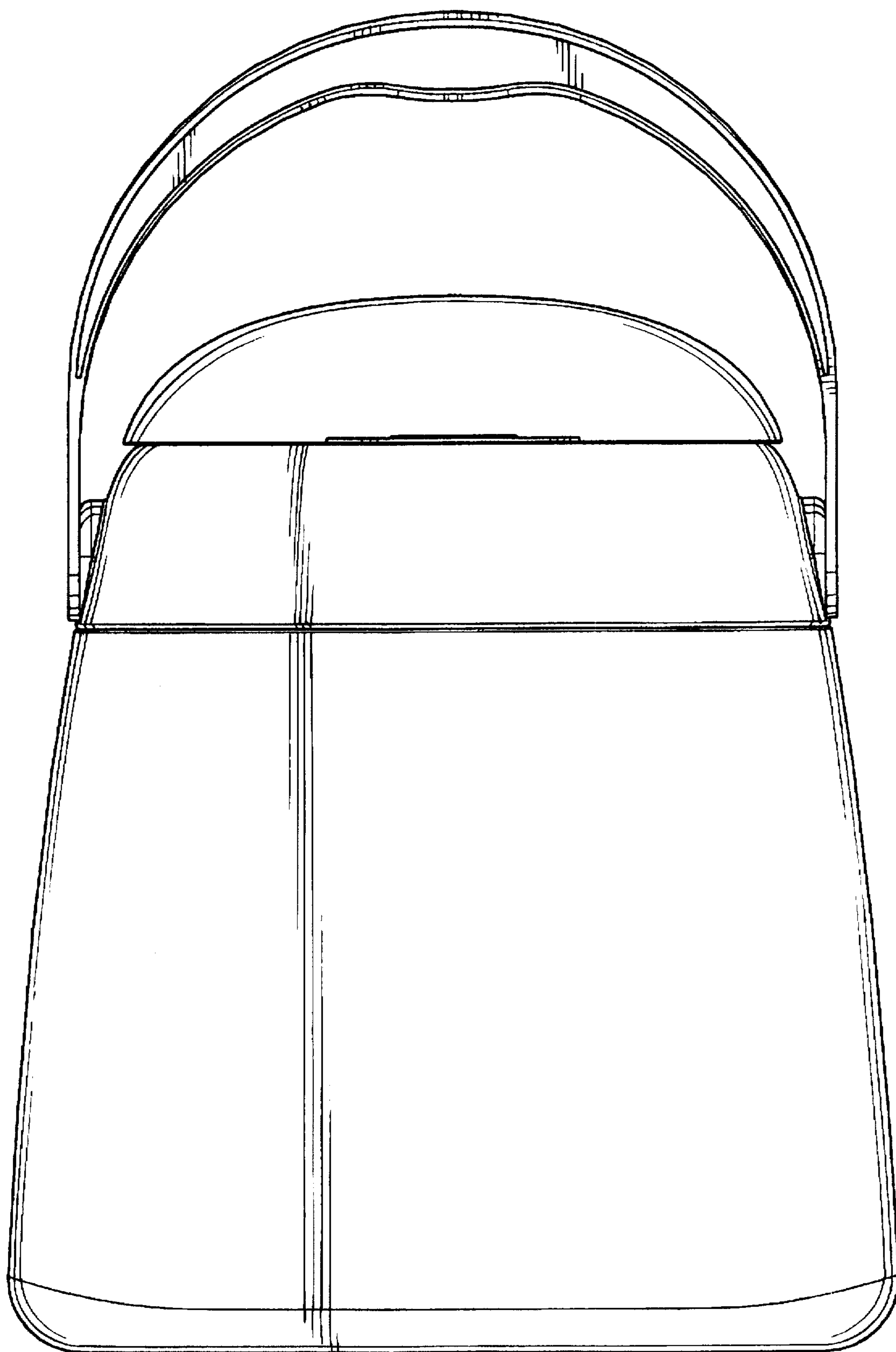
