[57] **CLAIM**

The ornamental design for a cutlery tool for potatoes, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a cutlery tool for potatoes showing my new design, the opposite side being a mirror image;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a side elevation view of an alternate embodiment of FIG. 1, the opposite side being a mirror image;

FIG. 7 is a front elevation view of FIG. 6;

FIG. 8 is a rear elevation of view FIG. 6;

FIG. 9 is a bottom plan view of FIG. 6;

FIG. 10 is a top plan view of FIG. 6;

FIG. 11 is a side elevation view of an alternate embodiment of FIG. 1, the opposite side being a mirror image;

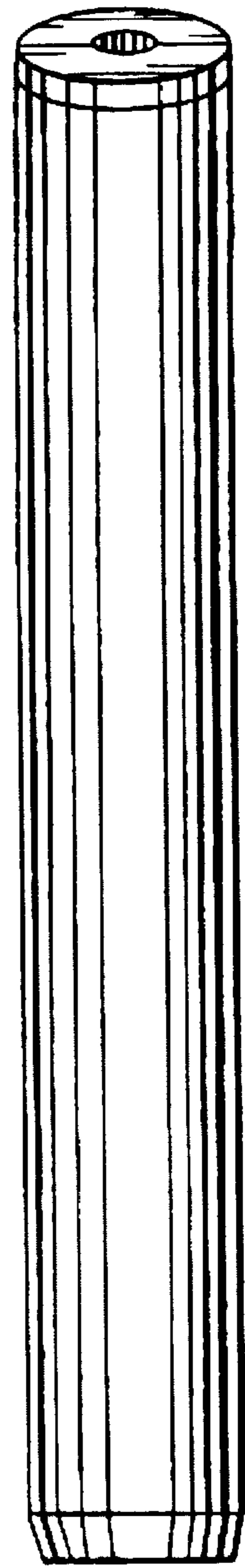
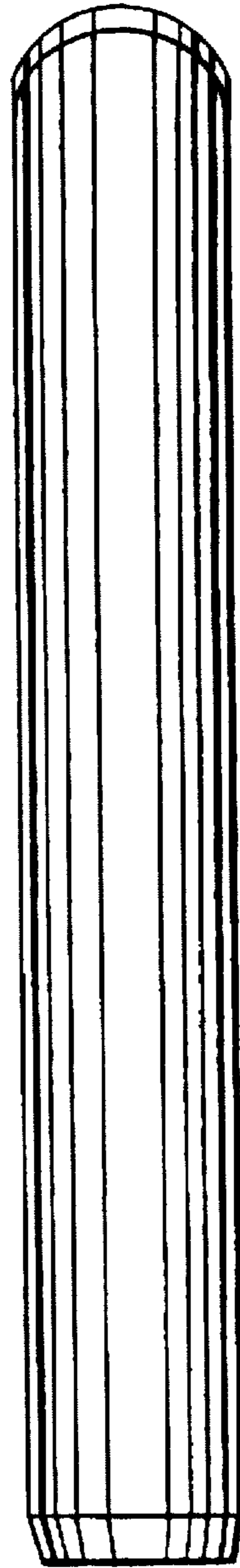


FIG. 12 FIG. 13

FIG. 12 is a front elevation view of FIG. 11;

FIG. 13 is a rear elevation view of FIG. 11;

FIG. 14 is a bottom plan view of FIG. 11; and,

FIG. 15 is a top plan view of FIG. 11.

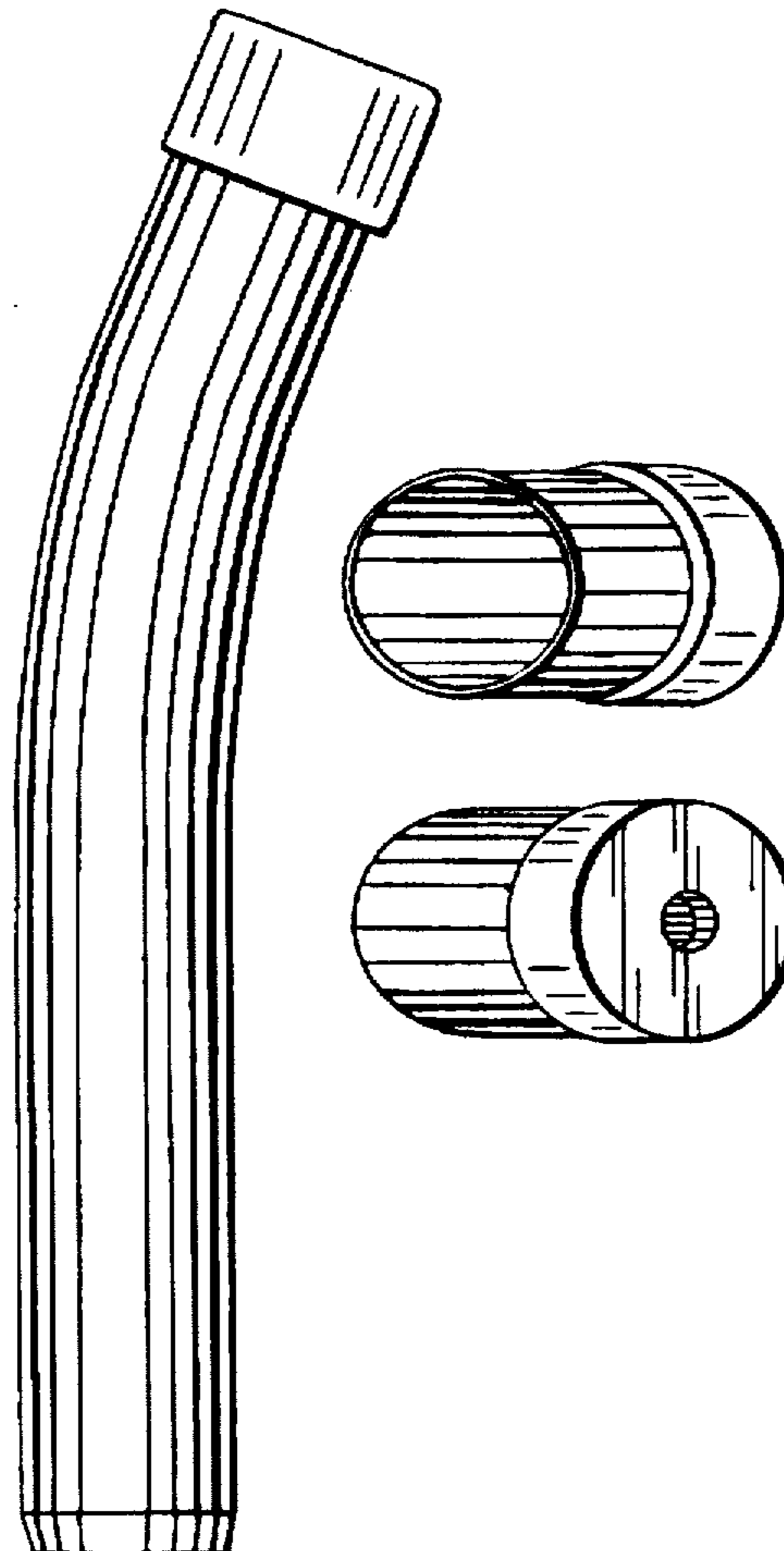

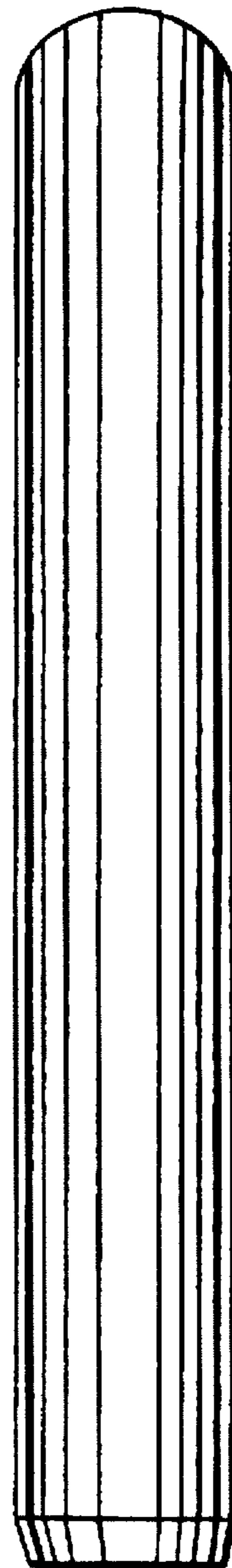

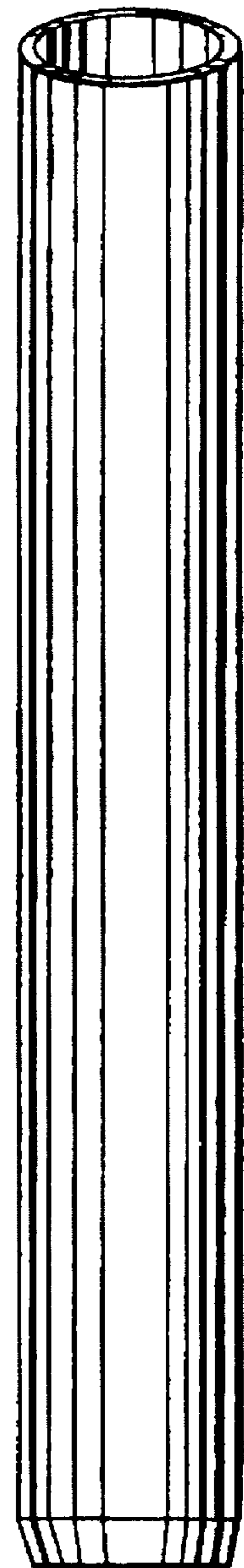

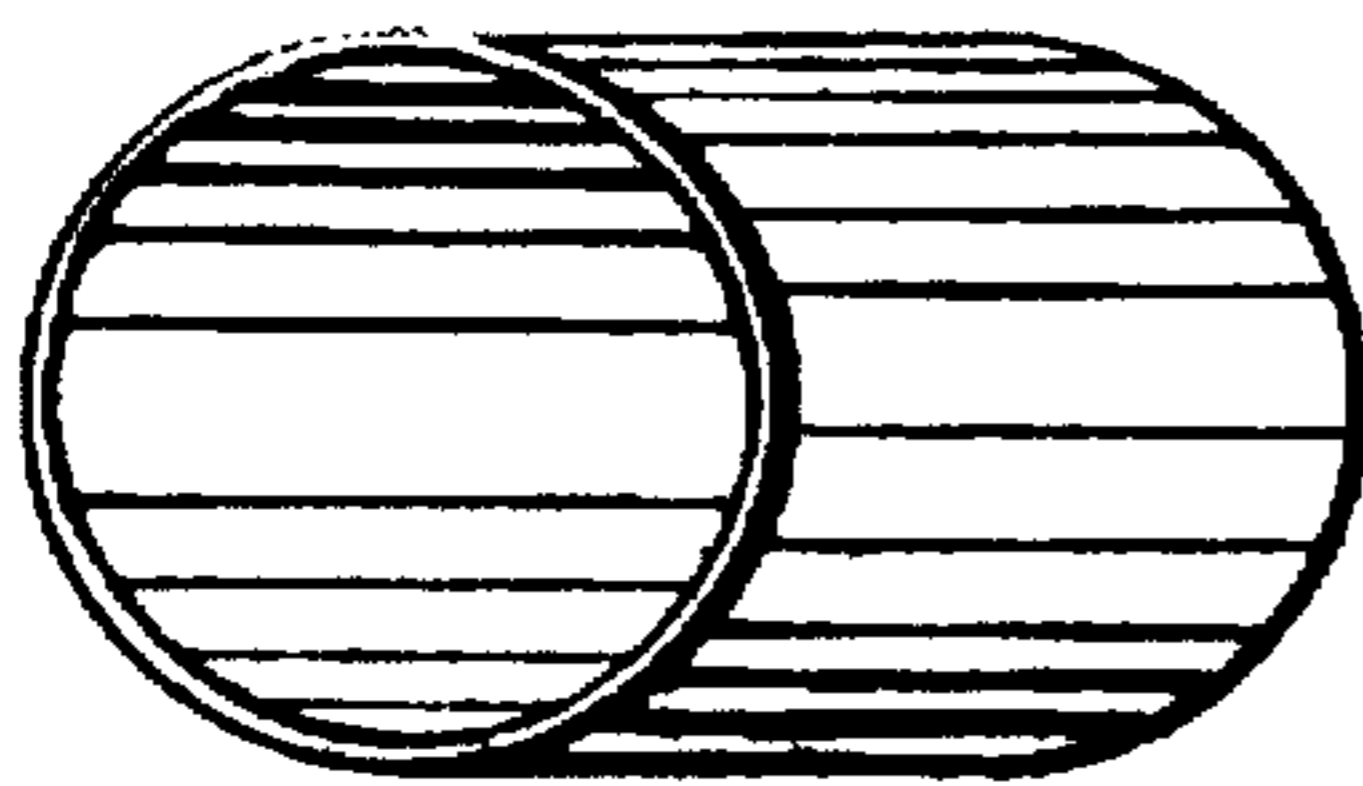

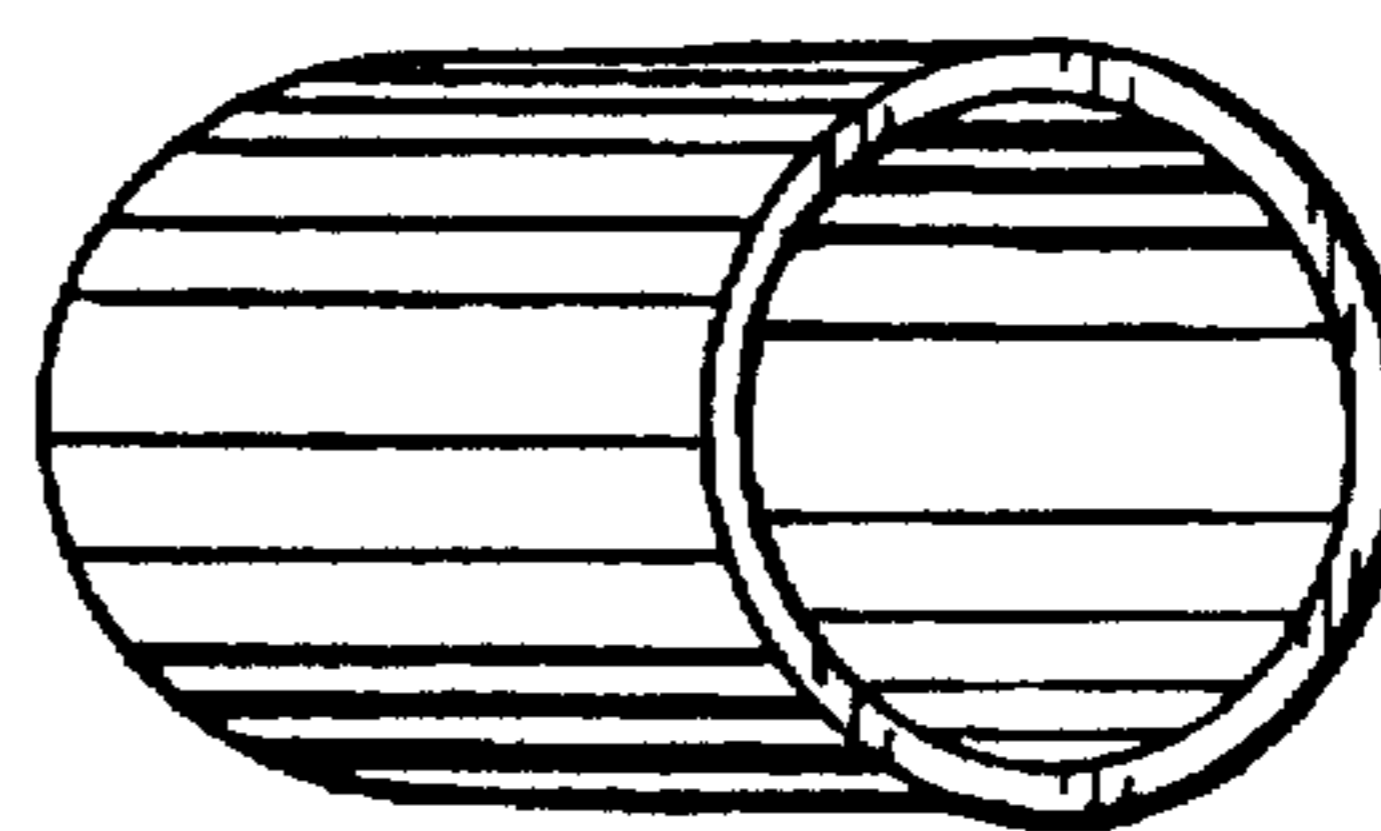

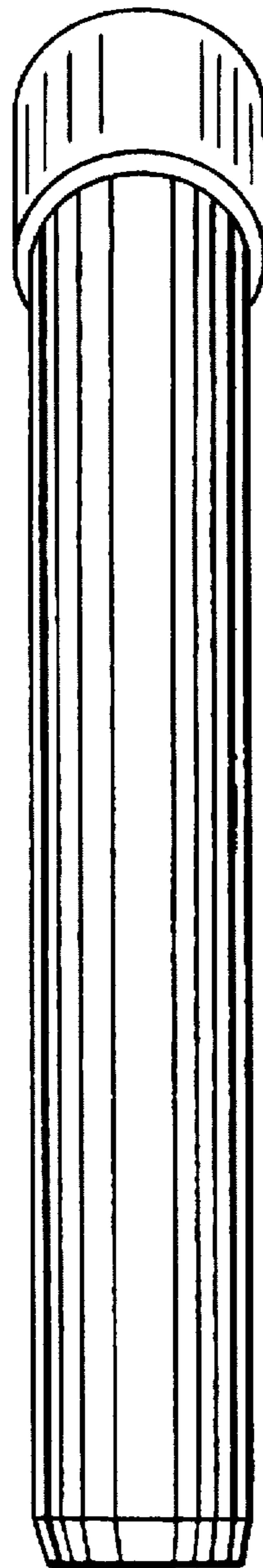

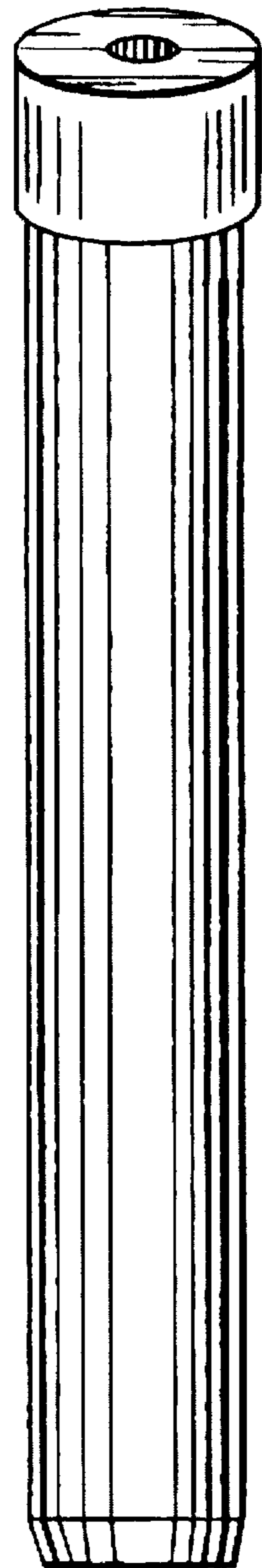

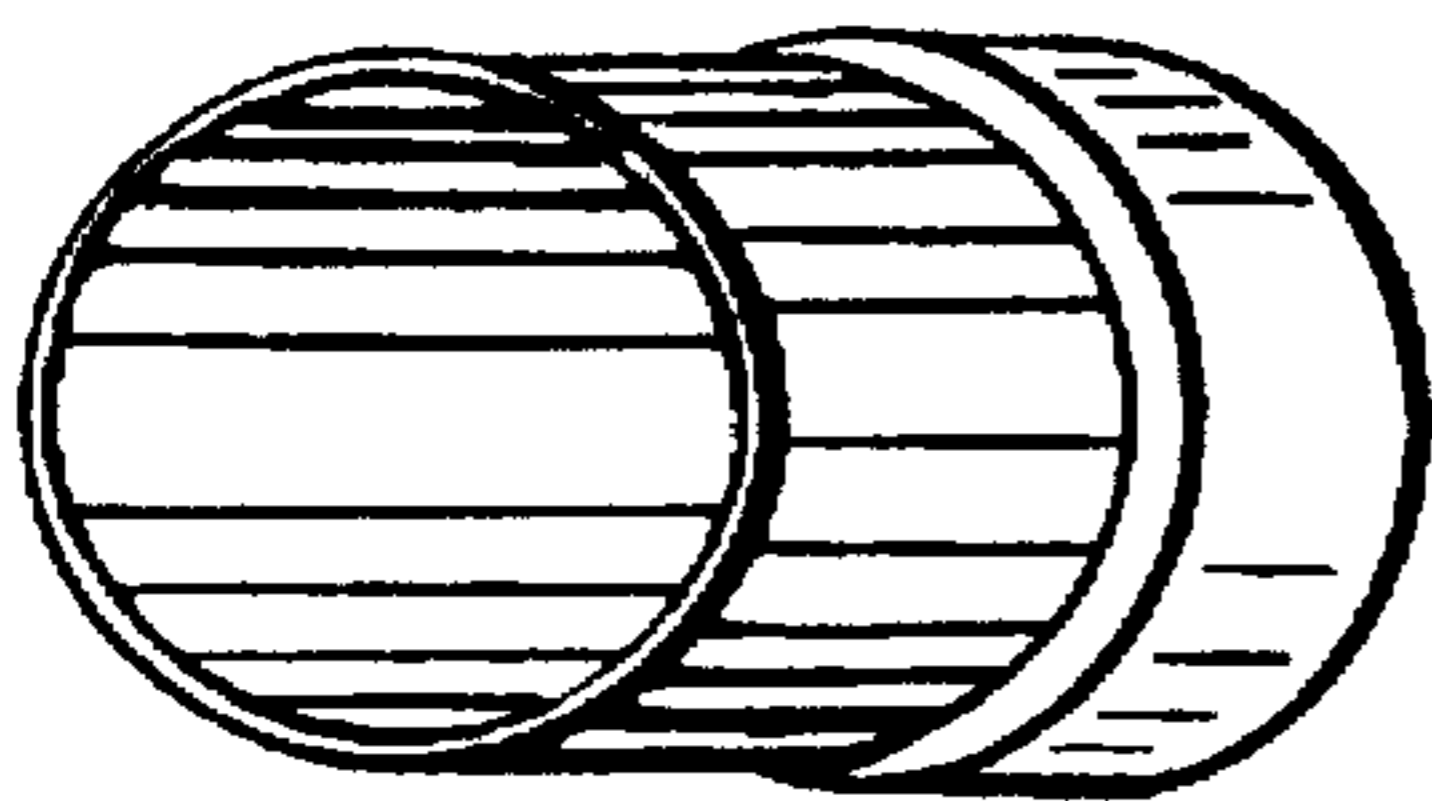

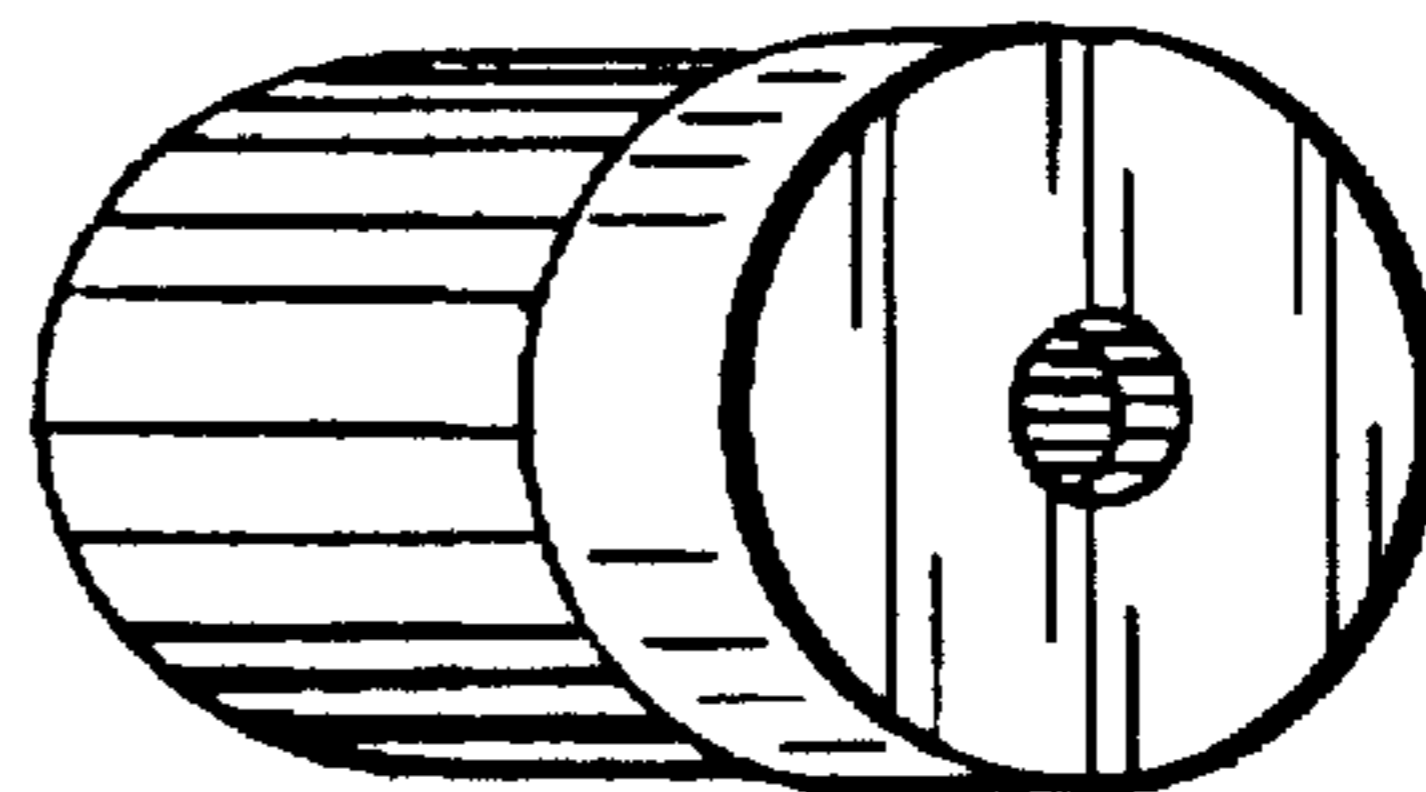

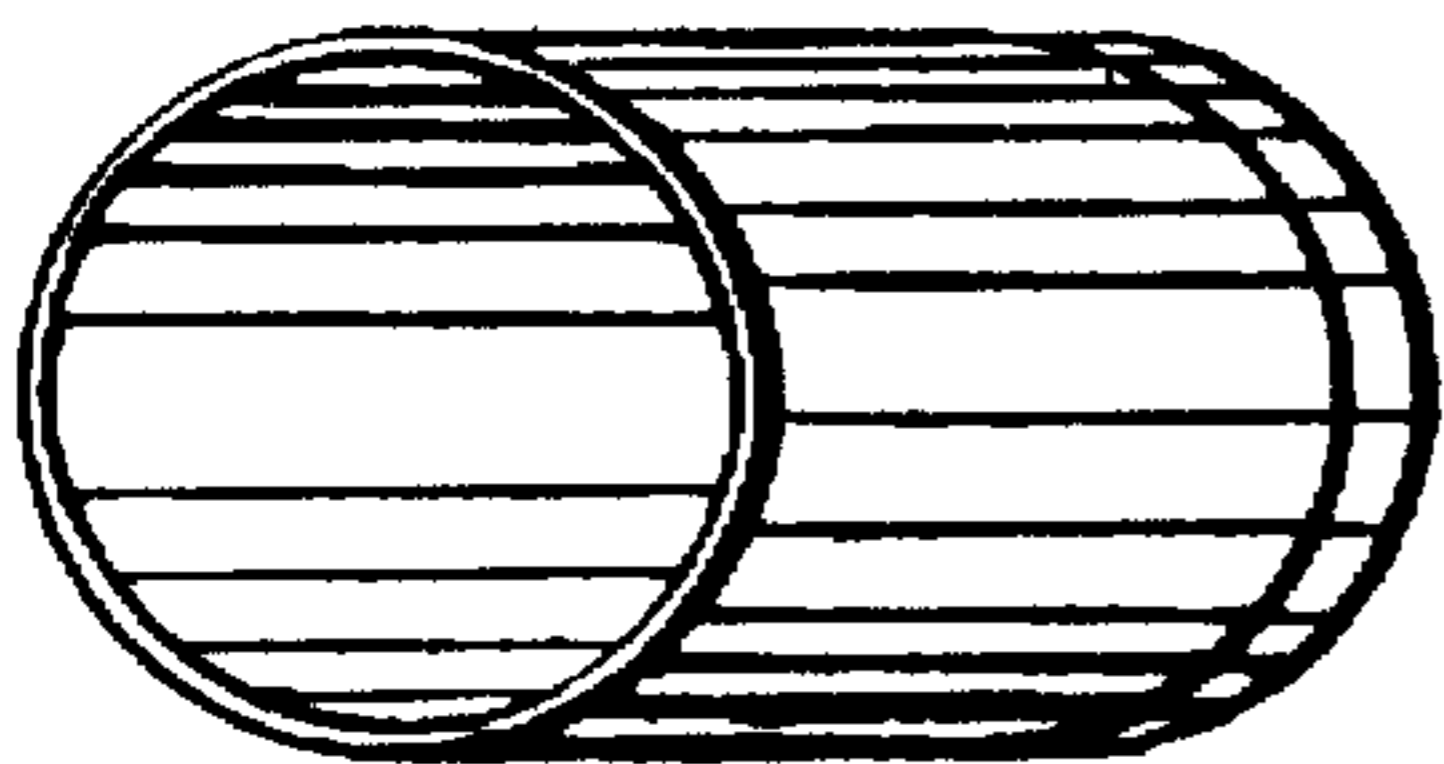

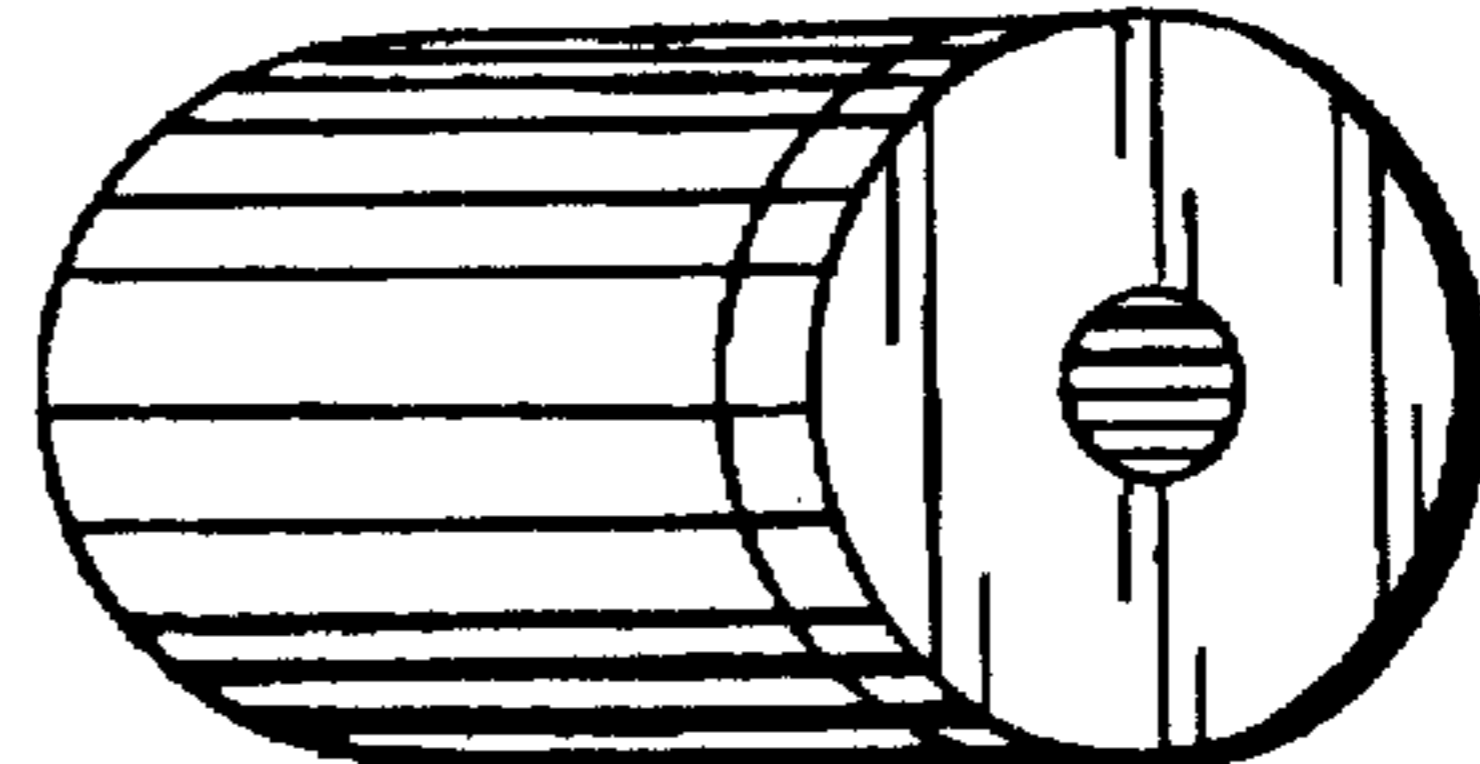
