[57] **CLAIM**

The ornamental design for a mobile telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the mobile telephone showing our new design with the flipper in an open position; FIG. 2 is a front, left side and bottom perspective view thereof with the flipper in an open position; FIG. 3 is a top plan view thereof with the flipper in an open position; FIG. 4 is a bottom plan view thereof with the flipper in an open position; FIG. 5 is a right side elevational view thereof with the flipper in an open position; FIG. 6 is a left side elevational view thereof with the flipper in an open position; FIG. 7 is a back, right side and top perspective view thereof with the flipper in a closed position; FIG. 8 is a back elevational view thereof with the flipper in a closed position; FIG. 9 is a front elevational view thereof with the flipper in a closed position; FIG. 10 is a front, left side and bottom perspective view thereof with the flipper in a closed position; FIG. 11 is a top plan view thereof with the flipper in a closed position; FIG. 12 is a bottom plan view thereof with the flipper in a closed position; FIG. 13 is a right side elevational view thereof with the flipper in a closed position; and, FIG. 14 is a left elevational view thereof with the flipper in a closed position.

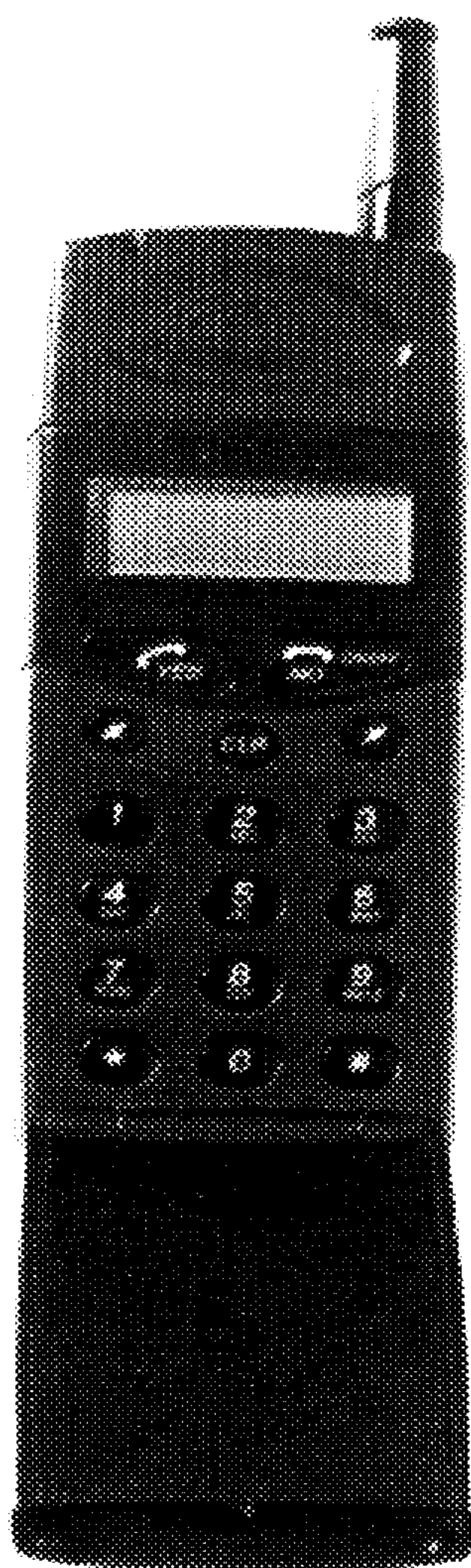

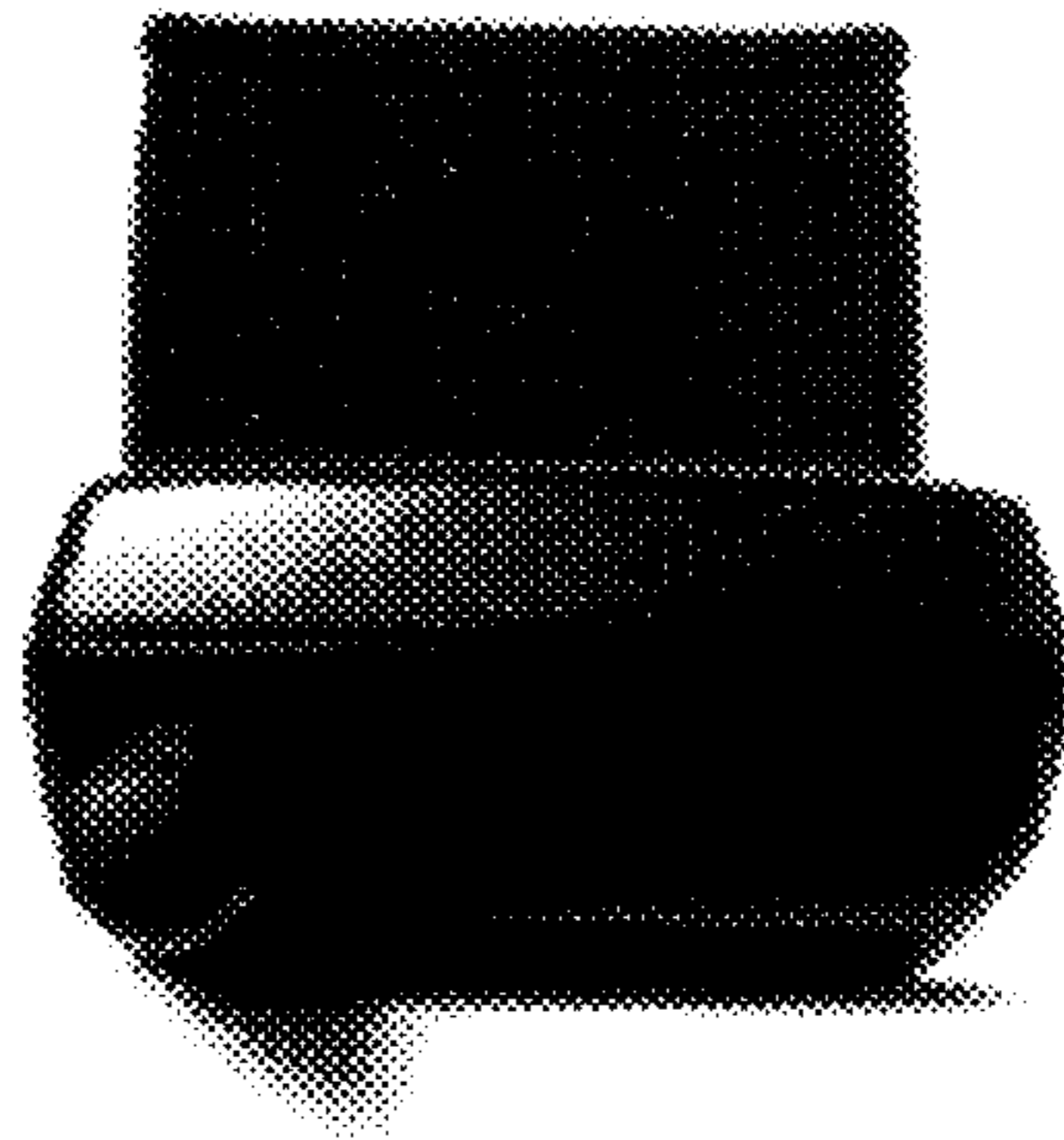

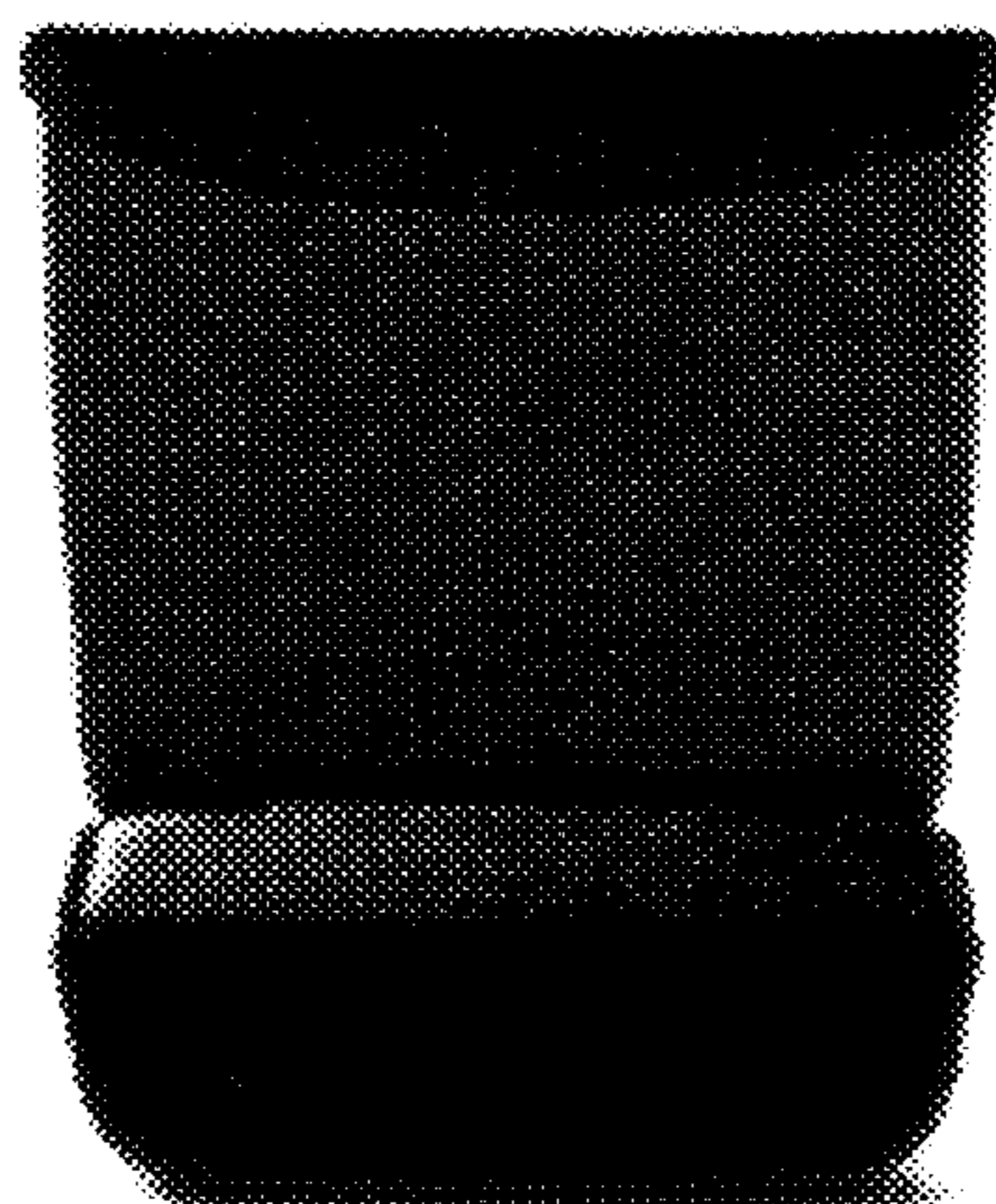

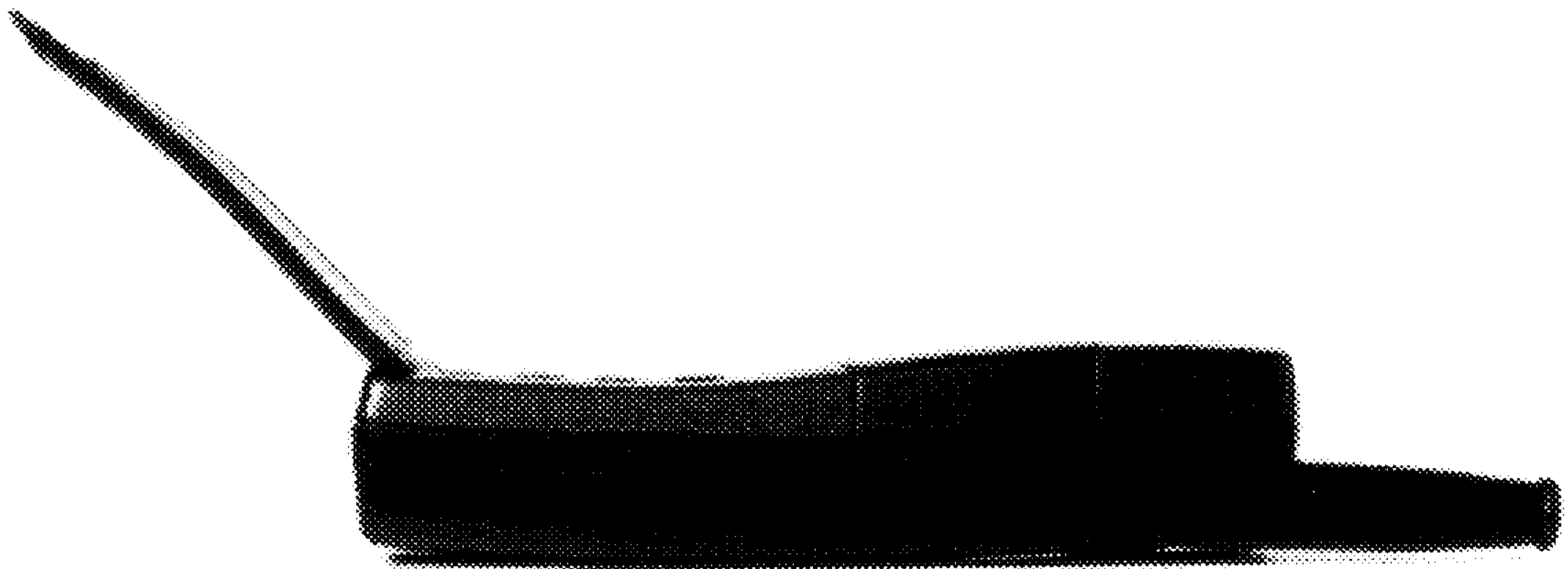

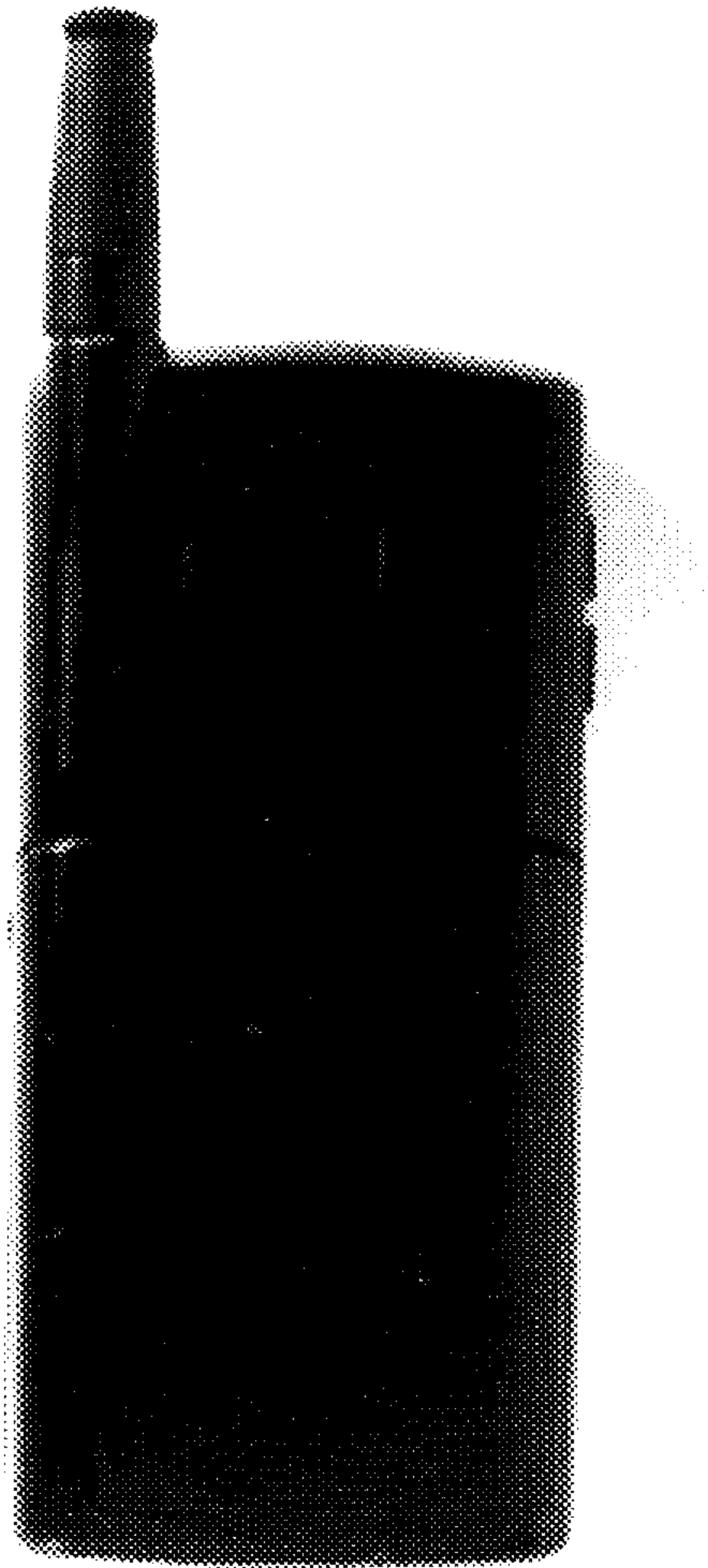

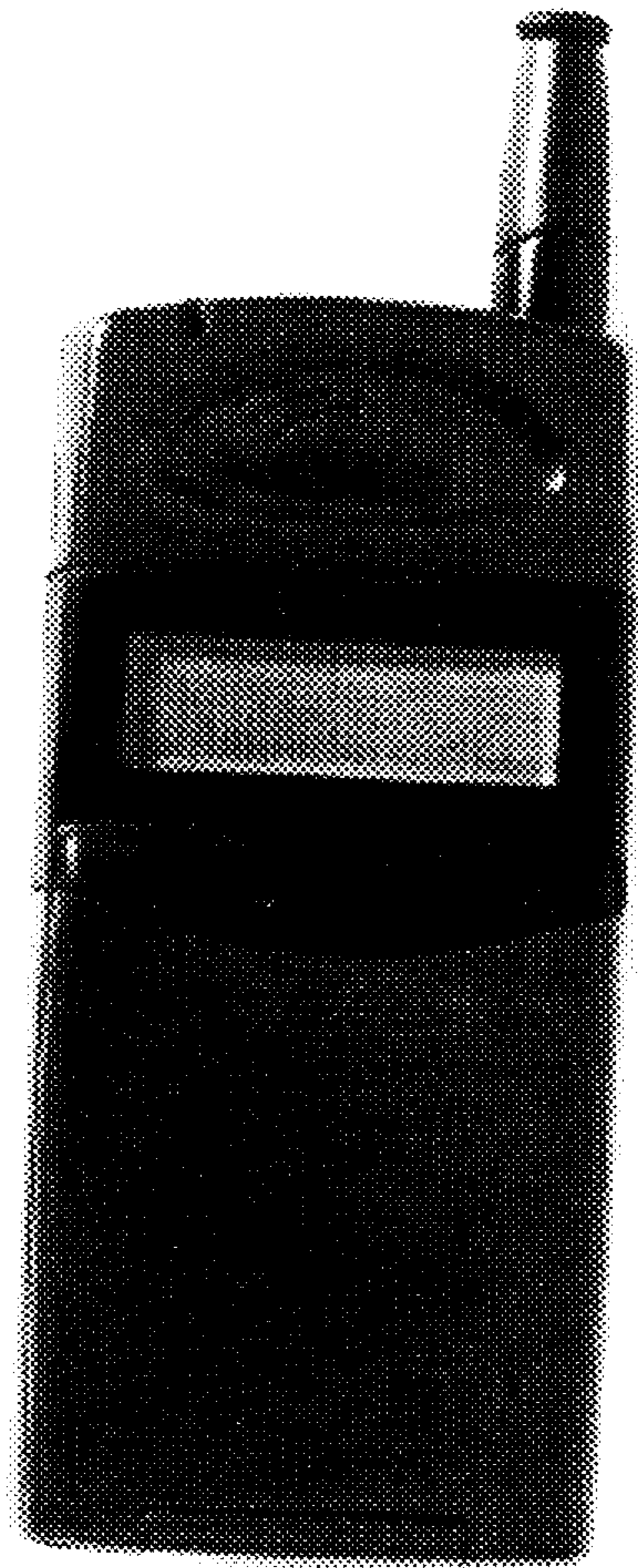

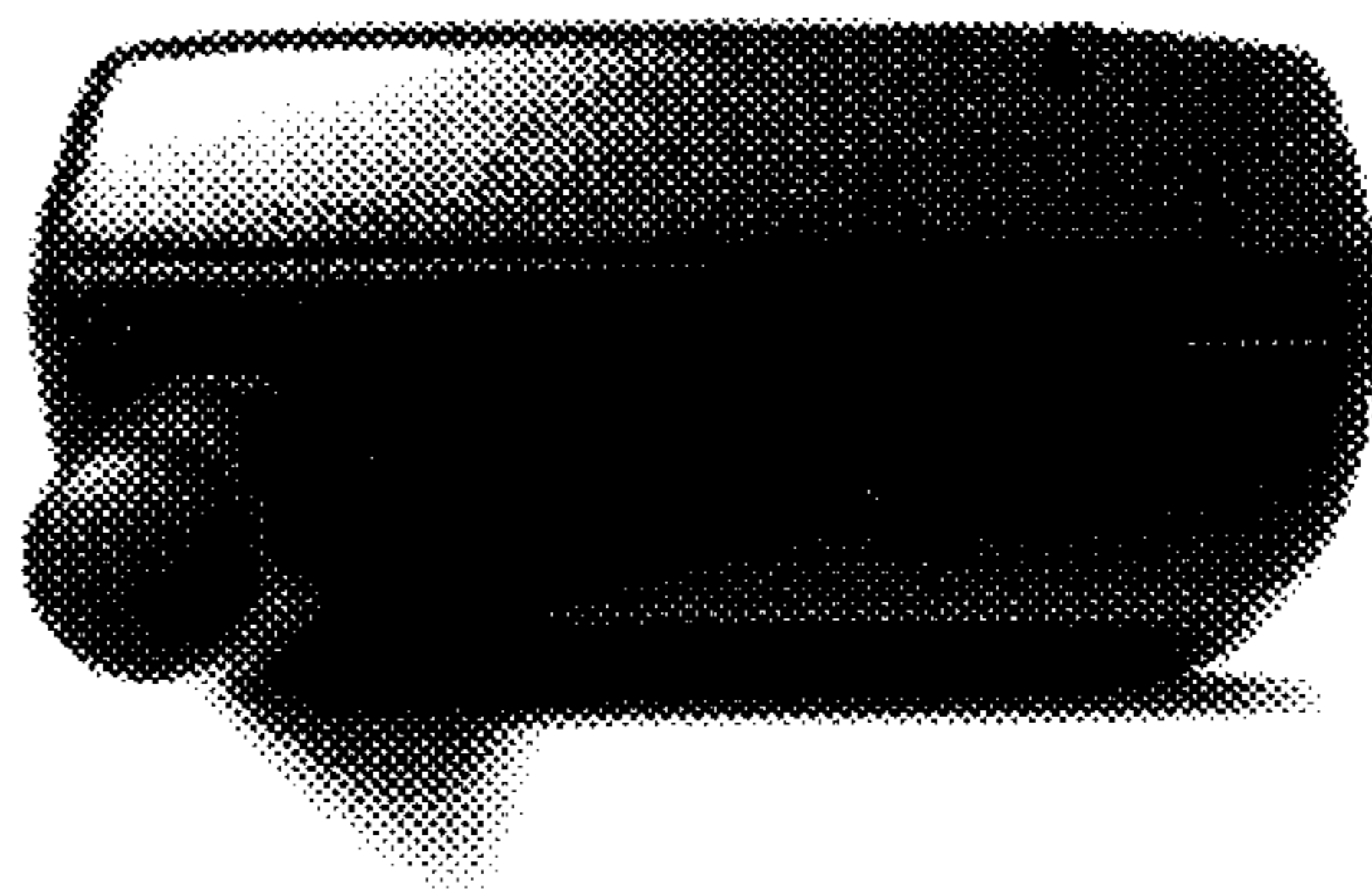

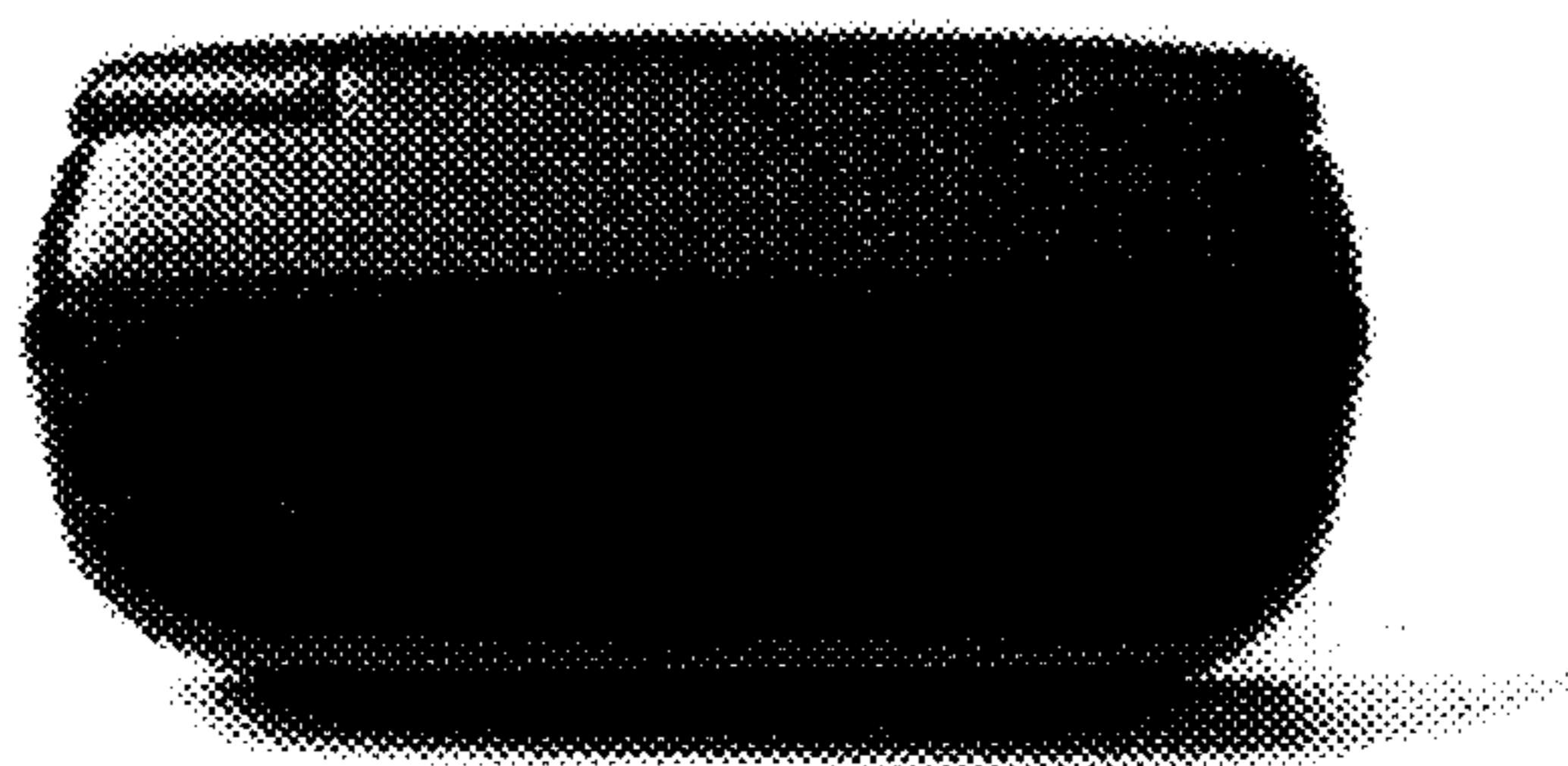

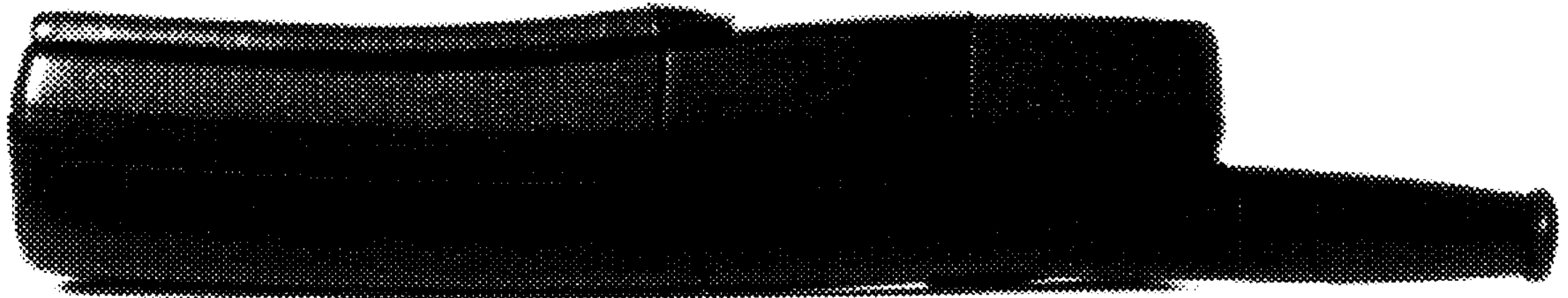
