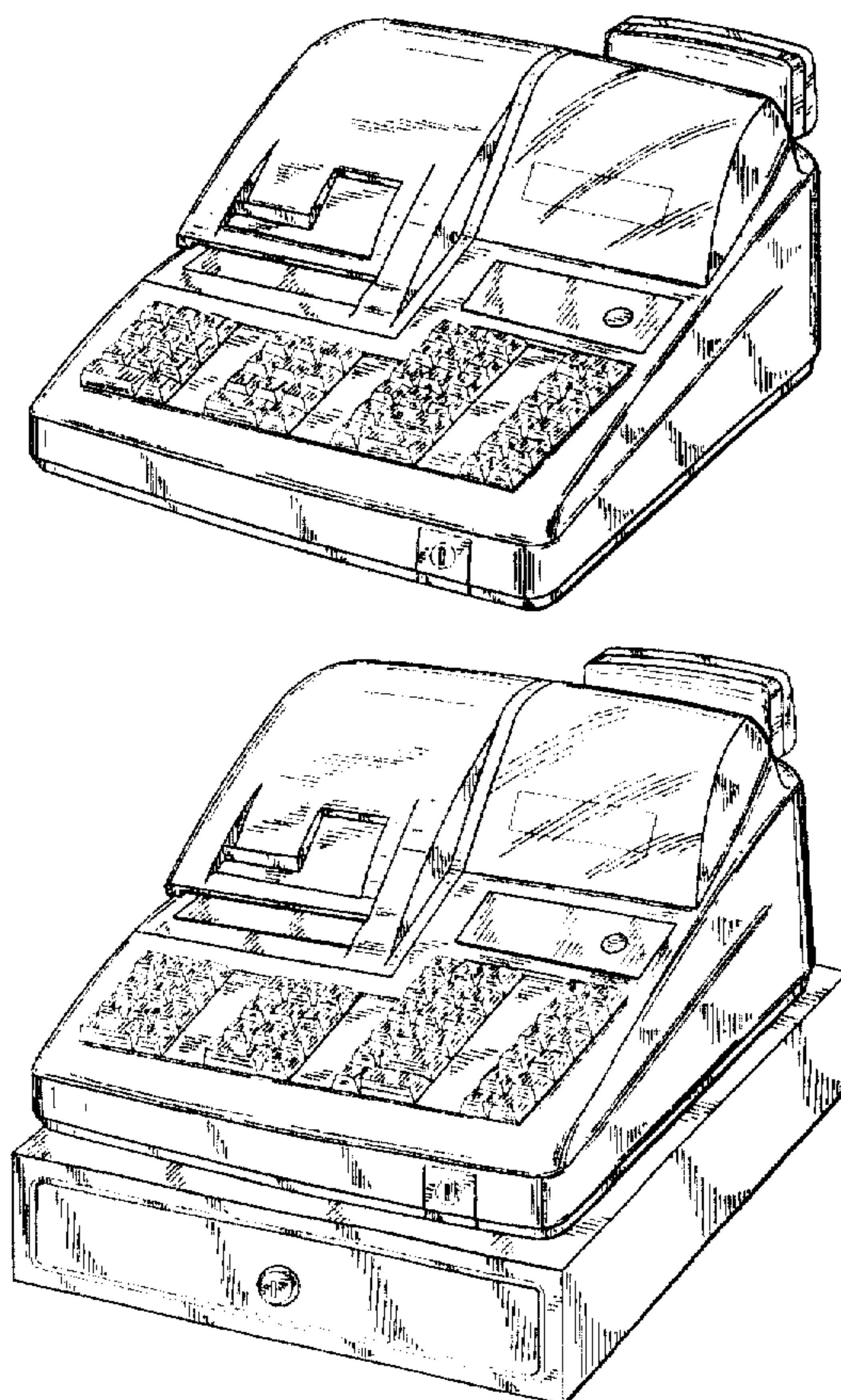
[57] CLAIM

The ornamental design for a "cash register", as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a cash register according to my design;

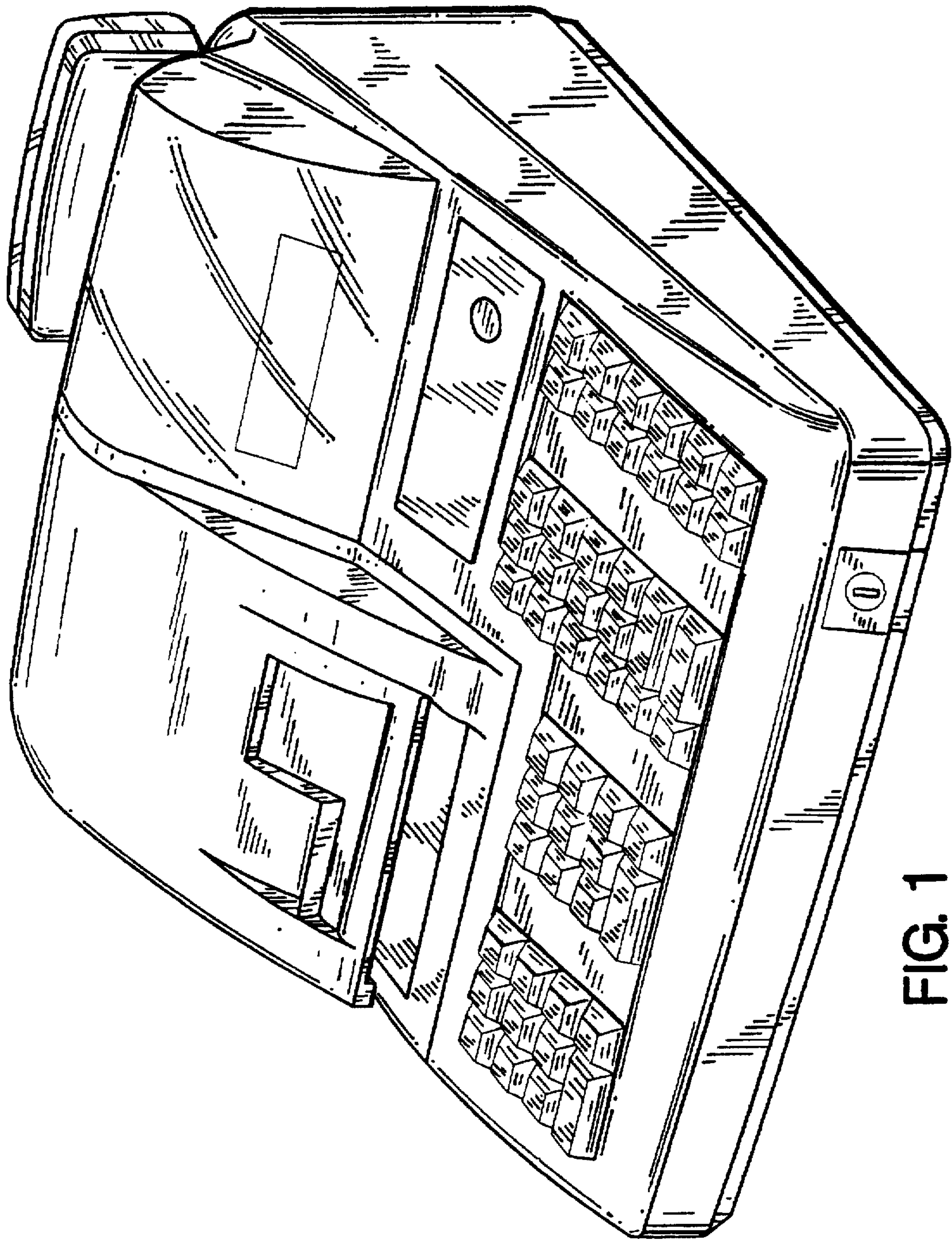

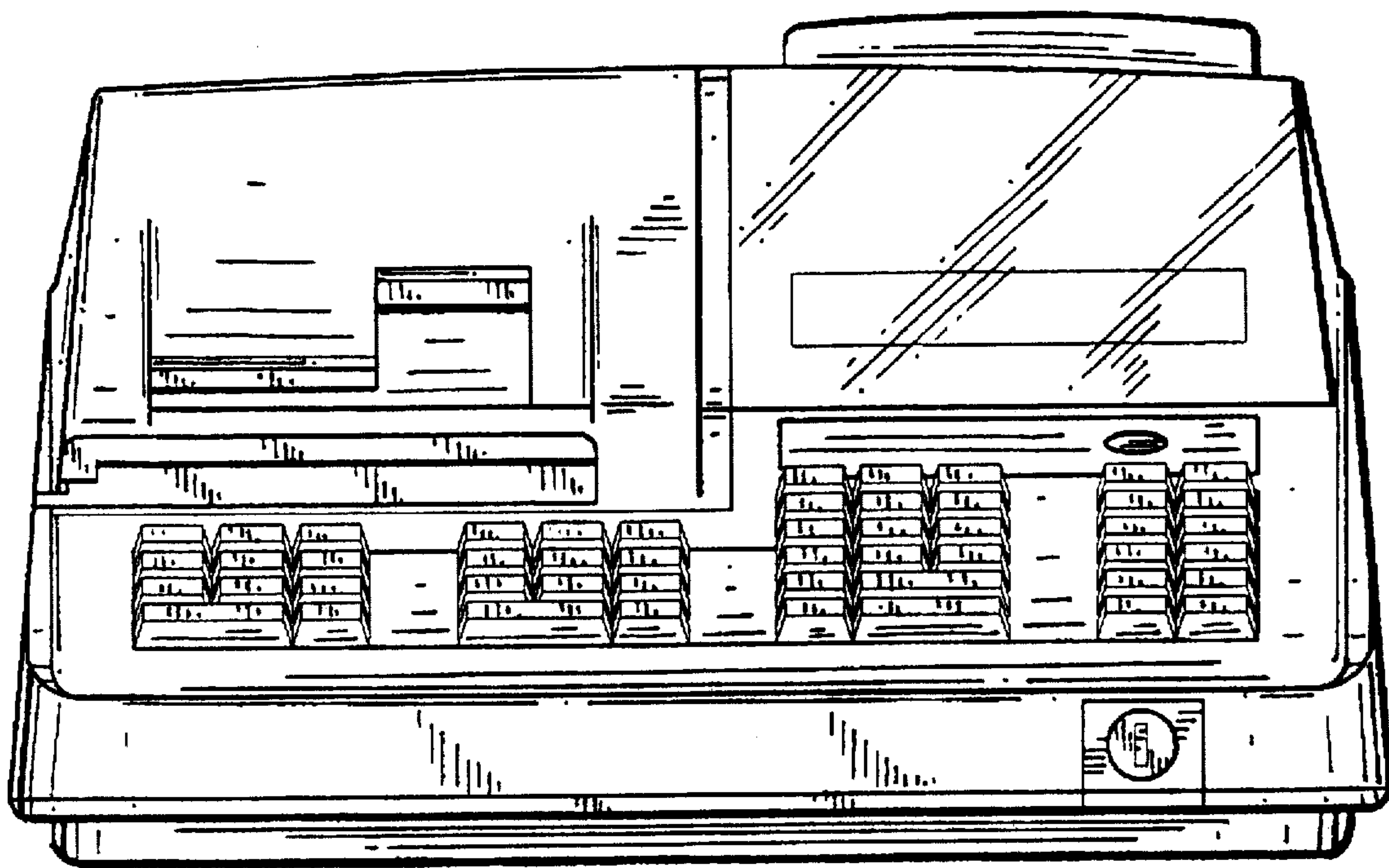

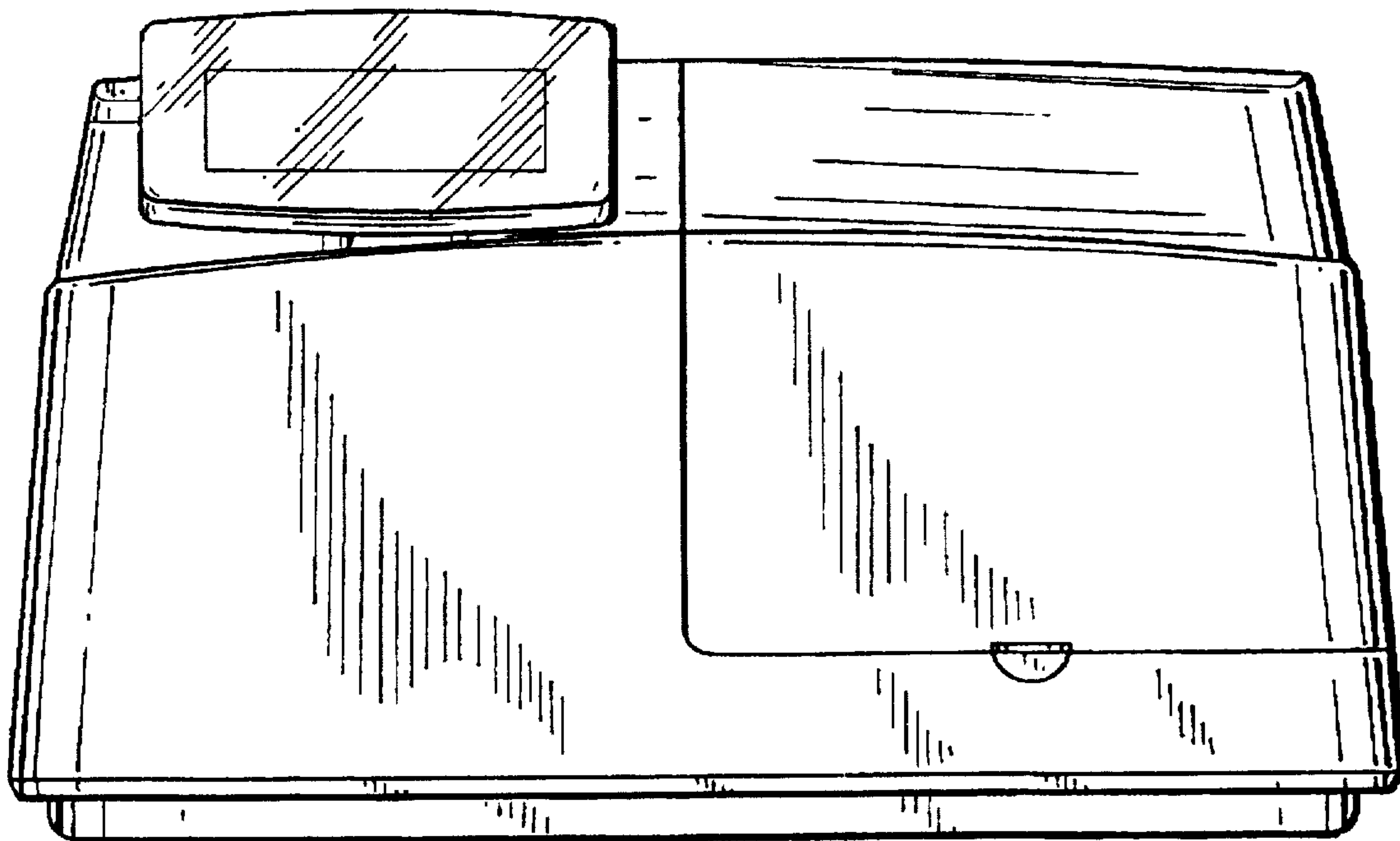

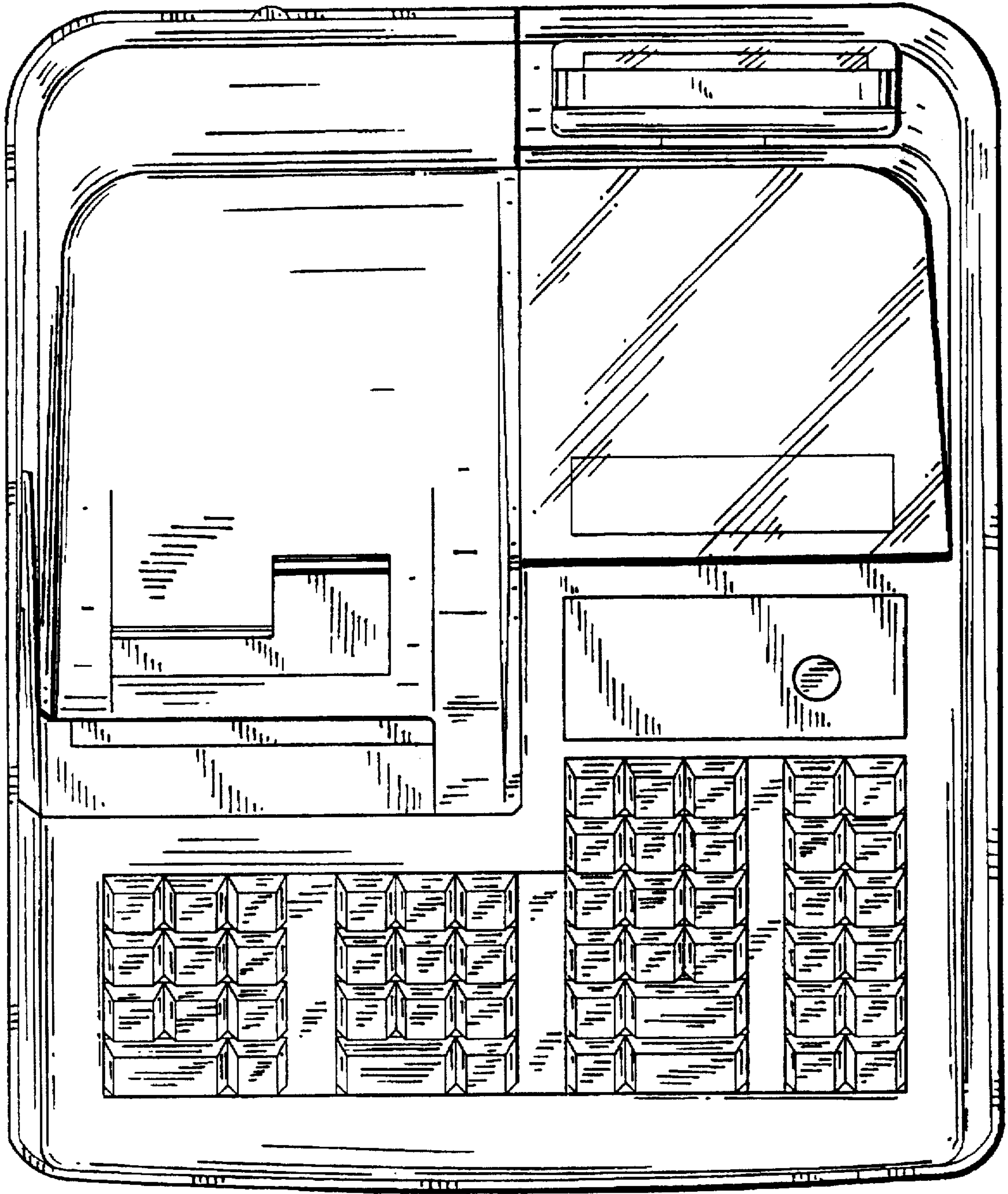

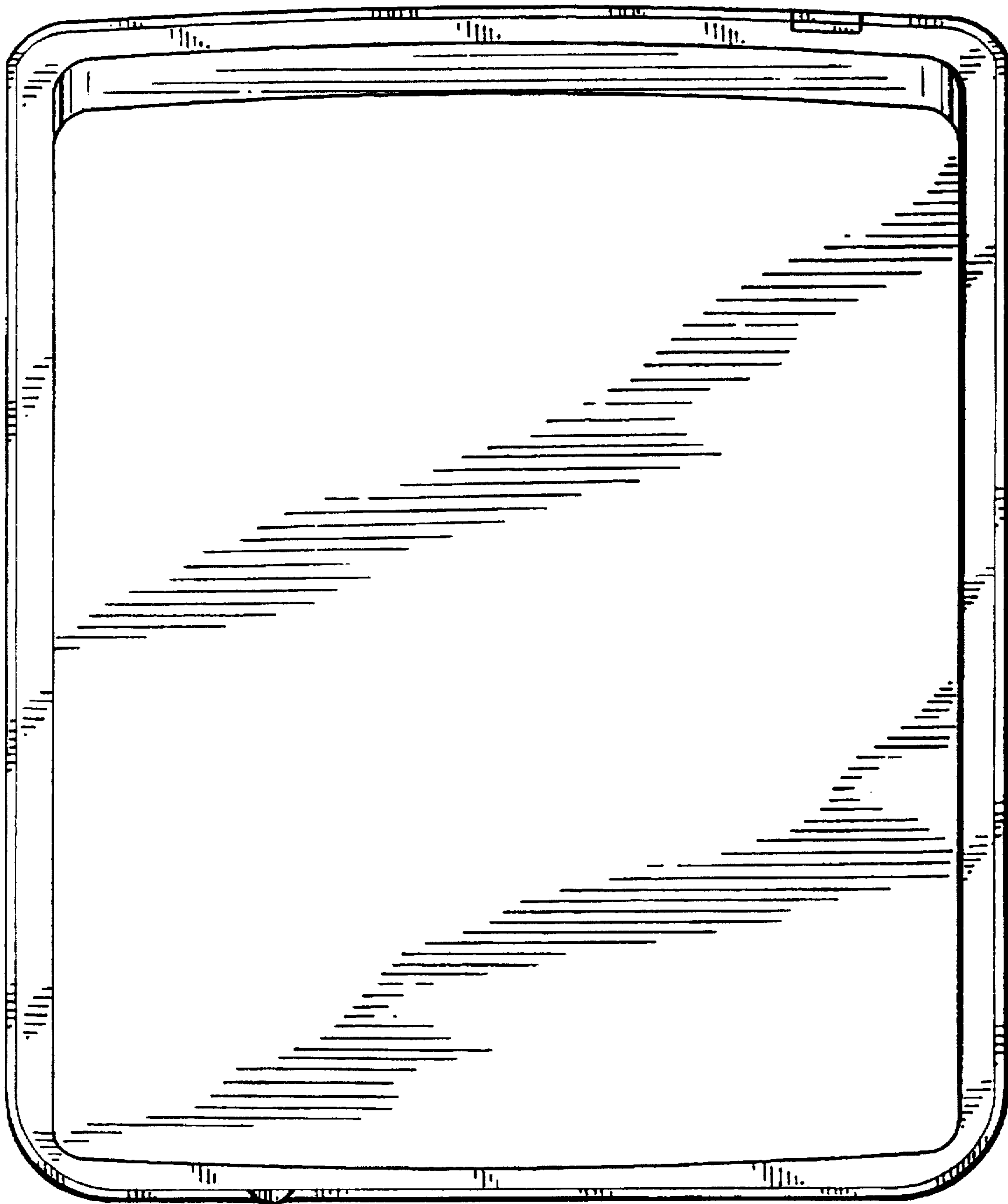

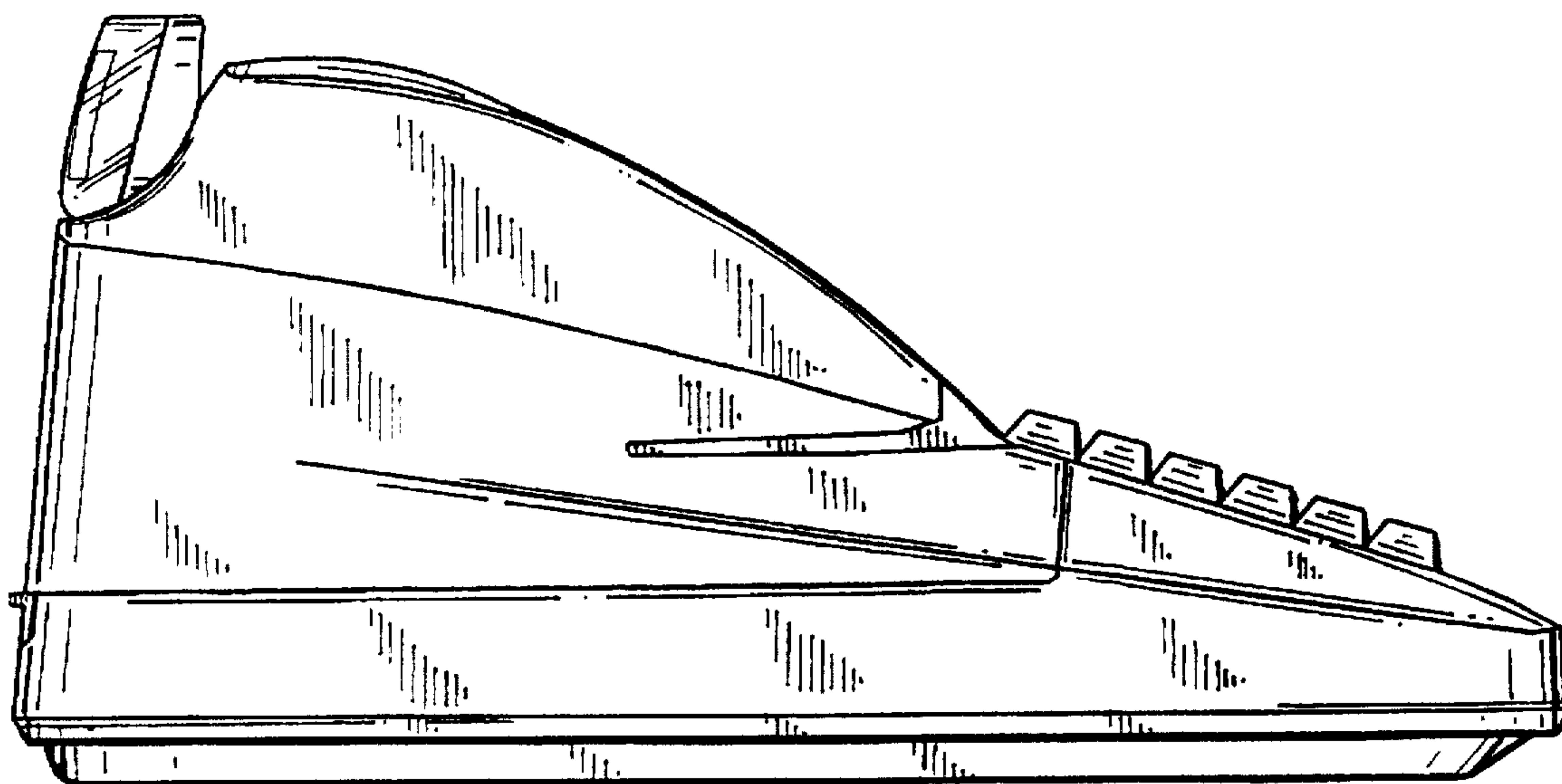

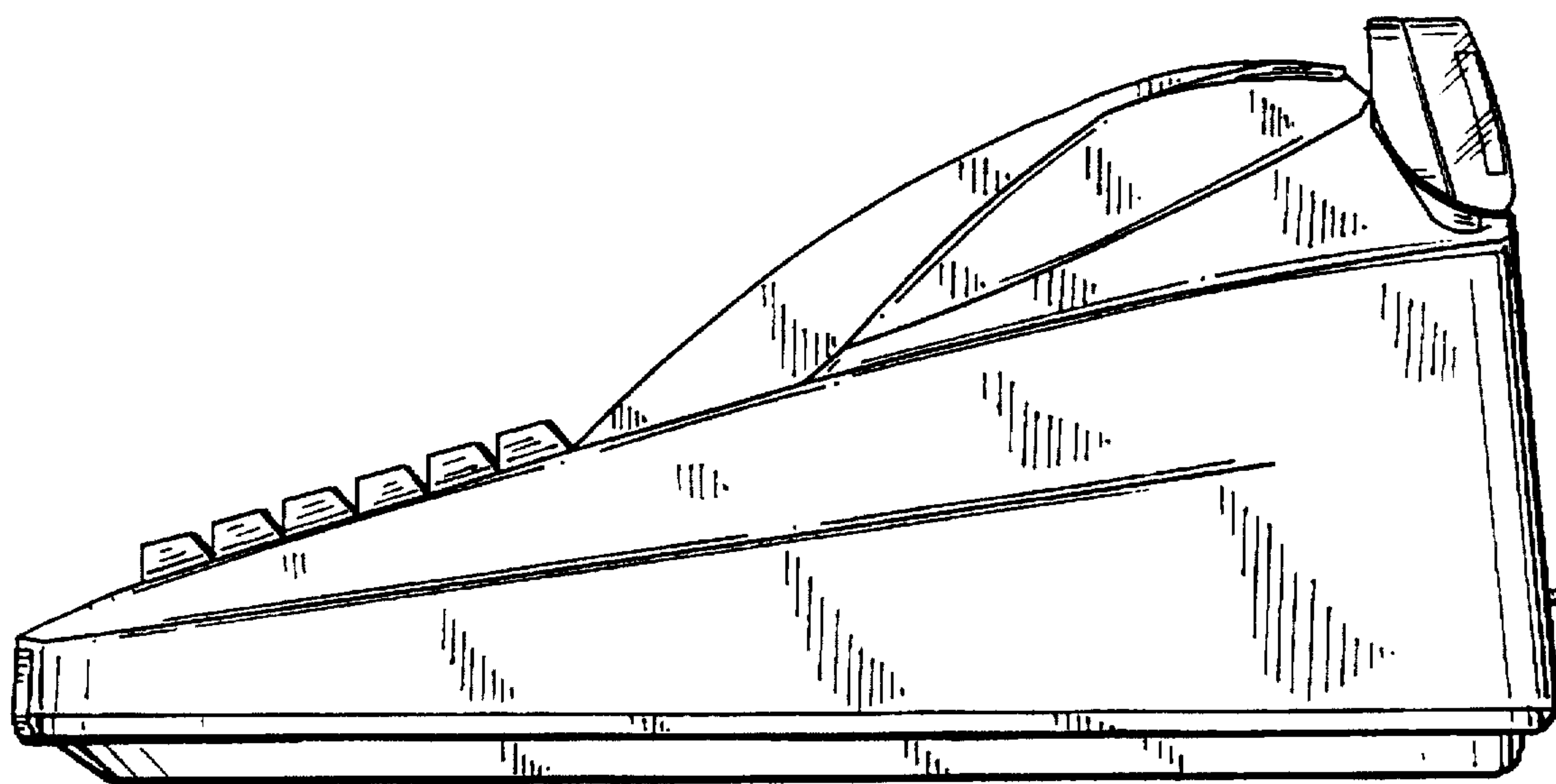

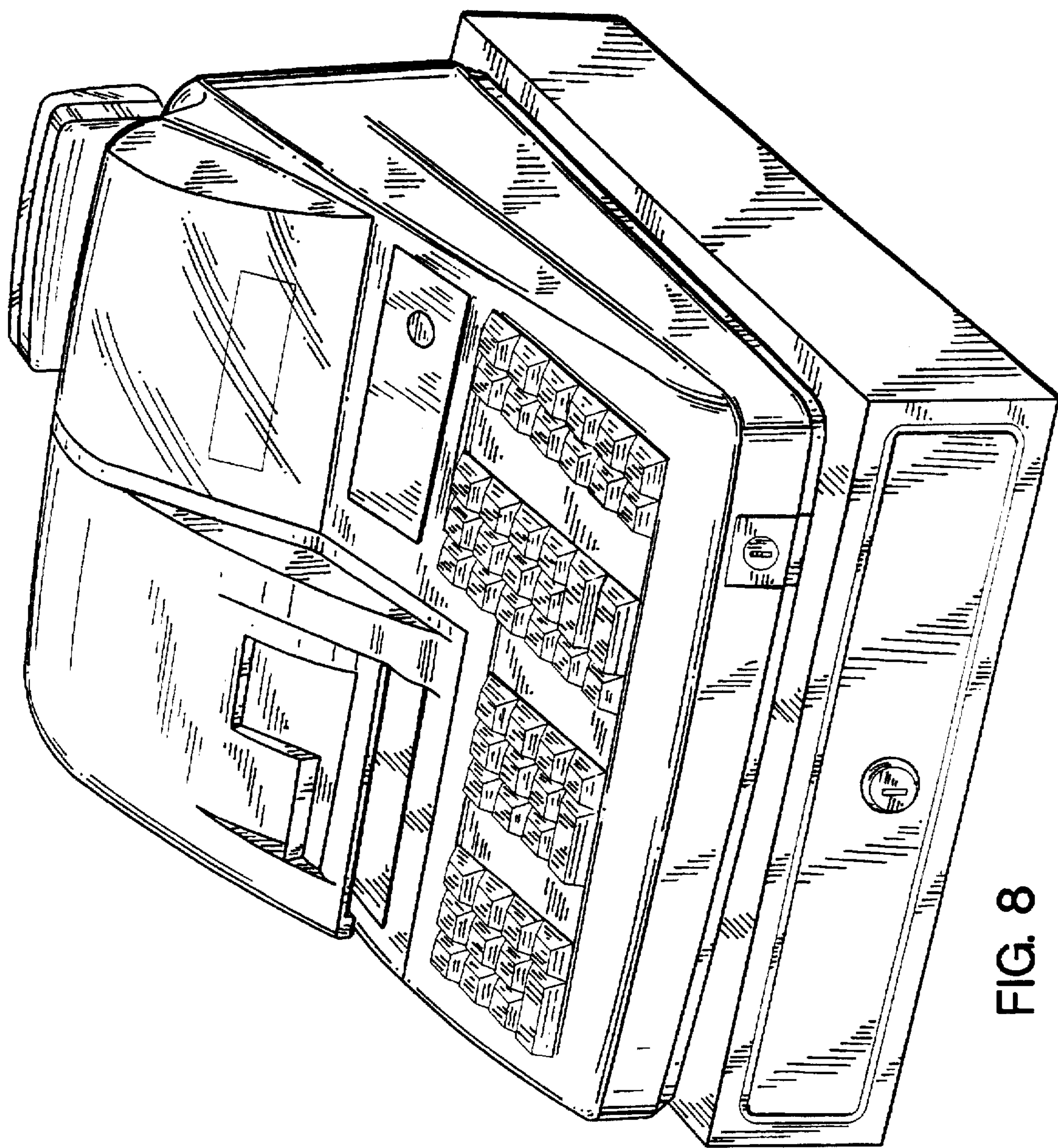

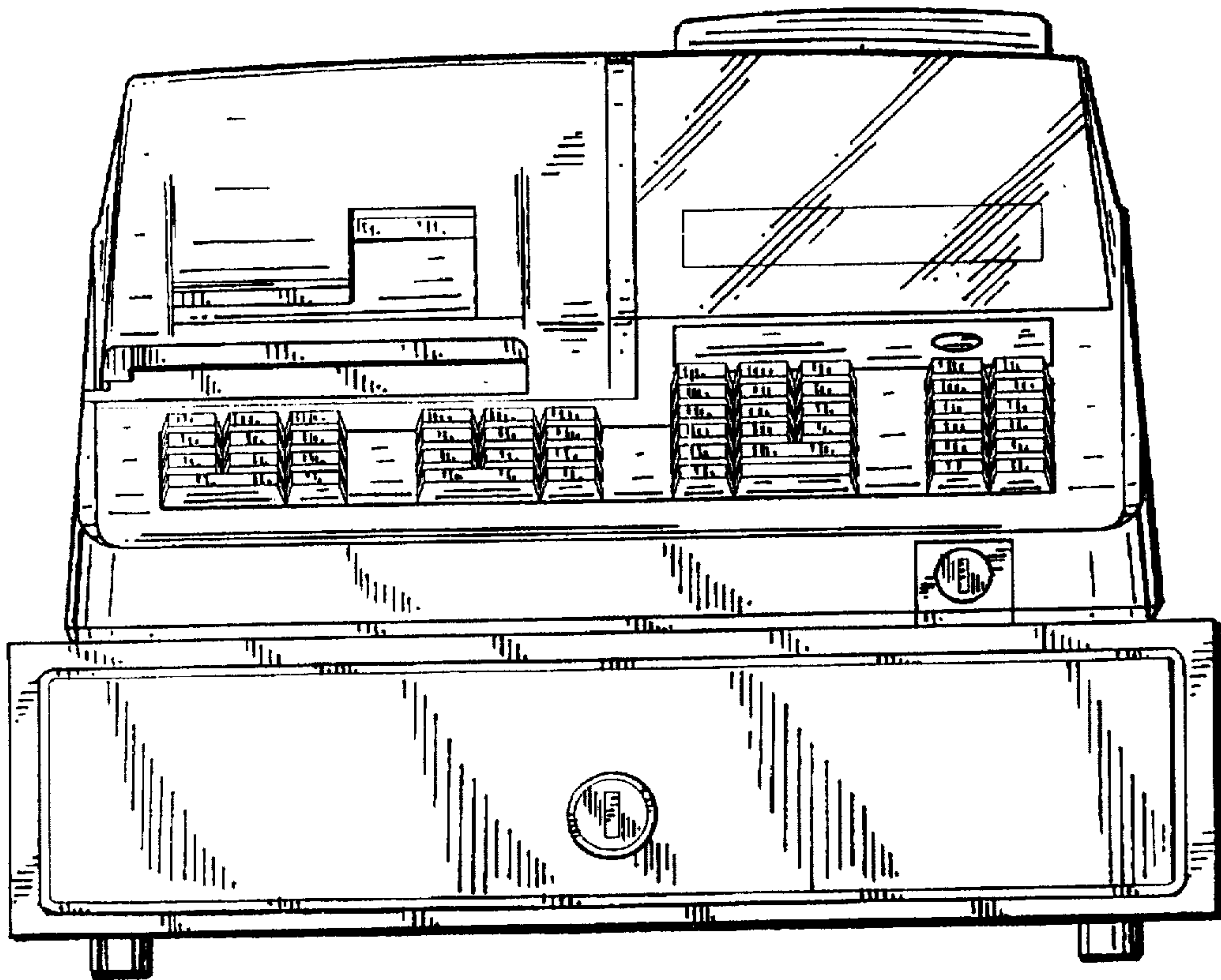

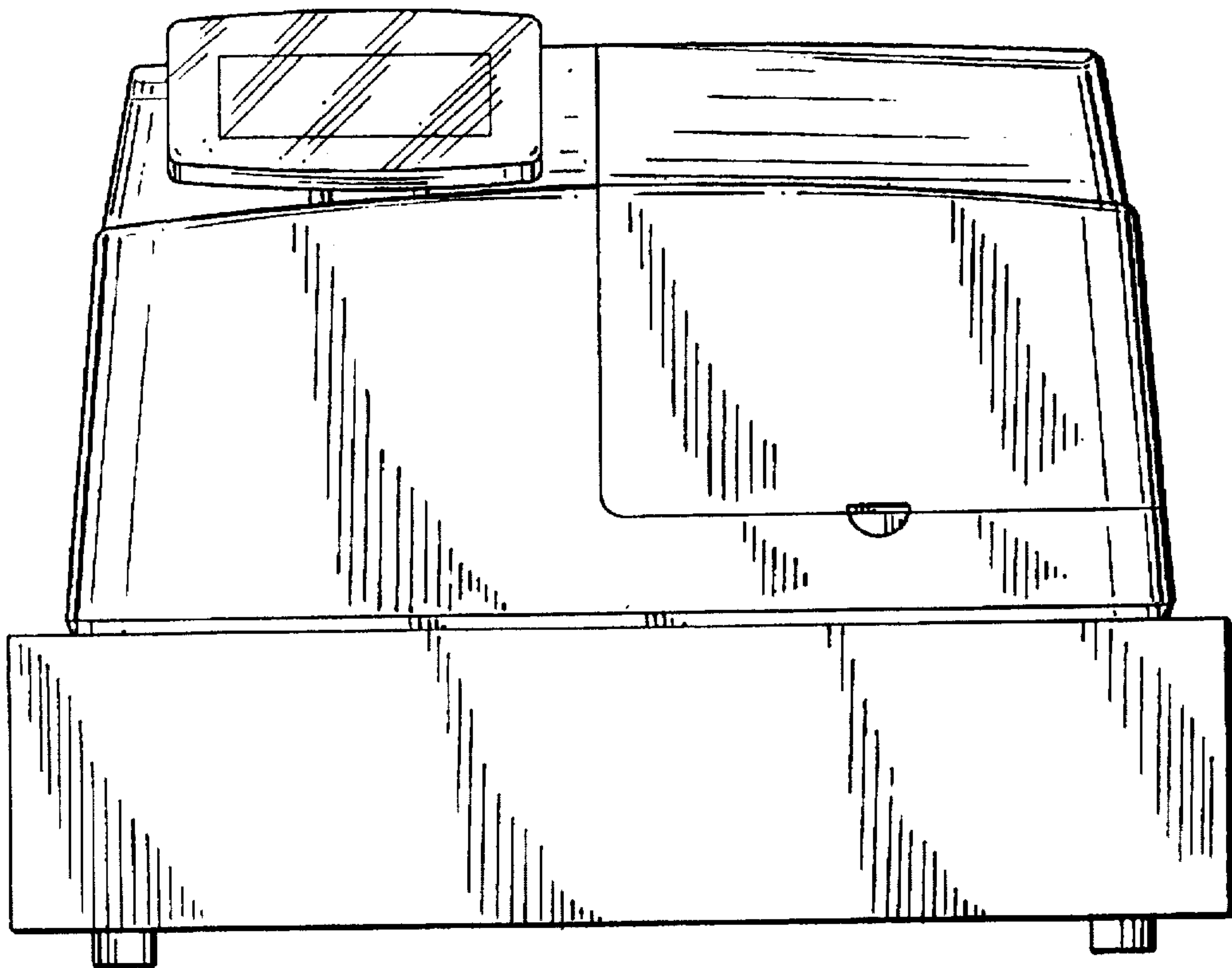

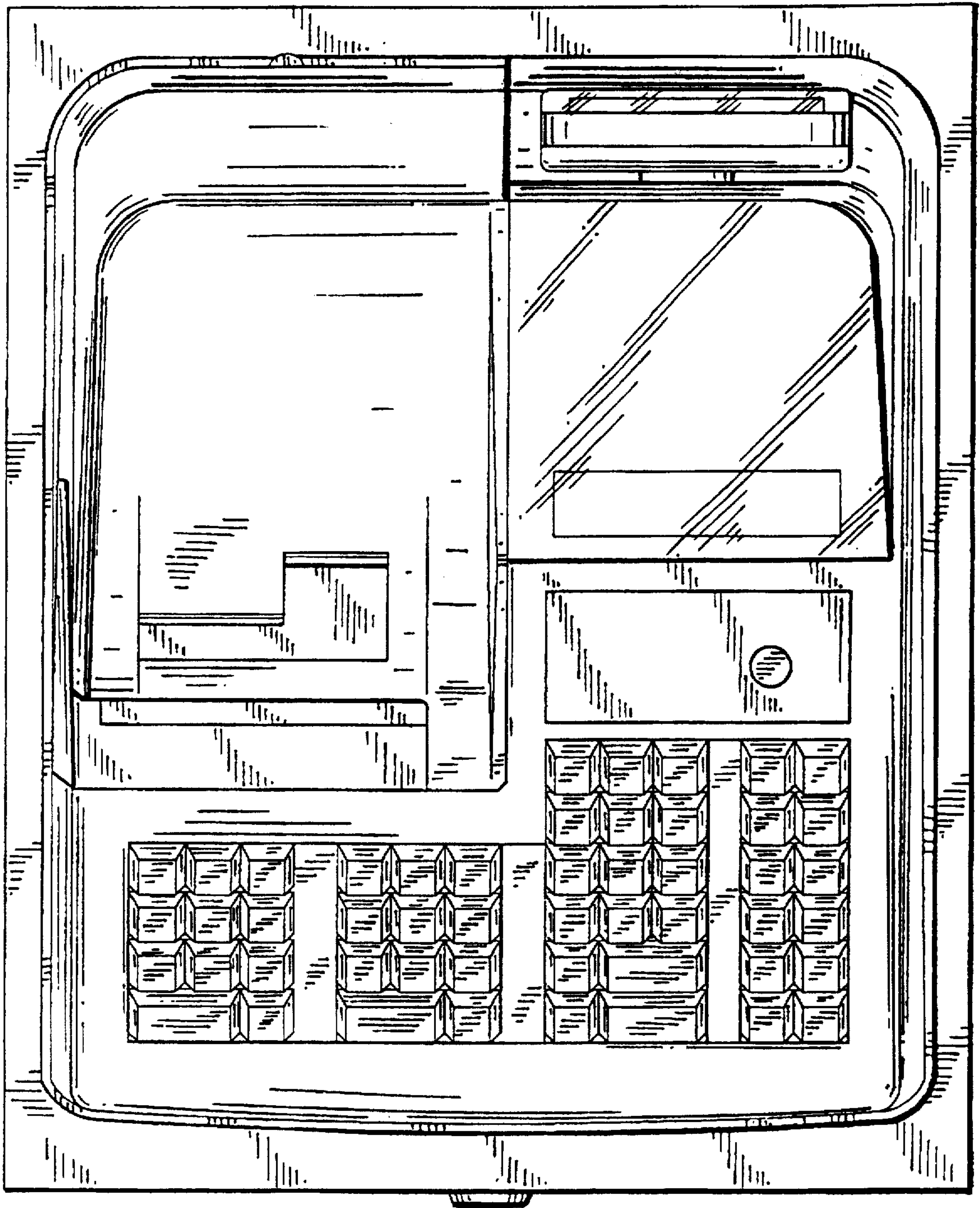

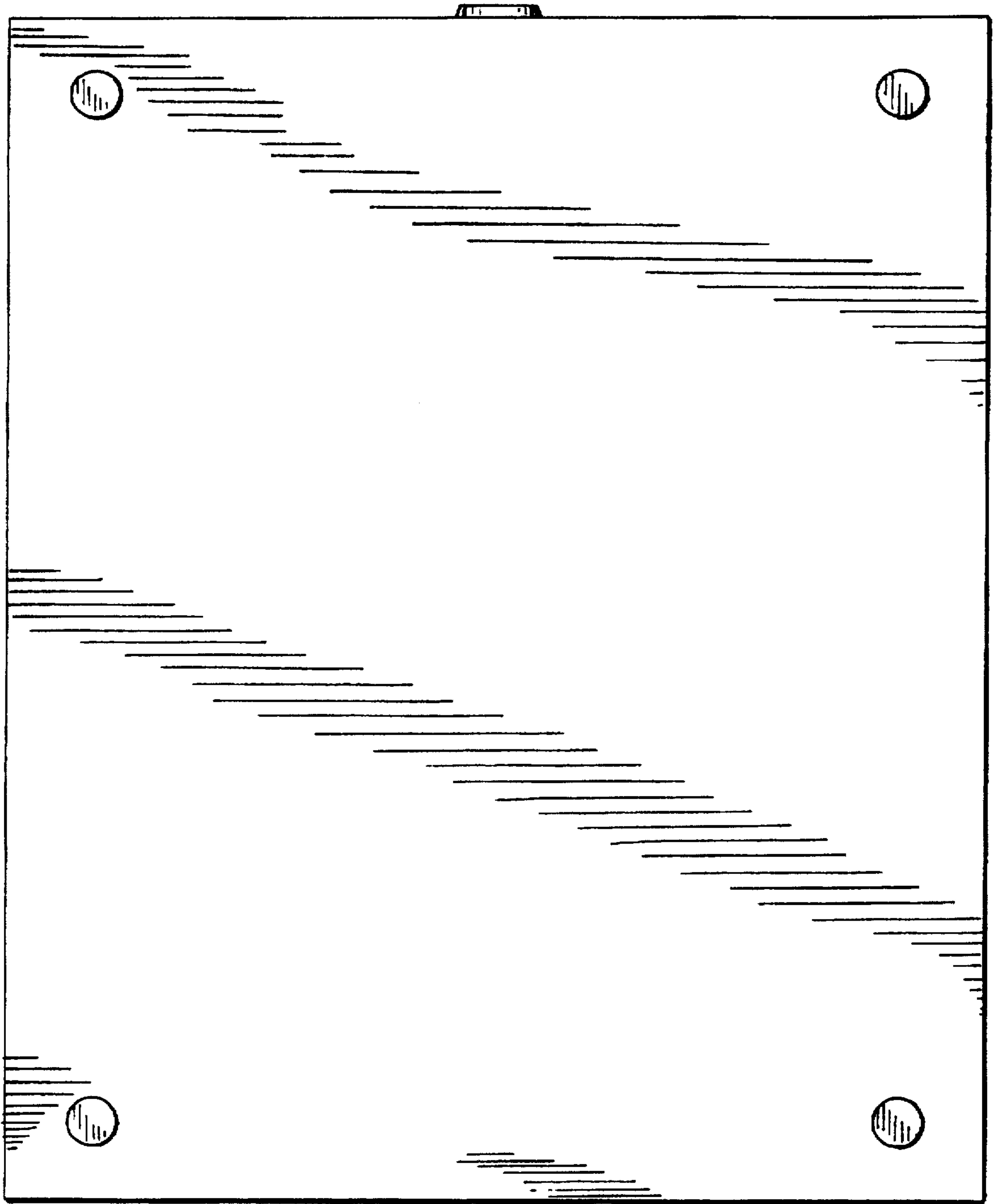

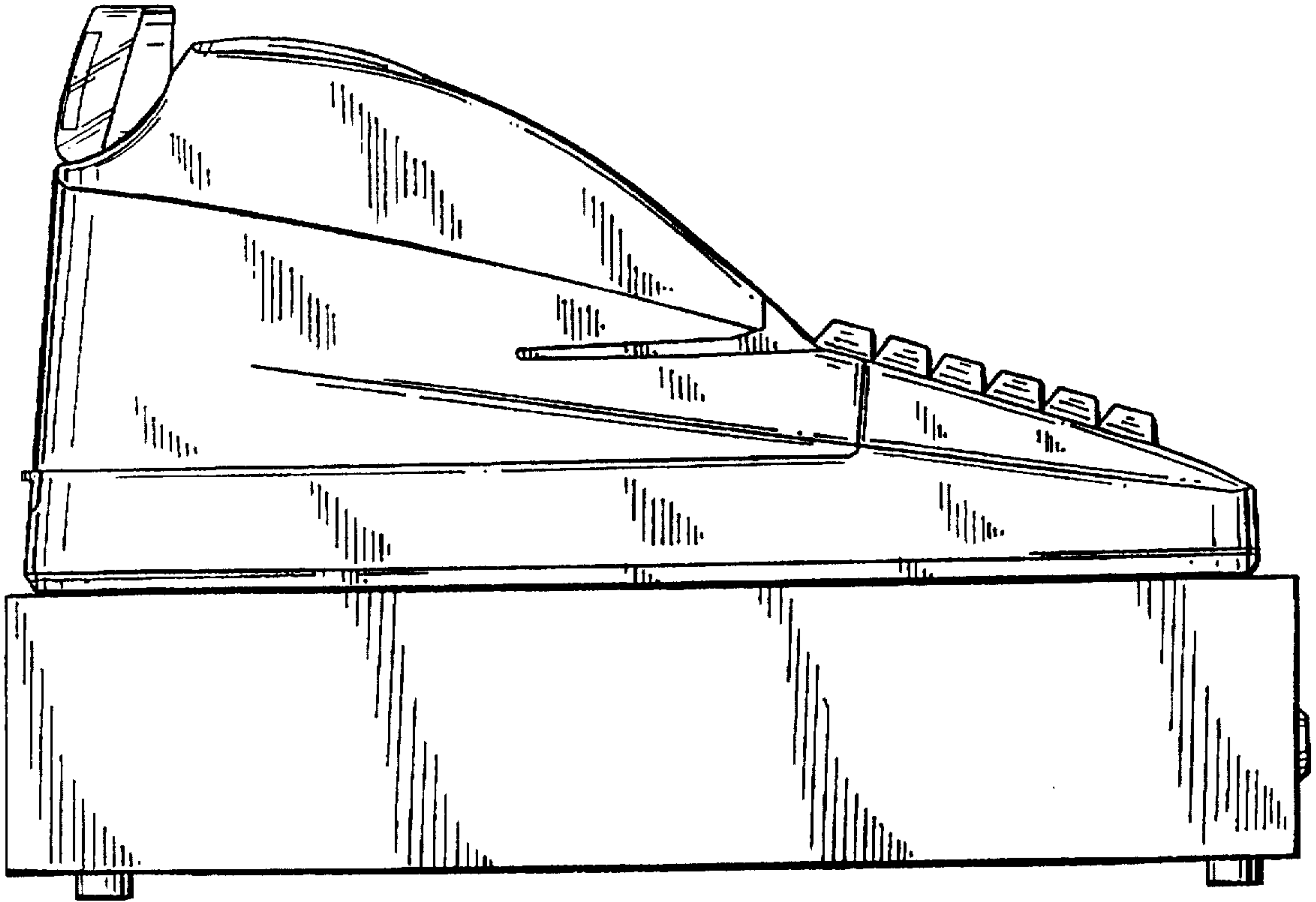

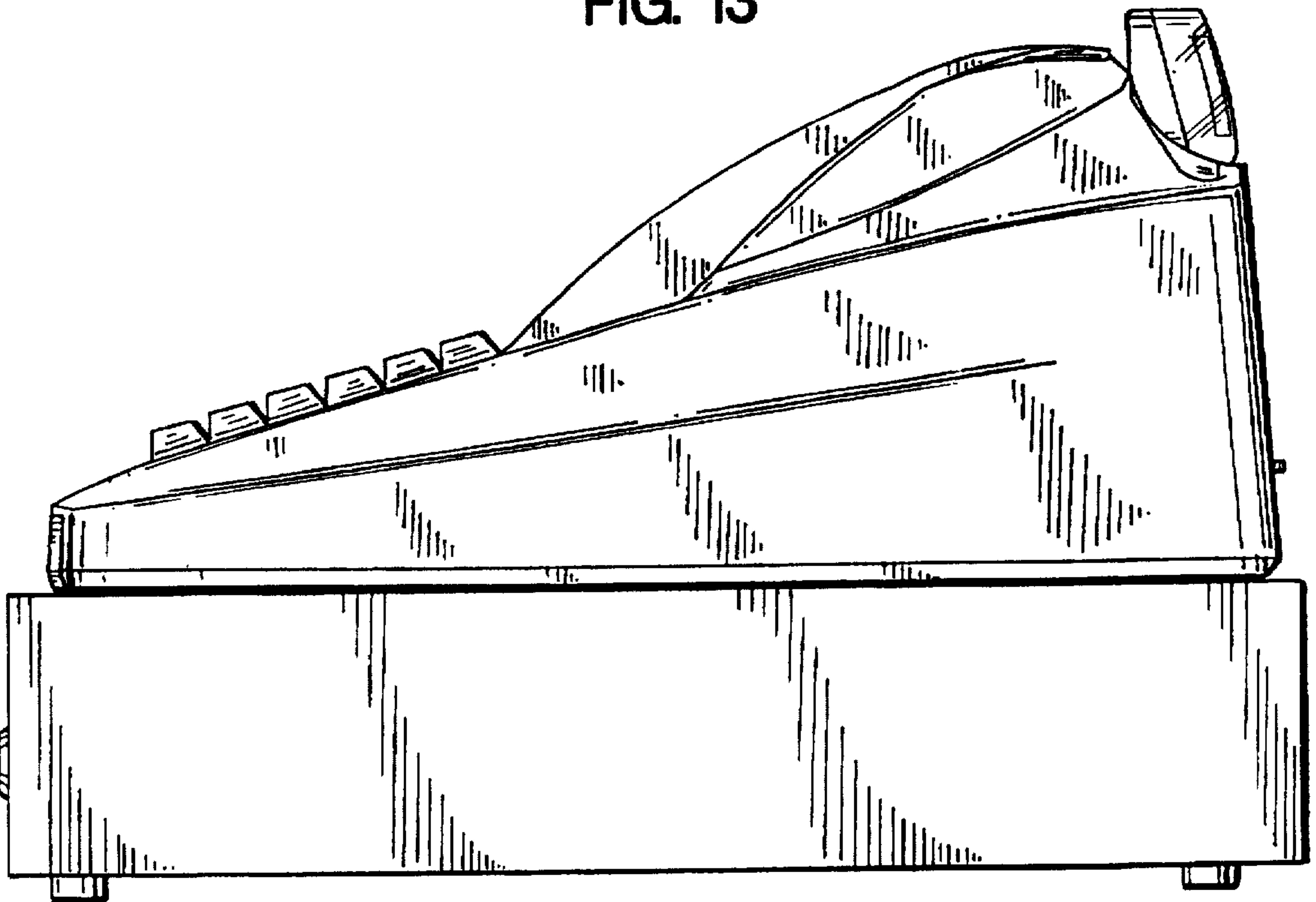
