[57] **CLAIM**

The ornamental design of a service station canopy, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of service station canopy in accordance with the present design;

FIG. 2 is a front view of the service station canopy of FIG. 1;

FIG. 3 is a top view of the service station canopy of FIG. 1;

FIG. 4 is a side view of the service station canopy of FIG. 1;

FIG. 5 is a back view of the service station canopy of FIG. 1;

FIG. 6 is a perspective view of a second embodiment of a service station canopy with the peripheral edge of the canopy ornamented in red;

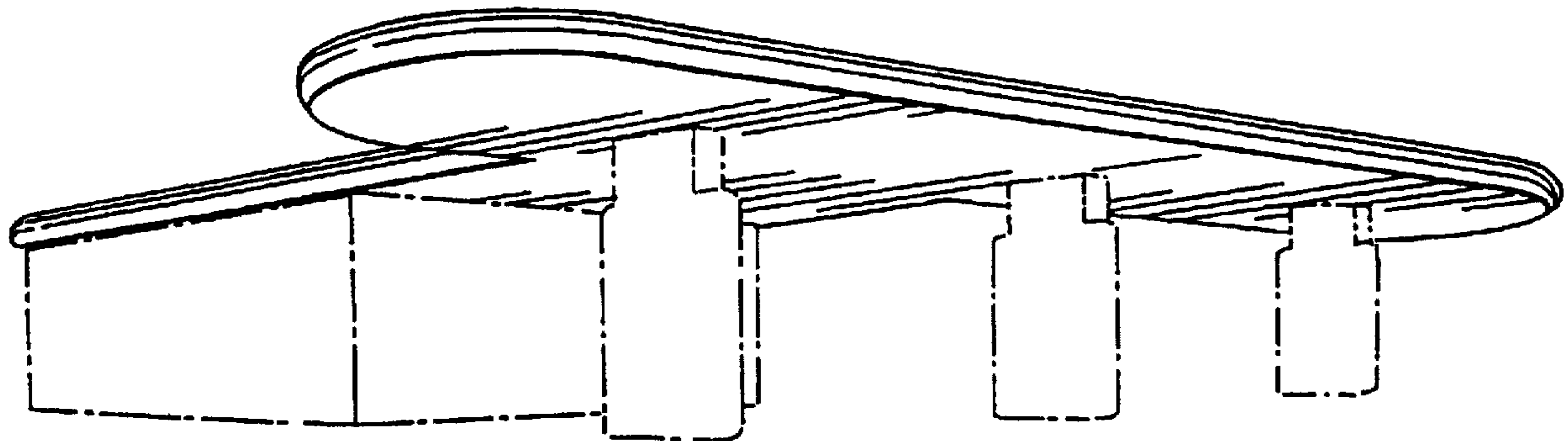
FIG. 7 is a front view of the service station canopy of FIG. 6;

FIG. 8 is a top view of the service station canopy of FIG. 6; and,

FIG. 9 is a side view of the service station canopy of FIG. 6.

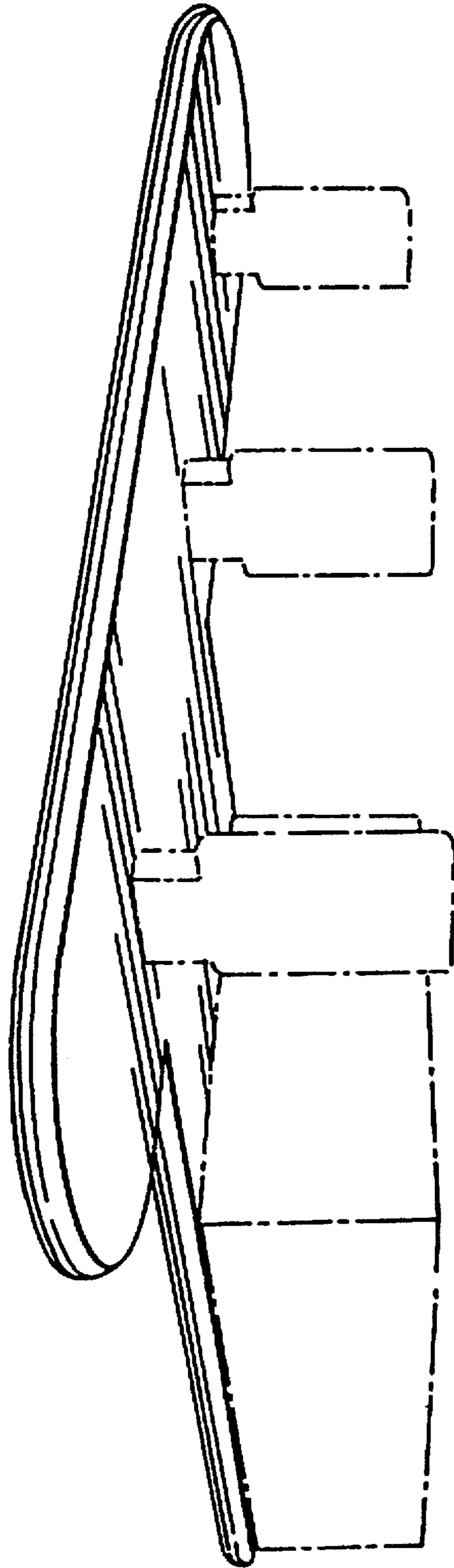
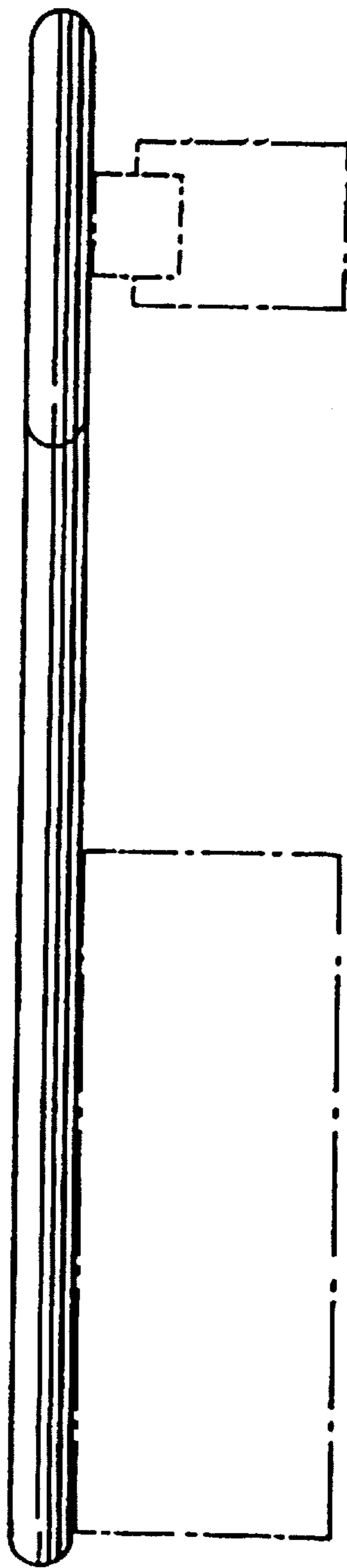
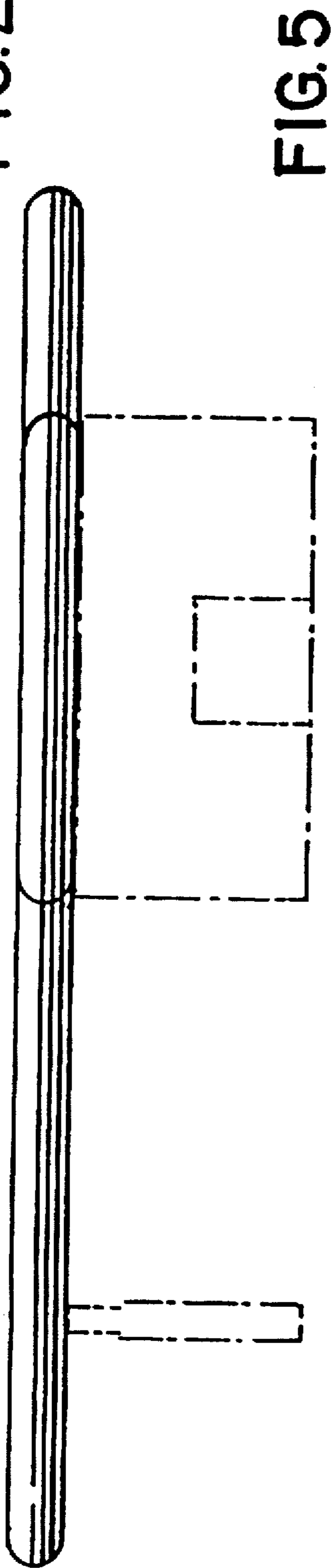
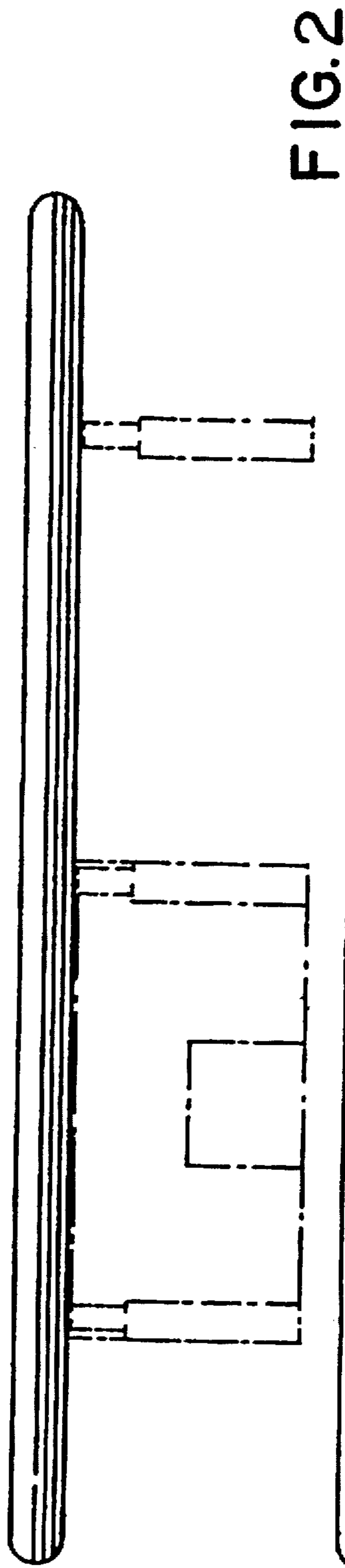

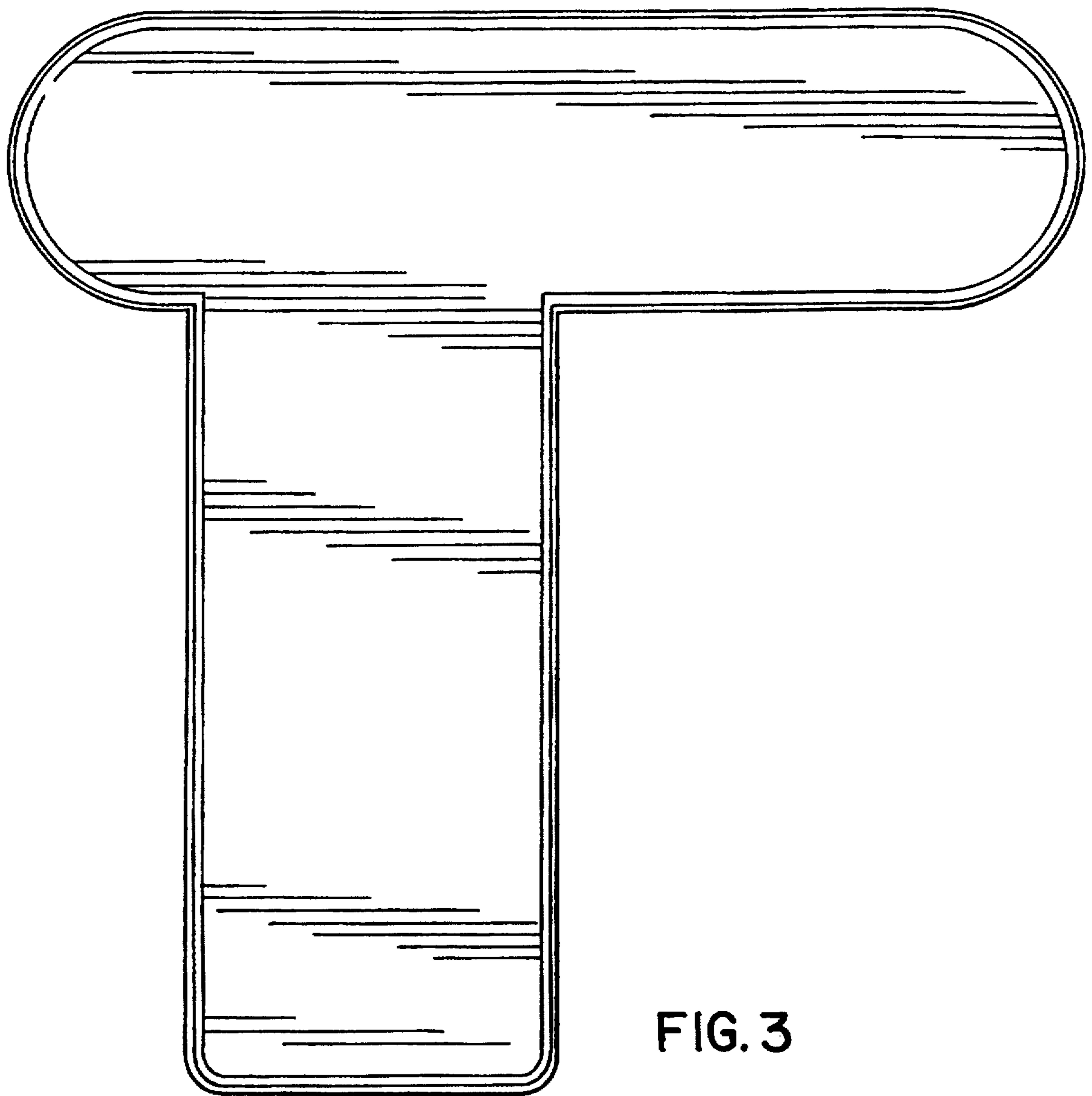

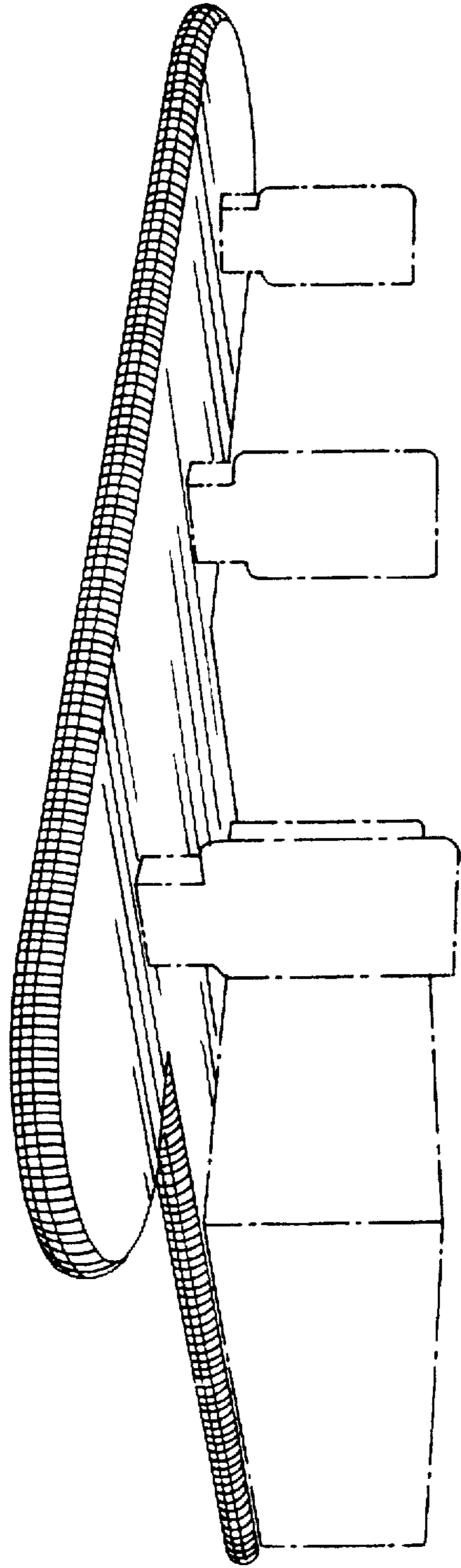
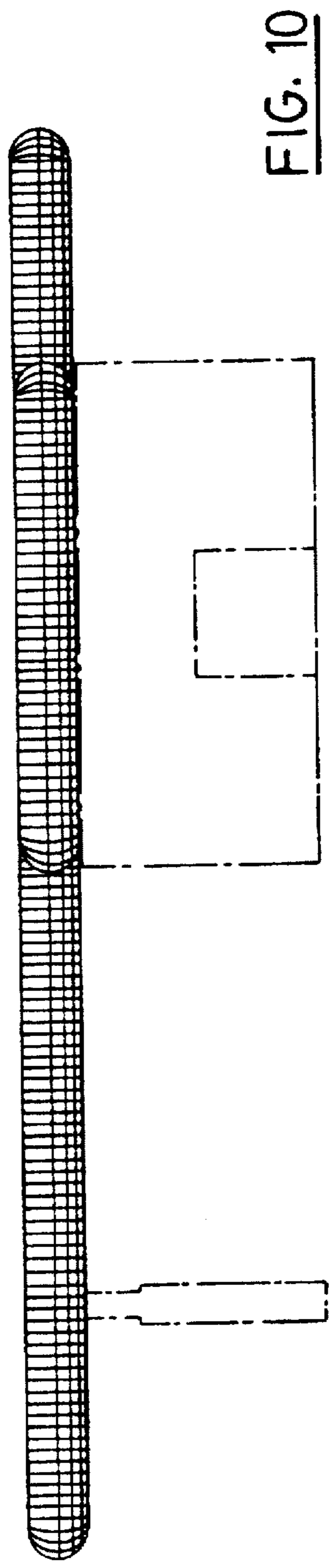
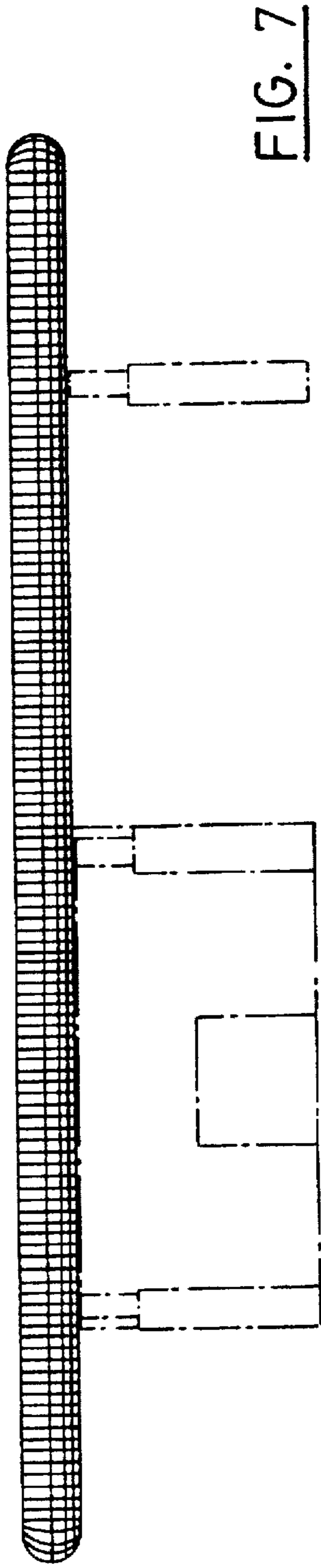

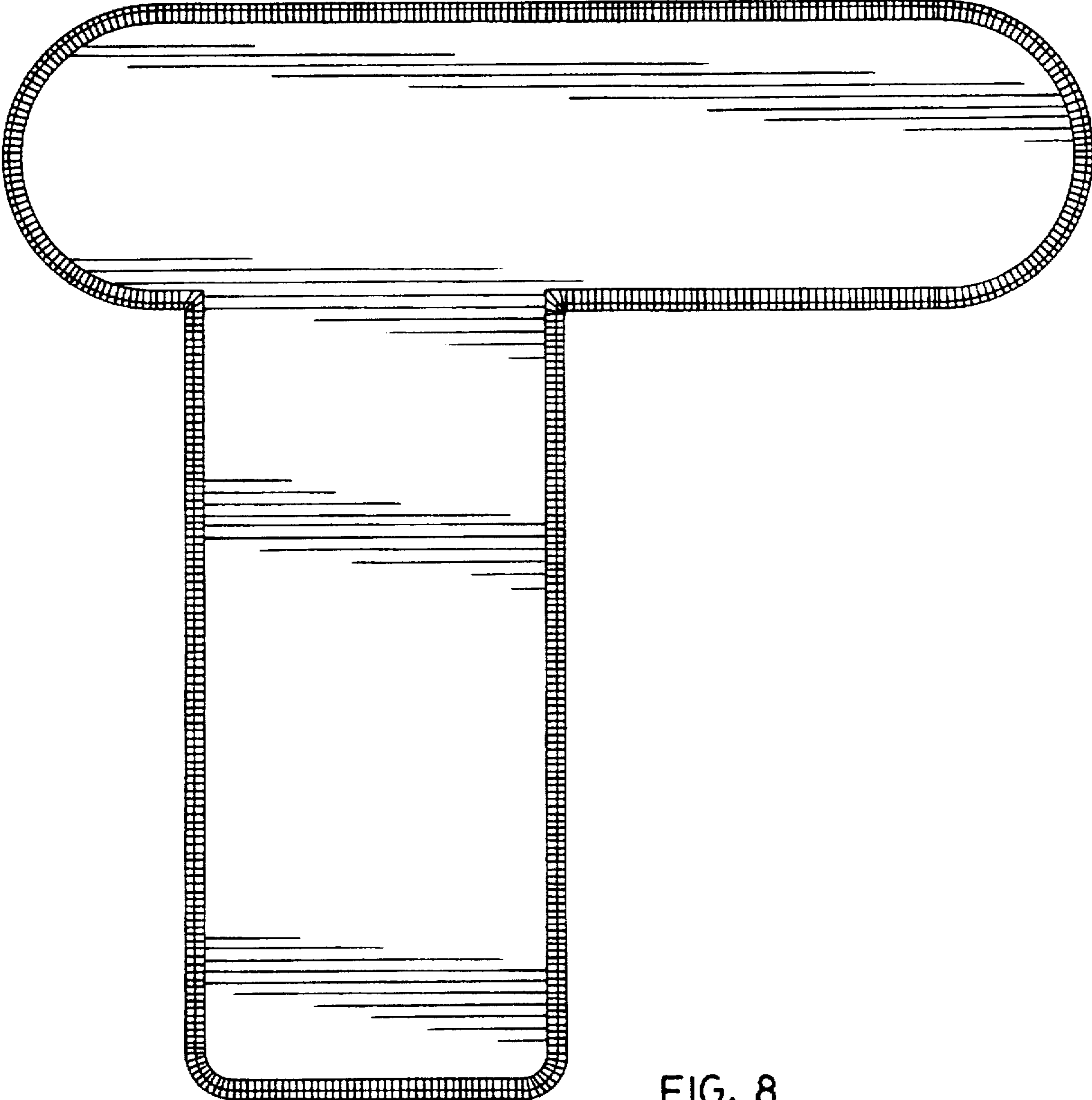
