The ornamental design for a back moisturizer applicator, as shown.

## DESCRIPTION

FIG. 1 is a front view of the back moisturizer applicator of the present invention;

FIG. 2 is a rear view of the back moisturizer applicator of FIG. 1;

FIG. 3 is a left side view of the back moisturizer applicator of FIG. 1;

FIG. 4 is a right side view of the back moisturizer applicator of FIG. 1;

FIG. 5 is a top plan view of the back moisturizer applicator of FIG. 1;

FIG. 6 is a bottom plan view of the back moisturizer applicator of FIG. 1; and,

FIG. 7 is a cross sectional view along line 7—7 of FIG. 1.

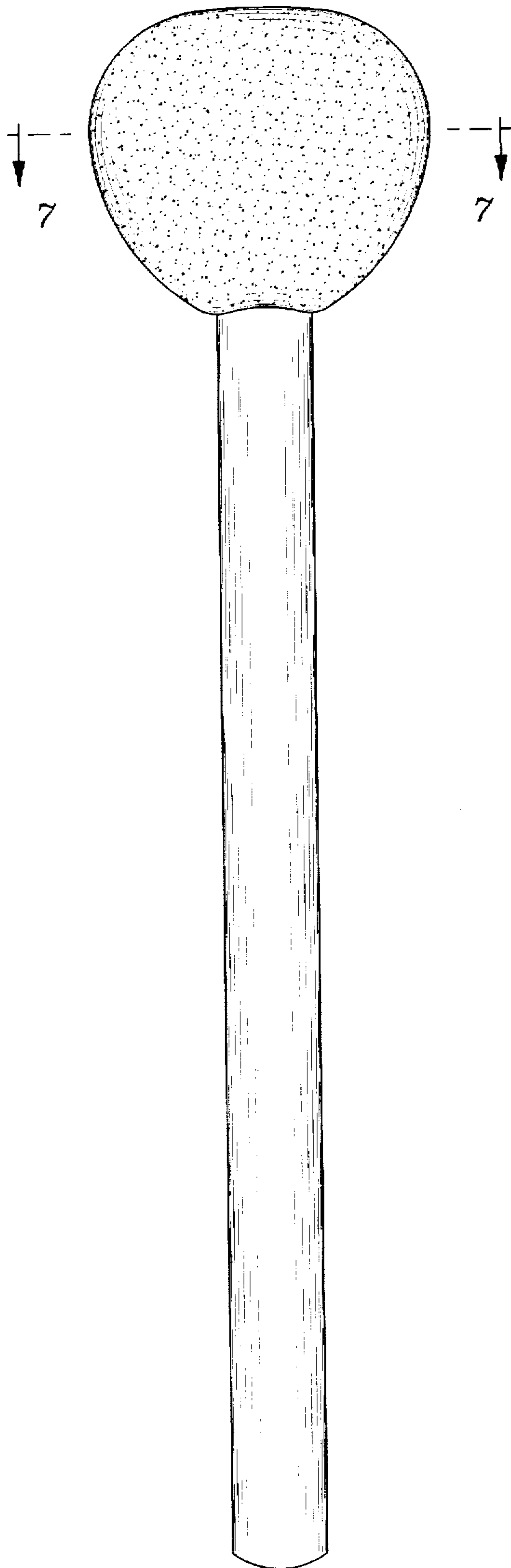

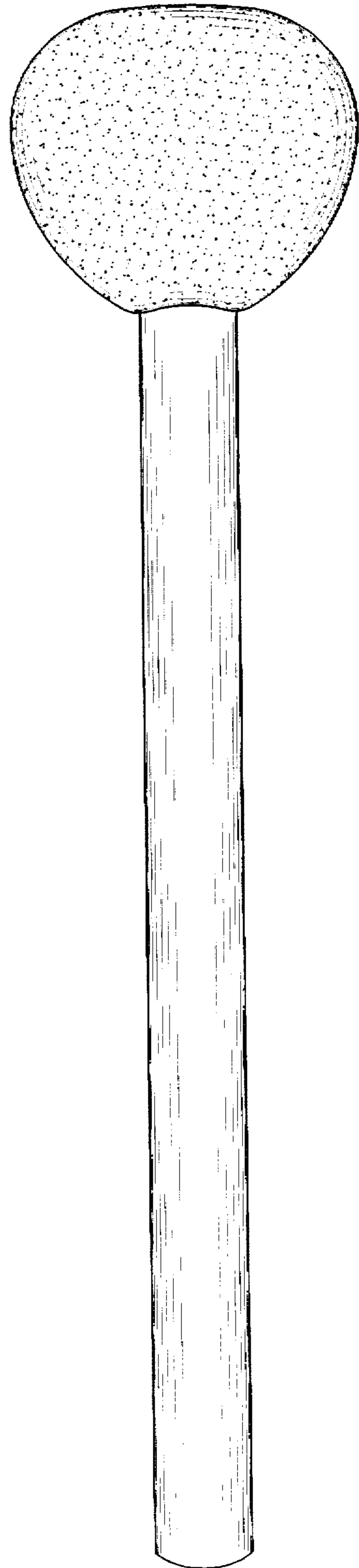

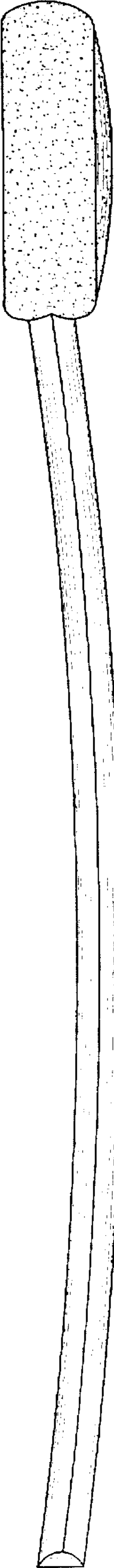

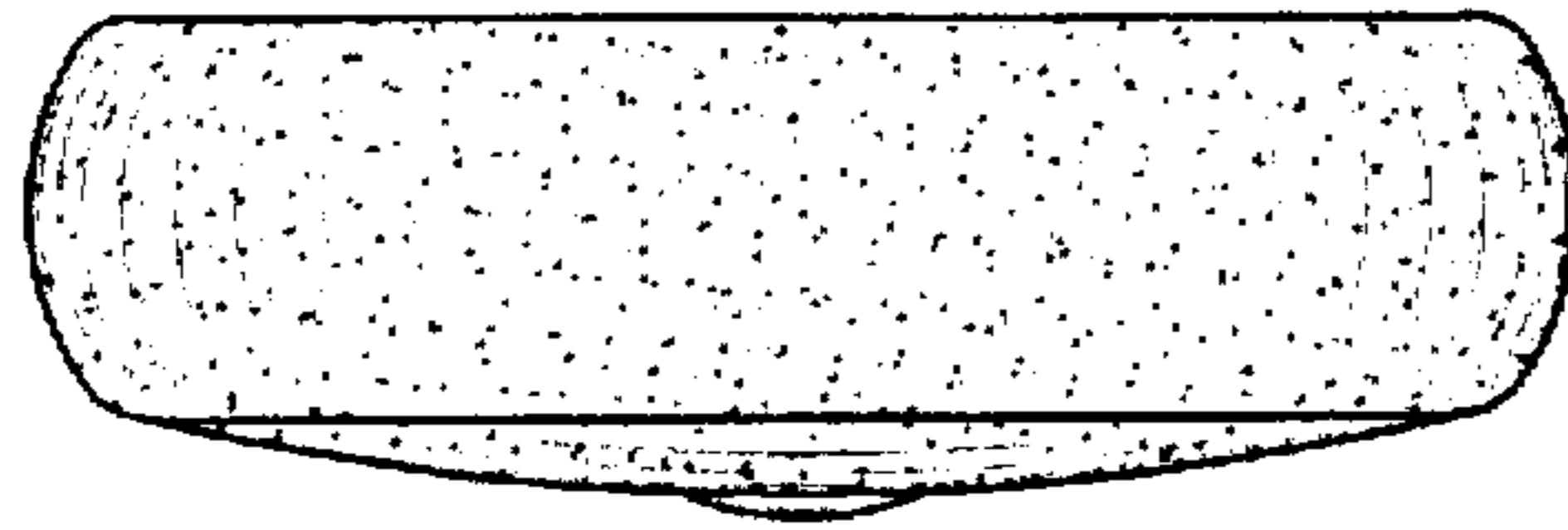

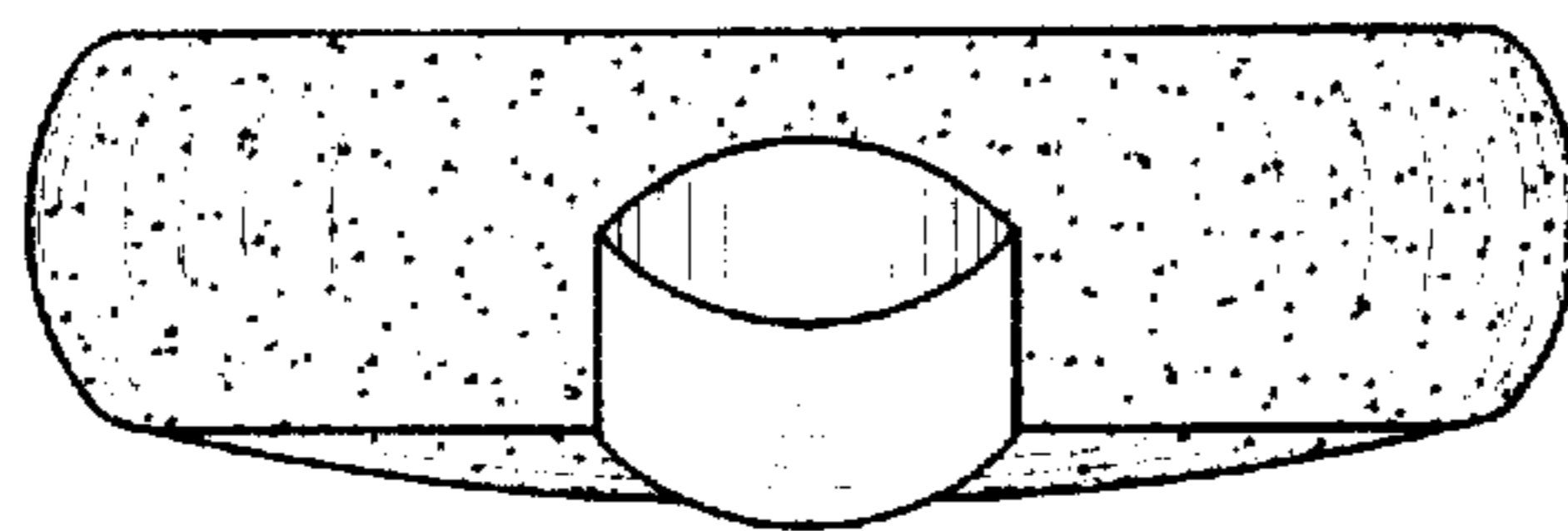
