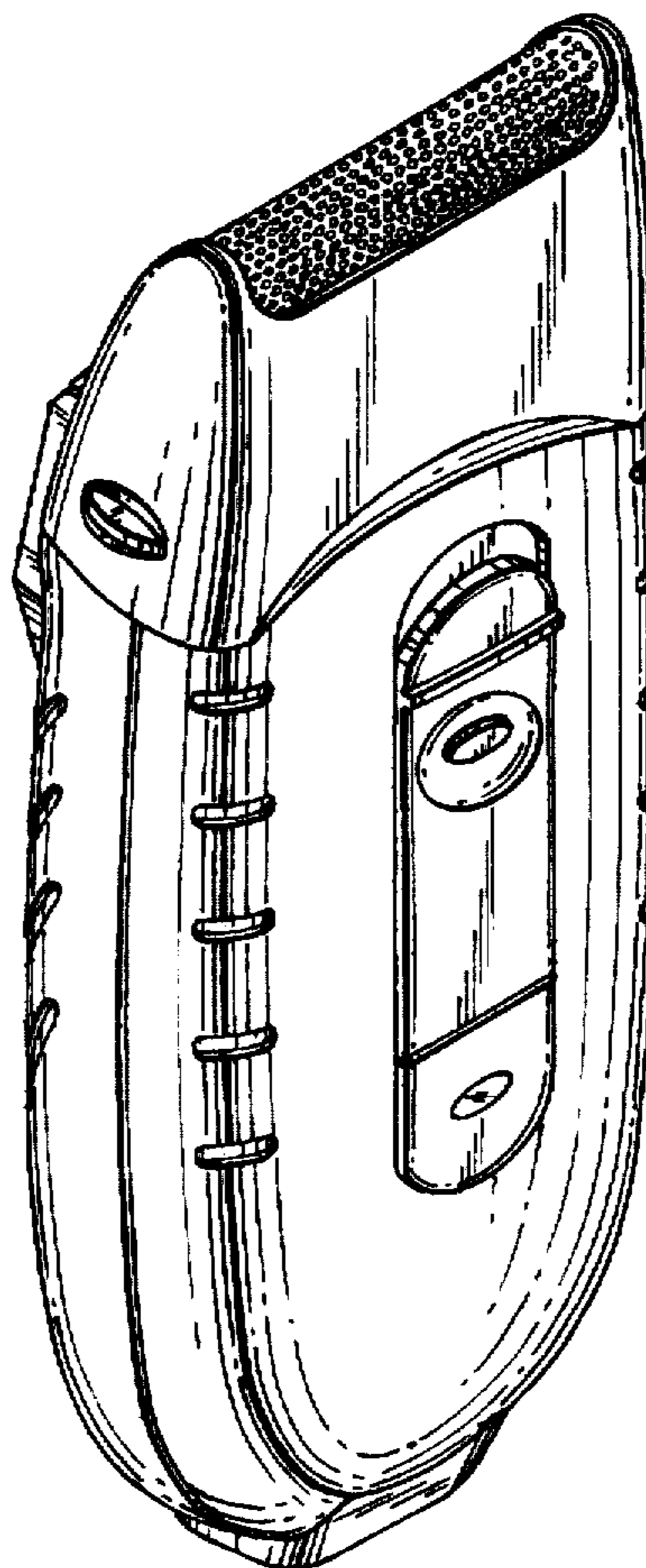
[57] **CLAIM**

The ornamental design for a rechargeable shaver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the rechargeable shaver showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a side elevational view, looking from the right side of FIG. 3, the opposite side being a mirror image thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is an enlarged view of a portion of the foil as shown in area "7" of FIG. 3.

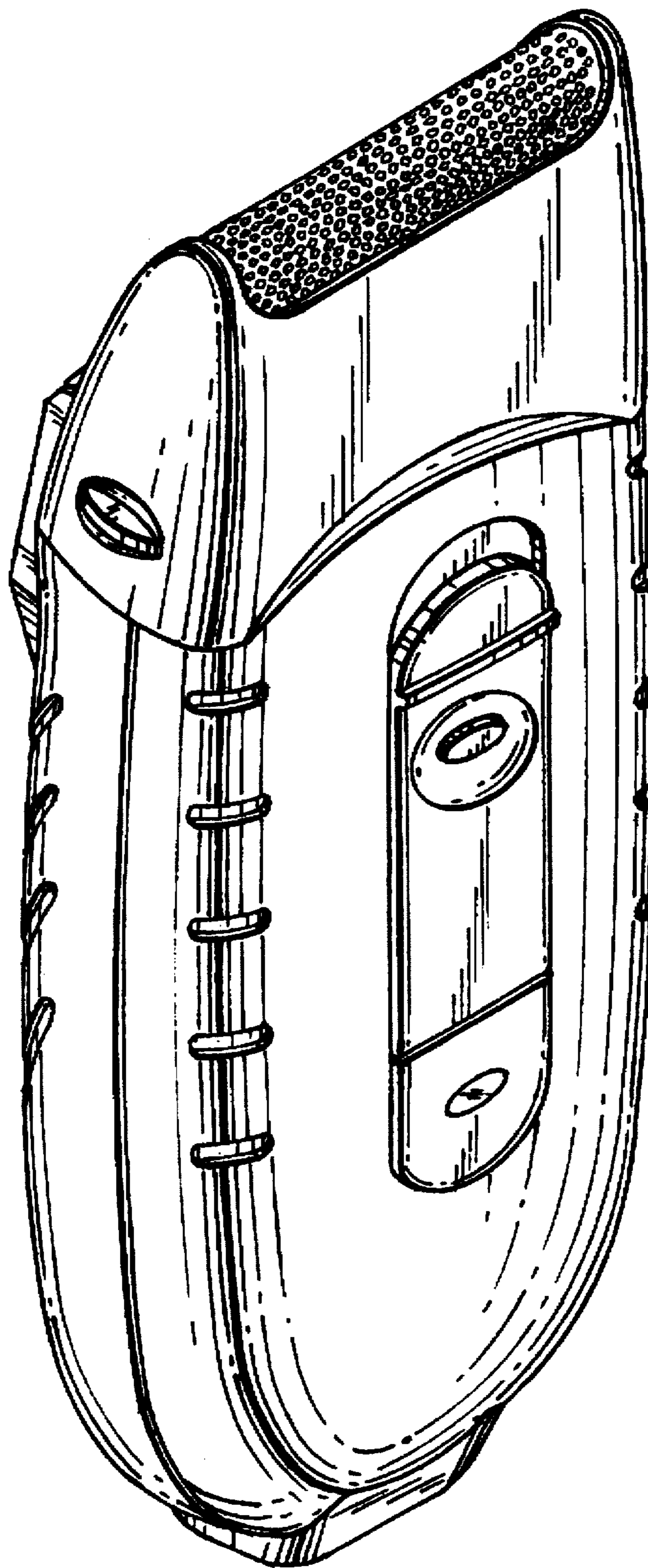

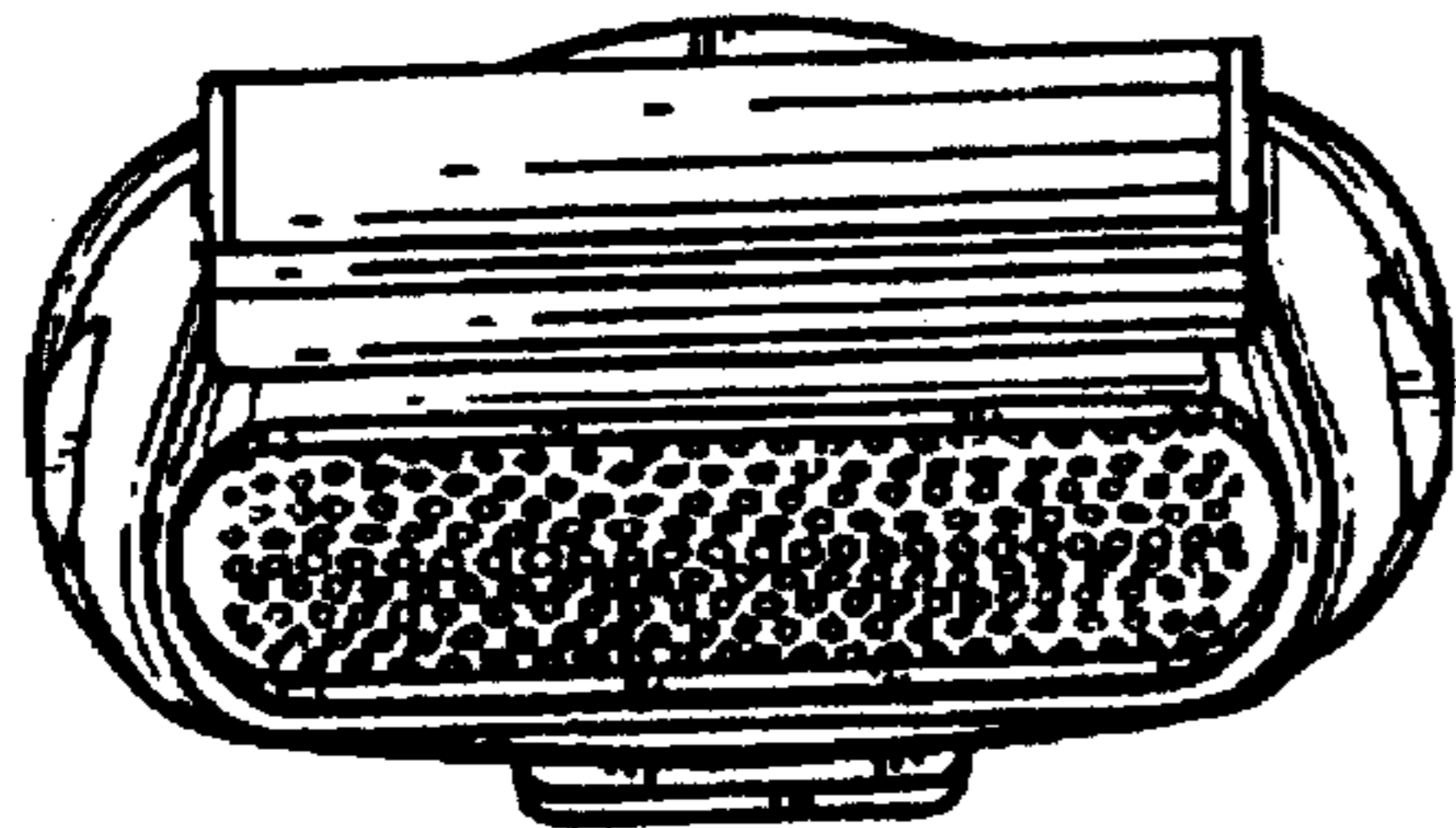

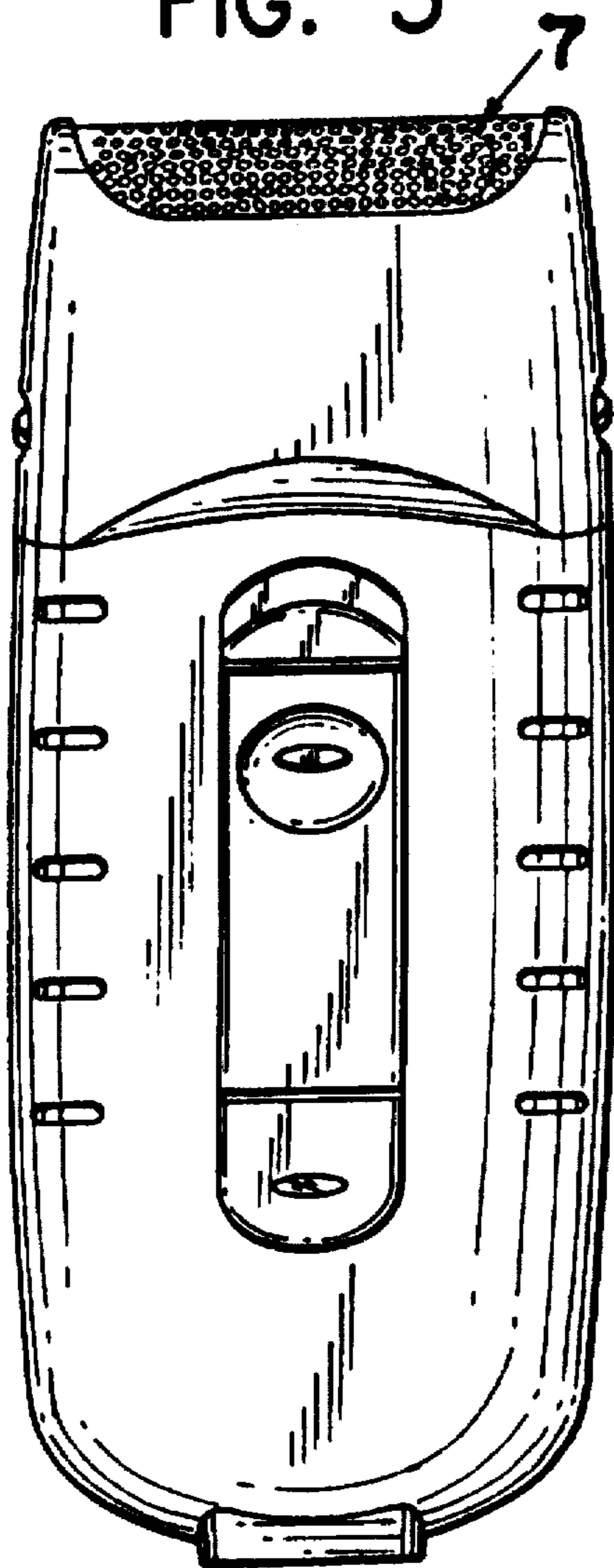

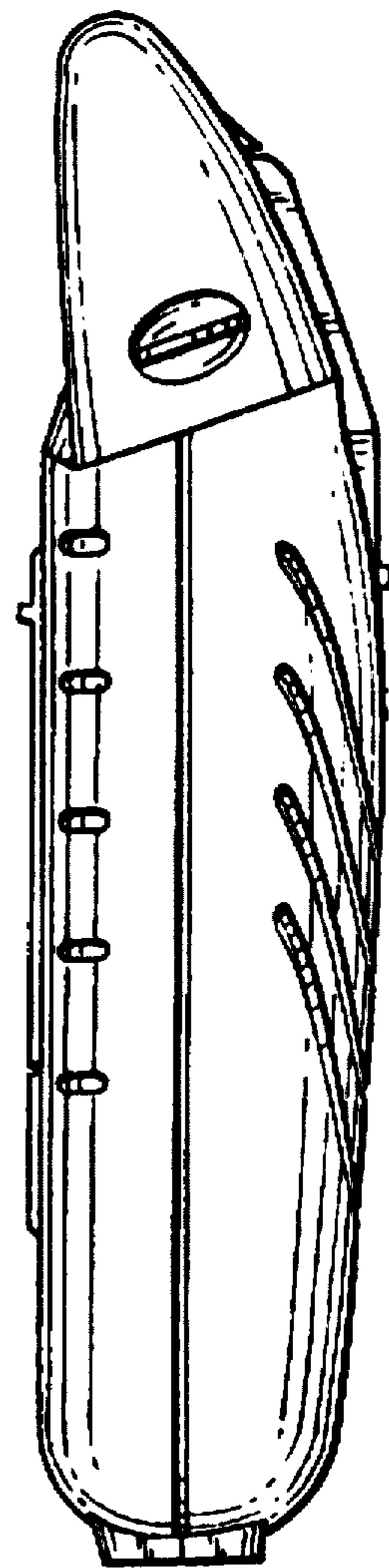

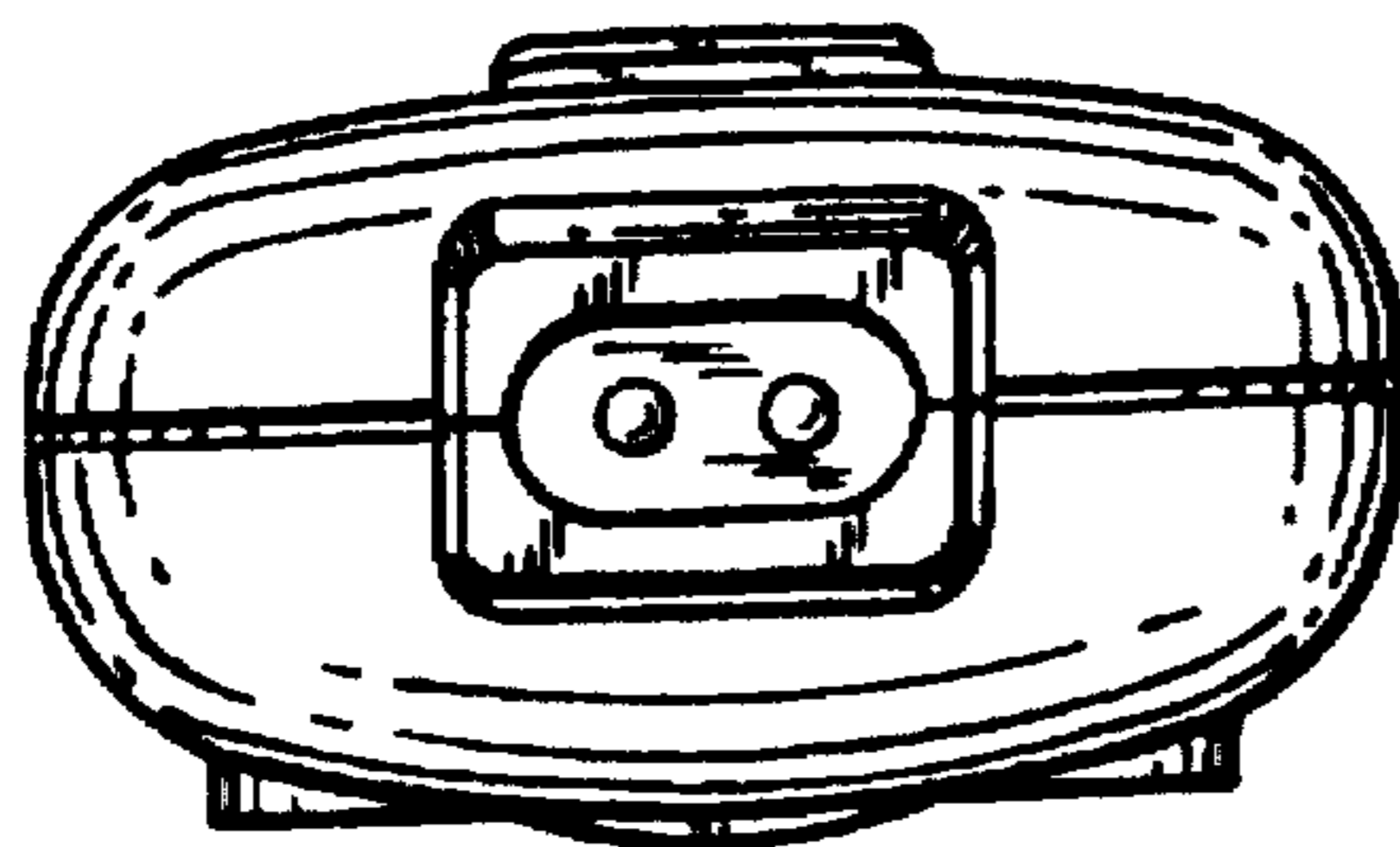
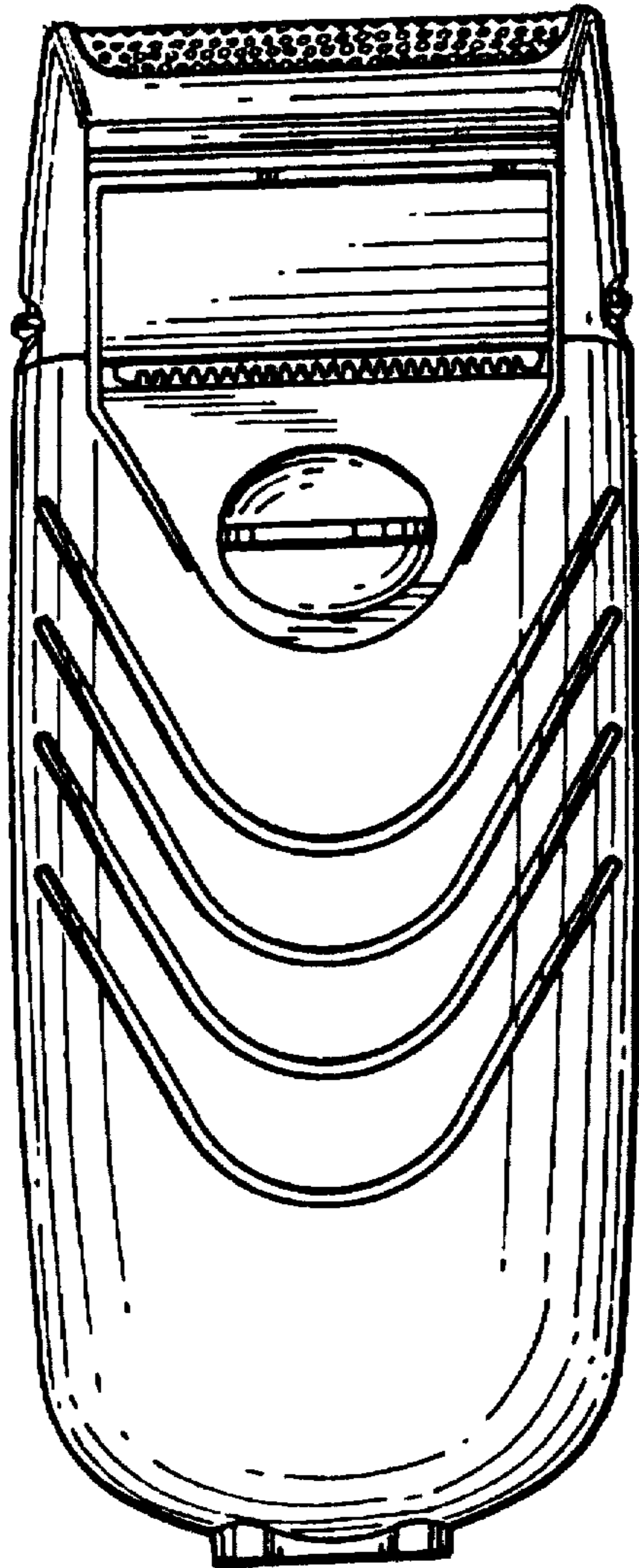
