## [57] CLAIM

The ornamental design for a console for an appliance front panel, as shown and described.

## DESCRIPTION

FIG. 1 is a front left perspective view of a console for an appliance front panel showing our new design, the broken line showing of the front panel of an appliance being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a front elevational view of the console for an appliance front panel of FIG. 1;

FIG. 3 is a top plan view of the console for an appliance front panel of FIG. 1;

FIG. 4 is a bottom plan view of the console for an appliance front panel of FIG. 1;

FIG. 5 is a right side elevational view of the console for an appliance front panel of FIG. 1, the left side elevational view being a mirror image thereof;

FIG. 6 is a front left perspective view of a second embodiment of the console for an appliance front panel showing our new design, the broken line showing of the front panel of an appliance being for illustrative purposes only and forming no part of the claimed design;

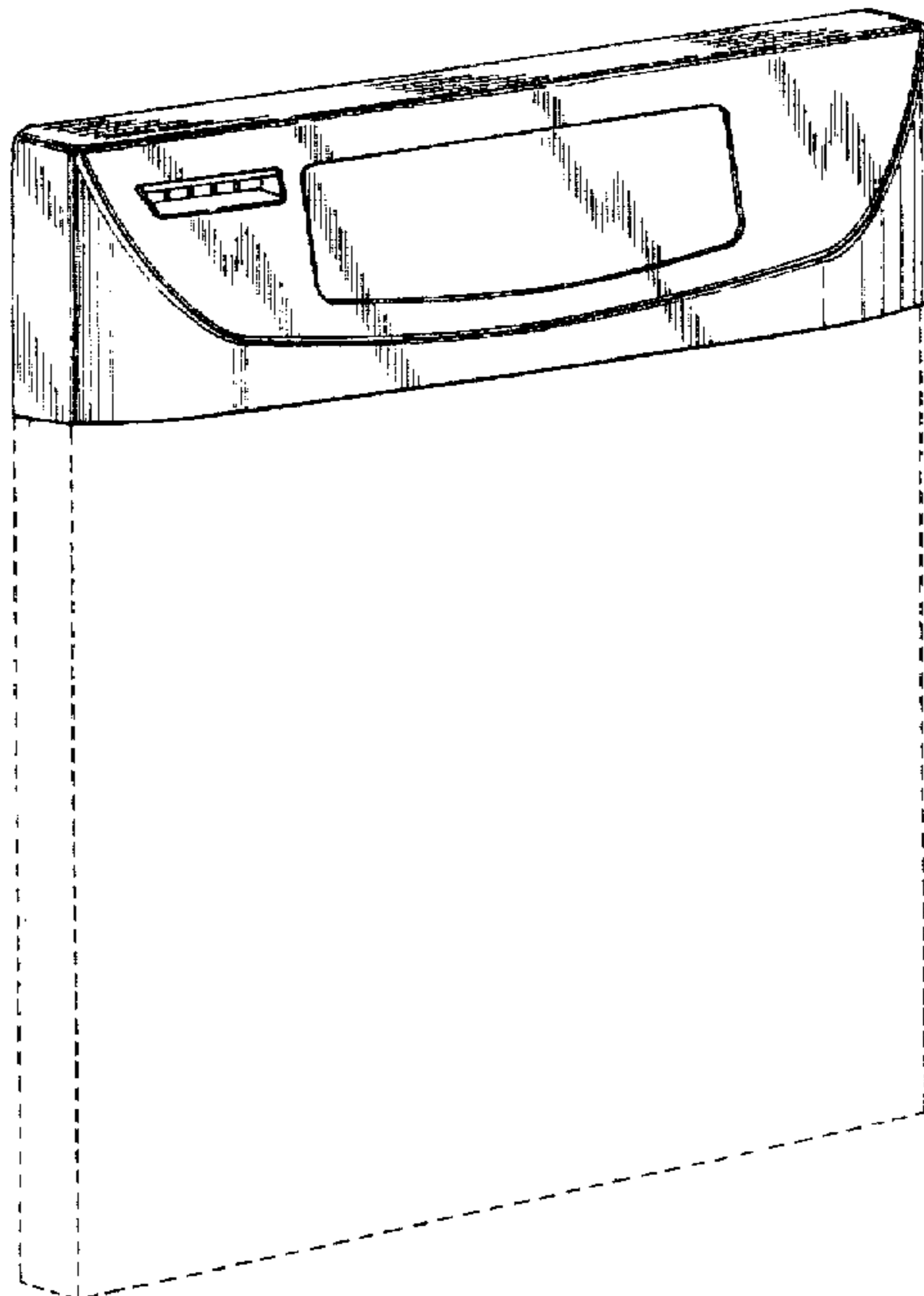
FIG. 7 is a front elevational view of the console for an appliance front panel of FIG. 6;

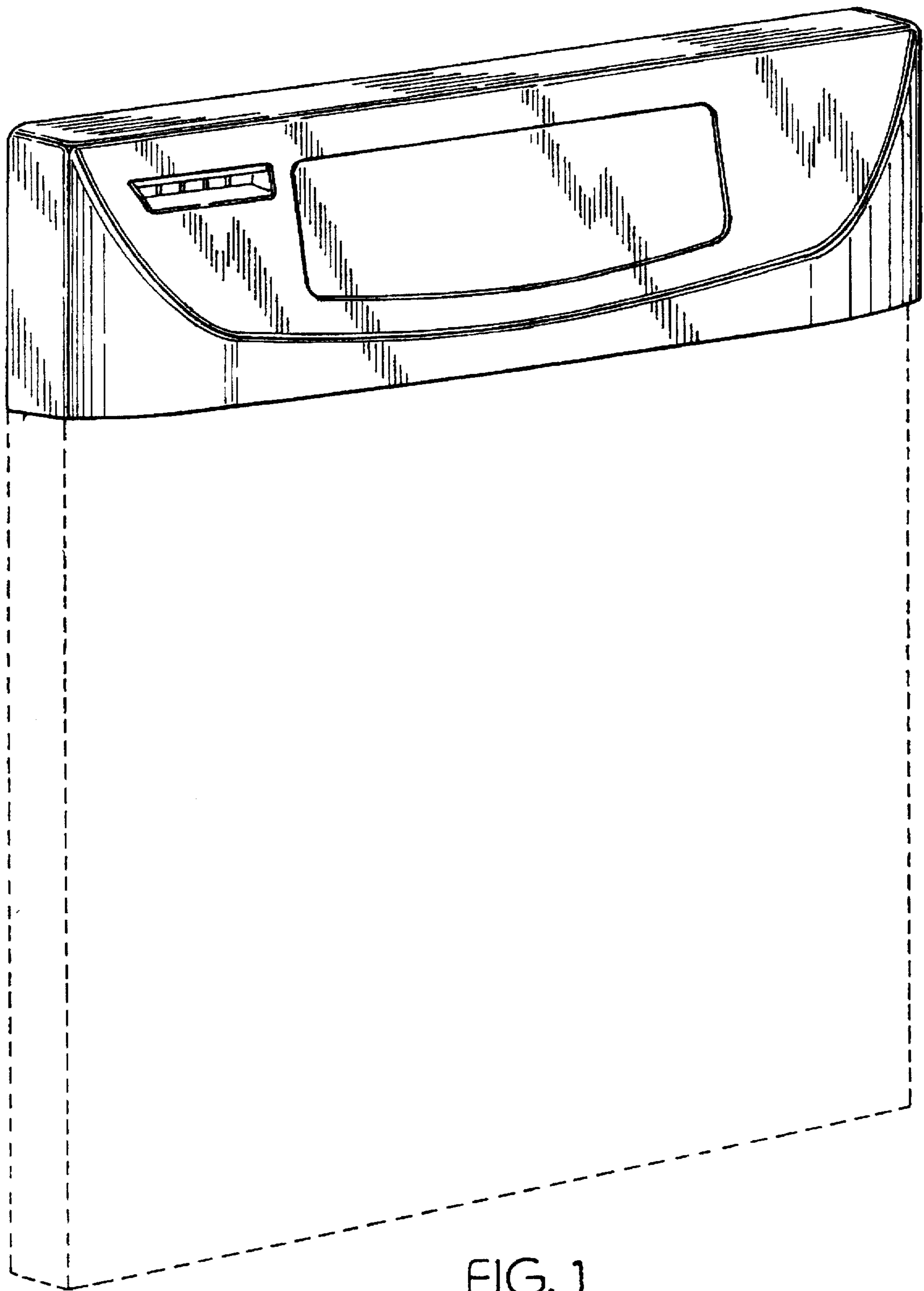
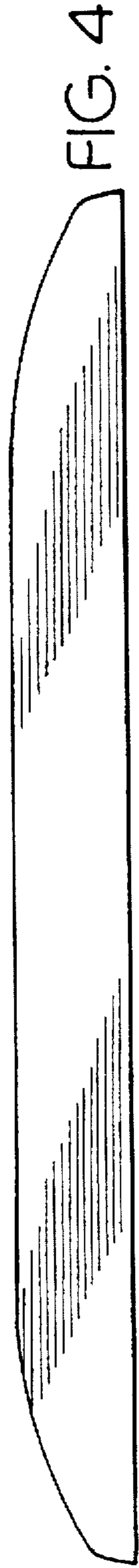
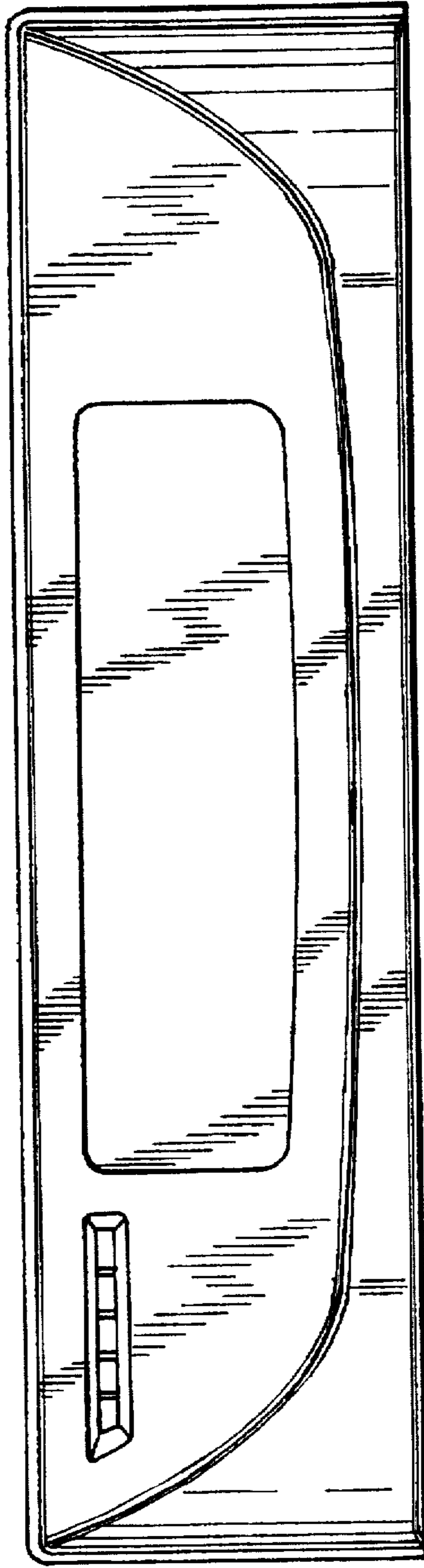
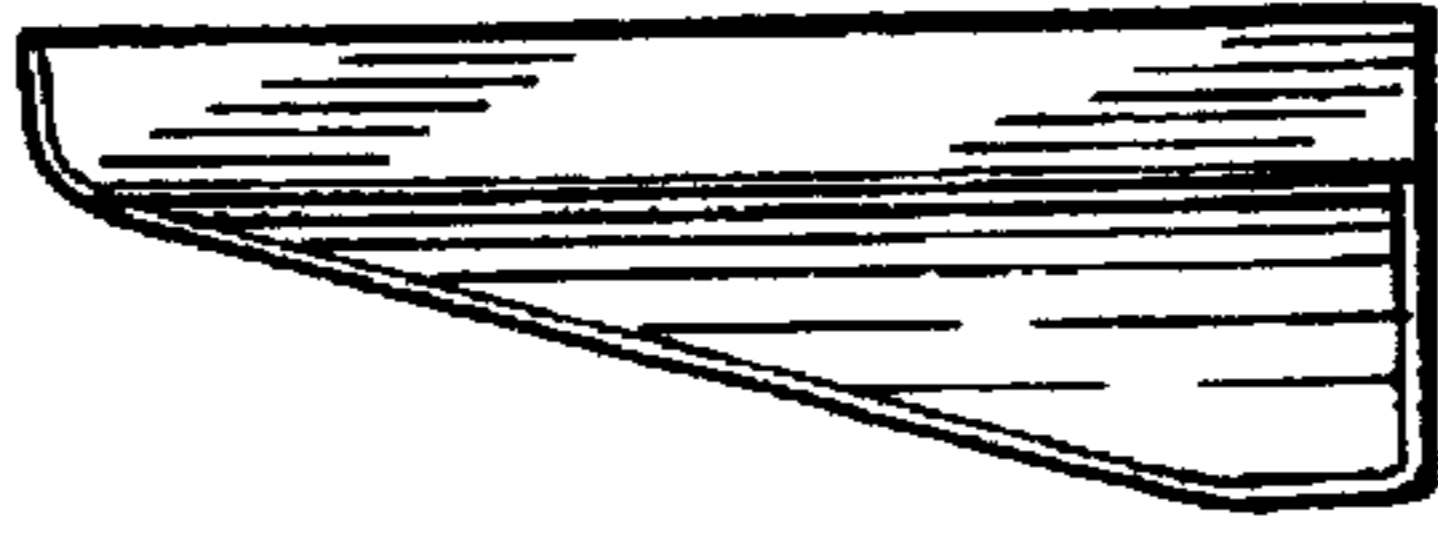
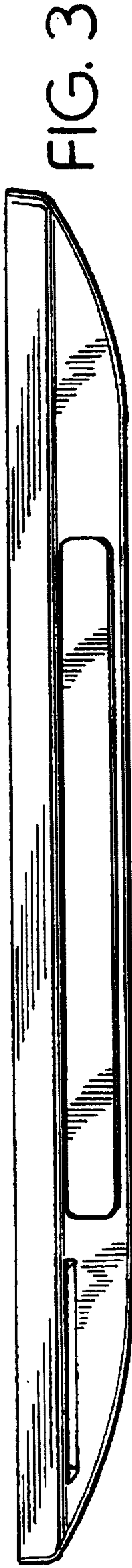

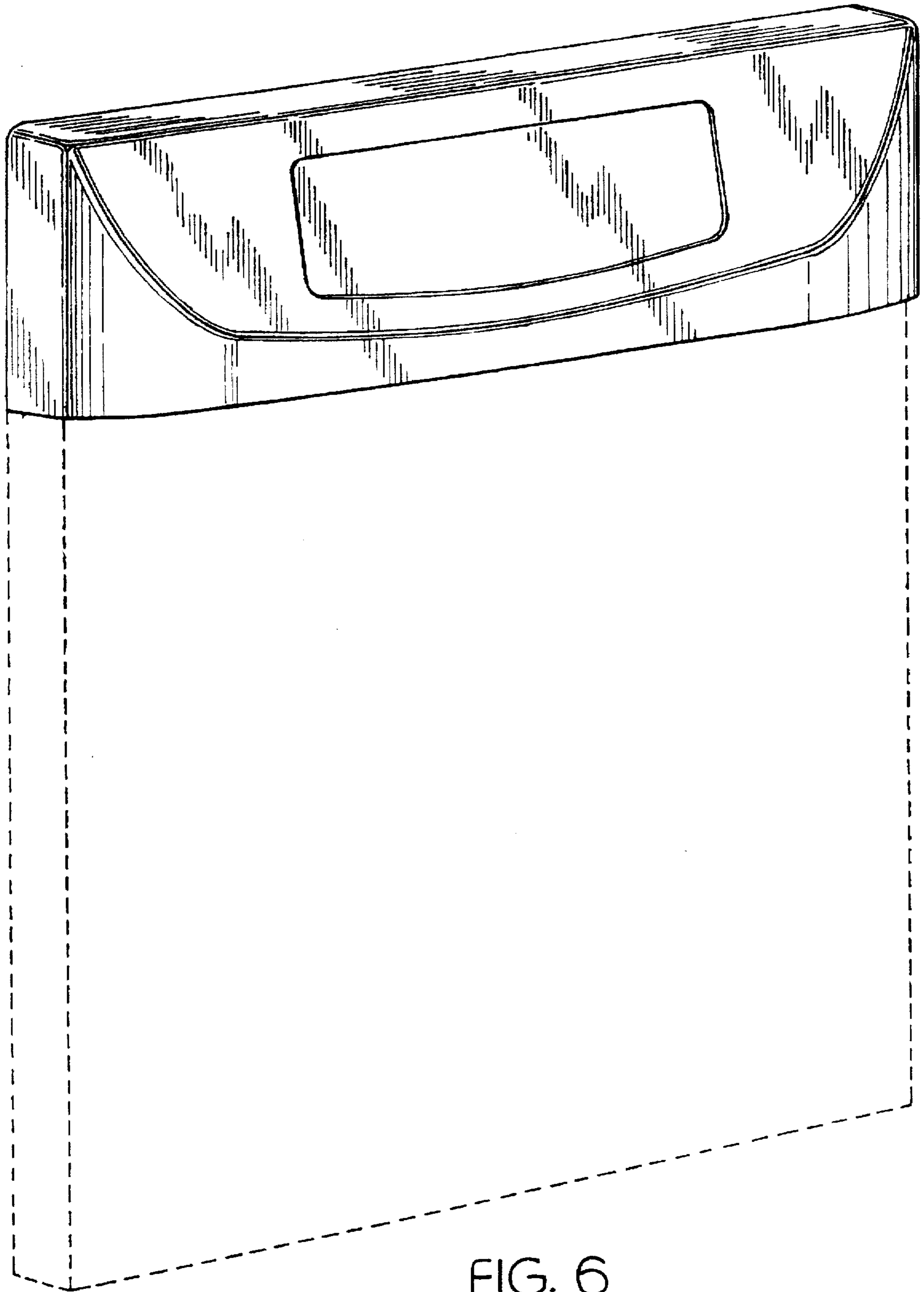

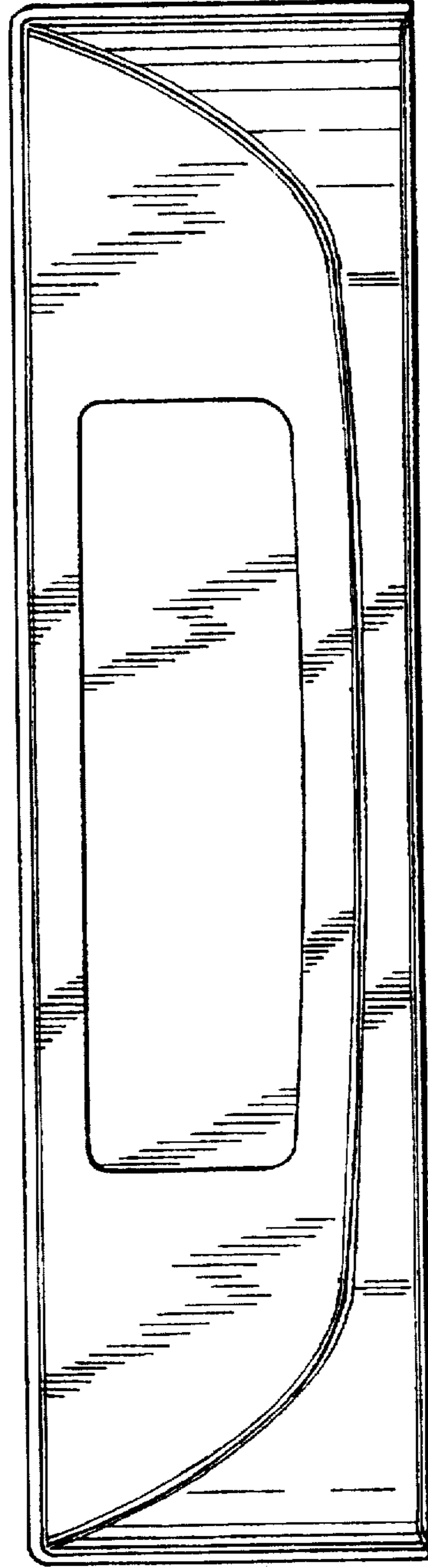

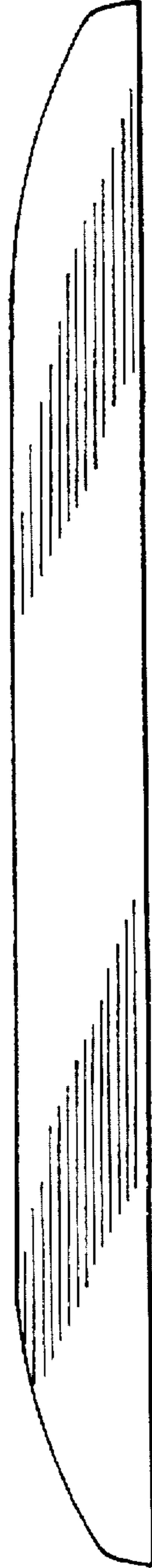
