[57] CLAIM

The ornamental design for a protective shoe, as shown and described.

DESCRIPTION

 FIG. 27 is a left side view of the protective shoe of FIG. 26, the right side view being a mirror image thereof;

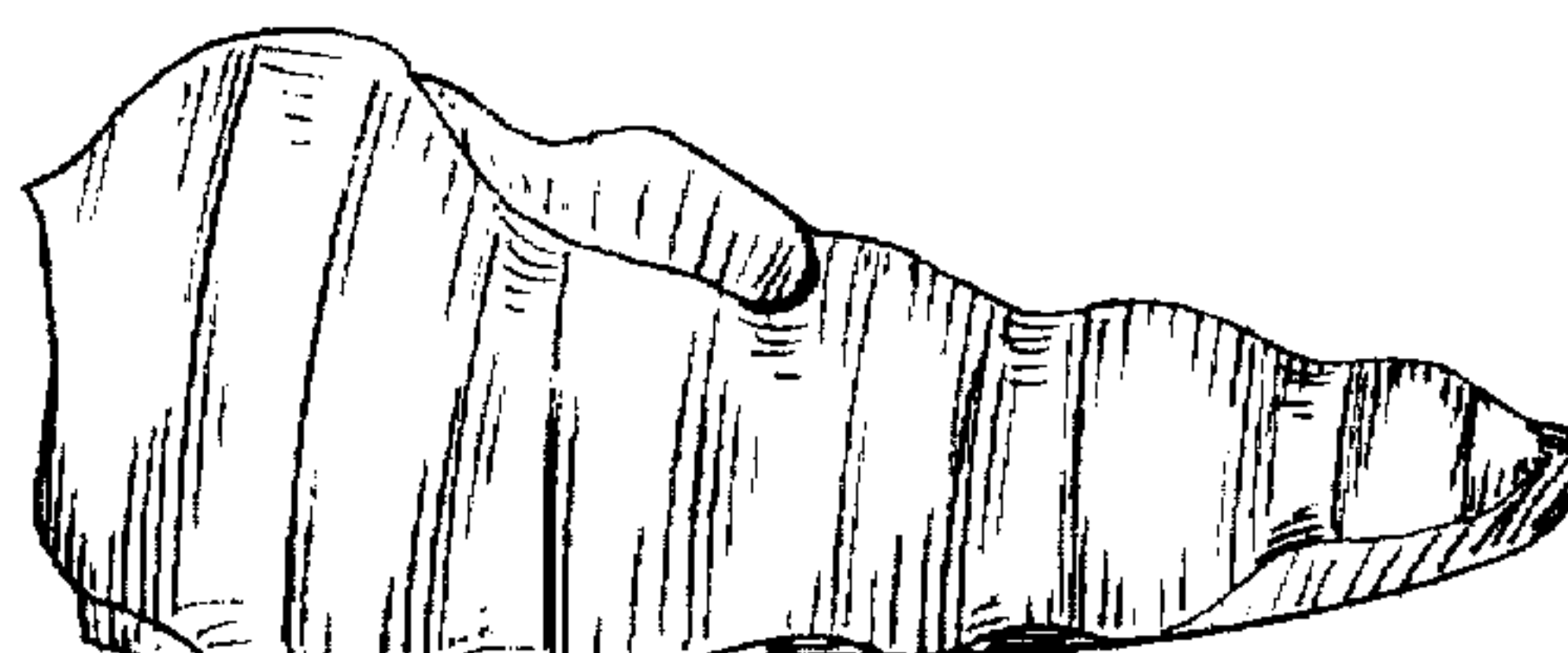
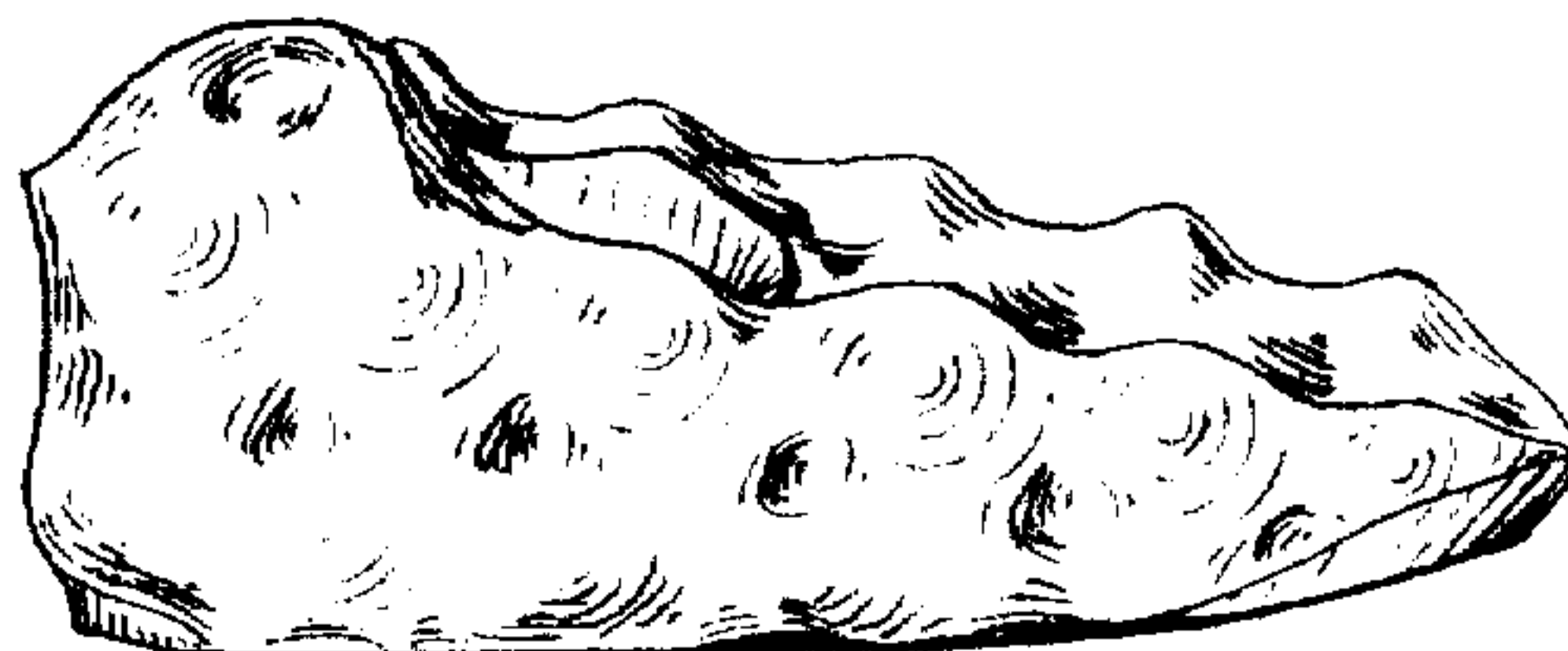
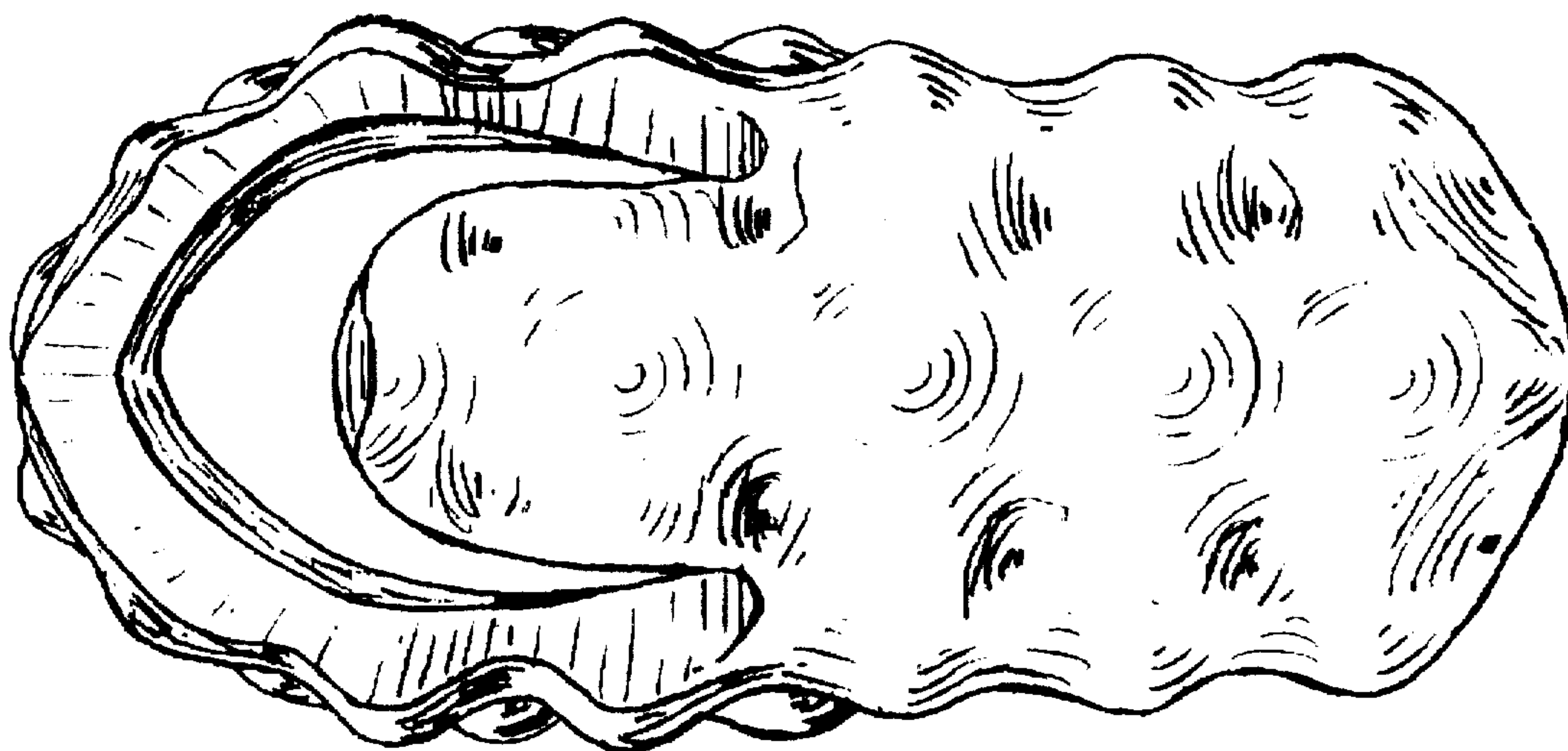


FIG. 28 is a bottom view of the protective shoe of FIG. 26;

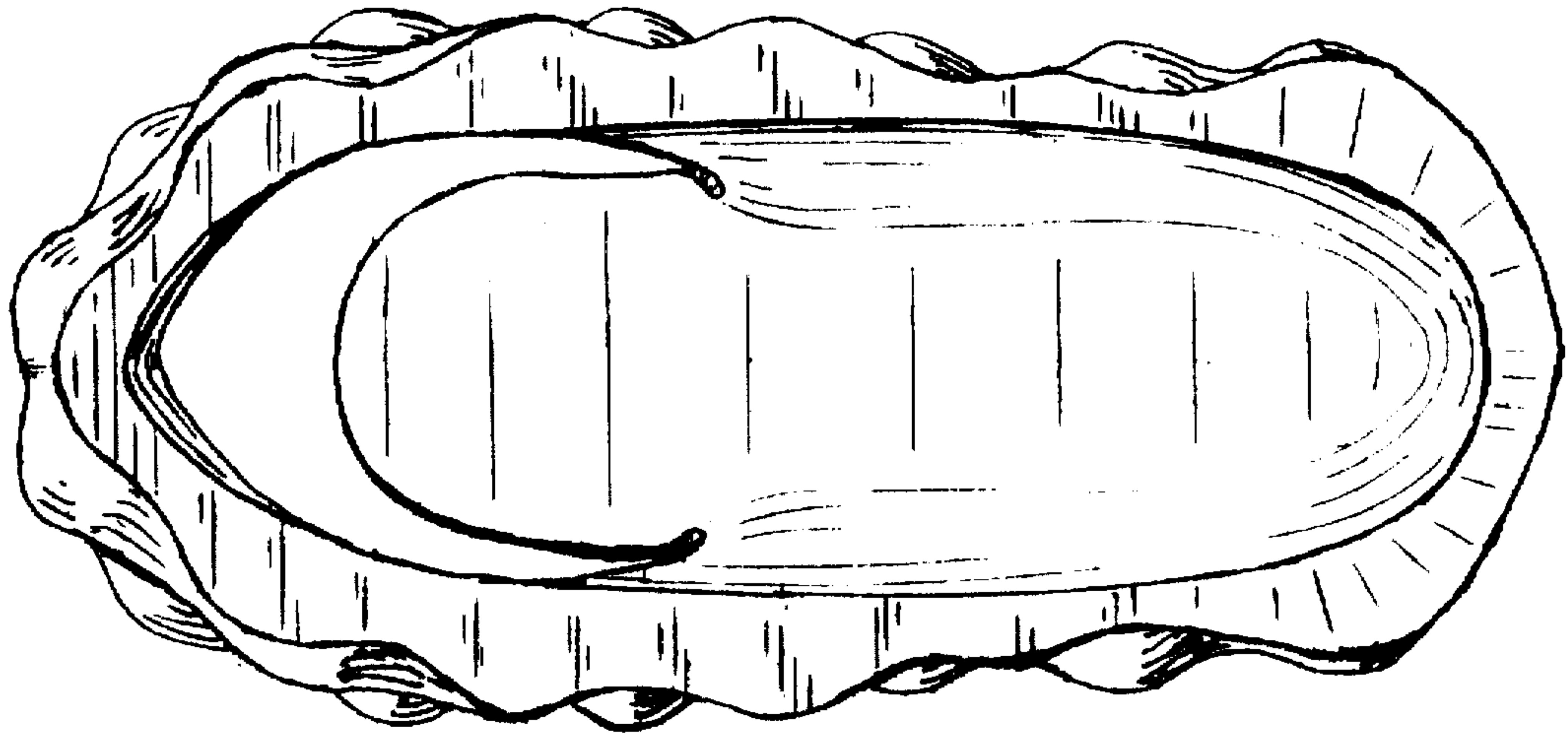

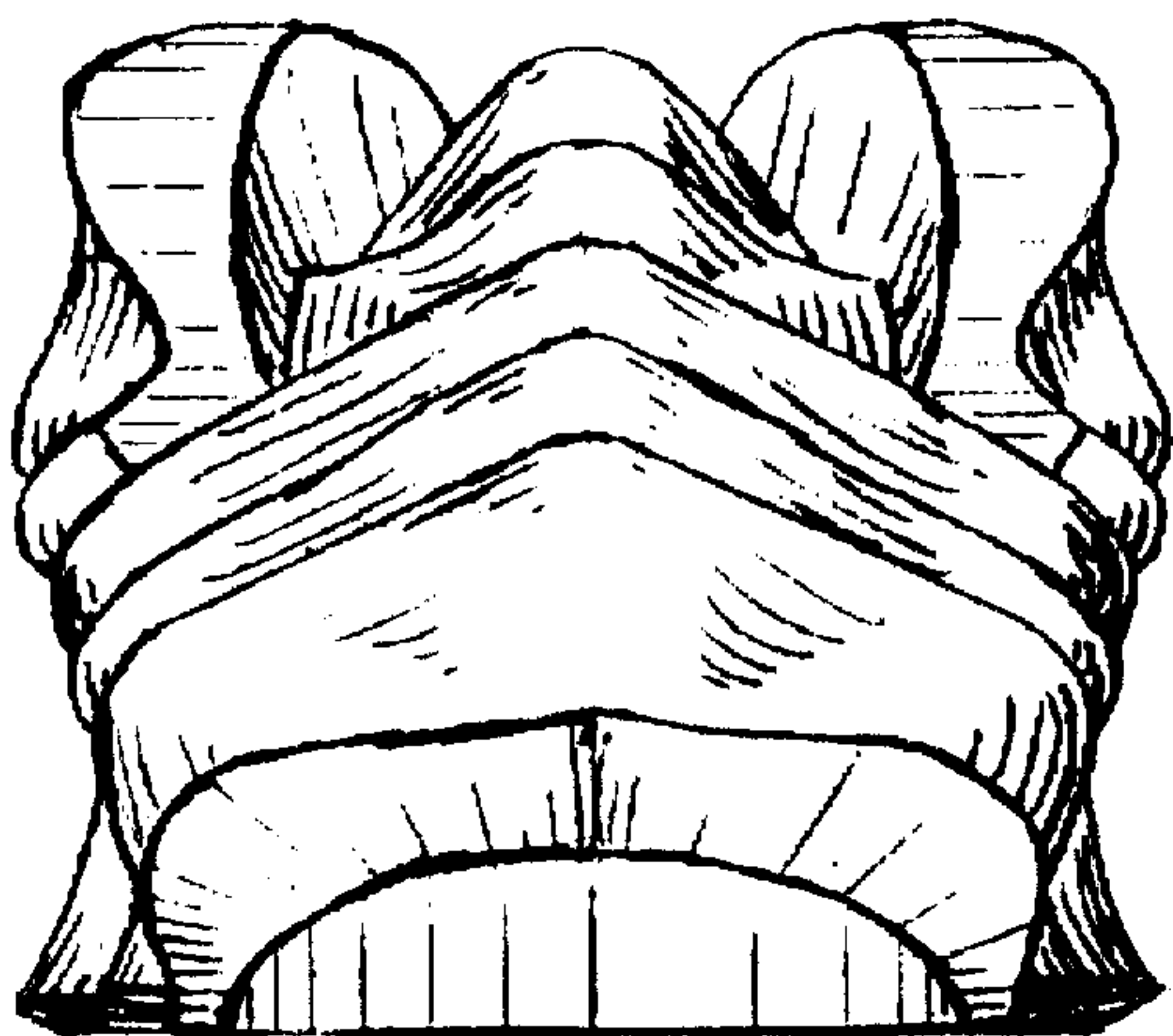

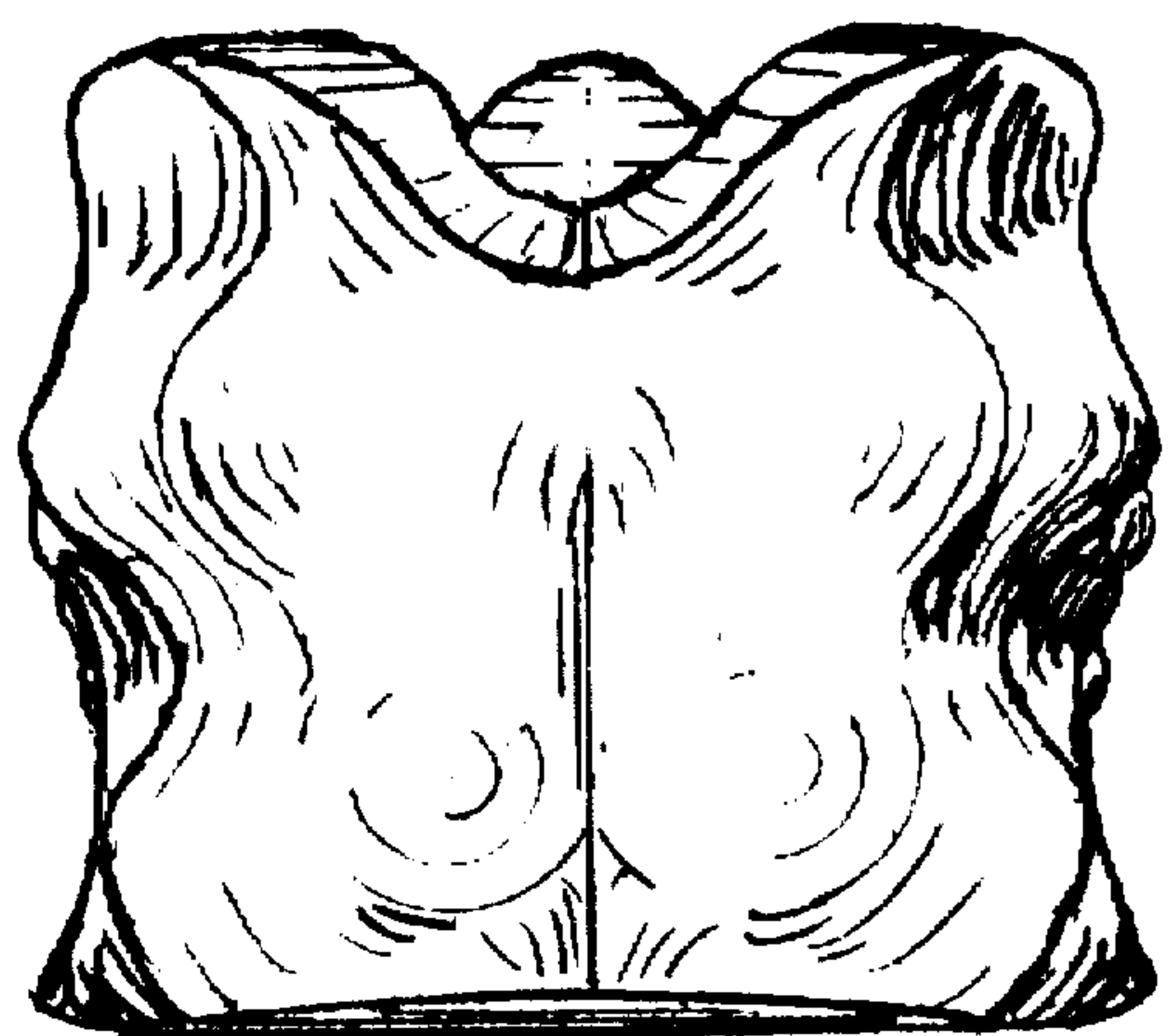

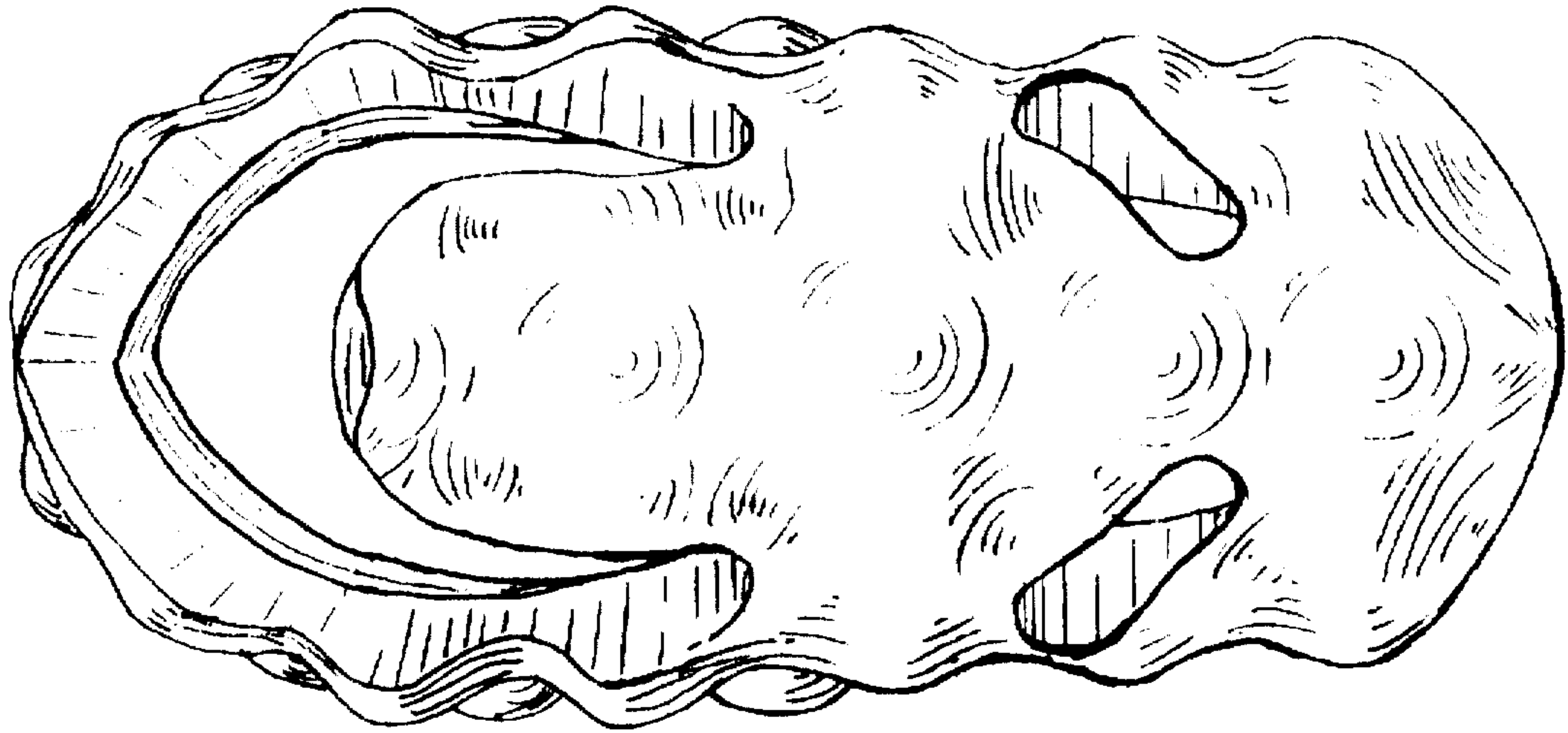

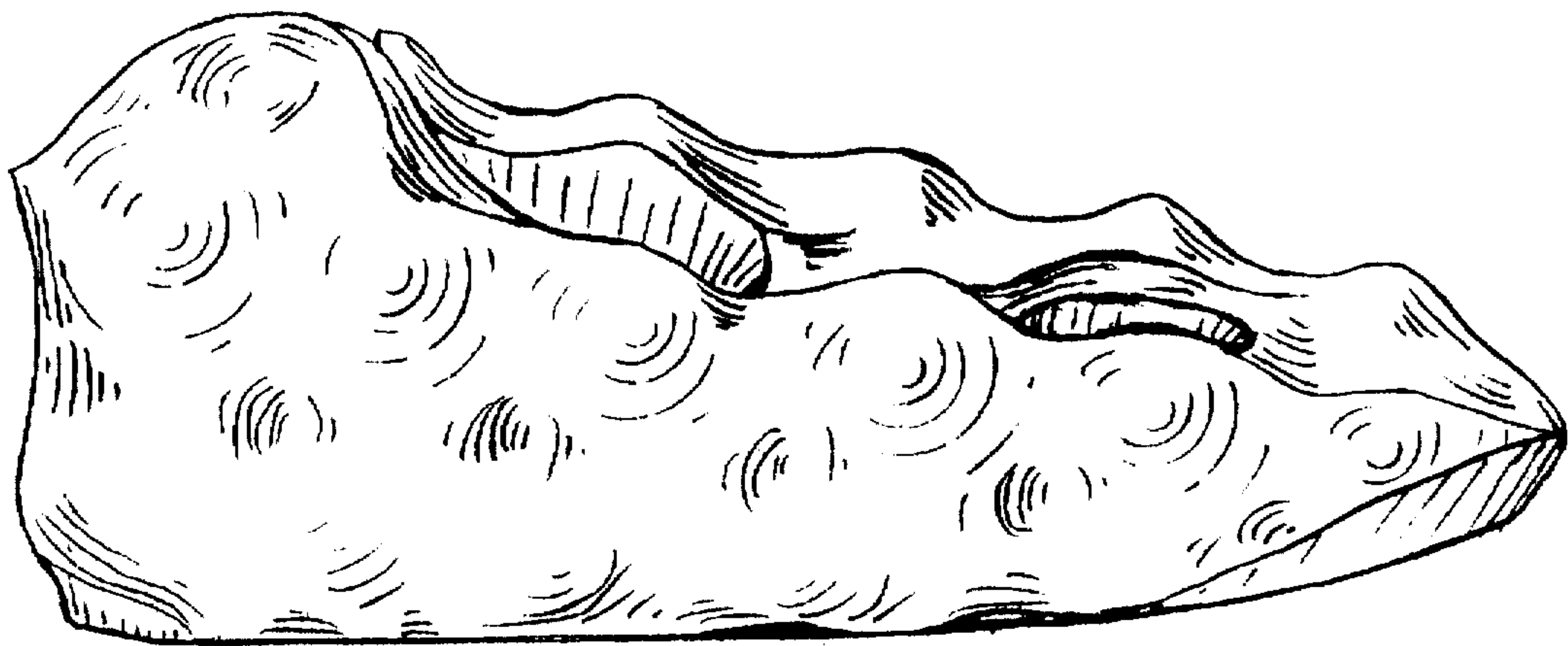

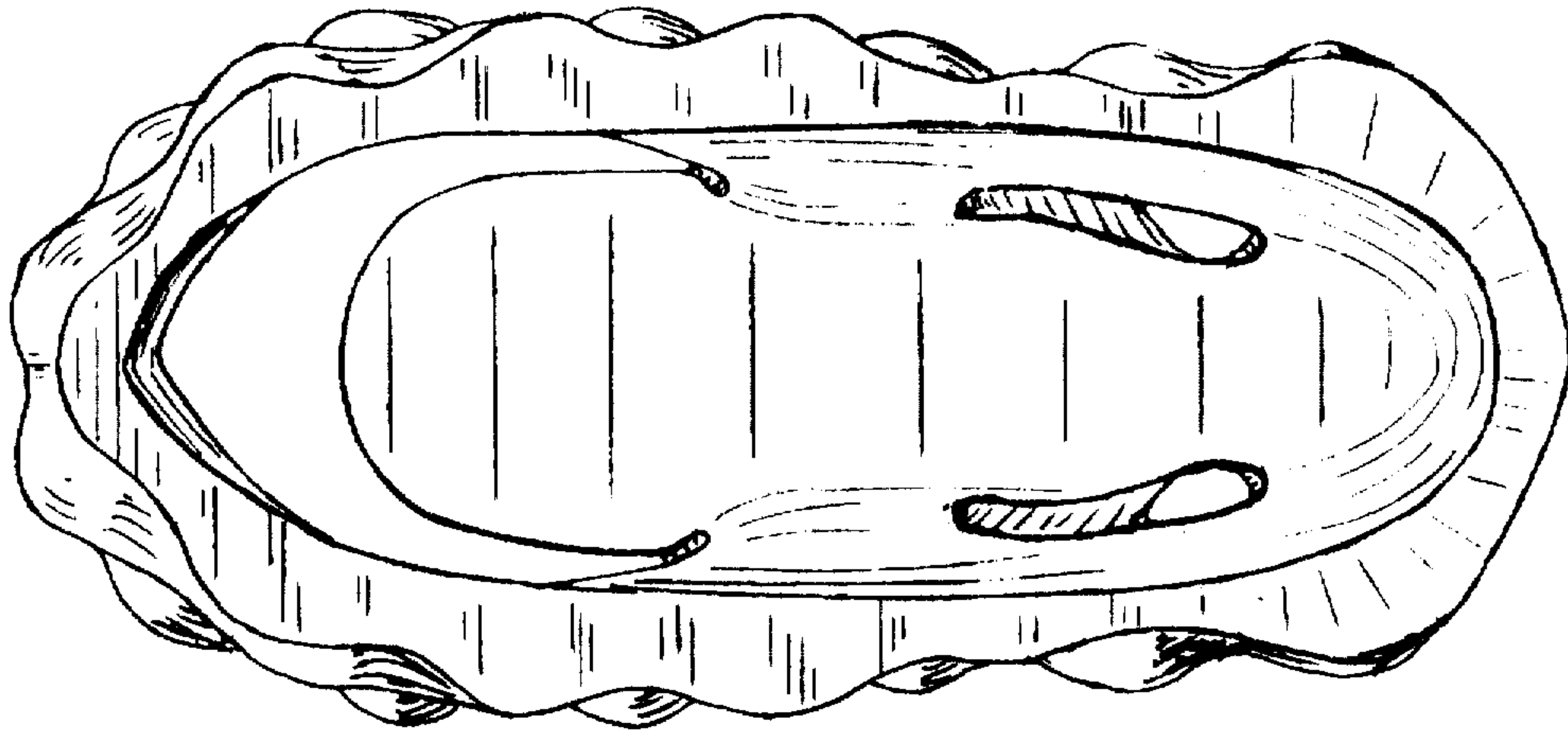

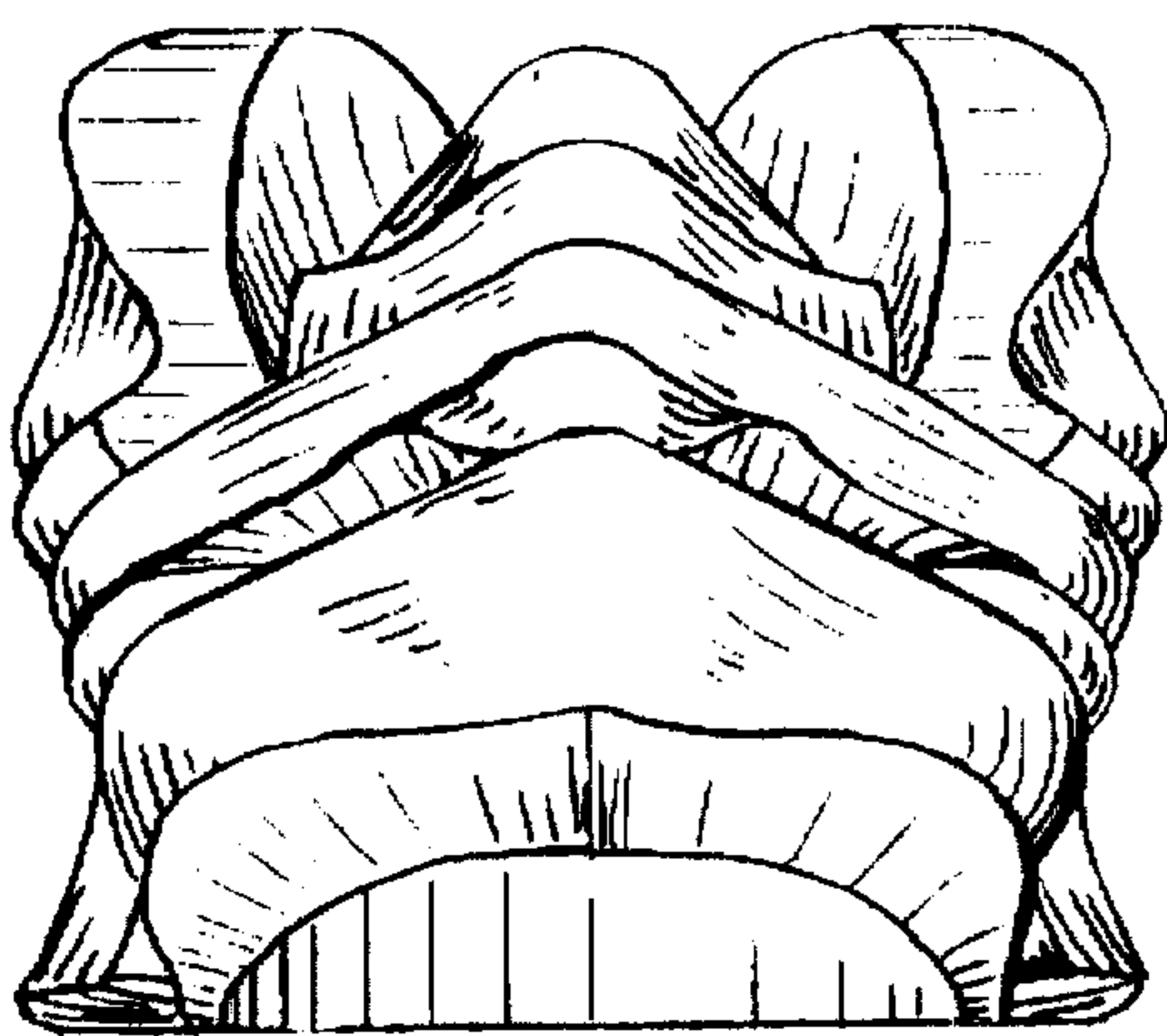

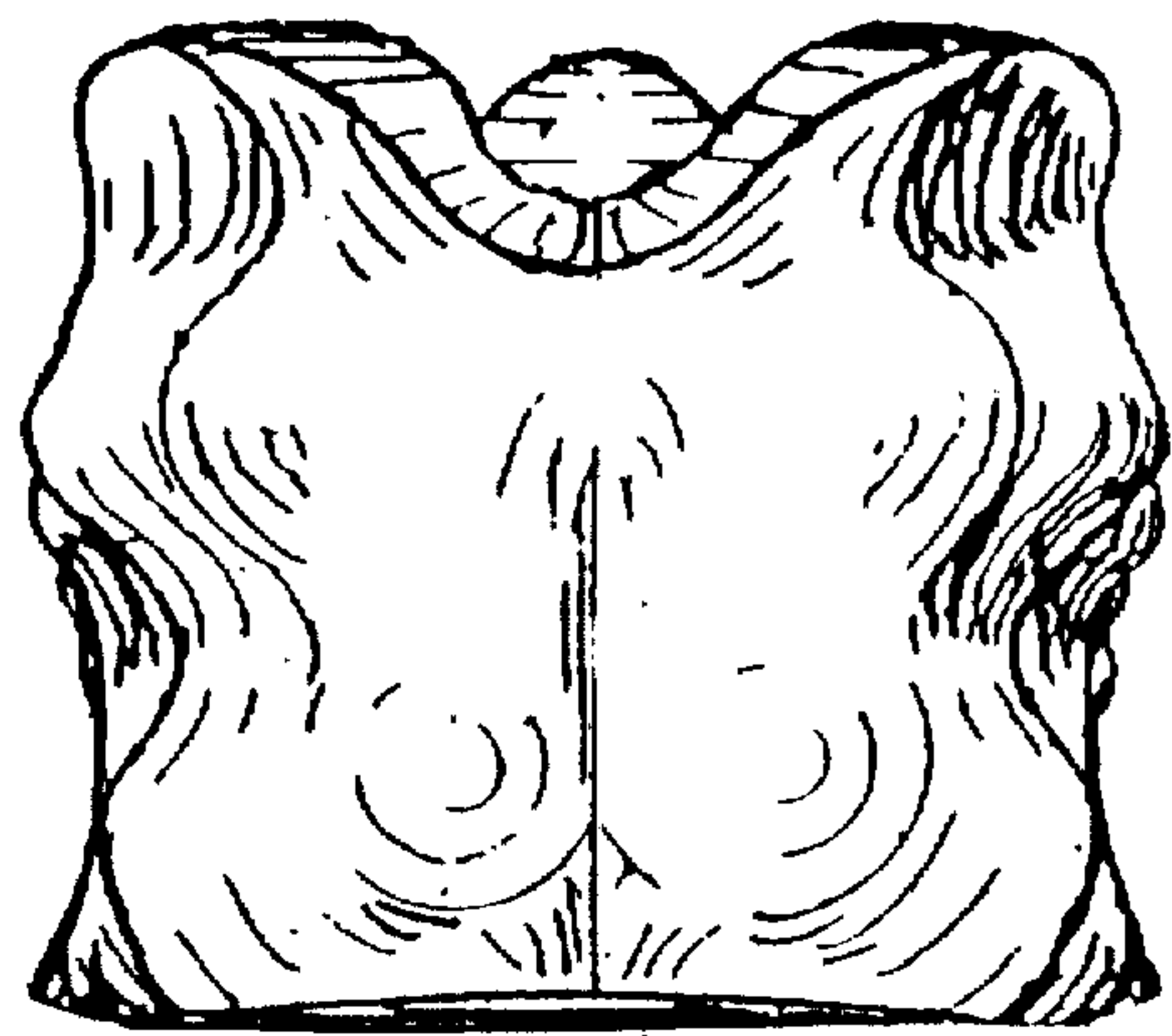

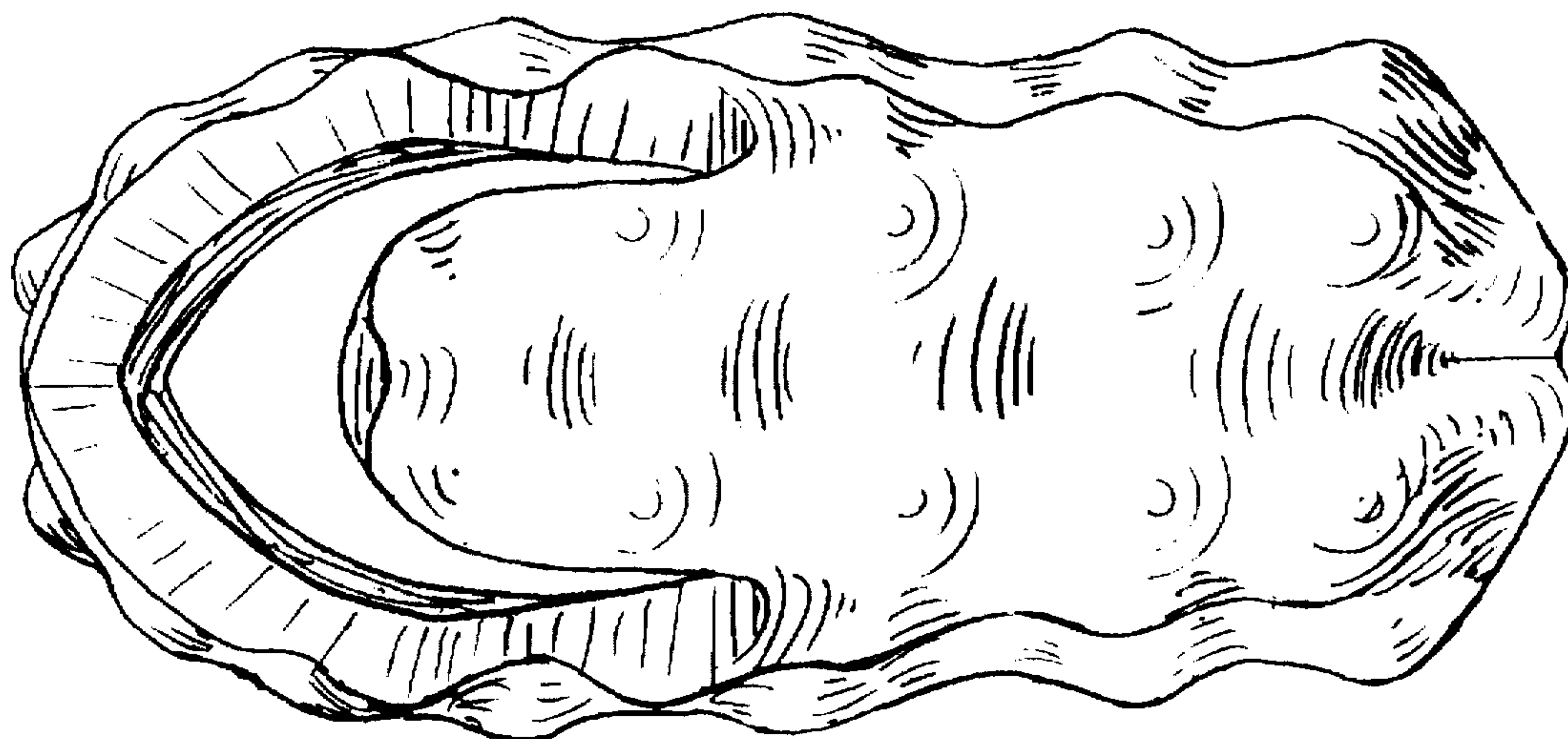

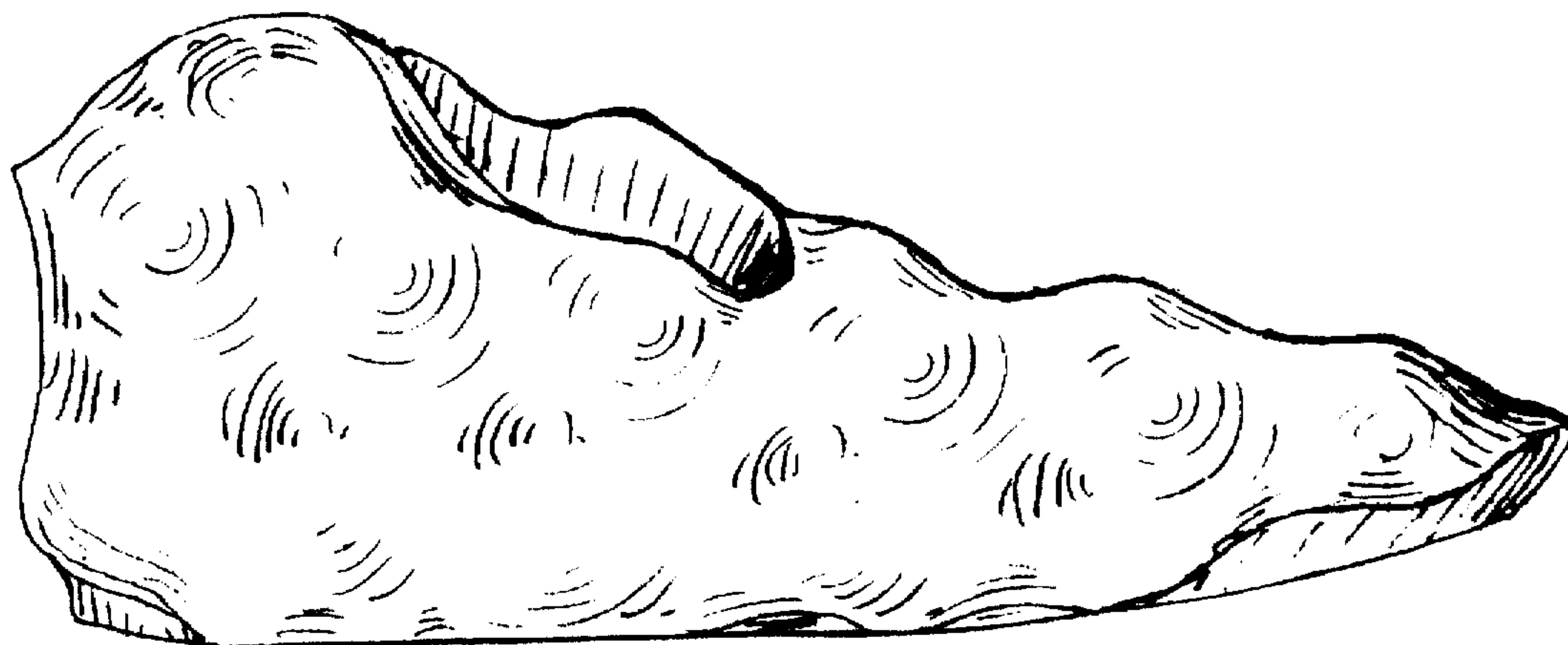

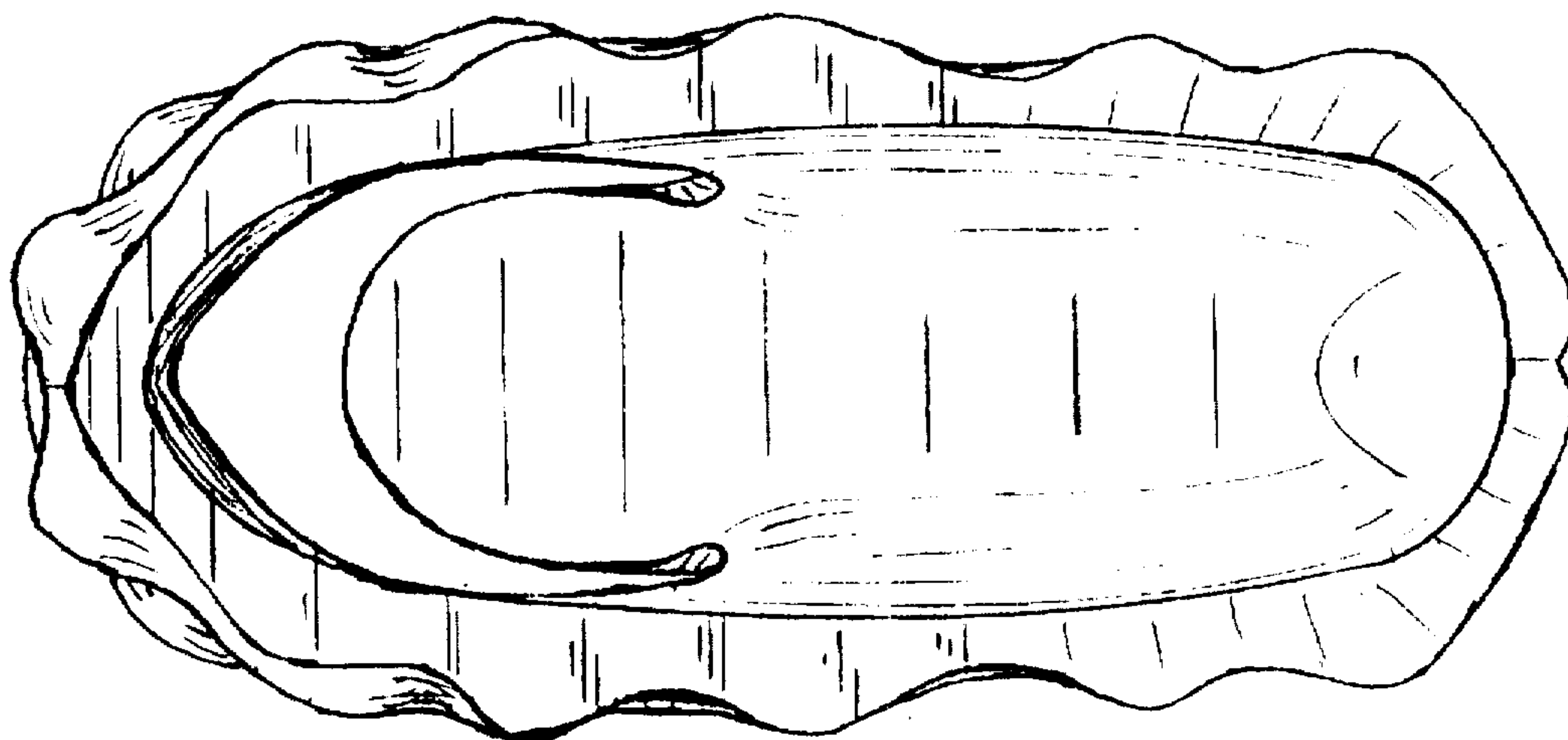

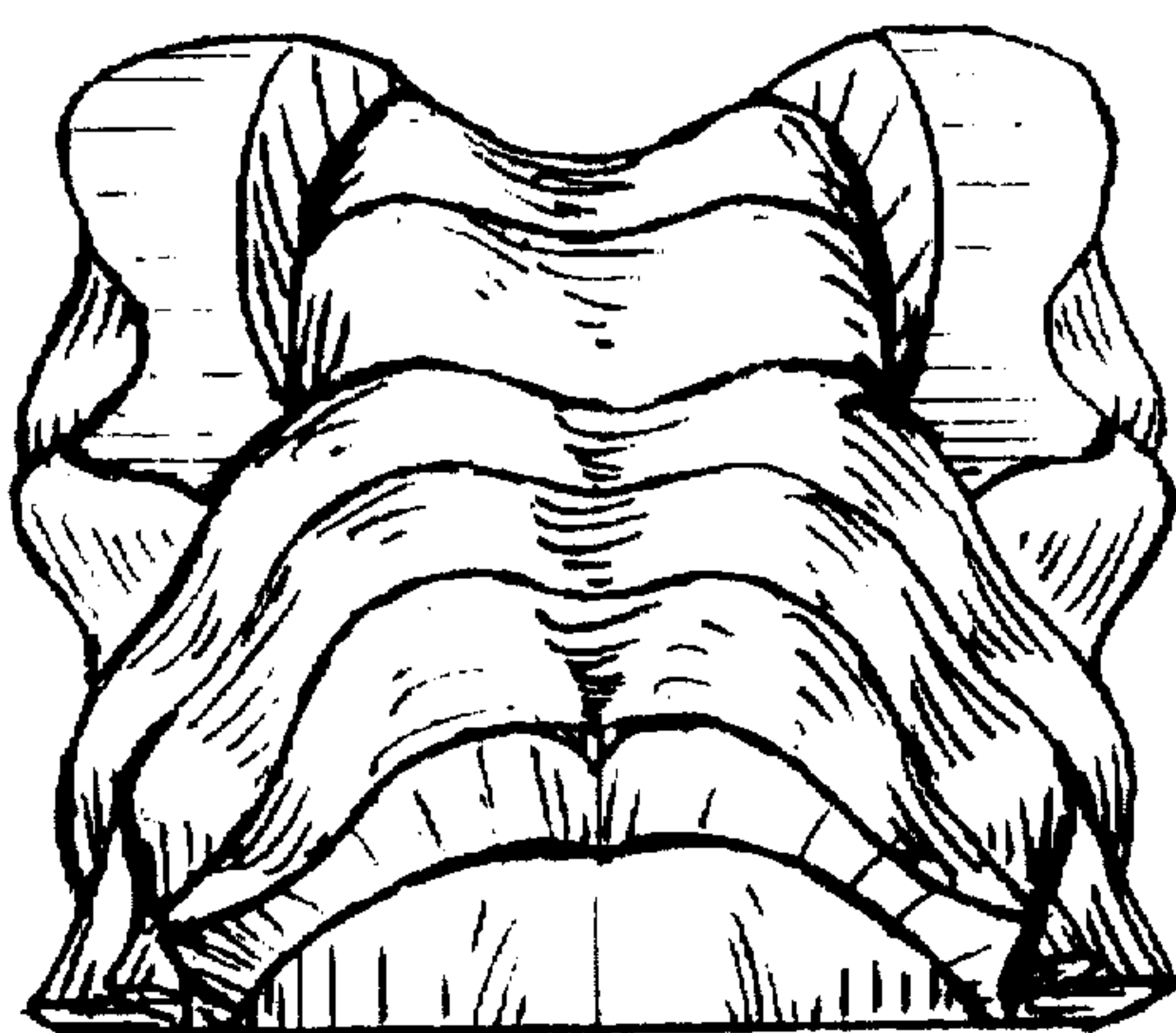

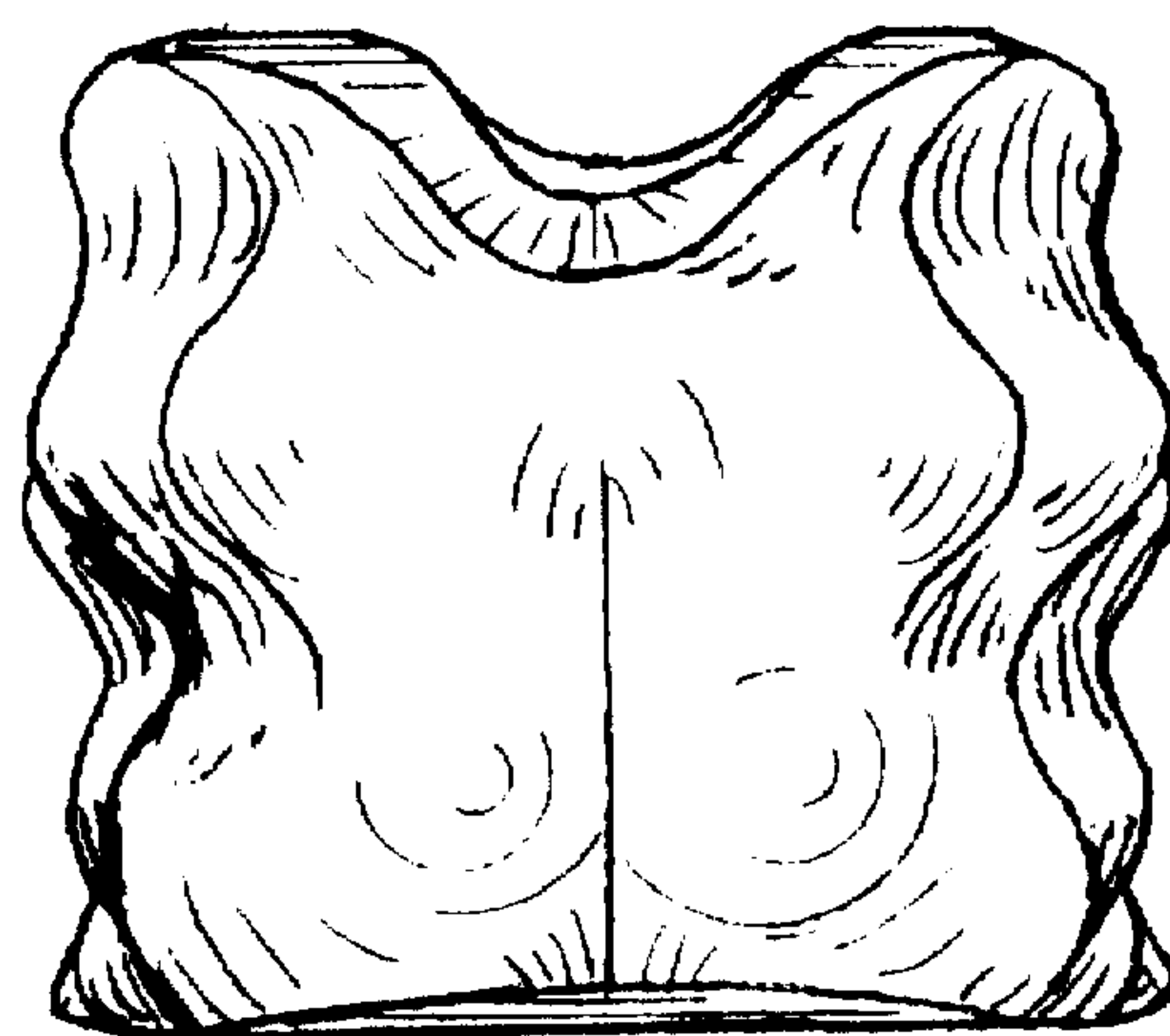

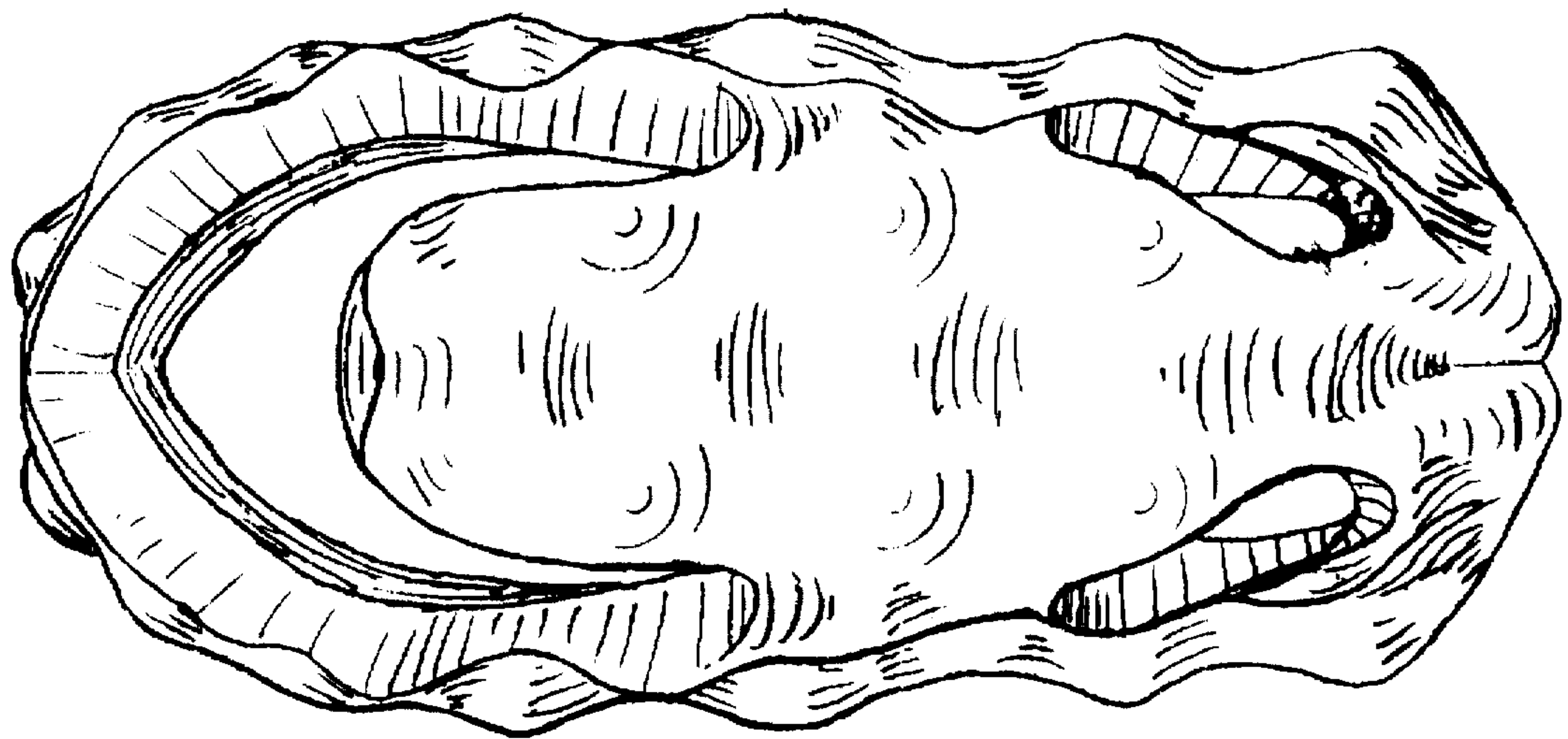

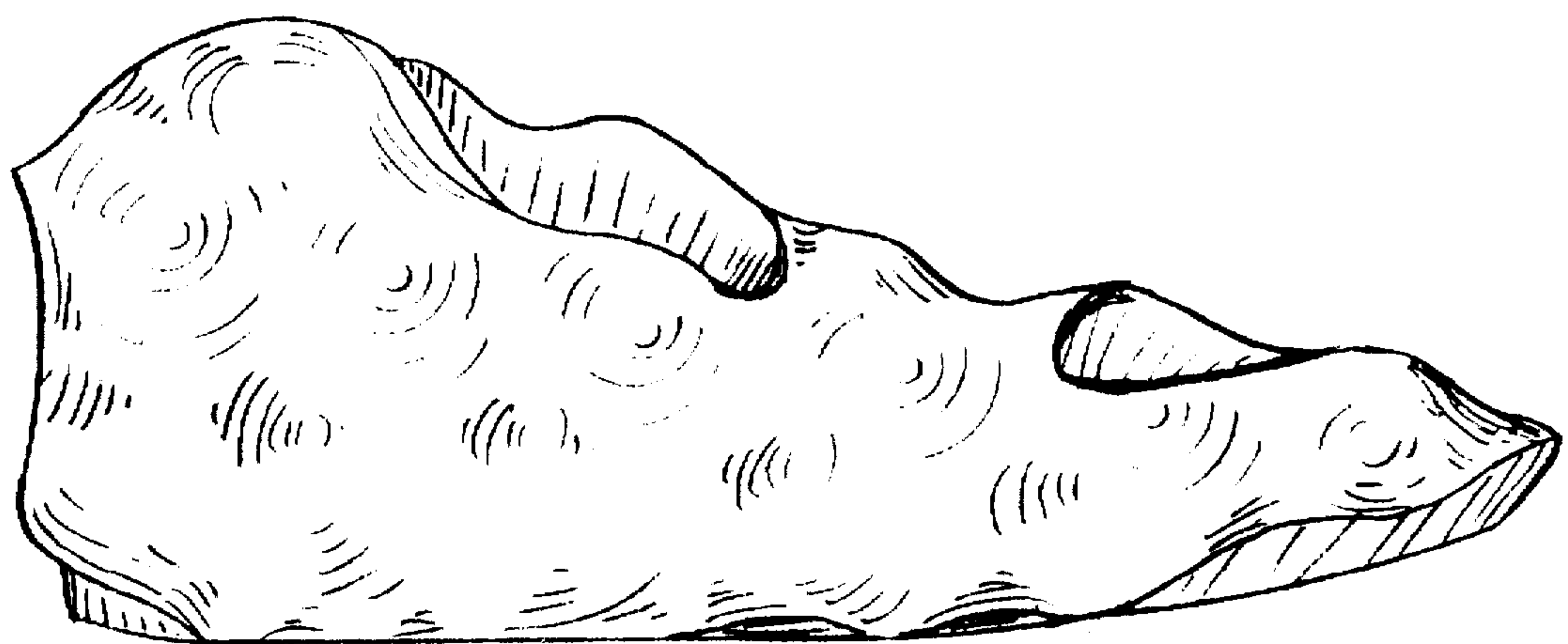

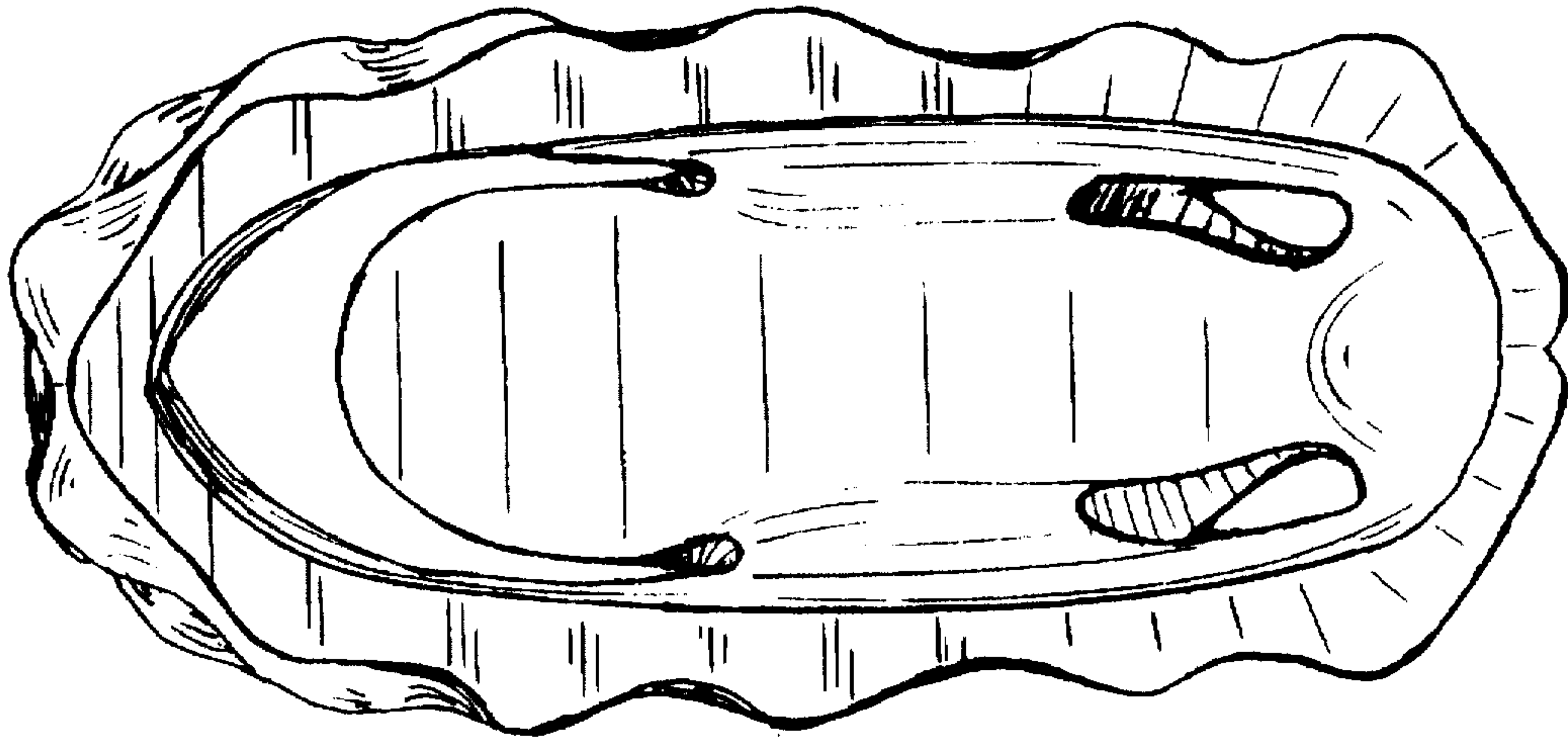

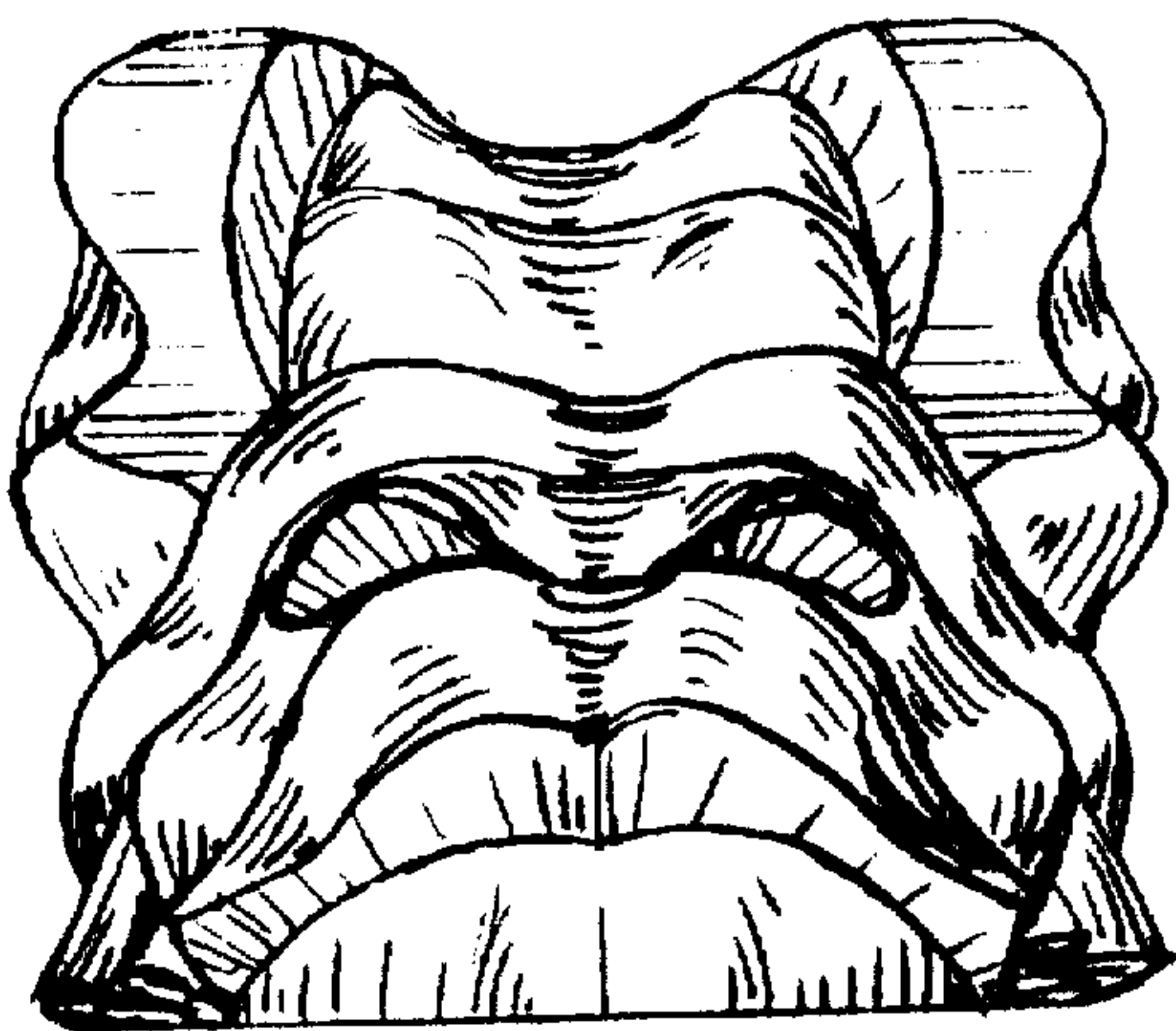

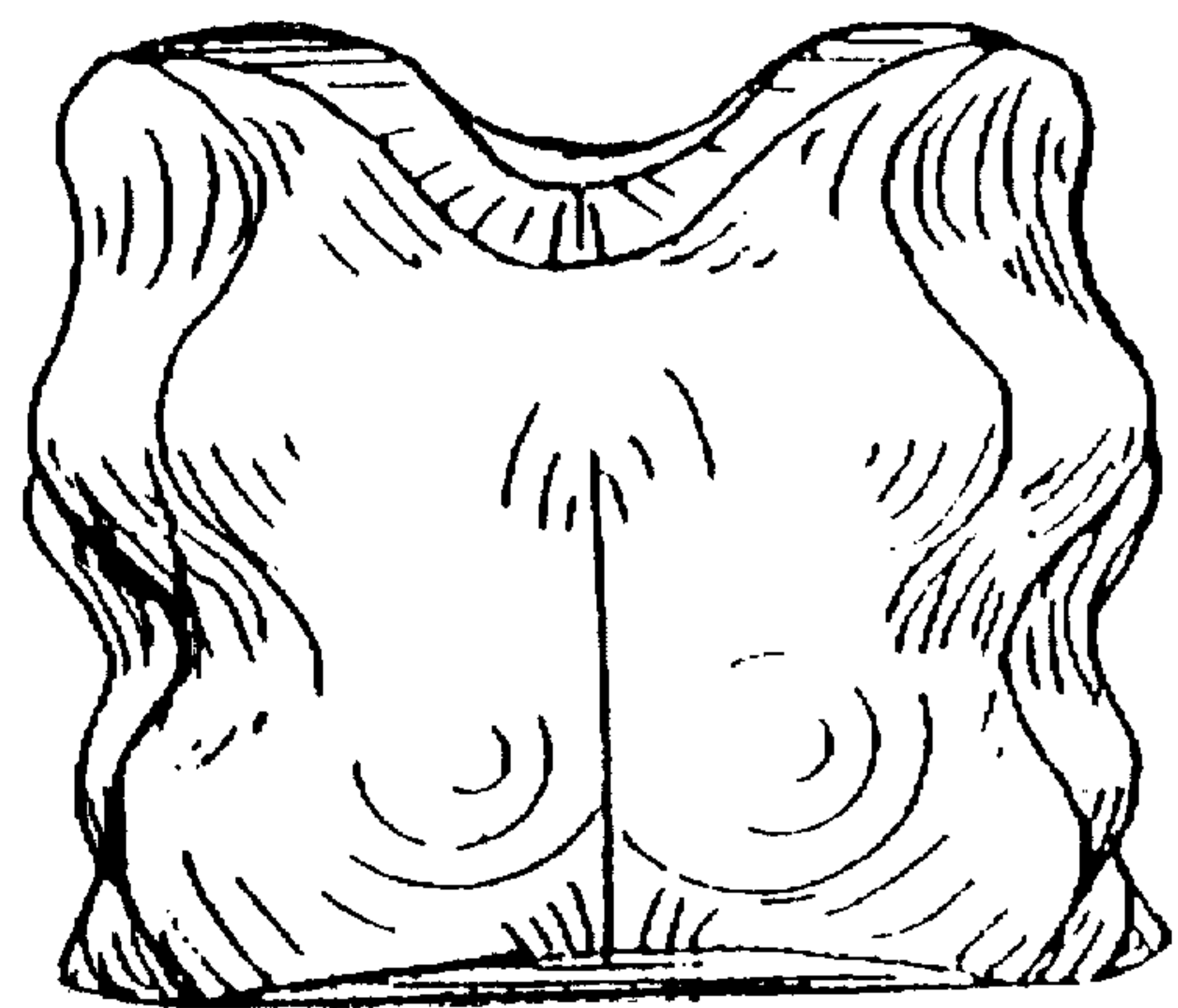
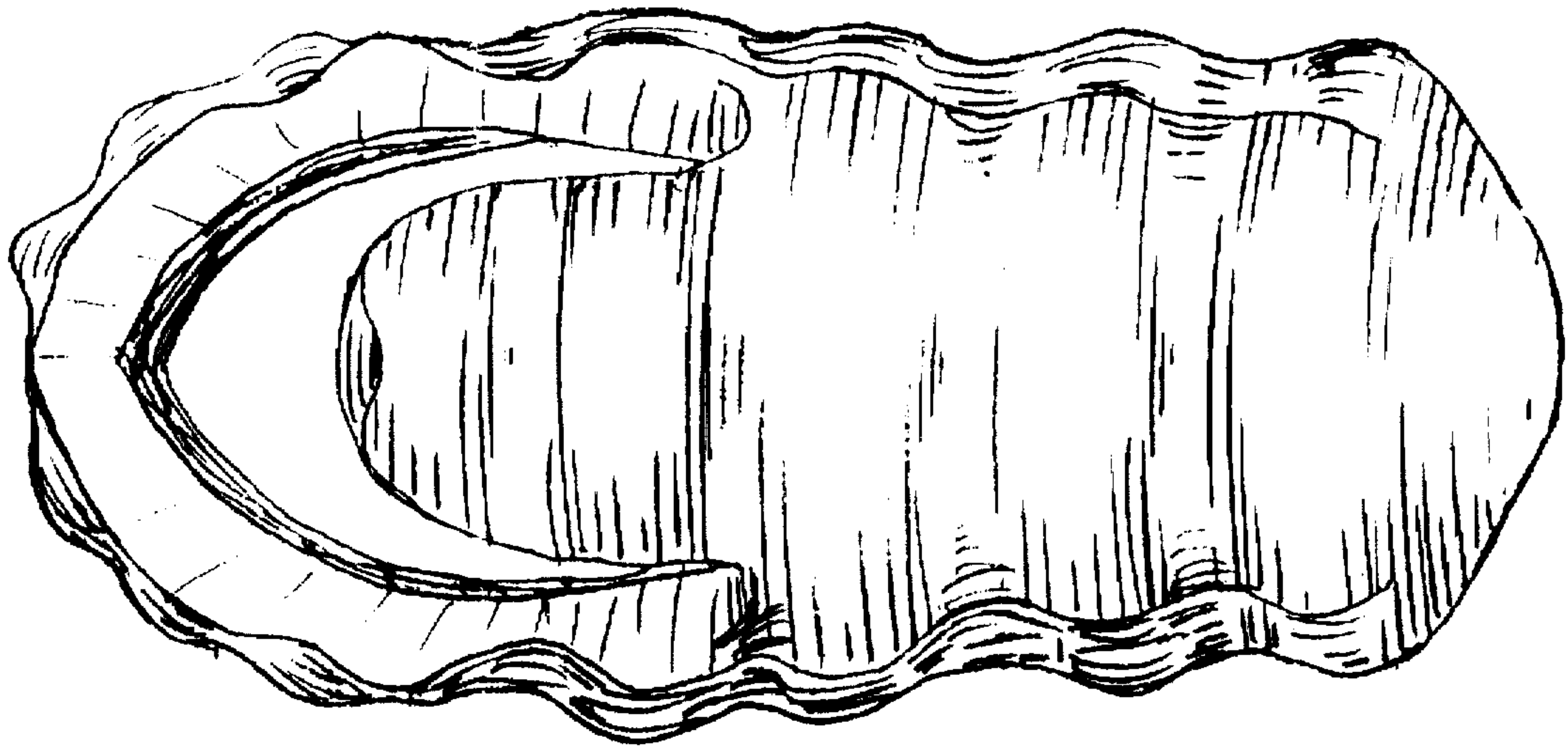
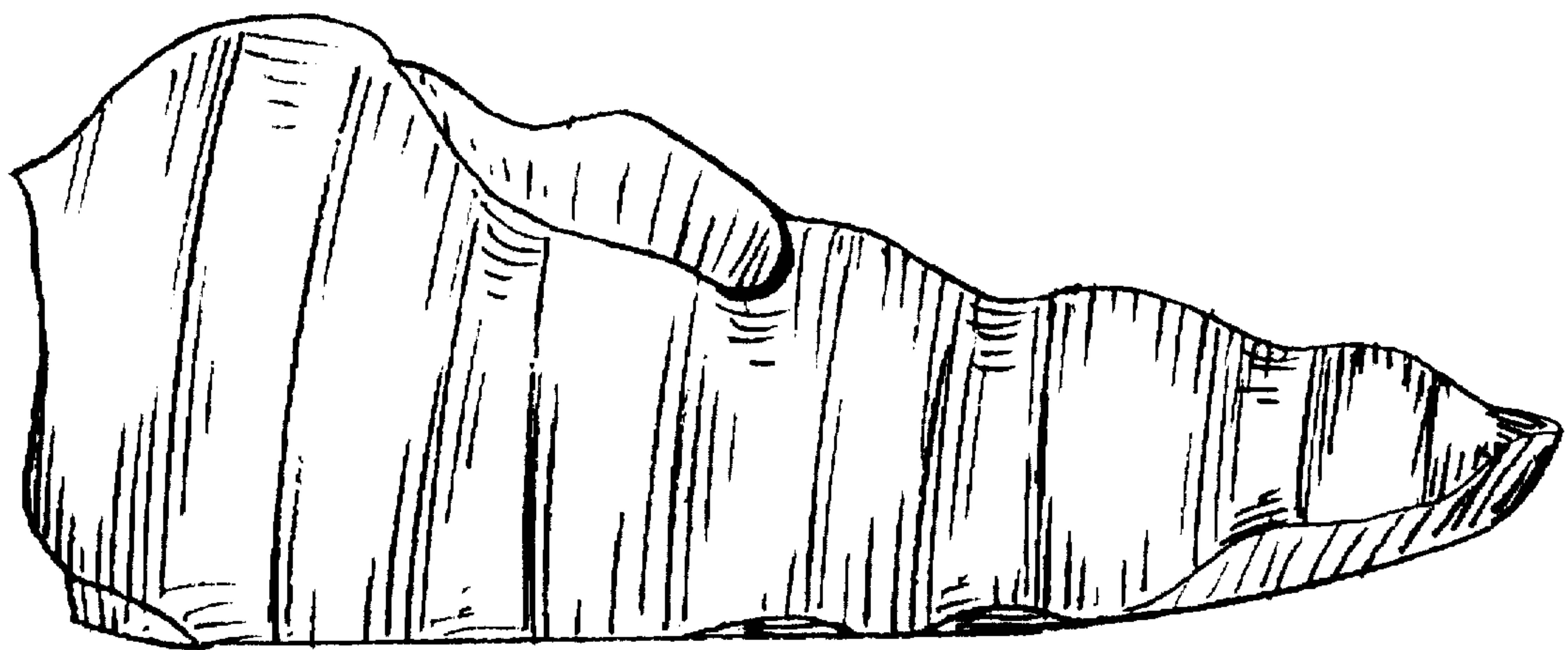

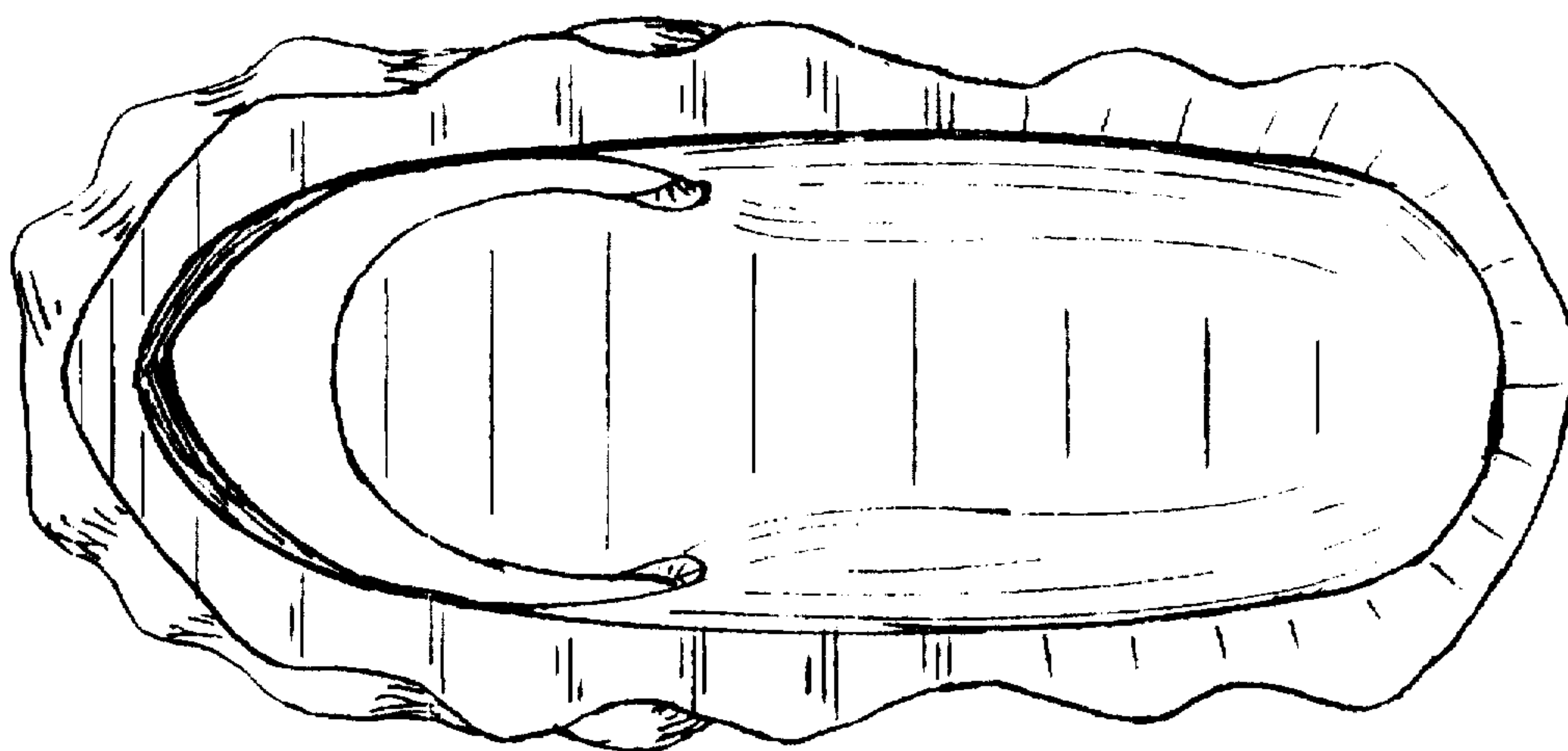

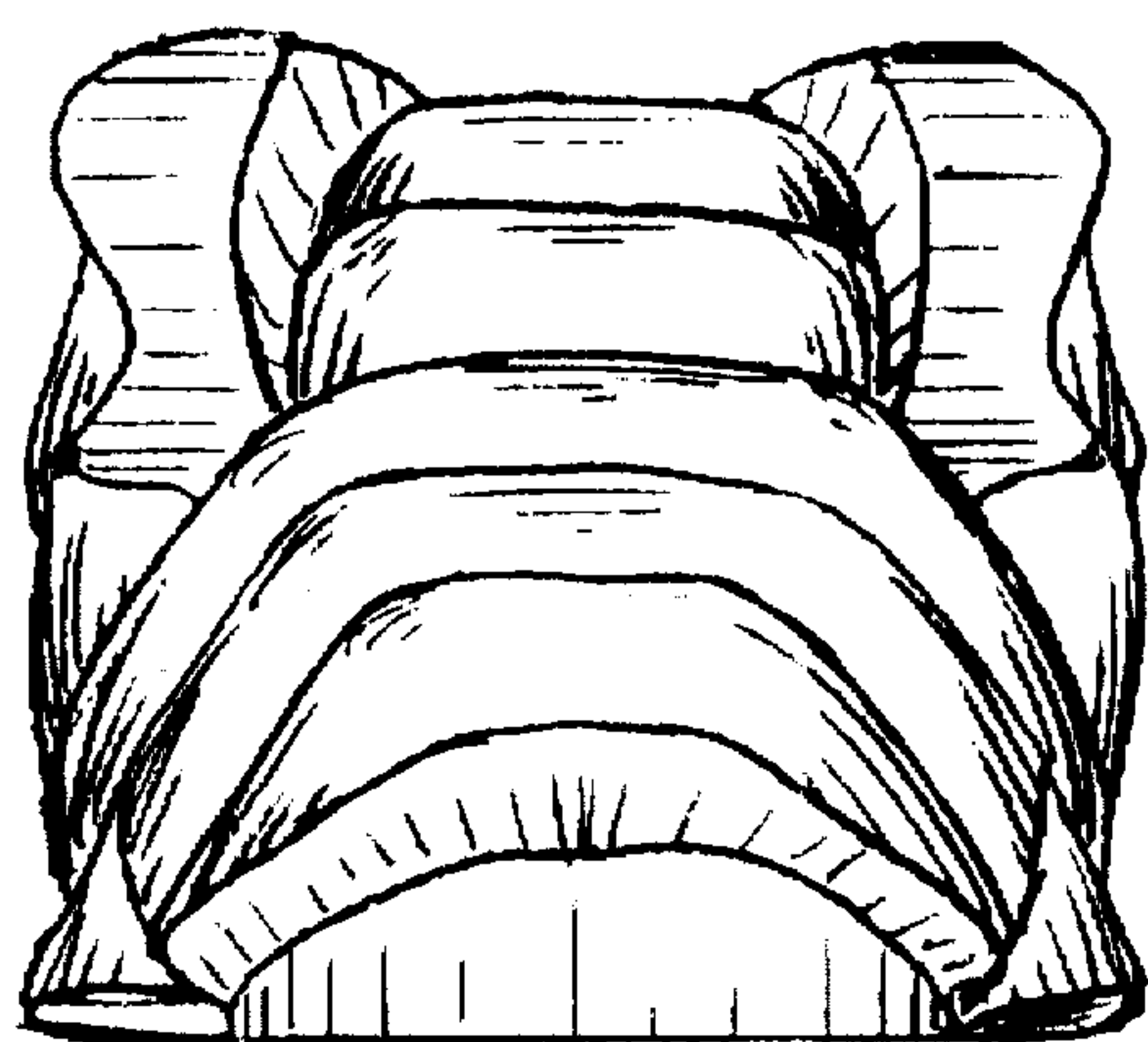

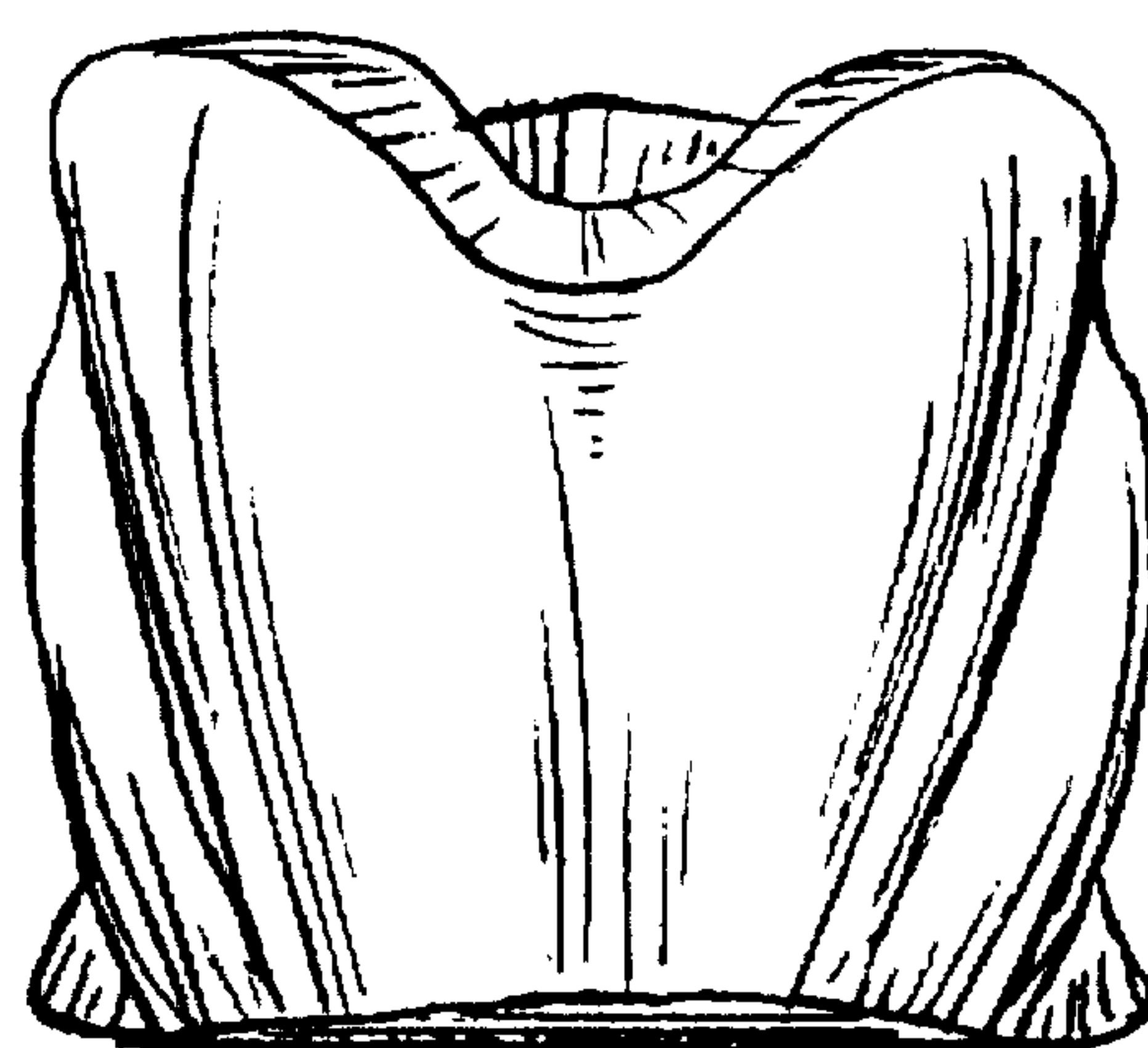

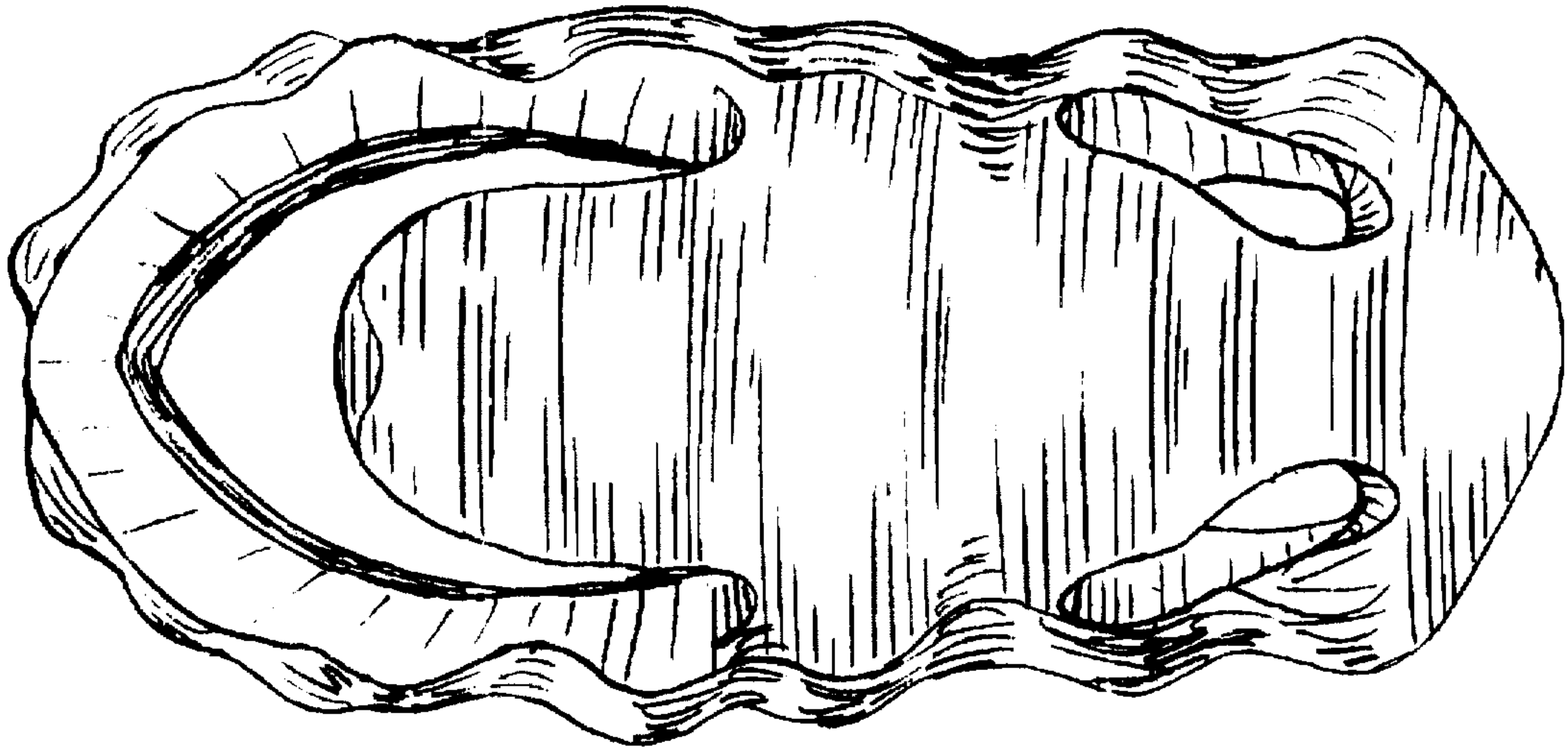

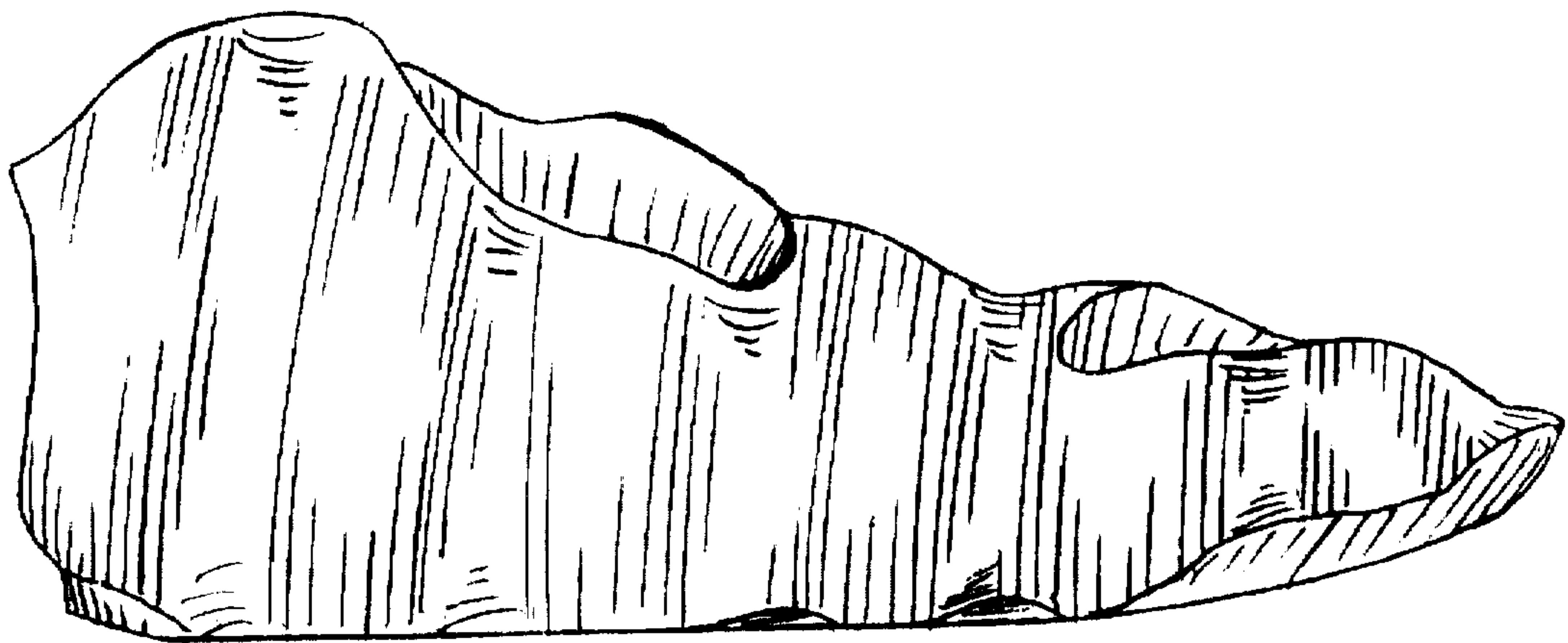

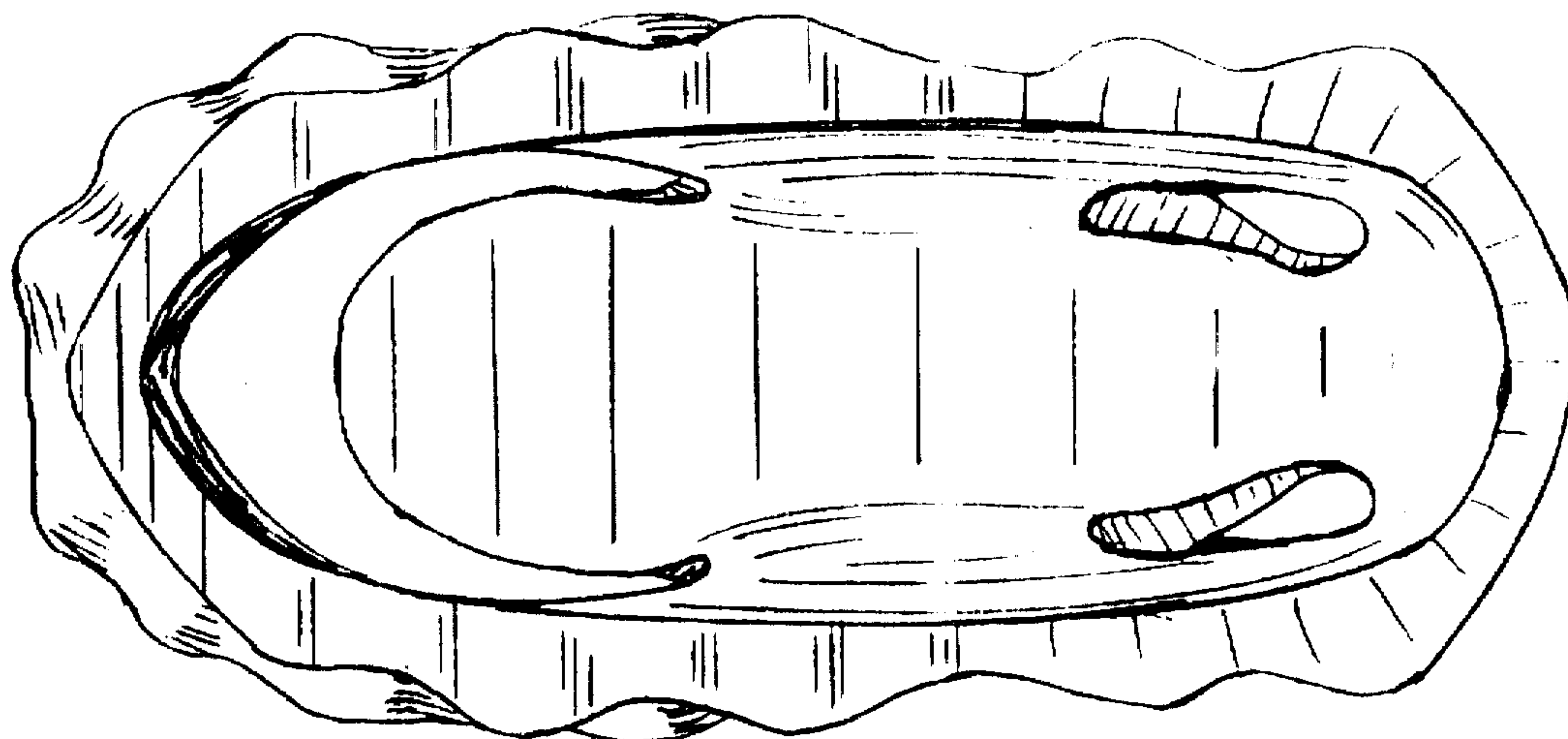

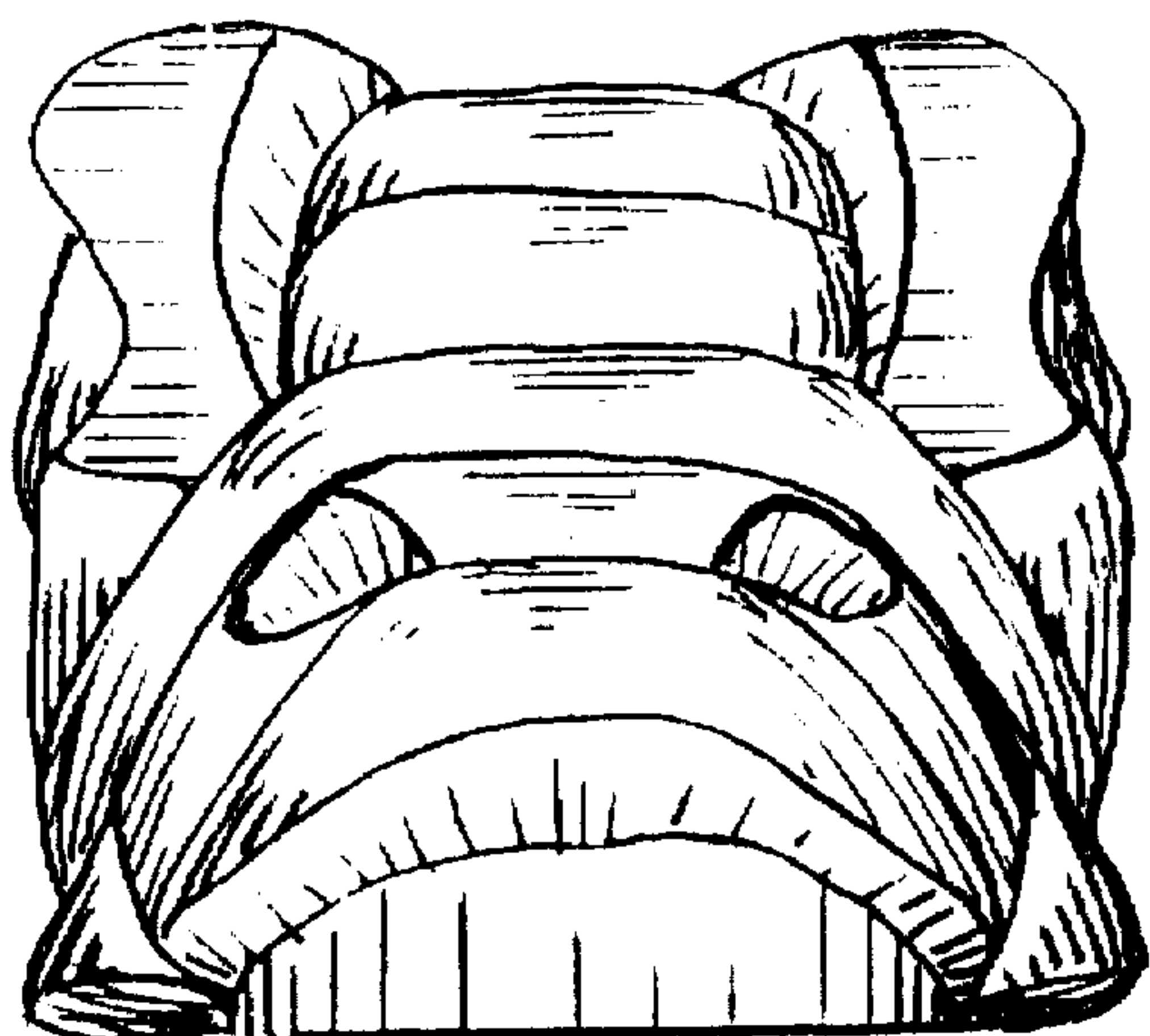

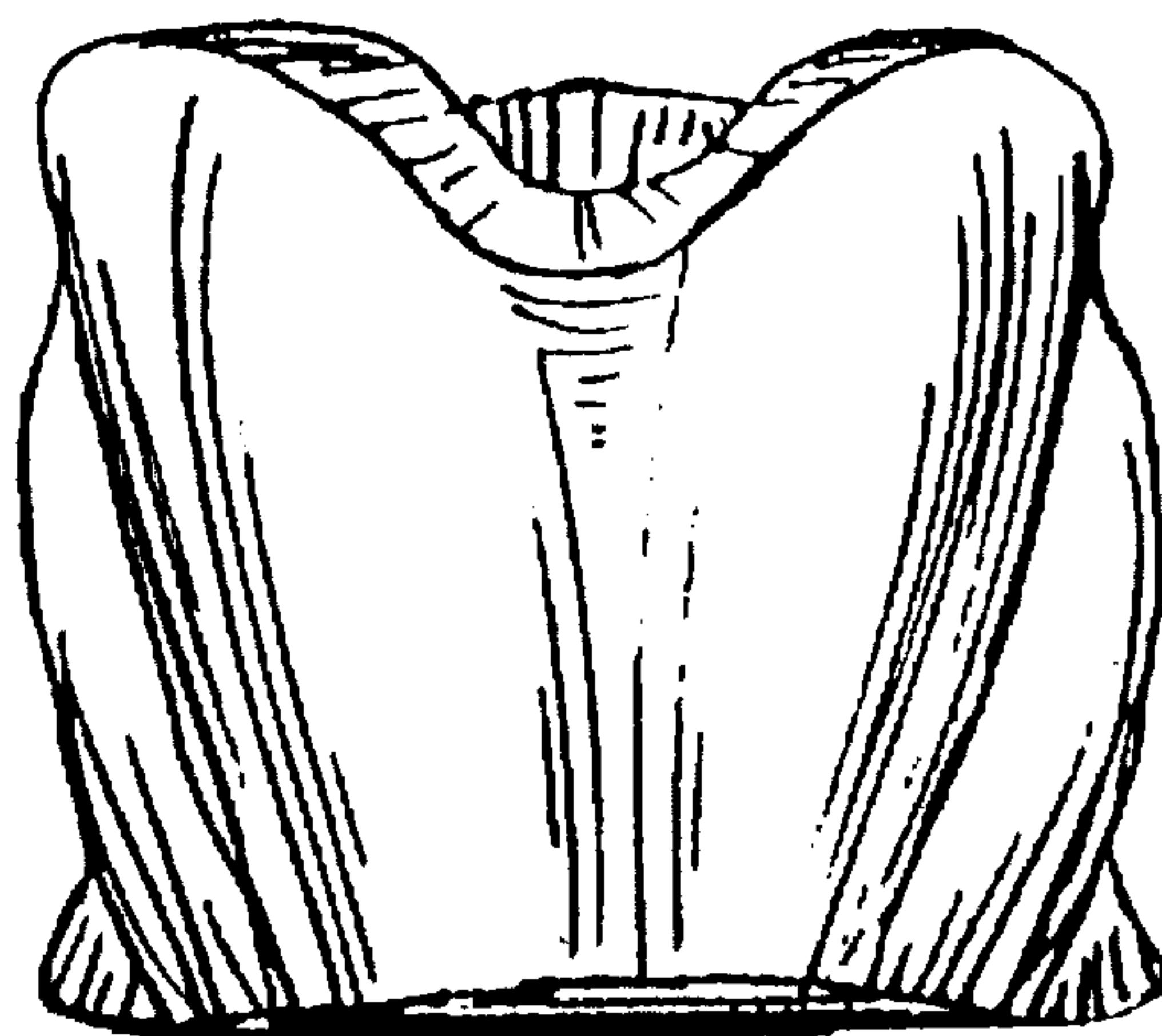
